

Metabolome-wide association study on *ABCA7* demonstrates a role for ceramide metabolism in impaired cognitive performance and Alzheimer's disease

Abstract

Genome-wide association studies (GWAS) have identified genetic loci associated with risk of Alzheimer's disease (AD), but underlying mechanisms are largely unknown. We conducted a metabolome-wide association study (MWAS) of AD-associated loci from GWAS using untargeted metabolic profiling (metabolomics) by ultra-performance liquid chromatography-mass spectrometry (UPLC-MS). We identified an association of lactosylceramides (LacCer) with AD-related single nucleotide polymorphisms (SNPs) in *ABCA7* ($P = 5.0 \times 10^{-5}$ to 1.3×10^{-44}). We show that plasma LacCer concentrations are associated with cognitive performance in humans and concentrations of sphingomyelins, ceramides, and hexose-ceramides were altered in brain tissue from *ABCA7* knock out mice ,compared to wild type (WT) ($P = 0.049$ to 1.4×10^{-5}). We then used Mendelian randomisation to show that the association of LacCer with AD risk is potentially causal. Our work suggests that risk for AD arising from functional variations in *ABCA7* are mediated at least in part through ceramides. Modulation of their metabolism or downstream signalling may offer new therapeutic opportunities for AD.

In recent years, genome-wide association studies (GWAS) have robustly identified thousands of genetic loci for complex traits and disorders. Genetic loci have been used to identify pathways affected in early stages of disease and to differentiate potential causal pathways from pathological processes secondary to their chronic progression in diseases such as Alzheimer's disease (AD). GWAS have so far identified 47 unique genetic loci for AD¹⁻³. Mechanistic understanding of familial-early onset AD arising from variants in genes for amyloid precursor protein (*APP*), presenilin 1 (*PSEN1*) or presenilin 2 (*PSEN2*) has centred around the processing of *APP*, but for most other identified loci contributing to the much more common, sporadic, late onset form of the disease, the underlying pathway(s) mediating risk are less well understood or unknown.

Untargeted metabolomics allows the identification of metabolites and other small molecules in biological samples and provides an objective means to investigate the metabolic consequences of differences in genetic background, endogenous physiological processes and exogenous (environmental) exposures on disease risk^{Lotta, 2016 #10;Wittebans, 2019 #11;Tzoulaki, 2019 #13;Holmes, 2008 #14;Illig, 2010 #15}. For AD, metabolomics has been applied most commonly to patient cohorts in small, underpowered studies with typically fewer than 200 cases. Recently, larger studies have found associations between abnormalities in bile acids and AD or mild cognitive impairment (MCI)⁹ and an association between d18:1/24:1 dihexosyl-ceramide and *ABCA7* was reported based on study of 1954 ethnically Chinese individuals¹⁰.

We conducted a metabolome-wide genetic association study (MWAS) for two epidemiologic cohorts – the Airwave Health Monitoring Study (Airwave)¹¹ and the Rotterdam Study (RS)¹² using ultra-performance liquid chromatography-mass spectrometry (UPLC-MS) and genetic variants identified in prior AD GWAS studies¹⁻³. We then tested for associations of the identified metabolites with cognitive measures in Airwave and for participants in the Finnish Geriatric Intervention Study to Prevent Cognitive Impairment and Disability (FINGER)¹³, a clinical trial of lifestyle interventions to prevent or delay dementia among an elderly cohort. We also performed

a target lipidomic profile of ceramides and metabolically related molecules in brain tissue from the *Abca7* knockout (KO) mouse¹⁴. Finally, we applied Mendelian randomisation¹⁵ to assess potential causal roles of the identified metabolites in determining later life cognitive decline and the risk of AD.

Results

The study workflow is summarised in **Supplementary Figure 1**.

MWAS on AD-related SNPs identifies associations between ABCA7 and LacCers

In our UPLC-MS analysis of the Airwave and Rotterdam Study data, we measured 5199 mass spectral features (the unique mass to charge ratio-retention time pairing, m/z -RT) and annotated 1815 of them (**Supplementary Table 1**). The 47 AD-related SNPs that were associated with metabolic features at a metabolome-wide significance level (MWSL, see **Supplementary Methods**) are shown in the Manhattan plot in **Figure 1**. We observed the strongest association (Pearson correlation coefficient = -0.53, $P = 7.16 \times 10^{-44}$) between rs3752246 in *ABCA7* and a feature with $m/z = 1068.696$ and RT = 7.84 min in the negative ionisation mode spectrum (abbreviated as LNEG, 1068.6958_7.8401) which corresponded to LacCer (d18:1/24:1) (**Figure 1, Supplementary Table 2**). Overall, we identified 121 associations with 10 AD-related SNPs at *ABCA7* that surpassed the significance threshold (**Supplementary Table 2**). These features corresponded to 41 unique mass spectrometry features (MWSL $\alpha = 0.05$) mapped to 16 metabolites.-(**Figure 2, Supplementary Table 2, Supplementary Methods**). Ten of the 41 metabolic features were from LacCer or sulfatide hexosyl ceramide (SHexCer) which were also associated with two AD-related SNPs in *APOE*, suggesting common metabolic pathways underlying AD risk for *ABCA7* and *APOE*. Using expression quantitative trait loci (eQTL) data from The Genotype-Tissue Expression (GTEx) project¹⁶, we found that the 10 *ABCA7* SNPs were associated with lower expression of *ABCA7* in multiple human brain tissues including the

cerebellum and cerebral hemisphere (**Supplementary Figure 2**). Given the specificity and strength of the metabolite associations for the *ABCA7* locus, we focused the remainder of our study on defining the pathways linking *ABCA7* and risk of AD.

Metabolomic signatures and cognitive performance

We tested the 14 metabolomic features associated with *ABCA7* detected on the Imperial Phenome Centre platform against individual cognitive performance variation in Airwave and the FINGER trial data using mixed-effect regression models (see [Methods](#)). We did not have sufficient number of samples – Airwave only – to test the two metabolites found only on the Metabolon platform. Eleven of these features were annotated in FINGER data (mean age 69.2 ± 4.7 years) and five of these (including three LacCer species) were positively associated ($P < 0.05/11$, Bonferroni threshold) with a composite cognitive score based on an extended version of the Neuropsychological Test Battery¹⁷. None of these features were associated with cognitive performance among Airwave participants (mean age 40.0 ± 9.2 years), but they were on average more than 20 years younger than FINGER trial participants (**Figure 3-a**). We also tested for associations between changes in these 14 metabolic features in plasma and changes in cognitive scores in the FINGER trial, comparing baseline and two-year follow-up data, and found that higher level of an *N*-acylphosphatidylethanolamine, referred to here as NAPE5* (SLNEG 1015.7305 9.0037), was associated with slower cognitive decline (**Supplementary Figure 3**).

Ceramide metabolism in the brain tissue of the *Abca7* knockout mouse

We then carried out metabolic profiling of brain tissue (left hemispheric cerebral cortex) from the *Abca7* KO mouse versus WT to test whether variations in lipid profiles related to *ABCA7* in peripheral blood in the human studies also are found in brain tissue. We performed UPLC-MS in both positive and negative ionisation modes on the lipid phase of chloroform/methanol/water

extractions of the cerebral cortex and then performed Principal Component Analysis (PCA) to visualise dominant patterns (**Figure 4**). While the main variance in the positive ionisation mode data was driven by sex (PC1 = 80.4%, PC2 = 8.7 %), the principle factor discriminating samples in the negative ionisation mode data was attributed to genotype (PC1 = 59%, PC2= 14.2%, PC3 = 6.9 %). We also found lower levels of phosphatidylcholines and phosphatidylglycerols in brain tissue from *Abca7* null mice, consistent with previous reports^{14,18}.

Based on associations of plasma LacCer concentrations with the *ABCA7* locus in the human studies, we filtered the lipidomic data specifically for sphingolipids (sphingomyelins, ceramides, and hexose-ceramides) and performed two-way analysis of variance (ANOVA) to investigate genotype-sex interactions. Nine sphingolipids detected in negative mode ionisation differed between *Abca7* KO and WT ($P < 0.05$), with seven associated with genotype and two associated with sex (one passing the Bonferroni correction for multiple testing). Repeating this analysis for the positive mode ionisation dataset, 244 differences were identified across the detected sphingolipids, of which 159 were associated with sex (two passing the Bonferroni correction for multiple testing) and 44 associated with interactions between sex and genotype (24 passing the Bonferroni correction for multiple testing). These data suggest a role for *ABCA7* in regulating ceramide metabolism in the brain, and that may, at least partially, be sex-dependent.

Mendelian randomisation analysis

Of the 41 mass spectral features related to the 10 AD-related SNPs at *ABCA7*, we annotated eight to three metabolites: LacCer(d18:1/24:1), LacCer(d42:3) and LacCer(d18:1/22:0). From GWAS on Airwave data, we identified genetic instruments (SNPs) for two-sample Mendelian randomisation analysis based on a representative metabolic feature for each of the three metabolites, i.e. LNEG_970.7177_7.8397 for LacCer(d18:1/24:1), LNEG_1066.6794_7.3646 for

LacCer(d42:3), and LNEG_1043.6825_7.8568 for LacCer(d18:1/22:0). List of genetic variants for each metabolic feature is presented in **Supplementary Table 3**. Two-sample Mendelian randomisation analysis was performed to assess the association of the metabolic features with risk of AD. Using the inverse variance weighted method, we found supporting evidence for inverse associations of LacCer(d18:1/24:1) and LacCer(d42:3) with AD (**Figure 3-b**). Estimates from weighted median and MR-Egger methods, as sensitivity analyses, were consistent with the inverse variance weighted estimates, although the MR-Egger estimate had wide confidence intervals reflecting its reduced power compared with the other two methods.

Discussion

We found evidence that LacCers play a role in the association between variants in the *ABCA7* gene and metabolic pathways associated with cognitive performance and AD based on aggregated metabolomic and genomic data from both human and animal studies. Our MWAS indicated that among genes so far identified for AD, *ABCA7* demonstrates the strongest association with metabolic traits in the peripheral blood of humans. We found 121 associations between 10 independent genetic variants at *ABCA7* and mass spectral features in the lipophilic fraction of peripheral blood. Most of the features were annotated to LacCers, with the most robust association being found between rs3752246 and LacCer (d18:1/24:1). Further, we found that deletion of *Abca7* in the mouse results in a range of alterations in sphingolipid metabolism, particularly for ceramides and hexose-ceramides. Moreover, using the Mendelian randomisation approach, we found evidence supporting a potential causal role of LacCers on the risk of AD.

The genetic loci associated with AD can be separated into two broadly-defined groups of genes. The first set are a small number of genes including *APP*, *PSEN1* and *PSEN2* that have a strong autosomal dominant hereditary effect and associate with familial-early onset AD. For these loci, potential underlying molecular mechanisms have been postulated including that underpinning

the influential “amyloid hypothesis” positing that amyloid-beta accumulation results in presenile plaque formation¹⁹⁻²¹. The second group is larger and includes genes such as *APOE* that are associated with sporadic late-onset AD (LOAD). These latter genetic risks interact with environmental factors for the development of AD later in life. Relative to the early onset forms, much less is known about specific mechanisms associated with sporadic LOAD or, indeed, whether there is a common mechanism, or whether a number of distinct mechanistic pathways converge on a common pathology.

ABCA7 is part of the ATP-binding cassette (ABC) transporter family, important in regulating phospholipid and cholesterol transport across the cell membrane, as well as within the cell between subcellular organelles¹⁸. *ABCA7* is highly expressed in microglia in cell culture and in neuronal cells, particularly in the hippocampus²². From cell culture experiments, *ABCA7* expression is regulated by sterols through the *SREBP2* pathway²³, and increased expression of *ABCA7* has been shown to enrich HeLa cells with ceramides²⁴. Neuronal cells lacking *ABCA7* show evidence for increased ER-stress and A β 40 and A β 42 production. Sakae et al. proposed that *ABCA7* deficiency alters lipid metabolism in ways that secondarily increase *SREBP2* and *BACE1* expression and induce ER stress and A β accumulation to initiate cognitive deficits that lead to prodromal AD¹⁴. Consistent with this model, genetic variants at *ABCA7* are associated with relative atrophy of the cortex and hippocampus both in cognitively normal people and those with mild cognitive impairment²⁵.

We applied complementary epidemiological resources and approaches to gain new understanding of the pathways linking genetic variants in *ABCA7* to AD risk. Although a large proportion of Airwave¹¹ participants are too young to show clinically meaningful cognitive decline, it provides a resource in which relationships between genetic variants and early disturbances in intermediate molecular phenotypes can be explored. We also included data

from older adults in FINGER (aged 60 to 77 years at baseline)²⁶ to investigate effects of identified metabolites on cognition. We demonstrated associations of LacCer(d18:1/22:0), LacCer(d18:1/24:0), LacCer(d18:1/16:0), SHexCer, and NAPE5* with cognitive performance. Moreover, we found that levels of NAPE5* were inversely associated with decline in cognitive performance over a two-year period in FINGER (**Supplementary Figure 3**).

Our untargeted lipidomic assay of *Abca7* KO and WT mouse brains showed decreases in a wide range of phosphatidylcholines and phosphatidylglycerols and differences in the concentrations of more than 250 sphingolipids (including ceramides). These results strongly support a role for ABCA7 in sphingolipid/ceramide metabolism. Consistent with this, in an earlier report, Sakae and colleagues used a targeted lipidomics assay of 275 lipids to assess lipidomic changes in the brains of *Abca7* KO mice¹⁴. They found differences in 24 specific lipids, consisting of decreases in 12 species of phosphatidylethanolamines, three species of phosphatidylglycerols, one lysophosphatidylcholine and two sphingomyelins, and increases in three phosphatidylcholines, one ceramide, three sulfatides and one cerebroside.

We used Mendelian randomisation to test for potential causal relationships between LacCer concentrations in plasma and AD. This is a type of instrumental variable analysis where genetic variants are used as instruments to overcome unmeasured confounding and reverse causation in observational studies²⁷. The two-sample Mendelian randomisation design uses data on risk factors (in this case metabolic features of the LacCers) and outcome (AD) from different cohorts, which allows possibilities to increase statistical power. For our analysis, we first performed a GWAS on metabolic features in Airwave to generate genetic instruments for the target LacCers and then took advantage of the most recent and largest AD GWAS data to test for associations of these genetic variants with AD². Using this approach, we found evidence of a possible causal association of increased concentrations of plasma LacCer (d18:1/24:1) and

LacCer (42:3) with decreased risk of AD. Thus, we have found that *ABCA7* contributes to the regulation of systemic LacCer metabolism and that these glycolipids may play causal roles in the genesis of AD.

Gene association, epidemiological studies and animal and cell models all have suggested causal roles for lipid dyshomeostasis in AD pathogenesis, especially for *APOE*, *ABCA7* and *TREM2*²⁸. Gene-set analyses support this by implicating pathways involving lipid metabolism in addition to those for inflammation and amyloid processing¹. Metabolomic studies of ApoE and Trem2 in mouse models^{28,29} and cell culture directly implicate lipid dyshomeostasis and inflammation with genetic risk of AD. These observations suggest that the genesis of LOAD may share general features of the metabolic disease-associated inflammation (“meta-inflammation”) that affects adipose and other peripheral tissues in the metabolic syndrome³⁰. In this context, we note that four metabolites, NAPE3*, NAPE4*, NAPE5*, PA* and one unassigned metabolite (UA) corresponding to the feature SLNEG_782.4965 3.5812 associated with *ABCA7* SNPs (but not with any of the SNPs at *APOE*) have arachidonic acid (20:4) side chains. The MS/MS experiments for the unassigned metabolite (UA) was also shown to contain a (20:4) acyl chain by tandem mass spectrometry. LacCers activate cPLA2- α , a phospholipase that hydrolyses arachidonic acid from phospholipids³¹. Arachidonic acid, a substrate for cyclooxygenase (COX) and lipoxygenase (LOX), is a driver of macrophage and microglial pro-inflammatory pathways in aging and AD³².

Our observations regarding gene-metabolite interactions associated with AD are novel, however, have some limitations. First, we discovered associations of LacCers with the *ABCA7* locus using peripheral blood rather than directly in the brain. Our results thus either imply that systemic biochemical pathology promotes the genesis of AD (e.g., via inflammation) or that there is a related lipid dyshomeostasis in the CNS. However, our observations of differences in

concentrations of other lipids (particularly sphingolipids, ceramides, and hexose-ceramides) in the *Abca7* KO mouse brain relative to WT controls are most consistent with the latter possibility. Second, rather than directly testing causal associations between concentrations of LacCers and AD, we carried out Mendelian randomisation analyses in which genetic information was used to identify potential causal links between the LacCers and risk of AD. This approach involves three key assumptions²⁷: i) the genetic variants are associated with the risk factor (LacCer metabolites in this case); ii) there are no unmeasured confounders between genetic variants and outcome (AD); and iii) the genetic variants affect the outcome only through their effect on the risk factor (that is, there are no directional pleiotropic effects). We fulfilled the first assumption by setting strict criteria for selecting genetic variants ($P < 5 \times 10^{-8}$ and F-statistics > 10). It is difficult to verify whether the second and third assumptions hold, but our findings were robust to sensitivity analyses and the MR-Egger method did not indicate any potential directional pleiotropic effects.

ABCA7 is widely expressed throughout the body, including the brain, particularly in myeloid cells (<https://www.proteinatlas.org/>). AD-risk raising SNPs were all associated with reduced *ABCA7* activity, and Satoh and co-workers have previously shown that knockout of the gene in the mouse increases soluble A β in an APP mouse model³³. From our observations, we propose that in addition to regulating cholesterol and phosphatidylcholine concentrations, *ABCA7* regulates intracellular concentrations of ceramides and hexosyl-ceramides, which were increased in the cortex of *Abca7* KO mice (**Figure 5**). We further hypothesize that the accumulation of these ceramide species in the brain may increase the cleavage of APP to induce plaque formation, as has been previously suggested¹⁴. This may possibly occur by increasing lipid raft formation, and/or contributing to ER stress, as seen for example in peripheral cell types when exposed to palmitate induced ER-stress through altering both cell membrane composition and dynamics³⁴.

In conclusion, we report associations between SNPs at the *ABCA7* locus and LacCers in peripheral blood, which were associated with differences in cognitive function and potential causal links with risk of AD³⁵. Manipulation of sphingolipid metabolism is already being explored for augmenting the efficacy of anti-cancer and insulin resistance therapeutics, effective strategies for which could be tested as “re-purposed” treatments for AD³⁶.

Online Methods

Study samples

Airwave is an occupational cohort of 53,116 police officers and staff ages 18 years and over across Great Britain that was launched in June 2004¹¹. Blood samples were obtained at the screening visit (with consent) and stored at –80 °C at the laboratory, before being transferred to the biorepository facility and stored in vapour phase liquid nitrogen. Metabolomic assays were done for approximately 5,250 samples (**Supplementary Table 1**). The samples were divided into two separate sample sets (referred to herein as Airwave 1 and Airwave 2). Airwave 1 utilised lithium heparin plasma samples and Airwave 2 utilised EDTA plasma samples. Both sets of samples were analysed at the Imperial Phenome Centre (London, UK). In addition, a set of 2,250 samples were analysed by Metabolon Inc.TM (Morrisville, NC, USA), of which 1,000 were also included in Airwave 2.

The Rotterdam Study is a prospective cohort study of individuals in the Ommoord district of the city of Rotterdam, the Netherlands¹². At baseline, between 1990 and 1993, 7,983 participants over 55 years old were interviewed at home and underwent extensive clinical examination at the research centre. Serum samples were collected from 1997 to 1999, stored at –20 °C and analysed for metabolites by Metabometrix Ltd (London, UK) using protocols adopted from the Imperial Phenome Centre. The Airwave and Rotterdam sample and features numbers are described in **Supplementary Table 4**.

FINGER is a randomised controlled trial of 1,260 individuals aged 60–77 years with increased risk for dementia based on the Cardiovascular Risk Factors, Aging, and Incidence of Dementia (CAIDE) dementia risk score and a cognition at mean level or slightly lower than expected for their age³⁷. The population was randomly assigned to a multidomain intervention (diet, exercise, cognitive training, vascular risk monitoring) or a control group (general health advice) in a 1:1 ratio. We used metabolomic and cognitive data at baseline and 2-year follow-up. EDTA plasma samples were analysed at the Imperial Phenome Centre.

Genomics data

For both Airwave and the Rotterdam Study, DNA samples were extracted from leukocytes. Genotyping was done using Illumina Infinium HumanExome-12v1-1 BeadChip Array in Airwave and Illumina 550 K arrays in the Rotterdam Study. Both studies imputed their data to 1000 Genomes Phase 3 reference panel.

Metabolomics data

For each cohort (Airwave 1, Rotterdam Study and FINGER), metabolomics data were acquired using UPLC-MS. Methods and quality control (QC) have been described previously³⁸⁻⁴⁰. Briefly, a pooled study reference sample was prepared for each population. Serum and plasma long-term reference samples were prepared using commercial bulk serum and plasma (BioIVT [Seralab], West Sussex, UK). These QC samples were analysed at regular intervals throughout data acquisition. Mixtures of authentic reference standards were added to the study reference, long-term reference, and study samples used in the UPLC-MS analysis to enable targeted monitoring of data quality during acquisition.

Plasma samples from FINGER were prepared and underwent UPLC-MS profiling analysis for lipids and small metabolites as previously described³⁸. The same procedures were used for the analysis of plasma samples from Airwave and serum samples from Rotterdam Study except that 100µl of samples was used without dilution prior to addition of isopropanol for the lipidomics analyses. Briefly, batches of 80 samples were prepared into 96-well plates. Each sample was mixed with four parts of 4°C isopropanol, incubated at 4°C, centrifuged, and the supernatant aliquoted into a 96-well plate. All analyses were acquired on Acquity UPLC systems coupled to Xevo G2-S ToF mass spectrometers (Waters Corporation, Milford, Massachusetts, United States). For these samples three platforms were used - reverse phase in positive ionisation mode which detects largely lipid species (Lipid Positive mode - LPOS), reverse phase in negative ionisation mode which detects largely lipid species (Lipid Negative mode - LNEG) and HILIC chromatography in positive mode which detects largely small and polar metabolites (HILIC Positive mode - HPOS).

Data processing

Peak picking was completed using Bioconductor R-package XCMS⁴¹. Drift correction was done using a method previously described⁴². For FINGER, we used nPYc toolbox⁴³. Negative values were replaced with zeros, and the data were natural log-transformed after adding one. We filtered the data based on retention time to exclude non-retained and cleaning phase features – only features in the following retention times (in minutes) were accepted: HPOS (0.5-7); LNEG (0.3-9.5); LPOS (0.45-12). We used principal components analysis (PCA) to identify samples that were outliers and excluded them. Further, we excluded values that were >5 median absolute deviations (MAD) from the median. We used 10 principal components from genome-wide scans to adjust for population stratification. Finally, we transformed the data into z-scores using median and MAD, so that we had comparable intensities across studies. We determined cross-study feature correspondence for the Airwave and the Rotterdam Study using an in-house

algorithm that selects the matches that are the closest in retention time and mass to charge ratio (m/z ratio) in the two pre-aligned datasets.

UPLC-MS metabolite annotation

Lipid annotation was initially completed by matching accurate mass fragmentation measurements to reference spectra from online databases (LIPID MAPS⁴⁴, Metlin, HMDB) and previous publications. Where chemical reference materials were commercially available (Avanti Polar Lipids, Sigma Aldrich, Cayman Scientific), they were used to generate definitive molecular identification by direct matching of chromatographic and spectral qualities (including accurate mass, MS/MS spectra, and isotopic distribution) to those observed in the profiling data. For FINGER data, annotations were transferred from the Airwave data after finding feature correspondence between the two datasets, using the same method as described above.

Selection of genetic variants

We identified 47 unique genetic loci based on three recent GWAS on AD¹⁻³. The lead SNP from 45 genetic loci were available in our data and was analysed in the exploratory stage MWAS (see below). To focus on the pathways linking *ABCA7* and risk of AD, we selected SNPs with a $P < 1 \times 10^{-5}$ within +/- 500 kb from the lead SNP in *ABCA7* using the most recent GWAS by the International Genomics of Alzheimer's Project (IGAP) consortium² (Discovery stage: N_{case} / control = 21,982 / 41,944). For correlated SNPs with $r^2 \geq 0.5$, we kept the SNP with the smallest *P*-value, resulting in 10 SNPs selected for the MWAS focusing on *ABCA7*.

Metabolome-wide association study (MWAS)

We carried out a linear regression to study the association of each SNP with all metabolomic features (Metabolon, HPOS, LNEG, LPOS) with adjustment for age, sex, and cohort. We used a permutation-based method to estimate the MWAS Significance Level^{45,46} to account for multiple

testing and the high degree of correlation in metabolomics datasets. A P -value threshold giving a 5% Family-Wise Error Rate was computed for each SNP in each metabolomics platform.

Representative features

For subsequent analysis, we used a single feature to represent each metabolite. The representative feature was chosen based on the major detected ion (either parent ion, closest adduct, or isotope which gave the largest intensity and was not confounded by isobaric species).

Association of metabolites with cognition

We used data from the Airwave and FINGER studies to study the association of identified metabolites with cognitive performance. Cognition was measured using a version of the Cardiff Cognitive Battery⁴⁷ in Airwave and using standard neuropsychological tests (an extended version of the Neuropsychological Test Battery) in FINGER²⁶. The analysis for FINGER was based on metabolomics and cognition data both available at baseline and at the follow-up visit. In Airwave, however, the analysis was cross-sectional using the cognition and metabolomic data for individuals at baseline.

Mendelian randomisation

We performed two-sample Mendelian randomisation analyses to investigate the potential causal relationship between metabolomic features associated with SNPs in *ABCA7* and AD risk. We conducted GWAS on these metabolomic features in Airwave to identify genetic instruments for the Mendelian randomisation analyses. For each feature, data points outside 5 MAD from the median were deleted and subsequently imputed using the k-nearest neighbour (kNN) algorithm (k=10). GWAS were performed using the high-dimensional association analyses (HASE) framework with adjustment for age and sex⁴⁸. Population stratification was controlled by

adjusting for 10 principal components during data pre-processing stage. The number of participants analysed in GWAS were 1977 (HPOS), 1979 (LPOS), and 1983 (LNEG).

For each metabolic feature, SNPs with $P < 5 \times 10^{-8}$ and an F-statistics > 10 were selected as genetic instruments for the Mendelian randomisation analysis. To mitigate weak instrument bias, we only included SNPs with a minor allele frequency greater than 5% and imputation quality greater than 0.6. We removed correlated SNPs ($r^2 > 0.1$) by retaining the SNPs with the smallest P -value. Mendelian randomisation analyses were performed for metabolic features with more than three independent genetic instruments to allow further sensitivity analyses. The genetic association of AD was based on the most recent GWAS of IGAP².

We searched for genetic instruments for 14 mass spectral features. Three or more independent instruments were available for eight features, annotated to three metabolites. We selected a representative feature for each metabolite for the Mendelian randomisation analysis (**Supplementary Table 4**). We estimated the effect of metabolic features on risk of AD using the inverse variance weighted (IVW) method⁴⁹. Potential pleiotropic effects were assessed using weighted median (WM) and MR-Egger regression as sensitivity analyses. Potential outlier SNPs were identified using MR-PRESSO and were excluded from the analyses⁵⁰. We accounted for multiple testing using Bonferroni correction accounting for the number of tested metabolites ($P < 0.05/3 = 0.0167$).

Mouse *Abca7* knockout model

All animal procedures were approved by the Mayo Clinic's Institutional Animal Care and Use Committee and were performed in accordance with the National Institutes of Health's *Guide for the Care and Use of Laboratory Animals*⁵¹. *Abca7* knockout mice (*Abca7*^{-/-})⁵² were crossbred with WT C57BL/6 inbred mice. Littermate male and female *Abca7*^{+/+} (WT) and *Abca7*^{-/-} (KO)

mice were killed at 50 weeks age (4 WT male, 3 WT female, 4 KO male, 3 KO female, 3 pooled samples) and the left hemisphere of the brain rapidly dissected and frozen on dry ice. Left cerebral cortex (20 mg of wet weight tissue) was extracted using chloroform/methanol/water biphasic extraction and the lipid fraction analysed using UPLC-MS with reverse phase chromatography of the lipid fraction (LPOS and LNEG). Peak picking was performed using the R library XCMS after optimisation of peaks extraction and retention time correction parameters with the library IPO⁵³ in conjunction with a tool for automated optimization of XCMS parameters. Further data processing was completed using the KniMet⁵⁴. Briefly, features were removed from further analysis if detected in less than 50% of the pooled samples with a relative LipidSplash internal standard deviation higher than 20%, annotated by exact mass match with the LIPID MAPS database. Missing values were either imputed using the R library "impute"⁵⁵ for multivariate statistical analysis, or replaced with half of the minimum value found in the feature for univariate statistical analysis. In total 10837 features were detected in positive and negative ionisation mode, with 5,503 of these features being assigned by a combination of exact mass, retention time matching and comparison with standards. Multivariate statistics comparing metabolic features detected in KO versus WT mice were performed on both negative and positive ionisation mode data.

Figure 1 – Manhattan plot on the association of metabolites detected by mass

spectrometry with AD-related SNPs. Features associated with *ABCA7* SNPs are annotated.

For some metabolites more than one metabolic feature was found to be associated with AD-related SNPs and the number of metabolic features corresponding to the same metabolites are described in brackets. Key: LacCer: lactosylceramide, NAPE: N-acyl phosphatidylethanolamine, PA: phosphatidic acid. Red features are assayed by negative ionization mode lipidomics and blue features by positive ionization mode lipidomics.

Figure 2 – Metabolites associated with AD-related SNPs at *ABCA7* (dark grey) and their association with AD-related SNPs at *APOE* (light grey).

A circle surrounds all the multi-platform features annotated to the same metabolite and at least one of those features is associated with the connected SNP. Colours indicate metabolite class and symbols represent the analytical platform used. The features PA*, NAPE4* and NAPE5* contain the carbon side-chain (20:4).

Figure 3 – a) The association of *ABCA7*-associated metabolites with cognitive score in

FINGER trial and Airwave. For FINGER, the association between metabolite concentrations and cognition was tested using a linear mixed model adjusted for fixed effects of age at baseline, sex, intervention, visit (binary) and domain of participant groups; and for random effects of within-subject variation. For Airwave, the association between metabolite concentrations and cognition at baseline was tested using a linear mixed model adjusted for fixed effects of age at baseline, sex, visit (binary) of participant groups; and for random effects of within-subject variation. We obtained the z-score for both metabolite levels and cognition values prior to analysis. Chemical species are represented by their molecular ion or most abundant adduct ion. Larger dots indicate 95% CI, not including the null value; red dots indicate associations with $P < 0.05/11$ for FINGER and $P < 0.05/14$ for Airwave (Bonferroni correction for

11 and 14 features, respectively). **b) Associations between ABCA7-associated metabolites and risk of AD based on Mendelian randomisation.** Dots indicate inverse variance weighted (IVW) estimates, triangles indicate weighted median (WM) and squares indicate Egger estimates. Red and larger shapes indicate significant associations with $P < 0.05/3$ (Bonferroni correction for 3 features).

Figure 4 – Schematic of the proposed interaction between ceramide metabolism and ABCA7 in the brain. SNPs associated with loss or reduction in function in *ABCA7* are also associated with AD. *ABCA7* regulates the intracellular lipidome by exporting cholesterol and/or phospholipids out of the cell. We suggest impaired transport via *ABCA7* either directly or indirectly causes an accumulation of intracellular ceramides, hexosylceramide and lactosylceramide. These species are suggested to interact with the cell membrane, altering fluidity and in turn may increase the activity of beta-site APP cleaving enzyme to process amyloid precursor protein to produce extracellular amyloid plaques. Alternatively, ceramides may also contribute to increased apoptosis in the brain, similar to pathways detected in peripheral tissue.

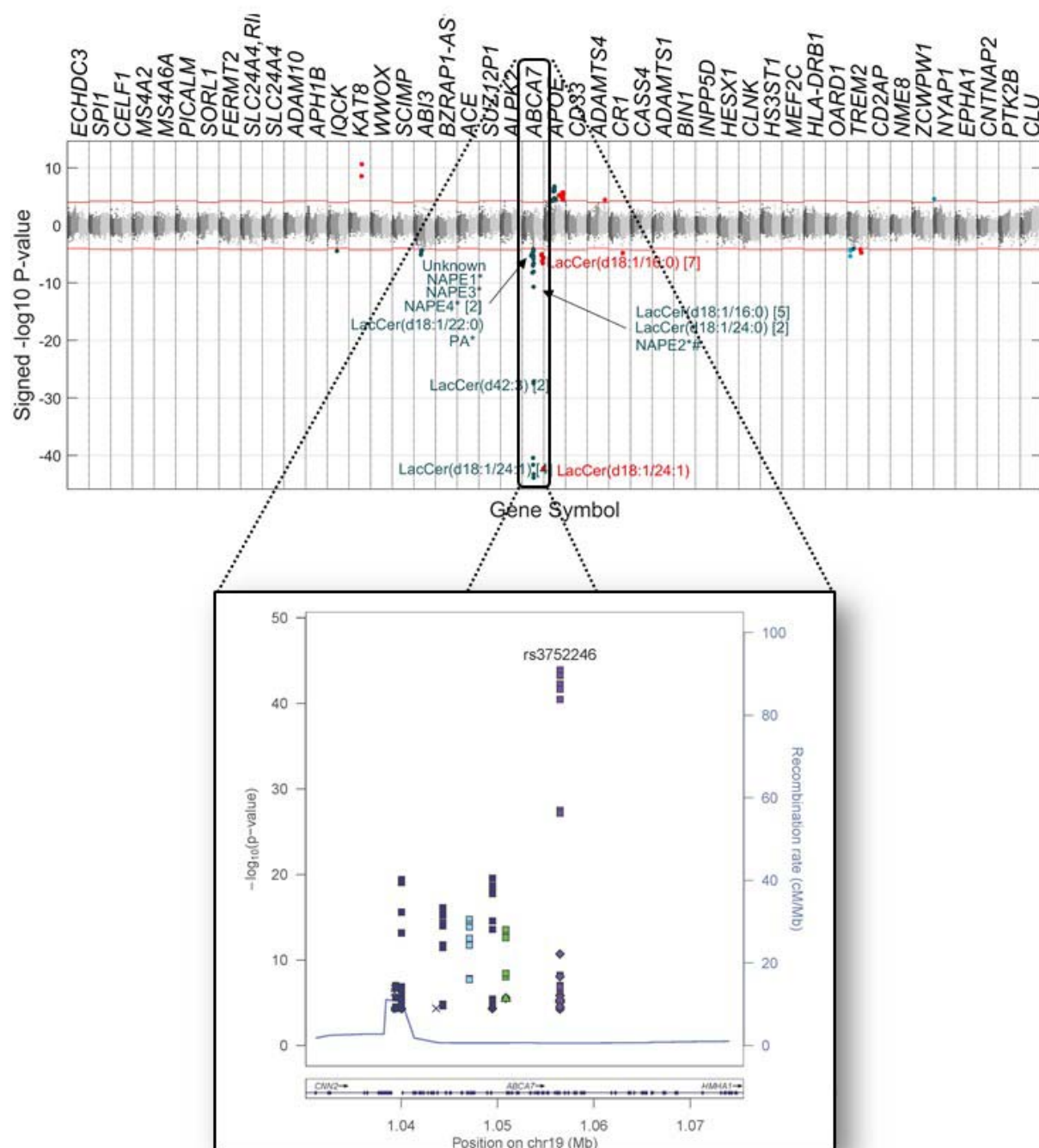

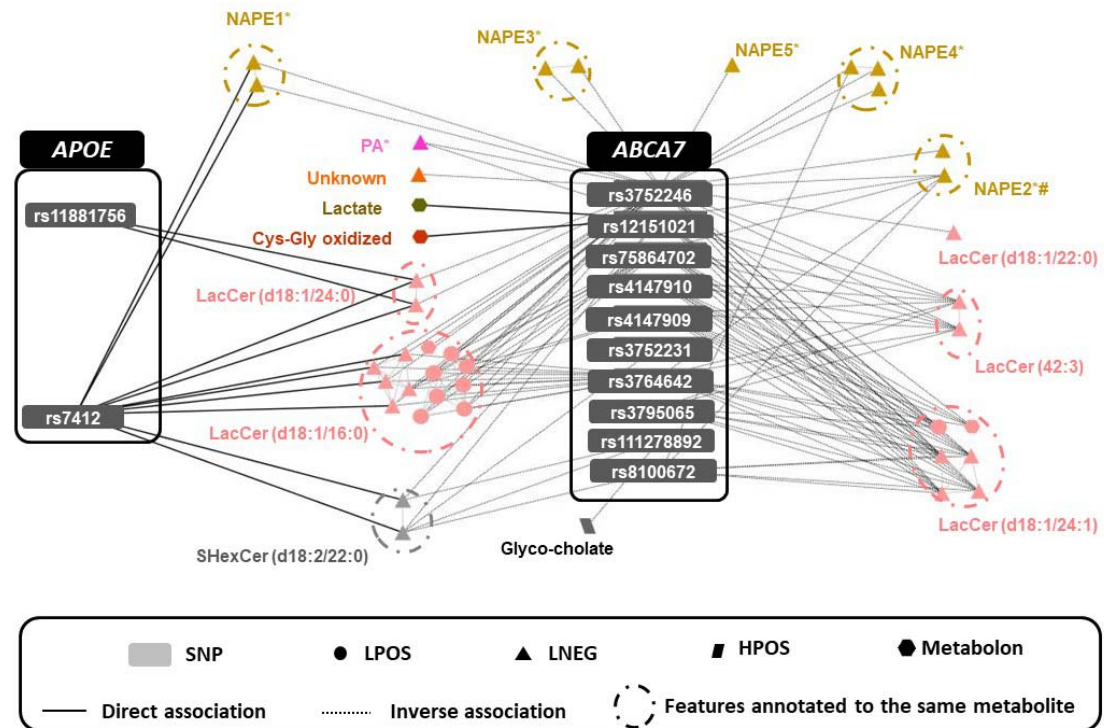
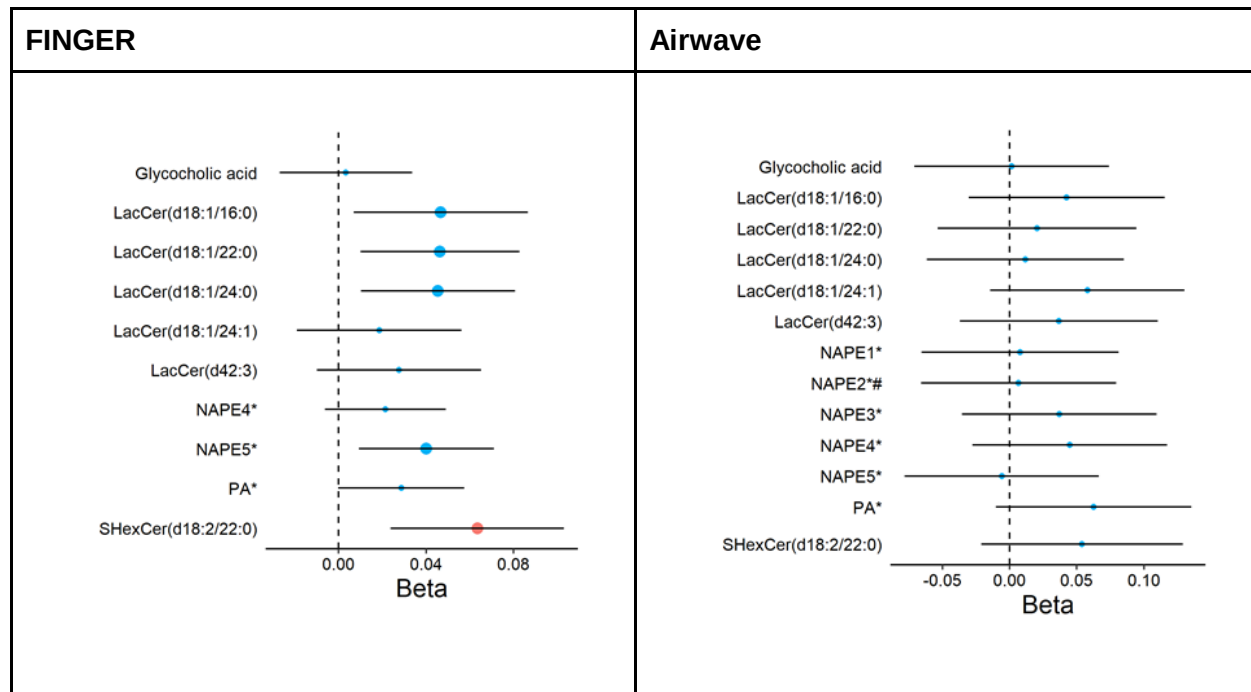

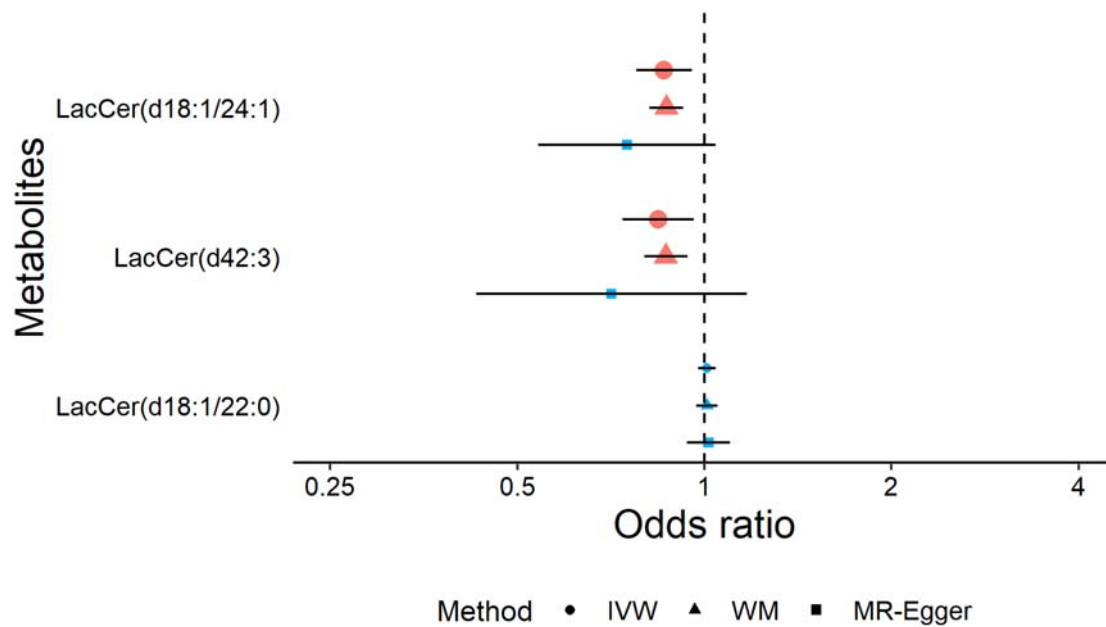

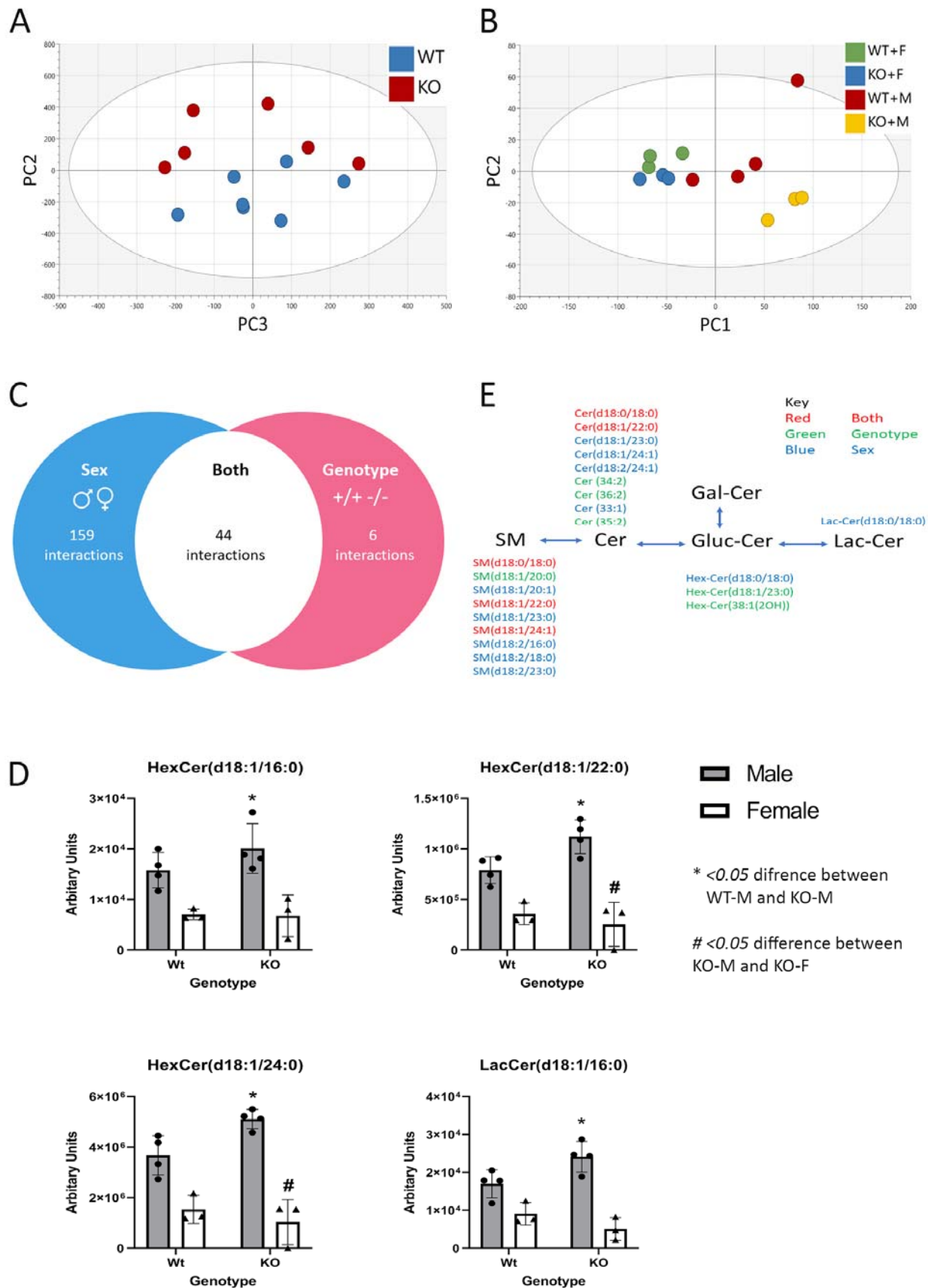
