Abstract

Coronavirus disease 2019 (COVID-19) was first diagnosed in Colombia from a traveler arriving from Italy on February 26, 2020. To date, available data on the origins and number or introductions of SARS-CoV-2 into the country are limited. Here, we sequenced SARS-CoV-2 from 43 clinical samples and—together with other 73 genomes sequences available from the country—we investigated the emergence and the routes of importation of COVID-19 into Colombia using epidemiological, historical air travel and phylogenetic observations. Our study provided evidence of multiple introductions, mostly from Europe, with at least 12 lineages being documented. Phylogenetic findings validated the lineage diversity, supported multiple importation events and the evolutionary relationship of epidemiologically-linked transmission chains. Our results reconstruct the early evolutionary history of SARS-CoV-2 in Colombia and highlight the advantages of genome sequencing to complement COVID-19 outbreak investigation.

Introduction

Coronavirus disease 2019 (COVID-19) is a life-threatening respiratory illness caused by SARS-CoV-2, an emerging zoonotic virus first identified in Wuhan city, Hubei province, China (1). The first confirmed cases of COVID-19 were reported on January 12, 2020, from patients presenting respiratory symptoms between December 8, 2019 and January 2, 2020 (2). Despite early containment and mitigation measures set in place (3), the high infectiousness, presymptomatic and prolonged transmission of SARS-CoV-2 (4,5) combined with other factors such as globalization, led to its rapid spread across the world.

Rigorous contact-tracing and physical distancing measures implemented in different countries have been demonstrated to be effective in delaying the epidemic during the contention phase (6–9). However, ensuing lockdowns and travel restrictions to minimize the healthcare burden has led to wellbeing decline and economic downturn, with profound impacts in low-to-middle income countries (10). The contention phase in Colombia started with the first case of COVID-19 confirmed by the Instituto Nacional de Salud (INS) on March 6, 2020, from a person returning from Italy on February 26, 2020 (11). On March 23, 2020, 314 cases had been confirmed which prompted the closure of all the country borders to contain the outbreak. “On March 31, 2020, more than 10% of confirmed cases were individuals with no known exposure to a patient with COVID-19, presumably due to extensive community transmission, and therefore the mitigation phase was declared with physical-distancing as the main strategy to further limit virus spread.” On June 18, 2020, 57,046 confirmed cases, and 1,864 deaths had been reported in Colombia (12).

The unprecedented global health and societal emergency posed by the COVID-19 pandemic urged data sharing and faster-than-ever outbreak research developments which are reflected in the fact that over 37,000 SARS-CoV-2 complete genomes have been made available through public databases, mainly GISAID (Global Initiative on Sharing All Influenza Data). SARS-CoV-2 is an RNA virus with an estimated substitution rate of around 0.8×10^{-3} to 1.1×10^{-3} substitutions/site/year (13,14) which means that it evolves fast as it is transmitted. The availability of SARS-CoV-2 genomes enable us to detect this fast generating variation and therefore genomic epidemiology is a powerful approach to characterize the outbreak (15). Genomic epidemiology which on phylogenetic analysis and has allowed researchers across the

world to ascertain SARS-CoV-2 emergence in humans, to reveal the importation and local transmission chains not detected by travel history and traditional contact-tracing strategies and, to trace the geographic spread and prevalence of strains bearing specific mutations of epidemiologic relevance (16–20).

Here we describe the complete genome sequencing of SARS-CoV-2 from 43 clinical samples together with the epidemiological investigation of imported cases and the phylogenetic findings using 122 genome sequences from Colombia, which characterize the epidemic onset of COVID-19 in the country. Our study suggests multiple independent introductions from across the world, mainly from Europe and the co-circulation of multiple lineages in the most affected departments. These findings contribute to the molecular surveillance of COVID-19 and provide venues for future outbreak response and interventions in the country.

Materials and methods

Sample preparation

Nasopharyngeal swabs samples from patients with clinical presentations of SARS-CoV-2 across the country were received at the Instituto Nacional de Salud (INS, National Institute of Health) as part of the virological surveillance of COVID-19. Diagnosing suspected cases of COVID-19 was performed by using the qRT-PCR protocol (21) recommended and transferred by the PAHO/WHO to the INS. Due to scarce resources, a total of 43 samples (Suppl Table 1) were selected for genome sequencing representing either the earliest documented samples per affected department (at least one sample from each department) or samples linked to transmission chains. Viral RNA extraction was performed by using the QIAamp Viral RNA Mini

kit (Qiagen Inc., Chatsworth, CA, USA) or the MagNA Pure LC nucleic acid extraction system (Roche Diagnostics GmbH, Mannheim, Germany).

Genomic library preparation and sequencing

Library preparation and sequencing were performed following the ARTIC network (real-time molecular epidemiology for outbreak response) protocol and using both Nanopore and Illumina technologies (22). Ten samples were processed using Oxford Nanopore Technologies (Oxford Nanopore Technologies, Oxford, UK). The remaining 33 samples were processed with the Nextera XT DNA library prep kit (Illumina, San Diego, CA, USA) and sequenced using the MiSeq reagent kit version 2 and the MiSeq instrument (Illumina, San Diego, CA, USA).

Genomic sequence assembly

Nanopore reads were basecalled using Guppy version 3.2.2 (Oxford Nanopore Technologies, Oxford, UK) and then demultiplexed and trimmed using Porechop version 0.3.2_pre (23). Processed reads were aligned against SARS-CoV-2 reference genome (GenBank NC_045512.2) using BWA-MEM (24). Single nucleotide variants were called with a depth of at least 200x and then polished consensus was generated using Nanopolish version 0.13.2 (25). MiSeq reads were demultiplexed and quality control was performed with a Q-score threshold of 30 using fastp (26). Processed reads were aligned against SARS-CoV-2 reference genome (GenBank NC_045512.2), single nucleotide variants were called with a depth of at least 100x and consensus genomes were generated using BWA-MEM version 0.7.17 (24) and BBMap (27).

Phylogenetic analysis of SARS-CoV-2 in Colombia

The SARS-CoV-2 genome sequences obtained in the present study and those from Colombia deposited in GISAID were collated (n=122) and combined with 1461 representative genome sequences from the South America-focused subsampling available from NextStrain (28) as of 20th May 2020 (Table S2) plus reference MN908947.3. The median value of sequences available per department was 1.5 (mean of 3.9 sequences, a max of 45 sequences were obtained from a single locality). The full genomic dataset was classified in lineages (29) using PANGOLIN (Phylogenetic Assignment of Named Global Outbreak LINEages) (30) and aligned with 10 iterative refinements using MAFFT (31). All the alignment positions flagged as problematic for phylogenetic inference were removed (e.g. highly homoplastic positions and 3' and 5' ends) (32). Maximum likelihood phylogenetic reconstruction was performed with the curated alignment and a HKY+ Γ 4 substitution model (33) using IQTREE (34). Branch support was estimated with an SH-like approximate likelihood ratio test (SH-aLRT)—a value greater than or equal to 0.75 was considered a high SH-aLRT (35). Six sequences from Colombia that showed inconsistent temporal signal with a clock analysis using TreeTime (36) were removed from further analysis. Time-scaled trees were inferred and rooted with least-squares criteria and the evolutionary rate of about 1.1×10^{-3} subs/site/year estimated by (13) using TreeTime (36) and LSD (37). The geographical locations (aggregated by continent except for Colombia) of the sequence data were considered as discrete states and used for migration inference—with transitions modeled as a time reversible process—in TreeTime (36). The number of state transitions into Colombia were interpreted as a proxy for the minimum number of introductions. In sensitivity analysis and in order to measure the effect of the SARS-CoV-2 uneven genomic representativeness across the world, two down sampling strategies datasets were implemented where, based on location, the sequences were randomly resampled 100 times and the

phylogenetic and migration inference was replicated. The downsampling strategies were as follows: (i) retaining a number of sequences per region (whenever possible) equal to the number of sequences available for Colombia and (ii) retaining 50 sequences per region and the total number of sequences from Colombia (this was the most even sampling per region for the South America-focused subsample).

Potential routes of COVID-19 importation in Colombia

The relative proportion of expected importations of COVID-19 by country to Colombia was inferred by taking into account SARS-CoV-2 incidence per international air passengers arriving in Colombia and the available flight travel. The number of international flights and number of passengers arriving to Colombia from January 1 to March 9, 2020 were obtained from the Special Administrative Unit of Civil Aeronautics of Colombia (Aerocivil, aerocivil.gov.co). The air travel data consists of direct flights from 14 countries to 7 main cities. COVID-19 incidence for each of the 14 countries with direct flights to Colombia was calculated using the number of confirmed cases reported by the World Health Organization—as of March 17, 2020, the date when travel restrictions started in Colombia (38)—and the total population for each country for 2019 reported in the United Nations World Population Prospects 2019 database (39) as in (40) (Appendix).

Results and discussion

Epidemiology investigation of introductions, contact-tracing and community transmission of SARS-CoV-2 in Colombia

In Colombia, preventive isolation and monitoring for passengers arriving from China, Italy, France, and Spain started on March 10, 2020. National health emergency was declared on

March 12 and tougher measures started to be set in place including the closing of borders (March 17) the ban of international (March 20) and domestic flights (March 25). Implementations of lockdowns occurred from March 25 onwards (Resolutions 380 and 385 from the Colombian Ministry of Health and Social Protection; Decree 412 and 457 from the Colombian Ministry of the Interior; Decree 439 from the Ministry of Transport). Despite massive drop in air traffic, more than 15.500 residents returned to Colombia through humanitarian flights during April and June (41).

As per June the first, over 30 thousand cases of COVID-19 had been documented in the country and 857 cases (2.8%) had been linked to travel abroad (Figure 1A). The majority of imported cases were symptomatic (n=816, 95.2%) and the most important geographical sources were Spain (n=245, 28.6%), the United States of America (n=203, 23.7%), Ecuador (n=50, 5.8%), Mexico (n=49, 5.7%) and Brazil (n=41, 4.8%). The 41 asymptomatic imported cases were detected through contact-tracing and the majority of these cases were imported from Spain (n=16, 39%), the United States (n=13, 31.7%), Brazil (n=3, 7.3%) and Mexico (n=2, 4.9%). Most of the symptomatic imported cases were traced back to European countries and then to countries in the Americas. The most important geographical sources in terms of imported cases were Spain (30.5%), the United States of America (25.2%), Mexico (6%), Ecuador (5.8%), and Brazil (5.1%). The number of symptomatic imported cases steadily increased and reached a peak on March 14, 2020, when local cases were on the rise and earlier than the closure of borders and ban of international air travel. Our estimate is based on the average incubation time of COVID-19 (42) and consequently 4.8 days earlier than peak based on symptoms onset (March 18, Figure 1B). The first introductions were predominantly linked to Europe, however, both Europe and the American region were important geographical sources of infections during the onset of the

epidemic. The introductions post-peak occurred for the most part from South American countries.

SARS-CoV-2 diversity in Colombia

In order to gain a better understanding of the dynamics of SARS-CoV-2 spread into Colombia, 43 whole genome sequences obtained in the present study were combined with sequences from Colombia deposited in GISAID, resulting in a set of 122 complete genomes. Sequences from Colombia were classified in a total of 12 sublineages: A.1.2, A.2, A.5, B, B.1, B.1.1, B.1.3, B.1.5, B.1.8, B.1.11, B.2, and B.2.5. The proportion of lineages documented in Colombia seems to reflect founder effects, for example, sublineages B.1, B.1.1, and B.1.5 were found in the early epidemiologically-linked transmission chains and, consistently, the most frequently observed lineages in the genome sequence data from Colombia were B.1 (n= 59, 48.4%), B.1.5 (n=31, 25.4%) and B.1.1 (n=16, 13.1%) (Figure 2A). Comparable findings were observed for other South American countries (43–45) from the South America-focused subsampling available from NextStrain, where the most frequently observed lineages were B.1 (n= 149, 60.8%), B.1.5 (n=33, 13.5%) and A.5 (n=14, 5.7%). Colombia is divided into 32 departments and the genome sequence data covered the 20 affected departments (up to date) and the capital district. The median value of available sequences per department was 1.5 (mean of 3.9 sequences, a max of 45 sequences were obtained from a single locality). Consequently, on average, one single lineage was identified by department. For instance, the number of documented lineages was highly correlated with the availability of samples (Pearson's product-moment correlation of 0.72, p -value<0.001) and uncorrelated with the number of local cases (Pearson's product-moment correlation of 0.35, p -value=0.049). Five different lineages were

documented in the departments of Valle del Cauca and Antioquia and three different lineages were documented in Cundinamarca which are the departments with a higher number of samples (Figure 2B) and whose capitals are the most populated. A moderate positive correlation was observed between the number of lineages documented in a department and the number of imported cases (Pearson's product-moment correlation 0.51, p -value = 0.002).

Molecular evolution of SARS-CoV-2 in Colombia

A total of 133 nucleotide variants (NVs) were identified using the full genome sequences from Colombia and the reference NC_045512.2. The majority ($n=131$) of the NVs fell in the coding region (one NV was identified at each non-coding end). A total of 71 (54,2%) of the NVs in coding sites led to non-synonymous substitutions. Most of the NVs (92 out of 133) were unique to a sequence and among the shared NVs, 38 (out of 41) were associated with a specific lineage (Tables S3 and S4). These observations suggest that the substitutions are not laboratory-specific and most likely the outcome of *in-situ* evolution and/or shared ancestry (Appendix).

In our study, 90% sequences from Colombia displayed amino acid change D614G (108 of a total 120 Colombian sequences covered the region), while the remaining 10% (12 sequences) displayed the D614 (Table S4). G614 has been associated with higher infectivity (46) and greater transmissibility (47) with no effects on disease severity outcomes (48). All G614 sequences also carried mutations that segregate together as described in (47): at the 5'UTR we identified the nucleotide substitution C241T, at the ORF1ab (Nsp3 encoding-gene) the synonymous substitution C3037T and at the ORF1ab (RdRp encoding-gene) the amino acid

change P4715L position. The presence of these and other mutations warrant further monitoring because they can be phenotypically and epidemiologically relevant.

Most of the patients (n=90) from Colombia for whom genomic sequences were available were symptomatic (59.6% with cough and fever and the remaining with at least one of these two symptoms) and (n=10) of them died (70% presented comorbidities) (Table S1). However, given the limited number of available genomic sequences, it was not possible to reliably investigate any genetic determinant of clinical outcome.

Evolutionary relationships between local and global SARS-CoV-2 isolates

The time-stamped phylogeny of 122 isolates of Colombia and 1462 representative global SARS-CoV-2 isolates (Figure 3A) showed that the estimated time to the most recent common ancestor for the sampled sequence data is December 7, 2019 (October 25 - December 26). Asia was the inferred ancestral state at the root. Both these observations are in line with the known epidemiology of the pandemic. A root-to-tip regression of genetic distance against sampling time evidenced consistent temporal signal in the sequence data (Figure 3B). The isolates from Colombia appeared intersperse among the isolates from other countries (Figure 3A and 3C) suggesting multiple introductions. However, there was considerable phylogenetic uncertainty along the tree and the fine-grained relationships of the isolates from Colombia could not be resolved with confidence (Figure S1). Phylogenetic uncertainty together with uneven sampling made the quantification of the number of introductions into the country challenging, let alone dating the time of the introductions. The number of state transitions into Colombia (Figure 4A) heavily relies on the number and nature of the sequences that are included from other locations. Using all sequences in the South America-focused subsampling available from NextStrain, we

estimated that on average 64 (IQ 62-67) introductions have occurred into the country but this estimate gets lower as we reduce the number of samples (sensitivity analyses) from other locations (down to 22 with the most even down-sampled dataset). Independently of the dataset (either the complete or the subsampled datasets) and in line with the epidemiological information, most of the geographical source attributions of the introductions are attributed to Europe (Figure 4B and Figure S2). This observation is also in agreement with our estimates using travel data as detailed below (Figure 4C and Figure S2).

Between January and March 2020, 7 cities of Colombia received 1,593,211 international passengers from 14 countries. Bogotá concentrated the majority of the flights with around 77% of the passengers, followed by Medellín with 11%, Cartagena with 6%, and Cali with 4%. In total, 35% of international passengers started their journey in the USA, 17% in Mexico, and 12% in Chile. However, we estimate that 87% of all imported COVID-19 cases came from Europe, 9.5% from North America, and 3.4% from South America. When stratified by country, the primary source of importation was Spain with 71.4% (Figure S2).of the cases, followed by the USA with 8.4%, Germany with 8%, and France with 3.4% 65.2% of the COVID-19 cases were expected to arrive at Bogotá, followed by Medellín with 20% and Cali with 9%. We estimate that the route Spain-Bogotá carried 42% of the total imported cases.

Since the first introduction of SARS-CoV-2 in Colombia (February 26, 2020) contact-tracing efforts had been set in place. Multiple sequences were obtained from seven distinct early epidemiologically-linked transmission chains (Table S1). This information was mapped into the phylogeny (Figure 3C) and all but one set of sequences did not group. However, it appeared very close in the tree. This underscores the potential utility of genomic epidemiology to link

individuals with incomplete information (e.g. cases that end-up disconnected due to intermediate asymptomatic carriers) and complement outbreak transmission.

This study has some limitations. Firstly, the geographical sources of infection relied on people to self-report their own symptoms onset and travel history, which is subject to inaccuracies. Secondly, we use air travel data from important destinations in Colombia but other locations may also have fueled COVID-19 emergence and dissemination in the country; flight travel data was not available from March 9, 2020, onwards. Thirdly, the number of sequences sampled represented a tiny fraction of the documented number of imported cases into Colombia; the sample was selected to be a country-wide representative given limited resources for genome sequencing and consequently, the introduced viral diversity may also have been underestimated. Another limitation of this analysis is the inherent uncertainty stemming from global unsystematic sampling. Therefore, the inferences about the number of introductions and the corresponding geographical source need to be interpreted with caution. We attempted to overcome this by undertaking sensitivity analyses and contrasting the results with the available epidemiological data and our estimates from travel data. However, more sequence data from Colombia and undersampled countries together with information of sampling representativeness per country is needed in order to account for sampling uncertainty in a more statistically rigorous manner.

Our study provided evidence that an important number of independent introductions occurred to Colombia with at least 12 lineages documented. Most of the notified introductions to Latin American countries occurred from Europe and this observation was supported by phylogenetic and air travel data (49,50). Although the sequence data do not represent the actual number of epidemiologically-linked transmission chains, our phylogenetic findings validated the

linkage for those epidemiologically-linked transmission chains with available sequence data. Our results further underscore the advantages of genome sequencing to complement COVID-19 outbreak investigation and support the need for a more comprehensive country-wide study of the epidemiology and spread of SARS-CoV-2 in Colombia.

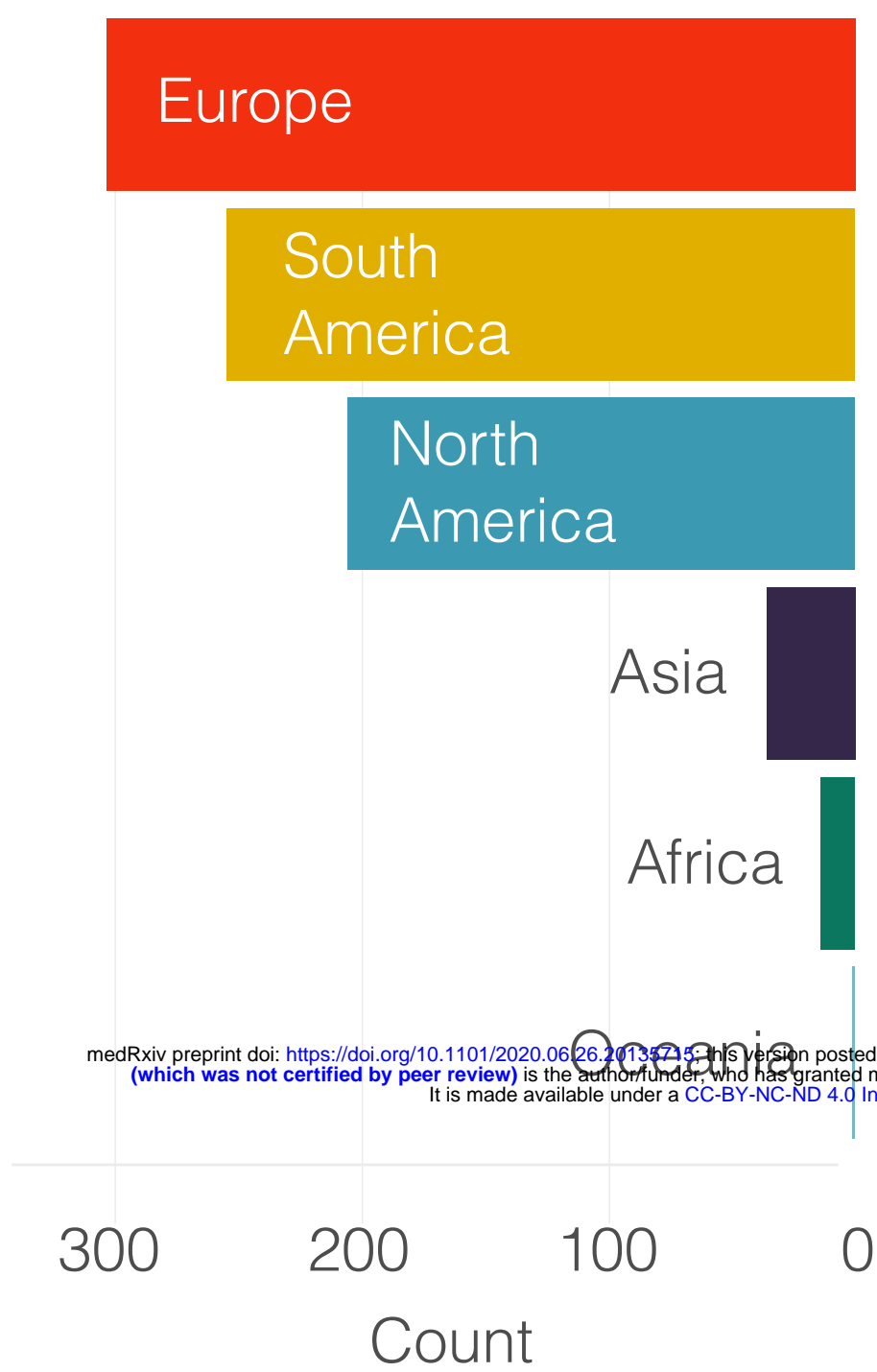
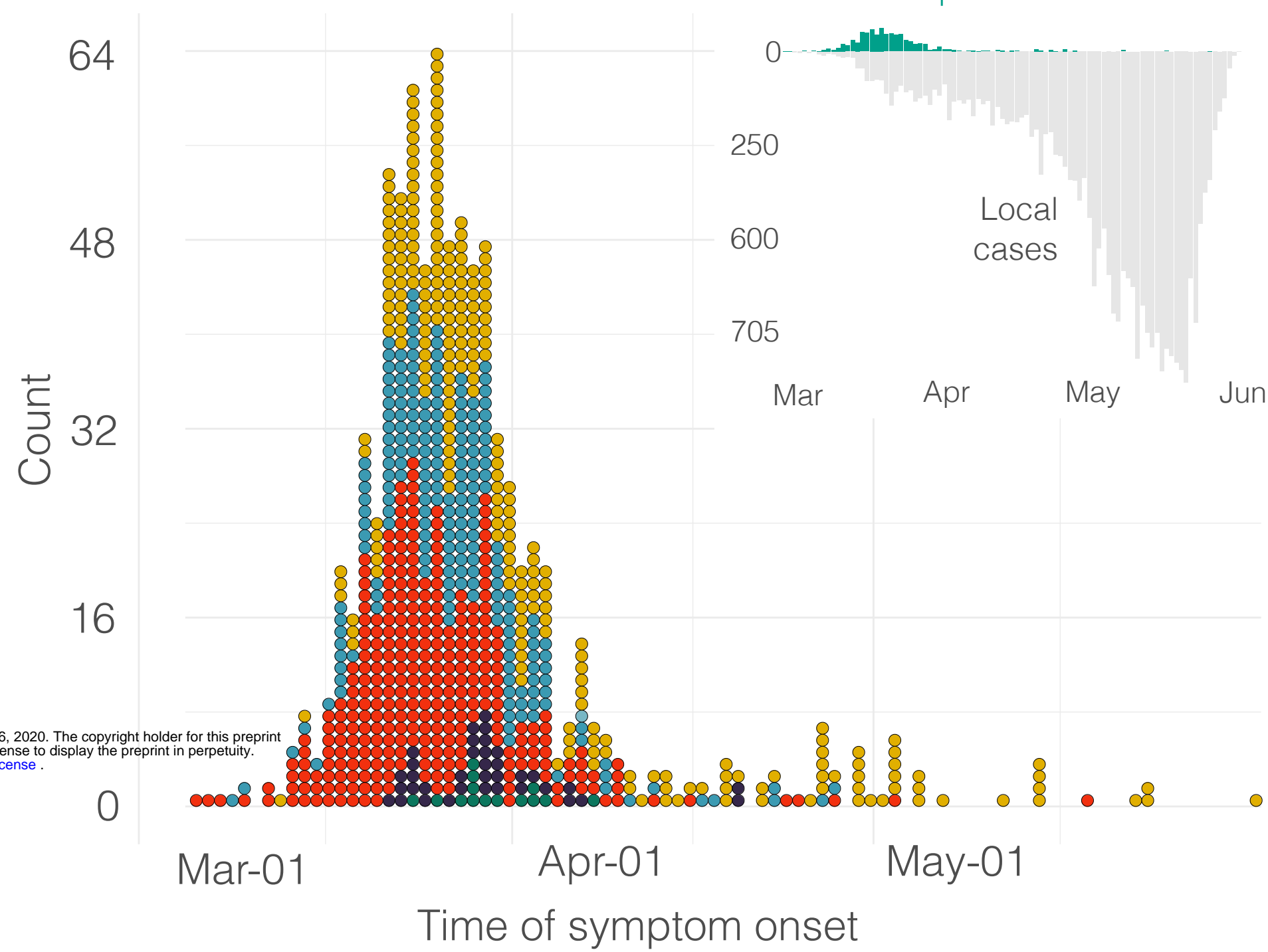
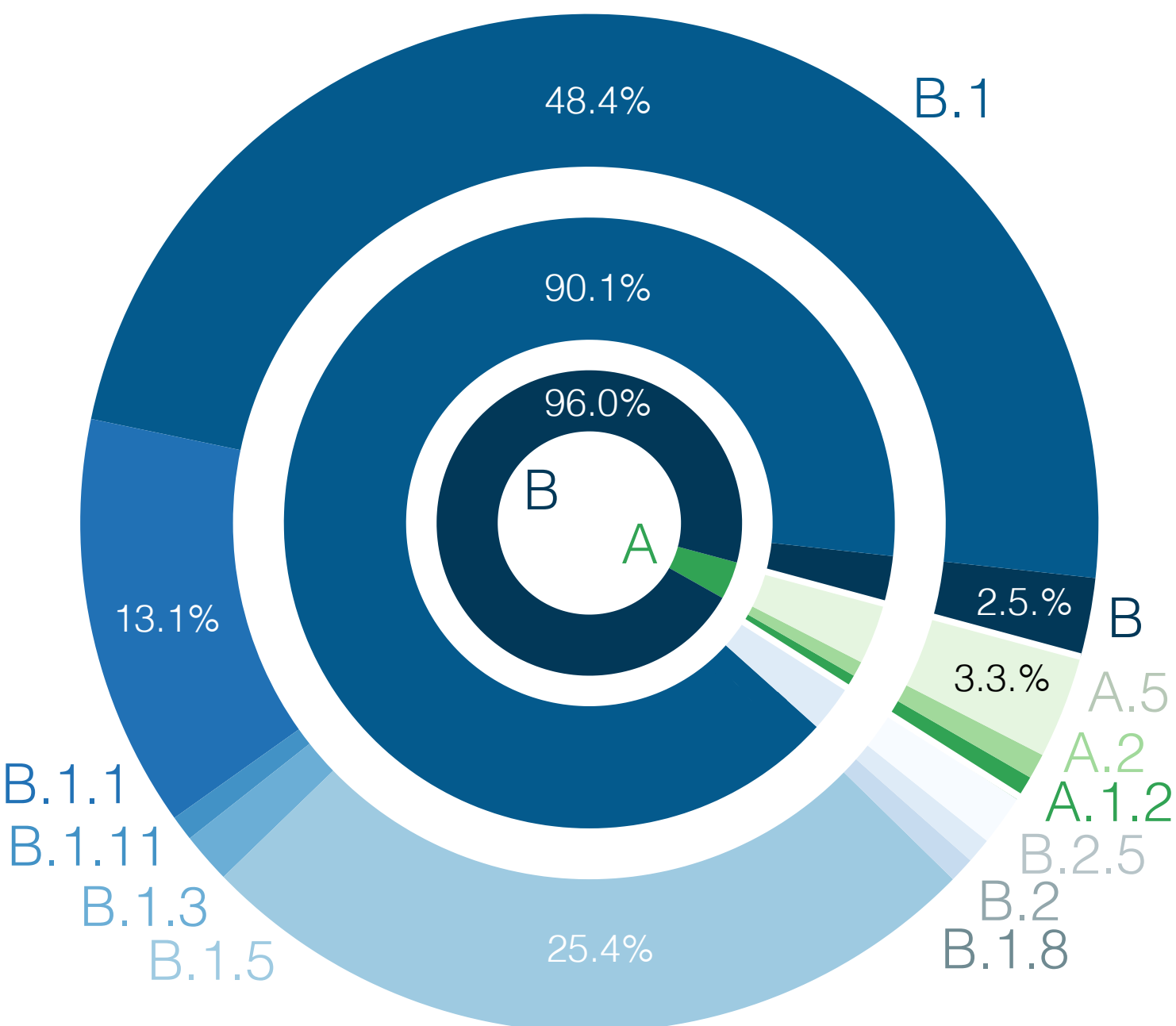
