# Title: Long-term Exposures to Air Pollutants Affect FeNO in Children: A Longitudinal Study

### 29 ABSTRACT

- Fractional exhaled nitric oxide (FeNO) is a marker of airway inflammation shown to be
- responsive to short-term air pollution exposures; however, effects of long-term exposures are
- uncertain. Using longitudinal assessments of FeNO and air pollutant exposures, we aimed to
- determine whether FeNO is a marker for chronic effects of air pollution exposures after
- 34 accounting for short-term exposures effects.
- 35
- FeNO was assessed up to six times 2004-2012 in 3607 schoolchildren from 12 communities in
- 37 the Southern California Children's Health Study. Within-community long-term ambient air
- pollution exposures ( $PM_{2.5}$ ,  $PM_{10}$ ,  $NO_2$ ,  $O_3$ ) were represented by differences between
- 39 community-specific annual averages and the eight-year average spanning the study period.
- 40 Linear mixed-effect models estimated within-participant associations of annual average air
- 41 pollution with current FeNO, controlling for previous FeNO, prior seven-day average pollution,
- 42 potential confounders, and community-level random intercepts. We considered effect
- 43 modification by sex, ethnicity, asthma, and allergy at baseline.
- 44
- 45 We found FeNO was positively associated with annual average air pollution, after accounting for
- 46 short-term exposures. One standard deviation higher annual  $PM_{2.5}$  and  $NO_2$  exposures ( $PM_{2.5}$ :2.0
- 47  $\mu$ g/m<sup>3</sup>; NO<sub>2</sub>:2.7 ppb) were associated, respectively, with 4.6% (95%CI:2.3%-6.8%) and 6.5%
- 48 (95%CI:4.1%-8.9%) higher FeNO. These associations were larger among females. We found
- 49 little evidence supporting association with  $PM_{10}$  or  $O_3$ .
- 50
- 51 Annual average PM<sub>2.5</sub> and NO<sub>2</sub> levels were associated with FeNO in schoolchildren, adding new
- 52 evidence that long-term exposure affects FeNO beyond the well-documented short-term effects.
- 53 Longitudinal FeNO measurements may be useful as an early marker of chronic respiratory
- $_{54}$  effects of long-term  $PM_{2.5}$  and  $NO_2$  exposures in children.

# 56 Key messages

- We show strong evidence that long-term exposures to air pollutants affect FeNO, independent of the well-documented associations with short-term exposures to air
- independent of the well-documented associations with short-term exposures to airpollution
  - Longitudinal FeNO measurements may be useful as an early marker of chronic respiratory effects of long-term air pollution exposures in children.

### 83 INTRODUCTION

84 Breathing polluted air has a multitude of impacts on human health, many of which are thought to

- be driven by inflammatory mechanisms. The primary route of exposure is inhalation, thus the
- respiratory system is a major target organ for toxic effects as it receives the largest dose. The
- 87 fractional concentration of exhaled nitric oxide (FeNO) is a marker of airway inflammation
- 88 which has been shown to be useful for the assessment of acute respiratory effects of short-term  $\frac{1}{2}$
- exposure (hours to weeks) to ambient air pollutants,  $^{1-3}$  including particulate matter with an
- aerodynamic diameter of 2.5 or 10  $\mu$ m or less (PM<sub>2.5</sub> and PM<sub>10</sub>, respectively), black smoke,
- 91 elemental carbon (EC), nitrogen dioxide (NO<sub>2</sub>), and ultrafine particles. In the Southern

- 96 Currently, there is limited and inconsistent evidence for effects of longer-term air pollution
- 97 exposures on FeNO. For example, a number of cross-sectional studies have related FeNO to
- 98 either location-based proxies for long-term exposures to traffic/industrial activity or long-term
- 99 (seasonal to annual average) ambient pollution. Some of these studies found significant positive
- 100 associations<sup>5-7</sup> (two with adjustment for short-term exposures<sup>8, 9</sup>) but others did not.<sup>10-15</sup> An early
- analysis of CHS data over a short follow-up period is one of the few studies to date relating
- 102 longitudinally assessed FeNO to long-term ambient air pollution exposures. Using two
- assessments of FeNO approximately one year apart in ~1200 schoolchildren, we found that
- 104 increased annual average  $PM_{2.5}$  or  $NO_2$  was associated with increased within-participant FeNO,
- after adjusting for short-term exposures (in the prior week).<sup>16</sup>

- 107 We hypothesize that FeNO is affected by both long-term and short-term exposures to ambient air
- pollution. In this study, the estimand of interest is long-term ambient air pollution exposure
   effect, and short-term exposure is treated as nuisance parameter. We examined the full
- longitudinal CHS data—which includes up to six repeated FeNO assessments in more than 3000
- schoolchildren—to investigate whether long-term (i.e., annual average) ambient air pollution
- exposures are associated with within-participant changes in FeNO, after accounting for short-
- 112 term (i.e., weekly average) exposures.

# 115 MATERIAL AND METHODS

## 116 Study Population

- Participants in this study were part of the most recent southern California Children's Health 117 Study (CHS) cohort, which started enrollment in 2002-2003 from kindergarten and first grade 118 classrooms. Detailed information on study design, participant recruitment, and data collection 119 has been reported previously.<sup>17</sup> This analysis includes 3607 school children aged 6-17 years from 120 12 communities in Southern California, who had FeNO assessed up to 6 times in approximately 121 annual visits from 2004-2005 through 2011-2012. Ethical approval of the protocol was obtained 122 from the University of Southern California institutional review board (approval # HS-13-00150, 123 continuing review date April 17, 2019). Informed assent was obtained for each child, and 124 informed consent from a parent or guardian. The research protocol was reviewed and approved 125
- by the University of Southern California Health Campus Institutional Review Board.

# 128 FeNO measurement

FeNO was measured at schools following the American Thoracic Society (ATS) guidelines using 129 130 an offline technique at the first two visits (2004-2005 and 2005-2006 school years) and online technique in the subsequent four visits. For offline measurement, breath was collected in 131 132 aluminized Mylar bags using commercial breath sampling kits (Sievers Division, GE Analytical Instruments, Boulder, Colorado, USA). Each child took 2-3 initial deep breaths through the kit's 133 NO scrubber followed by a near-vital-capacity breath and immediate controlled exhalation 134 through the sampling kit. The collected bag samples were measured in central laboratory for 135 FeNO level at targeted 100 ml/sec flow rate using a standard chemiluminescent analyzer system 136 (Sievers Division). For online measurement, FeNO was measured directly using EcoMedics 137 CLD-88-SP analyzers with DeNOx accessories to provide NO-free inhaled air (EcoPhysics Inc, 138 Ann Arbor, MI, USA/Duernten, Switzerland). Each child was asked to provide at least three 139 maneuvers at the target 50 ml/sec flow rate. The plateau concentration for each maneuver was 140 taken from the 3 second plateau with the minimum NO coefficient of variation. FeNO was 141 represented by the mean of two or three ATS acceptable plateaus that differed by less than 15% 142 or 1 ppb where all ATS acceptable plateaus were less than 10 ppb. Offline FeNO data were 143 converted to estimates of FeNO as would be measured online at 50 ml/sec expiratory flow. The 144 145 conversion was performed using a statistical model determined in the post hoc comparison study, which involved 362 children measured on and off line in the same testing session. We exclude 146

- observations with reported use of inhaled corticosteroids. Details of FeNO data collection, 147
- quality control, and conversion procedures have been reported previously.<sup>18-20</sup> 148

#### **Air Pollution Data** 150

Daily 24-hour average PM<sub>2.5</sub>, PM<sub>10</sub>, NO<sub>2</sub>, O<sub>3</sub> (10am-6pm only), and temperature data were 151

obtained for the study period from central monitoring sites in each community operated by local 152

air pollution agencies in conformance with US Environmental Protection Agency (EPA) 153

- 154 requirements. For each pollutant, community-specific study period averages were computed (a
- seven-year average, from 2004/05-2011/12). For each pollutant and each participants' FeNO test 155
- date, annual average pollution was calculated based on the 12 months preceding the test date in 156
- 157 that participant's community. Weekly averages were calculated based on the 7 days preceding
- the test date. Air pollution data was interpolated to fill in data gaps on days with missing 158
- exposure using modeled predictions based on data from nearby monitors. While such processes 159
- could be potential sources of bias, previous sensitivity analyses on CHS data that limited use to 160
- complete data have not altered main study findings.<sup>4</sup> The primary "long-term" exposure of 161 interest for this study was the annual within-community fluctuation, defined as the difference
- 162
- between annual averages and the seven year average concentration for each community. We 163
- refer to seven day average as "short-term" exposures hereafter. 164
- 165

#### **Other Covariates** 166

- 167 Race/ethnicity, medication use, current wheeze status, exposure to secondhand tobacco smoke
- (SHS), asthma history, and allergy history were determined from annual self-administered 168
- questionnaires. Questionnaires were completed by parents from baseline to year 2006-2007, and 169
- by children from follow-up year 2007-2008 onwards. Questionnaires were collected at the school 170
- visit during which the child's FeNO test was performed. Ambient air nitric oxide was measured 171
- at the time of FeNO collection. Trained technicians measured height and weight at every FeNO 172
- 173 test date following a standardized protocol. Age- and sex-specific body mass index (BMI)

174 percentiles were calculated based on the Centers for Disease Control and Prevention BMI growth

- charts<sup>21</sup>. 175
- 176

#### 177 **Statistical Analysis**

FeNO had a right-skewed distribution, so we used geometric mean and geometric standard 178

- deviation to quantify central tendency and dispersion and performed all analyses with natural 179
- log-transformed FeNO. In descriptive data analyses, we summarized the characteristics of the 180
- study participants, compared the distribution of baseline year log FeNO by these characteristics, 181
- and also summarized the distribution of the community-specific seven-year pollutant averages 182
- and the annual within-community fluctuations. We also calculated Pearson correlation 183
- coefficients of annual within-community fluctuations between pairs of pollutants. 184
- 185
- 186 We estimated linear mixed effect models to examine the association of log FeNO with annual
- 187 within-community fluctuations in air pollution, adjusting for short-term exposures, confounders,
- and design variables as well as log FeNO at the previous visit. More details on the model 188
- specification could be found in the Supplementary appendix. Potential confounders included sex, 189
- 190 race/ethnicity, and respiratory allergy at baseline, as well as time-varying measures of asthma
- status, medication use, current wheeze, secondhand tobacco smoke exposure, recent respiratory 191
- illness, concurrent room air nitric oxide, month of FeNO test, and average temperature in the 192
- 193 week preceding the FeNO test. To assess confounding, we used the analytic change-in-estimate
- $(\geq 10\%)$  criterion. We also evaluated whether long-term exposure associations were modified by: 194 baseline asthma, baseline allergy, sex, and ethnicity. In sensitivity analyses, the final models
- 195 were refitted by: (a) removing the five communities which contributed to only the first four (of 196
- six) FeNO visits, (b) removing one community at a time, (c) adding a community-level random 197
- slope on long-term exposure to investigate potential heterogeneity by community, (d) subsetting 198
- 199 to only online FeNO collection (the last four of the six visits), or (e) accounting for the serial
- correlation of FeNO observations from same participant by using an autoregressive within-200
- participant level random component instead of controlling for previous visit log FeNO. In all 201
- models, missing data were assumed to be missing at random. All analyses were conducted using 202
- the statistical package R version  $3.5.1^{22}$ . Hypothesis tests were performed under a 0.05 203
- significance level and a two-sided alternative. 204

#### 206 RESULTS

The 3607 children, with mean age 9 at baseline, were evenly distributed by sex (male: 49.7%), 207 primarily Hispanic (56.3%) or non-Hispanic White (33.2%), 41.5% had allergies, 15.1% had 208

- asthma, and 3% had reported a recent respiratory illness (Table 1). At baseline, the geometric 209
- mean FeNO was 12.1 ppb (geometric SD: 1.9 ppb) and baseline FeNO was statistically
- 210 significantly associated with most participant characteristics. Specifically, boys on average had 211
- 212 significantly higher FeNO than girls (p-value=0.015). FeNO differed by race/ethnicity (p-value
- <0.001), with African American children having higher FeNO than the other race/ethnicity 213
- groups. Children with respiratory conditions, such as asthma, wheeze, allergy, and recent 214
- 215 respiratory illness, had statistically significantly higher FeNO than those without (p-values all
- <0.001). FeNO was positively associated with age and height (p-value <0.001), but not BMI (p-216
- 217 value=0.831). FeNO varied by month of collection (p-value<0.001), with the lowest geometric
- 218 means in cooler months (December – March).

- 225 Community-specific seven-year average air pollution concentrations ranged approximately two
- to three-fold across the 12 communities (Table 2). Most communities experienced a downward
- trend in annual average  $PM_{2.5}$  and  $NO_2$  over the study period (Figure 1), which was a major
- source of variation in the annual within-community fluctuations for these pollutants. The
- standard deviation of annual within-community fluctuations was  $2.0 \ \mu g/m^3$  for PM<sub>2.5</sub>, 6.7
- $\mu g/m^3$  for PM<sub>10</sub>, 2.7 ppb for NO<sub>2</sub>, and 2.5 ppb for O<sub>3</sub> (Table 2). As shown in Table 3, PM<sub>2.5</sub> and
- PM<sub>10</sub> had the highest correlation in seven-year averages across-communities (Pearson's R=0.81), while PM<sub>2.5</sub> and NO<sub>2</sub> had the largest correlation in annual within-community fluctuations
- (Pearson's R=0.64) and annual within-community fluctuations of  $O_3$  were negatively correlated
- with the other pollutants. Log FeNO was correlated with log FeNO at the previous visit
- (Pearson's R=0.65), indicating moderately strong first order autocorrelation.

- Long-term exposures to PM<sub>2.5</sub> and NO<sub>2</sub> were positively associated with within-person changes in
- FeNO, after adjustment for covariates and short-term exposure (Table 4). A one SD ( $2.0 \ \mu g/m^3$ )
- increase in the annual within-community fluctuation of PM<sub>2.5</sub> was associated with a 4.6% within-
- participant increase in FeNO (95% CI: 2.3%-6.8%), controlling for covariates including FeNO at
- the previous visit and seven-day average  $PM_{2.5}$ . Similarly, a one SD (2.7 ppb) increase in the
- annual within-community fluctuation of NO<sub>2</sub> was associated with a 6.5% within-participant
- increase in FeNO (95% CI: 4.1%-8.9%), controlling for covariates. We found no evidence for an
- association of long-term  $PM_{10}$  and FeNO. Long-term  $O_3$  was negatively associated with FeNO in
- the primary analysis, but this association was attenuated and no longer statistically significant in
- sensitivity analyses (Tables 1S and 2S). All models were adjusted for sex, race, respiratory
- allergy, asthma, medication use, wheeze, secondhand tobacco smoking, recent respiratory illness,
- room air nitric oxide, month, temperature, and short-term exposure of air pollution.

267 There was evidence that the associations of long-term  $PM_{2.5}$  and  $NO_2$  with FeNO varied by sex,

with larger estimated associations in females (interaction p-values: 0.007 for PM<sub>2.5</sub> and 0.066 for

NO<sub>2</sub>) (Table 5). In sensitivity analyses (Supplementary Table 1), we still observed statistically

significant positive associations of long-term  $PM_{2.5}$  and  $NO_2$  with FeNO after: (a) removing the

five communities followed only through four years, (b) removing one community at a time

272 (Supplementary Table 2), and (c) taking out the adjustment for short-term air pollution, though

273 we did observe some heterogeneity in the associations.

### 278 **DISCUSSION**

In a large, prospective cohort study of schoolchildren in 12 Southern California communities, we

found statistically significant positive associations of FeNO—assessed longitudinally over an

eight-year period—with within-community fluctuations in annual average PM<sub>2.5</sub> and NO<sub>2</sub> after

adjusting for prior week exposure, previous visit FeNO, and confounders. This provides the

strong evidence that long-term exposures to air pollutants affect FeNO, independent of the well-

documented associations with short-term exposures to air pollution.

285 Results of this longitudinal study (using all six FeNO visits in the CHS) are consistent with a

preliminary longitudinal analysis of CHS data (using only the first two online FeNO

assessments),<sup>16</sup> which had found *within-participant* associations of long-term PM<sub>2.5</sub> and NO<sub>2</sub>

(but not  $PM_{10}$  or  $O_3$ ) with FeNO while adjusting for short-term exposure. The preliminary CHS

- study had targeted within-participant changes in FeNO using a different but complementary
- statistical approach in which the change in FeNO was modeled as a function of the change in
- annual average air pollution.<sup>16</sup> When studying FeNO, it is important to consider within-
- 292 participant changes over time from longitudinally collected data, given the considerable
- unexplained across-participant heterogeneity in FeNO typically observed in cross-sectional
- studies (e.g.,  $R^2 < 0.3$ ).<sup>23</sup> Indeed, in our data we observed moderately strong autocorrelation in

295 FeNO indicating relatively stable within-person FeNO. As an additional example, in 158 296 asthmatic adults, the intraclass correlation of FeNO over one year was 0.73, with low baseline FeNO tending to stay low and higher baseline FeNO tending to stay high, but with more 297 variability.<sup>24</sup> To our knowledge, the only other study relating longitudinally assessed FeNO to 298 long-term air pollution exposures found positive but non-statistically-significant associations of 299 300 FeNO (measured twice over six months in 130 children) with seasonal black carbon levels at 301 subjects' residence (estimated by land-use regression), even after adjusting for short-term exposures (2 hour, 24 hour, or 7 day average black carbon from central site monitors).<sup>25</sup> This 302 study's statistical analysis did not fully target within-participant associations since it used linear 303 304 mixed models with a participant-level random intercept but did not decompose time-varying exposures (X<sub>ii</sub>) into within- and between-person terms (i.e.,  $X_{ii}$ - $\overline{X}_i$ . and  $\overline{X}_i$ .).<sup>26</sup> 305 A number of cross-sectional studies have related FeNO to long-term (seasonal to annual average) 306 ambient pollution or location-based proxies for long-term exposures to traffic/industrial activity. 307 By design, these studies can estimate only between-participant associations of exposures with 308 FeNO and hence are subject to the limitations of this approach. Some cross-sectional studies 309 provide evidence supporting long-term exposure effects. In 241 healthy, full-term infants, 310 311 prenatal average NO<sub>2</sub> from a central monitoring site was associated with increased FeNO measured during sleep at five weeks of age, even after adjusting for mean  $NO_2$  in the 2 days 312 prior to the FeNO test or residential distance to major road.<sup>9</sup> Two studies relating FeNO to 313 314 proximity to industrial activity found FeNO to be elevated in children living closer to oil refinery/petrochemical activity<sup>6</sup> and in children attending schools closer to a steel mill,<sup>7</sup> though 315 neither study adjusted for short-term air pollution exposures. Three studies<sup>5, 8, 27</sup> found a similar 316 magnitude positive association between a proxy measure for traffic exposure (length of road in a 317 318 circular buffer around the home), with the strongest associations for the smallest buffers around the home. While the length of road traffic exposure proxy likely represents both long- and short-319 320 term exposures, one of these studies adjusted for short-term exposure (central site 24 hour average ambient pollution) and found the length of road association to be robust to the 321 adjustment.<sup>8</sup> suggesting a long-term exposure effect. Other cross-sectional studies have found no 322 evidence for long-term exposure effects, perhaps due to exposure metrics relying on spatial 323 variation which are not sensitive to traffic sources on smaller, local roads (e.g., land-use 324 regression predicted seasonal or annual averages,<sup>14, 15, 25</sup> traffic counts,<sup>10, 13</sup> or distance to major 325 road<sup>11, 13</sup>) or too few locations with high/low exposure to separate the source of interest from 326 potential confounders.<sup>12</sup> 327 Many study communities observed declines in annual average PM<sub>2.5</sub> and NO<sub>2</sub> during the study 328 period. These declines were a key source of the variation in our long-term exposure metric 329 (within-community annual fluctuations, calculated as the difference between annual averages 330 331 and the seven-year average concentration for each community). Our standard interpretation of the observed positive associations as "percent increase in FeNO per SD increase in exposure" 332 333 (e.g., 6.5% increase in FeNO (95% CI: 4.1%-8.9%) per 2.7 ppb increase in long-term NO<sub>2</sub>), could alternatively be reformulated as a "percent decrease in FeNO per SD decrease in 334 exposure". For example, scaled to an observed declines, in Glendora annual average  $NO_2$ 335 336 decreased by 11.3 ppb over the study period, and we estimated a 30% decrease in FeNO (95% 337 CI: 18.2% to 42.9%) per 11.3 ppb *decrease* in long-term NO<sub>2</sub>). A number of studies have used natural or designed experiments to demonstrate that FeNO decreased following decreasing 338 339 (primarily short-term) exposures. For example, following the adoption of clean fuel/technology school buses, 10-30% reductions in FeNO were observed in 275 schoolchildren.<sup>28</sup> Following 340

dramatic drops in air pollution in response to anti-air pollution measures enacted for the Beijing

Olympics, FeNO decreased ~57% in 125 health young adults (and subsequently rose 135% after  $\frac{29}{29}$  With  $\frac{29}{29}$  With

the games)<sup>3</sup> and ~27% in 36 children.<sup>29</sup> Within-participant FeNO also declined in a group of 42

retired teachers relocated from a higher air pollution city to a lower pollution city for 9 days<sup>30</sup> and in 37 untreated allergic children moved from an urban to a rural environment for 7 days,

with the reductions in FeNO restricted to participants with the highest FeNO at baseline in the

with the reductions in Ferro restricted to participants with the highest Ferro at baseline in
 urban environment.<sup>31</sup>

348 Several additional results in our study merit further discussion. We found evidence for larger

effects of long-term  $PM_{2.5}$  and  $NO_2$  in females as compared to males (p=0.007 and 0.07,

respectively), but no evidence for effect modification by asthma or allergy. In the preliminary

351 CHS analysis of long-term air pollution effects on FeNO, we had found no evidence for effect

modification by sex.<sup>16</sup> Sex/gender differences have been observed previously in air pollution epidemiology analyses, generally with larger effects for boys in early life and girls/women in

epidemiology analyses, generally with larger effects for boys in early life and girls/women in later childhood and older age.<sup>32</sup> We also found a statistically significant negative association for

long-term O<sub>3</sub>, which was not robust to our various sensitivity analyses. Within-community

annual average  $O_3$  was negatively correlated with  $PM_{2.5}$  PM<sub>10</sub>, and NO<sub>2</sub> and unlike those

pollutants, there were trends of increasing  $O_3$  during the study period. Finally, the association of

long-term  $NO_2$  with FeNO was larger in magnitude when leaving out one community (Upland)

or including a community-level random slope. Upland had the highest annual average  $NO_2$  at the

360 beginning of the study period, and one of the largest declines over the study period.

361 This study has several strengths, including: a large ethnically diverse population-based cohort of

schoolchildren; prospective longitudinal assessment of FeNO (up to 6 measurements over an

eight year period); a Southern California study location with substantial within- and between-

364 community variation in ambient air pollution exposures during the study period, representative

of the range observed nationally in the United States; as well as a study design and statistical

analyses approach that allowed us to target within-person associations of long-term air pollution

and FeNO (automatically controlling for time-constant confounders) while adjusting for short-term air pollution exposures.

This study has several limitations. The method for FeNO assessment changed during the study period, as technology improved (offline assessment used for the first two FeNO visits and online

assessment used for the next four FeNO visits). Although the offline values were converted to predicted online values based on a published internally-developed prediction model with an  $R^2$  =

predicted online values based on a published internally-developed prediction model with an  $R^2 = 0.94^{33}$ , there remains a possibility that this change in breath collection technique may have

373 0.24 , there remains a possibility that this change in oreath conection technique may have 374 impacted our effect estimates. In a sensitivity analysis restricting to only online FeNO visits, the

association of long-term NO<sub>2</sub> with FeNO remained similar and statistically significant (though

with wider confidence intervals because of smaller sample size) and the association of long-term

 $PM_{2.5}$  with FeNO was still positive, but attenuated and no longer statistically significant. A

378 limitation of our study design is that FeNO was assessed in only the most recent CHS cohort,

allowing only for investigation of associations with within-community fluctuations in annual

average air pollution. We were unable to investigate associations of within-community
 fluctuations in multi-year averages. Previous high impact CHS publications have taken

fluctuations in multi-year averages. Previous high impact CHS publications have taken
 advantage of multiple CHS cohorts (with staggered recruitment over time from the same

communities) to demonstrate that, in the same communities, declines in long-term (multi-year)

average air pollution have been associated with improved lung function growth,<sup>34</sup> reduced

bronchitic symptoms,<sup>35</sup> and reduced asthma incidence.<sup>36</sup> However, the most recent CHS cohort

- 386 was still recruited from multiple cities, with a wide range of annual average ambient air pollution
- levels at baseline and differing trends over the course of the study period.
- 388
- In conclusion, our findings provide the strongest evidence to date that long-term  $PM_{2.5}$  and  $NO_2$
- exposures affect within-participant FeNO, independent of the effects of short-term exposures,
- even during a study period with declining pollution levels. Longitudinal FeNO measurements
- may be useful as an early marker of chronic respiratory effects of long-term air pollution
- exposures in children.
