

1 **Poor Readability of COVID-19 Vaccine Information for the General Public: A Lost Opportunity**

23 **ABSTRACT**

24 **Background:** All adults in the United States now have access to COVID-19 vaccines. During the
25 vaccination process, Emergency Use Authorization (EUA) fact sheets are provided.

26 **Objective:** To analyze the ease of reading (i.e., readability) of the EUA-approved fact sheets for
27 the vaccines currently available in the United States, the V-Safe adverse event survey script,
28 and the Centers for Disease Control and Prevention (CDC) website on COVID-19 vaccines.

29 **Design:** We analyzed the readability of Pfizer, Moderna, and Janssen EUA fact sheets, as well as
30 the V-Safe survey script and the vaccine-related information on the CDC website.

31 **Measurements:** Readability factors include the following: average length of paragraphs,
32 sentences, and words; font size and style; use of passive voice; the Gunning-Fog index; the
33 Flesch Reading Ease index; and the Flesch-Kincaid Grade Level index.

34 **Results:** Only the V-Safe adverse event survey script met readability standards for adequate
35 comprehension. The mean readability scores of the EUA fact sheets and the CDC website were
36 as follows: Flesch Reading Ease score (mean 44.35); Flesch-Kincaid Grade Level (mean 10.48);
37 and Gunning-Fog index (mean 11.8). These scores indicate that a 10th-12th grade-level
38 education is necessary to comprehend these documents.

39 **Conclusion:** The average person in the United States would have difficulty understanding the
40 information provided in the EUA fact sheets and CDC COVID-19 vaccine website; however, the
41 V-Safe survey was written at an appropriate reading level. To ensure that the public fully
42 understands information regarding COVID-19 vaccines, simplified information material should
43 be developed.

45 INTRODUCTION

46 The 2019 coronavirus disease (COVID-19) is a respiratory illness that has resulted in a
47 global pandemic and the subsequent development of vaccines.¹ Vaccine information for
48 recipients includes several vaccine information documents, including the Centers for Disease
49 Control and Prevention (CDC) website on COVID-19 vaccines and the vaccine-specific
50 emergency-use authorization (EUA) fact sheet for the Pfizer, Moderna, or Janssen vaccine they
51 are receiving. Subjects are also encouraged to sign up for an adverse event tracking survey
52 called V-Safe. The CDC website on COVID-19 and the EUA fact sheets contain basic vaccine
53 information, including potential benefits, side effects, and necessary precautions. The purpose
54 of this study was to analyze the readability of the EUA fact sheets, the CDC website on COVID-
55 19 information, and the V-Safe adverse event survey script in the United States to determine if
56 they meet guidelines for adequate public readability.

57 Vaccine recipients should be able to understand vaccine information in order to
58 adequately understand possible risks and benefits of receiving the vaccine. Because these
59 documents are the primary method of communicating vaccine information to the public, the
60 readability of these materials is critical. Determining the readability of such documents is
61 necessary to make sure that the text is written at an adequate comprehension level for the
62 general public with differing reading skills. A National Work Group on Literacy and Health study
63 demonstrated that approximately 25% of U.S. citizens have very low-level reading skills and are
64 unable to comprehend medication instructions or a bus schedule.² The National Adult Literacy
65 Agency suggests that reading materials for the general population should have a 7th-grade

66 readability level, which is the average reading level for adults in the United States.³ To achieve
67 this, many experts advise using plain wording, active voice, short sentences, and present tense.⁴

68 **MATERIALS and METHODS**

69 We acquired the following vaccine information documents: COVID-19 vaccine EUA fact
70 sheets, which are given to vaccine recipients in the U.S., from Pfizer, Moderna, and Janssen; the
71 full V-Safe adverse event survey script; and COVID-19 vaccine information found on the CDC
72 website (i.e. Questions and Answers; Does it Work?; Is it safe?; Are there side effects?; and
73 What if I am pregnant or breastfeeding?) for the general public.⁵ Although the length of the V-
74 Safe script varies based on the reported symptoms, we reviewed the entire script.

75 Two study authors independently analyzed the readability metrics of each document
76 using Microsoft Word readability tools. Formatting metrics, including total length, sentence
77 length, font size and style, and percentage of passive sentences, in addition to three standard
78 readability formulas were used to analyze the reading difficulty of each document.

79 The Flesch Reading Ease score is a readability formula that predicts ease of reading on a
80 scale from 1 to 100, with higher scores indicating easier readability and 70 being the level of an
81 average U.S. reader.⁴ The Flesch-Kincaid Grade Level score is a readability index that
82 determines the ease of readability on a scale from 1 to 12. This score corresponds to the
83 education-grade level necessary to comprehend a passage.⁴ Table 1 compares the Flesch-
84 Kincaid Grade Level score and Flesch Reading Ease scores. The Gunning-Fog index is a
85 readability index that scores from 1 to 20 based on the number of complex or polysyllabic
86 words in a sentence and the number of sentences in a roughly 100-word passage. The most
87 reliable score is obtained by averaging the Gunning-Fog index score for three random 100-word

88 passages throughout a document. A Gunning-Fog index score of 7 is necessary to achieve near-
89 universal comprehension in the United States (See Table 2).⁶

90 **RESULTS**

91 We reviewed the COVID-19 EUA vaccine fact sheets for the Pfizer, Moderna, and
92 Janssen vaccines, the complete V-Safe adverse event survey script, and CDC information about
93 COVID-19 vaccines. No significant differences were detected in the scoring metrics between the
94 two independent study authors who analyzed readability.

95 Document length ranged from 5 to 18 pages (mean 8.25). The number of words in the
96 documents (including headers) ranged from 1,662 to 5,564 (mean 3,086.8). The average words
97 per page ranged from 175.9 to 334.2 (mean 294.8), the average words per paragraph ranged
98 from 7.0 to 25.1 (mean 17.76), and the average word length ranged from 4.9 to 5.4 characters
99 (mean 5.18). The font size ranged from 11 to 16 points, and all documents used sans serif fonts.

100 The average sentence length ranged from 9.8 to 18.7 words (mean 14.4) (see Table 3),
101 and the percent of passive sentences ranged from 0.2% to 21.1% (mean 15.04%). The Flesch
102 Reading Ease Score ranged from 40.9 to 66.8 (mean 48.84). The Flesch-Kincaid Grade Level
103 ranged from 6.3 to 11.6 (mean 9.76). The Gunning-Fog Score ranged from 8.03 to 12.43 (mean
104 11.19). See Table 4.

105 **CONCLUSIONS**

106 To our knowledge, this is the first study on readability for COVID-19 vaccine information
107 currently used for the general public in the United States. We found that only the V-Safe
108 adverse event survey script met most of the recommended readability levels for average

109 vaccine recipient. The remaining information sources we reviewed did not met readability
110 standards.

111 Readability studies demonstrate that the general public in the United States is less likely
112 to understand long documents.⁷ Such studies recommend that health information documents
113 should be shorter than 15 pages.⁸ The vaccine information documents in this study had an
114 acceptable page length average of 8.25, but the range extended to 18 pages, with an outlier of
115 28 pages. High word density also raises the difficulty level of a text; therefore, it is advised that
116 sentences are a maximum of 12 – 17 words long.⁹ Although the average sentence length (14.4
117 words) in our study was acceptable, the range extended to 18.7 words.

118 Font style and size also play roles in analyzing the readability of a text. Sans serif fonts
119 (i.e., Arial and Calibri) are easier to read than serif fonts (i.e., Times New Roman), and smaller
120 fonts such as size 12 are harder to read than larger fonts such as size 14.¹⁰ All documents used
121 an appropriate font style, but the size 12 font found in every document was too small. Many
122 passive-voice sentences, or sentences with the subject receiving the action of the verb, also
123 decrease readability.⁴ The average percentage of passive-voice sentences in our study was fairly
124 low, but the range extended up to 21%.

125 Because nearly half of adults in the United States read at a 7th-grade level,¹¹ vaccine
126 information materials provided for the currently available COVID-19 vaccines are too difficult to
127 understand for many adult readers. Since it is important that vaccine recipients are able to
128 comprehend information materials, documents with easier readability should be developed
129 and used.

130 In addition to simplified readability, the use of instructional graphics and multimedia,
131 including pictures, videos, colors, slideshows, and charts, can also increase
132 comprehension.¹² These resources were used on the CDC website and the V-Safe survey script
133 but not in the EUA vaccine fact sheets. Further studies are required to determine other cultural
134 and educational barriers to the most useful methods of patient education.

135 Our study is limited to the use of readability statistics pertaining only to education levels
136 from the United States. The strength of our study includes comparisons between widely used
137 and easily accessible online material regarding COVID-19 vaccines and standardized metrics to
138 assess readability.

139 In conclusion, our study demonstrates that a significant portion of the U.S. general
140 public would only be able to comprehend the V-Safe script out of the informational documents
141 we studied. However, use of the V-Safe script requires a smart phone. Given the importance of
142 these documents to inform and build trust within the community regarding COVID-19 vaccines,
143 greater effort must be applied to improve the readability of these information documents.
