- 2 Title: Treatment interruption is a risk factor for sickness presenteeism: a large-scale cross-sectional
- 3 study during the COVID-19 pandemic

37 Abstract

38	Objectives: This study examined the relationship between interruption to routine medical care
39	during the coronavirus disease 2019 pandemic and sickness presenteeism among workers in Japan.
40	Methods: A cross-sectional study using data obtained from an internet monitor questionnaire was
41	conducted. Interruption to medical care was defined based on the response "I have not been able to
42	go to the hospital or receive treatment as scheduled." The fraction of sickness presenteeism days in
43	the past 30 days was employed as the primary outcome. A fractional logit model was used for
44	analysis to treat bounded data.
45	Results: Of the 27,036 participants, 17,526 (65%) were workers who did not require routine medical
46	care, 8,451 (31%) were using medical care as scheduled, and 1,059 (4%) experienced interrupted
47	medical care. The adjusted odds ratio (aOR) of sickness presenteeism was significantly higher
48	among workers who experienced interrupted medical care (3.44; 95% confidence interval [CI]:
49	3.04–3.89) than those who did not require routine medical care. In terms of symptoms, the highest
50	aOR was observed among workers with mental health symptoms (aOR: 5.59, 95%CI: 5.04-6.20).
51	Conclusions: This study suggests the importance of continuing necessary treatment during a
52	pandemic to prevent presenteeism.

55 Introduction

56	Sickness presenteeism is an increasingly important issue in occupational health. Aronsson
57	defined sickness presenteeism as "people, despite complaints and ill health that should prompt rest
58	and absence from work, still turning up at their jobs" ¹ . Sickness presenteeism is the result of a choice
59	made by a worker with ill-health, disease, or capacity loss between sickness presenteeism and
60	sickness absence ² . This decision is influenced by the individual's personality, values, economic
61	status, workplace "demands for presence" and support for adaptation, and national culture and
62	employment customs ² . Evidence suggests that sickness presenteeism can lead to sickness absence
63	and future worsening of physical and mental health conditions ^{3–9} . In addition, the impact of working
64	while ill on productivity is also gaining attention, especially in North America ^{10,11} . A variety of
65	diseases and health conditions have been found to be associated with sickness presenteeism,
66	suggesting the importance of managing disease and maintaining good condition ^{4,12} .
67	Under the coronavirus disease 2019 (COVID-19) pandemic, there is concern that both
68	organizational and individual factors will increase sickness presenteeism above that observed under
69	normal conditions ^{13–15} . Increased workload on workers can lead to a negative work culture around
70	taking sick leave, such as where workers who choose to work while ill are valued for their loyalty to
71	the company and motivation to work, thus promoting sickness presenteeism ¹⁶ . Examples of

72	individual factors that may increase sickness presenteeism include worsening economic situations
73	and job insecurity; increased telecommuting, which can make it easier for workers to work even
74	while sick; the impact of the pandemic on anxiety and mental health; worsening of health conditions
75	and diseases due to lifestyle changes; and worsening of chronic diseases due to the inability to access
76	medical resources. All of these factors are expected to lead to an increase in sickness presenteeism.
77	Interruption to medical care is an important problem in the COVID-19 pandemic. Access to
78	necessary routine medical care and medical resources is reportedly being affected in many countries
79	around the world ^{17–19} . In Japan, there is data showing that the number of prescriptions issued has
80	decreased ²⁰ . Interruption to medical care can adversely affect management of chronic diseases and
81	delay the detection and treatment of new diseases ²² . In fact, excess deaths unrelated to COVID-19
82	have been reported ²³ . Thus, interruption to medical care during the COVID-19 pandemic may lead to
83	worsening of non-COVID-19 diseases and health conditions.
84	During the COVID-19 pandemic, the number of people working while ill may increase as a
85	result of worsening health conditions arising from treatment interruptions and delays. This may
86	result in an increase in sickness presenteeism. However, few studies have examined the effect of
87	medical care interruption on sickness presenteeism during the COVID-19 pandemic. We
88	hypothesized that sickness presenteeism has increased among workers who experienced

89 interruptions to their medical care during the COVID-19 pandemic. The purpose of this study was to

- 90 examine the association between medical care interruption and sickness presenteeism in Japanese
- 91 workers during the COVID-19 pandemic.

93 **Materials and Methods**

94	We performed a cross-sectional study based on baseline survey data obtained in the

95 Collaborative Online Research on the Novel- Coronavirus and Work (CORoNaWork) project, a

- 96 prospective cohort study that performed a questionnaire-based survey of Internet monitors to
- 97 determine the effect of the COVID-19 pandemic on workers' health. Details of the study protocol are
- published elsewhere²³. The practical aspects of the survey, namely recruitment, data sampling, initial 98
- 99 data clean-up, and management of respondents' user identifications (IDs) for tracking cohort data,
- 100 were conducted by Cross Marketing Inc. (Tokyo, Japan), which has 4.7 million registered monitors.
- 101 Before completing the online survey, participants read a description of the survey's aims and details
- 102 about the handling of their information. Only participants who agreed with the contents of the
- 103 description were allowed to participate. Participants' user IDs were stored by the survey company.
- 104 To participate in surveys offered by the survey company, users had to register in advance. Once
- 105 registered, participants were given a user ID to use when completing online surveys. Thus, all

106	surveys were conducted anonymously. The survey company assigned each respondent a unique
107	number that would be used only within this study to merge the data from the first and subsequent
108	surveys, based on the user ID within the survey company. The user ID is not provided to the
109	researcher, but the unique number enabled the researcher to merge the data and create the cohort
110	data. Participants' personal data were anonymized prior to receipt by the researchers, and were
111	protected based on the survey company's privacy policy. This study was approved by the Ethics
112	Committee of the University of Occupational and Environmental Health, Japan (Approval No.
113	R2-079 and R3-006).
114	The baseline survey was conducted from December 22 to 26, 2020. A total of 605,381
115	registered monitors were emailed invitations to participate. Sampling was designed such that sex and
116	occupation (office and non-office workers) were approximately equal among the five regions of
117	residence. Specifically, we predetermined a total of 20 units comprising five regions of residence,
118	two sexes, and two occupations. Sampling was continued until each unit reached 1500 responses
119	plus a margin of 10%, after which the unit was closed to participation. We devised the five regions
120	of residence according to infection and geographic status: first, Japan's 47 prefectures were divided
121	into four categories based on the cumulative COVID-19 infection rate; second, the category with the
122	highest infection rate was further divided into Kanto and non-Kanto regions. A total of 55,045
102	participants answered the initial screening questions of whom 33 302 matched the survey's criteria

124	(worker status, region of residence, sex, and age). Participants answered one questionnaire item per
125	page, with the overall questionnaire containing 55 pages. Participants could review and change their
126	responses using the back button. Participants who provided fraudulent responses (n=6,266)
127	according to the survey company or a predefined definition of a fraudulent response were excluded.
128	Fraudulent responses included an unusually short response time (below 6 minutes), unusually short
129	height (below 140 cm), unusually low weight (below 30 kg), varying answers to similar questions in
130	the survey (e.g., varying answers to questions about marital status or area of residence), and
131	incorrect answers to tiered questions used to identify inappropriate responses (e.g., choose the third
132	highest number from the following five numbers). After exclusion, responses from 27,036
133	participants aged from 20 and 65 years who indicated they were working when completing the
134	survey were ultimately included in the analysis.
135	
136	Assessment of treatment status
137	We assessed the presence of disease and use of medical care using the following question:
138	"Do you have a disease that requires regular visits to the hospital or treatment?" Responses were "I
139	do not have any such disease"; "I am able to go to the hospital or receive treatment as scheduled"; "I

140 have not been able to go to the hospital or receive treatment as scheduled."

141	Those who answered "I do not have any such disease" were defined as workers who did not
142	require routine medical care, and thus did not have any disease that requires hospital visits or
143	treatment. Those who answered "I am able to go to the hospital or receive treatment as scheduled"
144	were defined as workers who used medical care. Those who answered "I have not been able to go to
145	the hospital or receive treatment as scheduled" were defined as workers who experienced interrupted
146	medical care.
147	
148	Assessment of sickness presenteeism and other covariates
149	Respondents' number of sickness presenteeism days was ascertained based on the following
150

mainly interpersonal communication, mainly physical work), marital status (married,

157 divorced/deceased, never married), equivalent income (household income divided by the square root

158	of the number of people in the household), education (junior high school, high school, vocational
159	school/junior college/college of technology, university/graduate school), frequency of working from
160	home (at least one day a month, at least one day a week, at least two days a week, at least four days a
161	week), company size (total number of employees in the respondent's main place of work [1 for
162	self-employed]), presence of a policy by the employer requesting that employees refrain from
163	attending work while ill (yes or no), and the number of days worked per week.
164	The cumulative infection rate of COVID-19 in the province of residence was employed as a
165	community-level variable.
166	To control for potential confounders, we also asked participants to indicate their main
167	symptoms using the following question: "Which of the following conditions or body parts give you
168	the most trouble during your work?" The options were "No problem"; "pain"; "movement";
169	"tightness, loss of energy, appetite, fever, dizziness, or feeling poor"; "toileting or elimination";
170	"mental health"; "skin, hair, or beauty"; "sleep"; "eyes"; "nose"; "ears"; and "other."
171	

172 Statistical analysis

173	Age was treated as a continuous variable and reported as mean and standard deviation (SD).
174	The number of sickness presenteeism days was treated as a discrete variable and converted to a
175	fractional response variable by dividing by the maximum value of 30 days. Categorical variables
176	were reported as number and percentage. Equivalent income was categorized into quartiles.
177	We compared the results of Poisson regression, Zero-inflated Poisson regression (ZIP),
178	negative binomial regression, Zero-inflated Negative Binomial regression (ZINB), and fractional
179	logistic regression as statistical models. To handle data with excess zeros, which indicates a
180	population at low risk of sickness presenteeism, we considered a zero-inflated model ²⁴ . Fractional
181	logistic regression ²⁶ was also considered because the maximum possible number of days of sickness
182	presenteeism was 30, allowing the data to be treated as bounded data. As a measure of model fitness,
183	we compared the Akaike's Information Criterion (AIC), and ultimately adopted the fractional logit
184	model.
185	Fractional logistic regression analysis was conducted with the fraction of sickness
186	presenteeism days in last 30 days (0 indicates 0 days of sickness presenteeism; 1 indicates 30 days of
187	sickness presenteeism) as the dependent variable and the respondents' category of treatment status as
188	an independent variable.

189	We adjusted for the following potential confounders: sex, age, job type, marital status,
190	equivalent income, education, frequency of working from home, company size, cumulative infection
191	rate by prefecture, main symptoms, presence of a policy by the employer requesting that employees
192	refrain from attending work while ill, and the number of days worked per week.
193	In further analysis, we estimated the margins of sickness presenteeism days for each
194	treatment status and symptom. First, we used the same statistical model as that in the main analysis.
195	Second, we calculated the predictive margins of sickness presenteeism days, substituting measured
196	values for other covariates, dividing the data into 36 groups (3 treatment statuses and 12
197	symptoms) ²⁷ . In the fractional logit model, because predictive margins were calculated as fractions,
198	we multiplied margins and standard errors by 30 to obtain predictive margins for sickness
199	presenteeism days in the last 30 days. Preliminarily, we confirmed the simple main effects for each
200	treatment status compared to workers who did not require routine medical care by adding the
201	interaction term between treatment status and symptoms to the model used for the main analysis. For
202	all analyses, the Bonferroni method was used to adjust for multiple comparisons.
203	All comparisons were performed in Stata (Stata Statistical Software: Release 16; StataCorp
204	LLC, TX, USA), with $p < 0.05$ indicating statistical significance.

206 Results

207	The demographic and sociological characteristics of the analyzed population are shown in
208	Table 1. A total of 13,814 (51%) were men, and the mean age was 47.0 years (SD: 10.5). Of the total
209	population, 17,526 (65%) were workers who did not require routine medical care, 8,451 (31%) were
210	using medical care as scheduled, and 1,059 (4%) experienced interrupted medical care. The
211	distribution of sickness presenteeism is shown for the three treatment statuses in a histogram in
212	Figure 1. While the majority of respondents reported zero days of sickness presenteeism, a large
213	number also selected the maximum of 30 days. There were also small clusters at 5, 10, and 20 days,
214	which may be due to digit preference.
215	The association between treatment status and the fraction of sickness presenteeism days is
216	shown in Table 2. There was a significant association between the fraction of sickness presenteeism
217	days and treatment status. After adjusting for other covariates in the multivariate model, the odds
218	ratio (aOR) of sickness presenteeism days was significantly higher among workers who used
219	medical care (aOR: 1.36, 95% CI: 1.26–1.46, p<0.001) and workers who experienced interrupted
220	medical care (aOR: 3.28, 95%CI: 2.93–3.67, p<0.001) compared to workers who did not require
221	routine medical care.

222	The association between participants' main symptoms and the fraction of sickness
223	presenteeism days is shown in Table 3. There were significant associations between the fraction of
224	sickness presenteeism days and some symptoms using the model presented in Table 2. The highest
225	OR of sickness presenteeism days was observed for mental health symptoms (aOR: 5.35, 95% CI:
226	4.85–5.91, <i>p</i> <0.001).
227	The predictive margins of sickness presenteeism days for each treatment status and
228	symptom are shown in Table 4 and Figure 2. When the analysis was performed based on the three
229	treatment statuses, irrespective of symptom, the predictive margin of sickness presenteeism days
230	among workers who experienced interrupted medical care was 6.6 days (standard error [SE]=0.25),
231	while that among workers who did not require routine medical care was 1.4 days (SE=0.03). When
232	the analysis was performed based on the 36 treatment-symptom groups (3 treatment statuses and 12
233	symptoms), the largest predictive margin of sickness presenteeism days was observed for mental
234	health symptoms AND interrupted medical care (predictive margin: 9.9 days, SE=0.38). The simple
235	effect comparisons test, which included the interaction term between treatment status and symptoms,
236	showed that there were significant differences between workers with the same symptoms who did
237	and did not require routine medical care, and between workers with the same symptoms who
238	experienced interruption to medical care and who did not require routine medical care. For example,
239	the fraction of sickness presenteeism days significantly differed between those with mental health

symptoms who used medical care and those with mental health symptoms who did not require

- routine medical care (p < 0.001).

243 Discussion

244	This study demonstrated an association between treatment interruption and sickness
245	presenteeism among Japanese workers during the country's third wave of the COVID-19 pandemic.
246	Compared to workers who did not require routine medical care, workers who had diseases that
247	required routine medical care reported more days of sickness presenteeism, and those who
248	experienced interrupted medical care reported even more such days. Furthermore, our findings
249	revealed that there may be some symptoms that are more likely to lead to sickness presenteeism.
250	We found that workers who experienced interrupted medical care had increased sickness
251	presenteeism. This is because appropriate treatment can improve work function and productivity by
252	improving workers' health and subjective symptoms ^{10,28} . Employees who experience interrupted
253	treatment for chronic diseases may be forced to return to work due to fear of being laid off,
254	depending on the financial situation of their workplace during the pandemic. It is important to
255	continue regular treatments to manage disease and maintain health ²⁹ to prevent inappropriate
256	presence at work while ill.

257	We found that the proportion of sickness presenteeism days varies by the type of symptoms
258	experienced by workers. While ORs among workers with symptoms related to mental health
259	problems, loss of energy/fever, body movement, and sleep were high, those among workers with
260	nose and skin, hair, beauty symptoms were moderate. Sickness presenteeism is the result of a
261	worker's choice to attend work despite being unwell rather than being absent from work. Many
262	previous studies conducted mainly in Europe have evaluated "sickness presenteeism" as a health
263	behavior based on whether or not workers "worked one or more days in a certain period of time with
264	a health condition for which they think they really should be absent ^{3,2,30} . This is in contrast to studies
265	of "presenteeism" in North America, where the concept is evaluated as productivity loss due to
266	illness or a health condition using the Work Limitations Questionnaire or other tools ^{10,31} . One reason
267	as to why sickness presenteeism is more likely to be reported by workers experiencing mental health
268	problems may be that these symptoms are severe enough to cause "health conditions for which they
269	think they really should be absent." In contrast, physical symptoms such as those of allergic rhinitis
270	may not be considered "health conditions for which they think they really should be absent"
271	regardless of severity. If workers themselves do not consider their symptoms to be "health conditions
272	for which they think they really should be absent," they may not report experiencing sickness
273	presenteeism. However, there may be cases in which workers do not deem it necessary to be absent
274	from work, despite having a symptom that reduces productivity. Allergies with nose-related

275	symptoms are one example that causes loss of productivity due to presenteeism ^{11,32} . Workers may
276	not link these symptoms to sickness presenteeism due to differences in interpretation of "health
277	conditions that require absence from work." This is an important point when evaluating "sickness
278	presenteeism" as a health behavior.
279	We also found that the impact of continuing treatment on the prevention of sickness
280	presenteeism varied by symptom. Sickness presenteeism was more frequent in workers with
281	treatment interruption and symptoms related to pain, tightness and loss of energy, toileting and
282	elimination, mental health, sleep, and eyes than those who did not require routine medical care.
283	Among those who reported toileting and elimination, sleep, and eye symptoms, there was no
284	difference in sickness presenteeism between workers who used medical care and those who did not
285	require routine medical care. This suggests the importance of continuing necessary routine medical
286	care for preventing sickness presenteeism due to these symptoms. For those with pain, tightness and
287	loss of energy, and mental health symptoms, sickness presenteeism remained high even with
288	continued treatment, indicating the need to identify appropriate treatment and manage one's daily
289	health condition in addition to continuing treatment. Meanwhile, the prevalence of sickness
290	presenteeism was comparable among treatment statuses for participants with movement and mobility,
291	nose, and ear symptoms. This may be because individuals may not consider these symptoms
292	sufficiently adverse to engage in sickness presenteeism, or may experience chronic symptoms for

- 293 which support and adaptive behaviors have already been put into place such as movement symptoms.
- 294 The impact of continuing treatment on sickness presenteeism may be related to whether an
- individual considers their symptoms to be sufficiently adverse to require an absence from work, or
- whether or not the symptoms can be improved with treatment.
- 297 There are several limitations to this study. First, since this study is a survey of Internet
- 298 monitors, limitations regarding selection bias and generalizability are unavoidable. To reduce
- 299 potential bias, sampling and recruitment were conducted according to occupation and sex in each
- 300 region and the COVID-19 infection rate. To understand the characteristics of the target population of
- 301 this survey, we compared the results with those of national surveys and occupational surveys using
- 302 various batteries²³. Second, we did not obtain detailed information related to treatment interruptions,
- 303 including the type of disease, duration, and reasons for interruption. We were thus unable to
- 304 determine whether the reason for interruption to treatment was due to patient-related reasons (e.g.,
- 305 economic situation and anxiety) or hospital-related reasons (e.g., schedule adjustment). Additionally,
- 306 the questions we used to identify exposure factors were related to the presence or absence of diseases
- 307 that require hospital visits and use of medical care. However, sickness presenteeism is not just
- 308 related to disease and medical status, but also a wide range of health conditions or concerns. Third,
- 309 interruptions to treatment may be the result of better disease control and improved health. It is
- 310 unclear how these factors would affect the occurrence of sickness presenteeism. Fourth, because this

311	study examined sickness	presenteeism among v	vorkers during	the third wave	of the COVID-19

- 312 pandemic in Japan, caution is needed when interpreting the results. Further, causality is unclear. For
- 313 example, because most workers were told to remain home if they were experiencing COVID-like
- 314 symptoms during the pandemic, sickness presenteeism may have been reduced during this period.
- 315 However, it is unclear how such instructions affected overall sickness presenteeism, including that
- associated with symptoms unrelated to COVID-19. Finally, we did not consider all possible
- 317 confounders affecting sickness presenteeism because we did not obtain information on some
- 318 confounders, such as job insecurity, annual leave rights, and the culture around employment and sick
- 319 leave in each company.

321 Conclusion

Interruption to medical care was associated with the occurrence of sickness presenteeism during Japan's third wave of the COVID-19 pandemic. While the occurrence of sickness presenteeism largely differed according to symptoms, it may be possible that there were important cases of sickness presenteeism that were undetectable using the questionnaire. This study demonstrates the importance of maintaining one's health condition and continuing necessary treatment even during an infectious disease pandemic.
