2 **Analysis of the current state of acupuncture clinical trial**

3 **registration and reporting: for the past 9 years**

18 **Abstract**

19 *Background.* An increasing number of acupuncture clinical trials are registered, but
20 the reports of results and data transparency are unclear. We aim to analyze and

21 evaluate the current state of registration and reports of acupuncture clinical trials.

22 *Methods.* This paper focused on the acupuncture clinical trials that met the criteria in

23 relevant studies registered and published during the period between 1 Jan 2013 to 31

24 Dec 2021. We traced by email to leaders that the report could not be searched. Besides,

25 questionnaire investigation was chosen to acupuncture clinicians around by WeChat.

26 *Results.* The overall reporting rate of acupuncture clinical trial results from the two

27 registration centers was 25%. Clinicaltrials.gov reporting rate was 12% and that from

28 ChiCTR was 41%. Only a small proportion of trials were available on the registry

29 website. Only the NIH clinical registry platform has records on the status of studies.

30 We only received 3 replies that indicated the project was due to be ended but not

31 completed. According to questionnaire, 157 clinicians have led clinical projects in

32 Acupuncture. It shows that 84% projects were ended but not completed or not

33 completed by the due date. About the reasons that caused the failure to find articles

34 after the end of the project, 85% participants thought projects were ended but not

35 completed or not completed by the due date. 15% participants thought projects were

36 manuscript rejected, manuscript accepted but not in print, results protected,

37 registration number unmarked, project delayed or negative results not submitted.

38 *Conclusion:* The number of acupuncture clinical trial registrations is steadily

39 increasing, but the reporting rate of trial results is relatively low and the transparency

40 of data is not ideal. Therefore, first of all, researchers should put more attention on

41 trials designed, trial reported and respect to science. Secondly, set up a research
42 progress tracker on registration platforms accessible to the public users. At the same
43 time, the journal is suggested that adjust the evaluation criteria for reporting the
44 negative results. Researchers with negative results are encouraged to show. Most
45 importantly, the funders are recommended to optimize the ended review.

46 **Introduction**

47 Clinical trial registration means that specific information about a trial needs to be
48 prospectively registered in a web-based publicly accessible database [1]. Since the
49 International Committee of Medical Journal Editors (ICMJE) announced in 2004 that
50 clinical trials must be registered to be considered for publication [2], there has been an
51 increasing emphasis on the regulation of acupuncture clinical trial registration to
52 reduce the duplication of research [3] and to help prevent bias in reporting of results
53 [4,5,6]. The Final Rule [7,8], which came into effect on 18 January 2017, provides
54 further clarity on clinical trial registration and reporting requirements. The timely
55 publication of trial data will facilitate academic communication, provide guidance on
56 clinical practice and promote the development of evidence-based medicine [9].

57 After searching and collecting registered clinical trial literature, it is noticed that some
58 of the clinical trial literature is marked with registration numbers, and some registered
59 trials have not been published or data is unavailable. A study has evaluated the
60 registration and reporting of clinical trials from the start of the registry to 2013 and the

61 results were not optimistic [10]. To further explore the current state of the number of
62 registered clinical trials on acupuncture and their reporting in recent years, this study
63 intends to dig deeper into the clinical trials related to acupuncture registered from
64 2013 to 2021, in order to discover the problems and seek possible solutions to
65 improve the quality of clinical research.

66 **Methods**

67 **Search strategies**

68 Terms, such as "needle" and "acupuncture" , are searched in Chinese Clinical Trial
69 Registry platform[11]. We select "Advanced Search" with the search term
70 "acupuncture" in Clinicaltrials.gov[12]. The search period was set from January 1,
71 2013 to December 31, 2021.

72 The publications were searched on the Web of Science, PubMed, CNKI, WanFang,
73 VIP, and China Biomedical Literature Database, in English and Chinese only.

74 For some trials that the report could not be searched, we traced by email to leaders,
75 the main issues investigated was the progress of trails.

76 Email response rate too low, so questionnaire investigation was chosen to acupuncture
77 clinicians around by WeChat. The content of the survey was following: Question 1.
78 Have you ever held a clinical project in Acupuncture? Question 2. Would your project
79 be completed on time and would the results related to the research objectives be
80 published before the end of the project? Question 3. What do you think caused the

81 failure to find articles related to the research objectives in public available databases
82 after the end of the project? (If the answer to question 1 is no, the rest of the questions
83 cannot be seen).

84 **Inclusion criteria** All clinical trials related to acupuncture (including
85 electroacupuncture) registered between 1 January 2013 and 31 December 2021.

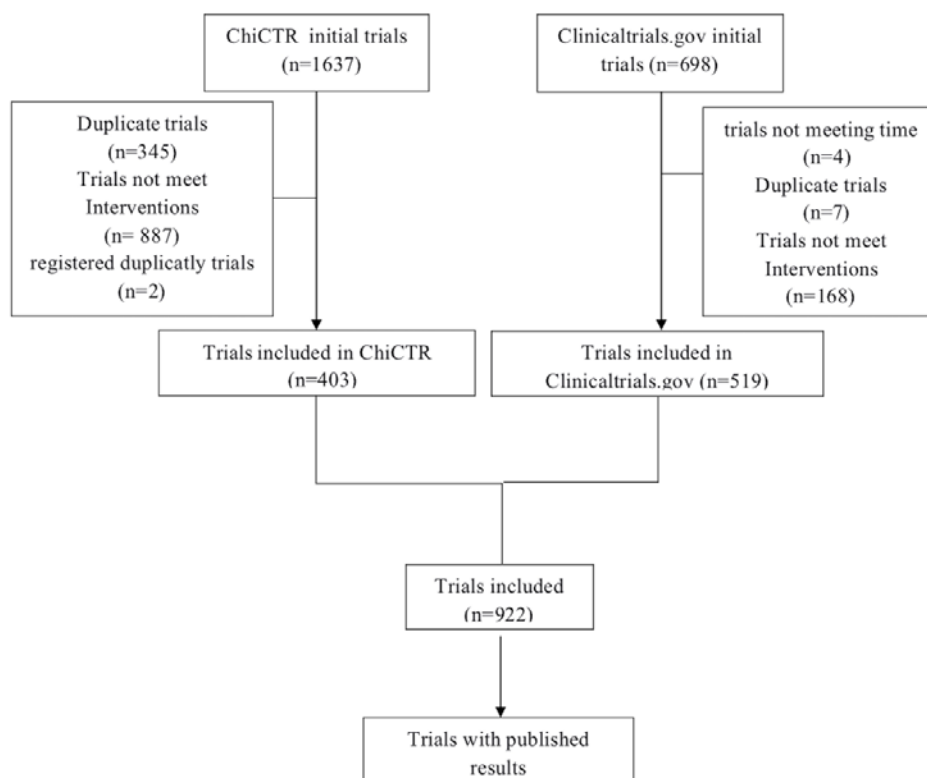
86 **Exclusion criteria** Duplicate registered clinical trials.

87 **Statistical analysis** After training three researchers responsible for the literature
88 search (Benlu Chen, Yun Fu and Yingying Cai), data from the registered trials were
89 extracted and summarized through EXCEL. And articles with published trial results
90 were considered as results publication. The report was based on the above databases
91 for subject terms, publication date, author, author institution, registration number,
92 subject number, etc. If the publication is in the type of protocol or review, it is
93 considered as other publication. The results of email responses and questionnaires are
94 also summarized in Excel. For the extraction and searching process, if there is
95 disagreement among three researchers, firstly, three parties should negotiate to solve
96 the problem. If the agreement is not reached after the negotiation, then we need to
97 seek help from experienced people or relevant experts.

98 **Results**

99 The results of the search are shown in Fig 1. We found 2335 registered trials in
100 ChiCTR and Clinicaltrials.gov. After selection, we finally selected 922 trials for our

101 study. Of the included trials, ChiCTR had 166 trials whose results have now been
102 published, and Clinicaltrials.gov with 62 trails. The results of the two centers are
103 listed separately as there are differences in reporting and implementation of results
104 and focuses on different issues. The state of trial registration and reporting is shown in
105 Table 1.

114 **1. Number of acupuncture clinical trial registrations**

115 2014 witnessed the most significant increase in registrations of Clinicaltrials.gov.
 116 2017 witnessed the most significant increase in registrations of ChiCTR and 2020
 117 witnessed the felling.

118 **2. Results publication rate**

119 The total results reporting rate for acupuncture clinical trial articles in both registries
 120 was 25%. Specifically, Clinicaltrials.gov reporting rate was 12% for results, same as
 121 those reports with registration numbers marked. Other types of publication accounted
 122 for 13%. ChiCTR reporting rate was 41% for results, with 21% for reporting with
 123 registration numbers clearly marked, and 7% for other types of publication.

124 **3. Publication timeline**

125 The majority of trials with published results were published after completion of the
126 trial, accounting for 83%. Specifically, Clinicaltrials.gov accounted for 84% of the
127 trials registered; ChiCTR accounted for 83%.

128 Only 17% of the trials were published early. Of the unpublished trials, only 18% are
129 in progress before the due date, while the rest were unpublished on due date.

130 **4. Results data availability**

131 Only a small proportion of trials were available on the registry website. A total of 6%
132 trials were available from both registries. Specifically, 8% Clinicaltrials.gov trials
133 were available; and 4% ChiCTR trials were available. 90% published trials' data was
134 not publicly available. Specifically, 87% published trials' data of Clinicaltrials.gov
135 was not publicly available and ChiCTR was available for 91%.

136 **5. Study status of unpublished trials**

137 Only the NIH clinical registry platform has records on the status of studies, of which
138 the largest number were recruiting, completed and unknown details at 108, 102 and 74
139 respectively. A small number of trials were discontinued and suspended details at 12
140 and 2, respectively.

141 **6. Survey results**

142 We sent 694 emails but only received 3 replies. All email responses indicated that the
143 project was due to be ended but not completed.

144 There were 218 acupuncture clinicians who took part in the questionnaire. 157
145 clinicians have led clinical projects in Acupuncture. But of them, only 12% projects
146 were completed. 51% projects were ended but not completed. 33% projects were not
147 completed by the due date. 4% projects were in progress. About the reasons that
148 caused the failure to find articles related to the research objectives in public available
149 databases after the end of the project, 52% participants thought projects were ended
150 but not completed. 33% participants thought projects were not completed by the due
151 date. 3% participants thought manuscript was rejected. 2% participants thought
152 manuscript was accepted but not in print. 3% participants thought results need to be
153 protected. 2% participants thought registration number was not marked. 3%
154 participants thought project was delayed. 2% participants thought negative results
155 were not submitted.

156 **Discussion**

157 **1.Registration trends**

158 The number of acupuncture clinical trial registrations in both registries has steadily
159 increased year by year. At the beginning of 2017, the fact that the number of ChiCTR
160 registrations are significantly higher than the previous number, and even higher than
161 Clinicaltrials.gov, is probably related to the application to WHO ICTR made by
162 Clinicaltrials.gov in the US in 2017 and which is approved- local applications for
163 registration when there is a WHO ICTR-accredited Level 1 registry where the trial is

164 conducted [13]. There is a significant drop in ChiCTR registrations in 2020, likely due
165 to the impact of the COVID-19 and the large amount of medical resources invested in
166 China, but this does not affect the future trend of steady growth in acupuncture
167 clinical trial registrations. Currently, acupuncture trials are in a period of modest
168 growth, with no peak growth performance. Therefore, emphasis should be placed on
169 clinical innovation and talent development in acupuncture, and researchers need to
170 broaden the disease spectrum of acupuncture to better promote the development of
171 acupuncture.

172 **2. Reporting situation**

173 Concerning the reporting of trials, it is clear that the reporting rates of results from
174 acupuncture trials registered at both centers are low, and ChiCTR has a significantly
175 higher rate of reporting results than Clinicaltrials.gov does. This may be related to the
176 Chengdu Declaration published in April 2006, which announced the implementation
177 of priority publication by ChiCTR member journals on a case-by-case basis [14].
178 There is no pattern in the number of trials published in terms of year due to a small
179 number of publications. Based on the survey results, the low reporting rate is due to
180 the following possibilities: some of trials were ended but not completed or not
181 completed by the due date. Some of the trial manuscripts were rejected, which may
182 due to low quality research or partial problems with the research program. Some of
183 the trial manuscripts were accepted but not in print. Some of the trial results need to

184 be protected. Some projects have been delayed. Some of the trials' negative results
185 were not submitted. In addition, it is possible that the low reporting rate is related to
186 outcome reporting bias [15,16,17], and studies demonstrated that publication bias is a
187 problem that still needs to be addressed [18].During the search process, some articles
188 were found to be similar to the registered content but without the registration number
189 to confirm. These articles rely on the responses of researchers to be sure, but most
190 researchers did not respond to emails.

191 **3. Data availability**

192 The result of data availability in both centers is not satisfactory. According to our
193 knowledge, some projects require that the results of the research be protected for a
194 certain period of time. The data availability rate at Clinicaltrials.gov is significantly
195 higher than that at ChiCTR, indicating that Clinicaltrials.gov is more concerned with
196 the implementation of data disclosure. However, there is still much room for
197 improvement in this area at both centers, far from the trial reporting rate. The centers
198 need to play their roles as supervisors and ask trials that have published results to
199 upload their data and take appropriate action if necessary. For trials with results that
200 need to be protected, there is an option to first mark them on the registration website
201 and make them public when the time comes.

202 **4. Study Status**

203 Clinicaltrials.gov clearly identifies trial study status and requires investigators to

204 record any changes about trial status in the relevant section of the website. The main
205 status can be divided by a few groups are Completed, Not yet recruiting, Recruiting,
206 Enrolling by invitation, Active, not recruiting, Suspended, Terminated, Withdrawn and
207 Unknown. The trials with the status of Terminated and Withdrawn could be conducted
208 to improve the limitations of study field. In addition, it was found that most of the
209 trials with the status of Completed had not been queried for publication. Maybe, some
210 of which had been accepted but not in print and some of which were in the process of
211 being written and some results were asked to be protected. Therefore, the status
212 should be marked clearly, and measures need to be taken by the registry to urge and
213 facilitate trials with the status of Completed to report their results and make their data
214 publicly available. This shows that the research status of trials is of critical
215 importance.

216 **5. Proposed solutions**

217 We need to face the problem of low reporting rates of registered trial results. Firstly,
218 in response to the lack of registration numbers, trial centers and major journals should
219 call for clinical trials to be registered before publication and require registration
220 numbers to be indicated. Secondly, researchers are expected to pay more attention to
221 the results reporting and data disclosure of registered acupuncture clinical trials.
222 Thirdly,
223 to reduce the likelihood of rejection, researchers need to be considerate when

224 designing their studies and seek advice from experts. Then, registries will monitor the
225 publication of results and timely updates in the registries. The registries shall, as far as
226 possible, request investigators to update the progress of their trials, and shall take
227 appropriate measures to promote the completion and reporting rate of trials that are
228 not reported by the due date. At the same time, ChiCTR should be called upon to
229 create a new research status item, and to set the number of years of research, and to
230 urge investigators to update according to their research status. Funding institutions
231 could also refer to the NIHR to request that registration information needs to be
232 updated during the study period [19]. Furthermore, the potential for biased results
233 reporting needs to be called out to journals and academics to pay more attention to the
234 results of studies, rather than focusing on positive results. Researchers with negative
235 results are encouraged to actively submit manuscripts. Last but not least, funding
236 institutions should be strict in their project end approval, and could take a model from
237 the NIHR [16] in requiring that the date of publication of trial results be disclosed and
238 that past registrations and publications be taken into account when reviewing funding
239 applications for new clinical trials.

240 **6. Limitations**

241 Limitations of this study: This paper mainly focuses on the acupuncture trials
242 registered with Clinicaltrials.gov and ChiCTR, which may not reflect registrations and
243 reporting from other registries, regions or countries. International studies may be

244 carried out with global cooperation. Relevant information regarding WHO is not
245 available which set a limit to data. The study is based on trials registered from 1
246 January 2013 to 31 December 2021. Not all leaders responded to the survey, which
247 may cause bias in the results. The questionnaire was conceived with a small number
248 of participants and should be followed up with a larger survey. Subject classification
249 is not shown on the Clinicaltrials.gov website, hence, it is not possible to analyze the
250 relationship between registration, reporting and subject classification.

251 **Conclusion**

252 The number of acupuncture clinical trial registries is increasing steadily, but the
253 reporting rate of trial results is very low and the transparency of data is not ideal. At
254 the same time, the unavailability of registered trial results greatly weakens the
255 advantages of clinical trial registries, causing a waste of research resources and funds
256 and a possible shortage of research in the corresponding fields. Therefore, firstly, it is
257 recommended that researchers need to put more focus on acupuncture clinical trial
258 reports with respect and be considerate when designing their studies and seek advice
259 from experts. Secondly, study progress can be recorded and monitored on the
260 registration platforms which allow the public to access data. At the same time, the
261 journal could update the evaluation criteria for evaluating negative-result reports to
262 minimize the bias that may occur. Researchers with negative results are encouraged to
263 actively submit manuscripts. Last but not least, funding institutions are expected to

264 optimize the end-of-trial review, strengthen the reporting monitoring of core outcome
265 indicators, regulate clinical research and reduce the waste of public resources.
