## 1 The role of inflammation in the prospective associations between early childhood

# 2 sleep problems and ADHD at 10 years: Findings from a UK birth cohort study

## 24 Abstract

Background: Several underlying mechanisms potentially account for the link between sleep and attention deficit and hyperactivity disorder (ADHD), including inflammation. However, studies so far have been cross-sectional. We investigate (i) the association between early childhood sleep and probable ADHD diagnosis in childhood; and (ii) whether childhood circulating inflammatory markers mediate any associations.

Methods and Findings: Data from the Avon Longitudinal Study of Parents and Children (ALSPAC) 30 were available for 7658 10-years-old children. Parent-reported sleep duration, night awakening 31 frequency, and regular sleep routines were collected at 3.5 years. The Development and Wellbeing 32 Assessment (DAWBA) was administered to capture children with clinically relevant ADHD 33 34 symptoms, or probable ADHD diagnosis. Further, blood samples were collected at 9 years, from 35 which two inflammatory markers were obtained [i.e. interleukin-6 (IL-6) and C-reactive protein (CRP)]. Logistic regressions were applied to investigate the associations between sleep variables at 36 3.5 years and probable ADHD diagnosis at 10 years. Further, path analysis was applied to examine 37 the mediating role of inflammation at 9 years (i.e. as measured by CRP and IL-6) in the associations 38 between early sleep and ADHD at 10 years. We found that less regular sleep routines (OR=0.51, 39 40 95%CI=0.28-0.93, p=0.029), shorter nighttime sleep (OR=0.70, 95%CI=0.56-0.89, p=0.004), and higher night awakening (OR=1.27, 951%CI=1.06-1.52, p=0.009) at 3.5 years were associated with 41 higher odds of probable ADHD at 10 years. Further, IL-6 at 9 years mediated the association between 42 irregular sleep routines and ADHD (bias-corrected estimate, -0.002; p=0.005); and between night 43 awakening and ADHD (bias-corrected estimate, 0.002; p=0.003). 44

45 Conclusions: Several sleep problems in early childhood constitute a risk factor for probable ADHD
46 diagnosis at 10 years. These associations may be mediated by inflammation, as measured by IL-6.
47 These results open a new research vista to the pathophysiology of ADHD and highlight sleep and
48 inflammation as potential preventative targets for ADHD.

## 49 Introduction

A good night of sleep is considered to be essential for every aspect of a child's functioning (1). 50 Further, identification of sleep problems in children is important because they are associated with 51 physical, cognitive, and socio-emotional problems (2). For instance, sleep problems are commonly 52 comorbid with neurodevelopmental conditions, including Attention Deficit and Hyperactivity 53 Disorder (ADHD) (3). Systematic reviews indicate that the prevalence of ADHD in children and 54 young people is between 2% and 7%, with an average of around 5% (4), and is characterized by 55 attention difficulties, impulsivity and/or hyperactivity that interfere with social functioning and/or 56 development (5). The aetiology of ADHD is multifactorial and includes both genetic and 57 58 environmental factors (6,7). One manifestation of this aetiology is disturbed sleep and there has been a dramatic increase in new research to better understand the association between disturbed sleep and 59 ADHD (8). 60

Sleep disturbances are commonly comorbid with ADHD, and between 70% and 85% of 61 children with ADHD experience problems with sleep (9). Sleep problems, such as fragmented sleep, 62 bedtime resistance, and/or sleep-onset insomnia in early childhood have been found to precede 63 ADHD symptoms. For instance, sleep disturbances at age 4 are associated with attention problems at 64 65 age 15 (10). Other studies have revealed similar associations at earlier stages, with sleep problems between the ages of 2–4 years being associated with attention deficits at age 5 (11) or short sleep 66 duration from 3-24 months associating with inattention at 5 years (12). These studies suggest that 67 sleep problems in early childhood may be an initial symptom, risk indicator of later ADHD or a causal 68 factor in the development of ADHD symptoms. However, most of these longitudinal studies have 69 focused on ADHD symptomatology, rather than ADHD diagnosis. Further, it is still unclear whether 70 71 all or only some specific sleep problems in early childhood precede the development of ADHD, although previous reviews and meta-analyses suggest that different sleep variables are associated 72 73 with ADHD symptoms (13,14). Further, sleep problems in individuals with ADHD can result in

significant functional impairments that affect mood, attention, behavior, and ultimately quality of
life,(15) which supports the necessity of further investigating sleep problems in ADHD.

If sleep and ADHD are robustly and prospectively associated, the next step would be to understand the potential mechanisms by which sleep difficulties may increase the risk for ADHD. This could help us better understand the aetiology of poorer outcomes in people with ADHD and consequently design more targeted interventions. Among these potential candidates, inflammation has recently received some attention, and preliminary evidence suggests that inflammatory processes could contribute to the association between sleep and ADHD (16), although this requires further research consideration.

Sleep disturbances have been associated with altered levels of inflammatory cytokines in 83 84 adults (17), but data in youth is still lacking. Two of the inflammatory markers that have received 85 greatest attention in relation to sleep are interleukin-6 (IL-6) and C-reactive protein (CRP) (17). IL-6 is a pro-inflammatory cytokine produced in response to environmental stressors, infections and 86 injuries. Dysregulated and persistent IL-6 production in certain cell populations leads to the 87 88 development of various diseases (18). CRP is a pentameric protein synthesized by the liver, and its level rises in response to inflammation (19). A recent study reported that morning serum IL-6 89 associates with actigraphy-based night sleep efficiency and minutes spent awake in children and 90 adolescents (20). Further, a recent study reported higher CRP and IL6 levels in children with ADHD, 91 compared to healthy children (21,22). Overall, there is recent evidence to support the potential 92 93 contributing role of inflammation in the association between sleep and ADHD in children. Currently, as far as we are aware there is no research which has specifically investigated the prospective 94 association between inflammation, sleep and ADHD. Increased understanding here would allow us 95 96 to further interrogate potential mechanisms underlying the links between disturbed sleep and ADHD and potentially better targeted early interventions in ADHD. 97

98 Therefore, the aims of this study were to investigate (i) the association between sleep variables 99 (i.e., regular sleep routines, daytime sleep duration, nighttime sleep duration and night awakenings) 100 in early childhood and probable ADHD diagnosis in childhood; and (ii) whether circulating markers 101 of inflammation (i.e., CRP and IL-6) in childhood mediate the associations between sleep variables 102 and later probable ADHD diagnosis. We hypothesized that shorter nighttime sleep duration would be 103 the key sleep variable to be associated with later ADHD,(12) and that CRP and IL-6 would mediate 104 the prospective association between sleep and ADHD.

#### **105** Methods and Materials

## 106 Participants

107 The Avon Longitudinal Study of Parents and Children (ALSPAC) is a UK birth cohort study examining the determinants of development, health and disease during childhood and beyond (23,24). 108 Pregnant women resident in Avon, UK with expected dates of delivery 1st April 1991 to 31st 109 December 1992 were invited to take part in the study. The ALSPAC study website contains details 110 of all the data available through a fully searchable data dictionary and variable search tool 111 (http://www.bristol.ac.uk/alspac/researchers/our-data/). Further details of the ALSPAC cohort are 112 provided in Supplementary material. Informed consent for the use of data collected via questionnaires 113 114 and clinics was obtained from participants following the recommendations of the ALSPAC Ethics 115 and Law Committee at the time. Ethical approval was obtained from the ALSPAC Law and Ethics committee and the local research ethics committees. 116

#### 117 Measures

118 Sleep assessment at 3.5 years old

Parent-reported sleep routines regularity, daytime sleep duration, nighttime sleep duration, and night awakenings frequency were assessed when the child was 3.5 years old. This time-point was focused upon based on previous findings that this time-point showed the strongest prospective associations with mental health problems in adolescence (25). Further, by the age of 3, children's sleep-wake patterns are consolidated (26), which allows us to better differentiate sleep difficulties from normative developmental patterns. These sleep variables were collected using questionnaires, and the mothers were asked about their child's bed and wake up times, night awakenings frequency, daytime sleep duration, and whether the child had regular sleep routines. Nighttime sleep duration was operationalized as the period between reported bedtime and morning wake time.

## 128 Probable ADHD diagnosis at 10 years old

129 Probable ADHD diagnosis at 10 years old was assessed via maternal ratings, using the well-validated Development and Well-Being Assessment interview (DAWBA) (27). Further details of the DAWBA 130 are provided in Supplementary material. Considering that most cases with ADHD are diagnosed when 131 children are 6 to 11 years old (28), we focused on ADHD at 10 years old to make sure that the majority 132 133 of the potential cases with ADHD would be characterized. The DAWBA was administered via computer, generating the following 'probability bands' (i.e. levels of prediction of the probability of 134 disorder for a DSM-IV diagnosis of ADHD, ranging from 0-very unlikely to 5-probable): 0:<0.1% 135 136 probability of children in this band having the disorder; 1:-0.5%; 2:-3%; 3:-15%; 4:-50%; 5:>70%, respectively. The top two levels of the DAWBA bands were used as computer-generated DAWBA 137 diagnoses, which was the measure selected for this study. This follows previous studies using the 138 DAWBA bands, which were validated in 7,912 British children (7-19 years) and 1,364 Norwegian 139 children (11-13 years), using clinician-rated DAWBA diagnoses as a gold standard (29). Briefly, the 140 141 prevalence estimates of the computer-generated DAWBA diagnoses were of roughly comparable magnitude to the prevalence estimates from the clinician-generated diagnoses, but the estimates were 142 not always very close. In contrast, the estimated effect sizes, significance levels and substantive 143 144 conclusions regarding risk factor associations were very similar or identical. Therefore, the computergenerated DAWBA diagnoses may provide a useful alternative to clinician-rated diagnoses, when 145 studying associations with risk factors, generating rough prevalence estimates or implementing 146

routine mental health screening. Therefore, here we use the term "probable ADHD diagnosis", insteadof ADHD diagnosis.

149 Inflammatory markers at 9 years old

Blood samples were collected from non-fasting participants during clinic assessment at 9 years at 150 around the same time of the day for each participant. Samples were immediately spun, frozen and 151 stored at -80 °C. There was no evidence of freeze-thaw cycles during storage. High-sensitivity CRP 152 (hsCRP) was measured at one time point at the same laboratory by automated particle-enhanced 153 immunoturbidimetric assay (Roche UK, Welwyn Garden City, UK). Additionally, IL-6 was 154 155 measured by single enzyme-linked immunosorbent assay (R&D Systems). All assay coefficients of variation were <5%. Data on IL-6 and CRP were available for 5071 and 5081 participants, 156 respectively. In the total sample, CRP values ranged from 0.01 to 67.74 mg/L. Fifty-nine subjects had 157 158 CRP levels >10 mg/L and were excluded from analysis due to the risk of confounding by acute inflammatory state (e.g. infection). IL-6 values ranged from 0.01 to 20.05 pg/ml and all values were 159 kept for the analyses. Higher levels of IL-6 (18) and CRP (30) are both associated with higher 160 probability of infection. IL-6 and CRP levels were log-transformed and standardized (Z-transformed), 161 following previous research in the topic (31). 162

#### 163 *Confounders*

Multiple family risk factors were assessed using the Family Adversity Index (FAI) during pregnancy, 164 at 2 years, and at 4 years. The FAI comprises 18 items on early parenthood, housing conditions, 165 maternal education, financial difficulties, parents' relationship, family size, family major problems, 166 maternal psychopathology, parents' substance abuse, crime records, partner support and social 167 168 network. Points were summed at each time point for a total FAI score across the 3 time points. The FAI total score has a range of 0–18, with higher scores indicating higher number of family adversities 169 across early childhood. We included this variable as confounder, as adverse family environment is 170 associated with ADHD (32). 171

Other socio-economic factors selected as covariates were child's sex, preterm delivery, ethnicity (white vs non-white), maternal age when baby was born, and maternal socioeconomic status, which was measured using the Cambridge Social Interaction and Stratification Scale, which provides a total score (33). All these variables were selected as relevant confounders as there is a higher prevalence of ADHD in males (34), preterm children (35), white children (36), children with young mothers (37), and low socio-economic status (38).

## 178 Statistical Analysis

As 50.3% of the original sample was lost to attrition by the 10-year follow-up, we conducted logistic 179 180 regressions to identify significant predictors of attrition. Children lost due to attrition were more frequently born preterm, had lower birth weight, had shorter gestational age, had younger mothers, 181 had higher scores in family adversity, and were more often of non-white ethnicity (see supplementary 182 183 table S1). Using the variables associated with selective dropout as the predictors, we fitted a logistic regression model (nonresponse vs response outcome) to determine weights for each individual using 184 the inverse probability of response. The regression coefficients from this model were used to 185 determine probability weights for the covariates in the main analyses. 186

A multi-staged analysis plan was developed. We first ran weighted logistic regression 187 analyses in SPSS-v27, to ascertain the unadjusted and adjusted associations between sleep variables 188 at 3.5 years and computer-generated DAWBA diagnoses of ADHD at 10 years. In Model A, we tested 189 unadjusted associations. In Model B, we controlled for sex, maternal age at birth, FAI, ethnicity, 190 191 preterm delivery and maternal socio-economic group. Further, the four sleep variables were evaluated 192 together in the same model, to account for the potential overlap between sleep patterns in childhood. Because this study involves exploratory analysis of multiple separate hypotheses, as opposed to 193 repeated analyses of a single hypothesis, we did not adjust for multiple testing (39). 194

To examine the potential mediating role of inflammation at 9 years, mediation models were
tested using path analysis in SPSS-Amos v27, with maximum likelihood estimation to test the effect

of childhood sleep variables at 3.5 years on computer-generated DAWBA diagnoses of ADHD at 10 197 198 years, with inflammatory markers at 9 years as mediating variables. We also controlled for the potential interaction of the explanatory variables (i.e., sleep variables). IL-6 and CRP were tested 199 separately in independent mediation models. We included as explanatory variables only those sleep 200 201 variables with significant associations in Model B, from the regression analyses. We also controlled for sex, FAI and preterm delivery, as these were the significant covariates from the regression 202 203 analyses. We used bootstrapped bias-corrected confidence intervals and p values for assessing the 204 significance of the standardized direct, indirect and total effects. Missing data was dealt with using the full information maximum likelihood method. 205

## 206 **Results**

Data were available on 7,769 participants whose mothers reported on ADHD information at 10 years.
Table 1 shows the frequencies and descriptive values of sociodemographic, sleep and clinical
variables. Further, a description of these variables in children with probable ADHD diagnosis,
compared to non-ADHD are presented in Table 2.

211 The associations from the logistic regressions between sleep variables at 3.5 years and computer-generated DAWBA diagnoses of ADHD at 10 years appear on Table 3. In Model A, the 212 four sleep variables at 3.5 years old were significantly associated with probable ADHD diagnosis at 213 10 years. Furthermore, in Model B, when we controlled for the covariates, children with less regular 214 sleep routines had higher odds of probable ADHD diagnosis at 10 years (OR=0.51, 95% CI=0.28-215 0.93, p=0.029), children with shorter nighttime sleep duration had higher odds of probable ADHD 216 diagnosis (OR=0.70, 95% CI=0.56-0.89, p=0.004), and children with higher night awakening 217 frequency had higher odds of probable ADHD diagnosis (OR=1.27,95I% CI=1.06-1.52, p=0.009). 218

In relation to IL-6 at 9 years as potential mediator of the association between early childhood
 sleep variables and computer-generated DAWBA diagnoses of ADHD at 10 years, model fit indexes

indicated excellent model fit ( $\chi$ 2=0.27, P=.60; RMSEA=0; CIF=1.00). Consistent with the adjusted 221 222 logistic regression, higher night awakening frequency at 3.5 years was directly and significantly associated with probable ADHD diagnosis at 10 years ( $\beta$ =0.035, p<0.001). Direct associations are 223 shown in Figure 1. Further, we observed an indirect effect of IL-6 at 9 years in the association between 224 irregular sleep routines at 3.5 years and probable ADHD diagnosis at 10 years (bias-corrected 225 estimate, -0.002; 95% CI=-0.003 to -0.001, p=0.005); and between higher night awakening frequency 226 227 at 3.5 years and probable ADHD diagnosis at 10 years (bias-corrected estimate, 0.002; 95% CI=0.001 to 0.003, p=0.003) (see Table S2 in Supplement, for the indirect effects). 228

229 Concerning the potential mediating role of CRP at 9 years, we also demonstrated a good model 230 fit ( $\chi 2=2.22$ , P=.14; RMSEA=0.009; CIF=1.00). Higher night awakening frequency at 3.5 years was 231 the only early sleep problem which was directly and significantly associated with probable ADHD 232 diagnosis at 10 years ( $\beta=0.036$ , p<0.001). Direct associations are shown in Figure 2. However, CRP 233 at 9 years did not mediate any of the associations between early childhood sleep problems and 234 probable ADHD diagnosis at 10 years (see Table S2 in Supplement, for the indirect effects).

## 235 **Discussion**

In a prospective well-established UK cohort study, we investigated whether several sleep variables at 236 3.5 years old were associated with the probable diagnosis of ADHD at 10 years old. To our 237 knowledge, this is the first longitudinal study to examine whether inflammation mediates the 238 association between early childhood sleep problems and subsequent probable ADHD diagnosis. First, 239 we found that irregular sleep routines, shorter nighttime sleep duration and higher night awakening 240 frequency at 3.5 years were all associated with probable ADHD diagnosis at 10 years. Second, we 241 found that IL-6 at 9 years mediated the associations of both irregular sleep routines and higher 242 frequency of night awakening at 3.5 years with ADHD at 10 years. In contrast, CRP at 9 years did 243

not mediate any of the associations between early childhood sleep problems and probable ADHDdiagnosis at 10 years.

246 We found that several parent-reported sleep problems in early childhood were prospectively associated with probable ADHD diagnosis at 10 years. This is consistent with previous research 247 supporting the notion that sleep problems in early childhood might constitute an important risk factor 248 for developing ADHD later in childhood. For instance, parent-reported short sleep duration at 5-6 249 years old is prospectively associated with ADHD symptoms at 8-9 years old (40). Furthermore, these 250 251 prospective associations with short sleep duration have been also reported at earlier ages, with shorter sleep duration from 3-to-24 months being associated with inattention at 5 years (12). These 252 prospective associations continue into adolescence, with recent evidence suggesting that several sleep 253 254 problems in early childhood, including insomnia, restless leg syndrome and frequent snoring (41), as 255 well as difficulty going to sleep, nightmares and restless sleep predict ADHD symptoms in adolescence (42). Our findings contribute to the existing evidence by highlighting that specific sleep 256 257 problems, including short sleep length and sleep fragmentation in early childhood are also related to probable ADHD diagnosis at 10 years old. Further, irregular sleep routines at 3.5 years were also 258 prospectively related to probable ADHD diagnosis at 10 years, suggesting that a lack of routine is 259 also an important factor to consider with regards to ADHD, as has been previously reported (43). 260

Several underlying mechanisms have been suggested to account for the link between sleep and ADHD. For example, sleep deprivation can impact the prefrontal cortex (44), and weaker function and structure of prefrontal cortex circuits associate with ADHD (45). Further, dopaminergic activity is associated with ADHD symptomology (46), and is also implicated in the regulation of sleep and waking (47). In this study, we focused on the two most commonly assayed inflammatory markers (i.e. IL-6 and CRP) as potential mediators of the prospective associations between sleep and ADHD in childhood, due to a possible role of inflammation in ADHD pathogenesis (48).

Our initial hypothesis that both markers of inflammation would mediate this association was 268 269 partially supported. We found that IL-6, but not CRP, at 9 years, mediated the associations between two of the sleep variables tested at 3.5 years (i.e., irregular sleep routines and frequent night 270 awakening) with ADHD at 10 years. The impacts of IL-6 and CRP on subsequent outcomes, including 271 mental health and brain development may differ. For instance, in a longitudinal study, higher levels 272 of IL-6 in childhood, but not CRP, were associated with an increased risk of developing depression 273 and psychosis in young adulthood (49). Similarly, IL-6 at 9 years, but not CRP, was prospectively 274 associated with diurnal mood variation, concentration difficulties, fatigue and sleep disturbances at 275 18 years old (50), and with increased risk of hypomanic symptoms by age 22 years (51). A recent 276 277 study also reported that genetically predicted IL-6, but not CRP, was significantly associated with gray matter volume (especially in the middle temporal gyrus and fusiform gyrus), and with cortical 278 thickness (mainly in the superior frontal gyrus) (52), which are areas implicated in ADHD. 279

So far, it is still unknown why IL-6 but not CRP might play a greater role in the development of subsequent mental health problems. One potential explanation might be found in the different physiological actions associated with each of these inflammatory markers (53). However, it is still unknown how this might lead to different adverse outcomes and under which circumstances. Therefore, further research to understand and compare the potential distinct role of IL-6 and CRP in the development of mental disorders is needed.

This study has several strengths, including the large population-based sample size, the longitudinal design, and the inclusion of several sleep variables in early childhood. There are also some limitations. First, other potential contributing factors, such as depression, cognition, social interactions, obstetric complications, viral infections, smoking or body mass index were left unexplored. Second, DAWBA probable ADHD at 10 years was only reported by parents, and thus parental perceptions and/or assumptions could be constituting a bias of these assessments. Future studies should consider self-reported and/or teacher-reported assessments, in addition to clinical

interviews. Similarly, sleep was reported by the parents, and thus future studies should focus on 293 294 objective measures of sleep. Third, the time-points included in this study were partially determined by the availability of the data collected in the ALSPAC. Future studies should also consider other 295 developmental stages to investigate this topic. Fourth, as might be expected in a long-term population 296 cohort study, the attrition rate was significant. However, we used procedures to ensure 297 representativeness of our results. Finally, the prevalence of children with probable ADHD diagnosis 298 299 using the top two levels of the DABWA-bands as computer-generated DAWBA diagnoses in this study was considerably smaller (i.e., 1.6%) than the prevalence reported by previous studies (e.g., 300 around 5%). These discrepancies in the prevalence might be related to the different methodology used 301 302 to assess ADHD and the specific time points investigated. However, the lower prevalence detected using the DAWBA in our study supports the assumption that the DAWBA represents clinically 303 relevant ADHD cases, and that only includes those children with probable ADHD diagnosis. 304

#### **305** Conclusions

Our findings showed that several sleep variables in early childhood, including shorter nighttime sleep 306 307 duration, higher night awakening and more irregular sleep routines at 3.5 years were associated with probable ADHD diagnosis at 10 years. Further, IL-6 at 9 years, but not CRP at 9 years mediated the 308 associations between early sleep problems (i.e., higher night awakening and more irregular sleep 309 routines) and probable ADHD diagnosis at 10 years. These findings support the relevant role of sleep 310 problems at early stages of life as a risk factor for developing ADHD. In addition, a non-resolving 311 312 pro-inflammatory mechanism might be a contributory pathway explaining why sleep problems in early childhood are linked to subsequent ADHD, and thus provides further support to the role of 313 inflammation in mechanistic pathways to neurodevelopmental disorders, including ADHD. These 314 315 results highlight the potential of future preventative interventions in ADHD, with the novel target of sleep and inflammation. 316






Figure 2. Path diagram showing the main direct associations, with CRP at 9 years as mediating factor. This figure shows only the direct associations of the independent, mediating and dependent variable. Sleep variables (i.e., regular sleep routines, nighttime sleep duration and night awakening frequency) at 3.5 years represent the independent variables; CRP at 9 years the mediating factor; and probable ADHD diagnosis at 10 years represents the outcome. The covariates also included in this path analyses were sex, family adversity and preterm delivery, due to the significant associations with the outcome found in the logistic regression model. Significant pathways are signified by solid arrows and nonsignificant pathways by dotted-dashed lines. 

# 570 Supplementary material

## 571 Further details of the ALSPAC cohort:

572 The initial number of pregnancies enrolled was 14,541 (for these at least one questionnaire was returned, or a "Children in Focus" clinic had been attended by 19/07/99). Of these initial pregnancies, 573 there was a total of 14676 foetuses, resulting in 14062 live births and 13988 children who were alive 574 575 at 1 year of age. When the oldest children were approximately 7 years of age, an attempt was made to bolster the initial sample with eligible cases who had failed to join the study originally. As a result, 576 in our study, as some variables were collected from the age of seven onwards there were data available 577 578 for more than the 14541 pregnancies mentioned above. Informed consent for the use of data collected via questionnaires and clinics was obtained from participants following the recommendations of the 579 ALSPAC Ethics and Law Committee at the time. Ethical approval was obtained from the ALSPAC 580 581 Law and Ethics committee and the local research ethics committees.

### 592 Further details of the Development and Well-Being Assessment (DAWBA):

The DAWBA is a package of interviews, questionnaires and rating techniques designed to generate 593 594 ICD-10 and DSM-IV or DSM-5 psychiatric diagnoses about 2-17 years old. The DAWBA includes a mix of 'closed'/structured questions and open-ended questions, where respondents describe their 595 difficulties in their own words. The full DAWBA package covers the following diagnoses: Separation 596 anxiety, Specific phobia, Social phobia, Panic disorder/agoraphobia, Post-traumatic stress disorder, 597 Obsessive compulsive disorder, Generalized anxiety disorder, Body dysmorphic disorder, Disruptive 598 599 mood dysregulation disorder, Major depression, ADHD/hyperkinesis, Oppositional defiant disorder, Conduct disorder, Eating disorders, including anorexia, bulimia and binge eating, Autism spectrum 600 disorders, Tic disorders, including Tourette syndrome, and Bipolar disorders. For each of these 601 602 disorders, the interview asks about all the symptoms, and other criteria needed for an operationalized diagnosis according to both DSM-IV (American Psychiatric Association, 1994) and the research 603 diagnostic version of ICD-10 (World Health Organisation, 1994). Panic disorder, agoraphobia, 604 605 autistic disorders, eating disorders, tic disorders, and any other concerns are covered more briefly, with clinical diagnoses of these disorders being correspondingly more dependent on rating the open-606 ended transcript. The time frame of the interview is the present and the recent past. For many 607 disorders, the ICD-10 and DSM-IV diagnostic criteria stipulate that the symptoms need to have 608 persisted for a specified number of months, e.g. a minimum of 6 months for hyperactivity, 609 610 oppositional-defiant disorder, and generalized anxiety disorders. In these instances, the relevant section of the DAWBA interview focuses on the child's symptoms over this 611

stipulated period. The time frame is longest for conduct disorder (since DSM-IV criteria include the
number of relevant behaviours displayed over the previous 12 months), and shortest for most of the
emotional disorders, where the focus is on the last month, in line with previous recommendations
(Shaffer et al., 1996).
