Caregiving in a Tertiary Health Institution in North Central Nigeria: Support Types and

Financial Burden

Abstract

Background

Caregivers play an important role in informal patient management. Identification of the support types and the challenges faced by caregivers will provide information on strategies to ease this burden. This study aimed to describe the support types and financial burden among

caregivers in a tertiary hospital in North Central Nigeria.

Methods

This was a cross-sectional study conducted among caregivers of in-patients admitted in a tertiary hospital in North Central Nigeria. Data was collected using a pre-tested interviewer-administered questionnaire. Data was analysed using the Statistical Package for Social Sciences package version 23. Results were reported in frequencies and proportions, and presented in prose, tables and charts.

Results

A total of 400 caregivers were recruited. Mean age was 38.32 ± 12.82 years and most (66.0%) were females. Caregivers supported their patients by running errands (96.3%) and 85.3% reported caregiving as stressful. The reported errands were purchase of medications (92.3%), supply of non-medical needs (63.3%), submission of laboratory samples and collection of results (52.3%) and service payment (47.5%). About two thirds (63.2%) reported loss of

income while caregiving and about half (50.8%) provided financial support to the patients.

Conclusion

This study suggests that majority of caregivers experience significant physical and financial

burden while caregiving. This burden can be eased off by the simplification of payment and

laboratory processes, and employment of more staff to support patients admitted in the

wards. The financial burden experienced by caregivers reinforces the need to encourage more

Nigerians to enrol in a health insurance scheme.

Introduction

A caregiver is an unpaid person usually a family member or a friend who is involved in

providing care whether formal or informal, full time or part time, to a patient in their home or

a care setting.[1]The need for this social support system in care settings such as the hospital

is recognised, where these informal care givers provide a wide array of support to their

patients.[1]This support could be physical (assisting in carrying out activities of daily living or

running errands), financial, emotional or social.[1,2]

The role caregivers play in patient management has been identified and the burden from this

role is recognised.[3,4] Caregivers provide care to their patients in form of assisting with

activities of daily such as bathing, feeding, helping with urination and defaecation.[5] They

also perform some nursing duties including serving medication and turning patients in

bed.[5]Caregiver burden has been linked to a negative impact on their physical, psychological

and emotional health.[4]

Caregivers in low resource settings are particularly more burdened in this regard compared to

those in developed countries.[5,6]Healthcare workers in these settings are often over-

burdened and may shift some of their responsibilities to the informal caregivers.[7,8]In

addition, patients and caregivers experience economic burden especially in health systems

where out of pocket payment for healthcare is prevalent. [9,10] For example, in Nigeria, the

burden faced by caregivers has been associated with the poor economic conditions in the

country and poor institutional support especially in public hospitals.[6,7]

An identification of the support types and the challenges faced by caregivers will provide

information on strategies to reduce the burden faced by caregivers, especially in low income

settings where evidence shows that they are more involved in providing support to their

patient while on hospital admission.[5] Extensive electronic literature review has revealed

sparse literature regarding the types of support and financial challenges that caregivers

experience in Nigeria. This study describes the support types and financial challenges among

caregivers in a tertiary hospital in North Central Nigeria. Findings from this study will be useful

for the policy makers, hospital administrators and other stakeholders to better manage

supportive caregiving services in the hospital.

Methods

Study design: This was a hospital-based cross-sectional study conducted to describe the

support types and financial challenges experienced by caregivers in-patients in University of

Ilorin Teaching Hospital (UITH), Ilorin.

Study setting: This study was conducted in the University of Ilorin Teaching Hospital (UITH),

Ilorin, Kwara State. It is a public owned tertiary hospital located in North Central Nigeria. It is

a 650-bedded hospital with an average of about 1,000 in-patient admissions per month. In

addition, to rendering its services to patients in Kwara State, patients from surrounding North-

central and part of south-western States are also referred to the hospital.

Caregivers play a role in the care of their patients in the hospital, similar to other hospitals in

Nigeria.[11]They are primarily responsible for running some errands including payment of

bills, and purchase of medications and consumables for their patients. On observation, the

hospital provides roofed open spaces around the hospital wards. In addition, a private guest

house with 10 rooms is available for caregivers to lodge within the hospital premises. Many

caregivers are seen to hang around the corridors close to their patient's ward during the day

and also at night. There is an open local market in the hospital where food and household

items can be purchased.

Study population: Adult caregivers of in-patients in UITH, Ilorin

Inclusion criteria: Adult caregivers of in-patients who had spent at least one night in UITH,

Ilorin.

Exclusion criteria: Caregivers less than 18 years of age and family/friends on visitation to the

hospital.

Variables: Variables included sociodemographic characteristics (age, gender, religion,

ethnicity, marital status, type of family, level of education, employment status and place of

residence), relationship with patient, timeline of hospital stay, and perception of care

received. Data was also collected on the estimated amount caregivers spend on their patients

and their sources of support, and the type of caregiving support they provide.

Data resource and measurement

Data collection tool: Data was collected using an interviewer administered questionnaire with

close-ended items. The questionnaire was developed from review of relevant literature by the

researchers. It was further validated by pretesting for the content validation among 40

respondents in a General Hospital Ilorin (a state government owned tertiary health facility). It

was also reviewed by experts for face validity.

Data collection: Data was collected from participants between 26th September 2019 and 25th

October 2019. Demographic variables such as age, gender, religion, level of education, and

employment status were collected. The data collection also collected data on variables related

to hospital stay of caregivers and perception of caregiving, type of support provided,

caregivers' finances and sources of support. These variables were based on self-reports, which

may cause recall bias. However, we tried to reduce this bias to limiting the participants to

those who had patients in the ward as at the time of data collection and in the case where a

patient had two or more caregivers, the caregiver who had spent more time with the patient

was selected.

Sample Size Determination: Using Leslie Fischer's Formula for the calculation of sample size

for a population less than 10,000,[12] after adjusting for non-response, a sample size of 400

caregivers the calculated minimum sample size was 270. However, a total of 400 caregivers

were recruited into the study over a period of one month.

Sampling method: Caregivers were identified through their patients on admission. They were

recruited from all the wards in the hospital. Using the in-patients register in each ward as a

sample frame, the patients' caregivers were proportionally recruited. In each ward, patients

randomly selected from the in-patient register based on the allocated number per ward.

Caregivers of the selected patients were traced and recruited into the study. In cases where

the caregiver did not meet the eligibility criteria, the next patient's caregiver on the register

was recruited. Where the patient had more than one caregiver at the time of data collection,

the caregiver who had spent more time with the patient was recruited.

Data analysis: Data was analysed using the Statistical Package for Social Sciences package

version 23. Descriptive statistics (means, standard deviation and percentages) were used to

analyze the data. Data was presented in tables (in frequency and proportion) and charts (bar).

Ethical consideration: Ethical approval was sought from the Ethical Review Committee of

UITH, Ilorin. The purpose and benefits of the study was explained to all the study participants

after which a written informed consent which was signed or thumb printed was obtained from

all. They were assured of the confidentiality and privacy of their information by avoiding the

use of identifiers and ensuring data security. All the principles of ethics were adhered to all

through the study.

Results

The majority (35.0%) of the respondents were between 30 and 39 years with mean age of

38.32 ± 12.82 years (Table 1). About two thirds (66%) of the caregivers were females and


majority (69.2%) were Muslims. Almost all (89.8%) of the respondents were of Yoruba ethnic group and most of them (81.7%) were married. More than one third (35.4%) attained tertiary education level, while only a minority (16.0%) had no formal education. More than two-third of the respondents (69.2%) were employed, out of which almost two thirds (63.2%) were self-employed. Trading was the most common occupation, accounting for 44.2% of all occupations. Almost three quarters (73.0%) of the respondents resided in the study area. Majority of the caregivers were immediate family members of the patients, with parents, children, siblings and spouses accounting for 35.5%, 18.8%, 13.8%, 11.0% and 15.8% respectively. Less than one fifth (15.8%) were other relatives and less than one tenth (5.1%) were non-relatives.

Running of errands (96.3%) is the commonest support type of caregiving provided to patients on admission in the hospital (Figure 1). Keeping patients' company (50.5%), feeding patients (37%) and serving medication (28.8%) were also reported as common caregiving roles. Some of the other identified support roles were helping with defecation (25.8%), lifting patients (21%), bathing patients (20.3%) and walking patients (7.8%).

Almost all (92.3%) of the caregivers run errands to buy medications for the patients, about two thirds (63.3%) supplied non-medical needs, more than half (52.3%) collected samples and almost half (47.5%) of them reportedly made payment for services.

Close to half (47%) of the respondents spent less than one week (between 1- 6 days) in the hospital (Table 2). Those who spent more than two weeks and those who spent between one and weeks accounted for 28.5% and 24.5% of respondents respectively. The mean and median length of stay were 1.8 and 2 weeks correspondingly. More than three quarters (79.0%) stayed with their patients both night and day. Less than one fifth (17.7%) stayed only during the day and only a minority (3.3%) stayed only at night.



Majority of the caregivers (88.3%) were aware of the ailment that their patients were being managed for. More than four fifths (85.3%) felt that staying in the hospital had created additional stress for them. Almost half (48.5%) believed their patient will not be well cared for in their absence, another 34.0% were not sure if their patients will be well cared for in their absence and only 17.5% believed their patients will be well cared for in their absence. The most common reasons why respondents believed their patients will not be well cared were inadequate staffing (54.3%), patient being too young to be left alone (20.0%), and the belief that no one can care better (8.6%).

In the course of taking care of their patients, majority (89.2%) spent \leq 1000 naira per day on expenses related to themselves (Table 3). The mean and median amount caregivers spent on themselves was found to be 803.94 naira and 600 naira respectively. Among those employed, about two thirds (63.2%) reported loss of income while caregiving. When asked to quantify the daily income lost, about four fifths (81.7%) reportedly lost an average of \leq 1,000 naira daily. The mean and median average daily loss was 1115.7 naira and the median amount was 3000.0 naira.

Only one tenth (11.0%) received financial support for themselves while caregiving. The commonest sources of support were other relatives (52.3%), friends (22.7%), parents (13.6%) and children 5 (11.4%). Slightly more than half (52.3%) had gotten >5000 naira daily from these sources and the mean and median amount was estimated to be 21931.8 naira and 6500.0 naira respectively. More than half (54.3%) of the respondents spent < 5000 naira daily on their patients. The mean and median amount spent daily was estimated to be 8835.14 naira and 5000 naira correspondingly. Drugs, food and investigations accounted for 84.2%, 14.3% and 1.5% of the patient's needs respectively.

Financial support for the patient was also gotten from other relatives (61.6%), friends (17.2%), church members (5.9%), parents (5.4%) and children (3.4%). Almost all (91.6%) of the respondents had gotten <5000 naira for the care of their patient; the mean and median amount gotten were 73,200 and 40,000 naira respectively.

Discussion

Caregiving cuts across most sociodemographic characteristics though some sects may be

involved than others. In this study, the mean age of caregivers was about 38 years; this is

similar to findings from South West Nigeria[13] and South South Nigeria.[11] This suggests

that majority of caregivers in Nigeria are within the age group of the active labour force. The

study also found a preponderance of the female gender among caregivers. This corroborates

with the known social construct in which women are central to caregiving within the family

setting and also in health care settings.[1,14] Most of the respondents were Yoruba and also

Muslims. This may be related to the fact that majority of the inhabitants in the study area are

Yoruba and practice Islam.[15]

This study found that almost all the caregivers supported their patients physically (running

errands and assisting with activities of daily living) and financially while on hospital admission

in a tertiary health institution in North Central Nigeria. This is similar to findings from other

parts of Nigeria[11,13,16] and other developing countries like India[1] and Iran.[8] Common

to these countries is the shortage of healthcare workers[17,18] and the existing social

cohesive system[19,20] where informal caregivers play a vital supportive role to their patients

during hospital admission.

Almost all the caregivers were relatives of the patients, with most of them being first degree

relatives. This is similar to findings from other studies in Nigeria[11,13,21] and in India.[1]A

probable reason for this is the cultural values and norms of caring within the family system in

these settings. More than two thirds of the caregivers were employed and out of these, most

of them were self-employed. This is in congruence with findings from South West Nigeria[13]

but incongruent with findings from South Nigeria where majority of caregivers were

unemployed or retired.[11] Being self-employed may infer that they are more in control and be more flexible of their time and can afford to stay with their patients in the hospital during work hours compared to those who are employees and are accountable to their employers. Findings from the study show an array of support types rendered by caregivers to their patients while on admission. Running of errands, feeding patients, serving medications, helping with defecation and bathing patients were the commonest forms of care reported. These errands were in form of buying medications, supplying non-medical needs, paying for services and running errands to and from the laboratory. This finding is not unique to the study area, as studies conducted in Nigeria and other developing countries have found that informal caregivers perform nursing duties and also run other errands in the hospital.[1,8,11] This may be due to the fact that healthcare workers may be overwhelmed. Thus, caregivers are needed to support with "non-technical" duties.

More than four fifths of the caregivers perceived staying around their patients in the hospital to be stressful. This is similar to findings to a previous study conducted in Nigeria where caregivers continued to care for their patients in spite of the perception that caregiving is a source of burden.[11]Closely linked to this is the fact that less than one fifths of them felt their patients would be well cared for in their absence. In addition, there was also a common perception that their patients will not be well cared for if they were not around due to inadequate staffing, the patient being too young to be left alone, the perception that no one can care better than them and the non-challant attitude of healthcare workers in the hospital. Olowookere et al found that about two fifths of caregivers were not satisfied with the hospital care received by their patient.[13]

Another important finding was this study was the gap in communication between caregivers and health workers. About one tenth of the caregivers did not know the type of ailment their

patient was being managed for. Similar studies have also identified communication gap

between healthcare professionals and caregivers in developed and developing

countries.[1,22] Caregivers appreciably contribute a supportive role in patient management,

and more so during transition of care following hospital discharge.[23] Good communication

with healthcare workers is associated with a reduced risk of readmission to the hospital.[24]

It is therefore imperative that healthcare workers involve carers, and communicate the nature

of illness, management process and follow up care to achieve optimal patient-related

outcomes.

The study also elucidates the financial burden experienced by caregivers. Implications from

this study suggest that caregivers lose daily income while they are away from their workplace,

giving care to their patients in the hospital. In addition, some spend their money on patients

and also have to spend money on themselves while in the hospital. Majority of them do not

receive financial support from other sources during this period while they experience

increased financial expenses and also a decrease in their income. Similarly, other studies

conducted in Nigeria among informal caregivers have revealed that financial burden as a

major challenge when caring for their loves ones.[11,16] In a study conducted in Nigeria

among caregivers, all of the respondents claimed that the medical bills of their patient was

paid out of pocket.[13]The financial burden faced by these caregivers further highlights the

bane of the limited financial risk protection mechanisms for healthcare services in the country.

Nigeria is a country where less than 5% and only 3% of people in the formal and informal

sectors respectively have health insurance. [25] Health insurance can go a long way in reducing

the financial burden faced by patients and their caregivers.

Limitations

This was a cross sectional study which was conducted in one health facility. The results from

this study might not be generalizable to the entire country. Factors associated with the

support types and the extent of financial burden experienced by caregivers were not

identified. Further research will be needed to identify these factors.

Conclusion

This study provides valuable information on the extent of physical and financial support, and

other challenges experienced by caregivers while staying with their patients on hospital

admission. Findings from this study underpin the need for policy makers, hospital

administrators and other stakeholders to consider the role caregivers play in patient

management and also institute processes to ease the burden that they face. The challenges

caregivers experience can be eased off by the simplification of payment processes, and

assigning a dedicated staff for the submission of laboratory samples, retrieval of results, and

the purchase of medical supplies. These will bring about changes that will results in a more

caregiver friendly environment. Outcomes from this study also highlights the need for

effective communication between healthcare professionals and caregivers in the

management process of their patients. Furthermore, the financial burden experienced by

caregivers reinforces the need to encourage more Nigerians to enrol in a health insurance

scheme.

What is known on this topic?
