- 1 **One Sentence Summary:** Antibody and T cell responses to booster SARS-CoV-2 vaccination
- 2 predict the risk of symptomatic breakthrough infection in kidney transplant recipients

1 Abstract:

As solid organ recipients are at high risk of severe COVID-19 and respond poorly to 2 primary SARS-CoV-2 mRNA vaccination, they have been prioritized for booster vaccination. 3 4 However, an immunological correlate of protection has not been identified in this vulnerable population. We conducted a prospective monocentric cohort study of 65 kidney transplant 5 6 recipients who received three doses of SARS-CoV-2 BNT162b2 mRNA vaccination. 7 Associations between symptomatic breakthrough infection (BTI) and vaccine responses, patient demographic and clinical characteristics were explored. Symptomatic COVID-19 was 8 9 diagnosed in 32% of kidney transplant recipients during a period of six months after the 10 administration of the third vaccine dose. During this period, SARS-CoV-2 delta and omicron were the dominant variants in the general population. Univariate analyzes identified avidity of 11 SARS-CoV-2 receptor binding domain (RBD) binding IgG, neutralizing antibodies and SARS-12 CoV-2 S2 domain-specific IFN-y responses as correlates of protection against BTI. Some 13 demographic and clinical parameters correlated with vaccine responses, but none correlated 14 15 with the risk of BTI. In multivariate analysis, the risk of BTI was best predicted by neutralizing antibody and S2-specific IFN- γ responses, adjusting for age, graft function and mycophenolate 16 mofetil use. In conclusion, both antibody and T cell responses predict the risk of BTI in kidney 17 transplant recipients who received three doses of SARS-CoV-2 mRNA vaccine. T cell 18 responses may help compensate for the suboptimal antibody response to vaccination in this 19 vulnerable population. 20

1 Main text:

2 INTRODUCTION

Solid organ transplant (SOT) recipients are at high risk of severe COVID-19 and death 3 (1-4). This high risk has been attributed to immunosuppressive therapies and to common co-4 5 morbidities, including cardiovascular disease, diabetes, and obesity, that have also been associated with severe COVID-19 and death in the general population (5, 6). While they had 6 7 not been included in COVID-19 vaccine trials, SOT recipients were offered COVID-19 vaccination early in vaccination campaigns. Unfortunately, their responses to COVID-19 8 vaccines were weaker than those of healthy adults: neutralizing antibodies were not detectable 9 in most patients, even after two doses of mRNA vaccine (7). These low vaccine responses were 10 associated with a high incidence of breakthrough infections (BTI), including severe cases (8– 11 12 12). SOT recipients were therefore prioritized for a booster with a third dose of COVID-19 vaccine. Higher levels of SARS-CoV-2 neutralizing antibodies were induced by booster as 13 14 compared to primary vaccination in these patients, in line with what is observed in the general 15 population (13–15). Yet, the level of immunity against BTI achieved by booster vaccination of SOT recipients, especially in the context of emerging SARS-CoV-2 variants, remains poorly 16 defined (16). 17

Serum levels of SARS-CoV-2 neutralizing antibodies are correlated with protection 18 against COVID-19 in the general population (17–20). In addition, booster mRNA vaccination 19 20 is associated with improved vaccine effectiveness in healthy adults (21). An immune correlate of protection against COVID-19 in SOT patients has not been identified. Despite their lower 21 levels in SOT recipients, neutralizing antibodies are likely to play a key role given their 22 23 importance in other populations. On the other hand, other immune effectors, in particular T lymphocytes, could contribute to protection in patients with limited vaccine-induced humoral 24 immunity. Notably, no clinical study has yet identified a correlation between T cell responses 25

1	to vaccination and protection against COVID-19 in the general population, possibly because of
2	a dominant role for neutralizing antibodies when induced at high levels (22).
3	Sociodemographic and clinical factors could also contribute to the risk of BTI in SOT
4	patients. Previous studies identified age, female gender and co-morbidities, such as metabolic
5	syndrome and kidney disease, as risk factors for SARS-CoV-2 BTI (23, 24). It is unclear
6	whether these factors increase the risk of BTI directly, or by reducing the immune response to
7	COVID-19 vaccination. Identifying risk factors for BTI in SOT recipients and their potential
8	impact on COVID-19 vaccine immunogenicity is required to identify high risk patients and to
9	guide COVID-19 booster immunization strategies.
10	This prospective cohort study was undertaken to identify risk factors of BTI in kidney
11	transplant recipients who had received three doses of BNT162b2 COVID-19 mRNA vaccine.

Associations with vaccine-induced immune responses, sociodemographic and clinical factorswere explored.

1 **RESULTS**

2 *Study population*

Sixty-six kidney transplant recipients were screened for the study. One patient was excluded 3 4 because of a positive PCR test on the day of the first COVID-19 vaccination. Characteristics of the 65 patients included in the study are shown in table S1. Mean age was 58.2 years. Mean 5 6 duration of transplantation was 7.4 years. Immunosuppressive treatment included steroids 7 (78%), mycophenolate mofetil (52%), azathioprine (25%), tacrolimus (68%), cyclosporine (14%) and everolimus (23%). During follow-up, one patient required chronic dialysis, one 8 9 patient withdrew consent, one patient was lost to follow-up between the second and the third 10 vaccination, and two patients declined the third dose of vaccine (Fig. 1). No patients died during the study period. 11

13 Incidence of SARS-CoV-2 BTI

Six cases of symptomatic SARS-CoV-2 BTI were diagnosed between the second and the third 14 15 COVID-19 vaccination. Thus, 54 patients were followed-up and received the third dose of vaccine, on average 161 days after having received the first vaccine dose (Fig. 1). One case of 16 symptomatic BTI was diagnosed within 28 days of the third dose of vaccine. At D3D28, 53 17 patients remained free of symptomatic BTI. Seventeen cases were diagnosed between 28 days 18 after the third vaccination and the fourth vaccination, when the study follow-up ended (Fig. 1). 19 Symptoms related to BTI are shown in table S2. One patient experienced moderate COVID-19 20 requiring oxygen supply, and the other 16 patients had mild COVID-19. Curative monoclonal 21 antibodies were administered to 14 patients (83%). At the end of the study period, 36 patients 22 remained free of symptomatic BTI. 23

Figure 2 depicts the cumulative number of symptomatic BTI in the study population over time 1 2 and in relation to the incidence of SARS-CoV-2 infection with individual variants of concern in the Belgian population. During the first period (before D3D28), the incidence rate of SARS-3 CoV-2 BTI in the study population was 0.63 (0.25; 1.30) cases per 1000 person-days. During 4 this period, the daily incidence of COVID-19 was estimated at less than 1 case per 1000 5 6 inhabitants in Belgium, and the alpha and delta VOC were dominant. During the second period (after D3D28), the incidence rate of BTI in the study population was about 4-fold higher: 2.74 7 (1.60; 4.38) cases per 1000 persons-days (comparison of incidence rates between the two 8 periods: p<0.001). During this second period, the estimated incidence of COVID-19 also 9 10 increased in the Belgian population and the delta and BA.1 omicron VOC were dominant (Fig. 2). 11

13 Immune response to COVID-19 vaccination

Administration of a third dose of COVID-19 vaccine significantly increased the levels and 14 quality of SARS-CoV-2 spike-specific antibodies (Fig. 3 and table S3). Geometric mean serum 15 concentration of RBD binding IgG increased from 8 IU/mL after two doses of vaccine to 35 16 IU/mL after three vaccine doses. The proportion of patients with detectable RBD binding IgG 17 was 51% after three vaccinations (27/53). Avidity of RBD binding IgG also increased in 18 patients with detectable RBD IgG with a five-fold slower dissociation rate between the second 19 and third dose of vaccine (from geometric mean of k_{off} : 0.0016 s⁻¹ after the second dose to 20 geometric mean of k_{off} : 0.0003 s⁻¹ after the third dose of vaccine). Neutralizing antibody levels 21 increased similarly, with only 2% of patients having detectable SARS-CoV-2 neutralizing 22 23 antibodies after two doses and 45% of patients after three vaccine doses. In contrast, cellular immune responses to SARS-CoV-2 were similar after the second and third doses of vaccine 24 25 (Fig. 3 and table S3).

2 Risk factors of SARS-CoV-2 BTI following booster COVID-19 vaccination

Potential risk factors for SARS-CoV-2 BTI after the third dose of COVID-19 vaccine were first 3 explored by univariate analysis using logistic regression (Fig. 4 and table S4). An increased risk 4 5 of BTI in kidney transplant recipients was associated with low RBD IgG avidity (odds ratio (95% CI): 0.07 (0.003; 0.61), p=0.04), low titer of neutralizing antibodies (0.15 (0.02; 0.64), 6 7 p=0.027), and low frequency of S2-specific, and not S1-specific, IFNy-producing cells (0.30 (0.11; 0.69), p=0.009). No significant association was detected between the risk of BTI 8 following booster COVID-19 vaccination and the demographic or clinical variables that were 9 analyzed (Fig. 4 and table S4). 10

The absence of significant association between demographic and clinical variables and the risk 11 12 of BTI led us to explore their potential association with the immune response to COVID-19 vaccination. As shown in table S5, older age was associated with lower humoral immune 13 responses to booster vaccination. Lower kidney graft function and mycophenolate mofetil use 14 were associated with lower humoral and cellular immune responses to booster vaccination, 15 whereas the use of azathioprine was associated with higher vaccine responses. Together, these 16 17 results indicate that demographic and clinical variables are associated with differences in immune responses to booster COVID-19 vaccination in kidney transplant recipients even if 18 they are not significantly associated with the risk of BTI in this population. 19

Multi-parametric analysis of immune response to booster COVID vaccination and the risk of
BTI

Multi-parametric serology analyzes were performed to further explore the association between
immune response to booster vaccination and the risk of BTI in kidney transplant recipients.

In multi-parametric analysis, patients who developed SARS-CoV-2 BTI after booster 1 2 vaccination had significantly lower RBD binding IgG titer and lower levels of neutralizing antibodies as compared to patients who remained free of symptomatic BTI (Fig. 5A). A similar 3 same trend was observed with RBD IgG avidity. Patients with BTI also had lower levels of S1-4 specific, but not S2-specific, binding IgG (Fig. 5B). In parallel, patients with BTI had lower 5 6 levels of S1-specific, but not S2-specific, IgG activating cellular phagocytosis (antibodydependent cellular phagocytosis, ADCP). After booster vaccination, only few patients had 7 detectable neutralizing antibodies against delta (n=4), omicron BA.1 (n=1) and omicron BA.2 8 (n=4) (table S6). None of them developed symptomatic BTI. Analysis of cellular immune 9 10 responses confirmed the results of the univariate analysis (Fig. 4): patients with BTI had significantly lower frequencies of S2-specific, and not S1-specific, IFN-y producing cells, as 11 compared to patients with no BTI (Fig. 5C). Humoral immune response parameters (RBD IgG, 12 13 RBD IgG avidity, Wuhan NT₅₀, S1 IgG, S2 IgG, S1 IgG ADCP and S2 IgG ADCP) were highly correlated (Fig. 5D). In contrast, significant but lower correlations were observed between 14 15 humoral and cellular immune response (S1 IFN- γ and S2 IFN- γ) parameters.

17 Multivariate analysis of risk factors of BTI

Multivariate analysis was performed to identify the immunological factors that best predicted 18 the risk of BTI following booster vaccination. Based on the associations observed between 19 20 clinical variables and COVID-19 vaccine responses (table S5), this analysis was adjusted for age, kidney graft function (eGFR) and mycophenolate use. Only variables with a variance 21 inflation factor (VIF) <10 (RBD binding IgG, Wuhan NT₅₀, S1 IgG, S2 IFN- γ) were included 22 23 in the analysis. Wuhan neutralizing antibody titer and S2 IFN- γ responses were the best predictors of BTI following booster vaccination, with odds ratios of 0.036 ((<0.001; 0.501), 24 p=0.028) and 0.145 ((0.016; 0.671), p=0.037), respectively. Based on this analysis, we 25

- 1 estimated that patients with a 10-fold increase in Wuhan NT₅₀ had on average a 28-fold lower
- 2 risk of BTI and patients with a 10-fold increase in S2 IFN-γ responses had on average a 7-fold
- 3 lower risk of BTI.

1 DISCUSSION

In this prospective cohort study, we observed that both humoral and cellular immune responses to booster COVID-19 vaccination predict the risk of symptomatic BTI in kidney transplant recipients. Although age, kidney graft function and the use of mycophenolate were associated with altered vaccine responses, no significant association was observed between these parameters, or other demographic and clinical parameters, and the occurrence of BTI. These data emphasize the importance of inducing adequate immunity through vaccination to protect this vulnerable population from COVID-19.

Our analysis was focused on kidney transplant recipients who had not been diagnosed with 9 10 COVID-19 either before vaccination or before the response to booster vaccination was measured. Patients had low humoral immune responses after two doses of mRNA vaccine, 11 12 confirming previous studies in SOT recipients (13–15). Humoral immunity was significantly enhanced by booster vaccination, as observed in the general population (21). In contrast, 13 14 cellular immune responses were similar following two doses of vaccination and after booster 15 vaccination. Enhanced cellular immune responses following booster vaccination was observed in the general population, suggesting that boosting of cellular immunity may be more difficult 16 to achieve in SOT recipients as compared to healthy adults (25). Despite enhanced immunity 17 following booster vaccination, patients remained at high risk of SARS-CoV-2 BTI. Thirty two 18 percent of our study population developed symptomatic BTI in the first 6 months following 19 booster vaccination. This incidence was significantly higher than the one observed before 20 booster vaccination, most likely because of the higher virus circulation of delta and omicron 21 VOC during this period. This observation further emphasizes the importance of booster 22 23 vaccination to prevent COVID-19 in SOT recipients (8, 9). Most patients received therapeutic monoclonal antibodies to prevent severe COVID-19 and only one patient required oxygen 24 25 supplementation.

To our knowledge, this is the first report on correlate of protection against COVID-19 in SOT 2 recipients. As observed in the general population, the antibody response to COVID-19 3 4 vaccination was associated with protection of kidney transplant recipients against BTI with VOC (20). As already published in the general population, the strongest association with 5 6 protection against BTI in SOT was observed with Wuhan neutralizing antibody titer (18, 20). 7 In addition to SARS-CoV-2 neutralization, antibodies mediate viral control via Fc-dependent effector functions, including ADCP. We observed high correlations between the titers of 8 9 binding, neutralizing and ADCP-promoting antibodies against SARS-CoV-2 RBD and S1 10 subunit, indicating a strong coordination between the diverse effector components of the antibody response. S1-specific ADCP-promoting IgG were higher in patients who remained 11 free of BTI following booster vaccination, supporting the notion that they may also contribute 12 to vaccine-induced protection. In contrast, S2-specific binding and ADCP-promoting IgG were 13 similar in patients who developed or did not develop BTI. This observation suggests a dominant 14 15 role of S1-specific antibodies in mediating protection against BTI in this population.

16 The S2-specific IFN- γ response to booster vaccination was the second most important predictor of BTI. As no significant association was observed with S1-specific IFN-y responses, our data 17 18 suggest a differential role of SARS-CoV-2 subunits in mediating protection following mRNA vaccination. As the S2 subunit is more conserved than the S1 subunit across SARS-CoV-2 19 20 VOC, it may be an important target for cell-mediated immunity against the delta and omicron variants to which our study population was exposed. To our knowledge, this is the first study 21 22 indicating a role for cellular immune response to vaccination in protection against COVID-19. 23 As suggested by Kent et al, a role for T cell immunity may be difficult to reveal in healthy adults who have optimal antibody responses to vaccination that may dominate protective 24 immunity against COVID-19 (22). The suboptimal humoral immune response to vaccination 25

observed in SOT recipients may increase the importance of cellular immune responses in this
population. Supporting this notion, a role for vaccine-induced T cell immunity in the context of
low humoral immunity was shown in non-human primate studies of COVID-19 (26).

5 This study has several limitations. First, its sample size is relatively low because it was a single centre study. This limitation was decreased by the high incidence of symptomatic BTI during a 6 7 period when delta and omicron VOC were dominant, allowing us to detect statistically significant associations with immunological parameters. A larger sample size may have 8 allowed us to detect significant associations with demographic and clinical parameters. Further 9 studies of correlates of protection in SOT recipients are needed to validate our observations. 10 Second, the study did not include systematic screening of SARS-CoV-2 by PCR and therefore 11 12 did not allow us to diagnose asymptomatic SARS-CoV-2 BTI. Such systematic screening was considered too challenging by the patients and by the study team. Instead, priority was placed 13 14 on diagnosing symptomatic BTI, which we consider to be diagnosed with high sensitivity. 15 Third, the study does not provide information regarding immunity against severe COVID-19, as most patients experiencing a BTI received therapeutic monoclonal antibodies and 16 consequently presented mostly mild symptoms. Finally, while the very strong dominance of 17 delta and omicron VOC in the Belgian population during the study period indicates that these 18 were likely the cause of BTI in our study population, sequencing of SARS-CoV-2 was not 19 performed systematically following diagnosis of BTI. Differences in correlates of protection 20 against delta and omicron variants have been suggested and may have influenced our results 21 (27). 22

In conclusion, this study shows that humoral and cellular immune responses induced by booster
 vaccination correlate with protection against SARS-CoV-2 BTI in kidney transplant recipients.
 These data emphasize the importance of reaching and maintaining a high level of immunity

through vaccination in this vulnerable population and suggest that vaccines inducing potent
 cellular immune responses, such as mRNA vaccines, may be particularly useful in populations
 with suboptimal humoral immune responses to vaccination.

5 MATERIALS AND METHODS:

6 Study design and population

7 This single centre prospective phase IV investigator-initiated study of the immunogenicity of the BNT162b2 vaccine (Pfizer-BioNTech) in kidney transplant recipients was approved by the 8 9 ethics committee of the Erasme Hospital (P2020/284 and A2021/131) and by the Belgian Federal Agency for Medicines and Health Products (FAMHP, EudraCT 2021-000-412-28). 10 Kidney transplant recipients aged at least 18 years were recruited in the Department of 11 Nephrology, Dialysis and Transplantation of the Erasme Hospital, Belgium. They were 12 informed and gave informed consent before administration of the first dose of BNT162b2 13 vaccine. Patients transplanted with multiple organs were excluded from the study. Patients 14 infected with SARS-CoV-2 before BNT162b2 vaccination were not included in this report. 15 Previous SARS-CoV-2 infection was defined as a history of a positive PCR on nasopharyngeal 16 swab before study recruitment and/or a positive serology (Wantai SARS-CoV-2 IgG Elisa, see 17 Supplementary methods) at recruitment, before administration of the first dose of BNT162b2 18 vaccine. Patients were seen by a study clinician at enrolment before the first dose, one month 19 20 after the second dose and the day of the third dose of vaccine. Demographic and clinical data were recorded, including age, gender, body mass index, comorbidities (hypertension, diabetes, 21 cardiovascular disease, chronic kidney insufficiency defined with eGFR < 30mL/min in CKD-22 23 EPi and evolutive or treated cancer), characteristics of transplantation history (duration, rank, graft function, induction treatment and immunosuppressive drugs), and absolute lymphocyte 24 25 count.

All patients received the BNT162b2 vaccine at day 0 and day 21, according to the Belgian 1 national vaccination program. The first vaccine dose was administered between March 2nd and 2 March 18th, 2021, and the second dose between March 23rd and April 8th, 2021. The third dose 3 of BNT162b2 vaccine was administered between August 17th and 20th, 2021, following an 4 amendment of the study protocol approved by the Belgian FAMHP. BNT162b2 is a lipid 5 nanoparticle-formulated, nucleoside-modified mRNA vaccine encoding a prefusion stabilized, 6 membrane-anchored SARS-CoV-2 full-length spike protein (28). The 30µg/0.3 mL dose was 7 administered by intra-muscular injection into the upper arm. Vaccines were administered by a 8 trained study nurse at Erasme Hospital. Participants were observed for a minimum of 15 9 10 minutes after vaccination. No serious adverse events were observed.

12 Breakthrough infection

13 Following recruitment, symptomatic SARS-CoV-2 breakthrough infections (BTI), defined as the occurrence of fever, chills, cough, dyspnoea, rhinitis, anosmia, dysgeusia, abdominal pain 14 15 or diarrhoea, associated with a positive SARS-CoV-2 PCR on nasopharyngeal swab, were 16 recorded. Patients were informed of symptoms compatible with COVID-19 and were encouraged to be tested by PCR of a nasopharyngeal swab in case of such symptoms. Patients 17 18 were regularly contacted by phone and/or by email to limit unreported BTI. The following data were recorded when a BTI was diagnosed: symptoms, date of symptom onset, oxygen 19 requirement, organ failure and treatment, including curative monoclonal antibodies. The date 20 21 of BTI was defined as the date of symptom onset. Only the first symptomatic BTI was included in the data analysis. 22

24 Immune response to BNT162b2 vaccination

Humoral and cellular immune responses to BNT162b2 vaccination were measured one month 1 2 after the second vaccine dose (D2D28) and one month after the third vaccine dose (D3D28). Pre-vaccination immune responses to SARS-CoV-2 were analyzed as baseline. Humoral 3 immune responses measured included SARS-CoV-2 receptor binding domain (RBD)-specific 4 binding IgG and avidity, SARS-CoV-2 Wuhan, B.1.617.2 Delta variant (83DJ-1), BA.1 5 6 Omicron variant and BA.2 Omicron variant neutralizing antibodies, and SARS-CoV-2 S1 and 7 S2 domain binding and phagocytosis inducing IgG. Cellular immune responses measured included S1 and S2 domain-specific IFN-y-producing cells. For detailed laboratory methods, 8 see Supplementary Material. 9

11 *Statistical analyzes*

Occurrence of SARS-CoV-2 BTI during the study period (from March 2nd-18th, 2021, to 12 13 February 1st, 2022) was plotted as a Kaplan-Meier survival curve. The incidence of SARS-CoV-2 infection diagnosed in Belgium during the study period and the proportion of infections 14 15 with variants of concern (VOC) circulating in Belgium were included in the graph to provide 16 the epidemiological context of the study (29). Incidence rate (person-day rate) of BTI was defined as the ratio of breakthrough infections (BTI) divided by the time each patient was 17 18 observed, totalled for all the patients. It was calculated for two different periods: (1) from the first day of vaccination to D3D28, and (2) from D3D28 to February 1st, 2022, when the fourth 19 dose of COVID-19 vaccine was administered. Descriptive data were evaluated with geometric 20 21 means (95% CI) for continuous variables, and n (%, 95% CI) for binary values. Descriptive 22 data were compared by t-test or Wilcoxon-Mann-Whitney rank test for parametric and nonparametric values, respectively, according to D'Agostino normality test. A Wilcoxon signed 23 rank test was used to test paired sampled, when comparing two time points. The proportion of 24 participants with antibody levels higher than the lower limit of detection (LLOD) at D2D28 or 25

1 D3D28 were calculated for SARS-CoV-2 RBD binding IgG (LLOD: 5.4 IU/mL according to 2 WHO standard) and neutralizing antibodies (LLOD: 77 IU/mL according to WHO standard). For RBD binding IgG and neutralizing antibodies, antibody concentrations below the limit of 3 4 detection were assigned a value equal to half of the LLOD before transformation. RBD IgG avidity was measured for samples with detectable binding RBD IgG only. For IFN- γ ELISpot, 5 data equal to 0 or less than 0 after subtraction of background were assigned a value of 1 before 6 7 transformation. Values higher than 300 spots forming cells/250,000 PBMC were censured at 8 1.200/ 10⁶ PBMC. The proportion of participants with cellular responses higher than an arbitrary cut-off of 50 SFC/10⁶ PBMC in IFN-γ ELISpot were calculated at D2D28 or D3D28. 9 10 Association between immune variables and demographic and clinical variables were explored by linear regressions. Univariate logistic regression was used to explore the factors associated 11 with the occurrence of BTI for the period between D3D28 and February 1st, 2022. Variables 12 13 with a p-value < 0.1 in univariate analyzes were included in a variance inflation factor (VIF) analysis. To avoid multi-collinearity, only variables with VIF<10 were included in multivariate 14 15 analysis. A multivariate logistic regression model was built to analyze risk factors of BTI, 16 adjusting for age, kidney graft function and mycophenolate mofetil use, considered as important variables influencing immune responses to SARS-CoV-2 vaccination, based on our linear 17 18 regression data and on published data (30, 31). Missing data were excluded from the final 19 analysis. The final model was selected based on backward selection of variables. All statistical analyzes were done using R version 4.2.0 (32). 20
