1	Metagenomic analysis after selective culture enrichment of wastewater demonstrates
2	increased burden of antibiotic resistant genes in hospitals relative to the community

45 Abstract

46 Antimicrobial resistance (AMR) is an ever-increasing threat to global health. Wastewater-based 47 surveillance is an emerging methodology that objectively enables an inclusive and 48 comprehensive assessment of population AMR in an observed sewershed. Here we compared the resistome of two tertiary-care hospitals with two separate neighborhoods, using complimentary 49 50 targeted qPCR and metagenomics of wastewater before and after selective culture enrichment for clinically important Gram negatives. In total 26 ARG-type (1225 ARG-subtypes) were found 51 52 across all samples, in which β-lactam ARG was the richest (the number of different ARG-53 subtypes found) followed by multidrug, fluoroquinolone, macrolide-lincosamide-streptogramin 54 (MLS) and aminoglycoside. The composition of ARGs in wastewater differed between raw 55 wastewater pellets and culture-enriched wastewater samples and the resistomes clustered based 56 on the type of location (Hospitals vs neighborhoods). Hospital wastewater was found to have higher diversity and greater abundance of ARGs compared to neighborhood wastewater when 57 the composition profiles of ARGs in both raw and culture-enriched wastewater pellets. 58 59 Clinically relevant ARG (i.e., VIM, NDM metallo-ß-lactamases) were detected in culture 60 enrichment samples that were not identified in raw samples, despite a lower targeted sequencing depth. Wastewater-based surveillance is an effective, and potentially extremely important and 61 powerful tool that could be developed to augment hospital-based infection control and 62 antimicrobial stewardship programs, creating a safer space for those receiving care. 63

65 **INTRODUCTION**

66 The emergence and spread of antimicrobial-resistant organisms (AROs) is a profound global 67 health threat (Mulvey and Simor 2009; Finaly B et al. 2019). AROs result in disproportionally 68 higher morbidity and mortality, and incur huge healthcare costs (Cosgrove et al. 2003; Tumbarello et al. 2015; Morata et al. 2012; Zimlichman et al. 2013; Valiquette, Chakra, and 69 70 Laupland 2014; Ghantoji et al. 2010). Globally, ARO-related deaths are expected to rise to 10 million/year by 2050, costing the global economy >\$100 trillion in lost productivity 71 72 (Strathdee, Davies, and Marcelin 2020). In particular, emerging threats such as Enterobacterales 73 and *Pseudomonas aeruginosa*-producing extended-spectrum β-lactamases (ESBLs) (Peirano et 74 al. 2020; Holland et al. 2020; Peirano et al. 2012; Pitout et al. 2007; Pitout et al. 2004), metallobeta-lactamases (MBLs) (Matsumura et al. 2018; Peirano et al. 2018; Parkins et al. 2007; Pitout, 75 76 Nordmann, et al. 2005; Pitout, Gregson, et al. 2005; Doyle et al. 2012) and KPC carbapenemases (Doyle et al. 2012; Stoesser et al. 2017; Chan et al. 2013) are associated with increasing 77 incidence, and few potential treatment options and thusly recognized as key organisms of 78 79 concern by the World Health Organization and US Centers for Disease Control and Prevention.

Recently Mitchell and collaborators (2022) performed an exploratory analysis of AMR and 80 81 proposed a framework to align AMR research with AMR policy and its connections across the 82 One Health landscape (i.e., humans-animals-environment). Two of the eight key themes that were emphasized was the optimizations of AMR surveillance and the understanding of AMR in 83 the environment (Mitchell, O'Neill, and King 2022). These key aspects require a broad 84 knowledge of resistance burden within the community and understanding of the drivers behind 85 86 AMR outbreaks/hotspots. In the light of this, wastewater-based surveillance (WBS) has been described as a potential tool that could be adapted for this purpose. Indeed, WBS has proven 87

transformative in understanding the COVID-19 pandemic (Acosta et al. 2021; Acosta et al. 2022;
Acosta et al. 2023; Peccia et al. 2020; Randazzo et al. 2020; Miyani et al. 2021; Zhu et al. 2021;
Xiao et al. 2021; Zhan et al. 2022; Galani et al. 2022; Hegazy et al. 2022; Hubert et al. 2022).
WBS's major advantage is its ability to objectively monitor entire populations passively and
comprehensively, making it accurate, inclusive and cost-effective (Choi 2020; Sims and
Kasprzyk-Hordern 2020).

94 Multiple approaches have been used in initial investigations of AMR in wastewater including both culture-dependant and independent approaches. These works have increasingly identified 95 96 clinically relevant ARGs in wastewater, including Metallo-*β*-lactamases (MBLs) (e.g., New 97 Delhi Metallo-beta-lactamases (NDM), VIMs, IMPs) and mobile colistin resistance (i.e., Mcr-1) (Mittal 2019; Lira et al. 2020; Fleres et al. 2019). A limitation of metagenomic assessment of 98 99 environmental samples relates to sequencing depth, with progressively greater costs incurred 100 with higher sequencing depths when assessing for ultra-rare gene targets (Zhang et al. 2015; Wang et al. 2015). Furthermore, accurate gene identification and classification is dependant on 101 102 factors including efficient assembly of short-read fragments into large contigs, inhibitory factors 103 in the matrix, and contaminating host DNA. Selective culture enrichment is an elegant technique, 104 uniquely positioned to augment metagenomic assessment of complex samples overcoming some of these limitations (Whelan et al. 2020; Zhang, Zhang, and Ju 2022; Wang et al. 2021). For 105 106 instance, manipulating growth conditions, specific phenotypes of interest (i.e., those mediate via 107 transmissible beta-lactamases) can be differentially increased potentially improving the detection 108 limits of agnostic approaches for ultra-rare genes. Furthermore, culture enrichment also 109 increases the potential to ascribe individual ARG to those organisms carrying them in the natural 110 environment (Miłobedzka et al. 2022; Marano et al. 2021).

111 Herein, we assessed the resistome of wastewater from multiple tertiary care hospitals and 112 neighborhoods in Calgary, Canada, by deploying complementary metagenomic analysis of raw pellet and selectively culture-enriched wastewater samples to identify genes mediating 113 114 antimicrobial resistance of critical pathogens. Hospitals represent a unique and under explored area for wastewater-based surveillance applications. Indeed, infections represent the area where 115 116 hospitals are most vulnerable, yet least resourced to respond dynamically, and new tools to 117 augment infection control, and antimicrobial stewardship are desperately required. The aims of this work were i). establish if the resistome of hospital wastewater differed from the general 118 119 population, ii). determine if specific class of ARG existed disproportionally in hospitals and iii). determine if selective culture enrichment would increase the potential of conventional 120 121 metagenomics approaches in detecting ultra-rare ARG of clinically relevant Gram negatives.

122 MATERIAL AND METHODS

123 Wastewater collection

124 Twenty-four-hour composite wastewater was collected from two hospitals (Hospital-1 and 125 Hospital-2) and two neighborhood locations (NE1 and NW1) (Supplementary Figure 1) in the summer of 2021 across Calgary, Alberta Canada. Hospital sampling locations were chosen for 126 127 their comprehensive and exclusive coverage of each site's sewershed (Acosta et al. 2021). These two hospitals encompass 47% of regional tertiary-care adult beds in the city of Calgary: 128 Hospital-1 (Northeast Calgary, ~511 inpatient beds) and Hospital-2 (Southwest Calgary, ~611 129 inpatient beds). Neighborhood locations were chosen based on ease of access and similar size of 130 population served (i.e., NE1: 44,839 and NW1: 46,008), where population size was estimated 131 based on the number of service connections (Acosta et al. 2022) and to capture populations of 132 133 diverse socioeconomic backgrounds. For example, NE1 relative to NW1 had an average

household size of 3.78 vs NW1 2.72 individuals; percentage of constituents belonging to a
visible minority of 81.1% vs 35.6 and an average household income of \$36,809 (Canadian) vs
68,228 as determined using federal census data (ref). Wastewater samples were time-weighted,
in which autosamplers were programmed to collect 100 ml of wastewater every 15 mins, for a
total of 96 pooled samples over a period of 24 h. Samples were collected and stored on ice by
City of Calgary staff using a standardized protocol (Acosta et al. 2021; Acosta et al. 2022). This
project was approved by the Conjoint Regional Health Ethics Board (REB20-1252).

141 Pellet collection and culture enrichment

Wastewater pelleting was adapted from a published protocol (Che et al. 2019). Briefly, two aliquots of 40 ml were taken from each composite sample after thorough mixing. Samples were centrifuged at 4200 rpm for 20 minutes at $4\Box$. The supernatant from each was carefully removed and discarded, and the pellets combined. The total volume of pellet recovered was recorded and used for further calculations. All processed pellet samples were either stored at -20°C before DNA extraction or were immediately plated for culture-enrichment steps.

In an attempt to increase detection of Gram-negative resistance mechanisms, 50 µl of each fresh 148 pellet was plated and spread onto MacConkey agar plates supplemented with either 8µg/ml 149 150 meropenem (MEM), 4µg/ml ciprofloxacin (CIP), 8µg/ml ceftriaxone (CRO) or 2µg/ml colistin (COL). Plates were incubated overnight (12 h) at 37 °C. Bacterial growth was collected by 151 adding 1 ml of UltraPure[™] DNase/RNase-Free Distilled Water (Invitrogen) to plates, physical 152 scraping to collect growth, and the final volume collected. The total volume of the culture-153 154 enriched wastewater pellet recovered was recorded and used for further calculations. All the processed culture-enriched wastewater pellets were stored at -20°C before DNA extraction. 155

156 DNA extraction, library preparation and shotgun metagenomic sequencing

157 Aliquots of 250 µl of either the raw wastewater pellet or culture-enriched pellet were used for 158 total genomic DNA extraction using the PowerSoil DNA Isolation Kit (Qiagen) according to the 159 manufacturer's recommendations. An extraction blank control was included for every processed 160 sample batch to ensure no contamination occurred. DNA concentration was measured using the 161 Qubit fluorometer (Thermo Fisher Scientific). All extracted DNA samples were sent out for 162 library preparation and shotgun metagenomic sequencing to Novogene Corporation Inc., California, USA. Paired-end sequencing $(2 \times 150 \text{ bp})$ sequencing was performed on Illumina 163 164 Novaseq 6000 PE150 platform with a sequencing output target of ~10 giga-bases (~33M paired 165 reads/sample) for the raw pellets and 6 giga-bases (~20M paired reads/sample) for the culture-166 enriched samples (Supplementary Table 1).

167 **Bioinformatics workflow**

168 Illumina raw reads were first filtered by our sequencing provider (Novogene, USA). In 169 particular, i) reads containing adapters were removed, ii) reads containing N>10% were 170 removed, where N represents a base that cannot be determined; and iii) reads containing low quality (Q score \leq 5) were removed. The base qualities and adapter contamination were double-171 172 checked by the authors using FastQC (v.0.11.9)(Andrews 2010), and further trimmed using 173 Trimmomatic (v0.39) (Bolger, Lohse, and Usadel 2014). For annotating ARGs to the trimmed reads, we used DeepARG-SL pipeline v2.0, which aligns reads against DeepARG-DB v2.0 174 175 database which includes ARGs found from multiple public databases (i.e., CARD, ARDB, 176 UniProt, and also 16S rRNA gene databases (i.e., SILVA and Greengenes)) (Arango-Argoty et 177 al. 2018; Arango-Argoty et al. 2016). The DeepARG-SL pipeline v2.0 outputs were subject to 178 further analysis, for instance to calculate coverage (or ARG copy) (E1), and normalized ARG

abundance (E2) for each subtype homologues (e.g., OXA-1, -2, etc.) according to the customized
workflow written in Python (v3.5.3).

where number of reads is the number of ARG read identified to a specific ARG; read length is 184 185 the sequence length (bp) of the Illumina reads (i.e., 150 bp); reference length is the sequence 186 length of the corresponding target ARG sequence referring to DeepARG-DB v2.0 database 187 (Arango-Argoty et al. 2018); Number of 16S sRNA copies is the number of the 16S rRNA gene 188 sequence identified in each sample; and the 16S rRNA gene length is the sequence length of 16S 189 rRNA gene (i.e., 1432 bp) (Yang et al. 2016). All downstream analyses was performed using 16S 190 rRNAs-normalized ARG abundance hereafter. Identified ARG subtypes were categorized and 191 aggregated by ARG-types which refers to the antimicrobial agents to which each gene confers resistance (Figure 1A). The workflow using an example dataset will be available in the second 192 193 author's GitHub page (https://github.com/myjackson) upon acceptance of this manuscript to a journal or request from reviewer. The raw reads will be available in the National Center for 194 Biotechnology Information (NCBI) Sequence Read Archive (SRA) repository, under the 195 BioProject ID XXXX (http://www.ncbi.nlm.nih.gov/bioproject/XXXX). The data will be 196 released to the public when the manuscript is formally accepted for publication. 197

198 **ARG qPCR assays**

199 qPCR was performed to objectively quantify the absolute abundance of different ARGs of 200 interest (i.e., *bla*_{CTX-M-1}, *bla*_{KPC-3}, *bla*_{NDM-1}, *vanA*) in raw and enriched wastewater pellets. For each ARG detection, 10 µl reaction contained 5 µl of TaqMan® Fast Advanced Master Mix 201 202 (Applied Biosystems), 0.5 µl of TaqMan Gene Expression assay (Thermo Fisher Scientific) (Supplementary Table 2), and 4 µl of the template DNA. For all ARG qPCR assays, the qPCR 203 program reaction consisted of an initial step at 50°C for 2 min, then a step at 95°C for 2 min 204 205 followed by 40 cycles of 95°C for 1 s, 60°C for 20 s. A 9-fold dilution series of double-stranded 206 DNA fragments (Integrated DNA Technologies (IDT), USA) were synthesized for each ARO 207 qPCR assay (Supplementary Table 3) and were run in triplicate on every 96-well PCR plate to produce standard curves and used to estimate the absolute quantity (copies/µl). 208

For total burden of specific antimicrobial resistant organisms (AROs) and associated 209 210 determinants (i.e., *Clostridioides difficile* (CD) and *tcdA*), each 10 µl reaction contained 5 µl of 211 TaqMan® Fast Advanced Master Mix (Applied Biosystems), 0.5 µl of a mix of forward and 212 reverse primers, 0.5 µl of probe (Supplementary Table 2); and 4 µl of the DNA template. For 213 both CD 16S rRNA and tcdA qPCR assays, the qPCR program reaction consisted of an initial step at 50°C for 2 min, then a step at 95°C for 2 min followed by 50 cycles of 95°C for 1 s, 56°C 214 for 20 s. A 7-fold dilution series of double-stranded DNA fragments (Integrated DNA 215 216 Technologies (IDT), USA) was synthesized and used (Supplementary Table 3) and were run in 217 triplicate on every 96-well PCR plate to produce standard curves and used to estimate the 218 absolute quantity (copies/ul).

For total bacterial load determination (16S rRNA gene copies/ml of wastewater), each 10 μ l reaction contains 5 μ l of TaqMan® Fast Advanced Master Mix (Applied Biosystems), 0.5 μ l of a mix of forward and reverse primers, 0.5 μ l of probe (Supplementary Table2); and 2.5 μ l of the

222 DNA template. The qPCR program reaction consisted of an initial step at 50°C for 2 min, then a step at 95°C for 2 min followed by 40 cycles of 95°C for 1 s, 62 °C for 20 s. A 9-fold dilution 223 series of P. aeruginosa genomic DNA PA01 strain (62.5 to 1.6 X 10⁻⁴ ng/µl) was used as 224 225 standard curve. Data were converted from DNA concentration (ng/µl) to 16S rRNA copy number as previously described by Zhao et al (Zhao et al. 2012). The number of 16S copies in a 226 given reaction was multiplied by the total number of nanograms in the entire sample DNA prep 227 228 and total eluted volume after DNA extraction and then divided by the volume of wastewater used 229 for DNA extraction to give an absolute abundance of 16S copies/ml of wastewater. All samples 230 were assayed in duplicate, and all runs contained non-template control. All qPCR reactions were 231 carried out in the QuantStudio 5 Real-time PCR systems (Applied Biosystems).

232 Statistical analysis

Alpha-diversity was calculated to estimate the ARG diversity from the metagenomic sequencing 233 data using Shannon Diversity index (SDI). SDI was compared between hospitals $(n \square = \square 8)$ and 234 235 neighborhoods (n=8) locations from the culture-enriched wastewater pellet samples using Mann-236 Whitney test ($\alpha \square = \square 0.05$). Kruskal-Wallis Test was performed to test for differences in SDI 237 across samples after culture-enrichment based on the antibiotics used. Beta-diversity clustering 238 plots (i.e., non-metric multidimensional scaling (NMDS)) were generated using the Bray-Curtis 239 dissimilarities metrics of the ARG-subtypes to visualise potential clustering patterns among samples. Analysis of similarity (ANOSIM) (Somerfield, Clarke, and Gorley 2021) was 240 241 conducted to determine the significance of dissimilarities between/among groups. Permutational 242 multivariate analysis of variance (PERMANOVA) tests were performed to test differences in the Bray-Curtis distance matrices. Both ANOSIM and PERMANOVA were performed with 243 permutations=999 using the vegan package in R. Two-proportions z-test was used to evaluate the 244

richness distribution of ARG-types across all samples. When appropriate, P-values were adjusted
for multiple comparisons by using Benjamini–Hochberg P-value correction for multiple testing.
All data analyses and visualizations were performed in GraphPad Prism-9 software (La Jolla,
CA) and in R (V4.0.4).

250 **RESULTS**

251 General composition profiles of ARGs in wastewater samples

252 Metagenomic DNA isolated from wastewater samples was used to determine ARGs profiles. 253 Shotgun metagenomic sequencing yielded 1.24 billion raw reads; 31.8% and 68.2% of those sequences were obtained from raw wastewater pellets (n=4) and culture-enrichment samples 254 255 (n=16), respectively. Sequencing produced (mean \pm SD) ~98.6 \pm 22.1 million raw reads per raw wastewater pellet, and 49.7 ± 13.7 million reads per culture-enriched pellet sample 256 257 (Supplementary Table 1). Out of the total sequenced reads, 5.3 million raw reads were 258 successfully aligned to the DeepARG-database and used for the normalization analysis. To 259 compare levels of ARGs between groups we normalized the abundance of each ARG by dividing 260 raw reads by the total abundance of the 16S rRNA copies. ARGs in the all samples comprised 26 main ARG-types (Figure 1A) and 1225 ARG-subtypes (Supplementary Table 4), of which the 261 most rich (the number of different ARG-subtypes found) ARG-type that was identified was β-262 lactam resistance (57.6%), followed by multidrug (11.8%), fluoroquinolone (5.6%), macrolide-263 264 lincosamide-streptogramin (MLS) (5.4%), aminoglycoside (4.6%), tetracycline (3.9%) and 265 glycopeptide (2.4%) resistance genes (Figure 1A). There were differences in the distribution of the proportion of some ARG-type identified between pellet and culture-enrichment samples 266

267 (Figure 1B). The proportion of β -lactam ARGs-type identified in samples selectively enriched by 268 culture was greater than in raw pellets (adjusted P-value <0.05). In contrast, multidrug, MLS, 269 tetracycline and glycopeptide ARGs-types identified in raw wastewater pellets was greater than 270 in culture enriched samples (adjusted P-value <0.05).

271 Composition profiles of ARGs in wastewater differs between raw wastewater pellet and

272 culture-enriched wastewater pellet

273 To determine whether culture enrichment was a suitable approach for identifying ARG in wastewater samples, we calculated a normalized abundance ratio of a given ARG-type after 274 275 culture enrichment relative to raw pellets (Enrichment factor (EF)). Out of the 26 ARG-types 276 found in this study (Figure 1), 19 (73%) were found to have increased abundance compared to raw wastewater pellets regardless of the antibiotic that was used for selection (Table 1). The 277 ARG-types categories which had the greatest increase after culture enrichment was polymyxin, 278 (median EF of 23.9, IQR 12.1-37.9) followed by aminoglycoside:aminocoumarin, 279 280 nitroimidazole, and triclosan. In contrast tetracycline, bacitracin and rifamycin had the smallest 281 EF across all categories. A few ARG-types were found to have EF decrease after culture enrichment regardless of conditions tested (i.e., glycopeptide) or in neighborhood samples 282 283 regardless of the antibiotic that was used for selection (i.e., antibacterial free fatty acids, and pleuromutilin) (Table 1). Bicyclomycin was the only ARG-type that was detected only in 284 culture-enriched wastewater pellets but not in wastewater pellet samples. 285

To better understand the differences in resistomes across locations and conditions, we calculated the Bray-Curtis dissimilarities and found a clustering of samples based on treatment (i.e., before and after culture enrichment) and sample location (i.e., hospital and neighborhood) (Figure 2). We performed ANOSIM test and found that overall beta diversity values by treatment (ANOSIM

statistic R=0.799, P=0.0012) and sample location (ANOSIM statistic R=0.112, P=0.0463) were significantly different. To further test the effect of treatment and sample location we performed PERMANOVA test to determine the effect of those variable on the resistome. ARG-subtypes profiles were found to be distinguishable by treatment (R^2 =41.7, P=0.001) but not by collection location (R^2 =9.6, P=0.09).

295 Because β -lactam resistance was identified as the most diverse ARG-type and its clinical 296 importance, we further analysed the normalized abundance ratio of specific β -lactamases before and after culture enrichment. β-lactamases were grouped by the Ambler classification and the EF 297 298 was calculated. For most of the β -lactamases analysed there was an increase in their abundance 299 after enrichment (Figure 3). CTX-M and AmpC had the highest average EF value regardless of the antibiotic used (101 and 90 EF, respectively). The overall average EF values were the 300 301 smallest for KPC (6.7) and NDM (3.2) across all conditions (i.e., antibiotic selection) (Figure 3). However, KPC and NDM were the least abundant of these gene types, and their EF ratios for 302 many neighborhood samples could not calculated (indicated as FNQ) as they were only 303 304 identified after enrichment (i.e., not in raw pellet). A few β -lactamases (i.e., OXA and GES) 305 were found to have decreased in abundance after culture enrichment. VIM was only detected at Hospital-1 location, where the EF value was 36.3 with MEM. 306

To characterize in greater detail several of the β -lactamases that we observed EF values increase (i.e., CTX-M and NDM) or decrease (i.e., OXA) after culture enrichment, the normalized ARG abundance was analyzed by ARG-subtypes. We found 61 different CTX-M enzyme types, where CTX-M- 90, 29 and 84 were the most abundant, found across all sample locations and antibiotic tested (Figure 4A). CTX-M 14 and CTX-M-15 variants were found in many conditions (i.e., before and after culture enrichment) across all sample locations (Supplementary Table 4). We

found 10 NDM variants across all resistomes analyzed. NDM-3, 17 and 2 were the most abundant variants found across all samples (Figure 4B). Finally, we found 152 OXA enzyme variants, where OXA-1, -3 and -9 were the most abundant across all samples (Figure 4C).

316 Composition profiles of ARGs in culture-enriched wastewater pellet samples

ARG diversity analysis of hospital and neighbourhood wastewater from culture-enriched pellet 317 318 samples was performed by measuring the Shannon diversity index (SDI). The median SDI for hospitals: 4.7 (IQR: 4.4 - 4.81) and neighborhoods: 4.43 (IQR: 3.91 - 4.54)) was significantly 319 different between locations regardless of enrichment condition (Figure 5A, P< 0.05, Mann-320 321 Whitney test). We also analyzed the SDI to understand overall alpha-diversity across all cultureenriched conditions (Figure 5B). Median SDI was highest for wastewater enriched on 322 MacConkey agar plates supplemented with ceftriaxone (SDI median 4.7, IQR: 4.4-4.7), followed 323 by ciprofloxacin (SDI median 4.6, IQR: 4.4-4.7), meropenem (SDI median 4.5, IQR: 3.9-4.6) 324 and colistin (SDI median 3.9, IQR: 3.9-4.2) (P<0.05, Kruskal-Wallis test). 325

326 Clustering of wastewater resistomes in NDMS ordination plot was shown to be influenced by 327 location sample location as demonstrated by the Ordination plot at the ARG-subtype level (Figure 5C) with similar results at ARG-type (data not shown). Similarly, NMDS ordination plot 328 329 showed a separation of resistomes based on the antibiotic used for selection. The separation between hospital and neighborhoods and between antibiotic used after culture enrichment was 330 further tested with ANOSIM (ANOSIM statistic R=0.187, P=0.011 and ANOSIM statistic 331 R=0.252, P=0.004 for sample location and antibiotic analyses, respectively) and PERMANOVA 332 tests (R^2 =16, P=0.015 and R^2 =40.03, P=0.004 for sample location and antibiotic analyses, 333 respectively). 334

335 Few ARG-types were identified exclusively in the resistome of raw wastewater pellets. Of those, 336 mupirocin was the only ARG-type whose presence was only observed for all conditions and locations tested (Table 1). However, its normalized abundance was amongst the lowest of ARG-337 types in raw pellets $(7.1 \times 10^{-5} \text{ vs } 1.4 \times 10^{-1})$. Similarly, oxazolidinone was only found in 338 wastewater pellet samples with the exception that it was also found in meropenem culture-339 enriched wastewater pellet samples in both neighborhood locations (i.e., NE1 and NW1) (Table 340 341 1). Pleuromutilin and antibacterial free fatty acids ARG-types were also only detected in pelleted samples in only hospital locations (i.e., Hopsital-1 and 2) (Table 1). 342

343 Quantitative confirmation of differential detection of target ARG

We used qPCR to objectively and independently document the abundance of ARG in wastewater 344 pellets. As β -lactam resistance was the most abundant ARG-type that was identified (57.6%), we 345 quantified the absolute abundance of target β -lactamases in raw wastewater pellet samples 346 relative to the total bacterial load (i.e., quantified by the 16S rRNA gene copies). Here we 347 348 confirmed metagenomic observations (Supplementary Table 4) and established that $bla_{CTX-M-1}$, 349 *bla*_{KPC-3} and *bla*_{NDM-1} were 9.6-fold, 4066-fold and 5924-fold higher in raw hospital wastewater 350 pellets compared to neighbourhood samples (P < 0.05) (Supplementary Figure 2A). We likewise 351 quantified the presence of vanA as a surrogate for Vancomycin-Resistant Enterococci (VRE), 352 total-C. difficile, and one of its enterotoxins encoded by the tcdA gene in pelleted raw wastewater. We found that vanA, total-C. difficile and tcdA relative abundance were 14.5, 11.8, 353 354 19.7 fold-higher in hospital than in neighborhood sites (Supplementary Figure 2B) (P < 0.05). 355 Finally, since the culture enrichment of wastewater pellet samples was performed on media (i.e., 356 MacConkey agar plates) that selects against Gram positive bacteria, we decided to confirm by 357 qPCR that vanA in culture-enriched wastewater pellet samples was negatively selected. We

found a negative selection against the presence of *vanA* gene in MacConkey enriched wastewaterrelative to raw pellets (Supplementary Figure 2C).

360 **DISCUSSION**

361 Interest in wastewater-based surveillance (WBS) of ARO has been progressively growing. WBS 362 provides an integrated view of ARG burden across a population that is objective, comprehensive 363 and inclusive. Furthermore, it can be performed serially, and at a tiny fraction of the cost of serial active surveillance to monitor for changes in the prevalence of specific ARG, as might occur in 364 365 the context of an outbreak (Harrington et al. 2022; Li et al. 2022). Despite the great potential of 366 this technology, its application to hospitals has been limited to date. Hospitals are where societies sickest and most vulnerable are cohorted together to receive care. As a consequence, patients in 367 hospital are simultaneously the most susceptible to acquiring infection and the most likely to 368 experience adverse outcomes as a result. As 37-44% of admitted patients receive antibiotics 369 during their hospital stay, the selection pressure for ARO colonization and subsequent infection 370 371 is particularly intense and dynamic surveillance mechanisms to monitor for changing prevalence 372 of organisms urgently required to augment antimicrobial stewardship and infection control 373 programs (Taylor et al. 2015; Tan et al. 2017; Rudnick et al. 2020; Hocquet, Muller, and 374 Bertrand 2016). Importantly, this work established that the resistome of hospitals differed 375 significantly from community derived samples, and ARG of notable nosocomial pathogens were markedly increased. 376

377 Several early approaches have been used for the analysis of AMR in hospital wastewater. For 378 example, Buelow and collaborators (2018) studied the resistome hospital wastewater compared 379 to receiving urban wastewater but identified only a few ARGs using a high-throughput qPCR 380 (Buelow et al. 2018). Other studies have only been focused on the characterization of the

381 diversity of specific ARGs (e.g., ESBLs and KPCs) in hospital wastewater using culture 382 dependent methodologies (Adekanmbi et al. 2020; Chagas et al. 2011). Culture based studies 383 have identified carbapenemase producing organisms both exclusively in WWTP receiving 384 wastewater from hospitals (Ludden et al. 2017) or across all monitored sites irrespective of contributing hospitals (Blaak et al. 2021). Early metagenomic approaches have been described 385 using hospital wastewater (Rodriguez-Mozaz et al. 2015; Petrovich et al. 2020; Duong et al. 386 387 2008; Fuentefria, Ferreira, and Corcao 2011; Szekeres et al. 2017; Hutinel, Larsson, and Flach 2022; Hocquet, Muller, and Bertrand 2016) however, no study has utilized culture-enrichment to 388 389 study in more greater detail the resistome of complex samples such as hospital wastewater samples. Furthermore, by comparing resistomes from multiple hospitals and neighborhoods, we 390 have increased the robustness of these observations. 391

392 Using complementary metagenomic and culture enrichment we identified the presence of ARG encoding resistance to β-lactam, multidrug, fluoroquinolone, MLS, aminoglycoside, tetracycline, 393 glycopeptide, diaminopyrimidine, phenicol, fosfomycin, and others. The most diverse ARGs-394 395 types detected conferred resistance to β -lactam in both hospital and neighborhood wastewater. 396 We found that the alpha diversity of ARGs found after cultured enrichment were higher in 397 hospital samples compared to neighborhoods. Similar to our results, a previous study showed that hospital wastewater was found to be richer in ARGs than the other type of samples (e.g., 398 urban wastewater), particularly when comparing ARGs-types related with 399 β -lactam and 400 vancomycin resistance genes (~15-fold and ~175 fold higher in hospital wastewater, 401 respectively) (Buelow et al. 2018). These results are also supported by previous studies that have demonstrated that hospital wastewater contains richer and high abundances of ARGs than 402 403 municipal which has been extrapolated to relate to higher burden of ARG colonization amongst

404 hospitalized individuals (Petrovich et al. 2020; Paulus et al. 2019). Even in the "environmental" 405 One Health compartment, the high concentrations of antibiotics in hospital wastewater relative to 406 municipal wastewater create selective pressure on the microbiota driving resistance (Szekeres et 407 al. 2017). Hospital wastewater therefore serve as a particular hotpot for ARGs and AROs dissemination across the watershed, into the environment and ultimately into humans and 408 409 animals (Kaur, Yadav, and Tyagi 2020; Rodriguez-Mozaz et al. 2015; Rizzo et al. 2013; 410 Vlahović-Palčevski et al. 2007; Robert et al. 2012). Cai et al. (2021), performed weekly WBS of a single ~250 bed hospital in Shantou, China for ARG using metagenomics over a period of 411 412 several months. They compared their wastewater derived data with pathogens from 104 413 individuals (16% of submitted clinical specimens) and used network analysis to demonstrate strong correlations with many ARG-types and recovered clinical pathogens (Cai et al. 2021). 414

415 Although metagenomic sequencing is a robust approach for ARGs identification and 416 characterization relative to traditional targeted studies, next-generation sequencing (NGS) 417 requires tremendous sequencing depth in order to effectively identify AMR due to its low 418 sensitivity and lower limit of detection (Lanza et al. 2018; Guitor et al. 2019). Coupling limited 419 selective culture-enrichment of wastewater with metagenomic sequencing allowed us to detect a 420 range of ARG sub-types (including clinically important KPCs, NDMs and VIM metallo-betalactamases) that would otherwise not have been detected, despite a sequencing depth less than 421 half of the raw pellets. Such an approach can manifest in significant cost savings – particularly 422 423 relevant for high volume longitudinal monitoring programs. Interestingly, increased detection of 424 these targets occurred using ciprofloxacin in addition to both the beta-lactams; meropenem and ceftriaxone, likely relating to the co-location of ARG on transmissible mobile elements in 425 426 resistant pathogens (Parkins et al. 2007). The exceptional enrichment agent was colistin, which negatively selected against carbapenemases, and only modestly enriched for *mcr*-1 which was
exceedingly infrequent in the samples collected (NE-1 and NW-1). We identified bicyclomycin
ARG, uniquely in the culture-enriched wastewater pellet samples. Antibiotic resistant to
bicyclomycin is mediated by a transmembrane protein that excludes it from penetrating the cell
(Malik et al. 2014) and it has been found in *P. aeruginosa* strains responsible for outbreaks
(Fonseca et al. 2015).

433 A common critique of metagenomic studies is the inability to distinguish between live and dead organisms, particularly relevant if infection control measures are to be implemented based on 434 435 wastewater data. Culture enrichment negates this. Only a few studies have used a similar 436 approach of culture enrichment, but they have only focused on AMR in influent and effluent municipal wastewater rather than hospitals. Zhang and collaborators (2022) assessed the 437 resistome through culture enriched phenotypic metagenomics in municipal wastewater treatment 438 439 plant and its receiving river samples. This study detected a greater diversity and number of ARGs when coupling culture enrichment and metagenomic analysis than direct metagenomic 440 441 sequencing, with a particular focus on carbapenemase and ESBLs (Zhang, Zhang, and Ju 2022). 442 Marano and collaborators (2021) used culture-enrichment under copiotrophic conditions to 443 enrich and determine the microbiome and resistomes of AROs and ARGs in soil that was irrigated with treated-wastewater. They observed that cephalosporin and carbapenem resistant 444 *Enterobacterales* only after culture enrichment and not in raw soil samples (Marano et al. 2021). 445 Other alternatives to culture enrichment prior to metagenomic analysis consist of using 446 commercially available AMR target enrichment NGS panels (Harrington et al. 2022). 447

448 Targeted surveillance of specific clinically relevant ARG serves to complement metagenomic449 assessments. Indeed, others have suggested that this approach has increased sensitivity relative to

shot gun metagenomics (Miłobedzka et al. 2022). Using this approach, we demonstrated marked increase in clinically relevant ARG in hospital wastewater pellets relative to community samples including β -lactamases from nosocomial Gram negatives (i.e., CTX-M ESBLs, KPCs and NDM) and Gram-positive pathogens (i.e., total *C. difficile* and *tcdA*, and *vanA* from VRE).

454 This study has several notable limitations. We specifically used a lower sequencing target depth 455 in culture enrichment samples in order to assess if this process could manifest in cost savings for identification of ultra-rare ARG. Owing to this difference, we were unable able to perform direct 456 comparisons in terms of SDI between these data sets. The use of selective culture enrichment, 457 458 designed to increase the identification of any particular target, will conversely mask alternates. 459 As our goal was to assess for ultra-rare carpabenemases presumed to colonize a tiny fraction of the population where it is a minor constituent within resident microbiota, we enriched with 460 461 MacConkey agar and appropriate antibiotics to select for these mechanisms. In doing so, we selected against other clinically relevant nosocomial pathogens (i.e., VRE and other Gram 462 positives) which were however readily identified owing to their increased prevalence and 463 464 abundance in colonized/infected individuals. This study did not assess the relationship between 465 antibiotics released into hospital wastewater and abundance of ARGs found in those samples. 466 Only a few studies have looked at that matter and it has been found a correlation between antibiotic concentrations and resistance in wastewater (Rodriguez-Mozaz et al. 2015; Gao, 467 Munir, and Xagoraraki 2012). Finally, we did not identify the taxonomic identity of those 468 469 organisms carrying ARG, nor did we assess the role of mobile genetic elements in distribution of 470 antimicrobial resistance in hospital and community samples. However, culture-based enrichment 471 offers the potential to retrospectively go back and attempt to recover individual pathogens

472 carrying an ARG-type of interest for greater characterization through whole genome sequencing473 analysis.

474 Conclusion

Here we were able to demonstrate using multiple independent sampling locations and 475 complementary modalities (i.e., metagenomics and qPCR) that the resistome of hospitals, differs 476 477 from communities, and is particularly enriched for beta-lactam resistance and nosocomial pathogens such as VRE and C. difficile. By adopting a simple, semi-selective culture enrichment 478 step we were able to identify ultra-rare, and clinically relevant ARG such as NDM and KPC 479 while simultaneously reducing the costs associated with sequencing. Wastewater-based 480 481 surveillance is a potentially extremely important and powerful tool that warrants exploration as a tool to augment hospital-based infection control and antimicrobial stewardship programs. 482
