# Screening of Thalassemia Carriers, Hemoglobin Variants, and Comparison of Hematological Parameters between Children of Bangladesh and Forcibly Displaced Myanmar Nationals

#### 41 Abstract

Thalassemia is a hereditary blood disorder with different severity spectrums. This study aimed to assess thalassemia screening rates between children of Bangladesh and selected camps of Forcibly Displaced Myanmar Nationals (FDMN) in Cox's Bazar in Bangladesh and compare the hematological parameters among the screening groups. Complete blood count (CBC) analysis and hemoglobin electrophoresis for each participant were performed by collecting venous blood. Statistical analysis was employed for the comparison of parameters in blood. The thalassemia carrier and other hemoglobin variant rate in Bangladeshi children in selected areas have been found to be 20.7% and in FDMN children, the rate is 8.2%. Hematological differences are visualized among children of two nations. Intra-and interpopulation variances are highlighted in principal component analysis where higher variance (94.87%) in Bangladeshi children than FDMN children (80.68%). Receiver operating characteristics (ROC) and area under the curve (AUC) analyses revealed, RBC (0.761, 0.902, and 0.791) and RDW-CV are better model (0.819, 0.925, and 0.858) among the classifier of blood parameters. Pearson correlation shows distinguished covariation or association among the parameters. The outcome of the study highlights the discrepancies in levels of carriers in regions in Bangladesh and suggests further screening as well as population based molecular research to ensure better treatment strategies. #### 82 **1. Introduction**

83 Thalassemia is an inherited hemolytic anemia which passes through autosomal recessive pattern [1]. A fractional or complete absence in the synthesis of  $\alpha$ -globin chains or  $\beta$ -globin chains due to 84 genetic defects in the *a-globin* gene cluster on chromosome 16 or the  $\beta$ -globin gene cluster on 85 chromosome 11 can lead to the synthesis of defective hemoglobin [2]. In  $\beta$ -thalassemia, the main 86 consequence of unstable hemoglobin and iron overload is oxidative stress [4]. Iron triggers the 87 manufacture of reactive oxygen species, which in excess are toxic, contributing to oxidative 88 damage to red blood cells, leukocytes (recurrent infections), platelets (hypercoagulable state) [4], 89 90 cellular dysfunction, apoptosis, and necrosis in vital organs such as heart, liver and endocrine system [1, 2]. People with  $\beta$ -thalassemia major ( $\beta 0 / \beta 0, \beta 0 / \beta^+$ , and sometimes  $\beta^+ / \beta^+$ ) generally 91 92 get medical attention within the first two years of life and necessitate regular RBC transfusions to survive [2]. This transfusion can cause iron overload [3]. Dysregulation of iron homeostasis 93 promotes iron deposition in the organs and influences disease severity, which is the main cause of 94 death in beta-thalassemia patients [4, 5]. Each year worldwide more than 300,000 newborns are 95 96 detected with major hemoglobinopathies of whom 60,000 to 70,000 are  $\beta$ -thalassemia major cases, especially in the Mediterranean area, Middle East, Far East, and East Asia [3]. In Bangladesh, the 97 98 birth rate of 33/10,000 had been reported where 8.68% had HbE trait, 2.24% had  $\beta$ -thalassemia (β-thal) trait and nearly 2500 thalassemia major cases are added every year in Bangladesh [6,7] 99 100 while in Myanmar, thalassemia carrier rate was 4.3% [8]. Previously migration increased the frequency of thalassemia disease in lower-prevalence regions [10]. Over a million Rohingyas from 101 102 Myanmar were forcefully displaced to Bangladesh and other neighboring countries by January 2018. Over half of the displaced Rohingyas have sought shelter in Bangladesh and settled in 103 104 Rohingya camps in Cox's Bazar [11]. There are no published thalassemia screening outcomes on Forcefully Displaced Myanmar Nationals (FDMN) in Bangladesh. This study aimed to compare 105 the prevalence of thalassemia carriers and hemoglobin variants to associate hematological 106 parameters among Bangladeshi children and Rohingya children who were forcibly displaced from 107 108 Myanmar in Bangladesh.

#### 109 **2. Methods**

#### **2.1. Enrollment of Study Participants**

111 In screening campaigns, a total of 92 Bangladeshi children (49% male and 51% female), aged

between 1 and 15 years and 110 children of forcibly displaced Myanmar Nationals (58% male and

42% female), aged between 7 and 16 years were enrolled in the study from 2 May 2022 to 22

October 2022. The study (# PNR-22003) was ethically approved by Institutional Review Board of Institute for Developing Science and Health Initiatives (ideSHi). Participants were provided informed consent and written consent was taken from parents or legal guardians of each participant.

Considering, the level of significance = 5%, power of the test = 85%, expected prevalence rate for Bangladeshi population  $P_b$  =10.2% [14], margin of error e=10% and including 15% attrition rate the sample size is  $n_b$  = 92. Again, with the level of significance = 5%, power of the test = 96%, expected prevalence rate for Myanmar population  $P_m$  =4.3% [8], margin of error e=9% and including 15% attrition rate the sample size is  $n_m$  = 110.

#### 135 2.2. Analysis of Complete Blood Count of The Study Participants

136 Three ml of venous blood was collected from each participant in EDTA containing vacutainer and

the collected blood samples were transported to the laboratory maintaining 4-8°C and preserved at

138 4°C until analysis. The complete blood count (CBC) was performed for each sample by using XS-

139 800i Hematology Analyzer (Sysmex, Japan) following the manufacturers' instruction. Major

- 140 hematological parameters like hemoglobin (HGB), hematocrit (HCT), RBC count and Red Cell
- 141 Indices including mean corpuscular volume (MCV), mean corpuscular hemoglobin (MCH), mean
- indices mendang mean corpused at volume (inc v), mean corpused at hemogroom (incert), mean
- 142 corpuscular hemoglobin concentration (MCHC) and Red cell distribution width (RDW) were
- 143 considered for analysis.

#### 144 **2.3. Hemoglobin Electrophoresis**

Hemoglobin electrophoresis was performed on automated capillary electrophoresis system (Sebia,
France) using Capillary Hemoglobin (E) kit to measure HbA, HbA2, HbF, and other abnormal Hb
variants following manufacturer's instructions.

#### 148 **2.4 Statistical Analysis**

Statistical analysis was performed using SPSS and GraphPad Prism software (version 9.0) and R programming. P < 0.05 was considered statistically significant for all the tests. One-way ANOVA was performed for the analysis of hematological differences, and the distribution pattern was visualized. Principle component analysis was performed for understanding intra and inter population variation. Covariation of association among the major hematological parameters was visualized by Pearson correlation. Receiver operating characteristics (ROC) and area under the curve (AUC) analyses were also conducted for diagnostic assessment.

#### 158 **3. Results**

## 159 3.1. Thalassemia Carrier and Hemoglobin Variant Screening 160 Outcomes

In the study, the screening showed that the frequency of thalassemia traits and other hemoglobin variants in Bangladeshi children was 20.7%, where beta thalassemia trait (BTT) and HbE trait (HbET) were 5.43% and 13.04%, respectively. The highest carrier frequency was found among the children in Dhaka and Rangpur (only HbE, 23.5%) divisions, while it is comparatively lower in Chattogram (17.65%, BTT-11.76%, HbET-5.89%), and Barishal (17.65%, BTT-11.76%, HbET- 5.89%). The lowest carrier frequency was observed among the children in Sylhet (only

HbET-5.8%), Mymensingh (only HbET-5.8%) and Khulna (only BTT-5.8%) divisions. The low
HbA2 had been detected in Rajshahi (1.1%).

On the other hand, thalassemia carrier and other hemoglobin variant frequency was 8.2% among the children from the FDMNs, where BTT and HbE were 2.73% and 5.45%, respectively. In addition, HbD variant was also found in the Bangladeshi children (1.09%) and FDMN children (0.9%). The distribution of different groups in screening was displayed in Fig 1.

177 3.2. Analysis of Hemoglobin Variants

Hemoglobin electrophoresis among the healthy participants of Bangladeshi children showed the 178 levels of HbA and HbA2 were 97.14  $\pm$  0.31% and 2.80  $\pm$  0.25%, respectively. In beta thalassemia 179 trait (BTT), the levels of HbA, HbA2 and HbF were  $93.78 \pm 1.5\%$ ,  $5.40 \pm 0.36\%$ , and  $2.05 \pm 2.33\%$ 180 respectively. In HbE trait the levels of HbA, HbA2 and HbE were  $70.80 \pm 1.4\%$ ,  $3.72 \pm 0.48\%$ , 181 and 25.39± 1.08%, respectively. In addition, HbA (54%), HbA2 (3.7%), and HbD (42.3%) were 182 found in HbD trait. In low HbA2 participant, HbA was 98.1% and HbA2 was 1.9%, and suspected 183 to have alpha thalassemia trait (HGB 8.7 g/dL, RBC 4.68 X10^12/L, MCV 55.8 fL, MCH 18.6 184 185 pg) according to Mentzer index (MCV/RBC <13).

On the other hand, among the normal or non-carrier children of FDMN, the levels of HbA and HbA2 were  $97.3 \pm 0.29\%$  and  $2.67 \pm 0.21\%$  respectively. In beta thalassemia trait (BTT), the level of HbA was  $93.6 \pm 0.47\%$ , HbA2 was  $5.3 \pm 0.47\%$  and HbF was  $1.17 \pm 0.5\%$ . In HbE trait, the level of HbA was  $72.9 \pm 3.12\%$ , HbA2 was  $3.8 \pm 0.35\%$ , HbE was  $23.0 \pm 3.4\%$ , and HbF was 1.1%. In addition, a child of FDMN with HbD trait showed the level of HbA, HbA2, and HbD at 56.4%, 2.9%, and 41%, respectively. Alpha thalassemia trait was not found in FDMN children from study population.

#### **3.3. Principal Component Analysis**

In this study, the principal component analysis was considered as feature extractor to compare the participants of Bangladesh (BD) and Forcibly Displaced Children of Myanmar Nationals. The

197 principal components, PC1 and PC2 accounted for most of the variation in the participants based

198 on gender and age distribution. In Fig 2A among Bangladeshi children, PC1 and PC2 showed

199 63.0% and 31.7% variance, respectively (in total 94.87%). On the contrary, the FDMN children

showed the variance of PC1 and PC2 at 50% and 30.7%, respectively, while the total variance was

201 80.68% (Fig 2B).

### 3.4. Analysis of Hematological Differences between Bangladeshi and Forcibly Displaced Children of Myanmar Nationals

The column bar graphs exhibited a diverse distribution of major hematological parameters amongthe prevalent groups in children of the two countries.

According to the one-way ANOVA test, RBC, MCV, MCH, and RDW-CV were substantially 215 different among the normal, BTT, and HbET groups in Bangladeshi children (Fig 3A), with a p-216 value of 0.05. Among the BTT children of Bangladesh, RBC and RDW-CV were found 217 significantly higher, whereas MCV and MCH were significantly lower compared to the normal 218 value (Table 1). In the FDMN children, all the hematological parameters except MCHC showed 219 significant results among the normal, BTT and HbET groups (Fig 3B) with a p-value of <0.05. 220 RBC and RDW-CV were significantly higher, while HGB, HCT, MCV, and MCH were 221 significantly lower compared to the normal level in BTT in the FDMN children (Table 2). 222

However, the hematological parameters of both Bangladeshi children and FDMN children showed

significant results for RBC, HGB, MCV, MCH, HCT, and RDW-CV among the normal, BTT and

HbET groups. RBC and RDW-CV were significantly higher, while HGB, HCT, and MCH were

significantly lower in BTT of both populations (Table 3).

## 3.5. Correlation among Hematological Parameters in Different Groups of Children in Bangladesh and Forcibly Displaced Myanmar Nationals (FDMN)

Pearson correlation showed covariation or association among the hematological parameters. 249 Diverse correlation pattern in CBC parameters was persistent in both BD and FDMN children. 250 251 Among Bangladeshi children, normal or non-carriers and HbET showed quite similar type of strong positive correlation pattern among RBC, HGB, HCT, MCV and MCH, while RDW-CV 252 exhibited negative correlation with the other hematological parameters. BTT showed strong 253 positive relationship among RBC, HGB, HCT, and RDW-CV, MCV, and MCH. In FDMN, 254 variations were more prominent among the different groups. BTT exhibited strong positive 255 correlation among most of the hematological parameters except HCT and RDW-CV (Fig 4). 256 257

#### **3.6. ROC Curve Analysis**

ROC curve analysis was performed for the assessment of diagnostic value of thalassemia carrier and hemoglobin variant screening. ROC curves were plotted for children of Bangladesh and FDMN children (Fig 5A, Fig 5B) and for both nations (Fig 5C). AUC was measured to visualize the classifier of blood parameter model. RBC (0.761, 0.902, and 0.791) and RDW-CV (0.819, 0.925, and 0.858) covered high AUC and good classifier for carrier screening. High AUC indicated more accuracy for diagnostic performance which might be supportive to hemoglobin electrophoresis test for proper diagnosis of thalassemia and hemoglobinopathies.

#### 279 **4. Discussion**

This is the first study for assessment of thalassemia carrier and hemoglobin variant screening data 280 281 in children between Bangladesh and Forcibly Displaced Myanmar Nationals (FDMN). In the study, the frequency of thalassemia carriers and hemoglobin variants in Bangladeshi children is 282 283 found 20.7%, which is double of the previous report (10.2%) [7, 14]. The highest carrier frequency was found in Dhaka and Rangpur divisions while the lowest carrier frequency was observed in 284 Sylhet, Mymensingh, and Khulna divisions. On the other hand, the carrier rate in FDMN children 285 was 8.2%, where beta thalassemia trait (BTT) rate is 2.73%, and HbE trait (HbET) rate is 5.45%. 286 287 Combining the rate for both study groups, the cumulative carrier rate is around 14% which is also demonstrate the increasing trend compared to previous record [7, 14]. Principle component 288 analysis highlights the marked variations in Bangladesh and Forcibly Displaced Myanmar 289 Nationals for their genetic ancestry conformation. Higher variance has been exposed in 290 Bangladeshi children (94.9%) than in FDMN children (80.7%) for intra-and inter-population 291 variances of different groups. Divergent distribution pattern of major hematological parameters 292 was visualized for the children of both Bangladesh and FDMN. The variations were higher in BTT 293 group of both populations while wider distribution in Bangladesh and narrower distribution 294 patterns are visible in FDMN children. ROC curve evaluates the diagnostic performance of carrier 295 and hemoglobin variant screening by demonstrating the sensitivity and specificity of the test. AUC 296 under ROC curve was measured to visualize the classifier of blood parameter model. RBC (0.761, 297 0.902, and 0.791) and RDW-CV (0.819, 0.925, and 0.858) display high AUC which indicates 298 better classifier for the screening. Comparing all the parameters, RBC and RDW-CV are 299 300 supportive to hemoglobin electrophoresis to evaluate the screening outcomes. There was association of RDW-CV and thalassemia disease severity in previous study [9]. Correlation 301 302 matrixes represent covariation or association among the parameters. Distinguished correlation was revealed in both Bangladesh and FDMN children. BTT groups of both Bangladesh and FDMN 303 304 demonstrate the higher number of strong positive correlation among parameters although the parameters differ in their association. Mostly RDW-CV demonstrates quite negative association 305 306 with other hematological parameters in the FDMN children. All the analyses demonstrate the similarities and discrepancies in the major hematological parameters of the groups from 307 308 Bangladesh and Forcibly Displaced Myanmar Nationals. The screening in children has been

conducted to determine the carrier and hemoglobin variant rates of existing populations with two 309 different genetic background in Bangladesh. However, a drawback is that we could screen only a 310 limited number of children since this was conducted within a thalassemia awareness program. 311 More extensive thalassemia carrier screening and awareness programs, prenatal diagnosis, and 312 compulsory carrier screening before marriage should be implemented to prevent the spread of 313 thalassemia disease and other hemoglobinopathies. This comparative study will be helpful for 314 track the rates of thalassemia carrier and hemoglobin variant in children to prevent the disease 315 burden. As well as this population-based study will expedite molecular analysis for the 316 improvement of thalassemia treatment strategies by initiating personalized medicine. Finally, such 317 studies and programs will help in creating awareness of thalassemia, its prevention and in policy 318 changes in the country. 319

#### **5.** Conclusion

The frequency of carrier and hemoglobin variant is much higher in Bangladeshi children than the displaced population from Myanmar (FDMN) into Bangladesh. This comparative study highlights the discrepancies in thalassemia carrier and hemoglobin variant status on children which will be helpful to understand the burden of thalassemia and hemoglobinopathies. Increasing the number of screening and being aware of devastating health consequences are vital for prevention of disease.




Fig 1. The alluvial plot represents distribution of screening outcomes in BD and FDMN children. The color codes indicate different groups: Beta Thalassemia Trait (purple), HbD Trait (blue), HbE Trait (lemon), Low Hb A2 (orange).




Fig 2. Intra-and inter-population variances are highlighted in Principal component analysis. (A) PC scores in BD children's groups and (B) PC scores in FDMN children's groups. The color codes represent different groups in BD and FDMN children, Normal (blue), Beta Thalassemia Trait (BTT) (red), HbE (green), HbD (purple), Low HbA2 (orange).






Fig 3. Distribution pattern of major hematological parameters.

Normal, Beta Thalassemia Trait (BTT), and Hemoglobin E Trait (HbET) groups in both (A) BD and (B) FDMN children.






