## 33 Abstract

34 Background: The historical view that pregnancy intention is dichotomous (i.e., intending or not 35 intending pregnancy), and the notion that all individuals not intending pregnancy should be using 36 highly effective contraceptive methods, oversimplifies how we view contraceptive decision-37 making. To better understand this, we studied contraceptive congruence as an alternative, 3-level 38 measure describing methods as very congruent, somewhat congruent, or incongruent with one's 39 individual attitudes about becoming pregnant. 40 Methods: Secondary data analysis included 982 MyNewOptions study participants who were not 41 intending pregnancy within the next year. The cross-sectional survey assessed attitudes about how 42 important it is to avoid pregnancy, how pleased/upset one would be if pregnant, and current 43 contraceptive method use. Participant answers to attitudinal questions and effectiveness of current 44 contraceptive method were used to determine congruence categories. 45 Results: Contraceptive methods included LARC (8%), other prescription methods (50%), non-46 prescription methods (30%), and no method (12%). Methods for 23% of participants were very 47 congruent, 48% somewhat congruent, and 29% incongruent with attitudes about becoming 48 pregnant. Contraceptive congruence was significantly associated with contraceptive satisfaction 49 in bivariate analysis. Predictors of contraceptive congruence included being married or living 50 with partner, full-time employment, and intending future pregnancy in the next 1-5 years. 51 Conclusion: Contraceptive congruence is a novel measure that acknowledges pregnancy 52 ambivalence and is associated with higher contraceptive satisfaction scores. Future contraception 53 research should strive for robust, patient-centered measures of contraceptive use that acknowledge 54 the complex attitudes affecting individual contraceptive behavior and satisfaction.

55 What is already known on this topic: Pregnancy intention is historically seen as a dichotomous 56 outcome ("intended" vs "unintended"), does not capture the full breadth of pregnancy 57 ambivalence, and may be an oversimplification of an individual's reality. 58 What this study adds: To better understand this complex interaction of pregnancy intention with 59 contraceptive use, we propose contraceptive congruence as an alternative, 3-level measure that 60 describes methods as very congruent, somewhat congruent, or incongruent with one's individual 61 attitudes about becoming pregnant. Contraceptive congruence is a novel patient centered measure 62 that acknowledges pregnancy ambivalence, is associated with higher contraceptive satisfaction 63 scores, and with further research could change contraceptive counseling in the future. 64 How this study might affect research, practice or policy: The differences observed in 65 contraceptive congruence and contraceptive effectiveness suggests that better strategies are 66 needed to measure patient-centered contraceptive method use. Clinical practice and policy must 67 advance how we use reproductive life planning, shared decision making, motivational 68 interviewing, and patient autonomy to help patients find contraceptive methods that are aligned 69 with their pregnancy intentions, ambivalence, and individual preferences. 70

## 71 **1. Introduction**

72	With effectiveness of over 99%, long-acting reversible contraception (LARC), which
73	include the intrauterine device (IUD) and the contraceptive implant, are often touted as the
74	preferred methods for reducing unintended pregnancies. <sup>1-3</sup> However, indiscriminate promotion
75	of LARCs is problematic for several reasons, including the inaccurate assumption that pregnancy
76	intention is dichotomous – i.e., either intending pregnancy or not intending pregnancy. On the
77	contrary, many individuals feel some degree of ambivalence even when stating they are or are
78	not intending pregnancy.
79	Commonly used measures of pregnancy intention have generally assessed whether

80 participants want/intend to have a baby in the future.<sup>4</sup> Although a "not sure" category is often 81 offered and used by researchers to define ambivalence, we suspect that these "not sure" 82 responses are not capturing the full breadth of pregnancy ambivalence. In contraceptive behavior 83 studies, individuals who self-report not intending pregnancy are often expected or encouraged to 84 use a LARC or other highly effective form of contraception. While efficacy is a convenient and 85 easy outcome measure, it is also flawed.

86 Misunderstanding pregnancy ambivalence and its role in contraceptive decision making 87 is not only an issue for research methodology, but a critically important concept that needs to be 88 better understood to provide patient-centered clinical care. Gubrium and colleagues state that no 89 one contraceptive method should be first line for everyone and furthermore endorsing LARC 90 methods for everyone may be perpetuated by the Healthy People 2020 goal of reducing method 91 failure from 12.4% to 9.9%.<sup>56</sup> In a recent study that supports individualizing contraceptive 92 counseling, participants desiring to avoid pregnancy had higher odds of any and more consistent contraceptive use, but not use of a more effective method.<sup>7</sup> To acknowledge these complexities 93

94 in contraceptive decision-making, we need to include patient-centered perspectives in how we 95 define whether contraceptive choices are congruent with individual situations, instead of always 96 advocating for highest efficacy methods for all. 97 Our objective is to propose an alternative 3-level measure, contraceptive congruence, that 98 categorizes the contraceptive method an individual is using as being very congruent, somewhat 99 congruent, or incongruent with their attitudes toward future pregnancy. We aim to define this 100 new research measure and describe its association with contraceptive method satisfaction, as 101 well as the traditional hierarchy of contraceptive method effectiveness using data from the 102 MyNewOptions study. We hypothesize that contraceptive congruence will yield different results 103 than method effectiveness alone. 104 105 2. Methods 106 2.1. Study sample 107 Data for these cross-sectional analyses are from the baseline survey (prior to study 108 interventions) of the MyNewOptions randomized controlled trial. The parent study tested the 109 effectiveness of web-based interventions to assist insured self-identified women in making 110 ).<sup>8</sup> Study individualized contraceptive choices (ClinicalTrials.gov identifier: 111 participants were members of Highmark Health plans in Pennsylvania and sampled from the

112 Highmark enrollee database. Eligible self-identified women were aged 18-40, not intending

113 pregnancy in the next 12 months, not surgically sterile (or current partner with vasectomy),

sexually active with reported male partner(s), and had Internet access. The baseline survey,

115 completed in 2014, assessed pregnancy and contraceptive history, current contraceptive use and

116 behaviors, and sociodemographic factors. Further details regarding the MyNewOptions study

117 protocol are previously published.<sup>9</sup>

There were 987 participants in the MyNewOptions study; the analytic sample for the current analysis was limited to the 982 participants who provided complete survey responses for the main independent and dependent variables of interest, as described below (2.2 Measures).
The MyNewOptions study was approved by the **Section 200** Institutional Review Board.

124 2.2. *Measures* 

#### 125 2.2.1. Outcome Variable: Contraceptive Congruence with Pregnancy Attitudes

126 Contraceptive congruence is a 3-level variable describing whether an individual's 127 contraceptive method is very congruent (VC), somewhat congruent (SC), or incongruent (IC) 128 with one's attitudes about getting pregnant. The research metric variable was constructed based 129 on the participant's responses to three questions—current primary contraceptive method, 130 importance of avoiding pregnancy, and pleased/upset if became pregnant. Contraceptive methods 131 were categorized into four groups representing highest to lowest effectiveness: 1) long-acting 132 reversible contraceptive (LARC) including intrauterine devices (IUDs) and contraceptive 133 implants, which have a failure rate of <1%, 2) other prescription methods (i.e., oral 134 contraceptives, injectable, patch, vaginal ring), which have a typical failure rate of 6-9%, 3) non-135 prescription methods (i.e., barrier methods, spermicide, withdrawal, fertility-awareness based 136 methods (FABM)), with a typical failure rate of 12-24%, and 4) no method. Importance of 137 avoiding pregnancy was assessed with the question, "Thinking about your life right now, how 138 important is it to you to avoid becoming pregnant?"-the response choices were very important,

139 somewhat important, a little important, and not at all important. How pleased/upset one would be 140 if pregnant was assessed with the item, "Now, imagine that you have just found out today that 141 you are pregnant. How would you feel?"—the response choices were very upset, somewhat 142 upset, unsure, somewhat pleased, and very pleased.

143 The definitions for very congruent, somewhat congruent, or incongruent are shown in 144 Figure 1. Whether a participant's contraception is VC, SC, or IC is dependent on individual 145 responses to the pregnancy attitude questions. The strictest definition for congruence applies to 146 participants for whom it is very important to avoid getting pregnant or would be very upset if 147 pregnant, in which case only contraceptive methods with highest effectiveness (i.e., LARC) are 148 defined as very congruent. In this same scenario, other prescription methods would be somewhat 149 congruent, and non-prescription or no method would be incongruent. In cases where it is 150 somewhat/a little important to avoid pregnancy or would only be a little upset/not sure/or a little 151 pleased if pregnant, a more moderate definition for congruence applies, where any prescription 152 method is very congruent, any non-prescription method is somewhat congruent, and no method 153 is incongruent. Finally, for participants stating it is not at all important to avoid pregnancy or 154 would be very pleased if pregnant within the next year, LARCs are considered somewhat 155 congruent, given dependence on clinicians for insertion/removal, and all other methods (or no 156 method) are considered very congruent.

## 159 2.2.2. Independent variables

160 Independent variables were included that were expected to be associated with contraceptive use,

161 including intended timing of future pregnancy, pregnancy history, and sociodemographic

162 variables. Intended timing of future pregnancy was a 5-level variable that captured when

163 individuals intended a future pregnancy (in 1-2 years, 2-5 years, 5 or more years, never, or not

164 sure); only participants not intending pregnancy in the next year were eligible for the parent

165 study. Pregnancy history variables included number of previous live births and any prior

166 unintended pregnancy or abortion. Sociodemographic characteristics included age group,

167 relationship status, self-reported race/ethnicity, prior education, employment status, annual

168 household income, and religion.

169 The MyNewOptions baseline survey also included a single-item measure of contraceptive
170 satisfaction: "My overall satisfaction with my birth control method(s) is..." The response options

171	were very satisfied, somewhat satisfied, neither satisfied nor dissatisfied, somewhat dissatisfied,
172	and strongly dissatisfied." For analysis, contraceptive satisfaction was dichotomized as very
173	satisfied vs. all other categories. <sup>10</sup> We included contraceptive satisfaction to evaluate whether it
174	correlated with contraceptive congruence. However, we did not include contraceptive
175	satisfaction in the adjusted analysis, as we did not hypothesize that contraceptive congruence
176	would be independent of contraceptive satisfaction.

#### 178 2.2.3. Statistical analysis

179 Prior to any analysis, frequencies and percentages were used to summarize all 180 independent and outcome variables. A series of Chi-square tests were performed to assess 181 bivariate associations between the contraceptive congruence variable and the demographic 182 variables (Table 1). All associations with a p-value less than 0.05 were considered significant. A 183 multivariable logistic regression was performed including the significant variables from the 184 bivariate analysis (Table 2), except satisfaction as outlined above (2.2.2. Independent variables). 185 We attempted to use ordinal logistic regression, but the model failed the assumption of 186 proportional odds. Therefore, we collapsed "Somewhat Congruent" and "Incongruent" 187 categories into one category taken as a reference group against "Very Congruent" and applied 188 binomial logistic regression. Prior to any multivariable modeling, we checked for 189 multicollinearity between factors using variance inflation factor (VIF) statistics. Any factors with 190 VIF statistics >5 would be excluded from the model, but no multicollinearity was found. Odds 191 ratios were used to quantify the magnitude and direction of any significant associations. The 192 Hosmer and Lemeshow goodness-of-fit test was used to assess the fit of the model which was

193 good (p=0.551). The statistical analysis software SAS version 9.4 was used to perform all
194 analyses (SAS Institute, Cary, NC, USA).

195

## 196 **3. Results**

197 The majority of the 982 participants in the analytic sample was between 18 and 25 years 198 old, in a relationship, white, a college graduate, employed, and had an annual household income 199 of greater than \$50,000 (Table 1). Most individuals had no prior live births andwere intending to 200 have a baby sometime in the future, with the intended timing of future pregnancy well 201 distributed. Individuals were most likely to report they would be very upset if found out they 202 were pregnant today (36.9%) and considered avoiding pregnancy right now to be very important 203 (65.1%). Current contraceptive methods included LARCs (8.4%), other prescription methods 204 (49.8%), non-prescription methods (30.4%), and no method (11.5%). The main outcome 205 variable, contraceptive congruence, was distributed as follows: 23.3% very congruent (n=229), 206 48.0% somewhat congruent (n=471), and 28.7% incongruent (n=282). 207 Contraceptive congruence varied by participant characteristics (Table 1). Age was 208 significantly associated with congruence, with participants aged 26-33 and 34-40 years old more 209 likely to be very congruent (33.3% and 26.7%, respectively) compared with only 13.9% of 18-210 25-year-old individuals (p < 0.001). Being married or cohabiting, a college graduate, employed 211 full-time, intending pregnancy within the next 5 years, prior live birth, higher income, and prior 212 unintended pregnancy or abortion were associated with higher contraceptive congruence. 213 Although the multi-level race/ethnicity and religion variables were significant in chi-square 214 analyses (p=0.001 and p=0.022, respectively), there was not a clear trend of higher/lower 215 congruence with any specific race/ethnicity or religious group. Congruence was associated with

- 216 contraceptive satisfaction 63% of very congruent participants had high method satisfaction,
- 217 compared with 58% of somewhat congruent and 28% of incongruent participants.

- 222 Multivariable logistic regression model results are shown in Table 2, modeling very
- 223 congruent contraceptive use. Compared to those who were not partnered, individuals who were
- 224 living with their partner or married had greater odds of using a contraceptive method that was
- 225 very congruent with their pregnancy attitudes. Likewise, full-time employment was associated
- with higher congruence. Finally, individuals who intend pregnancy in 1-2 or 2-5 years were more
- 227 likely to be congruent than participants who never intend to get pregnant.

#### 230 **4. Discussion**

231 In this paper, we propose a new variable, contraceptive congruence, to describe whether 232 an individual's primary contraceptive method is aligned with one's attitudes toward future 233 pregnancy to illustrate the pitfalls of using pregnancy intention alone in making assumptions 234 about the "correctness" of one's contraceptive method use. In this cohort of insured 235 reproductive-age participants not intending pregnancy in the next year, only a minority (8.4%) 236 was using a highly effective LARC, but a higher proportion (23.3%) were using a method that 237 was very congruent with their pregnancy attitudes. While we would hope to see more individuals 238 with high contraceptive congruence, our novel research metric suggests that measuring 239 congruence is very different than just evaluating LARC use alone. 240 While we acknowledged the importance of future pregnancy ambivalence by using this 241 novel contraceptive congruence variable, we also recognize that our methods are flawed since

242 measurement of ambivalence has not been standardized nor validated. As described in previous 243 qualitative studies and perspectives, pregnancy intention is not binary ("unintended" vs 244 "intended"). Intention is much more nuanced and better described along a continuum, as suggested by many participants responding with ambivalence over pregnancy intention.<sup>1711-17</sup> 245 246 Individuals who have strong intentions to avoid pregnancy are more likely to choose a LARC 247 method over individuals with some ambivalence towards pregnancy, who may view a LARC as 248 too permanent.<sup>14</sup> By incorporating pregnancy ambivalence, the contraceptive congruence 249 measure recognizes that the most effective methods are not always the most patient-centered for 250 all individuals seeking contraception.

251 Measures of pregnancy intention, which can be assessed with a singular question or batteries of questions,<sup>16 18-23</sup> have not been found to be durable over time. More abstract 252 253 questions (e.g., lifetime intention) are less reliable, but if asked on a shorter timeframe (e.g., one 254 year) with more specific examples, participants have a better ability to predict their intentions.<sup>18</sup> 255 <sup>21</sup> Our data showed similar results, with individuals intending to become pregnant in the next 1-5 256 years being more likely to be very congruent with their method than those who never intend 257 pregnancy. The literature also suggests that intention can be unstable when asked prospectively and retrospectively, and likely not durable over time.<sup>24-26</sup> Our findings are consistent with this 258 259 fluidity in intention, as participants who do not intend pregnancy ever or for at least 5 years, are 260 half as likely to be very congruent between attitudinal questions and contraceptive method. 261 These results suggest that an individual's contraceptive preferences may be better understood 262 when their future intention is supplemented with the two additional pregnancy attitude questions, 263 which suggests that more work needs to be done to develop a better metric. This measure can be

264	used to describe whether contraceptive methods are aligned with individual needs, and this
265	metric can then be used for both research measurement and clinical assessment.
266	Our study has several limitations. By design, our study population only included privately
267	insured self-reported women from a single state, yielding a demographically and
268	socioeconomically homogeneous sample. Thus, our study results are not generalizable to more
269	racially and economically diverse populations in other parts of the U.S. However, LARC use in
270	our study was similar to that reported in the National Survey of Family Growth, suggesting that
271	the contraceptive use patterns may not be dissimilar from a U.S. population-based sample. <sup>27</sup> Of
272	note, this was a secondary analysis from a randomized trial testing the comparative effectiveness
273	of web-based reproductive life planning interventions on contraceptive decision making.9
274	Because this analysis used survey data from the baseline measurement prior to randomization,
275	the study interventions would not have interfered with the baseline participant responses. We
276	also acknowledge the limitations of the congruence variable, which may not account for all
277	factors that would be necessary for a robust, patient-centered measure.
278	Although our primary focus was to understand the implications of contraceptive use
279	measurement for research purposes, there are implications for clinical practice and policy.
280	Clinicians and public health agencies may encourage LARC methods to satisfy population-based
281	goals of reducing unintended pregnancies, without acknowledging that individuals are making
282	contraceptive choices that are influenced by many factors beyond effectiveness alone and may be
283	driven by ambivalence over pregnancy intention and planning. <sup>14 16 28</sup> Clinical practice and policy
284	must also advance how we use reproductive life planning, shared decision making, motivational
285	interviewing, and patient autonomy to help patients find contraceptive methods that are aligned
286	with their individual pregnancy intentions, ambivalence, and preferences. <sup>1 5 14 18 19 29</sup>
