## 12 Abstract

Vaccine hesitancy is a major barrier challenging the control of infectious diseases. 13 14 Previous studies demonstrated high rates of COVID-19 vaccine hesitancy in the Middle 15 East. The current study aimed to investigate the attitudes towards COVID-19 vaccination and COVID-19 vaccine uptake among the adult population in Iraq. This cross-sectional 16 17 self-administered survey-based study was conducted in August-September 2022. 18 Recruitment of possible participants was done using chain-referral sampling. The survey 19 instrument assessed participants' demographics, attitudes toward COVID-19 20 vaccination, beliefs in COVID-19 misinformation, vaccine conspiracy beliefs, and sources of information regarding the vaccine. The study sample comprised a total of 2544 21 22 individuals, with the majority reporting the uptake of at least one dose of COVID-19 23 vaccination (n=2226, 87.5%). Positive attitudes towards COVID-19 vaccination were 24 expressed by the majority of participants (n=1966, 77.3%), while neutral attitudes were 25 expressed by 345 participants (13.6%), and negative attitudes were expressed by 233 26 participants (9.2%). Strong, moderate, slight, and absence of COVID-19 misinformation 27 were expressed by 12.4%, 22.6%, 36.2%, and 28.7% participants, respectively. The 28 majority of participants showed a neutral attitude towards COVID-19 vaccine 29 conspiracies (n=1464, 57.5%), while 607 participants embraced these conspiracies 30 (23.9%), and 473 disagreed with such beliefs (18.6%). In the multivariate analysis, 31 factors associated with positive attitudes towards COVID-19 vaccination included 32 disbelief in COVID-19 misinformation and disagreement with vaccine conspiracies. 33 Higher COVID-19 vaccine uptake was significantly associated with history of COVID-19 infection, higher income, residence outside the capital, disbelief in COVID-19 34 35 misinformation, disagreement with vaccine conspiracies, and reliance on reputable information sources. COVID-19 vaccine coverage prevailed among the participants, with 36 37 a majority having positive attitudes towards COVID-19 vaccination. Disbelief in COVID-38 19 misinformation and disagreement with vaccine conspiracies were correlated with 39 positive vaccine attitudes and higher vaccine uptake. These insights can inform targeted interventions to enhance vaccination campaigns. 40

### Introduction 41

Vaccination represents one of the greatest achievements of modern science, with 42 43 resounding success in controlling the morbidity and mortality associated with infectious diseases.<sup>1-3</sup> The remarkable success that accompanied the advent of several effective and 44 45 safe vaccines is manifested by the eradication of smallpox and the control of diseases such 46 as measles and poliomyelitis.<sup>4</sup>

47 Despite the role of vaccination as a central measure in infectious disease prevention, 48 vaccine hesitancy emerged as a threatening challenge undermining the success of 49 vaccination.<sup>5</sup> Vaccine hesitancy, defined as the reluctance or rejection of vaccines despite 50 their availability, has become a top threatening global health concern.<sup>6-8</sup> The issue of 51 vaccine hesitancy emerged long before the emergence of the novel severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) and the subsequent coronavirus 52 53 disease 2019 (COVID-19) pandemic.9-11

54 Previous studies indicated a wide range of factors linked with vaccination hesitancy, which is a place-, time-, and context-specific phenomenon.<sup>6, 12-14</sup> Nevertheless, the 55 56 emergence of the COVID-19 pandemic exacerbated the issue of vaccine hesitancy.<sup>15, 16</sup> 57 Unsubstantiated conspiracy theories, myths, and mis-/dis-information surrounding the 58 virus, preventive measures, and COVID-19 vaccines fueled the phenomenon of COVID-19 59 vaccine hesitancy, which was reported in various regions worldwide.<sup>16-18</sup> Thus, effective 60 control of COVID-19 relies not only on the availability of effective and safe vaccines, but 61 extends to involve positive attitudes and behaviors towards vaccination as well.<sup>19</sup>

62 The COVID-19 pandemic resulted in a profound negative impact on varying levels. The development and distribution of vaccines emerged as a promising measure to mitigate 63 64 the negative impact of this unprecedented pandemic.<sup>20, 21</sup> However, and as mentioned 65 earlier, the success of COVID-19 vaccination campaigns extended beyond the issues of COVID-19 vaccine efficacy and safety, since attitudes towards COVID-19 vaccination 66 played a major role in its uptake.<sup>22</sup> 67

68 The infiltration of conspiracy beliefs and misinformation regarding various infectious 69 diseases and vaccines —including COVID-19— has recently been notable in Arab countries.<sup>23-25</sup> This included unsubstantiated claims which lacked credible scientific 70 71 evidence. Examples of these false ideas include the idea that SARS-CoV-2 is a man-made 72 virus, the claim that COVID-19 vaccination aimed to implant microchips for surveillance. 73 and the idea that vaccination induces infertility to reduce the global population size.<sup>23, 26,</sup> 74 <sup>27</sup> The association between these factors and adverse health behaviors has been documented in various settings, including the recurring pattern of a link between vaccine 75 76 hesitancy and endorsement of these beliefs.<sup>27-29</sup>

77 Iraq, a Middle Eastern country, has a diverse population of over 41 million in 2021, and the country serves as a distinctive case study of a versatile society.<sup>30</sup> As of 18 October 78 79 2023, Iraq reported 2,465,545 cumulative COVID-19 cases and 25,375 cumulative deaths. 80 COVID-19 vaccination in Iraq started on 2 March 2021, with 19,557,364 vaccine doses 81 administered, benefiting 11,332,925 individuals with at least one dose and 7,944,775 82 individuals with a complete primary vaccination series as of 18 October 2023.<sup>31</sup> Four 83 vaccine types —Pfizer/BioNTech, Oxford/AstraZeneca, Sinopharm, and Sputnik V—

84 received approval for use in the country.<sup>32</sup> Several early studies from Iraq showed 85 varying attitudes towards COVID-19 vaccination and its associated determinants; nevertheless, the majority of these studies did not focus on the role of misinformation 86 87 and vaccine conspiracies on COVID-19 vaccine uptake.33-40

88 Therefore, the objectives of the current study included the elucidation of possible factors 89 that could be associated with higher COVID-19 vaccine uptake and positive attitudes 90 towards the vaccine among the adult Iraqi population. Specifically, we aimed to assess 91 the possible role of vaccine conspiracy beliefs and COVID-19 misinformation in shaping 92 vaccination attitudes and behaviors. Given the scope of this issue, we aspire to provide 93 novel clues into the role of medical-specific conspiracies on adverse health behaviors, 94 potentially offering valuable contributions to collective attempts for successful 95 vaccination campaigns.

### 96 **Materials and Methods**

### 97 **Study design**

98 This study employed a cross-sectional design, utilizing a self-administered online 99 questionnaire as the data collection tool. Inclusion criteria were specified in the introductory section of the e-survey and encompassed the following: participants had to 100 101 be Iraqi citizens, possess proficiency in the Arabic language, and be aged 18 years or

102 older.

103 The survey distribution occurred during 5 August 2022–14 September 2022. The 104 questionnaire was hosted in Google Forms, and the survey language was Arabic. The survey distribution was based on chain-referral sampling starting with the contacts of 105 106 the authors from Iraq (N.K. and M.A.) using e-mails, the direct messaging application 107 WhatsApp, and social media platforms (Facebook and Twitter). The participants were 108 asked to share the survey with their contacts as well. The survey was anonymous, and no 109 incentives were offered for participation. For those who consented to participate, 110 response to all items was mandatory to eliminate item non-response bias.

The minimum sample size in the current study was estimated at 2401 participants. 111 Calculation of the minimum sample size in this study was done using Epitools-112 Epidemiological Calculators, using the following assumptions: an estimated prevalence 113 of 50%, the desired precision of estimate at 2%, and the Iraqi population size of about 114 115 41,179,351 people in 2021.<sup>30,41</sup>

### **Survey instrument** 116

The survey instrument comprised seven sections as follows: First, an introductory 117 118 section which provided a short explanation of the research and its aims stressing on the

119 anonymity of the survey and the eligibility criteria, followed by the e-consent mandatory item: "Do you agree to participate in the study?". If the respondent selected "No", the 120

121 survey was directed to "submit form" page.

122 Second, the socio-demographics section: Seven items were used to assess the socio-123 demographic characteristics of the participants as follows: (1) age (as a continuous

124 variable, and grouped during the analysis based on the median age of the participants 125 into  $\leq 27$  years vs. > 27 years); (2) sex (male vs. female); (3) occupational category (employed healthcare worker (HCW), employed non-HCW, unemployed, or 126 127 university/college student); (4) governorate (the Capital Baghdad vs. outside the 128 Capital); (5) educational level (high school or less vs. undergraduate vs. postgraduate); 129 (6) monthly income of household ( $\leq$  500,000 Iraqi dinar (IQD) vs. > 500,000 IQD). The 130 classification was based on two times estimate of the minimum wage in the country (500,000 IQD  $\cong$  342.55529 US Dollars;<sup>42, 43</sup> and (7) history of chronic diseases (e.g., 131 132 diabetes mellitus, hypertension, heart, or renal disease) with yes vs. no as the possible 133 answers.

134 Third, a section on COVID-19 history of infection and COVID-19 vaccine uptake: Five 135 items were used as follows: (1) "Have you been diagnosed with COVID-19?" (yes vs. no); (2) for the respondents who answered the previous question with "yes", the question 136 "How many times have you been diagnosed with COVID-19?" followed; (3) "Have you 137 received COVID-19 vaccination" (yes vs. no); (4) for the respondents who answered the 138 139 previous question with "yes", the question "Which type of COVID-19 vaccines have you received?" followed with the following choices: the US-based Pfizer-BioNTech COVID-19 140 141 Vaccine, the UK-based Oxford-AstraZeneca COVID-19 vaccine, the China-based 142 Sinopharm BBIBP vaccine, the Russia-based Sputnik V vaccine, other types of vaccines 143 and more than one type of vaccine; and (5) "How many doses of COVID-19 vaccines have 144 you received?"

Fourth, a section on the attitude of the participants towards COVID-19 vaccination, 145 146 comprised the following question: "In your personal opinion, how would you rate the 147 importance of getting the vaccine to protect against COVID-19?". The item was measured 148 on a 5-point Likert scale: very important, important, neutral/no opinion, not important, 149 and not important at all. These responses were subsequently categorized into three 150 distinct vaccination attitude groups as follows: positive attitude group comprising 151 participants who indicated that COVID-19 vaccination was either "very important" or 152 "important", the neutral attitude group encompassing participants who answered 153 "neutral/no opinion", and the negative attitude group including participants who 154 perceived COVID-19 vaccination as "not important" or "not important at all".

Fifth, assessment of COVID-19 misinformation, with three items based on previous 155 studies addressing COVID-19 vaccine hesitancy in the Middle East,<sup>27, 44</sup> as follows: (1) 156 157 "What is your belief regarding the origin of SARS-CoV-2 in humans?" with options to 158 choose "natural" (scored as 1) or "man-made" (scored as 2).; (2) "COVID-19 vaccine is a 159 way to implant microchips into people as a control scheme" (with "yes" scored as 2 vs. "no" scored as 1); (3) "Getting COVID-19 vaccines will lead to infertility" (with "ves" 160 161 scored as 2 vs. "no" scored as 1). The sum of the scores for the three items comprised the 162 misinformation score which was subsequently classified into four categories as follows: 163 a score of 3 indicated absence of belief in COVID-19 misinformation, a score of 4 indicated 164 a slight belief in misinformation, a score of 5 indicated a moderate belief in 165 misinformation, and a score of 6 indicating a strong belief in COVID-19 misinformation.

166 Sixth, assessment of the sources of COVID-19 vaccine information using the following 167 item: "What is your single main source of information about COVID-19 vaccines?" with

168 the following options: Physicians, scientists and scientific journals vs. TV programs and 169 newspapers vs. social media platforms.

170 Finally, the seventh section on the assessment of COVID-19 vaccine conspiracy beliefs: 171 The conspiracy beliefs regarding COVID-19 vaccination was assessed using seven items 172 based on the original vaccine conspiracy beliefs scale (VCBS) adopted from Shapiro et al. 173 that was used previously in the assessment of COVID-19 vaccine hesitancy and influenza 174 vaccine uptake.<sup>27, 45, 46</sup> The seven items were: (1) COVID-19 vaccine safety data are often 175 fabricated; (2) people are deceived about the safety of COVID-19 vaccines (3) 176 pharmaceutical companies cover up the dangers of COVID-19 vaccines; (4) COVID-19 vaccine efficacy data are often fabricated; (5) people are deceived about the effectiveness 177 of COVID-19 vaccines; (6) vaccination of children is harmful, and this fact is hidden from 178 179 people; and (7) governments are trying to cover up the link between vaccines and other diseases, such as autism.<sup>27, 45</sup> The scale was assessed on a 7-point Likert scale as follows: 180 strongly disagree (scored as 1), disagree (scored as 2), somewhat disagree (scored as 3), 181 182 neutral/no opinion (scored as 4), somewhat agree (scored as 5), agree (scored as 6) and 183 strongly agree (scored as 7). The Cronbach α value for the VCBS was 0.893 indicating the acceptable internal consistency of the scale. The VCBS score could range between 7 and 184 185 49, with higher scores indicating the embrace of vaccine conspiracy beliefs. The VCBS was 186 then classified into three categories as follows: VCBS: 7–20 (disagreement with vaccine 187 conspiracies), VCBS: 21-35 (neutral), and VCBS: 36-49 (agreement with vaccine 188 conspiracies).

**Ethical approval** 189

The current study was approved by the Scientific and Ethical Unit at Al-Kindy College of 190

- 191 Medicine, University of Baghdad (approved by the Council of Al-Kindy College of 192 Medicine in session No. 20, date: 6 July 2022 under no specific reference number).

193 An electronic informed consent was required for successful completion of the survey by 194 the inclusion of an introductory mandatory item asking the participants to approve their

195 participation in the survey.

### 196 **Statistical analysis**

197 Data and statistical analyses were conducted using BM SPSS v26.0 for Windows (Armonk, 198 NY, USA: IBM Corp.). Univariate analyses were conducted employing the chi-squared ( $\chi^2$ ) 199 test. Associations with a significance level of p < .100 in univariate analyses were 200 considered for inclusion in the subsequent multivariate analysis. Multivariate analysis 201 was conducted using multinomial logistic regression. The Nagelkerke R<sup>2</sup> statistic was 202 employed to assess the variance explained by the model. A significance threshold of 203 *p*<.050 was applied to determine statistical significance.

### Results 206

### **Study sample characteristics** 207

The study sample comprised a total of 2544 individuals. Characteristics of the study 208 sample are shown in (Table 1). 209

# Attitude Towards COVID-19 Vaccination, COVID-19 Vaccine Uptake and its Associated Variables

The overall attitude of the participants towards COVID-19 vaccination was mostly positive (n=1966, 77.3%), while a neutral attitude was expressed by 345 participants (13.6%), and negative attitude was expressed by 233 participants (9.2%).

Using univariate analysis, the following factors were associated with a positive attitude towards COVID-19 vaccination: male sex, age > 27 years, being a HCW, postgraduate education, and monthly income > 500K IQD (**Table 2**).

226 The majority of participants reported uptake of at least a single dose of COVID-19 227 vaccination (n=2226, 87.5%) while 318 participants had no self-reported history of 228 COVID-19 vaccine uptake (12.5%). Using univariate analysis, the following factors were 229 associated with COVID-19 vaccine uptake: being an HCW, residence outside the Capital, 230 income > 500K IQD, and a history of confirmed COVID-19 infection (**Table 2**).

### 231 The Belief in COVID-19 Misinformation and the Embrace of COVID-19 Vaccine 232 **Conspiracy Beliefs**

233 Regarding the belief in COVID-19 misinformation, the complete absence of such beliefs 234 was reported among 731 participants (28.7%), while a slight belief in misinformation 235 was reported among 922 participants (36.2%). Moderate belief in misinformation was 236 reported among 576 participants (22.6%), and the strong belief in COVID-19 misinformation was observed among 315 participants (12.4%). For the attitude towards 237 238 COVID-19 vaccine conspiracies, the majority of participants exhibited a neutral attitude 239 (n=1464, 57.5%), with 607 participants showing the embrace of COVID-19 vaccine 240 conspiracies (23.9%), and 473 showing disagreement with such beliefs (18.6%).

In univariate analysis, the strong belief in COVID-19 misinformation and the agreement 241 242 with COVID-19 vaccine conspiracies were associated with both negative attitude to 243 COVID-19 vaccination and less COVID-19 vaccine uptake (Table 3).

### 249 Source of Information about COVID-19 Vaccines

The main sources of information regarding COVID-19 vaccination included physicians, 250 251 scientists, and scientific journals (n=1090, 42.8%), followed closely by social media

252 platforms (n=1040, 40.9%), and finally TV programs and newspapers (n=414, 16.3%).

253 The dependence on social media platforms was associated with both a negative attitude

to COVID-19 vaccination and less COVID-19 vaccine uptake (Figure 1).

# Multivariate analysis for factors associated with Positive Attitude towards COVID 19 Vaccination

The Nagelkerke R<sup>2</sup> value of 0.245 indicated that the regression model explained 24.5% of the variability observed in the data. For demographic variables, only males were

262 significantly less likely to have a neutral attitude compared to females, with an adjusted

263 odds ratio (aOR) of 0.64 (95% CI: 0.44–0.92, *p*=.016).

Statistically significant associations were observed between belief in misinformation and 264 COVID-19 vaccine attitude. Participants with no belief in misinformation displayed a 265 266 significantly higher likelihood of a positive attitude, with an aOR of 7.82 (95% CI: 4.16-14.68), while those with slight belief exhibited an aOR of 3.75 (95% CI: 2.46–5.71), and 267 those with moderate belief an aOR of 1.58 (95% CI: 1.07–2.31), all compared to strong 268 269 belief (*p*<.001, **Table 4**). Similarly, those who disagreed with COVID-19 vaccine 270 conspiracy beliefs (VCBS: 7–20) showed a higher likelihood of a positive attitude towards 271 COVID-19 vaccination, with an aOR of 10.42 (95% CI: 4.62–23.54), while those with a 272 neutral attitude (VCBS: 21-35) displayed an aOR of 4.57 (95% CI: 3.30-6.33), both 273 compared to those who endorsed vaccine conspiracies (*p*<.001, **Table 4**). Additionally, 274 participants with a neutral vaccine conspiracy attitude (VCBS: 21–35) displayed a higher 275 likelihood of a neutral attitude towards COVID-19 vaccination, with an aOR of 4.02 (95% 276 CI: 2.73–5.92), compared to those who endorsed vaccine conspiracies (*p*<.001, **Table 4**).

## 284 Multivariate Analysis for the Factors Associated with COVID-19 Vaccine Uptake

285 The Nagelkerke R<sup>2</sup> of 0.128 showed that the regression model explained 12.8% of the 286 variability observed in the data. Participants residing in Baghdad were less likely to have 287 received the COVID-19 vaccine, as indicated by an aOR of 0.56 (95% CI: 0.43–0.73, *p*<.001, 288 Table 5), compared to those residing outside Baghdad. Employed individuals in non-289 healthcare roles were significantly less likely to have received the COVID-19 vaccine, with 290 an aOR of 0.70 (95% CI: 0.52–0.93, p=.015, **Table 5**) compared to university/college 291 students. Individuals with a history of COVID-19 infection showed higher rates of COVID-292 19 vaccine uptake, with an aOR of 1.53 (95% CI: 1.19–1.97, *p*=.001, **Table 5**). Additionally, 293 participants with an income of ≤ 500K IQD showed less likelihood of COVID-19 vaccine 294 uptake, with an aOR of 0.66 (95% CI: 0.50-0.88), compared to those with incomes 295 exceeding 500K IOD (*p*=.004, **Table 5**).

Moreover, participants who reported no belief in COVID-19 misinformation exhibited a significantly higher likelihood of COVID-19 vaccine uptake, reflected in an aOR of 2.29 (95% CI: 1.45–3.61) compared to those with strong beliefs in misinformation (*p*<.001).

304 Also, participants with a slight belief in misinformation demonstrated a higher likelihood

305 of COVID-19 vaccine uptake, with an aOR of 1.49 (95% CI: 1.04–2.15, *p*=.031, **Table 5**). A

- 306 higher likelihood of COVID-19 vaccine uptake was observed among the participants who
- 307 disagreed with COVID-19 vaccine conspiracy beliefs (VCBS: 7–20) reflected by an aOR of
- 308 3.65 (95% CI: 2.16–6.18), and among participants with neutral attitude towards vaccine
- 309 conspiracies (VCBS: 21–35) with an aOR of 2.06 (95% CI: 1.56–2.71) compared to those
- 310 who endorsed vaccine conspiracies (*p*<.001 for both comparisons, **Table 5**). Finally,
- 311 participants who relied on physicians, scientists, and scientific journals as their source of
- information regarding COVID-19 vaccination exhibited a significantly increased 312 likelihood of COVID-19 vaccine uptake, as indicated by an aOR of 1.46 (95% CI: 1.10–1.94,
- 313 314 *p*=.009, **Table 5**) compared to those who relied on social media platforms.

### 315 Discussion

316 The current study revealed a clear distinct pattern in the possible factors influencing

- 317 COVID-19 vaccination attitudes and uptake. Notably, lower vaccine uptake and negative
- 318 attitudes towards the vaccine were significantly associated with endorsement of vaccine
- 319 conspiracies and COVID-19 misinformation.
- 320 In comparison to the previous studies conducted in Iraq, the participants in the current
- 321 study demonstrated a favorable attitude towards COVID-19 vaccination. For example, an 322
- earlier study by Ghazi et al. indicated that 77.6% of respondents were willing to take the 323 vaccine when available, a rate almost the same of the current study findings which
- 324 indicated that 77.3% displayed a positive attitude to COVID-19 vaccination.<sup>33</sup> Another
- 325 Iragi study in 2021 by Shareef *et al.* reported a lower acceptance rate of 56.2%.<sup>37</sup> On the
- 326 other hand, Al-Qerem et al. conducted a survey study in July 2021 and found that 88.6%
- 327 of respondents were willing to be vaccinated against COVID-19, with concerns about
- 328 vaccine safety and the need for more information being the primary reasons for vaccine
- 329 refusal.<sup>38</sup>
- 330 From a global perspective, the acceptance rate observed in our study is slightly higher
- 331 than the global average of 65–75%, as indicated by recent systematic reviews.<sup>47, 48</sup>
- 332 Despite the observed variability in the rates of COVID-19 vaccine acceptance which can
- 333 be attributed to survey timing, phrasing of the items assessing vaccination hesitancy, and
- 334 possible sampling bias, the common pattern in line with our findings is the generally
- 335 positive attitude towards COVID-19 vaccination in Iraq.<sup>16, 37-39</sup>
- 336 A notable aspect of this study was the clear demonstration of the correlation between COVID-19 vaccine conspiracies, COVID-19 misinformation, and negative attitudes and 337 338 behaviors towards COVID-19 vaccination. This manifested in significantly lower vaccine 339 uptake and less favorable attitudes towards the vaccine. The government in Iraq has 340 taken measures to combat such misinformation, emphasizing the importance of 341 vaccination and warning against spreading false information.<sup>49, 50</sup>
- 342 The Iraqi government adopted a non-mandatory approach regarding COVID-19 343 vaccination, refraining from imposing vaccine mandates due to the lack of legal support 344 of such a measure.<sup>51</sup> Instead, the Iraqi Ministry of Health and Environment advocated for 345 alternative public health strategies. In Iraq, employees were encouraged to voluntarily 346 provide either a weekly COVID-19 testing card or a vaccination card as a prerequisite for 347 work attendance without punishing measures against unvaccinated employees.<sup>51</sup> The 348 Iraqi government also initiated vaccination campaigns to enhance COVID-19 vaccine

349 coverage, with comprehensive plans to augment vaccine supply and to expand 350 vaccination facilities, with a particular focus on vaccinating HCWs to counter vaccine-351 related misinformation effectively.<sup>51, 52</sup>

352 The findings of the current study highlighted the significant association between conspiracy beliefs and negative health behavior manifested in lower COVID-19 vaccine 353 354 uptake. Extensive evidence has consistently highlighted the widespread presence of medical conspiracy theories and their potential impact on various aspects of health-355 356 related behaviors, including the willingness to get vaccinated and actual vaccine 357 uptake.<sup>27, 46, 53-57</sup> The adoption of conspiracy theories can exert a direct influence on individual engagement behaviors, including health-related practices.<sup>58-60</sup> For example, 358 the detrimental impact of embracing COVID-19 conspiracy beliefs on compliance with 359 360 government-imposed restrictions, adherence to preventive measures, and willingness to 361 receive COVID-19 vaccination was shown in a study from the U.S. by Romer and 362 Jamieson.<sup>61</sup> Similarly, research conducted in Finland by Pivetti *et al.* demonstrated that 363 the endorsement of COVID-19 conspiracy beliefs was associated with lower support for 364 pandemic-related governmental restrictions.<sup>62</sup> In the Arab countries of the Middle East, 365 the COVID-19 vaccine conspiracies have been shown to be associated with higher rates 366 of vaccine hesitancy/rejection.<sup>27,44</sup>

367 In the current study, an interesting observation was the striking contrast in the determinants of participants' attitudes towards COVID-19 vaccination compared to their 368 369 actual vaccine uptake. Notably, demographic variables appeared to play a minimal role 370 in shaping attitudes, whereas several demographic variables were significantly 371 correlated with actual vaccine uptake. This divergence between attitudes and behavior 372 can be attributed to the inherent distinction between what people think or feel 373 representing attitudes, and what they actually do manifested in behavior.<sup>63</sup> Attitudes 374 often reflect abstract viewpoints and personal beliefs, while behavior could be influenced 375 by a range of external factors, including governmental policies and societal 376 expectations.<sup>64, 65</sup> Thus, it is conceivable that individuals may hold certain attitudes about 377 vaccination but, when faced with practical circumstances, their behavior may align 378 differently.

379 The major finding in this study was unveiling the significant association between vaccine 380 conspiracy beliefs, misinformation, and negative attitudes towards COVID-19 381 vaccination, as well as a reduced likelihood of vaccine uptake. Plausible explanations of 382 this association could be based on previous and recent evidence highlighting the impact of conspiracies and misinformation on vaccination behavior.<sup>54, 66-68</sup> Conspiracy theories 383 384 and misinformation have the potential to deter individuals from getting vaccinated through reducing vaccine confidence.<sup>18, 69</sup> Endorsing conspiracy beliefs can undermine 385 the trust in healthcare systems, governmental agencies, and pharmaceutical 386 companies.<sup>70, 71</sup> Trust is an essential aspect in the decision-making process of getting 387 vaccinated.<sup>72, 73</sup> Hence, compromised trust could result in a negative attitudes towards 388 389 vaccination due to fear among individuals that they are not being provided with accurate 390 and safe preventive measures.<sup>74</sup>

391 Additionally, the current study results showed that the source of information could play 392 an important role in COVID-19 vaccine uptake. Health misinformation often spreads 393 through channels that may lack credibility, such as social media platforms.<sup>75-77</sup> When

individuals rely on social media for health information, they may inadvertently expose
themselves to distorted views on vaccine safety and efficacy.<sup>78</sup> The current study results
were consistent with this point of view by revealing that COVID-19 vaccine uptake was
lower among those who relied on social media platforms compared to individuals who
sought vaccine information from scientifically credible sources (e.g., physicians,
scientists, etc.).

400 Besides the important roles of vaccine conspiracy beliefs and misinformation, it is worth 401 mentioning other factors were linked to actual COVID-19 vaccine uptake in this study. 402 These factors could offer useful insights into the complexity of the vaccine uptake as a health behavior. First, participants living outside of the capital, Baghdad exhibited higher 403 404 COVID-19 vaccine uptake. This suggests that targeted efforts should be made to prioritize 405 vaccination campaigns in the capital city of Iraq. Additionally, lower income was associated with lower COVID-19 vaccine uptake, which emphasizes the importance of 406 addressing socio-economic disparities to ensure equitable access to COVID-19 407 408 vaccination. Furthermore, the history of COVID-19 infection appeared to influence 409 vaccination behavior, although the exact nature of this relationship is not discernible. It 410 is possible that individuals who had experienced the disease may have been less 411 complacent about vaccination due to their personal encounter with the disease. However, 412 establishing a direct cause-and-effect relationship in this regard can be challenging and 413 requires further investigation. Finally, in this study, university/college students, as a 414 group, exhibited higher COVID-19 vaccination rates. This aligns with previous research 415 and can be attributed to the view that students are generally more informed and engaged 416 in health-related matters.44,79

Lastly, it is essential to acknowledge the limitations of this study, which should be 417 418 considered carefully in any attempt to generalize the results as follows: (1) The 419 possibility of response bias should be considered with participants who chose to respond 420 to the survey being not representative of the entire adult population in Iraq. Additionally, 421 individuals with stronger opinions, whether positive or negative, about COVID-19 422 vaccination might have been more motivated to participate in the study, resulting in 423 response bias as well, with subsequent over- or under-estimation of COVID-19 vaccine 424 hesitancy/resistance and misinformation levels. (2) The study employed a cross-425 sectional design, entailing the capturing of data at a single point of time, which is helpful 426 for elucidating associations but cannot establish causality. Additionally, the data were 427 collected at a specific time point, making it hard to draw definitive conclusions about the 428 temporal trends in vaccination attitudes and behaviors. It is recommended to conduct 429 longitudinal studies to establish causal relationships and to analyze the temporal trends. 430 (3) The current study utilized the chain-referral sampling method to recruit participants, which is a non-random sampling method possibly introducing selection bias; therefore, 431 432 the sample may not be fully representative of the broader adult Iragi population. In 433 addition, the study inevitably excluded certain groups, such as individuals without 434 internet access or those who could not complete an online survey, further deepening the 435 issue of possible selection bias. (4) The findings of this study may not be easily 436 generalizable to other regions or countries with different cultural, social, or healthcare 437 contexts, based on the attributes of vaccine hesitancy as a phenomenon. Subsequently, 438 this could compromise the generalizability of the study results on the global level. (5) 439 Social desirability bias should be considered since the participants might have provided 440 what they believed as socially acceptable responses. This could have led to overreporting

- 441 positive attitudes towards vaccination and underreporting negative vaccination attitudes
- 442 endorsing conspiracy beliefs.

## 443 **Conclusions**

In conclusion, this study aimed to provide a comprehensive assessment of the factors shaping attitudes and behaviors related to COVID-19 vaccination in Iraq. The findings of the current study could provide valuable insights into the interplay between COVID-19 vaccine conspiracies, COVID-19 misinformation, and negative health attitudes and behaviors, which were manifested in lower COVID-19 vaccine uptake and unfavorable attitudes towards the vaccine.

450 These results emphasized the critical need for targeted interventions aiming to address 451 misinformation and to enhance COVID-19 vaccine literacy. Engaging HCWs as advocates 452 for vaccination can play a pivotal role in improving vaccine acceptance and uptake among 453 the population, which was highlighted by their significant role as a source of information 454 among participants who had higher rates of COVID-19 vaccine uptake. Furthermore, 455 tailoring communication strategies to specific demographics and belief-based subgroups 456 can be an important measure for effectively countering COVID-19 vaccine-related uptake 457 challenges. Ultimately, the implementation of these strategies can contribute to the global 458 effort to combat the COVID-19 pandemic by increasing vaccine acceptance and 459 participation, ultimately resulting in a positive impact on global health.
