# **1** Increased reproductive tract infections among secondary school girls

2 during the COVID-19 pandemic: associations with pandemic related

# 3 stress, mental health, and domestic safety

#### 25 Abstract

- 26 **Background**: Kenya, like many countries, shuttered schools during COVID-19, with subsequent
- 27 increases in poor mental health, sexual activity, and pregnancy. We sought to understand how the
- 28 COVID-19 pandemic may mediate risk of reproductive tract infections. We hypothesized that greater
- 29 COVID-19 related stress would mediate risk via mental health, feeling safe inside the home, and
- 30 sexual exposure, given the pandemic mitigation-related impacts of school closures on these factors.
- 31 Methods: We analyzed data from a cohort of 436 girls enrolled in secondary school in rural western
- 32 Kenya. Baseline, 6-, 12-, and 18- month study visits occurred April 2018 December 2019 (pre-
- COVID), and 30-, 36-, and 48- month study visits occurred September 2020 July 2022 (COVID
- 34 period). At study visits, participants self-completed a survey for sociodemographics and sexual
- 35 practices, and provided self-collected vaginal swabs for Bacterial vaginosis (BV) testing, with STI
- testing at annual visits. COVID-related stress was measured with a standardized scale and dichotomized at highest quartile. Mixed effects modeling quantified how BV and STI changed over
- dichotomized at highest quartile. Mixed effects modeling quantified how BV and STI changed over
   time, and longitudinal mediation analysis quantified how the relationship between COVID-19 stress
- and increased BV was mediated.
- 40 Findings: BV and STI prevalence increased from 12.1% and 10.7% pre-COVID to 24.5% and 18.1%
- 41 during COVID, respectively. This equated to a 26% (95% CI 1.00 1.59) and 36% (95% CI 0.98 –
- 42 1.88) increased relative prevalence of BV and STIs, respectively, in the COVID-19 period compared
- 43 to pre-COVID, adjusted for numerous sociodemographic and behavioral factors. Higher COVID-
- 44 related stress was associated with elevated depressive symptoms and feeling less safe inside the
- 45 home, which were each associated with increased likelihood of having a boyfriend. In longitudinal
- 46 mediation analyses, the direct effect of COVID-related stress on BV was small and non-significant,
- 47 indicating increased BV was due to the constellation of factors that were impacted during the
- 48 COVID-pandemic.
- 49 **Conclusions:** In this cohort of adolescent girls, BV and STIs increased following COVID-related
- 50 school closures. These results highlight modifiable factors to help maintain sexual and reproductive
- 51 health resiliency, such as anticipating and mitigating mental health impacts, domestic safety
- 52 concerns, and maintaining sexual health services to prevent and treat reproductive tract infections.

#### 54 **1. INTRODUCTION**

The World Health Organization (WHO) declared the end of the COVID-19 pandemic as a public 55

56 health emergency on May 5, 2023. To help stem the initial impact of COVID-19, Kenya, like many

57 countries around the world, shuttered schools on March 16, 2020, and put in place restrictions and

58 curfews related to travel and social distancing [1]. Schools were partially reopened on October 19,

59 2020, and fully reopened on January 4, 2021. The closure of schools, curfews, and restrictions on

- 60 travel and public gatherings were costly to the economy and disruptive to the social fabric of
- 61 Kenyans. The World Bank reported an estimated 2 million Kenyans were newly forced into poverty
- due to the pandemic [2]. The tangible impacts of the economic decline led to increases in job loss and 62 63 food insecurity, especially during the first 6 months of the pandemic, and this fall-out extended to
- 64 many low- and middle- income countries [3].
- 65 During the school closures, there were increases in adolescent pregnancy observed in our cohort of
- 66 secondary schoolgirls in western Kenya [4]. Among these secondary schoolgirls, the pandemic

67 period was associated with a 3-fold higher risk of school dropout relative to pre-COVID-19 learners.

68 This was a global phenomenon; school closures due to COVID-19 led to permanent school dropout

- 69 stemming from exacerbated and expanded poverty, added responsibilities of employment, domestic
- 70 work, and childcare, and pregnancy and marriage [5]. In meta-analyses of worldwide data, there were
- 71 increases in depressive symptoms and anxiety among children and adolescents, with greater 72
- prevalence and severity seen among girls and older children [6,7]. Evidence also emerged showing increases in sexual offenses against children coincident with lockdowns, curfews and school closures
- 73
- 74 [8].

75 Information is emerging on the impact of the COVID-19 pandemic on rates of sexually transmitted

76 infections (STIs), which disproportionately affect adolescent girls and young women. While there

- 77 were some decreases in STIs during the initial lockdown phases likely due to underreporting and
- 78 limited access to services [9,10], STIs rebounded at increasing rates over the pre-COVID period in
- 79 the United States [11,12], China [13], and Spain [14]. Maintaining reproductive tract health is a
- 80 public health and clinical priority. Bacterial vaginosis (BV) increases the risk of HIV acquisition 1.6-
- 81 fold [15] and non-ulcerative STIs increase the risk of HIV acquisition 3- to 5- fold [16]. This is
- 82 especially relevant in western Kenya, where the prevalence of HIV in the general adult population
- 83 ranges from 16% (Kisumu County) to 21% (Siaya County) [17]. BV and STIs are also associated
- 84 with increased risk of adverse pregnancy outcomes, such as preterm birth and premature rupture of
- 85 membranes [18], which already occur at increased rates among adolescent and young women
- 86 (AGYW) [19].
- 87 In this analysis, we describe how the prevalence of reproductive tract infections changed in a cohort
- 88 of Kenyan secondary schoolgirls from before to during and after the COVID-19 pandemic. We also
- 89 sought to understand how the COVID-19 pandemic could mediate subsequent risk of reproductive
- 90 tract infections. We hypothesized that greater COVID-19 related stress would mediate risk via mental
- 91 health, safety in the home, and sexual exposure, given the pandemic mitigation-related impacts of 92
- school closures on these factors. Quantifying the extent to which these factors contribute to 93 reproductive tract infection risk can help with decision-making around intervention development and
- 94 prioritization.

#### 95 2. METHODS

- 96 This study was approved by the institutional review boards of the Kenya Medical Research Institutes
- 97 Scientific Ethics Review Unit (KEMRI, SERU #3215), Maseno University Ethics Review
- 98 Committee (MUERC, MSU/DRPI/MUERC/01021/21), (Liverpool School of Tropical Medicine
- 99 (LSTM, #15-005), and University of Illinois at Chicago (UIC, #2017-1301). Written informed
- 100 consent was obtained for all participants, with written assent and guardian consent obtained for non-
- 101 emancipated minors.

# 102 2.1 Study Design and Participants

- 103 Data for this analysis came from the Cups and Community Health (CaCHe) study [20,21], a sub-set
- 104 of participants within the Cups or Cash for Girls (CCG) trial (ClinicalTrials.gov NCT03051789). The
- 105 CCG trial has been described in detail [22]. Briefly, CCG was a cluster-randomized controlled trial in
- 106 which secondary schools were randomized into 4 arms (1:1:1:1): (1) provision of menstrual cups
- 107 with training on safe cup use and care; (2) conditional cash transfer (CCT) based on  $\geq 80\%$  school
- 108 attendance in previous term; (3) menstrual cup and CCT; and (4) usual practice. For the CaCHe
- study, we enrolled approximately 20% of girls in the cup only and control arms of the CCG trial. The
- 110 CaCHe study was powered to detect a 25% reduced relative prevalence of BV for the cup arm
- 111 compared to the control arm, over 6 study visits. After enrollment, CaCHe participants were followed

every 6 months through 30 months for the trial analysis [20] (Figure 1). The 24-month study visit

scheduled to occur May 2020 was missed due to the COVID-19 pandemic. The 42-month visit was

114 missed due to a gap in funding.

117 Legend: Baseline began May 2018, and study visits took place at schools every 6 months through

118 October 2019 (18-month visit). The 24-month planned endline visit was cancelled due to COVID-19

restrictions and school closures. As schools were closed, we conducted the 30-month visit in the

120 community, as were subsequent study visits due to participants completing school. With careful

rebudgeting, we extended follow-up to 36-months, to continue capturing COVID-19 related impacts.

122 At the 36-month visit, specimens were obtained from 329 participants; an additional 58 participants

123 who had relocated were followed-up by telephone as the funding available did not support travel 124 outside the area. Subsequent funding allowed for follow-up for all participants, including those who

124 outside the area. Subsequent funding allowed for follow-up for all participants, including those who 125 left the study area. \*Due to COVID-19 precautions which limited the number of persons able to

gather, the study area. Due to COVID-19 precations which infinited the number of persons able to gather, the study period for the 30-month visit was extended, with 372 participants completed

between September 30 – December 18, 2020, and an additional 25 participants between January 15 –

128 February 7, 2021.

#### 129 2.2 Data Collected

At each study visit, participants undertook a self-completed survey that collected information on 130 131 sociodemographics, sexual practices, mental health, and menstrual practices. Participants were asked 132 if they were sexually active in the past 6 months, and if they had been coerced or tricked to have sex 133 in the past 6 months. Transactional sex was assessed through a series of questions that assessed sex in 134 exchange for things (e.g., pads, money, school fees) or treatment (e.g., favors, employment). Girls 135 were asked their marital status at each visit. Among those who reported being sexually active, they 136 were asked whether it was with a boyfriend, husband, or partner. At the 18-month study visit, a 137 separate question was added asking if participants were sexually active with someone who they 138 consider to be a boyfriend, partner or husband in the past 6 months, and this variable was used for the 139 18-month visit onwards. Few participants reported being married until the 48-month visit (Table 1) 140 and thus the variable used for analysis is referred to as having a "boyfriend" for simplicity. At the 12-141 , 30-, 36-, and 48- month visits, depressive symptoms were assessed using the 9-item Personal Health 142 Questionnaire (PHQ-9); scores were dichotomized at 5 or higher for analyses, reflecting mildly 143 elevated depressive symptoms [23]. The 12-month visit PHQ-9 score was applied at the baseline, 6-, 144 and 18- month visits for longitudinal modeling due to lack of measure at these time points. Domestic 145 safety was assessed at each time point during the COVID-19 period with a single question: "Since 146 the curfews and school closures due to COVID-19, do you feel more safe or less safe inside your 147 home?" with responses of "Less safe", "The same", "More safe". For analysis, responses were

148 dichotomized as "Less safe" vs. "The same or more safe".

149 Socioeconomic status at baseline was measured using questions related to household possessions, as

reported in [24]. To reduce participant burden and for relevance to menstrual hygiene, only latrine

151 type and water source used at home were asked at each subsequent 6 month visit and served as proxy

152 for socioeconomic status (SES) as a time-updated measure. Latrine type was scaled 1 to 4 points

153 (bush/field = 1, traditional pit = 2, improved pit = 3, flush toilet = 4) and water source was scaled 1 to

154 4 points (surface water = 1, borehole =2, rainwater = 3, piped water = 4) for a total of 8 points, with

155 higher score reflecting greater improvement. This proxy SES score was dichotomized at 3 or less

156 (lower) vs. 4 to 8 (higher). As compared to baseline SES using the more comprehensive assessment

157 of household possessions, 79% of participants with higher proxy SES (4 to 8 score) also had higher 158 SES by full assessment, and 42% of those with lower proxy SES (2-3 score) had lower SES by full

SES by full assessment, and 42% of those with lower proxy SES (2-3 score) had lower SES by full assessment (tetrachoric rho = 0.54). School level water, sanitation, and hygiene (WASH) score at

baseline was measured using previously described methods [23]; though schools were closed during

161 the COVID-19 pandemic, this cluster-level variable was retained due to its relevance to area-level

162 SES.

COVID-related stress: Stress related to the COVID-19 pandemic and mitigation measures was 163 164 assessed at the 30-, 36-, and 48-month visits using 8 questions covering physical and emotional 165 reaction domains related to COVID-19 specific psychological distress [25]. These questions ask 166 about changes in physical (e.g., sleeping, concentrating) and emotional experiences (e.g., feelings of 167 anxiousness, worry). Response categories were simplified from five categories to "Agree", "Don't 168 know/Not Sure", and "Disagree". COVID-related stress score was calculated by assigning 2 points 169 per question if the participant agreed, 1 point if participants responded "Don't know/Not sure" 170 response, and 0 if participants disagreed. The frequency distribution of responses to individual items

171 over time are in Supplemental Table 1. Cronbach's alpha was 0.87 (30-month), 0.86 (36-month), and

172 0.90 (48-month).

- 173 BV and STI Testing and Treatment: At baseline and each 6-month study visit, participants were asked
- to take self-collected vaginal swabs to test for BV and STIs, as detailed previously [20]. BV testing
- 175 was done at each 6-month visit, and STI testing was conducted at baseline, 12-, 30-, and 48- month
- visits. Self-collected swabs for BV were immediately smeared on glass slides by the study staff and
- 177 checked for sufficiency by a laboratory technician in the field. Slides were transported to the
- 178 laboratory and gram stained, followed by Nugent's scoring for detection of BV (Nugent score 7-10)
- 179 [26]. Infection with *Neisseria gonorrhoeae* (NG) and *Chlamydia trachomatis* (CT) were assessed via
- 180 nucleic acid amplification test (GeneXpert, Cepheid, Sunnydale, California, United States) and
- 181 *Trichomonas vaginalis* (TV) by rapid immunochromatographic assay (OSOM TV antigen detection
- assay (Sekisui, Lexington, MA, US). All participants were provided results, and those who tested
- 183 positive for BV or STIs were offered antibiotic treatment, regardless of symptoms.

# 184 2.3 Statistical Analysis

- 185 This analysis had two components: (1) mixed effects modeling to quantify how BV and STI changed
- 186 from the pre- and post- COVID periods, and (2) longitudinal mediation analysis to explain how the
- 187 relationship between COVID-19 stress and increased risk of BV was mediated. Due to minimal
- 188 missing data, analyses were conducted as complete case.

# 189 2.3.1. Change in BV and STIs from Before to During COVID-19


- 190 BV (Nugent score 7-10 vs. 0-6) is used as the primary outcome due to availability at all study visits
- 191 (except the 24 months missed visit) and for high correlation with sexual activity [21]. We examined
- 192 the change in BV over time using generalized linear mixed effects models with Poisson distribution, 193 with random effects for participant and cluster (school) and robust variance estimate. We examined
- the prevalence ratio of BV during the COVID-19 period (visits 30- through 48- months) as compared
- to pre-COVID (baseline through 18- months), and multivariable models adjusted for intervention
- 196 status and *a priori* confounders [20]: baseline STI status, age, socioeconomic status, PHQ-9, and
- reports of having a boyfriend and engaging in transactional sex. As a secondary analysis, STIs were
- 198 modeled using mixed effects models as described above. Mixed effects models were conducted in
- 199 Stata/SE v17 (College Station, TX).

# 200 2.3.2 Longitudinal mediation model

- 201 We conducted longitudinal mediation analysis to test our hypotheses that greater COVID-related
- stress mediated elevated depressive symptoms and feeling less safe inside the home, which in turn
- 203 mediated the proximal exposure, of having a boyfriend (Figure 2). The variable "sexually active"
- itself was not included in the model, since it is in the causal pathway for STIs, and often for BV. The
- 205 outcome for analysis was BV, as STI was measured only at annual study visits. We controlled for
- assigned intervention status as a known factor associated with BV [20], socioeconomic status and age
- as level 1 confounders (Figure 2), and engaging in transactional sex as a level 2 confounder (Figure
- 208 2). The mediation approach differs from multivariable adjustment (approach 1, above), in that the
- independent variable (COVID-related stress) is proposed to *influence* the mediator variables
   (depressive symptoms, domestic safety, having a boyfriend), which in turn influences the dependent
- variable (BV). In this way, the mediator variables seek to clarify *how* the independent and dependent
- 212 variables are related.

226 The longitudinal mediation analysis decomposed the overall impact of higher COVID-related stress

227 on the risk of getting BV into multiple distinct pathways using a counterfactual framework for

228 mediation [27,28]. We defined a generalized marginal structural model for nested counterfactuals

- where we directly parameterized each of the indirect effect pathways (Figure 2) through four distinct
- pathways: the *direct effect*, and indirect pathways a1, a2, and a3. The a1 pathway encompasses all potential pathways involving elevated depressive symptoms (PHQ-9 > 5), while a2 encompasses
- those associated with feeling less safe at home compared to prior to the COVID-19 pandemic. Lastly,
- a3 captures the influence of having a boyfriend on the outcome, BV. We derived parameter estimates
- of the direct and the indirect effects by regressing BV on COVID-19 related stress (the exposure) as
- 235 well as all the other possible pathways, using a weighted approach and incorporating random
- 236 intercepts [29]. Causal mediation analysis with a non-rare binary outcome often introduces some
- ambiguity due to the non-collapsibility of odds ratio, and we address this challenge using a log linear
- 238 model with robust bootstrapping for standard error estimation [30]. We also report percentage of
- 239 mediation effect. Longitudinal mediation was conducted in R (v4.1.13).

# 240 3. **RESULTS**

At baseline, participants were median age 16.9 years and were median age 21.0 years at the 48-

- 242 month visit, in keeping with the 4-year span of time (Table 1). The proportion of participants
- reporting having a boyfriend and being sexually active increased over time, especially at the 12-, 30-
- , and 48-month visits. At the 30-month visit, when schools largely remained closed and curfews were


- still in place, over one-third (34.5%) of participants reported feeling less safe in their home as
- compared to before the COVID-19 pandemic and associated lockdowns; this decreased to 17.8% by
- the 48-month visit.

# 248 **3.1.Distribution of Covariates by COVID-Related Stress**

- 249 The median COVID-19 stress impact score was 10 at 30 months and remained similar across time
- 250 points (Supplemental Table 1). There were higher rates of agreement with statements related to worry
- about getting infected with COVID, friend and family getting infected with COVID, or transmitting
- 252 COVID to someone else, and lowest rates of agreement with difficulty sleeping, concentrating, and
- 253 feeling overwhelmed.

# 254 **3.2.Increase in BV and STIs in the COVID-19 period as compared to the pre-COVID period**

- 255 Bacterial vaginosis increased from 11.2% at baseline to 14.1% at 18 months, and in the COVID-19
- 256 period, increased to 22.2% at 30 months and 28.1% by 48 months (Figure 3). Similarly, STI
- 257 prevalence increased from 9.9% at baseline to 11.6% at 12 months, rising to 16.2% at the 30-month
- and to 20.1% by the 48-month visit (Figure 3). At each timepoint during the COVID-19 period, the
- 259 prevalence of BV was greater for participants with higher reported COVID-related stress, those with
- lower socioeconomic indicators, reports of having a boyfriend, engaging in transactional sex,
- elevated PHQ-9 score, and feeling less safe inside the home (Table 2). In multivariable mixed effects
- modeling, there was a 26% increased relative prevalence of BV in the COVID-19 period compared to 263 prov COVID (adjusted provalence actio [aPB] = 1.26; 05% (CL 1.00, -1.50; Table 2) adjusted for
- 263 pre-COVID (adjusted prevalence ratio [aPR] = 1.26; 95% CI: 1.00 1.59; Table 3), adjusted for 264 assigned intervention status; baseline school-level WASH score, socioeconomic status, sexual
- assigned intervention status, baseline school-level wASH score, socioeconomic status, sexual activity, and STI status; and time-varying age, socioeconomic status, elevated PHO-9 score, engaging
- 265 in transactional sex, and having a boyfriend. Similarly, there was a 36% increased prevalence ratio of
- 267 STI in the COVID-19 period compared to the pre-COVID period (aPR = 1.36; 95% CI: 0.98 1.88)
- 268 (Table 3).

# 275 **3.3.Results of Mediation model**

276 We hypothesized that stress related to COVID-19 could be mediating the increased prevalence of 277 reproductive tract infection through depressive symptoms and domestic safety, both adversely 278 affected by the pandemic and potentially related to increased likelihood of having a boyfriend and 279 thus sexual exposure. To demonstrate the plausibility of the hypothesized relationships, the 280 association between COVID-related stress and mediators was examined with mixed effects models. 281 As shown in Table 4, feeling less safe inside the home compared to before the COVID-19 pandemic 282 (aPR = 2.16; 95% CI: 1.74 - 2.68) was elevated among participants with highest quartile COVID-283 related stress score, adjusted for numerous baseline and time-varying covariates, though elevated 284 depressive symptoms was not. Adjusted for the same numerous baseline and time-varying 285 confounders, having a boyfriend (level 2 mediator) was statistically significantly increased with both 286 level 1 mediators: elevated depressive symptoms (aPR = 1.20; 95% CI: 1.08 - 1.33) and feeling less safe inside the home compared to before COVID-19 (aPR = 1.21; 95% CI: 1.06 - 1.39), but was not 287 288 associated with COVID-related stress. In longitudinal mediation analysis, AGYW who reported 289 higher COVID-19 related stress had a non-significant 11% increased prevalence ratio of BV (Table 290 5). Among the various pathways through which COVID-19 related stress could mediate the risk of 291 BV, feeling less safe inside emerged as an important factor, contributing to 57.3% of the total effect. 292 This was followed by the influence of having a boyfriend at 25.2%, and elevated depressive

293 symptoms at 15.3%.

# 294 4. **DISCUSSION**

In this cohort of AGYW in western Kenya, the prevalence of BV and STIs increased over time, with

- 296 greater increases observed during the period of COVID-19, immediately following school closures.
   297 The data captured in our cohort with time accruing before and during the COVID-19 pandemic
- 298 enabled us to quantify this increase and evaluate reasons behind it. AGYW who were more greatly
- affected by the pandemic, as measured by COVID-related stress, were also more likely to report
- 300 feeling less safe inside the home, and in turn, were more likely to have a boyfriend, which was
- 301 proximal to having BV. Despite the association of these factors with increased COVID-related stress
- and with BV, and counter to our hypothesis, the direct effect of COVID-related stress on BV was
- 303 small and non-significant, indicating the increased likelihood of BV was due to the constellation of
- 304 factors that were impacted during the COVID-pandemic.
- 305 Having a boyfriend, the most proximal factor to BV and having greater likelihood of sexual
- 306 exposure, may represent a coping mechanism in response to financial stress, feeling less safe in the
- home, or feelings of depression and anxiety. As reviewed in a study of sexual coping mechanisms
   during the COVID-19 pandemic, sexual connections and the intimacy entailed "can help cope with
- 309 stressors and traumatic events" [31]. While not disaggregated by gender, the most frequently reported
- 310 sexual strategies were sex as a source of pleasure and intimacy, to bond with and please a partner, to
- 311 express care and strengthen the relationship, or to relieve stress and relax. A cross-sectional survey of
- 312 Kenyan school going adolescents aged 13-19 living in Nairobi or the Coast region found high
- 313 prevalences of anxiety (19.1%) and elevated depressive symptoms (19.1% with PHQ-9  $\ge$  10), as well
- as high mean scores for emotional and behavioral problems [32]. Mbithi et al. also observed that
- living in unsafe neighborhoods, being physically forced to have sex, and drinking alcohol were
- associated with increased odds of depressive symptoms and anxiety. In a mobile phone-based survey
- 317 of 2,224 adult-adolescent (age 10-19 years) pairs from Kisumu, Nairobi, and Coastal region, 36% of 318 adolescents reported depressive symptoms, and this was associated with adult loss of income, which
- in turn was associated with household tensions and violence [33]. We observed marginal significance
- 320 of elevated depressive symptoms among those with higher COVID-19 related stress, and there are
- 321 other dimensions of mental health that we did not measure. As we continue follow-up of these
- 322 AGYW, we have incorporated expanded measures of stress and anxiety. Our qualitative work will
- 323 incorporate questions related to what extent and how sexual relationships may be serving as a coping
- response to stress, and how these AGYW respond to and cope with stress more broadly. This may
- 325 provide insight for future interventions to provide AGYW with healthy coping strategies.
- Alternatively, having a boyfriend may represent increased sexual exposure through financial need or
   coercion. Our qualitative study involving focus groups with study participants and men in their
   communities provide further insight [34]. AGYW expressed that there were increased drivers for sex
- during the COVID-19 lockdowns, school closures, and restrictions: increased poverty with
- 330 concomitant pressures for transactional sex, including from men, peers, and parents; boredom and
- freedom to visit boyfriends; COVID-19 restrictions and curfews that left them having to spend nights with boyfriends; greater competition for boyfriends, leading to more risk taking (e.g., having sex).

  Men expressed that providing material and financial support was helping adolescent girls and young
- women during the pandemic, and at the same time they had awareness that this enabled them a power
- differential in engaging girls to have sex or to have sex without condoms. In semi-structured in-depth
- interviews with 34 adolescent-caregiver dyads who had participated in the Shamba Maisha
- 337 agricultural microfinance intervention in Kenya, AGYW receiving the intervention reported "no
- 338 longer needing to engage in transactional sex or have multiple concurrent sexual partners as a way to
- 339 meet their basic needs" [35]. Interviews revealed that girls felt less pressure for reciprocating for
- assistance with sex and that power differentials were reduced, by not having to rely on men for food
- 341 and other needs. Although *Shamba Maisha* intervention took place prior to the pandemic, structural

interventions addressing underlying drivers of sexual risk taking may sustainably reduce AGYW

343 vulnerability to economic disruptions, such as those brought by the COVID-19 pandemic.

Feeling less safe in the home compared to before the COVID-19 pandemic was elevated among 344 345 AGYW reporting higher levels of COVID-related stress and was associated with increased 346 prevalence of BV. As noted, worldwide there were increases in all forms of violence against women 347 and girls (including domestic violence, gender-based violence, and sexual assault), and this has been 348 named the "Shadow Pandemic" by UN Women [36]. The conditions of the pandemic, especially 349 during initial lockdowns and longer lasting restrictions on movement, led to financial stress, isolation 350 with abusers, tighter living quarters, reduced access to health care, police and justice, and social 351 services. UN Women called for national responses that provide psychosocial support to survivors, 352 expanded services (e.g., shelters, hotlines, counseling), and "strong messages" that violence against women and girls will be met with legal response [37]. The COVID-19 pandemic demonstrated there 353 354 is need and opportunity for virtual applications to provide services [38], though the applicability of 355 virtual services remains challenging for rural and other areas with pre-existing limited infrastructural 356 resources for technology and confidentiality, and limited or non-existent access to in-person services. 357 While we did not measure whether feeling less safe was physical, emotional, or sexual, results such 358 as ours reflecting the downstream impacts of domestic safety on reproductive health of AGYW 359 highlights the need to invest in and ensure these services are functionally in place prior to or shortly 360 following the next population level crisis. Interventions that are more likely to have significant and 361 sustained impact on preventing gender-based violence are not quick or easy solutions, such as 362 community-based and school-based promotion of gender equality, transforming gender stereotypes and discriminatory norms, reforming discriminatory laws, ensuring women's access to formal wage 363 364 employment and education, and increasing women's access to financial security [39]. As Mehta and 365 Seeley have previously written [40], the progress in sexual and reproductive health of the past 30 366 years is at critical juncture due to ongoing population level crises of pandemics, climate change, and 367 conflict.

#### 368 Limitations

369 The longitudinal multilevel mediation analysis with multiple mediators at each level is quite

370 complex, particularly when dealing with binary as opposed to continuous mediators and outcomes.

With limited work in this area, defining an appropriate model with assumptions that satisfies all the

data constraints is challenging. Marginal structural modelling is an effective method when it comes

to modeling sequential mediators, but there is limited work that implements time-varying multi-level mediation. For this reason, we were selective in our choice of mediators. Subsequent analyses will

# 379 Conclusions

380 In this cohort of adolescent girls and young women, the prevalence of BV and STIs increased

381 following school closures during the COVID-19 pandemic. Longitudinal analysis demonstrated that

382 this increased risk was mediated by depressive symptoms and feeling less safe in the home, which

383 led to increased likelihood of having boyfriends and thus sexual exposures. These results highlight

384 specific modifiable factors that can be targeted by interventions during crises, to help maintain sexual

and reproductive health resiliency in AGYW: mitigating mental health impacts and domestic safety

386 concerns. Our results also indicate further research is needed to elucidate the benefits and risks of

relying on boyfriends and sex partners to cope with these stressors, and how these relationships may 387 388 be leveraged as a resource.
