

1 Factors supporting the primary care physicians' performance in 2 Benin: a multiple case study

13 Abstract

14 Introduction

15 In Benin, as in many African countries, there is a gradual increase in physicians practising at
16 the primary care level. A literature review showed that these primary care physicians (PCPs)
17 have great potential for improving the quality of care. However, several conditions are
18 necessary for this potential to be unlocked and for the PCPs to contribute effectively to
19 strengthen their local health system. This study aims to understand the factors that underpin
20 the performance of PCPs in Benin.

21 Methods

22 We conducted a multiple case study in which we analysed eight contrasting PCP practices
23 spread across five health districts in Benin. The study used a combination of quantitative and
24 qualitative methods. We collected quantitative data through direct observations of the
25 services provided by the PCPs. A descriptive statistical analysis of these data helped to assign
26 performance scores to each PCP's practices (for the technical quality of services and
27 communication with patients). For the qualitative data collection, we conducted 40 in-depth
28 interviews and 16 focus group discussions with PCPs, other health workers, health
29 authorities, local authorities and other community members. This qualitative data was
30 subjected to thematic content analysis to identify the factors that might explain the
31 observed performances. We then constructed a matrix presenting all the cases studied and
32 the potential performance factors. Finally, we carried out a cross-case analysis to identify the
33 most critical factors supporting the performance of PCPs in Benin.

34 Results:

35 The PCPs' performance scores ranged from 14.7 to 19.3 (out of 20) for communication and
36 from 68% to 88% (out of 100%) for technical quality of care. Out of 14 potential performance
37 factors retained after the first phase of the qualitative analysis, cross-analysis revealed nine
38 factors that appeared to be essential in supporting the performance of PCPs in Benin in both
39 the public and private sectors. These were (i) the values supporting the PCPs' practices, (ii)

40 the PCPs' preparation to practice at first- line, (iii) the support provided to the PCPs from the

41 hierarchy, peers or professional associations, (iv) the leadership mandate given to the PCPs
42 and the degree of autonomy allocated to exert it, (v) the modalities of the financing of the
43 PCPs' practices, (vi) the accountability mechanisms in place to support the PCPs' practices,
44 (vii) the PCPs' relationship with the rest of the primary care team and their leadership style,
45 (viii) the PCPs' collaboration with community leaders and other public officials, and (ix) the
46 context in which the PCP's practices are embedded.

47 **Conclusion:**

48 This study has enabled the identification of a series of factors that could act as levers for
49 improving the practice of PCPs in Benin.

53 Introduction

54 Like the rest of the international community, African governments have committed to
55 ensuring healthy lives and promoting well-being for all their citizens (1). This goal cannot be
56 achieved without well-trained, motivated, available, and properly distributed human
57 resources for health (2). While the shortage of health workers is the most visible and
58 debated issue when it comes to human resources for health in Africa (2), the sub-optimal
59 utilization and performance of the existing workforce is an important, yet often unnoticed,
60 problem. Notably, recent years have seen a growing presence of physicians at African
61 primary care facilities (3,4), whereas the dominating policy choice (still) favors task-shifting
62 and provision of primary care services by nurse-practitioners (5,6). This situation results from
63 a combination of physician training efforts by African universities, governments' limited
64 capacity to recruit and position them at higher healthcare levels, limited access to
65 specialized training, and expansion of the private sector (7). This growing presence of
66 primary care physicians (PCPs) in Africa is mainly observed in the private sector (and in urban
67 areas) as a spontaneous, opportunistic, and poorly planned movement. However, there are
68 a few cases where the PCPs are positioned as part of the academic development of family
69 medicine or as part of a governmental choice to improve health systems' outcomes (4). For
70 example, the Beninese government recently launched a program to post physicians in some
71 of the largest primary care facilities that were previously staffed by non-physicians. The aim
72 of this program is, among others, to improve quality of care and financial viability of these
73 facilities. However, little is known on the ability of these physicians to contribute to these
74 goals.

75 Several scholars have indicated that PCPs have a good potential for improving the quality of
76 primary care in sub-Saharan Africa and the well-being of the population (4,8–10). In many
77 settings, PCPs improved the technical quality of care (11,12), the access to care for complex
78 conditions (11,13,14), and the clinical processes through training and supervision of non-
79 physicians (13). They were also able to innovate during the COVID-19 pandemic and support
80 the country responses (8,10). However, there is also evidence that PCPs in African countries
81 sometimes perform poorly, especially when it comes to key features of good primary care,
82 such as patient-centeredness, (financial) accessibility (15,16), technical quality of care (16–
83 18), continuity of care (9,19), comprehensiveness, coordination, and community
84 engagement (13,17). Moreover, the bulk of African PCPs work in urban areas and in the
85 private sector, which threatens the equitable access to the services they provide (4,8). These
86 performance issues are alarming as they may lead to inefficiencies, given that PCPs remain a
87 relatively rare and expensive source of care.

88 Fortunately, the current evidence indicates that, under certain conditions, the potential of
89 PCPs can be unleashed to improve primary care in African countries. Indeed, the PCPs'
90 practices are diverse across various settings, and the literature report positive outcomes for
91 the practice models that are relatively better organized and guided by a set of clear
92 principles and governance arrangements. This is for instance the case for family physicians
93 who receive a 2 to 4 years post-graduate training in family medicine, or for the "*Médecins*

94 *Généralistes Communautaires*” who are community-based physicians serving in rural areas
95 of some francophone Africa countries (4) or even physicians without a specific postgraduate
96 training but who have received some degree of governance guidance (20). Therefore,
97 understanding which factors influence the PCPs performance in a given context could help to
98 better guide and improve their practices. This is especially important in countries, like Benin
99 and many other African countries, where primary care delivery largely relies on non-
100 physicians and where the PCPs still remain relatively scarce.

101
102 A review of the PCPs’ practices in sub-Saharan Africa, taking a health system lens (4), helped
103 identify potential factors that could influence PCPs’ practices positively or negatively. The
104 professional identity of the PCPs includes the values underlying their practice, their
105 motivation to work as PCP, and their educational and professional trajectory, which is likely
106 to influence the way they perform in relation to primary care. Governance factors such as
107 the existence of policy guidance, clear role definitions, resource allocation modalities,
108 incentives and other accountability mechanisms may also influence PCPs’ performance. The
109 way PCPs’ activities are organized and their relationships with other primary care team
110 members, local health authorities, community members and other key stakeholders are
111 additional factors that can influence their performance. The work environment (tools,
112 equipment, infrastructure, etc.) and the overall context (rural, urban, poverty, overall health
113 systems performance, etc.) can also influence PCPs’ performance.

114
115 The literature examining PCPs’ performance outside Africa also suggest similar factors, but it
116 usually regroups these factors into physicians’ personal and professional characteristics on
117 the one hand, and organizational and systemic factors on the other (21). The physicians’
118 characteristics most often pertain to their training and professional experience, and to a
119 lesser extent to their age and gender. The organizational and systemic factors include the
120 organization of the physicians’ practices (role and task distribution with other staff for
121 instance), their workload, the availability of adequate infrastructure and equipment, and the
122 features of the local health system in which the PCPs’ practices are embedded. The
123 organizational and systemic factors are reported to play a greater part in physicians’
124 performance than their personal characteristics (21). The specific factors (or combination of
125 factors) that influence PCPs’ practices in sub-Saharan African countries are barely known.
126 Most of the publications on PCPs’ practices in Sub-Saharan Africa refer to the Republic of
127 South Africa and a limited number of other anglophone countries such as Nigeria, Kenya, or
128 Ethiopia (4).

129
130 Our study aims to better understand the factors that support the PCPs’ performance in
131 Benin (West Africa). We define performance as the PCPs’ ability (individually and together
132 with the rest of the primary care team) to provide care that is in line with the key features of
133 good primary care and to contribute to the good functioning of the local health system in
134 which they practice. The research questions are: (1) What is the performance of selected

135 PCPs' practices in Benin?; (2) Which factors are perceived by a range of stakeholders to
136 influence performance?; (3) What are the factors highlighted by the cross case-analysis
137 most likely to contribute to PCPs offer of quality primary care in Benin?

138 **Methods**

139 **Study design**

140 This is a multiple-case study, using a combination of quantitative and qualitative methods.
141 For this multiple-cases study, we defined the case as the performance of a given PCP (see
142 the objectives at the end of the introduction section).
143

144 **Selection of the study sites**

145 To address the research questions, we needed to contrast various performance levels (good,
146 average and poor) and observe multiple potential influencing factors. Therefore, we
147 purposively selected 8 cases. For each case, a study site was selected using following the
148 steps described below.

149 *Step 1: Defining sets of variables to use as criteria to appraise PCPs' performance*

150 Because our objective was to include a range of study sites with different performance
151 levels, we needed criteria to help us predict the performance of the PCPs in our database. As
152 a result of previous studies (8,28), we had access to a database of 150 PCPs. A factor analysis
153 from this database helped us to identify three criteria. Each criterion comprises a set of
154 variables (see supplementary file 1). The first criterion is related to the practice of quality
155 improvement and public health activities. The second criterion is related to the availability of
156 essential health services (i.e. those defined in the Benin national guidelines as high-impact
157 interventions) at affordable cost. The third criterion related to the self-rated satisfaction of
158 the PCP. We wish to emphasize that we did not aim to construct a scientifically validated
159 tool to assess PCPs' performance but rather to find a pragmatic approach to establish a level
160 of contrast between individual PCPs deemed sufficient for our specific study purpose.
161

162 *Step 2: Predicting the PCP performance based on each criterion*

163 For each PCP, we calculated a score for each criterion, integrating the values of the variables
164 composing this criterion. A score was considered low when below the mean score for a given
165 criterion minus the standard deviation ($\text{score} < \mu - \sigma$). A medium score was a score situated
166 between the mean minus the standard deviation and the mean plus the standard deviation
167 ($\mu - \sigma < \text{score} < \mu + \sigma$). A high score was higher than the mean plus standard deviation ($\text{score} >$
168 $\mu + \sigma$).
169

170 *Step 3: Purposive selection of the PCPs to be included.*

171 We purposively selected 8 PCPs aiming for a large mix: 2 PCPs with high scores for at least
 172 two criteria, 3 PCPs with medium scores across the criteria, and 3 PCPs with low scores for at
 173 least 2 criteria. In order to have a sufficiently large variation of cases, we also considered the
 174 gender and postgraduate training, if any, of PCPs, the institutional ownership of the facility
 175 where the PCPs practice, and the geographic position and the urbanization level of the
 176 facility's location.

177 Table 1 presents the characteristics of each of the 8 study sites, representing the 8 cases
 178 studied.

185 **Study settings**

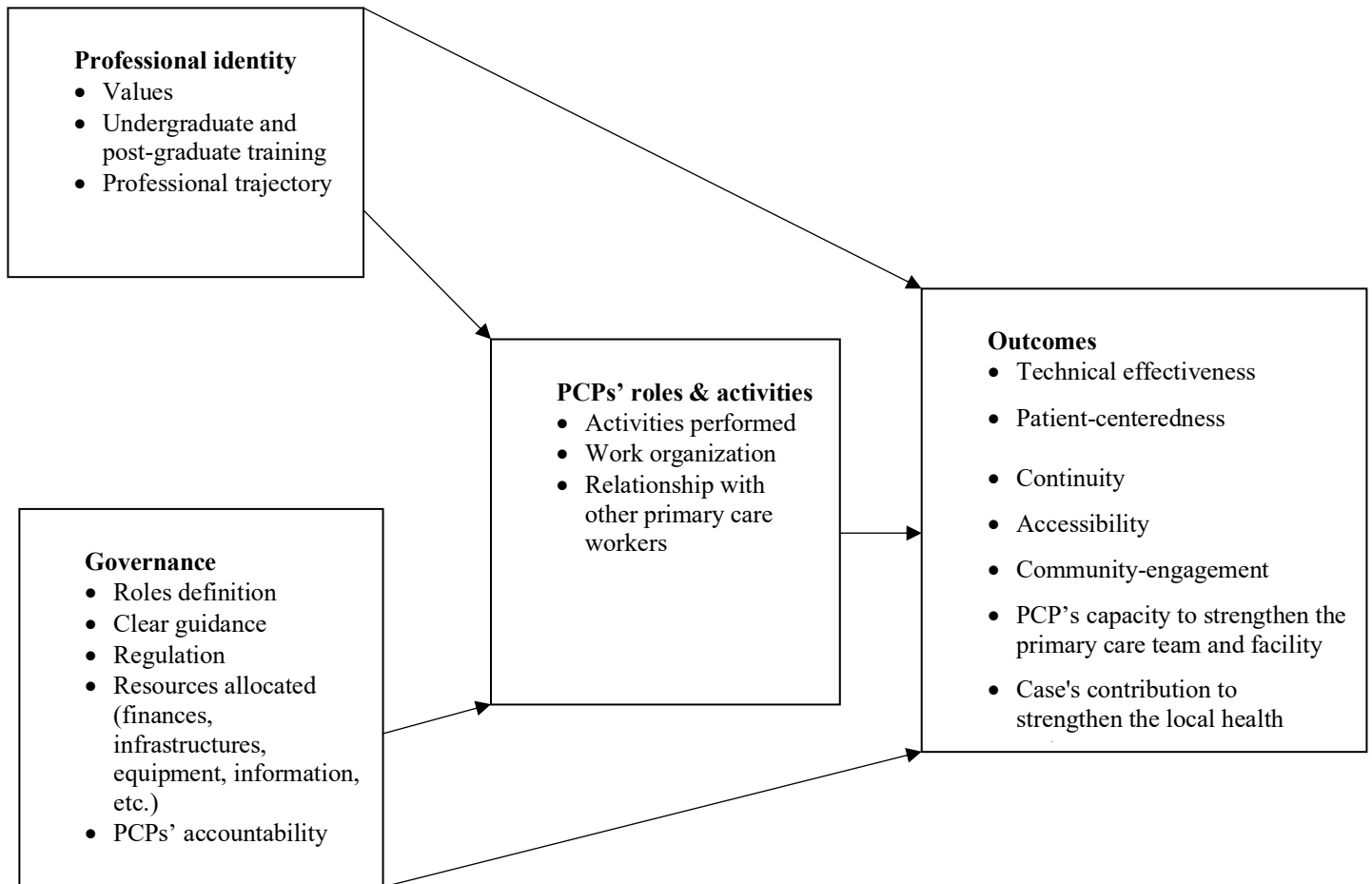


Figure 2: conceptual framework

186 The study sites are spread across five health districts in Benin (figure 2). Three districts are
187 urban: Cotonou 2-3 (Cot 2-3), Cotonou 5 (Cot 5) and Parakou-N'Dali (PN); and the two
188 others are predominantly rural: Ouidah-Kpomassè-Tori (OKT), and Nikki-Kalalé-Pèrèrè (NKP).

193 **Conceptual framework**

194 The conceptual framework (figure 1) used for this study was iteratively constructed based on
195 the Donabedian model (23), a scoping review previously conducted by the research team (4)
196 and relevant literature on primary health care and health systems (24,25). We also
197 integrated in the framework the factors described in the literature (see above) as influencing
198 PCPs' practices.

199
200 In this framework, the outcomes box regroups the range of performance dimensions of PCPs
201 and their teams that we assessed in this study: technical effectiveness, patient-
202 centeredness, accessibility of the PCP's services, continuity of care, community-engagement,
203 the PCP's capacity to strengthen the primary care team and the facility as a whole, and the
204 contribution of the PCP's practices to strengthen the local health system. The first five

205 dimensions are widely used to assess primary care performance (26,27) and we have chosen
206 them because the ultimate goal of this work is to improve the contribution of general
207 practitioners to quality primary care in Benin and Africa. These dimensions were also
208 perceived by Beninese stakeholders as key to judge the PCPs' performance. The PCPs'
209 capacity to strengthen the primary care team and the facility and their contribution to
210 strengthen the local health system are less commonly used to assess the performance of the
211 primary physicians or primary care workforce in general. However, they were deemed
212 important by the stakeholders in Benin because the PCPs are usually seen as the leader of
213 their teams and because their work is meant to support the performance of the local health
214 system, which role is to improve the health well-being of the population within their
215 boundaries.

216
217 It is important to note that all these performance dimensions, apart from the PCPs' capacity
218 to strengthen primary care teams and facilities, include not only the individual performance
219 of the PCPs, but also that of the primary care team. Indeed, as PCPs rarely work alone in
220 Benin, it would not be appropriate to assess their individual performance in isolation.

221
222 From the literature (4,21,24,25), we identified a number of factors that can potentially
223 influence PCPs' performance. We regrouped them into three categories: first, elements
224 pertaining to the professional identity of the PCPs; second, governance features of their
225 practice; and third, the nature of activities conducted and roles played in the local health
226 system (see figure 1).

230 **Data collection**

231 *Quantitative data collection*

232 The quantitative data served to respond to research question 1. We collected this data
233 through direct observations of the curative out-patient consultations conducted by each of
234 the 8 PCPs. The consultations were observed by a physician present in the consultation
235 room, using a structured observation grid. This grid was developed based on two tools: the
236 Global Consultation Rating Scale, which is a validated scale for assessing physician-patient
237 communication and patient-centeredness (29), and another tool for assessing the quality of
238 the clinical examination based on care protocols used in Benin (30). The observation grid
239 helped us to quantitatively assess two essential primary care dimensions: patient-
240 centeredness of care and its technical effectiveness. We pre-tested the grid with five PCPs
241 working outside of our study area to assess the relevance of these items. Feedback from
242 these physicians was used to further improve the grids. Feedback was also given by a
243 biostatistician. The physician who observed the consultations was trained for that purpose
244 and conducted 10 observations together with the principal investigator (KB) prior to the
245 actual data collection. They compared their scores for each of the 10 consultations.
246 Discrepancies were discussed to ensure common understanding of both tools. Each PCP was
247 observed for three consecutive days, selected as much as possible in the busiest period. Our
248 aim was to observe at least 20 consultations. We achieved this goal for all PCPs except in site
249 7. The number of consultations observed for each PCP is displayed in table 2.

250

251 *Qualitative data collection*

252 The qualitative data was collected through individual in-depth interviews (IDI) and focus
253 group discussions (FGD), using individual and group interview guides. These guides included
254 questions pertaining to all our research questions. For research question 1, we asked key
255 informants' opinion on the performance of the PCPs and their respective teams. For
256 research question 2, we explored the respondents' perceptions on the factors that
257 influenced (either positively or negatively) the performance of the PCPs studied. For
258 research question 3, the interviews provided information on the factors that could possibly
259 influence the PCPs' performance: their professional trajectory; their relationships with other
260 team members, local health authorities, and community members; their activities; the
261 organization of the primary care team; the type of support PCPs received; the accountability
262 mechanisms, etc. For research question 3, we complemented the interviews with field
263 observations. The latter provided information related to the PCPs' work environment, the
264 equipment and infrastructure available, and the work organization of the PCPs and their
265 teams.

266

267 For each PCP, key informants were selected from the following groups:

- 268 - All 8 PCPs (IDI)

- 269 - Other primary care workers operating in the health facility where the PCPs are based,
 270 including other physicians, nurses, midwives, nurse aids, and where available, non-
 271 clinical staff (IDI and FGD)
 272 - Local district health authorities (IDI)
 273 - Patients and other community members, including local and religious leaders,
 274 community health workers, and representatives of community-based organizations
 275 (IDI and FGD).

276 We respected the principle of maximum variation so as to have a diverse sample. The key
 277 informants shared information related to each of the three research questions. In total, we
 278 conducted 40 IDIs and 16 FGDs. The latter included 8 FGDs with 54 primary care workers
 279 and 8 FGDs with 63 community members (table 2).

280 To ensure a deep understanding of the PCPs’ practices and performance, the principal
 281 investigator (KB) and the research assistants spent two months to study the PCPs’ practices
 282 in their specific context. Moreover, KB kept in touch with the PCPs several months after the
 283 data collection for follow-up questions, when relevant.

288 **Data analysis**

289 **Research question 1**

290 We determined the performance of each PCP, including the individual performance of the
 291 PCPs as well as the performance of the primary care team as a whole.

292

293 For the individual performance of the PCPs, we analyzed the quantitative data using
 294 descriptive statistics. For each PCP, we then determined the mean communication score
 295 following the instructions of the Global Consultation rating Scale (29), and we determined

296 the percentage of recommended clinical actions effectively performed in line with the
297 prevailing care protocols in the country.

298

299 For the performance of the primary care team as a whole, we analyzed the qualitative data.
300 Most IDIs and FGD were recorded and transcribed verbatim. Summaries were immediately
301 produced after the interviews that were not recorded because the participant did not feel
302 comfortable with the recording. The research team kept a daily log, using a tool developed
303 in Microsoft Forms, reporting all research activities performed, and storing observation
304 notes. We uploaded the transcripts in the Dedoose software (32) and performed a thematic
305 content analysis (31) on the qualitative data. For research question 1, we coded the
306 respondents' opinions on the performance of the PCPs and their teams into good, average
307 or poor performance regarding the following dimensions: technical effectiveness, patient-
308 centeredness, accessibility, continuity of care, community-engagement, PCP's capacity to
309 strengthen the primary care team and facility, and the case's contribution to strengthen the
310 local health system. We then summarized the performance of each PCPs along each of
311 these dimensions into good, average or poor performance, based on the majority of
312 opinions. Finally, we integrated quantitative and qualitative results in a table presenting an
313 overall view of the cases' performance.

314

315 [Research questions 2 and 3](#)

316 We developed a coding tree, based on the factors indicated in our conceptual framework
317 and on the basis of our field notes. This coding tree was iteratively refined, and new codes
318 were progressively added during the data coding process. The codes were then regrouped
319 into themes, based on semantic similarities and co-occurrence.

320

321 More specifically for research question 2, we identified the factors that were most cited
322 across the 8 cases and across stakeholder' groups as important in shaping PCPs'
323 performance. We then summarized these factors in a table and provided examples of
324 positive and negative influencing factors, as indicated by our respondents.

325

326 For research question 3, we performed a cross-case analysis. This method facilitates
327 comparison of commonalities and differences in events, activities, and processes within the
328 various case studies (33). For the cross-case analysis in our study, we displayed in a matrix
329 all the cases and the main themes representing potential performance factors. We then
330 described in more depth the key aspects of each theme and discussed how this relates to
331 the case's performance. Finally, we summarized the similarities and the common elements
332 throughout the cases in relation to each theme and concluded on whether or not a
333 particular theme would be a factor influencing PCP's performance.

334

335 In this paper, we present a summary of the most important potential performance factors.
336 The matrix used for the cross-case analysis and the data within it, are presented in
337 supplementary file 2.

340 **Ethics**

341 This study received the ethical approvals of the Institutional Review Board of the Institute of
342 Tropical Medicine of Antwerp in Belgium (N° 1545/21) and the ethics committee for
343 biomedical research of the University of Parakou in Benin (N°0513/CLREB-UP/P/SP/R/SA).
344 We obtained informed consent from all participants, and the data were treated with strict
345 confidentiality.

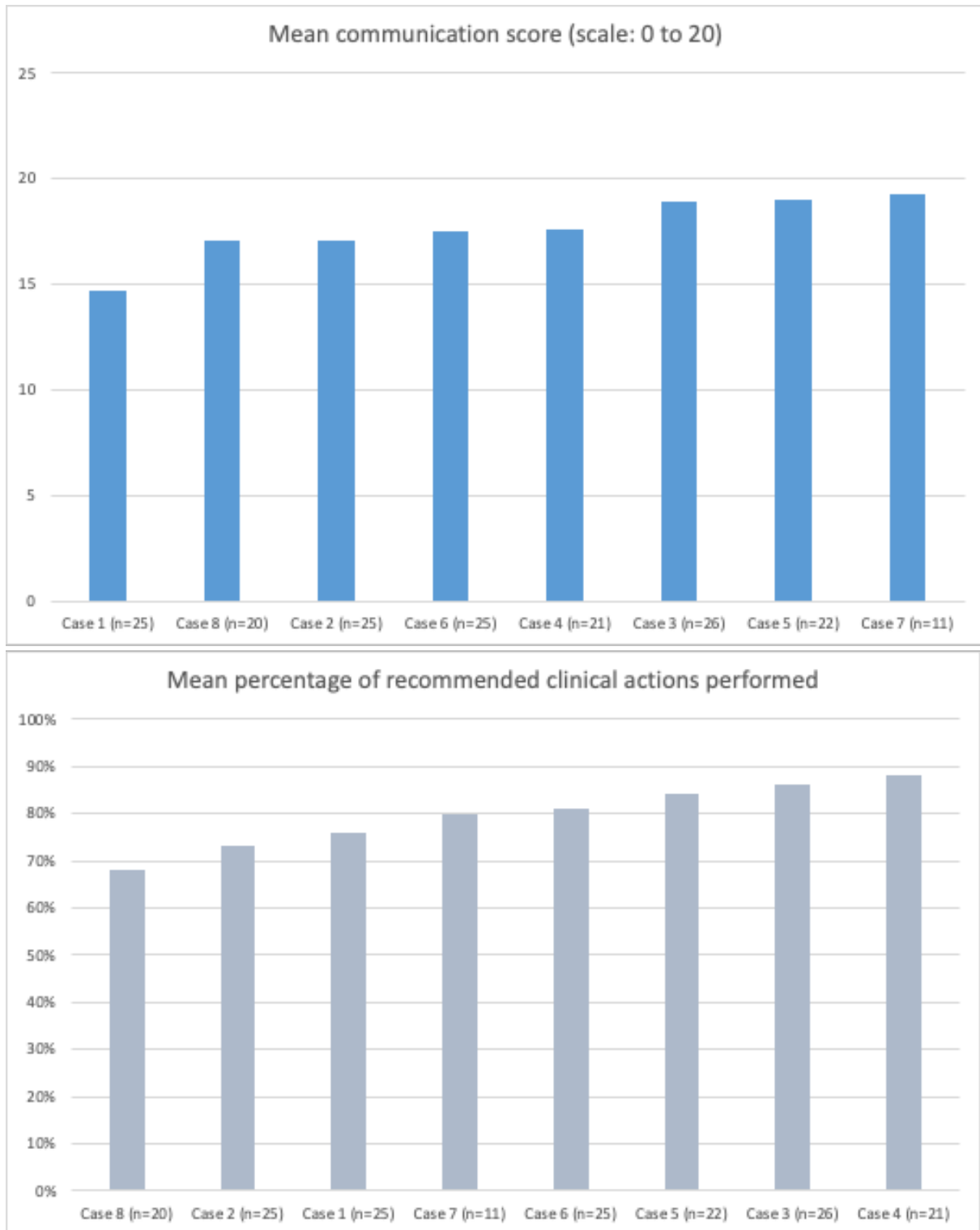

347 **Results**

348 **Performance of the 8 PCP cases in Benin.**

349 Figure 3 displays the mean communication scores and the mean percentage of
350 recommended clinical actions performed for each of the PCPs' observed.

354 Table 3 below summarizes the performance of the 8 PCP's practices, based on the
 355 qualitative analysis (stakeholders' perceptions and observation of the research team).

359 From the quantitative and qualitative results above, cases 1 and 2 have the weakest
 360 performance for all dimensions assessed. They had the lowest communication scores (14.69
 361 and 17.08 respectively) and the lowest percentages of recommended clinical actions (68%
 362 and 73% respectively). Similarly, based on stakeholders' perceptions and observations, the
 363 performance of these two cases was systematically poor or average throughout all
 364 dimensions.

365

366 The other six cases were more difficult to categorize. When we look at the individual
 367 performance for technical effectiveness and patient centered care, assessed through the
 368 consultations' observations, case 8 had low scores. However, the qualitative data indicated
 369 that it performed well in terms of community engagement and contribution to strengthen
 370 the local health system. Cases 3 and 5 appear to be the best performing cases when we
 371 consider individual performance during observations. Indeed, even if they did not have the
 372 best score for any of the two indicators, they both had high scores for both (see figure 3).
 373 The qualitative data also confirmed this finding. However, when we integrate the other
 374 dimensions and the performance of the primary care team as a whole, the performance of
 375 cases 3 and 5 are rather average. For instance, patient centeredness of care provided in case
 376 3 is average because of poor welcoming and communication with patients by the primary
 377 care team (apart from the PCP). Moreover, the accessibility of the PCP is limited because the
 378 PCP is regularly absent. As for case 5, its accessibility is limited because of high costs of care.
 379 There is also lack of a genuine community engagement beyond top-down designed
 380 sensitization campaigns. The contribution of this case to strengthen the local health system
 381 is difficult to appreciate because of the absence of a clearly defined population of
 382 responsibility and limited coordination with other health system actors.

383 Case 6 had an average performance for both indicators (17.47 for the communication scores
384 and 81% for the percentage of recommended clinical actions). The best performing case for
385 communication was case 7 (score of 19.28) but it was only average for the other indicator
386 (80%). Similarly, the best performing case in terms of complying with recommended clinical
387 actions was case 4 (88%) but it was only average for the other quantitative indicator (score
388 of 17,63). However, the qualitative data revealed that cases 6 and 7 performed better in
389 more dimensions than the other cases.

390

391 **Factors perceived by various stakeholders as key-influencers of PCPs' performance.**

392 The factors that were most frequently mentioned by the stakeholders were related (in
393 descending frequency order) to: (i) equipment, infrastructure, and utilities; (ii) support of the
394 primary care team; (iii) PCPs' intrinsic motivation and values; (iv) PCPs' knowledge and
395 competencies; (v) fulfilment of the PCP' personal needs; (vi) support from health authorities,
396 peers, local government authorities and/or community members; (vii) workload that PCPs
397 face; (viii) general context elements of the locality where the PCPs' practice is situated; and
398 finally (ix) financial resources available. Table 3 provides illustrations on how these factors
399 influence the PCPs' practices, as reported by the stakeholders.

402 **Factors highlighted by the cross-case analysis as likely to contribute to PCPs providing**
 403 **quality primary healthcare in Benin**

404 Based on the stakeholders' perceptions reported above, our conceptual framework and field
 405 observations, we identified a set of factors that can potentially influence the performance of
 406 the PCPs' practices. We have then conducted an analysis across the 8 cases to explore how
 407 each of these factors played out for each case and what could be the link between these
 408 factors and the case's performance. We concluded that a given factor probably influences a
 409 particular dimension of PCPs' performance when the following conditions were met:

- 410 - the factor is present for PCPs who display good performance and absent for the PCPs
 411 who display poor performance for a given dimension.
- 412 - There is a logical explanation on how the factor influences the PCPs' performance.

413
 414 Based on this analysis, we concluded that the following factors are likely to influence the
 415 performance of the PCPs' practices included in our study: (i) the set of values underpinning
 416 the PCPs' practices; (ii) the PCPs' preparation to practice at the level of the first line; (iii) the
 417 support provided to the PCPs by the hierarchy, peers or professional associations; (iv) the
 418 leadership mandate given to the PCPs and the degree of autonomy allocated to exert it; (v)
 419 the modalities of financing of the PCPs' practices; (vi) the accountability mechanisms in place
 420 to support PCPs' practices; (vii) the extent of collaboration with community leaders and
 421 other key stakeholders; (viii) the PCPs' relationship with the rest of the primary care team
 422 and their leadership style; and (ix) the context in which the PCPs' practices are embedded,
 423 especially whether this practice is in urban and rural area, and the ownership of the practice
 424 by the State or not.

425
 426 As illustration of this finding, the cases 1 and 2 were the least performing cases in our
 427 sample. In these cases, the PCPs had had little preparation to practice at the level of the first
 428 line, the mandate and roles assigned to them were limited to patients' consultations, and
 429 they had a limited autonomy for influencing anything in their health facilities. They did not
 430 have any incentive or requirement to go into the community and they work in silo or in
 431 minimum collaboration rather than in team with the other primary care team members
 432 (especially the case 2). In contrary, in the cases 6 and 7, which performed better than others

433 in several dimensions, the PCPs were very well prepared through a short post-graduate
434 training and field coaching. As the owners of their health facilities, they had a leadership
435 mandate and the necessary autonomy to exert this mandate. They also signed a charter with
436 their professional association, the health authorities, and the local authorities through which
437 they pledged to serve a well-defined population and they work together with the local
438 stakeholders. In these cases 6 and 7, the PCPs lead the primary care teams but they exert a
439 person-centered leadership with a good collaboration with the other primary care team
440 members and a particular attention to the needs of these team members.

441
442 Regarding the values, we found in all cases a commitment to serve the community and a
443 degree of professionalism. However, differences were found across the cases for other
444 values, and this impacts their performance. For example, in the sites where altruism and
445 commitment to help people were more developed (cases 1, 6 and 7), the financial
446 accessibility was better. In contrary, sites where these values were lacking (case 5) or only
447 officially stated (cases 2, 3,4, and 8), the financial accessibility was either average or bad.
448 Similar patterns were found for the support provided to the PCPs, the modalities of the
449 financing of the PCPs' practices, the accountability mechanisms, and the context.

450
451 Even though equipment and infrastructure are the most often mentioned factors by all types
452 of stakeholders, we could not find enough evidence to conclude that these influence the
453 performance of the cases studied. Neither could we conclude that continuing education and
454 fulfilment of the PCP's personal needs would influence the performance of the PCP. We did
455 not analyze the impact of the overall health regulation on the PCPs' practices because this
456 regulation is the same from one case to another and it was not possible to find differences
457 among the cases.

458 The table below summarizes our key findings. A detailed analysis of the factors influencing
459 the PCPs' practices across the 8 cases is available in the supplementary file 3.

461 **Discussion**

462 **Main results and comparison with international literature**

463 *Assessing the performance of the PCPs*

464 In this study, we used seven dimensions to evaluate the PCPs' performance: technical
465 effectiveness, patient-centeredness, accessibility of the PCPs' services, continuity of care,
466 community-engagement, the PCP's capacity to strengthen the primary care team and the
467 facility, and the contribution of the PCPs' practices to strengthen the local health system.
468 This holistic view of the PCPs' performance makes the evaluation complex, and simpler
469 approaches could be advocated for routine monitoring. However, our holistic approach
470 enabled us to get an in-depth understanding of the PCPs' performance and to identify issues
471 that might not be uncovered with the analysis of only one dimension. For instance, in our
472 study, the two cases performing best for technical effectiveness performed averagely for
473 other dimensions, which impeded the overall quality of the care received by the patients.
474 Measuring health workers' performance in primary care systems should thus include various
475 dimensions, reflecting the final outcomes expected from these systems. This
476 multidimensional assessment is a strong recommendation of the PHC measurement
477 framework published by WHO in 2020 (27) and other works (34,35). Unfortunately, many
478 studies on health workers' performance assessed one or very few dimensions, usually the
479 technical effectiveness for specific health conditions (36–38).

480
481 Another important fact is that the PCPs' performance can hardly be disentangled from that
482 of their team and the health facility in general. This is particularly true in contexts like Benin
483 and many other African countries where the PCPs usually work together or along with
484 nurses-practitioners. The case study approach we used allowed us to analyze the PCPs'
485 performance within their context and understand how this performance relates to the
486 performance of the rest of the healthcare team and to the patients' experiences. For
487 example, we found that some PCPs might have an excellent individual performance, but the
488 overall performance of their practices (which includes their own performance the one of
489 their team) was rather average. In other cases, individual average performance of the PCPs
490 was compensated by a good performance of the primary care team, resulting in good
491 patients' experience and good contribution to strengthening the primary care team. Our
492 approach to study the PCPs' performance aligns with the recommendations in the literature,
493 according to which one should not only focus on measuring and improving the performance
494 of individual health workers, but also consider team and organizational factors (21,34,38).

495

496 *Factors influencing the PCPs' performance*

497 Nine factors emerged from this multiple-cases study as likely to influence the PCPs'
498 performance in Benin:

- 499 - One factor is related to the professional identity of the PCPs': the values supporting
500 the PCPs' practices.

- 501 - Five are related to the governance of the PCPs' practices: the PCPs' preparation to
- 502 practice at the first- line, the support provided to the PCPs from the hierarchy, peers
- 503 or professional associations, the leadership mandate given to the PCPs and the
- 504 degree of autonomy allocated to exert it, the modalities of the financing of the PCPs'
- 505 practices, and the accountability mechanisms in place to support the PCPs' practices.
- 506 - Two are related to the roles and activities of the PCPs: the PCPs' relationship with the
- 507 rest of the primary care team and their leadership style and the PCPs' collaboration
- 508 with community leaders and other public officials.
- 509 - One transversal factor: the context in which the PCP's practices are embedded.

510

511 For the values, both the analysis of the stakeholders' perceptions and the cross-case analysis
512 showed that they influence various performance dimensions. Professional values are indeed
513 cornerstones of the identity of any profession (39), and they are reported to be important
514 for health workers' performance (39). However, as clearly illustrated among some of the
515 cases included in our study (table 5) and other studies (40), professional values should not
516 be taken for granted and it is not enough to articulate them in official documents. It is
517 important to ensure that the PCPs and other primary care workers adopt the values that
518 would support the performance expected from them. The few existing postgraduate training
519 programs for PCPs in sub-Saharan Africa (41,42) and some undergraduate programs (43)
520 include socialization of the trainees for the core PHC and family medicine values, such as
521 social justice, people-centeredness, community-orientation, etc. However, our study shows
522 that values can also be shared through interactions with peers within professional
523 associations or coaching from supervisors. This provides opportunities for PCPs already
524 working and countries without a postgraduate training program yet.

525

526 As for the PCPs' preparation, providing to the PCPs the necessary knowledge and skills to
527 practice in primary care settings was among the top five factors cited by the stakeholders we
528 interviewed. Scholars also pinpointed the physicians' knowledges and skills as a key factor
529 determining their performance (34,43). However, knowledge and skills should help the PCPs
530 to achieve the core primary care functions (27) and be geared towards the people's needs at
531 primary care level (as opposed to a hospital setting) (44). Other aspects of the PCPs'
532 preparation include preparing them psychologically to work in resource constrained
533 environments and improving their soft skills (leadership and communication skills for
534 example) to embrace the various roles expected from them, to work within a team and to
535 deal with the community leaders (5,34,45). Our study showed that the PCPs who got such
536 preparation tend to perform better. Alike the values, this preparation can be provided
537 through various channels including undergraduate training, postgraduate training, or
538 coaching by professional associations or supervisors.

539

540 Another factor highlighted by the stakeholders' interviews and the cross-case analysis is the
541 support received by the PCPs. This support helped the PCPs to have a better understanding

542 of the roles expected from them, to have access to some necessary resources, to get
543 feedback on their performance and to have a psychological resilience in difficult situations.
544 This in turn improved their performance. PCPs received support either from the hierarchy, or
545 their peers or professional associations. Studies in both hospital and primary care settings
546 reported that support from the health facility managers helps to implement best-
547 practices(38), motivates the health workers for good performance (34,35), and facilitates
548 access to necessary resources to provide care of good quality (38). Peer support is also
549 reported in the literature as a powerful means to enhance health workers' performance
550 (46).

551
552 Regarding the leadership mandate, the PCPs in our sample who were given this mandate
553 make visible efforts to improve the quality of care and the availability of resources in their
554 health facilities. We also found that among PCPs with a leadership mandate, those with the
555 necessary autonomy were more able to take the necessary decisions and hold the primary
556 care team accountable for a good performance. Leadership is a key function in health system
557 (27,47). In a primary care team this function can be fulfilled by any cadre. However, in the
558 African context, many stakeholders see the PCP as the leader of the primary care
559 team(5,45,48), and our study confirmed this. Consequently, giving the PCPs the official
560 mandate and skills to effectively exert this leadership mandate appears important.

561
562 Moreover, ensuring autonomy over resource utilization and daily management at the first
563 line facility is shown to improve performance because managers can be more responsive to
564 local needs and react better to daily issues (34).

565
566 Concerning the financing modalities of the PCPs' practices, the cross-case analysis showed
567 lack of financial support is likely to lead to increased costs for the patients and poor quality.
568 Providing financial support to the PCPs' practices can thus contribute to improve their
569 performance (and their financial sustainability) (49). For instance, we found in this study, as
570 in other work (34,35), that the opportunity to receive funding (or risk to lose it) was an
571 incentive to be more responsive to the patients. However, this financial support (and the
572 PCPs' payment mechanisms) must be carefully designed and geared towards the results
573 expected from the PCPs (34,50). It should avoid the issues related to financial incentives by
574 integrating a mix of provider payment mechanisms (50) and being combined with other
575 types of incentives. We also found that professional financial management can help the PCPs
576 to mitigate their costs and enhance their financial sustainability. This professional facility
577 management (different from the leadership) is also recommended by the WHO (27) and
578 does not need to be done by the PCPs themselves.

579
580 The accountability mechanisms in place to support the PCPs' practices strongly appeared in
581 the cross-case analysis as influencing the PCPs' practices. Effective accountability
582 mechanisms include a clear definition of the PCPs' roles (this was for example the case for

583 the PCPs in the public sector in our sample), a clear definition of the results expected
584 (including the population for which they are accountable), effective ways to assess and share
585 these results and clear consequences when these results are achieved or not. The literature
586 largely reports the need for the PCPs and the primary care teams in general to be
587 accountable (34,35,45). Our study also highlighted that accountability mechanisms can exist
588 and be enforced but not support the right results. For instance, the PCPs in the public sector
589 in our sample were held accountable for the income generated by their health facility, but
590 this does not necessarily support the core functions of primary care. Therefore, the
591 accountability mechanisms for PCPs in Africa should be built around the end results
592 expected from African primary care systems (34,51).

593
594 The PCPs' relationship with the rest of the primary care team (mentioned by the
595 stakeholders as the support of effective and available primary care team) is another
596 performance factor found by this study. Like in other research (27,38,50,52), we found that
597 the PCPs are likely to perform better if they work in cohesion with other primary care
598 professionals (especially nurse-practitioners). When such cohesion exists (rather than
599 working in silos or within hierarchical relationships), there are better chances for the primary
600 care team to have shared values, to share knowledge and to work together towards a shared
601 objective (38). Moreover, in the cases where there is a teamwork, we found that the non-
602 physicians were able to provide good quality of care to the patients, with the support of the
603 PCP, even when the latter is not present. This teamwork requires a leadership style from the
604 PCP that is person-centered and favors the development of shared objectives, understanding
605 and motivating team members, and building a team spirit (35,45).

606
607 The collaboration with community leaders and other public officials appeared in the cross-
608 case analysis and stakeholders' interviews as a factor that supports the PCPs' performance in
609 terms of community orientation and contribution to a good local health system. Indeed,
610 when such collaboration exists, the community leaders usually help the PCPs to understand
611 the needs of the communities they serve and to build the necessary trust for the use of the
612 health services by these communities. We also found some cases where the community
613 leaders helped the PCPs to access financial or material resources or provided feedback on
614 their practices, thus contributing to the overall performance of these PCPs. Engaging with
615 local stakeholders to understand key issues, design and implement solutions for these issues
616 has long been proven to be as an essential factor for improving performance and ensuring
617 the success of health interventions (27,35). However, this factor is more commonly cited
618 when referring to health for health system governance or facility management (27,35). Our
619 study shows that engaging key stakeholders in the community is also important for the
620 delivery of good quality primary care services and the performance of the primary care
621 teams.

622

623 The last factor emphasized by both the cross-case analysis and the stakeholders' interviews
624 is the context in which the PCPs' practices are embedded. We found that this context
625 influences the relative importance of other factors on PCPs' performance. For instance, a
626 PCP with a person-centered leadership style appears to be even more important in the
627 public sector than in the private sector. Indeed, the PCPs in the public sector don't always
628 have the necessary decision space to enforce orders given in a command-and-control way.
629 Also, lab tests, branded medicines and private health insurances were more available for the
630 cases located in urban areas. This increases the availability of services, but it also provides
631 more incentives for over prescription. The sociocultural and economic context indeed
632 influence the practice of any profession, and this should be considered when designing
633 interventions to improve health workers performance (21,34,35). The level of urbanization
634 warrants a particular attention as the share of the urban population is quickly growing
635 worldwide. In Benin, the urban population constituted 49.5% of the country's population in
636 2022 and this proportion is projected to be 65.45% in 2050. In Western Africa, 63.80% of the
637 population is expected to live in urban areas by 2050 (53). However, some positive factors
638 seem easier to get in rural areas (for instance a good relationship with community leaders).
639 Therefore, planning for primary care services and PCPs' practices should carefully consider
640 how to not lose the advantages linked to the rural areas and avoid or work around the
641 shortcomings inherent to urban settings.

642

643 **Factors with insufficient evidence regarding a potential influence on the PCPs' performance**
644 Even though they were cited by the stakeholders as influencing factors, we did not find
645 sufficient evidence at the cross-case analysis to conclude that the following factors influence
646 the PCPs' performance in Benin: the equipment and infrastructure available for the PCPs'
647 practices, the continuing education, the fulfillment of the PCPs' personal needs and the
648 workload of the PCPs.

649

650 The lack of equipment and infrastructure and the quasi-inexistence of a well-structured
651 continuing education system are common situations found across Benin's health system. In
652 our study, we did indeed observe this lack of resources and continuing education in most of
653 our cases, but we realized that those who performed well managed to overcome these
654 issues. For example, in some sites PCPs managed to ensure good continuity of care despite
655 the lack of digital patient records, which could have facilitated their work. Also, almost all
656 the cases that had good results with patient-centered care managed to do so despite
657 physical spaces that were not always appropriate. Finally, PCPs who had a leadership
658 mandate, the necessary will or creativity, the necessary autonomy, or the right relationships
659 with community leaders managed to gain access (even if temporarily) to resources for their
660 work. Similarly, some of the cases in our sample were able to compensate for the lack of
661 continuing education, thanks to peer support. Therefore, despite the importance of an
662 adequate equipment (21) and continuous training (21,37), our results show that much can
663 be done even with limited resources and other factors can help to have a good performance.

664 Other studies have also reported successful experiences of primary care provision in
665 resource-limited settings and even in situations of fragility (35,54). This opens great
666 possibilities in countries similar to Benin, with urgent need to improve the quality of care for
667 their population but where the socio-economic situation will probably not allow the PCPs to
668 get the same resources as PCPs in better-resourced countries.

669
670 Regarding the workload, some studies found that a high number of patients negatively
671 influences the physicians' performance(21). In our study, it was difficult to appreciate such
672 influence, as the average numbers of patients seen daily by the PCPs was relatively low. Also,
673 the PCPs with a high non-clinical workload in our sample were less available for patient care.
674 This was compensated by nurse-practitioners, and we did not find enough evidence to
675 conclude that it influences the PCPs' performance.

676

677 **Implications for practice**

678 [Contribution to international knowledge](#)

679 Most of the factors found in this study are consistent with previous knowledge. However,
680 subtleties emerged from our study which are linked to the Benin context and to similar
681 contexts in Africa and other regions with limited resources. In terms of strengthening
682 knowledge and competencies, several approaches can be used: basic training and
683 postgraduate training, of course, but also coaching and on-site support from peers and
684 supervisors. Therefore, in countries where postgraduate training does not exist yet, actions
685 can already be undertaken to have effective PCPs while waiting for postgraduate training
686 programs. Similarly, we found that limited availability of key resources such as equipment,
687 infrastructure, or continuing education can, to some degree, be compensated by a strong
688 leadership, a good support from peer communities or health authorities to the PCPs.

689

690 The study also highlighted structural factors (preparation of the PCPs, shared values adapted
691 to the context and to the expected results, etc.) which go beyond the individual
692 characteristics of doctors but have great potential to influence their performance.

693 Addressing these structural factors could help to tackle the root causes of the
694 underperformance of the PCPs and, more broadly, primary care systems.

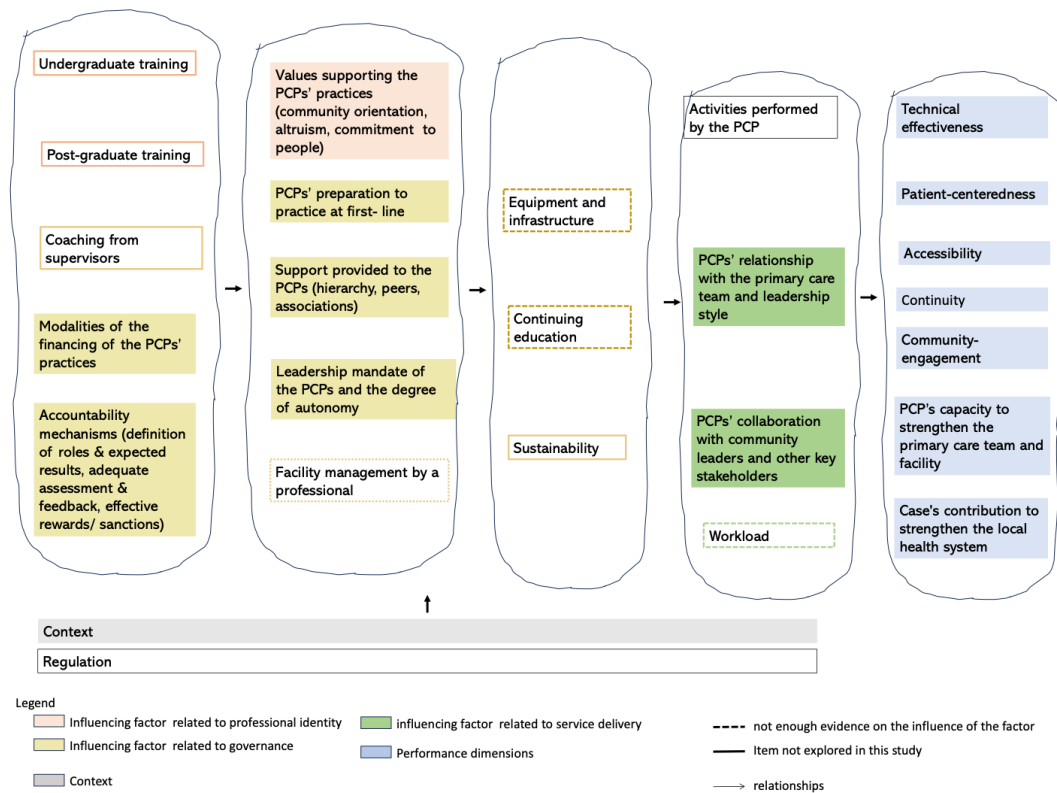
695 Finally, this study provided empirical evidence that can be combined with the existing
696 literature to build a theory on how the PCPs' performance can be supported in Benin and
697 refine the conceptual framework used for this study. This refined conceptual framework can
698 be used as a basis for a policy framework or to guide future efforts to analyze and improve
699 the PCPs' performance in Benin and similar contexts.

700

701 [Building a theory and a refined conceptual framework](#)

702 A deep analysis of the factors identified in this study showed that they are interlinked and
703 pathways to performance can be defined. These pathways include intermediary factors

704 (highlighted by the present study and previous literature) that can play a role in how a given
 705 factor influences the PCPs' performance (figure 4).

709 The following theory can summarise the pathways shown by figure 4.
 710 " If we offer adequate undergraduate training and adequate postgraduate training and/or
 711 the right coaching, the right financing modalities, and effective accountability mechanisms,
 712 we will have PCPs with the right values and the right preparation, with the necessary support
 713 and with a leadership mandate and the autonomy to exert it. These PCPs are able to mobilize
 714 the necessary resources (education and CME) to do their work and ensure the sustainability
 715 of their practices. This in turn can allow the PCPs to perform their activities in good
 716 collaboration and teamwork with the rest of the primary care team members and in
 717 collaboration with the community leaders and other key stakeholders and with the
 718 appropriate workload. All this leads to good performance, i.e the PCPs and their team
 719 providing are that is technically effective, patient-centered, accessible, and community
 720 oriented. The PCPs would also be able to strengthen her team and the PCPs' practices will
 721 effectively contribute to strengthen the local health system. Getting a professional facility
 722 manager (other than the PCP) can also help them in this reducing their workload, mobilizing
 723 resources and achieving the results. This pathway to performance will be influenced by the
 724 context and the right regulation can help maintaining it in a good direction".

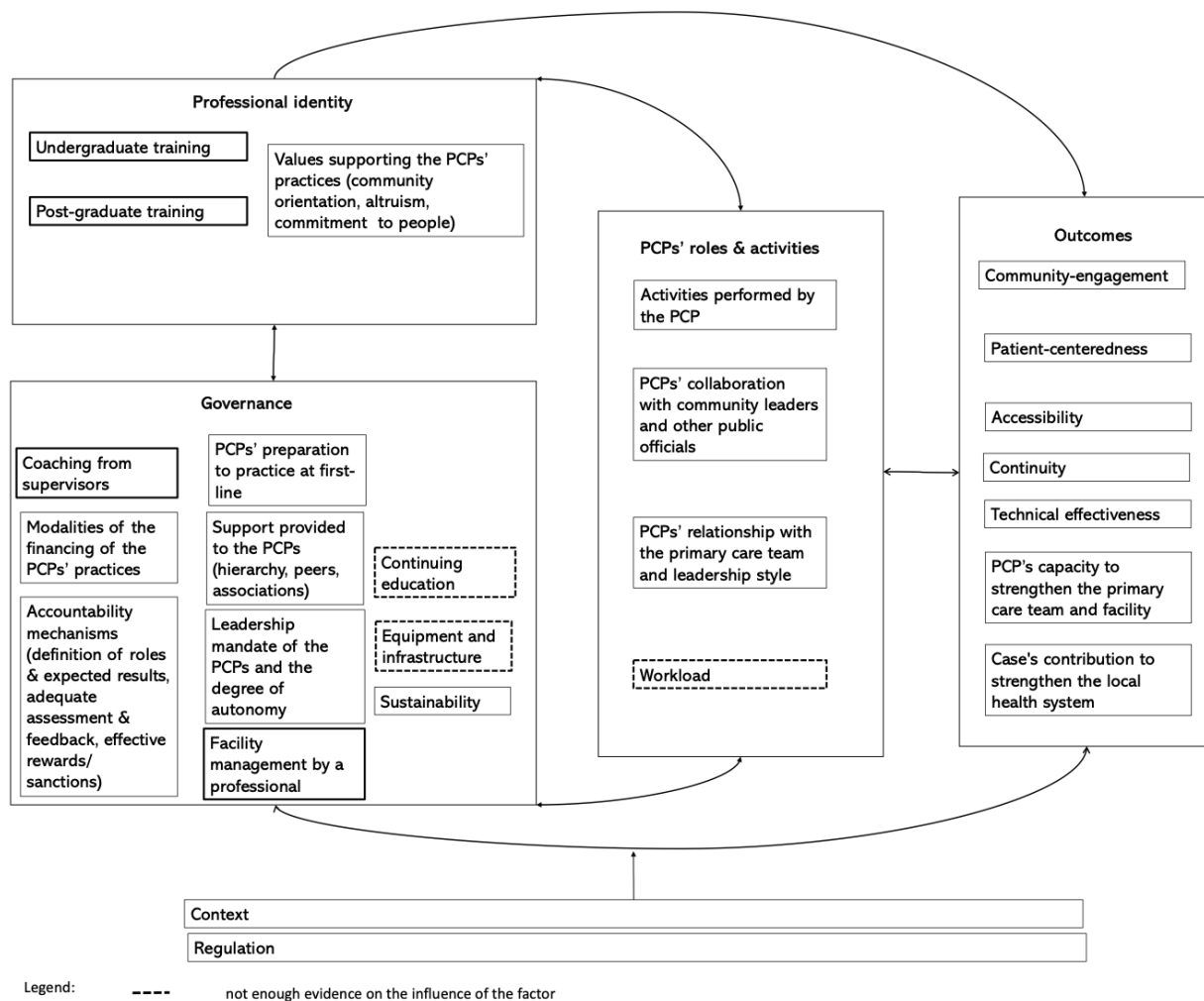


Figure 5: Refined conceptual framework for PCPs' performance

 725 From this theory, we build a refined conceptual framework displayed in figure 5.

Limitations and strengths

We used validated tools for assessing the performance of the PCPs but had only one observer to assess the consultations (instead of at least two as recommended for such assessment(29)). It was difficult to have more than one observer because of the small-sized consultation rooms and some reluctance from the PCPs and patients. This may have reduced the reliability of our findings. However, the triangulation between quantitative and qualitative data helped us to mitigate these insufficiencies. We also discussed the assessments at length between observer and principal instigator and enhance observer's inter-consultation variation. Another limitation is the low number of cases included in the multiple case study. There is thus room to study the range of factors influencing PCPs' performance on a larger sample and to test empirically the conceptual framework derived from these factors.

744 Despite these limitations, the study has several strengths. We achieved a reasonable level of
745 variation in our sites in terms of performance, geographic localization, urbanization level,
746 gender, and institutional ownership. This variation provided opportunities to observe
747 similarities and differences across cases and note how a given factor would play a role (or
748 not). This provides a certain level of confidence when concluding whether a factor was more
749 likely than others to influence the performance of PCPs. We used an ethnographic approach
750 with principal investigator and research assistants spending two months interviewing and
751 observing the primary care teams and other key stakeholders in great depth. Finally, we
752 succeeded in conducting 56 interviews allowing us to reach saturation of data.
753

754 **Conclusion**

755 By triangulating data related to the stakeholders' perceptions, field observations of PCP
756 practices and evidence from the literature, we can conclude that the following factors are
757 key in shaping PCPs' performance in Benin: (i) the values supporting the PCPs' practices, (ii)
758 the PCPs' preparation to practice at the first- line, (iii) the support provided to the PCPs from
759 the hierarchy, peers or professional associations, (iv) the leadership mandate given to the
760 PCPs and the degree of autonomy allocated to exert it, (v) the modalities of the financing of
761 the PCPs' practices, (vi) the accountability mechanisms in place to support the PCPs'
762 practices, (vii) the PCPs' relationship with the rest of the primary care team and their
763 leadership style, (viii) the PCPs' collaboration with community leaders and other public
764 officials, and (ix) the context in which the PCP's practices are embedded. Even if our
765 methodology does not allow us to overgeneralize our findings, the factors highlighted in this
766 study can further be tested in subsequent studies on PCPs' performance in other African
767 countries. Moreover, the study clearly shows that the factors affecting the PCPs' and other
768 health workers' performance are closely linked to the performance expected of them and to
769 the specificities of their working arrangements and conditions. This reinforces the idea of a
770 context-adapted policy framework being important for strengthening physician
771 performance. The empirical evidence on the factors generated by this study can be
772 leveraged to improve the PCPs' performance in Benin and similar contexts. It is a first step in
773 the development of coherent policies with regard to the organization and regulation of PCPs'
774 practices in Benin, and beyond in other West African countries with relatively similar health
775 systems.
