1	Sociodemographic and geographic variation in mortality attributable to
2	air pollution in the United States

# 33 Abstract:

34	There are large differences in premature mortality in the USA by racial/ethnic, education,
35	rurality, and social vulnerability index groups. Using existing concentration-response functions,
36	particulate matter (PM <sub>2.5</sub> ) air pollution, population estimates at the tract level, and county-level
37	mortality data, we estimated the degree to which these mortality discrepancies can be attributed
38	to differences in exposure and susceptibility to $PM_{2.5}$ . We show that differences in mortality
39	attributable to $PM_{2.5}$ were consistently more pronounced between racial/ethnic groups than by
40	education, rurality, or social vulnerability index, with the Black American population having by
41	far the highest proportion of deaths attributable to $PM_{2.5}$ in all years from 1990 to 2016. Over
42	half of the difference in age-adjusted all-cause mortality between the Black American and non-
43	Hispanic White population was attributable to PM <sub>2.5</sub> in the years 2000 to 2011.

# 51 Main Text

52	Despite improvements in the overall life expectancy in the USA over the past decades,
53	significant inequalities among different racial/ethnic and socioeconomic groups remain a
54	public health challenge <sup>1</sup> . For example, in 2019, the life expectancy at birth was 78.8 years for
55	the non-Hispanic (NH) White population but only 74.8 years for Black Americans <sup>2</sup> .
56	
57	Air pollution, particularly exposure to fine particulate matter (PM <sub>2.5</sub> ), is thought to be a major
58	risk factor for premature death, both worldwide and in the USA <sup>3</sup> . Although most areas in the
59	USA have seen declines in air pollution over the past decades, the pollution-related health
60	burden remains substantial <sup>3</sup> . Improvements in air pollution exposure have been unequally
61	distributed across population subgroups <sup>4-6</sup> . For instance, Tessum et al. <sup>5</sup> showed an overall
62	decrease in $PM_{2.5}$ exposure in the USA between 2005 and 2015, but that such benefits were
63	less pronounced among Black Americans, communities with lower educational attainment,
64	and rural communities. Several federal environmental policies have been implemented since
65	the 1970 Clean Air Act to address the fact that air pollution exposure differs across USA
66	communities and acknowledge the environmental justice implications of exposure to air
67	pollution. In particular, Executive Order 12898 (focusing on identifying and addressing the
68	disproportionately high adverse human health effects from environmental exposures and on
69	developing strategies for implementing environmental justice), Executive Order 14008
70	(focusing on climate change-related impacts and encouraging mitigations strategies that may
71	also have co-benefits on greenhouse gas emissions and public health) and the National
72	Ambient Air Quality Standard program state that air quality standards must be set at a level
73	that protects the most vulnerable populations. More information on these policies is provided
74	in the Supplementary Text.

75	In addition to being systematically more exposed to higher levels of air pollution, structurally
76	disadvantaged communities are also thought to be more susceptible to adverse health effects
77	from air pollution, which has sometimes been referred to as an environmental justice "double
78	jeopardy"7. For example, the concentration-response function (CRF) linking PM2.5 exposure
79	to mortality appears to be more pronounced among Black Americans <sup>8</sup> . Such differential
80	susceptibility is thought to be due to differential distributions in pre-existing comorbidities,
81	lack of access to health care, racialized occupational sorting into jobs with more hazardous
82	exposures, and other social and structural determinants of health <sup>7</sup> . Indeed, there is a rich
83	literature documenting how structural racism9, related to historical policies such as redlining
84	as well as contemporary inequalities in health care access, can explain such differential
85	susceptibility to air pollutants <sup>10</sup> .
86	
87	Using existing CRFs, PM <sub>2.5</sub> air pollution and population estimates at the census tract level,
88	and mortality data at the county level, the aim of this study was to quantify the contribution
89	of PM <sub>2.5</sub> to racial/ethnic, educational, geographic, and social vulnerability-related inequalities
90	in mortality in the USA to inform appropriate policy interventions. Studies that estimate the
91	number of deaths attributable to air pollution, and PM <sub>2.5</sub> in particular, usually rely on existing
92	CRFs from the literature to infer such burden <sup>11</sup> . These studies have used a single CRF for the
93	whole pooled population, assuming no differences in susceptibility to PM <sub>2.5</sub> , which may
94	drastically underestimate the unequal health burden of air pollution across vulnerable
95	communities. Given the evidence on differences in susceptibility to PM <sub>2.5</sub> by racial/ethnic
96	groups in the USA <sup>9–14</sup> , we used the CRF from Di et al. <sup>15</sup> for our primary analyses. The CRF
97	from Di et al. is the only existing CRF that provides race-ethnicity-specific estimates for each
98	of the main racial/ethnic categories in the US census and is based on a large sample of the

99	population from all US counties <sup>15</sup> . Our analysis relies on the assumption that this CRF
100	accurately depicts a causal effect of $PM_{2.5}$ exposure on mortality. To examine the degree to
101	which the use of CRFs that ignore differences in the concentration-response association by
102	racial/ethnic group underestimates disparities in PM2.5-attributable mortality between
103	racial/ethnic groups, we then compare our results to those obtained from two recent and
104	widely used uniform CRFs for the USA population in secondary analyses <sup>11,16</sup> . In this study,
105	we use the classification of racial/ethnic groups as a proxy for long-established and systemic
106	consequences of political, historical, and economic structures, social constructs as well as
107	environmental racism <sup>10,12,17</sup> .
108	
109	Results
110	Exposure to PM <sub>2.5</sub> at the national level:
111	In 2016, 0.8% of all census tracts and 0.9% of the overall population were exposed to an
112	annual mean $PM_{2.5}$ concentration above $12\mu g/m^3$ , which is the legally required threshold set
113	by the current National Ambient Air Quality Standard <sup>18</sup> . In comparison, in 1990, 83.4% of
114	census tracts and 85.9% of the population were exposed to $PM_{2.5}$ levels above $12\mu g/m^3.$ The
115	decline in PM <sub>2.5</sub> exposure (as well as all-cause mortality) overall, and separately by
116	subpopulation over time is plotted in figures Fig. S 2 -Fig. S 7. The mean population-
117	weighted $PM_{2.5}$ exposure levels, when averaged over the period from 2000 to 2016, were
118	highest among Black Americans at 9.38 $\mu$ g/m <sup>3</sup> , followed by Asians or Pacific Islanders at
119	9.21 $\mu$ g/m <sup>3</sup> , Hispanics or Latinos at 9.13 $\mu$ g/m <sup>3</sup> , Non-Hispanic Whites at 8.25 $\mu$ g/m <sup>3</sup> and
120	American Indians or Alaska Natives at 7.46 $\mu$ g/m <sup>3</sup> (Fig. S 4). Between 2000 and 2016, the
121	disparity in PM <sub>2.5</sub> exposure between Black Americans and Non-Hispanic Whites narrowed
122	from 2.17 $\mu$ g/m <sup>3</sup> to 0.94 $\mu$ g/m <sup>3</sup> .

# 123 *Estimated PM*<sub>2.5</sub>-attributable mortality at the national level:

124	In the overall population, the estimated $PM_{2.5}$ -attributable mortality declined from 79.2 (95%)
125	CI, 77.1 to 81.4) age-adjusted deaths per 100,000 in 1990 to 11.7 (95% CI, 11.4 to 12.0) in
126	2016. We observed this steep downward trend for all studied subpopulations, with absolute
127	differences between these groups narrowing considerably over the study period (Fig. 1, Fig.
128	S. 8). However, the lines representing each subpopulation in figure 1 did not intersect at any
129	time between 1990 and 2016. Thus, the most affected groups in 2016 were also the most
130	affected groups in 1990.
131	
132	From 1990 to 2016, Black Americans experienced an estimated 86% reduction in the age-
133	adjusted mortality rate attributable to PM2.5, the largest decline observed among all
134	racial/ethnic groups (Fig. 1). However, these larger improvements among Black Americans
135	must be considered in relation to their higher starting point in the PM <sub>2.5</sub> -attributable mortality
136	rate relative to other racial/ethnic groups. In fact, although the absolute size of the difference
137	in the PM <sub>2.5</sub> -attributable age-adjusted mortality rate between Black Americans and other
138	racial/ethnic groups decreased over the study period, the <i>relative</i> size of these differences
139	remained similar over time (Fig. S 9). Examining the estimated percent of all-cause mortality
140	that is attributable to $PM_{2.5}$ , rather than the $PM_{2.5}$ -attributable mortality rate, for each
141	population group yielded similar trends (Fig. 1). Of note, the declines in PM <sub>2.5</sub> exposure over
142	the study period have led to a decrease in the percent of all-cause mortality that is attributable
143	to PM <sub>2.5</sub> among each of our population subgroups. Unlike the decline in the PM <sub>2.5</sub> -
144	attributable mortality rate over time, this finding was not self-evident because it indicates that
145	for each population subgroup mortality from $PM_{2.5}$ decreased more rapidly than mortality
146	from other causes.

More than half of the difference in all-cause mortality between Black Americans and the
Non-Hispanic White population was attributable to $PM_{2.5}$ in each year from 2000 to 2011
(Fig. 2). With a decrease from 53.4% (95% CI, 51.2% to 55.9%) in 2000 to 49.9% (95% CI,
47.8% to 52.2%) in 2015, this proportion, however, has declined over time. The percent of
the difference in all-cause mortality to Black Americans that can be explained by differences
in exposure and susceptibility to $PM_{2.5}$ between racial/ethnic groups was lower for the
Hispanic or Latino White, Asian or Pacific Islander, and American Indian or Alaska Native
population than for the Non-Hispanic White population. Nonetheless, at a mean for the
period 2000 to 2015 of 20.8% (95% CI, 20.7% to 20.9%), 16.1% (95% CI, 16.1% to
16.2%) and 12.8% (95% CI, 12.7% to 12.8%) for the American Indian or Alaska Native,
Hispanic or Latino White, Asian or Pacific Islander, and population, respectively, the
percentages were still substantial.
We observed that disparities between racial/ethnic groups in PM2.5-attributable mortality
exist at all levels of education, rurality, socioeconomic status, household characteristics,
housing type and transportation, and social vulnerability index (Figures 3, S $10 - S 15$ ). In
fact, variation in PM2.5-attributable mortality by racial/ethnic group further increased when
the analysis was restricted to the population with high educational attainment or those
residing in non-metropolitan areas (Fig. S 16). The variation in PM2.5-attributable mortality
by racial/ethnic group was similar for the different levels of socioeconomic status, social
vulnerability index, and housing type and transportation (Fig. S 16). Black Americans and
Hispanic or Latino Whites had the highest PM2.5-attributable mortality at all levels of these
variables in the year 2016 (Figures 3, S $10 - S$ 14). Black Americans also had a higher

171	PM2.5-attributable mortality than the respective average for every level of these variables in
172	2016 (Figures 3, Fig. S 10– Fig. S 14). Hispanic or Latino Whites living in socially
173	vulnerable counties experienced double the PM2.5 attributable mortality than Hispanic or
174	Latino Whites living in socially resilient counties in 2016 (Fig. S 10, Fig. S 17).
175	
176	Those with low education and Black Americans had a higher PM2.5-attributable mortality
177	than the respective average for every level of rurality, socioeconomic status, housing type
178	and transportation, and social vulnerability index in 2016. Disparities in PM2.5-attributable
179	mortality by educational attainment were more pronounced for high socioeconomic status
180	than for middle and low socioeconomic status (Fig. S 18, Fig. S 19). Those with a high
181	school diploma or a lower level of education experienced a higher PM2.5-attributable
182	mortality than those with a higher educational attainment at all levels of rurality, social
183	vulnerability index, socioeconomic status, household characteristics, minority status, and
184	housing type and transportation (Fig. S 19 - Fig. S 24). High school graduates or lower living
185	in large metropolitan areas experienced 36.9% (95% CI, 34.5% to 39.3%) higher PM <sub>2.5</sub>
186	attributable mortality than those with the same level of education living in non metro areas in
187	2016 (Fig. S 25).
188 189	Disparities in PM <sub>2.5</sub> -attributable mortality by education or rurality were not as pronounced as
190	for racial/ethnic groups (Fig. 1). This finding was also corroborated when adapting a
191	coefficient of variation approach (15), which found that estimated age-adjusted $PM_{2.5}$ -
192	attributable mortality varied more by racial/ethnic group than by education or rurality in all
193	years of our study period (Fig. S 26). Nonetheless, differences in PM <sub>2.5</sub> -attributable mortality
194	by education and by rurality were still apparent. In the year 2016, those with a high school
195	diploma or lower experienced 16.9 (95% CI, 16.4 to 17.4) PM <sub>2.5</sub> -attributable age-adjusted

196	deaths per 100,000 (Fig. 1). This rate is nearly double compared to those with some college
197	education but no 4-year degree, who had a rate of 8.8 (95% CI, 8.5 to 9.0), and those with a
198	4-year college degree or higher, who had a rate of 7.7 (95% CI, 7.5 to 7.9) (Fig. 1). Similar
199	patterns are observed in all-cause mortality rates (Fig. S 5). Between 1990 and 2016, there
200	was a significant reduction in the absolute differences in PM <sub>2.5</sub> -attributable age-adjusted
201	mortality rates per 100,000 between large metro and non-metro areas, declining from 28.7 to
202	5.3. Despite this decrease in absolute disparity, the relative difference remained stable and
203	even showed a slight increase (Fig. 1). Specifically, large metro areas had 1.48 times the
204	PM <sub>2.5</sub> -attributable mortality rate of non-metro areas in 1990, and this ratio increased to 1.57
205	times in 2016 (Fig. 1).
206	
207	Variation in estimated PM <sub>2.5</sub> -attributable mortality across states and counties:
208	We observed substantial variation across states both in the age-adjusted $PM_{2.5}$ -attributable
209	mortality rate (Fig. S 27) as well as the percent of age-adjusted all-cause mortality that can be
210	attributed to $PM_{2.5}$ (Fig. 4). Fig. S 28 depicts the state-level positive association between
211	PM <sub>2.5</sub> exposure and all-cause mortality. In all states with a PM <sub>2.5</sub> -attributable mortality rate
212	above zero, Black Americans had a higher percent of all-cause mortality that can be
213	attributed to $PM_{2.5}$ (Fig. 4), as well as a higher $PM_{2.5}$ -attributable mortality rate (Fig. S 27), in
214	2016 than the Non-Hispanic White population. Similarly, those with a high school diploma
215	or lower education had a higher $PM_{2.5}$ -attributable mortality in all states compared to groups
216	with a higher level of education (Fig. S 28). In 31 of the 34 states that had both counties
217	designated as "large metro" and "non metro", "large metro" counties had a higher $PM_{2.5}$ -
218	attributable mortality compared to "non metro" counties (Fig. S 28).

220	When examining variation across counties, we found that in virtually all (96.6%) counties for
221	which data were available, Black Americans had a higher age-adjusted PM <sub>2.5</sub> -attributable
222	mortality rate than the Non-Hispanic White population (Fig. 5, Fig. S 29) for the mean value
223	across the period 2000 to 2016. The comparison between the Black American and Hispanic
224	or Latino White population was more varied, with a number of counties in the South-Eastern
225	USA having a lower PM <sub>2.5</sub> -attributable mortality rate for Black Americans than for Hispanic
226	or Latino Whites. The lowest $PM_{2.5}$ -attributable mortality rates for all three racial/ethnic
227	groups for which we had a sufficient sample size at the county level (Black American,
228	Hispanic or Latino White, and Non-Hispanic White) tended to be in counties in the Mountain
229	West. When taking into account spatial autocorrelation, we identified multiple county
230	clusters with significantly higher or lower differences in the $PM_{2.5}$ -attributable mortality rate
231	between racial/ethnic groups than in surrounding areas (Fig. S 30).
232	
233	All our analysis results, including differences in PM <sub>2.5</sub> -attributable mortality by racial/ethnic,
234	education, level of rurality, and social vulnerability-related groups, as well as trends over
235	time, remained similar in relative terms when restricting the study population to those aged
236	65 years and older (Figures S 31 – S 45).
237	
238	Discussion
239	Our study shows that improvements in air quality in the USA have decreased estimated
240	PM <sub>2.5</sub> -attributable mortality for all subpopulations that we examined. However, our analysis
241	also highlights the remaining inequalities in PM <sub>2.5</sub> -attributable mortality between different
242	subpopulations. These inequalities were most pronounced between racial/ethnic groups. In

fact, more than half of the difference in mortality between the Non-Hispanic White
population and Black Americans was attributable to PM<sub>2.5</sub> in each year from 2000 to 2011.

246 Our results indicate the strong association of the race and ethnicity group with adverse 247 environmental health outcomes – an association that is even stronger than for education, 248 rurality or social vulnerability-related factors. This finding aligns with a growing body of 249 evidence <sup>9,10,19</sup> demonstrating that racial/ethnic categories are not simply proxies for 250 socioeconomic differences but are also (imperfect) proxy measures for exposure to historical 251 and contemporary discriminatory practices. Racism and the discrimination of racial/ethnic 252 minorities emerged early in the founding of the USA and evolved into government-sponsored displacement, exclusion, and residential segregation<sup>9,10,19</sup>. Residential segregation is a 253 254 substantial consequence of structural racism that still negatively impacts the health of 255 racial/ethnic minorities today through various mechanisms involving both a disproportionate exposure to air pollutants and higher susceptibility to these pollutants<sup>4,7,9,15,20–22</sup>. Sources of 256 257 air pollution emissions are often located in marginalized communities, as residents of these 258 areas tend to have less economic opportunity, resources, and social capital, as well as limited 259 political power, to influence the decision-making processes that determine where such 260 sources of pollution are placed  $^{9,10,20}$ . In addition to its role in explaining differences in PM<sub>2.5</sub> 261 exposure between racial/ethnic groups, structural racism is likely also a major driver of the 262 unequal distribution of factors that contribute to the, on average, higher susceptibility to PM<sub>2.5</sub> exposure among many racial/ethnic minorities<sup>15</sup>. These factors include social 263 264 determinants of health, such as exclusion from job and educational opportunities, inadequate 265 access to healthcare, and maladaptive coping behaviors<sup>9</sup>.

267	An additional important finding of our analysis is that inequalities in PM <sub>2.5</sub> -attributable
268	mortality between racial/ethnic groups were obscured when ignoring differences in the
269	estimated susceptibility to PM2.5 across racial/ethnic groups. Using race-ethnicity-specific
270	mortality rates and $PM_{2.5}$ exposure measurements, but assuming that the mortality effects of a
271	given unit of PM <sub>2.5</sub> are equal across all racial/ethnic groups, will greatly underestimate
272	differences in PM <sub>2.5</sub> -attributable mortality. Similarly, using CRFs that do not take into
273	account differences in susceptibility to PM2.5 between racial/ethnic groups will generally
274	underestimate the benefit of reductions in PM <sub>2.5</sub> on health outcomes among structurally
275	disadvantaged groups. We, thus, advocate for the use of race-ethnicity-specific CRFs in
276	future health impact studies to ensure air quality policies protect subpopulations most at risk.
277	
278	We note some caveats of our study. A first set of limitations relates to the CRFs that we used
279	in our analysis. First, although the race-ethnicity-specific CRF by Di et al. <sup>15</sup> used in this
280	analysis was developed in the age group 65+ years, our manuscript presents results for the
281	age group 25+ years. To investigate whether our results would differ substantially if we
282	conducted our study in this older age group only, we have implemented all analyses shown in
283	this manuscript when restricting the study population to the age group 65+. The results
284	(shown in the Supplementary Materials) demonstrate that all relative differences and patterns
285	over time by racial/ethnic, education, and geography group remain similar. Second, we use a
286	uniform CRF to derive the mortality response for all subpopulations not related to
287	racial/ethnic group. There is evidence of differences in susceptibility to PM <sub>2.5</sub> for the
288	different subpopulations. For example, the composition of air pollution in urban areas has
289	more adverse health effects than in rural areas <sup>23</sup> . We may, thus, underestimate the differences
290	in PM <sub>2.5</sub> -attributable mortality between subpopulations not related to racial/ethnic group.

Third, because the true underlying PM<sub>2.5</sub>-attributable mortality rate is not practically
measurable, we cannot estimate the validity of any given CRF. We therefore present results
using multiple CRFs, selecting Di et al.'s model as our primary CRF due to its unique
provision of race-ethnicity-specific estimates and its foundation in a nationwide
sample<sup>11,16,24</sup>.

297 A second set of limitations relates to our PM<sub>2.5</sub> exposure measurements. We relied on 298 assigning PM<sub>2.5</sub> exposure based on the current location of residence. This could be 299 problematic for two reasons. First, if people live and work at different locations and pollution 300 levels are systematically different between these locations, our attribution estimates may be 301 biased. However, available evidence for urban areas finds the discrepancies in work and 302 residential PM<sub>2.5</sub> levels are small in absolute values  $(<0.1 \mu g/m^3)^{25}$ , suggesting that assigning 303 exposures by residence location may be a reasonable approximation of total exposure. A 304 related concern arises if mortality is driven mainly by long-term cumulative exposure, 305 populations change residence locations during the study period, and there exists a systematic 306 correlation between exposure at previous residence location and exposure at current 307 residence location. However, existing literature finds that both immediate and long-term 308 exposure matter for health outcomes, and again does not find consistent support for patterns of geographic mobility being associated with pollution levels in the USA<sup>26</sup>. Another potential 309 310 limitation associated with exposure assignment was due to pollution and population data 311 being available at a geographically more granular level (0.01° by 0.01° and the census tract 312 level, respectively) than our mortality data (available at the county level). As the geographic 313 level at which we conduct our analysis increases, the risk of ecological bias increases. 314 However, it is worth noting that the 'smoothing' effect of using county-level data is more

315 likely to result in underestimation rather than overestimation of disparities between 316 subpopulations. This is because the averaging process could dilute more extreme values that 317 contribute to these disparities, making them appear less pronounced than they actually are. 318 We, however, did not observe a substantial association between the proportion of all-cause 319 mortality attributable to  $PM_{25}$  with within-county variation in  $PM_{25}$  (S32, Panels C), 320 implying that aggregation of PM<sub>2.5</sub> exposure from the census tract to the county level is 321 unlikely to be an important source of bias in our analysis. Another limitation is that our final 322 confidence intervals for PM2.5-attributable mortality do not incorporate uncertainty arising 323 from the PM2.5-exposure estimates, because the PM2.5-exposure estimates on a  $0.01^{\circ}$  by 324  $0.01^{\circ}$  grid from Meng et al. only provide mean estimates (without uncertainty estimates). 325 Another limitation is that Di et al.'s CRF is derived from zip-code level data, while our study 326 is based on coarser county-level data. Hence there is a difference in exposure measurement 327 errors between those geographic levels. This could affect the validity of the point estimates 328 and confidence interval of the CRF by Di et al. estimates when applied to our study. For the 329 first point, a previous study<sup>27</sup> suggests that the bias for the point estimate introduced by the 330 exposure measurement error is generally small.

331

A third set of limitations of our study relates to our measurement of socioeconomic variables. First, we had to rely on racial/ethnic group as a proxy measure for exposure to racism. Richer data on exposure to racism would be a key asset for future research in this area<sup>28</sup>. Second, there is evidence that educational attainment recorded on death certificates tends to overestimate the decedent's level of education<sup>29</sup>. Lastly, because information on the social vulnerability-related factors was not available on the death certificates, we assigned the social vulnerability-related factors to all individual deaths within a county. It is important to

339	note that contextual factors such as the social vulnerability index we used may not capture
340	the individual-level socioeconomic status. Yet, contextual socioeconomic vulnerability may
341	be a more relevant indicator to inform/guide targeted policies across the US counties to
342	reduce air pollution related health disparities <sup>30</sup> . That being said, it would be interesting to
343	explore multi-level socioeconomic disparities in relation to deaths attributable to air pollution
344	in future work as such data becomes available.
345	
346	Methods
347	We harmonised mortality counts, population counts and PM <sub>2.5</sub> concentration estimates to
348	estimate PM <sub>2.5</sub> -attributable mortality across various sociodemographic population subgroups
349	in the United States between 1990 and 2016. The population subgroups used in our analyses
350	were racial/ethnic groups, educational attainment groups, rurality levels, socioeconomic
351	status, household characteristics, racial and ethnic minority status, housing type and
352	transportation, and social vulnerability index. We derived population counts at the census
353	tract level from the U.S. Census Bureau, using linear interpolation to account for missing
354	data in intercensal years. We acquired restricted-use county-level mortality counts from the
355	U.S. National Vital Statistics System. Both data sets were pre-disaggregated by racial/ethnic
356	groups and educational attainment at their respective sources. Additionally, we mapped
357	levels of rurality, socioeconomic status, household characteristics, racial and ethnic minority
358	status, housing type and transportation levels, and the social vulnerability index to the
359	population counts and mortality counts based on county level look-up tables from the
360	National Center for Health Statistics and the Centers for Disease Control and Prevention.
361	

362	We mapped $PM_{2.5}$ concentration levels from an established model <sup>31</sup> and ground-based
363	measurement data <sup>32</sup> to census tracts. We assigned population-weighted mean $PM_{2.5}$ exposure
364	estimates to each county. To estimate the mortality burden that is attributable to $PM_{2.5}$ at the
365	county (and, subsequently, state and national) level, we combined our annual population-
366	weighted mean PM <sub>2.5</sub> exposure estimate and mortality counts at the county level with a CRF.
367	The main CRF used in this analysis was by Di et al. <sup>15</sup> . For state or national-level analyses, we
368	aggregated county-level all-cause and PM2.5-attributable mortality counts to the respective
369	state or national level. We converted these raw mortality counts into age-adjusted mortality
370	rates.

### 176 Materials and Methods

This analysis brought together data from several sources. Fig. S 1 summarizes the different input data along with the geographic level at which this data was available, how we aggregated these data to the county level in order to generate a geographically harmonized dataset, and how

- the data were combined to arrive at age-adjusted  $PM_{2.5}$ -attributable mortality rates for each
- 181 population subgroup. In this Materials and Methods section, we provide a detailed description of 182 the following steps of our analysis, with a separate subheading for each step: i) our definition of
- 183 each racial/ethnic, education, rurality, and social vulnerability-related group; ii) each input
- 184 variable used to calculate age-standardized mortality rates; iii) each input variable used to
- 185 calculate population-weighted PM<sub>2.5</sub> exposure; iv) the steps to geographically harmonize our
- data; v) the calculations to estimate age-adjusted  $PM_{2.5}$ -attributable mortality; vi) the calculations
- 187 to estimate the degree to which differences in all-cause mortality between racial/ethnic groups
- 188 can be attributed to PM<sub>2.5</sub>; vii) a coefficient of variation approach used to compare the degree of
- 189 disparity in PM<sub>2.5</sub>-attributable mortality across racial/ethnic groups versus education and rurality
- 190 groups; viii) how we generated each map in our main manuscript and Supplementary Materials;
- 191 and ix) our analyses to investigate the importance of using race-ethnicity-specific concentration-
- 192 response functions (CRFs) when studying differences in PM<sub>2.5</sub>-attributable mortality between
- racial/ethnic groups. The studied time period was 1990-2016. We used R software, version 4.1.1
- 194 for all analyses (https://github.com/FridljDa/pm25\_inequality).

### 205 <u>Defining the population subgroups</u>

The population subgroups used in our analyses were racial/ethnic groups, education groups, and rurality levels, socioeconomic status, household characteristics, racial and ethnic minority status, housing type and transportation, and the social vulnerability index. We describe below how we defined each of these groups in our data.

210

211 Racial/ethnic group:

The racial/ethnic groups considered in this study were: "White" (85.9% of study population in 1990), "Black American" (10.7% in 1990, 12.7% in 2016), "Asian or Pacific Islander" (2.8% in 1990, 6.3% in 2016), and "American Indian or Alaska Native" (0.7% in 1990, 1.2% in 2016). From 2000 onwards, the data from the Decennial Census allowed us to additionally disaggregate "White" into the racial/ethnic groups "Non-Hispanic (NH) White" (66.3% in 2016) and "Hispanic White" (13.4% in 2016).

### 219 Educational attainment level:

220 We used educational attainment definitions from the US Census Bureau. Educational 221 attainment was recorded into the following three categories: "low", defined as high school 222 graduate or lower (44.7% of study population in 2009, 40.6% in 2016); "medium", defined as 223 some college education, but no 4-year college degree (27.7% in 2009, 29.1% in 2016); and 224 "high", defined as 4-year college graduate or higher (27.5% in 2009, 30.3% in 2016)<sup>35</sup>. We chose 225 these broad education categories because they minimize potential misclassification bias resulting from minor discrepancies in education reporting across the data sources for population and 226 227 mortality counts<sup>36</sup>. The US Census Bureau has not published data on educational attainment for the racial/ethnic group "American Indian or Alaska Native" by age<sup>35</sup>. The racial/ethnic group 228 229 "American Indian or Alaska Native" is, thus, not shown in Figure 3 in the main manuscript.

### 231 *Rurality level:*

We used the 2013 version of the Urban Rural Classification Scheme from the National 232 233 Center for Health Statistics to assign a rurality level to each county in our dataset<sup>37</sup>. To achieve 234 improved clarity of our findings, we aggregated six rurality levels in the scheme into three 235 categories. Specifically, we aggregated "large fringe metro" and "large central metro" into "large metro" (56.6% of study population in 2000, 54.8% in 2016), "small metro" and "medium metro" 236 237 into "small-medium metro" (29.2% in 2000, 30% in 2016), and "non-core" and "micropolitan" 238 into "non metro" (14.2% in 2000, 15.2% in 2016). We did not assign a rurality level for deaths 239 for which the county of residence and occurrence of death were not available (0% of deaths in 240 1990 and 0.0008% in 2016).

- 242 Socioeconomic Status:
- 243

We assigned socioeconomic status (SES) to each county in our dataset using estimates from the CDC's Agency for Toxic Substances and Disease Registry<sup>38</sup>. These estimates integrate metrics such as the population percentage living below 150% of the poverty line, unemployment rates, housing costs, educational levels, and health insurance coverage. The agency ranks counties on a percentile scale for SES. We categorized these rankings into 'Low SES' (0-33rd

percentile), 'Middle SES' (34-66th percentile), and 'High SES' (67-100th percentile). In our
 study, 'High SES' signifies better resource and opportunity access than 'Low SES'.

251

### 252 Household Characteristics and Disability:

We classified counties using the CDC's Agency for Toxic Substances and Disease Registry's estimates of Household Characteristics<sup>38</sup>. These estimates consider various demographic factors: population percentages of those over 65 or under 18, civilians with disabilities, single-parent households, and individuals with limited English proficiency. Each county received a percentile rank for Household Characteristics, which we grouped into three categories: 'Low HC' (0-33rd percentile), 'Middle HC' (34-66th percentile), and 'High HC' (67-100th percentile). In our study, a 'High HC' designation signals greater household stability and

- 260 demographic benefits compared to 'Low HC' counties.
- 261 262

### 263 Racial and Ethnic Minority Status:

264 We categorized counties using the CDC's Agency for Toxic Substances and Disease Registry estimates for Racial and Ethnic Minority Status<sup>38</sup>. These estimates reflect the 265 266 composition of various racial and ethnic groups, excluding Hispanic or Latino: Black or African 267 American, American Indian and Alaska Native, Asian, Native Hawaiian and Other Pacific 268 Islander, Two or More Races, and Other Races. Counties received a percentile rank reflecting 269 their Minority Status. We then organized these ranks into three levels: 'Low MS' for counties in 270 the 0-33rd percentile, 'Middle MS' for the 34-66th percentile, and 'High MS' for the 67-100th 271 percentile. In our study, a 'High MS' level suggests a lower prevalence of racial and ethnic 272 minorities, while a 'Low MS' level indicates a higher prevalence.

273

### 274 Housing Type and Transportation:

275 We categorized each county in our dataset using the CDC's Agency for Toxic Substances and Disease Registry estimates for housing and transportation factors<sup>38</sup>. These factors include the 276 277 presence of multi-unit structures, mobile homes, crowding (more than one person per room), lack 278 of vehicle access, and group quarters such as dormitories and nursing homes. The agency 279 provides a percentile ranking for each county based on these criteria. We classified these 280 rankings into three levels: 'Low HS' for counties in the 0-33rd percentile, indicating more 281 challenging housing and transportation conditions; 'Middle HS' for those in the 34-66th 282 percentile; and 'High HS' for counties in the 67-100th percentile, which suggests better housing 283 and transportation conditions.

### 286 Social Vulnerability Index:

We applied the CDC's Agency for Toxic Substances and Disease Registry's Social Vulnerability Index (SVI) to classify counties in our dataset<sup>38</sup>. The SVI evaluates a community's resilience by examining socioeconomic status, household composition, minority status, and housing types. Each county was ranked by percentile for SVI. We grouped these rankings into:

291 'Vulnerable SVI' (0-33rd percentile), indicating higher susceptibility; 'Moderate SVI' (34-66th

292 percentile); and 'Resilient SVI' (67-100th percentile), suggesting lower vulnerability to events
293 like natural disasters or epidemics.

294

295 Data sources to calculate age-standardized mortality rates:

296 This study analyzed de-identified, restricted-use mortality counts from the US National Vital Statistics System covering all deaths occurring within the United States<sup>39</sup>. For both of these 297 298 datasets, every entry is a record of a deceased person taken from death certificates that were 299 submitted to the vital statistics departments of every US state and the District of Columbia. For 300 the years 1990-1998, the cause of death was coded according to the International Classification 301 of Diseases (ICD) Ninth Revision. For the years 1999-2016, the cause of death was coded 302 according to the International Classification of Diseases (ICD) Tenth Revision. We assigned 303 each death to the county of residence of the deceased individual. When the county of residence 304 was missing but the address where the death occurred was present (which was the case in 0.16%305 of cases in 1990 and 0% in 2016), we used the county of death instead. We limited our analysis 306 to deaths occurring in the age group 25 years and older, because this is the most common age group analyzed in studies on the health effects of long-term PM<sub>2.5</sub> exposure<sup>9,16</sup>, and because 307 308 some of the population counts (see "Data sources to calculate population-weighted PM<sub>2.5</sub> 309 exposure") were only available for this age group $^{35}$ .

We ignored deaths for which the age at the time of death was not available. This was the case for 0.005% of deaths in 2016. Furthermore, we ignored deaths for which the decedent's racial/ethnic group or education was unknown or did not fall in the pre-specified categories. This amounted to 0.027% of deaths in 1990 and 0.004% of deaths in 2016 for the racial/ethnic group, and 4.87% of deaths in 2009 and 1.72% of deaths in 2016 for education. After these exclusions, a total of 63 261 546 deaths between 1990 and 2016 (2 057 450 deaths in 1990 and 2 678 827 deaths in 2016) remained in the analysis. The finest geographic resolution available for the

316 deaths in 2016) remained in the analysis. The finest geographic resolution 317 mortality counts was county.

319 Data sources to calculate population-weighted PM<sub>2.5</sub> exposure:

320 *PM*<sub>2.5</sub> *exposure*:

We compiled annual mean estimates of PM<sub>2.5</sub> concentration on a 0.01° by 0.01° (0.9 km by 321 322 1.1 km) grid from an established model for the 48 states of the contiguous USA and the District 323 of Columbia<sup>31</sup>. The model combines chemical transport modeling, satellite remote sensing, and 324 ground-based measurements. Meng et al. have reported that the estimated  $PM_{2.5}$  level from this 325 model was generally consistent with direct ground-based PM2.5 measurements, with a cross-326 validation R<sup>2</sup> between 0.6 and 0.85<sup>31</sup>. For Alaska and Hawaii, which were not included in the model by Meng et al.<sup>31</sup>, we collected ground-based measurement data from pre-generated annual 327 328 summary files provided by the United States Air Quality System Data Mart<sup>32</sup>. In 2016, the 329 monitors measuring  $PM_{2.5}$  in the state of Alaska were located in Anchorage, Fairbanks, the City 330 and Borough of Juneau, and the Matanuska-Susitna Borough, and in the state of Hawaii in 331 Honolulu, Kauai, and Maui. Averaged over the years 1990-2016, the population weighted-

median distance between a census tract centroid and a monitoring site in Alaska and Hawaii was
 14 km and 8 km, respectively.

334

335 *Population counts for estimation of population-weighted mean PM*<sub>2.5</sub> *exposure:* 

A detailed list of the data sources used for population counts in the estimation of

population-weighted mean PM<sub>2.5</sub> exposure can be found in table S2. To estimate population-

338 weighted mean PM<sub>2.5</sub> exposure for each population subgroup, we used population counts at the

339 lowest geographic level available, which was the census tract. Most census tracts in the USA

- have a population size between 1200 and 8000 (86.7% of census tracts in 1990; 93.5% in 2016).
- 341 Population counts by racial/ethnic group and age group at the census tract level are from the US
- 342 Decennial Census for the years 1990, 2000, and  $2010^{40-42}$ , and from the 5-year estimates in the
- 343 American Community Survey for the years 2009, and 2011-2016<sup>35</sup>. The American Community
- 344 Survey data were provided by the US Census Bureau after imputing missing information.
- Population estimates for the periods 1991-1999 and 2001-2008 were obtained by linearly
- interpolating the data from the 1990 and 2000 Decennial Census for the period 1991 to 1999, and
- 242 2000 and 2010 Decennial Census for the period 2001 to 2008. Because the boundaries of census-
- defined geographies are adjusted for every Decennial Census in response to changes in
   population, we first used the Longitudinal Tract Data Base<sup>43</sup> to crosswalk all Decennial Census
- to 2010 vintage census tract boundaries. This method is well validated<sup>44</sup>. The data from the
- 351 Decennial Census and the interpolations were aggregated by 5-year age groups (with the highest category being age 85+ years).
- Between 2009 and 2016, the American Community Survey offered population estimates at
   the census-tract level, categorized by age group and highest educational attainment<sup>35</sup>. We
   restricted counts by educational level to ages 25 and above, as persons under age 25 may not
- have completed their education. For the period 2009-2016, the American Community Survey
- 357 also provides population estimates for all permutations of racial/ethnic group and education level
- 358 at the census-tract level for the age group 25 years and above $^{35}$ .
- 359

360 <u>Geographic harmonization:</u>

We aggregated our PM<sub>2.5</sub> estimates, originally at a 0.01° by 0.01° (0.9 km by 1.1 km) grid resolution, to the county level to match the resolution of our mortality counts. Fig. S 1 summarizes this process.

364 We assigned annual PM<sub>2.5</sub> concentration estimates to each census tract by mapping the 365 nearest PM<sub>2.5</sub> estimate from a 0.01° by 0.01° (0.9 km by 1.1 km) grid to the centroid of the 366 respective tract. To aggregate PM<sub>2.5</sub> exposure data from census tracts to counties, we utilized 367 population estimates for each racial/ethnic, educational, rural, and social-vulnerability subgroup 368 at the census tract level (refer to Table S2). This allowed us to calculate the population-weighted 369 mean  $PM_{2.5}$  exposure annually for each subgroup at the county level. Figure S3 shows the 370 population-weighted mean  $PM_{2.5}$  exposure, calculated using this process, at the national level for 371 each population subgroup.

- 373 Estimation of the age-adjusted PM<sub>2.5</sub>-attributable mortality rate
- To estimate county-level mortality burden attributable to  $PM_{2.5}$ , we combined our annual population-weighted mean  $PM_{2.5}$  exposure estimates at the county level with mortality counts at the county level, using a concentration-response function (CRF) within a health impact assessment framework. A CRF *f* is a function from a concentration level *z* taking values in [0,1] and, in this analysis, depends on the population subgroup *c*. It is used to calculate the response, the PM<sub>2.5</sub>-attributable mortality count at the county level, in the following form:
- $R_{c} = \sum_{d} f(z_{c} | c, d) \cdot T_{d,c}, \text{ where } z_{c} \text{ is the population-weighted mean PM}_{2.5} \text{ exposure at the}$ 380 county level, *d* is a disease outcome (see table S3),  $T_{d,c}$  is the mortality count for the 381 subpopulation *c* and disease *d* at the county level, and  $R_{c}$  is the PM}<sub>2.5</sub>-attributable mortality 383 count for subpopulation *c* at the county level. For analyses at the state or national level, the 384 county-level all-cause and PM<sub>2.5</sub>-attributable mortality counts were then summed to the state or

385 national level. We converted these raw mortality counts into an age-adjusted mortality rate using the direct method<sup>1,45</sup>. The reference population was the 2000 US standard population as used in 386 the National Vital Statistics Reports, Vol. 57, No. 14<sup>1</sup>. The age categories in the US standard 387 388 population were 25-34, 35-44, 45-54, 55-64, 65-74, 75-84, and 85+ years. In data sources that 389 provided population counts for more granular age categories, we thus aggregated the counts to 390 these coarser age categories. Table S1 lists, by geographic level, population subgroup, and year, 391 each data source and age categories that were used for the calculation of age-adjusted mortality 392 rates. As explained in the main text, the CRF used in this analysis was by Di et al.<sup>15</sup>. Di et al. 393 394 provide both a general CRF that does not distinguish by racial/ethnic group as well as CRFs 395 specific to each racial/ethnic group considered in this study. We applied racial/ethnic group-396 specific CRFs only in analyses where we disaggregated results by these groups. The CRF f from 397 Di et al.<sup>15</sup> is a continuous and stepwise linear function. Specifically, f is zero for all values of 398 annual mean PM<sub>2.5</sub> between 0 and 5  $\mu$ g/m<sup>3</sup> and has a positive slope  $m_c$  (which varies by 399 racial/ethnic group) for all annual mean  $PM_{2.5}$  levels greater than 5  $\mu$ g/m<sup>3</sup>. Figure Fig. S 47 400 illustrates the shape of the CRF. Di et al.<sup>15</sup> provide the mean estimate along with a 95% CI for 401 each  $m_c$ . The CRF by Di et al. was developed among US adults aged 65 years and older<sup>15</sup>, whereas 402 403 our analysis applies this CRF to those aged 25 years and older. To examine whether restricting 404 our study population to those aged 65 years and older would change any of our conclusions, we 405 additionally conducted all analyses shown in the main manuscript when restricting the 406 population to this older age group. The results from these analyses are shown in the 407 Supplementary Materials (Figures Fig Fig. S 31 - Fig. S 45). 408 409 Estimation of the proportion of the all-cause mortality that is attributable to  $PM_{25}$ : To quantify the role of PM<sub>2.5</sub> attributable mortality relative to the all-cause mortality, we 410 411 calculated the ratio between both. Specifically, we calculated the proportion of all-cause mortality that is attributable to PM<sub>2.5</sub> using the formula: 412 413 PM2.5 attributable mortality rate 414 All cause mortality rate 415 The percentage of all-cause mortality attributable to  $PM_{2.5}$  is obtained by multiplying this 416 proportion by 100. 417 418 Estimation of the proportion of the all-cause mortality difference to a given racial/ethnic group 419 that is attributable to PM<sub>2.5</sub>: 420 To quantify the role of  $PM_{2.5}$  in mortality disparities between population subgroups, we 421 calculated the ratio between the difference in PM2.5-attributable mortality and the difference in

422 all-cause mortality with respect to a fixed reference group. Specifically, we used the following 423 formula:

PM2.5 attributable mortality rate<sub>1</sub> – PM2.5 attributable mortality rate<sub>2</sub> 425 All cause mortality  $rate_1 - All$  cause mortality  $rate_2$ 

427 For the racial/ethnic groups, we chose "Black American" as reference group because this 428 racial/ethnic group had both the highest PM<sub>2.5</sub>-attributable as well as all-cause mortality rate. 429

Comparing the degree of disparity in PM<sub>2.5</sub>-attributable mortality:

431 To compare the degree to which the age-adjusted PM<sub>2.5</sub>-attributable mortality rate varies for 432 different population subgroup, we adopted the coefficient of variation (CoV) approach from Jbailev et al.<sup>46</sup>. To do so, we first computed the age-adjusted PM<sub>2.5</sub>-attributable mortality rate (a) 433 434 for each population subgroup. We then calculated:

- 435  $CoV = \frac{\sqrt{Var(a)}}{mean(a)},$ 436

where Var(a) is the empirical variance of a and mean(a) is the empirical mean of a. For 438 439 example, consider the racial/ethnic groups "Black American", "NH White", "White Hispanic or 440 Latino", "Asian or Pacific Islander", and "American Indian and Alaska Native", where the age-441 adjusted mortality per 100,000 attributable to  $PM_{2.5}$  are, respectively, a =

442 (600, 400, 500, 400, 400). Then Var(a) = 8000, mean(a) = 460 and thus  $CoV \approx 0.19$ . 443 Coefficient of variation, therefore, is a measure of the variability of the data normalized by its 444 magnitude<sup>15</sup>.

445

446 Spatial analyses:

447 We first mapped, for each racial/ethnic group, the percentage of the all-cause age-adjusted 448 mortality rate that is attributable to PM<sub>2.5</sub> by US state and District of Columbia in the year 2016. 449 We then proceeded to map the county-level age-adjusted  $PM_{25}$ -attributable mortality per 450 100,000 for the three largest racial/ethnic groups (NH White, Hispanic or Latino White, and 451 Black Americans) because county-level sample sizes were insufficient for other racial/ethnic 452 groups. We also mapped county-specific differences in the age-adjusted PM<sub>2</sub> s-attributable 453 mortality rate between i) Black American and the NH White population, and ii) Black American 454 and the Hispanic or Latino White population. All county-level maps were created for each year 455 of our study period (i.e., from 2000 to 2016) as well as for the (unweighted) mean across the 456 years 2000 to 2016. Lastly, we generated all county-level maps when taking spatial 457 autocorrelation into account. To do so, we calculated the local indicator of spatial association 458 (LISA) using local Getis-Ord Gi statistics with contiguity-based spatial weights at the county 459 level<sup>47</sup>.

Analyses to assess the effect of using a race-ethnicity-specific CRF: 461

We carried out three sets of analyses to investigate the degree to which the use of CRFs 462 that ignore differences in the concentration-response association by racial/ethnic group 463 464 underestimate disparities in PM<sub>2</sub> s-attributable mortality between racial/ethnic groups. 465 First, we compared our findings when using the race-ethnicity-specific CRF by Di et al.<sup>15</sup>

to those obtained when using the uniform CRFs by Cohen et al.<sup>16</sup> and Burnett et al.<sup>11</sup>. We 466

467 selected these two CRFs because they are two recent and widely used CRFs for the US

- 468 population. The shape of these CRFs is provided in figure Fig. S 47. Each of the CRFs used in
- 469 this analysis are based on hazard ratio models that incorporate risk information from PM<sub>2.5</sub> and
- provide 95% confidence intervals. While Di et al.<sup>15</sup> provide hazard ratios for all-cause mortality, 470
- the CRFs by Cohen et al.<sup>16</sup> and Burnett et al.<sup>11</sup> are cause-specific. The ICD-10 codes used for 471
- 472 these cause-specific functions are listed in table S3. Using our notation from the formula
- 473 presented under "Estimation of the age-adjusted PM<sub>2</sub> s-attributable mortality rate" above, we can

- for  $R_c$  by taking the 2.5<sup>th</sup> and 97.5<sup>th</sup> percentile from this distribution of 900 values of  $R_c$ . 478
- Confidence intervals for the sum of  $R_c$  across age groups were then obtained by assuming that 479
- 480 each age group-specific  $R_c$  follows an independent Gaussian distribution (thus allowing us to
- estimate the standard deviation of each  $R_c$  from its confidence intervals). Burnett et al. <sup>11</sup>(12) 481
- 482 provide the mean estimate and standard deviation for f(z|c, d). 95% confidence interval bounds
- 483 for f(z|c,d) were estimated by assuming a normal distribution around the mean for f(z|c,d)
- 484 and, thus, using 1.96 times the standard deviation above and below the mean to arrive at the 485 upper and lower 95% confidence interval bounds, respectively. Burnett et al.<sup>11</sup> provide one main
- CRF f for all non-communicable diseases. Thus, the formula for  $R_c$  reduces to  $R_c = f(z_c|c,d)$ . 486 487  $T_{d.c}$ .
- Second, we compared our findings when using the race-ethnicity-specific CRF from Di et 488 al.<sup>15</sup> to those obtained when applying the CRF for "NH White" by Di et al. to all racial/ethnic 489 490 groups. This comparator, thus, ignores that racial/ethnic groups in the USA have different 491 susceptibilities to  $PM_{2.5}$  by assuming that all racial/ethnic groups have the same susceptibility to 492  $PM_{2.5}$  as the NH White population. We used the same coefficient of variation approach to compare the effect of this choice on the magnitude of differences in age-adjusted PM<sub>2.5</sub>-493 494 attributable mortality between racial/ethnic groups as described in these Supplementary
- 495 Materials under "Comparing the degree of disparity in PM<sub>2.5</sub>-attributable mortality".
- 496 Third, we used the observed mortality counts from 2016 and race-ethnicity-specific CRFs 497 (again, from Di et al.<sup>15</sup>), but assumed the same  $PM_{2.5}$  exposure for all racial/ethnic groups by 498 applying the population-weighted mean  $PM_{25}$  exposure in the overall USA population to all 499 racial/ethnic groups. This approach accounts for varying susceptibility to PM2.5 among 500 racial/ethnic groups while presuming uniform PM<sub>2.5</sub> exposure across these groups.

502 Comparison of CRF with race-ethnicity-specific estimates to CRFs that do not provide race-503 ethnicity-specific estimates:

504 When using race-ethnicity-specific CRFs, we estimated that a large proportion of the 505 differences in all-cause mortality between racial/ethnic groups can be attributed to PM2.5 506 exposure (Fig. 2, Fig. S 48). While we estimated that more than half of the difference in age-507 adjusted mortality between the NH White and Black American population was attributable to 508 PM<sub>2.5</sub> in each year from 2000 to 2011, the same proportion ranged only from 2.7% to 16.7% in

509 each year of this period when using CRFs<sup>16,18</sup> that do not provide race-ethnicity-specific

- 510 estimates (Fig. S 48). To further investigate the importance of using race-ethnicity-specific CRFs
- 511 when studying differences in PM2.5-attributable deaths between racial/ethnic groups, we

512 conducted two additional analyses. First, we compared our findings to those obtained when

- 532533 Uncertainty estimation:

534 We derived the point estimate and confidence interval for Di et al.'s CRF from the

535 original study<sup>15</sup>. In our analysis, we propagated these confidence intervals using the Delta

536 Method and parametric bootstrapping. The Delta Method, under the assumption of Gaussian

537 distributions, approximates the variance of a function of random variables primarily through

538 first-order Taylor expansions. Parametric bootstrapping involves generating new sample datasets

539 by resampling from a fitted model, and then re-estimating the parameter of interest on these new

540 datasets to construct its empirical distribution and confidence intervals. The Delta Method was

541 the preferred approach in cases where parametric bootstrapping was computationally prohibitive.

The new suite of primary standards will provide increased 614 protection against a wide range of PMrelated health effects, including premature mortality and 615 increased hospital admissions and emergency room visits, primarily in the elderly and 616 individuals with cardiopulmonary disease; increased respiratory symptoms and disease, in 617 children and individuals with cardiopulmonary disease such as asthma; decreased lung function, 618 particularly in children and individuals with asthma; and alterations in lung tissue and structure 619 and in respiratory tract defense mechanisms. The current secondary standards are revised by 620 making them identical in all respects to the new suite of primary standards. The new secondary 621 standards, in conjunction with a regional haze program, will provide appropriate protection 622 against PM-related public welfare effects including soiling, material damage, and visibility 623 impairment.
