50 Background

51 Vitamin D has been widely promoted for bone health through supplementation and 52 fortification of the general population. However, there is growing evidence that does 53 not support these strategies. Our aim is to review the quality and recommendations on 54 vitamin D nutritional and clinical practice guidelines and explore predictive factors for 55 their direction and strength.

57 Methods and analysis

58 We searched PubMed, EMBASE and CINAHL databases for vitamin D guidelines for 59 the last 10 years. We aim to perform descriptive analysis, a quality appraisal using 60 AGREE II scores (Appraisal of Guidelines Research and Evaluation) and a bivariate 61 analysis evaluating the association recommendations and AGREE II domains' scores 62 and pre-specified characteristics.

64 Ethics and dissemination

This is a systematic review protocol and therefore formal ethical approval is not required, as no primary, identifiable, personal data will be collected. Patients or the public were not involved in the design of our research. However, the findings from this review will be shared with key stakeholders, including patient groups, clinicians and guideline developers. We intend to publish our results in a suitable, peer-reviewed journal.

78 Introduction

79

Vitamin D plays a vital role in several physiological processes(1–4). The best understood of these functions is calcium regulation, counter-regulating parathyroid hormone secretion to maintain calcium serum levels(5) and calcium absorption in the gut. It is predominantly synthesized via direct sunlight (ultraviolet B radiation) exposure(6), as it is limited to only a few natural sources(7) in the human diet. Severe deficiency leads to rickets in children and osteomalacia in adults; its deficit has been associated with low bone mineral density(8), and increased risk of fractures(9).

Public health concerns about suboptimal vitamin D intake have led to the 87 88 development of dietary and supplementation recommendations(10) in nutritional 89 guidelines. However, the link between vitamin D intake and fracture risk is 90 controversial(11). These recommendations were initially addressed to populations at 91 risk of low sun exposure, particularly in northern latitudes(12). Early systematic 92 reviews(13–15) showed a decrease in fractures among older institutionalized women, 93 while more recent ones have demonstrated the absence of beneficial effect(16-22). 94 Of note is the absence of randomized clinical trials in the general population to evaluate outcomes such as fractures, with only surrogate outcomes (e.g. bone mineral 95 density and 25-hydroxycholecalciferol (25-OH-D)(23) being available. Vitamin D 96 97 supplementation has not shown any effect in preventing cardiovascular disease or 98 cancer(24–26), and high doses paradoxically, have been associated with an increase 99 in falls in the elderly(27).

Another subject of debate is what constitutes vitamin D deficiency. While some
studies declared epidemic proportions of deficiency(28), others have not confirmed

these claims(10). Typically assessed with 25-OH-D serum levels, the threshold tomaintain adequate bone health is also disputed(10).

104 Our aim is to review and analyze Vitamin D recommendations present in 105 nutritional and clinical practice guidelines (CPGs) as well as potentially related factors 106 for these recommendations.

110 Information sources & Search

We searched Medline via PubMed, EMBASE and CINAHL databases. We conducted our search for CPGs published between for the last ten years. The full search strategy can be found in **Supplementary File 1**.

116 Eligibility criteria

117

We will include guideline publications, following the definition of the Institute of Medicine(29). We will include those that formulate recommendations for vitamin D intake, and/or screening for the general, healthy population. We will exclude guidelines only addressed to the pediatric population (to prevent rickets), guidelines on specific conditions (e.g. chronic corticoid users), guidelines addressed to osteoporotic patients exclusively, or for secondary prevention of osteoporotic fractures.

127 Data extraction

will collect: year of publication, institution, region, target population, 129 We 130 proposed vitamin D levels, calcium advice (if given), sun exposure advice, screening 131 advice, fortification advice, suggested methods for vitamin D obtention, and 132 supplementation recommendations. Four reviewers will conduct screening, data 133 extraction, and quality assessment. We will resolve disagreements through discussion 134 or with the help of another reviewer (PA). We will classify recommendations following 135 the distinction that the Grading of Recommendations Assessment, Development and 136 Evaluation(GRADE) provides(30) in three categories: "Recommends", for 137 unequivocal, strong recommendations; "Suggests", for weak or conditional 138 recommendations; and "Does not recommend", for guidelines which do not provide 139 advice in favor or recommend against supplementation.

140 We will also collect information concerning the authors' potential conflicts of 141 interest (COIs) and how these are managed. We will focus on evaluating individual 142 COIs reporting and the potential Institutional COIs in accordance with methodology 143 implemented in previous evaluations(31,32). From each guideline, we will collect 144 information on each one of the categories identified by Hakoum et al. on its 145 methodological survey (32). These categories include not only financial conflicts of 146 interest but other less typically acknowledged categories such as intellectual COIs and 147 institutional financial and advocatory ties. Therefore, we will collect six different 148 dimensions of COIs including whether there is a COI clear process reporting, if the 149 authors reported affiliation, financial and intellectual COIs. We will also collect the type 150 of organization that formulates the recommendations and, if available, the institution's 151 potential financial or advocatory COIs(32). Two reviewers (DF and CC) will collect this

data independently. In case of disagreement, we will resolve it by discussion and the help of a third reviewer (PA). To perform our analysis we will summarize the different potential COIs in three categories. "Detected" for guidelines that we detected potential COIs in different of the aforementioned categories, "Undetected" for guidelines for which we do not have detected potential COIs and "Not reported" for guidelines who do not state at all a COI disclosure.

159 **Quality appraisal and risk of bias**

160

We will use the AGREE II (Appraisal of Guidelines Research and Evaluation version 2)(33) instrument. This tool evaluates the methodological rigour and transparency with which a guideline is developed. After calibration, four researchers will evaluate publications independently. We will calculate the percentage of the maximum possible score for each domain, and its standardized range (from 0% to 100%).

168 Data analysis

We will perform a descriptive analysis for each included guideline. We will assess the reproducibility of quantitative measurements made by different observers by calculating the intra-class correlation coefficients (ICC), and the associated 95% confidence intervals (CI) for each AGREE II domain. We will conduct a bivariate analysis to evaluate the potential association between recommendations and AGREE II scores with the following factors: region, type of organization, target population, suggested method to obtain Vitamin D, advice on sun exposure, advice on fortifying

- 177 strategies, and conflicts of interest. We will include in our logistic regression model the
- 178 results that remain significant in the bivariate analysis.
