Disruption of the renal service during COVID-19 pandemic, physicians survey responses from 5 countries

Abstract

The outbreak of COVID-19 has significant impact on health care systems. The workflow in

renal care facilities and dialysis facilities is complex. The aim of his study was to explore

multinational renal physician perspective about the disruption of outflow of renal service

amid COVID-19 pandemic.

Methods: we distributed a questionnaire electronically to renal physicians of various grades

from 5 countries. The questionnaire was formulated of 9 questions with domains centered on

the acute and chronic renal services

Results

97 physicians took part in the survey from 5 countries. 58% of the participating renal

physicians agreed that there has been disruption to the acute service offered to renal patients.

38% of the physicians who took the survey report disruption to the hemodialysis facilities.

Conclusion

At this challenging time of the pandemic, it is important to perform audits and quality control

to explore the deficiencies of acute and chronic renal care pathways.

Introduction

Since the outbreak of COVID-19 pandemic, caused by SARS-CoV-2, the healthcare systems

around the world have seen one of the biggest challenges. Drastic measures have been taken

by the health authorities to fight and mitigate the pandemic. The challenges to both acute and

chronic renal care services are paramount (1). We aimed to reach out to renal physicians of

variable grades to explore their experience about the outflow of both acute and chronic renal

care pathways.

Methods

We developed a survey and distributed it to health-care professionals in 5 countries around

the world (Egypt, Italy, Turkey, Spain and India). The survey consisted of 9 questions with

two main domains. Some questions were addressing the adequacy and timely application of

acute renal care to patients amid the COVID- 19 pandemic; the other questions were about

dialysis units' preparedness. Renal physicians were invited to take part through email. The

questions are shown in table (1)

Results

97 physicians took part in the survey from 5 countries. The countries represented in this

survey are Egypt, Italy, Turkey, Spain and India. 75% of the participants work in tertiary care

facilities, the remaining 25 % work in secondary care facilities.23% of the participants was

consultants; 65% were trainee and 12% were managers of renal service.

Responses

Disruption of the acute renal care

58% of the participating renal physicians agreed that there has been disruption to the acute

service offered to renal patients. Suspected cases of SARS-CoV2 virus experienced a varied

degree of delay in initiating acute care pathways. 63 percent of the physicians report

experiencing temporary disruption of acute hemodialysis units since the outbreak. The

disruption of acute hemodialysis was attributed to shortage of medical staff due to sick leaves

or due to the presence of suspected or confirmed cases of COVID-19. 25% of physicians

agree that it has been challenging to establish appropriate and timely diagnosis of renal

diseases, in the acute settings, due to conflict between acute renal care pathway and COVID-

19 pathway.

Disruption to the chronic hemodialysis service

38% of the physicians who took the survey report disruption to the hemodialysis facilities.

The disruption was caused by a number of factors. Accommodation of incipient dialysis

patients, staff absenteeism on sick leaves or the diagnosis of new cases of COVID-19. 43%

agreed that appropriate isolation measures were adhered to.

Admission policies

Admission policies to acute healthcare facilities were variable and in some occasions

interfered with timely management of patients who needed acute or chronic renal care and,

were suspected of having COVID-19. The delay was due to the requirement of obtaining two

negative SARS-CoV-2 nucleic acid tests for patients with criteria suspicious of COVID-19

Discussion:

In our survey, we explored the experience of renal physicians from 5 different countries. The

core of survey was the effect of COVID-19 on the provision of acute and chronic renal

service. 58% of the participants agreed that there has been disruption of the acute renal

pathway. There have been different guidelines addressing diffent domains of renal care amid

COVID-19. Previous reports have highlighted the importance of optimizing resources at the

time of increased demand (1). Admission policies of suspected or confirmed cases of

COVID-19 were different form one country to another, as reported by renal physicians in this

survey. In Wuhan suspected cases, among hemodialysis patients, were required to have 2

negative nucleic acid tests before being admitted to the dialysis facilities (2).

Conclusion: Renal physicians from 5 countries report temporary disruption of the acute and

chronic hemodialysis facilities. At this challenging time of the pandemic, it is important to

perform audits and quality control to explore the deficiencies of acute and chronic renal care

pathways.
