2 Correlation between serum 25(OH) vitamin D level

and sleep quality in elderly patients with type 2

23	Ba	ckground: Untreated sleep disorders have been linked with type 2 diabetes in previous evidence.
24	Th	is study was to investigate the correlation between serum 25(OH) vitamin D level and sleep
25	qu	ality in elderly patients with type 2 diabetes and reveal the therapeutic potential of 25(OH)
26	vit	amin D-based treatments to improve sleeping quality and its effect on diabetes management.
27	Me	ethods: The sleep quality of 186 elderly patients with type 2 diabetes were assessed by
28	qu	estionaires of Pittsburgh sleep index (PSQI), with a cutoff point of PSQI • 7 defined as poor
29	sle	ep. The measurement of serum 25(OH) vitamin D , fasting blood glucose, glycosylated
30	hei	moglobin, serum creatinine, total cholesterol, triglyceride, low-density lipoprotein cholesterol,
31	and	d urinary albumin/creatinine ratio were collected. History of diabetic nephropathy, diabetic
32	ret	inopathy, peripheral neuropathy, blood pressure, height, weight, hypoglycemic drug use, and
33	the	e duration of diabetes also were recorded. Both univariate and multivariate logistic regression
34	ana	alysis was used to investigate the relationship of serum 25(OH) vitamin D and sleep quality in
35	eld	erly patients with type 2 diabetes.
36	Re	sults: The age of elderly patients with type 2 diabetes was 73.6±4.3 years., and duration of
37	dia	betes was 8.8 ± 3.0 years. In the study, inadequate quality of sleep was reported in 63% elderly
38	pat	tients with type 2 diabetes. This study revealed that lower level of 25(OH) vitamin D was
39	- sig	nificantly associated with poor sleep quality in type 2 diabetes patients ($P < 0.05$). Multivariate

- 40 logistic regression analysis showed that 25(OH) vitamin D deficiency and the use of insulin were
- 41 risk factors for of inadequate sleep quality in elderly patients with type 2 diabetes.

42 **Conclusions:** Elderly type 2 diabetic patients with 25(OH) vitamin D deficiency showed a high

43 incidence of poor sleep quality, low-level of 25(OH) vitamin D was a risk factor for inadequate

44 quality of sleep in elderly patients with type 2 diabetes.

46 **1. Introduction**

47 Type 2 diabetes is a chronic endocrine ailment, its prevalence rate continues to rise because of 48 the change of lifestyle and is as high as 10% China and India¹. Type 2 diabetes is estimated that 49 around 60 million in Europe had type 2 diabetes by 2017 and would cause serious cardiovascular 50 effects². Type 2 diabetes and sleep disorders both are common health problems and affect each 51 other. Persons with diabetes suffered from sleep disorders and took more sleeping medications³⁴. 52 According to latest statistics, more than 30% of adults suffer from sleep disorders, and the incidence 53 of sleep disorders in the elderly over 60 years old is up to 40%⁵⁶. Type 2 diabetes has shown to be 54 associated with higher incidence of sleep disorders. Sleep disorders might be caused by the disease 55 itself or by complications of the disease, such as peripheral neuropathy and polyuria.

56 25(OH) vitamin D is essential for good bone health and deficiency or insufficiency have also 57 been linked to other health concerns, such as diabetes, cardiovascular disease, hypertension, tumor 58 and autoimmune diseases⁷. The prevalence of Vitamin D deficiency has increased in recent decades.⁸⁹ In a recent population-based study of Asian adults, approximately 75% had suboptimal 59 60 Vitamin D concentrations.¹⁰ The Endocrine Society Clinical Practice Guideline defines Vitamin D deficiency as 25(OH)D level <20 ng/mL and insufficiency as 21 to 29 ng/mL.¹¹ Some studies have 61 62 linked deficient 25(OH) vitamin D to neuropsychological diseases such as sleep disorders¹²⁻¹⁴, which 63 showed that 25(OH) vitamin D deficiency was associated with a higher risk of inadequate quality of 64 sleep. Massa, Jennifer et al. found a significant trend that lower total serum 25(OH) vitamin D was 65 associated with shorter sleep duration, and that men with the lowest total serum 25(OH) vitamin 66 D(< 20.3 ng/mL) were twice as likely to have a shorter sleep duration than those with the highest 67 total serum 25(OH) vitamin D (•40.06 ng/mL). Some researchers believed that the neural systems that control the opposing states of arousal and sleep are predominantly confined to the brainstem, 68 69 hypothalamus and the thalamus. It has been shown that 25(OH) vitamin D target neurons are 70 thought to be involved in sleep regulation¹⁵.

71 There was a statistical difference between 25(OH) vitamin D concentration in diabetic patients 72 and the healthy subjects in the study by Mohammad Ali Bayani. et al. The results showed that the 73 mean concentration of healthy women was higher than that 25(OH) vitamin D in diabetic women 74 $(27.03\pm10.28 \text{ ng/dl}, 19.3\pm11.9 \text{ ng/dl}, \text{respectively})$ (P =0.0001)¹⁶ Therfore, we may believe that 75 25(OH) vitamin D is important for diabetic women. In addition, a study was been shown that 76 25(OH) vitamin D affects sleep in people between the ages of 20 and 50. 25(OH) vitamin D 77 supplementation can improve the sleep quality, reduce the sleep latency, prolong the sleep time, 78 and improve the subjective sleep quality of patients with sleep disorders. However, there are still 79 few studies on the effect of 25(OH) vitamin D on sleep quality in elderly patients with type 2 80 diabetes¹⁷. 81 This study was designed to investigate the relationship between serum 25(OH) vitamin D levels

and sleep quality in elderly patients with type 2 diabetes in China and to fill in the literature gap onthis topic.

84 **2. Materials and Methods**

85 *2.1 Patients and definitions*

86 A total of 186 inpatients were selected, who were admitted in the Department of 87 Endocrinology and Geriatric Medicine of the First Affiliated Hospital of the University of Science 88 and Technology of China (USTC) from January 2019 to December 2019. All patients were over 60 89 years old and diagnosed with type 2 diabetes according to the 1999 WHO Diabetes Diagnostic 90 Criteria. Exclusion criteria : Patients with type 1 diabetes and other special types of diabetes; with 91 type 2 diabetes-related acute complications; with thyroid and parathyroid function disorders; with 92 cardiac insufficiency, hepatic and renal dysfunction, respiratory failure, malignant tumors, and 93 other severe illness; with incorporative psychiatric illnesses, mental retardation and cognitive 94 deficit; being treated with glucocorticoids, 25(OH) vitamin D, calcium and other drugs that may 95 affect 25(OH) vitamin D levels in the past 3 months. Patient informed consents were obtained. All

- 96 the data received Institutional Review Board (IRB) approval by the Ethics Committee.

98 2.2 Study design and Method

99 2.2.1 Clinical data collection

100 The age, blood pressure, height, body weight, the duration of type 2 diabetes patients,

101 medications (including oral hypoglycemic drugs and insulin) of all patients were recorded. Body

102 mass index (BMI) was calculated according in kg/m². All patients were subjected for fundus

103 examination to identify diabetic retinopathy after mydriasis, excluding other causes of retinopathy

104 and physical examination and nerve conduction velocity (NCV) examination to identify diabetic

105 peripheral neuropathy, excluding other neurological diseases and other causes of peripheral

106 neuropathy. Venous fasting blood was sampled including fasting blood glucose (FBG), glycosylated

107 hemoglobin (HbA1c), serum creatinine (Cr), total cholesterol (TC), triacylglycerol (TG) and

108 low-density lipoprotein (LDL-C) were measured. Urine albumin was assayed by

109 immunoturbidimetry, and urine creatinine concentration was determined by benedict-behre

110 creatinine colorimetry urine albumin/creatinine ratio (UACR) was calculated, and diabetic

111 nephropathy was defined by an UACR of $\cdot 30$ mg/g.

112 2.2.2 Sleep quality assessment

113 The Pittsburgh Sleep Quality Index (PSQI) was originally developed in 1989 to measure sleep 114 quality for psychiatric research as well as clinical practice¹⁸. The index has since been used to assess 115 sleep quality in patients suffering T2DM¹⁹. The PSQI scale was used to evaluate the sleep status of 116 all subjects in the past 4 weeks. The questionnaire included 19 self-assessments and 5 other 117 assessment items. Higher scores indicated worse sleep quality. The investigator made use of 118 questionnaire adjustment method. The adjustment tables were independently completed by the 119 study subjects. Those who could not be accomplished independently due to visual impairment, low 120 cultural level, etc., were asked by the investigator according to the content of the scale and the 121 answer results were truthfully recorded. Poor sleep quality was defined by a total PSQI score ²⁰ of 122 >7.

124 2.3 Statistical analyses

125	Normal distribution was determined by the Kolmogorove-Smirnov test, and the data were
126	expressed as mean \pm standard deviation. Group comparison was performed by t test. The data that
127	did not meet the normal distribution was compared by the Mann-Whitney U test. Count data were
128	reported in rates, and comparisons between groups were performed using the $\cdot 2$ test. Univariate
129	logistic regression analysis was used to screen variables for selected research factors. Univariate
130	analysis was performed with the presence of sleep disturbance as the dependent variable and
131	gender, age, body mass index (BMI), duration of diabetes, systolic blood pressure, diastolic blood
132	pressure, FBG, HbA1c, TG, TC, LDL-C, Cr, 25(OH) vitamin D , diabetic nephropathy, diabetic
133	peripheral neuropathy, diabetic retinopathy, and insulin use as the independent variables.
134	Multivariate logistic regression analysis was used to explore the influencing factors of sleep
135	disorder in elderly patients with type 2 diabetes. All tests were two-tailed test. A P value of <0.05
136	indicated statistically significant. SPSS software version 22.0 (SPSS Inc. Chicago, IL, USA,) was used
137	for statistical analysis of the data.

139 3. Results

3.1 Baseline characteristics of two groups accroding to sleep quality in the elderly patients with type 2
diabetes

142 186 type 2 diabetes elderly patients were recruited in the study with average age (73.6 ± 4.3) 143 years and the average duration of diabetes (8.8±3.0) years. There were 68 cases with diabetic 144 nephropathy, 62 cases with diabetic retinopathy, and 50 cases with diabetic peripheral neuropathy; 145 100 cases were treated with insulin. According to the total PSQI score, 186 elderly patients with 146 type 2 diabetes were divided into a normal sleep group (PSQI •7) and an inadequate sleep quality 147 group (total PSQI score > 7). 117 cases presented with poor sleep quality, accounting for 63% of all subjects under study. Compared with the normal sleep group, the inadequate sleep quality group 148 149 had lower 25(OH) vitamin D level, higher HbA1c level, and a higher incidence of diabetic 150 nephropathy and more insulin use (P<0.05). The differences in gender, age, BMI, duration of 151 diabetes, systolic blood pressure, diastolic blood pressure, FBG, TG, TC, LDL-C, and Cr levels in the 152 two groups were not statistically significant (all P>0.05). The results were showed in Table 1.

157 *3.2 Comparison of sleep quality in different* 25(OH) vitamin D *level groups in elderly patients with type* 2

158 diabetes

159 There were 141 cases presented with 25(OH) vitamin D deficiency, accounting for 76% of the

160 186 elderly patients with type 2 diabetes recruited in this study. The average PSQI total score of the

161 25(OH) vitamin D-deficient group was higher than that of the 25(OH) vitamin D -nondeficient

162 group, and the difference was statistically significant (P <0.05); The scores of 25(OH) vitamin D

163 deficient group were higher than those of normal 25(OH) vitamin D group (P < 0.05) in 7

164 dimensions of subjective sleep quality, sleep latency, sleep duration, habitual sleep efficiency, sleep

165 disturbances, use of sleeping medication and daytime dysfunction (**Table 2**).

170 3.3 Logistic regression analysis of risk factors for sleep disorders in elderly patients with type 2 diabetes

171 The results showed diabetic nephropathy, HbA1c, 25(OH) vitamin D, use of insulin were

172 related to the occurrence of inadequate quality of sleep in patients. Multivariate logistic regression

analysis of the above indicators suggested that 25(OH) vitamin D deficiency and the use of insulin

174 were risk factors for of inadequate sleep quality in elderly patients with type 2 diabetes. (Table 3)

177 **4. Discussion**

178 In this study, we revealed the correlation between serum 25(OH) vitamin D deficiency and179 sleep quality in elderly patients with type 2 diabetes.

180 Sleep plays an important role in human health, and sleep disorders is closely related to 181 diabetes²¹. In recent years, sleep disorders have been taken into account as an important risk factor 182 for the development of type 2 diabetes in the elderly. Sleep disorders and depression are more 183 prevalent in people with type 2 diabetes. Van Dijk et al. reported in the study that the probability of 184 increased nocturnal enuresis, pain, dysthermesthesia, and habitual snoring in diabetic populations 185 were significantly increased²². Epidemiological studies found that the incidence of sleep disorders in people with type 2 diabetes was 45% to $55\%^{^{23}24}$. This study showed the prevalence of inadequate 186 187 sleep quality, which is only a subset of all various sleep disorders, was high up to 63% in elderly 188 patients with type 2 diabetes. This indicated the incidence of sleep disorders would be significantly 189 higher in elderly patients among all type 2 diabetic patients⁵.

Inadequate sleep quality could cause sympathetic nerve excitement, increase the secretion of antagonist hormone of insulin such as nighttime growth hormone, glucagon, catecholamine, and cortisol, disturb glucose homeostasis; and increase insulin resistance²⁵. One has shown One study also showed that long-term sleep deprivation could reduce insulin secretion in the body leading to increased blood glucose levels in patients with diabetes²⁸. This study also found that HbA1c levels in diabetic patients with sleep disorders were higher than those in the normal sleep group, indicating that blood glucose in the sleep disorder group was more difficult to control.

197 Since serum 25(OH) vitamin D concentration is affected by many factors, including sun 198 exposure, lifestyle, and skin tone, etc. 25(OH) vitamin D deficiency has become a worldwide 199 problem and the prevalence is rising²⁷. Bayani et al. found that compared with healthy controls, serum 25(OH) vitamin D levels were significantly lower in patients with type 2 diabetes, and the 200 201 decline was more pronounced in women²⁸. This study also showed that 25(OH) vitamin D 202 deficiency was prevalent in elderly people with type 2 diabetes, accounting for 76% of the study 203 population. The potential causes of low 25(OH) vitamin D in elderly patients could be less outdoor 204 activities, shorter sunshine hours, and reduced gastrointestinal digestion and absorption in elderly 205 patients.

206 The data in this study show that in elderly patients with type 2 diabetes, the serum 25(OH) 207 vitamin D level in the sleep disorders group was lower than that in the normal sleep group, and the 208 insulin use rate was higher than in the normal sleep group. The average total PSQI score of the 209 25(OH) vitamin D -deficient group was higher than those of the normal vitamin D group, and the 210 25(OH) vitamin D -deficient group scored higher in 7 dimensions of subjective sleep quality, sleep 211 latency, sleep duration, habitual sleep efficiency, sleep disturbances, use of sleeping medication and 212 daytime dysfunction. Further logistic regression analysis showed that low level of 25(OH) vitamin 213 D and more insulin use were associated with sleep disturbance in elderly patients with type 2 214 diabetes. Logistic regression analysis of risk factors for sleep disorders in elderly patients with type 215 2 diabetes demonstrated that the low-level serum 25(OH) vitamin D was an important risk factor 216 for inadequate quality of sleep in elderly patients with type 2 diabetes.

Knhanes result showed that lower serum 25(OH) vitamin D levels were linked to a
significantly higher risk of short sleep duration^{29 30}. McCarty et al. found that patients with 25(OH)
vitamin D deficiency scored lower on the Epworth sleepiness scale (ESSs)³¹. Another study
measured objective sleep duration and sleep effectiveness of men over the age of 65 and found that
lower serum 25(OH) vitamin D levels were associated with shorter sleep duration and poorer sleep
effectiveness³². These results mentioned above were consistent with our data.

So far, the mechanisms for a link between sleep duration and 25(OH) vitamin D were not
clearly understood. Vitamin D receptors (VDR) were shown to be present in nearly all tissues of the
body, including many parts of the human brain, such as the hypothalamus, prefrontal cortex,
midbrain central gray, and substantia nigra, etc., which all play an important role in sleep
regulation³²⁻³⁴.

The classical clinical; presentation of Vitamin D deficiency is bone patient. Increased pain could be associated with sleep disturbances³⁵. Epidemiologic evidence for impact of 25(OH) vitamin D supplements on sleep quality was emerging. One study showed that people's pain levels, sleep quality, and various aspects of Quality of Life (QoL) can be significantly improved after standardized vitamin D supplementation³⁶. Another double-blind clinical trial showed improvements and increases in sleep quality and duration in patients with sleep disorders after eight weeks of continuous supplementation with 25(OH) vitamin D (50,000 IU/ 2 weeks)¹⁷.

As far as we know, this was the first study to analyze the relationship between serum 25(OH) vitamin D concentration and sleep quality in elderly patients with type 2 diabetes. The significance of this study is that the concentration of 25(OH) vitamin D can be used to identify sleep disorders in elderly patients with type 2 diabetes. These findings have positive implications for the prevention

and treatment of inadequate sleep quality in elderly patients with type 2 diabetes. One limitation of

- 240 this study was that the dietary habits and psychological state of patients were not assessed, which,
- 241 may also be related to sleep quality. Further, because of the character of the cross-sectional study, we
- 242 could not conclude the causal relationship among 25(OH) vitamin D and sleep quality. Therefore,
- 243 further studies with larger scale cohort studies and well-designed randomized controlled trials
- 244 would be needed to verify this relationship and reveal possible mechanisms.

245 **5 Conclusion**

- 246 In conclusion, this study confirms that 25(OH) vitamin D deficiency was more common in
- 247 elderly type 2 diabetic patients. There was a clear correlation between vitamin D deficiency and
- 248 sleep quality in this population. This initial work warrants further larger scale studies of ethnic
- 249 25(OH) vitamin D variations and potential causal interrelationship between sleep quality, insulin
- 250 usage and 25(OH) vitamin D deficiency state among elderly type 2 diabetic patients. Further studies
- are required to investigate possible biological mechanisms of the association between 25(OH)
- vitamin D deficiency, insulin usage and sleep quality, and to discover whether effective
- 253 interventions for 25(OH) vitamin D supplementation could improve sleeping quality and
- effectiveness of insulin treatment in decrease the risk of geriatric syndromes in elders with type 2
- 255 diabetes.
