1 School-based screening and treatment may reduce *P. falciparum* transmission

27 Abstract

28 In areas where malaria remains entrenched, novel transmission-reducing interventions are 29 essential for malaria elimination. We report the impact of screening-and-treatment of 30 asymptomatic schoolchildren (N=705) on gametocyte - the parasite stage responsible for 31 human-to-mosquito transmission - carriage and use concomitant household-based surveys to 32 predict the potential reduction in transmission in the surrounding community. Among 179 33 students with gametocyte-containing infections, 84% had positive malaria rapid diagnostic 34 tests. While gametocyte burden remained constant in untreated children, treatment with 35 artemether-lumefantrine reduced the gametocyte prevalence (p<0.0001) from 51.8% to 9.7% 36 and geometric mean gametocyte density (p=0.008) from 0.52 to 0.05 gametocytes/microliter. 37 Based on these estimates, the gametocyte burden in the community could be reduced by 25-38 55% depending on the season and the measure used to characterize gametocyte carriage. 39 Thus, school-based interventions to treat asymptomatic infections may be a high-yield 40 approach to not only improve the health and education of schoolchildren, but also decrease 41 malaria transmission.

42 Introduction

43 In the last two decades, many regions have made substantial progress toward elimination of 44 malaria. Recently, however, progress has stalled and malaria remains entrenched in some highly endemic areas like Malawi.¹ In these areas, current interventions (e.g., vector control, 45 46 universal access to effective testing and treatment, and preventive treatment of high risk populations²) may not adequately interrupt human-to-mosquito *Plasmodium falciparum* 47 48 transmission. Sub-clinical infections in individuals at lower risk of disease often remain untreated, creating a silent reservoir that may perpetuate transmission.³ To achieve malaria 49 50 elimination, interventions must not only prevent and treat disease but also decrease parasite transmission.⁴ 51

53 School-age children bear an under-appreciated burden of *P. falciparum* infection and may be a key transmission reservoir.⁵ School-age children frequently have higher prevalence of 54 infection than younger children and adults⁶⁻¹⁰ and their infections more often contain 55 gametocytes, the parasite stage required for human-to-mosquito transmission.^{8,11} When 56 57 bitten, infected school-age children and young children are similarly infectious to 58 mosquitoes.¹² However, school-age children have larger body surface area and less bed net use, increasing availability for bites.^{13–16} Together these factors suggest school-age children 59 are dominant sources of human-to-mosquito P. falciparum transmission.¹⁶⁻¹⁸ Indeed, 60 61 expanding community-based seasonal malaria chemoprevention from only young children to 62 include school-age children was associated with a 20% decrease in clinical malaria in older community members who did not receive the intervention.¹⁹ 63

With rising school enrollments across the malaria-endemic world, malaria interventions could
 leverage existing school infrastructure. Treatment options include "intermittent preventive

67 treatment" where all students regularly receive antimalarial drugs for parasite clearance and 68 transient prophylaxis, and "screening-and-treatment" where asymptomatic students are 69 screened and only those testing positive receive treatment. Preventive treatment directly 70 decreases infection and gametocyte prevalence, clinical disease, and anemia among students^{20,21}, but potential indirect effects on the surrounding community have not been 71 72 established. While dynamic modeling data suggests the utility of this intervention, only one 73 study has reported the impact of school-based preventive treatment on community-level 74 infection, finding a small but significant decrease in community infection prevalence 75 surrounding intervention schools despite low intervention coverage.^{22,23}

77 We conducted a school-based screen-and-treat cohort study in Malawi concurrent with 78 household-based cross-sectional surveys. Primary school students in four schools were 79 screened for infection using a rapid diagnostic test (RDT). If positive, students were treated 80 with artemether-lumefantrine. Subsequent gametocyte carriage in treated and untreated 81 students was assessed after one, two, and six weeks. Using the age distribution of gametocyte 82 containing infections in the communities surrounding the school, we estimated the potential 83 reduction in prevalence of gametocyte-containing infections and gametocyte density in the 84 community following screening-and-treatment of schoolchildren. If school-based preventive 85 treatment substantially reduces gametocyte burden in the community, this intervention could 86 both improve the health of schoolchildren and contribute more broadly to malaria 87 elimination.

89 **Results**

We enrolled 786 students in school-based cohorts: 405 in the rainy season and 381 in the dry
season. Complete follow-up was obtained for 616 students (78% of enrolled students)

- 92 (Supplemental Figure S1). Among the 705 students with baseline data, the mean age was
- 93 10.4 years, 51% were female, and 47% reported sleeping under a net the previous night. The

94 weighted prevalence of RDT-positivity among students at baseline was 42%. An additional

- 8% of students had infection detected by only PCR. The distribution of infection prevalence
- 96 varied by school and season (Figure 1).

108 Determinants of gametocyte burden in school-based cohorts at baseline

109 Overall, at baseline, 28% of students had gametocyte-containing infections (8-50% across 110 schools and seasons; Figure 1). To disentangle predictors of having an infection containing 111 gametocytes from those of simply having any infection, we evaluated predictors among only 112 students with P. falciparum infection. Among the 253 students with P. falciparum infection 113 by PCR at baseline, 70% contained gametocytes. Infections were more likely to contain 114 gametocytes in the rainy season and in younger students, although the age association was 115 not statistically significant (Table 1). Associations were comparable in multivariable models

116 with or without non-significant variables.

- 118 The crude weighted geometric mean gametocyte density among those with gametocytes was
- 119 0.34 gametocytes/µl (95% CI: 0.19-0.60 gametocytes/µl; range 0.002-661 gametocytes/µl).

120 Gametocyte density was higher in the rainy season and decreased with age (Table 2). Overall,

- 121 5.3% of students had high-density infections (≥10 gametocytes/µl, associated with increased
- 122 likelihood of transmission²⁴) at baseline. Among students with gametocyte-containing
- 123 infections, 19% had high density infections. In addition to season and age, odds of high
- 124 density gametocyte infection were significantly higher in children with fever and in the
- 125 lowest prevalence school (Bvumbwe; Supplemental Table S3).

127 Gametocyte-containing infections missed by RDT screening

- 128 A key factor in the success of screen-and-treat interventions is the screening test sensitivity
- 129 for detecting infections of interest, i.e., gametocyte-containing infections for transmission
- 130 reduction. Sixteen percent of all students gametocyte-containing infections and 9% with
- 131 high-density gametocyte-containing infections were RDT-negative and thus not treated.
- 132 RDTs were less likely to detect gametocyte-containing infections at lower densities (Table 3).
- 133 After adjusting for density, RDTs also missed gametocyte-containing infections more often
- 134 in the lowest prevalence school (Bvumbwe) than other schools (OR for failure 6.6, 95%
- 135 CI:1.9-24, p=0.004).

137 Impact of screen-and-treat intervention on gametocyte prevalence and density in the

138 school-based cohort

139 As hypothesized, treatment decreased gametocyte prevalence and density among students

140 during follow-up. Comparing gametocyte prevalence among all students from baseline to six

141 weeks after the intervention there was a reduction from 31.1% (95%CI: 27.6, 34.5) to 12.8%

142 (95%: 9.5,16.1) in the rainy season and from 25.7 (95%CI: 20.9, 30.4) to 8.8% (95%: 5.4,

143 12.2) in the dry season. Geometric mean gametocyte density decreased from 0.50

144 gametocytes/microliter (95%CI: 0.09, 2.81) to 0.02 (95%: 0.002, 0.20) in the rainy season

145 and 0.003 (95% CI: 0.001, 0.009) to 0.0001 (95%: 0.00001, 0.002) in the dry season.

The overall reduction occurred among treated students, while prevalence and density among untreated students remained constant or increased. The prevalence of gametocyte-containing infections among treated students decreased from 52% (95% CI: 45-58%) at baseline to 11% (95% CI: 7-14%) after two weeks, a 79% reduction (Figure 2A). Gametocyte prevalence remained low after six weeks [10%, 95% CI: 6-14%)]. Among untreated students (RDTnegative), the prevalence of gametocyte-containing infections remained unchanged from baseline [9% (95% CI: 5-14%)] to six weeks after the intervention [12% (95% CI: 7-17%)].

155	Gametocyte density followed the same trend, with 90% reduction in the geometric mean of
156	gametocyte density after treatment versus 59% increase in untreated children (Figure 2B).
157	There were 32 students with high-density gametocyte-containing infections at baseline: 28 in
158	RDT-positive students and four in RDT-negative students. Two weeks after screening-and-
159	treatment, only one high-density gametocyte infection was detected, which was in an
160	untreated student. Six weeks after treatment there were four high-density gametocyte-
161	containing infections, two in students that were not treated and two in students that received
162	treatment, corresponding to a 90% reduction in the prevalence of high-density gametocyte
163	infections. Results were similar across schools, a proxy for transmission settings (Figures 2C-
164	F).

177 Gametocytemia in the school-based cohort compared to school-age children in the

178 community

The proportion of infections containing gametocytes in the school-based cohort was similar to that in school-age children in the community (25% vs. 27%, p=0.62), supporting the generalizability of the intervention results to all school-age children in the community. The geometric mean density was higher in school-age children in the community (0.99 gametocytes/µl [95% CI:0.71-1.38]) than in the school (0.34 [95% CI:0.19-0.60], p=0.03). However, the proportion of infections containing ≥ 10 gametocytes/µl among those with gametocytes was similar (20% in the community vs. 18% in schools, p=0.51).

187 Predicted reduction in the community gametocyte population following treatment in 188 schools

189 The screen-and-treat intervention reduced gametocytemia in our school-based cohorts. 190 Furthermore, school-age children substantially contributed to the population of gametocyte-191 carriers in the surrounding communities; 46% of all gametocyte-containing infections and 192 high-density gametocyte-containing infections were in school-age children, who comprised 193 only 35% of the population (Supplemental Results and Figure S2). If the screen-and-treat 194 intervention were extended to all school attendees, we estimate it could result in at least six 195 weeks of reductions in the community prevalence of gametocyte-containing infections as 196 large as 26% in the rainy and 34% in the dry season (Figure 3A and 3B). The total 197 gametocyte burden (sum of gametocyte densities) in the community would be reduced by 198 33% in the rainy season and 25% in the dry season (Figure 3C and 3D). The number of 199 infections containing ≥ 10 gametocytes/µl would be reduced by 44% and 55% in the rainy and 200 dry seasons, respectively (Figure 3E and 3F).

217 **Discussion**

218 Additional malaria control interventions are needed in areas like Malawi where current 219 measures have not yielded substantial reduction in P. falciparum transmission. Our results 220 support the use of school-based screen-and-treat as an intervention that may not only improve 221 the health of schoolchildren, but also decrease transmission in the community. Almost half of 222 high-density gametocyte-containing infections in the community were in school-age children; 223 school-based treatment nearly eliminated this group's contribution to transmission for up to 224 six weeks. We also showed that RDTs detected most high-density gametocyte-containing 225 infections, and that treatment of sub-clinical infections based on RDT results reduced 226 gametocyte prevalence and density. Treating only children with positive RDTs could reduce 227 the community-level gametocyte burden by a third. This reduction in potentially infectious 228 reservoirs could help interrupt persistent malaria transmission.

230 The high prevalence of gametocyte-containing infections in school-age children in this study is consistent with prior work by our group and others.^{8,11,16} However, to our knowledge, this 231 232 is the first study to simultaneously determine gametocyte burden in schools and surrounding 233 communities to estimate the potential impact of school-based treatment on transmission. In 234 Uganda, school-based intermittent preventive treatment was associated with reduced parasite prevalence in the surrounding community in a large cluster randomized trial.²³ Although the 235 236 community-level effect was statistically significant, the magnitude was limited by low 237 intervention coverage. Because this intervention was conducted as a clinical trial, parents had 238 to come to the school to consent for each student, creating logistical barriers. Thus, further 239 estimates of the full potential of this intervention are needed.

241 While our results lend further support the potential contribution of school-based preventive 242 treatment to transmission reduction, there are limitations to our analyses. We did not use 243 RDTs to detect infections in the communities surrounding schools and had to extrapolate 244 from the relationships of PCR- and RDT-detected infections in the school-based cohort to 245 estimate the number of RDT-positive children who would attend school from the community. 246 However, the distribution of gametocyte prevalence in the school-based and community-247 based surveys was comparable, supporting the estimate. Furthermore, we used sensitive 248 molecular methods to detect and quantify gametocytes but did not directly measure 249 infectiousness using feeding assays. However, our data still likely represent the relative 250 contribution of different age groups to transmission because we evaluated not only the 251 prevalence of gametocytes but the density and further evaluate high-density gametocyte containing infections, which are the most likely to lead to mosquito infection.²⁴ Furthermore, 252 253 prior studies have shown that school-age children and younger children are more infectious to mosquitos than adults¹² and school-age children are more likely than younger children to be 254 bitten by competent vectors.¹⁶ Lastly, our estimates of the impact of the intervention in the 255 256 community assume universal coverage in students. In Malawi, school-based deworming programs routinely report coverage of >90% of school-age children.²⁵ Thus high levels of 257 258 coverage are possible.

Our results likely underestimate the overall effect of school-based treatment for three reasons. First, the impact of clearing gametocyte-containing infections in school-age children is expected to be amplified because competent vectors probably feed more often on school-age children and adults who have larger body surface than younger children^{15,26} and use bed nets less frequently.^{14–16,26} Second, in our community-level predictions, we conservatively assumed that gametocyte-containing infections in non-treated age groups would remain

266 constant. However, the decreased pool of infectious school-age children should also lead to 267 fewer new infections and fewer gametocyte-containing infections in younger children and 268 adults. Third, our results are based on a single treatment intervention; the impact of repeated 269 school-based treatment is likely to be even larger. In clinical trials that have evaluated the 270 impact of school-based malaria preventive treatment on health outcomes, the most successful 271 interventions were repeated either monthly during the high transmission season or quarterly throughout the year.²⁰ Reinfection rates, seasonal variation in transmission, and duration of 272 273 the prophylactic effect of the treatment drugs should be used to guide the frequency of 274 intervention required.

275

276 Currently, schools are platforms for successful deworming campaigns and feeding programs, 277 and a growing number of interventions target this age group, including vitamin 278 supplementation and adolescent vaccinations. The vast majority of children in sub-Saharan 279 Africa attend school, making schools a logistically feasible platform for targeted 280 interventions. Schools are particularly important to reaching this age group, since children 281 rarely have routine contact with the health care system after completing childhood 282 immunizations. Adding malaria preventive treatment to other school-based interventions in 283 an integrated school health package should improve the cost:benefit ratio, promote 284 sustainability, and improve health care access to an underserved population.

285

One concern is that risk of infection and disease could increase once students leave school or if the intervention ceased. A prior study of chemoprophylaxis in younger children demonstrated a transient increase in clinical infection when the intervention was discontinued.²⁷ However, this "rebound effect" was not observed in all chemoprophylaxis trials, nor has it been found after intermittent preventive treatment of infants.^{28–30} In highly

endemic settings where school-based treatment interventions are most needed, schoolchildren have acquired partial immunity and often have sub-clinical infections. Continued exposure should maintain some naturally acquired immunity. Another concern about the widespread use of preventive treatment is the potential for drug resistance. While this concern is important, it should be weighed against the direct student health and potential indirect community benefits when evaluating the approach.²⁰

297

298 Our results join previous studies in supporting the need for implementation studies to 299 measure the indirect impact of school-based treatment on community-level malaria 300 transmission. Although RDTs will fail to detect some low-density infections, such as those 301 observed in the dry season and in our lowest prevalence school, a screen-and-treat approach 302 may substantially reduce the population of gametocytes in the community. Alternatively, 303 providing preventive treatment to all students as intermittent preventive treatment, may have 304 even greater impact. While higher density gametocyte-containing infections are more likely 305 infectious, low density infections contribute to population-level transmission dynamics 306 because they are common.²⁴

307

In summary, these results demonstrate the potential for school-based malaria treatment to substantially decrease *P. falciparum* gametocyte carriage and thus transmission in the surrounding community. In combination with disease- and vector-control interventions, this transmission-focused strategy may be critical to reduce the burden of malaria in areas where this disease has remained entrenched despite current control measures.

316 Study sites and design

317 School-based cohort studies and household-based cross-sectional surveys were conducted at 318 the end of the rainy season (April-May) and during the dry season (September-October) of 319 2015. Two sites with consistently high (>40%) parasite prevalence in school-age children -320 Maseya and Makhuwira – and two with lower, seasonally varied transmission (>two-fold 321 seasonal prevalence difference) – Bvumbwe and Ngowe – were selected from 30 previously studied sites in southern Malawi.⁶ Long-lasting insecticide treated nets were distributed 322 323 through a national campaign in 2012. Rapid diagnostic tests (RDTs) and treatment with 324 artemether-lumefantrine were generally available in local government-operated health 325 facilities.

327 School-based cohorts: Students present on a sampling day were assigned numbers. Fifteen 328 students per grade-level were sampled using a random number generator. Students were 329 excluded if they: had no parent/guardian available to provide consent, would not attend 330 school throughout the 6-week study, or had a known artemether-lumefantrine allergy. 331 Students enrolled in the rainy season cohort were excluded from the dry season cohort.

Enrolled students were interviewed at baseline, one-, two-, and six-week visits about bed net use the night prior, current or recent illness, and antimalarial treatment. At baseline, a fingerprick blood sample was obtained for detection of *P. falciparum* by RDTs and hemoglobin was measured by portable photometer (Hemocue, Angelholm, Sweden). RDT-positive students received weight-based treatment with artemether-lumefantrine (Novartis Pharma AG or Ajanta Pharma Ltd). At baseline and all follow-up visits, finger-prick blood was obtained for molecular detection of any-stage parasite and gametocytes. At the final visit, parents were

340 interviewed and health passports (individual portable medical records) reviewed to identify

- 341 intercurrent fever or malaria treatment.

343 Household-based cross-sectional surveys: Concurrently cross-sectional surveys were 344 conducted in 80 households in each school catchment area, including a cluster of 30 from ongoing surveillance studies (Details in ⁶) and 50 households newly selected based on 345 346 closest Euclidian distance to the school. Households were visited within two weeks of the 347 school cohort baseline visit. Questionnaires based on the Malaria Indicator Survey were 348 administered and blood samples obtained for polymerase chain reaction (PCR) testing, as previously described.^{6,14} RDTs were not performed and no treatment was provided. School 349 350 attendance in the last four weeks was asked for all participants \geq five years. Few five-year-351 olds attended school, thus school-age children were defined as those six to 15 years old. 352 Younger children were defined as 6-71-months-old, and adults as over 15 years old.

355 Written informed consent and assent were obtained from adults and children, as appropriate.

365 quantitative reverse transcription PCR was performed on whole blood preserved in 366 RNAprotect Cell Reagent (Qiagen Inc. Valencia, CA, USA) to measure expression of the 367 mature gametocyte marker Pfs25.³¹

369 Infection and treatment definitions

370 P. falciparum infection was defined as positive PfLDH PCR results on at least one run. 371 Participants without PfLDH detected by PCR were considered gametocyte negative. RDT-372 positive students with negative PCRs were considered negative for active infection, but were 373 included in the treatment group for analysis because they had received artemether-374 lumefantrine. Other malaria treatment during follow-up was defined as any treatment with an 375 effective antimalarial reported during student follow-up interviews, during the parent 376 interview, or in the student's health passport. High-density gametocyte infections were those 377 with > 10 gametocytes/microliter (μ l). Lower densities of gametocytes are thought to 378 contribute less to transmission [25].

380 Statistical analysis

All analyses of the school-based population accounted for survey weights and school sampling strata (Supplementary Materials). Contribution to transmission was evaluated four ways: 1) gametocyte prevalence defined as the proportion of participants with any gametocytes; 2) gametocyte density; 3) total gametocyte burden calculated as the sum of participant gametocyte densities; and 4) prevalence of high-density gametocyte infections.

387 For school-based cohorts at baseline, logistic regression models were used to assess 388 determinants of gametocyte prevalence and linear models (log10-transformed) were used to 389 assess determinants of gametocyte density y among infections with > 0 gametocytes. We

390 used logistic regression among students with gametocyte-containing infections to identify 391 characteristics of students in whom RDTs failed to detect gametocyte-containing infections at 392 baseline. Gametocyte density was included as a continuous variable after assessing linearity 393 of the relationship with odds of RDT negativity. Because of baseline differences in 394 transmission pattern and demographics, all analyses were adjusted for school. In all models, 395 selection of relevant predictors was based on Wald tests through best subset regression. 396 Effect in linear models was reported as percent difference in absolute gametocyte density and 397 was calculated as $[exp(coeff)-1] \times 100$.

398

Differences in the prevalence of gametocytemia and gametocyte density over time between treated (RDT positive) and untreated students (RDT negative) were assessed in nested random intercept longitudinal models by testing an interaction term between treatment and indicator variables for visit. Based on these longitudinal models, predictions of gametocyte prevalence and density were obtained, marginal on random intercepts, and stratified by school, season, and treatment status (baseline RDT positive or negative), with other modeled predictors assumed constant.

To assess the contribution of school-age children to the overall community population of gametocytes, we compared the distribution of gametocyte-containing infections, high density gametocyte infection, and geometric mean gametocyte density through chi-squared tests and linear regression: i) across age-groups, and ii) between students in the school-cohort and school-age children in the community. This analysis was unweighted because sampling of community surveys was not stratified.

415 To evaluate the potential indirect impact of school-based preventive treatment on the 416 community, we estimated the expected reduction in the number of gametocyte-containing 417 infections, gametocyte burden, and the number of high density gametocyte-containing 418 infections in the communities surrounding schools if the screen-and-treat intervention had 419 included all students. Briefly, we first calculated the number of children from the community 420 likely to be in school from the age- and gender-weighted proportion of school-age children 421 that reported attending school in the past four weeks. To estimate the expected reduction in 422 the numbers of gametocyte-containing infections and high-density gametocyte-containing 423 infections in the communities surrounding schools, we used mixture of distributions and 424 conditional probabilities. To estimate the impact of the intervention on the overall 425 gametocyte burden, we first fit overdispersed Poisson models to the school-based cohort with 426 gametocyte density and RDT positivity results at baseline, then predicted the overall 427 gametocyte density changes following the intervention for the hypothetical population of 428 school-going children from the community who would have had a malaria infection and been 429 treated in the screen-and-treat intervention (RDT-positive at baseline) at each follow-up time 430 point. We assumed the population prevalence of gametocyte-containing infections in adults 431 and younger children would remain constant during the intervention period because they 432 would not receive the intervention.

Analyses were conducted in Stata/SE version 15.1 (StataCorp, College Station, TX, USA) and R v3.5 (R Foundation for Statistical Computing, Vienna, Austria).³² Weighted analyses used the survey module of Stata. Significance was set at alpha = 0.05. Further details of the predictive modeling and statistical analysis are provided in the Supplemental Information.
