

# Modeling the flow of the COVID-19 in Germany: The efficacy of lockdowns and social behavior

## Abstract

This study develops a computer simulation in understanding the flow of the COVID-19 in Germany between January 2020 and July 2020. This aims to analyze not only the flow of the COVID-19 but also the efficacy of taken measures during the given period. The computer model is based on the SEIR concept and it is based on the system dynamics approach in which some uncertain parameters are estimated through the calibration process. Moreover, the SEIR computer model is developed by considering different flows of COVID-19 cases in older and young people in Germany. This study successfully reproduces similar patterns of infected, recovered, and death cases. Moreover, as the SEIR model can successfully reproduce similar patterns, the SEIR model can be a basis to estimate other resources such as health workers, and bed capacities.

## 1. Introduction

Originally, earlier cases of COVID-19 were reported from Wuhan, China in December 2019. Upon the international travel involving Chinese visitors, the COVID-19 has spread across the world, leading to the first pandemic in the last decade. Owing to its largest and widespread impacts, the WHO reports the latest figures on confirmed cases and deaths across the world since January 2020.

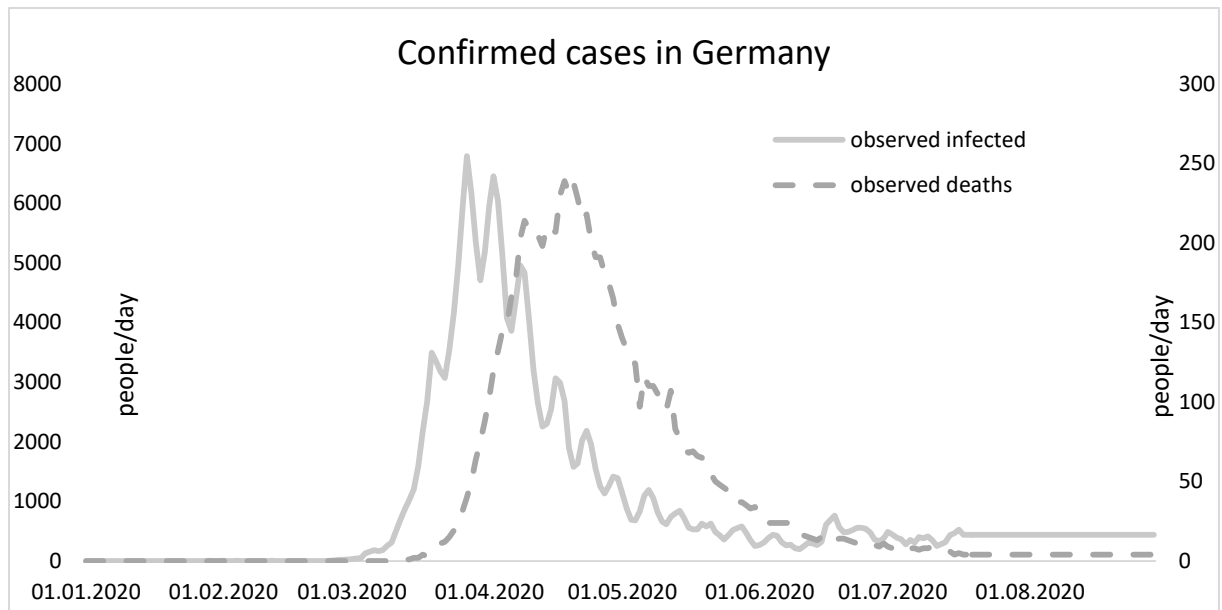


Figure 1. Confirmed infected and death cases in Germany

Germany, the largest economic producer in Europe, inevitably also has experienced this pandemic. The first COVID-19 case in Germany was reported in late January 2020 as the first confirmed patient contacted his infected colleague from China (e.g. Böhmer et al., 2020). Within two months, more than 100 confirmed cases were recorded in Germany (<https://www.worldometers.info/coronavirus/country/germany/>). Afterward, confirmed cases increased exponentially by about 6,000 in the mid-April 2020. By the end of July 2020, the COVID-19 cases decreased significantly as seen in figure 1.

To anticipate the massive flow of the COVID-19, the federal government introduced public closures by closing public spaces such as schools, universities, and restaurants starting from March 16 ([https://covid19-country-overviews.ecdc.europa.eu/#14\\_Germany](https://covid19-country-overviews.ecdc.europa.eu/#14_Germany)). A further measure was also applied such as the national curfew ban and restricting people gathering. In principle, people were advised to stay at home as long as possible and leaving home only for basic needs.

Several studies analyzed the COVID-19 dynamics in Germany. Existing studies (Barbarossa et al., 2020; Khailaie et al., 2020) introduced mathematical modeling in understanding the dynamic flow of the COVID-19 while other existing studies (Dudel et al., 2020; Karagiannidis et al., 2020; Nachtigall et al., 2020) explained demographic data of patients. The flow of the COVID-19 also has been the main focus of existing studies (Böhmer et al., 2020; Stang et al., 2020).

Despite important contributions, no available study has explained any computer simulation to investigate the flow of the COVID-19 in Germany. Existing studies (Barbarossa et al., 2020; Khailaie et al., 2020) only explained the flow of the COVID-19 in Germany but they did not separate two different measures in tackling the flow of the COVID-19. This is important as existing studies (Lüdecke, & von dem Knesebeck, 2020; Hoenig, & Wenz, 2020) indicated two types of policies: behavior reduction policy (voluntarily personal actions) and lockdowns (the government policy with enforcement laws).

Hence, this study aims to develop a computer model that investigates the first wave of the COVID-19. Furthermore, no available study has analyzed two types of policies in slashing the pandemic flow and neither available study has developed the cohort SEIR model that is based

on the SD approach. It is thus this study offers a computer model to explain the flow of the COVID-19 from January until July 2020 as well as analyzing the efficacy of the two different policies and consisting the cohort groups (young and old patients).

## **2. Methods and Data**

The computer model is based on data collected by [www.worldometer.com](http://www.worldometer.com) and Robert Koch Institute (RKI - [www.rki.de](http://www.rki.de)). This study also data relate to important measures from [https://covid19-country-overviews.ecdc.europa.eu/#14 Germany](https://covid19-country-overviews.ecdc.europa.eu/#14_Germany) as this portal provides information step by step the federal government took measures in tackling the flow of the COVID-19. Data collection includes several data types such as infected, deaths, and recoveries. Other important data are also collected such as ages, incubation time, and recovery time.

The computer model follows the Susceptible, Exposed, Infected, and Recovered (SEIR) concept. This computer model is based on the system dynamics (SD) approach as a lot of studies have successfully simulated infectious, non-infectious diseases, and other healthcare issues (Donsimoni et al., 2020; Darabi & Hosseinichimeh, 2020; Davahli et al., 2020; Homer & Hirsch, 2006). While the computer model follows the SEIR concept and the SD approach, challenges owing to limited data such as uncertain parameters are visible. This study calibrates uncertain parameters using the calibration process available in Vensim©.

To do the calibration process, this study uses the Markov Chain Monte Carlo (MCMC) calibration process owing to unknown parameters. To obtain the best parameter values, the system dynamics model compares two outputs including infected cases and deaths. The two observed variables are compared with simulated variables to get the best parameter values in which means that the best parameter values lead to the smaller discrepancies between the two variables.

This study also introduces two measures or policies in tackling the flow of the COVID-19. The first policy is called behavioral risk reduction and the second one is lockdowns (public closures). The main reason to separate policies is the first policy is once infected people and disinfected people easy to identify, self-quarantines and health attitude such as hand washing are two possible solutions. However, once separating infected and disinfected people is relatively difficult owing to case spikes, the second policy i.e. lockdown is the best solution to stop the transmission of diseases (Piguillem & Shi, 2020). Separating these two policies is also important owing to reasons. The first reason existing studies explained the importance of the first policy (Lüdecke, & von dem Knesebeck, 2020; Hoenig, & Wenz, 2020) and the

second reason is while the first policy is not supported by legal enforcement, the second policy is supported law enforcement (Hoenig, & Wenz, 2020).

### **3. Discussion and Results**

The SEIR model consists of two groups: old ( $\geq 60$  years) and young patients ( $< 60$  years). There is an imbalance proportion of the infected cases in the two groups as RKI (2020) has explained that the first group consists of about 95% of total deaths and about 21% of total infected cases. While the second group covers of 5% of total deaths and only 79% of total infected cases. This accommodates possible different factor patterns such as recovery time and infection duration between two groups.

Several studies (e.g. Karagiannidis et al., 2020; Nachtigall et al., 2020) pointed out that there is an imbalance effect of the COVID-19 in which older people tend to experience the most negative effects, especially high death cases among older people. It is thus separating patients in two groups means the cohort SEIR model represents imbalance effects of the COVID-19 across multiple age groups.

Table 1 displays the main variables used in this study and their estimated values based on existing studies. As previously mentioned, the MCMC calibration process is needed to obtain the best values, especially for unknown or uncertain parameters. During the MCMC calibration process, values of uncertain parameters are set based on table 1.

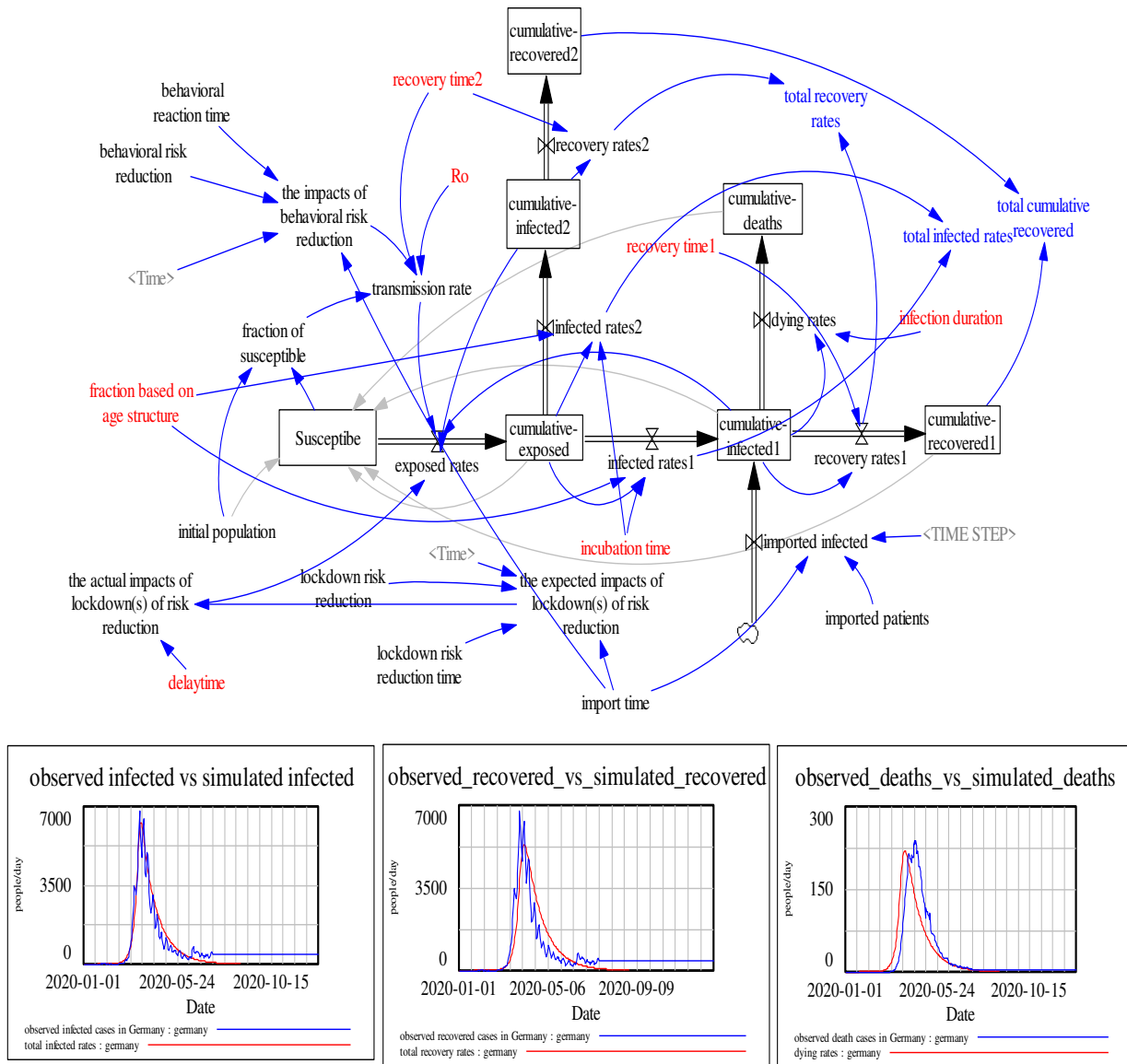


Figure 2. The SD model of Germany COVID-19

Figure 2 shows that the system dynamics model (SD) separates infected patients into two groups. This also means that for each group, the SD model calculates the number of infected cases, recoveries, and deaths. Recovery time1 is defined the average time between the symptom onset and recovery while infected duration1 is defined as the average time between the symptom onset and deaths.

The number of infected cases, deaths, and recoveries are based on equations 1-3 (similar equations apply for *infected rates2* and *recovery rates2*) as follows:

$$infected\ rates1 = "cumulative-exposed"/incubation\ time * fraction\ based\ on\ age\ structure \dots \quad (1)$$

$$dying\ rates = "cumulative-infected1"/infection\ duration \dots \quad (2)$$

$$\text{recovery rates1} = \text{"cumulative-infected1"/recovery time1} \dots\dots\dots (3)$$

Transmission rate measures the number of exposed people after contacting or stand closes with infected people. Following Fiddaman (2020), transmission rate is calculated based on equation 3. For the first policy, its impact is calculated based on equation 4. Equation 4 means that the first policy of behavioral reduction risk decreases transmission rate based on two factors: “behavioral reduction risk” and “behavioral reduction time”.

$$\text{Transmission rate} = (\text{Ro/recovery time2}) * \text{fraction of susceptible} * (1 - \text{the impacts of behavioral risk reduction}) \dots\dots\dots (4)$$

A similar equation is applied for the second policy as seen in equation 5. Equations 5a and 5b show the number of exposed cases decreases after the second policy starts at “lockdown risk reduction time”.

$$\text{the expected impacts of lockdown risk reduction} = \text{IF THEN ELSE}(\text{Time} \geq \text{import time} + \text{"lockdown risk reduction time"}, \text{"lockdown risk reduction"}, 0) \dots\dots\dots (5a)$$

$$\text{the actual impacts of lockdown risk reduction} = \text{DELAY3I}(\text{"the expected impacts of lockdown risk reduction"}, \text{delaytime}, \text{"the expected impacts of lockdown risk reduction"}) \dots\dots\dots (5b)$$

After running MCMC calibration process, the author finds some possible values with the smallest errors as seen in table 2.

It is found that the first policy efficacy is about 10%, assuming that an incubation time is about 3 days. While the second policy efficacy is about 85% in minimizing the COVID-19 flow. This finding may explain the second wave of the COVID-19 in Germany. Once the second policy i.e. the lockdown(s) are released the infected cases have risen significantly despite the public awareness or public behavior existence (wearing masks and social distancing in public spaces).

It appears that the SD model can reproduce similar outputs compared to respective observed outputs as seen in figure 2. The SD model performance shows that the SD model has symmetric Mean Percentage Errors (sMAPE) less than 10% (table 3).

#### **4. Conclusions**

This study fills a gap in which existing studies have not separated the impacts of the first policy (the people behavior) and the second policy (the government actions) in tackling the COVID-19 flow in Germany. To measure the impacts of the first and the second policy, this study develops the SEIR model based on the system dynamics approach and obtain the best parameter values through MCMC calibration process.

It is shown that the first policy i.e. preventive behavior such as handwashing and voluntarily social/physical distancing is important in minimizing the flow of the COVID-19. However, the second policy i.e. lockdowns shows is important roles in flattening the COVID-19 curve. With keep this point in mind, releasing lockdowns should be initiated carefully as, despite the importance of the preventive behavior, the first policy is not sufficient to significantly decrease the pandemic cases.

This study shows that the cohort SEIR model can successfully reproduce similar patterns of the COVID-19 in Germany. As it is the cohort SEIR model, it can be used to estimate the imbalance effects of the COVID-19 on different age groups. Moreover, as the cohort SEIR model can be a basis to simulate impacts of the COVID-19 on resources such as health workers and bed capacities.
