1	Understanding COVID-19 dynamics and the effects of interventions in the Philippines: A
2	mathematical modelling study

26 ABSTRACT

27 Background

28 COVID-19 appears to have caused less severe outbreaks in many low- and middle-income

29 countries (LMIC) compared with high-income countries, possibly because of differing

30 demographics, socio-economics, climate, surveillance, and policy responses. The Philippines

- 31 is a LMIC that has had a relatively severe COVID-19 outbreak but has recently curtailed
- 32 transmission while gradually easing interventions.
- 33 Methods

34 We applied an age-structured compartmental model that incorporated time-varying mobility,

35 testing, and personal protective behaviors (through a "Minimum Health Standards" policy,

36 MHS) to represent the Philippines COVID-19 epidemic nationally and for three highly

37 affected regions (Calabarzon, Central Visayas, and the National Capital Region). We

38 estimated effects of control measures, key epidemiological parameters, and projected the

39 impacts of easing interventions.

40 Results

Population age structure, contact rates, mobility, testing, and MHS were sufficient to explain the Philippines epidemic based on the good fit between modelled and reported cases, hospitalisations, and deaths. Several of the fitted epidemiological parameters were consistent with those reported in high-income settings. The model indicated that MHS reduced the probability of transmission per contact by 15-32%. The December 2020 case detection rate was estimated at ~14%, population recovered at ~12%, and scenario projections indicated high sensitivity to MHS adherence.

48 Conclusions

49 COVID-19 dynamics in the Philippines are driven by age, contact structure, and mobility,
50 and the epidemic can be understood within a similar framework as for high-income settings.
51 Continued compliance with low-cost MHS measures should allow the Philippines to maintain
52 epidemic control, but disease resurgence remains a threat due to low population immunity
53 and detection rates.

57 BACKGROUND

Coronavirus 2019 (COVID-19) epidemiology differs across settings with apparently less 58 severe outbreaks in many low- and middle-income countries (LMIC) compared with high 59 60 income countries (HIC), such that understanding why LMIC are less affected is critical to 61 understanding global epidemiology. Multiple demographic and socio-economic factors likely 62 drive differential COVID-19 burden across income groups. Expansive population pyramids 63 and tropical climates may reduce COVID-19 transmission and severe disease in many LMIC 64 (1–3), while high contact rates, high prevalence of comorbidities, high population densities, 65 and limited healthcare capacity could increase burden (4–8). While many LMIC have had lower COVID-19 burdens than HIC, weak surveillance systems (9) could also affect 66 epidemic estimates. Nonetheless, understanding why LMIC have had apparently less severe 67 68 outbreaks could help other countries better control their epidemics. 69

Most countries have implemented multiple non-pharmaceutical interventions (NPIs) to curtail
 COVID-19 transmission; although initially successful, easing restrictions has led to second,

72 apparently larger, waves of transmission (10) in many HIC, while similar levels of disease 73 resurgence have not occurred in many LMIC. Importantly, testing rates have increased substantially between the first and second waves of transmission, which could account for 74 75 some of the increased case numbers. There are three broad categories of NPIs, those that aim to: (i) isolate infected individuals and their contacts; (ii) reduce contact between infected and 76 susceptible people (henceforward "macrodistancing"); and (iii) reduce transmission given 77 78 contact between infected and susceptible people (henceforward "microdistancing"). Most HIC have enforced initiatives for all three types of NPIs with a focus on long, strict 79 80 macrodistancing interventions through stay-at-home orders. LMIC have also employed macrodistancing policies but often with shorter, less strict orders because these types of 81 initiatives exacerbate poverty and have societal costs (11,12) that LMIC cannot withstand. 82 83 Relaxing of short-term macrodistancing policies would be expected to lead to disease 84 resurgence (13), which runs counter to the experience of many LMIC. A meta-analysis indicates that inexpensive microdistancing policies (e.g., wearing face masks) can be highly 85 effective (14) and therefore could explain why many LMIC are continuing to suppress 86 87 transmission after an initial period of macrodistancing.

The Philippines is one of the most severely affected countries by COVID-19 in the Western 89 90 Pacific Region, but has also succeeded in curtailing the epidemic while easing their most 91 restrictive quarantine measures. Here we investigate COVID-19 epidemiology in the 92 Philippines and the effectiveness and sensitivity to microdistancing policies. The Philippines is a LMIC that has had over 459,000 confirmed cases and more than 8,500 deaths as of 20th 93 94 December 2020, although control has improved over recent months (15). In the continued absence of a vaccine, various NPIs have been implemented in the country, with the timing 95 and level of restriction varying by region. The NPIs implemented include different levels of 96

97	community quarantines, including school closures. Since October 2020, the Philippines has
98	shifted from a focus on community quarantine orders towards greater reliance on Minimum
99	Health Standards (MHS) policies, requiring the use of face coverings, physical distancing,
100	and hand hygiene. To gain insights into the Philippines epidemic, we present a data-driven
101	COVID-19 model, which includes age structure, heterogeneous contact patterns, time-
102	varying testing rates, and macro- and microdistancing. We use this model to 1) estimate
103	epidemiological parameters for COVID-19 in a LMIC for comparison with HIC; 2) consider
104	the past effect of NPIs; and 3) create scenarios for various policy changes and estimate
105	associated risk of disease resurgence.

106 METHODS

107 Model

108 We developed an age-structured deterministic compartmental model of SARS-CoV-2 109 transmission, the virus that causes COVID-19, to model disease spread at the national level, 110 and for three highly affected regions: Calabarzon (Region IV-A), Central Visayas (Region 111 VII), and the National Capital Region (Metro Manila). We included six sequential 112 compartments in the model representing susceptible, non-infectious exposed, infectious 113 exposed, early actively infectious, late actively infectious, and recovered/removed persons 114 (Fig. 1A), and stratified the infectious compartments by detection status and disease severity 115 (Fig. 1B). To account for age-dependent disease processes, we stratified all model 116 compartments by age group using 5-year age bands from birth to \geq 75 years of age and 117 allowed the proportion symptomatic, susceptibility to infection, infection fatality rate, and the 118 probability of hospitalisation to differ by age group. We used the 2020 projected population distribution by age from the Philippines Statistics Authority for the total population sizes of 119 120 each age group, which we then split among compartments (Figs. 1C, S1). To introduce

heterogeneous mixing by age, we incorporated synthetic mixing matrices developed by Prem *et al.* 2017 (16) (Fig. 1D).

124 We considered several inter-compartmental transition rates to represent epidemiologically 125 important processes. To estimate disease incidence, detected cases, hospitalisation, and ICU 126 admission rates, we quantified transitions between different exposed and infectious 127 compartments within the model (Fig. 1A-B, supplemental material). To calculate a modelled case detection rate, we calculated the proportion of symptomatic cases that were detected 128 129 (Fig. 1B). We related the case detection rate (CDR, equation 1) to the daily number of per capita tests performed using an exponential function, under the assumption that a certain 130 testing rate is associated with a specific case detection rate (with this parameter varied in 131 132 calibration):

134 Non-pharmaceutical interventions

135 We simulated community quarantines (e.g., business closures and working from home) by varying the relative contribution of four locations to an overall age-specific dynamic mixing 136 137 matrix (Fig. 1E). Using Google mobility data (https://www.google.com/covid19/mobility/), we scaled the household contribution to the matrix with residential mobility; the work 138 139 contribution with workplace mobility; and the contribution from other locations (contacts 140 outside of schools, homes, and work) with average mobility from all other Google mobility locations (Fig. 1E). We simulated school closures by scaling school contribution according to 141 142 the proportion of children attending schools under relevant policies. In the Philippines, school 143 closures started in mid-March 2020 in the most highly affected areas and schools have remained closed throughout the country through December 2020. 144

We simulated MHS as a scaled function that proportionally reduces the probability of transmission given contact (reducing the probability of an infected person passing on the infection and the probability of a contact being infected). We allowed the function to scale from zero when we assumed minimal compliance with MHS (15th August 2020) to a maximum value estimated by the calibration process (described below) when MHS was widely adopted (15th November 2020).

152 Calibration

153

154 We calibrated the model to data to reproduce local COVID-19 dynamics and compare estimations of key epidemiological parameters with prior estimates from HIC (Table 1). We 155 156 used three sources of local data as calibration targets; daily confirmed cases (determined by RT-PCR) and the most recent estimate of ICU occupancy and cumulative deaths. We 157 158 prioritized confirmed cases in the calibration process because these data are considered the 159 highest quality in the Philippines for COVID-19 (based on expert opinion), while limiting the 160 use of ICU and mortality data to the most recent values, as the quality of these data improved 161 over time. To account for differences between weekday and weekend reporting, we smoothed 162 daily confirmed cases using a seven day moving average. We fit the model to the three calibration targets using an adaptive Metropolis algorithm (17) (Table 1; supplemental 163 164 material). For the prior distributions of epidemiological calibration parameters, we used 165 uniform priors for highly uncertain quantities and truncated normal distributions for quantities informed by epidemiological evidence (Table 1; supplemental material). To 166 167 account for potential differences between HIC and LMIC, we included "adjuster" parameters 168 to modify the proportion of symptomatic individuals, proportion of symptomatic individuals hospitalised, and the infection fatality rate as the prior distributions are based on estimates 169

170 from HIC. The adjuster values are multiplicative factors applied to the odds ratio, where an adjuster value of one would indicate no adjustment is needed, a value below one would 171 indicate the parameter is lower in the Philippines, and a value above one would indicate the 172 173 parameter is higher in the Philippines. To calibrate the model, we ran seven independent 174 chains with approximately 1000 iterations per chain and discarded the first 200 iterations as 175 burn-in. We used Latin Hypercube Sampling across the multidimensional parameter space to 176 select initial parameter conditions. We structured the model, calibration data, likelihood 177 function, and priors identically for the national and regional models. We report the model 178 outputs as median values with 25-75 and 2.5-97.5 percentiles to show uncertainty.

180 Scenarios

181 We ran scenarios with different policy changes to estimate future COVID-19 transmission and potential for disease resurgence with easing different interventions. The baseline scenario 182 183 held mobility and MHS constant based on the most recent date of data (8th December 2020) 184 through the end of the scenario period (1st June 2021). All scenarios began on 10th 185 December 2020, with the exception of school reopenings, which began on 10th January 2021. 186 We simulated 50% return of onsite workers by increasing the relative contribution of workplace mobility in the overall age-specific mixing matrix from current levels to current 187 188 levels plus half the difference between current workplace mobility and pre-COVID 189 workplace mobility. We simulated school reopenings by scaling school contribution in the 190 overall age-specific mixing matrix from zero to one on the scenario start date (10th January 191 2021) to reflect full school attendance. To estimate the effect of easing MHS by 50, 70, and 100%, we decreased the microdistancing function, which reduces the values of all elements 192 193 of the mixing matrices by a certain proportion, to 0.5, 0.3, and 0.0, respectively. We report 194 the scenarios as median values with 25-75 and $2 \cdot 5 - 97 \cdot 5$ percentiles to show uncertainty.

195 RESULTS

196 Epidemiological fit

197

198 The model reproduced national and regional trends in confirmed cases, hospitalisations, and 199 deaths when incorporating changes in movement and adherence to MHS. The model fit was 200 considerably better with the inclusion of both community quarantine-adjusted movement and 201 adherence to MHS compared with a counterfactual scenario that only included community 202 quarantines (Figs. 2, S5-7). These results suggest that if MHS had not been implemented, 203 there would have likely been eight times as many cases at the outbreak peak. The four 204 calibrated models (national and three regional models) show good fit to confirmed cases 205 (Figs. 2-3). Additionally, the Central Visayas and the National Capital Region models show good fit to cumulative deaths and ICU occupancy, while the national and Calabarzon models 206 overpredict these two indicators (Figs. 4, S8-10). We estimated an attack rate of 207 208 approximately 12% (95% CI = 4-61%) as of 9th December 2020 (Fig. 4). 209 Parameter and case detection estimation 210 211 We estimated key epidemiological parameters and transition rates (Table 1; Fig. S11). The 212 213 posterior distribution of the incubation period, infectious period, and baseline probability of transmission per contact did not differ markedly from their prior distributions, obtained from 214 215 the literature. We incorporated parameters to adjust the proportion of symptomatic 216 individuals, the proportion of symptomatic individuals hospitalised, and the infection fatality

217 rate from the baseline values and estimated all three adjuster parameters at approximately

218 one, indicating no modification was needed. The maximum effect of MHS was estimated at

around 0.23 (95% CI = 0.15 - 0.32) with a tight posterior distribution (Fig. S11), suggesting

that MHS has reduced the risk of transmission per contact by about 23%. The model case

detection was estimated at approximately 11 to 25% in the Philippines (Fig. S12), although
the posterior distribution of this value was broad (Fig. S11).

224 Scenario projections

225 We projected transmission in the near term under a range of possible scenarios and show that 226 epidemic trajectories are highly sensitive to compliance with MHS. Moreover, allowing 227 home workers to return onsite while maintaining MHS is estimated to have limited impact on overall incidence, hospital occupancy, and mortality (Fig. 5). If current conditions are carried 228 229 forward, transmission is projected to continue at low levels and therefore should not 230 overwhelm hospital capacity or lead to excessive deaths. Allowing students to return to 231 school is estimated to result in a moderate increase in incidence, hospital occupancy, and deaths. Reducing the effectiveness of MHS by 50% is projected to lead to a steady increase in 232 233 burden, whereas reducing the effectiveness of MHS by 70% or 100% is projected to lead to a 234 major resurgence in disease rates, associated hospitalisations, and deaths.

236 DISCUSSION

Younger age distributions and more intergenerational contacts, combined with changes in 237 238 mobility and personal protective behaviors, appear to explain why the Philippines has 239 sustained a relatively less severe COVID-19 outbreak than high income countries (HIC). The 240 results from this study provide evidence that COVID-19 epidemiology in the Philippines is 241 not inherently different from HIC. For instance, hospitalisations and infection fatality rates do 242 not appear different from HIC, as would have been expected if healthcare capacity limitations 243 and high prevalence of comorbidities drive disease severity and mortality rates; these findings 244 support studies in some other LMIC (e.g., India; 18) but not others where excess deaths were considered (e.g., Brazil; 19). This highlights the importance of strong surveillance and 245

246 reporting systems for understanding COVID-19 epidemiology. Younger populations typical of LMIC may reduce disease burden in two ways: 1) a proportionally smaller percent of the 247 248 population is elderly (compared with HIC) and at highest risk of severe disease and mortality 249 from COVID-19 (1,2); and 2) those who survive to old age are often of higher socioeconomic 250 status and may have a disproportionately lower infection risk compared with the general 251 population (20). More intergenerational contacts in LMIC may also lower disease burden 252 because elderly people often reside with family rather than in aged-care facilities, which have driven outbreak clusters in many HIC (e.g., 21). An important finding of this study is that 253 254 adherence to MHS is largely responsible for limiting transmission in the Philippines while 255 gradually easing quarantines. These results were consistent across regions that span a wide population density gradient, suggesting that this approach could also be effective in other 256 257 similar settings. These types of personal protective measures will likely continue to be needed 258 after a vaccine becomes available, as distribution may take months or years, and vaccination 259 may not prevent onward transmission, and herd immunity may be difficult to attain in many 260 countries (22).

261

Current transmission trends in the Philippines (as of December 2020) indicate that the 262 263 country is now effectively suppressing COVID-19, but disease resurgence remains a major 264 threat without a widely available vaccine. Confirmed cases have decreased across the 265 Philippines, plateauing at approximately 1,500 confirmed cases per day in the last few 266 months of 2020, leaving most healthcare facilities with ample ICU capacity. As people resume semi-normal activities while maintaining MHS, low levels of transmission are likely 267 268 to continue, but should not overwhelm the healthcare system. The results of this study 269 support continuing a suppression approach as a bridge to broad-scale vaccination. To support this effort, we provided real-time weekly updates of the model outputs directly to policy-270

271 makers through the Department of Health COVID-19 Philippines Local Government Units Monitoring Platform (https://fassster.ehealth.ph/covid19/). The scenarios we considered in 272 this study indicate that relaxing societal restrictions like work-from-home orders and school 273 274 closures are not predicted to cause substantial disease resurgence. However, we acknowledge 275 that even with low levels of transmission and compliance with personal protective measures, 276 school outbreaks can occur (e.g., 23). Despite these findings, low case detection (11-25%) 277 and percentage recovered (<15%) and high sensitivity to maintaining MHS could lead to disease resurgence. Limited testing is a major obstacle for the Philippines (24) and many 278 279 other LMIC and can hinder our understanding of how the epidemic is progressing and 280 associated response measures needed to prevent disease resurgence.

282 There are several important limitations relevant to interpreting the model results, including 283 modelling assumptions, data limitations, and uncertainty. Most epidemiological parameters for COVID-19 used in this study were estimated from HIC (or China). While we included 284 285 "adjuster" parameters to allow the symptomatic proportion, hospitalisation, and mortality 286 rates to vary for the Philippines (similar to 25), we assumed that other parameters were similar to HIC, which may be inaccurate. However, most parameter estimates appear 287 reasonable given previously reported COVID-19 epidemiology in the Philippines (26). When 288 289 more data becomes available from the Philippines or similar settings, the current model can 290 be updated with new parameter values. Data issues made modelling and understanding the 291 epidemic in the Philippines particularly challenging, although data quality has progressively improved through time. For example, additional ICU facilities were created specifically for 292 293 COVID-19 in the Philippines and were not required to report usage, likely affecting these 294 estimates, especially early in the epidemic. Similarly, daily deaths, which are often considered the most reliable epidemic indicator internationally, have fluctuated markedly 295

296 over the course of the epidemic, often peaking at times that appear contradictory to patterns of confirmed cases. Although reporting of daily deaths appears unreliable, cumulative deaths 297 align reasonably well with the model projections of mortality without significant 298 299 modification to the internationally estimated infection-fatality rate. Finally, there is 300 uncertainty around all model parameters, with some parameters less well constrained than 301 others (e.g., case detection rate), which highlights the need for more epidemiological 302 information. Future studies could build on this effort by including new, more robust data 303 sources for model parameters and calibration targets. 304

305 CONCLUSION

306 One of the most critical issues facing countries around the world is determining the best 307 strategy for successfully easing lockdown measures without triggering disease resurgence. 308 More than 188 countries have been affected by COVID-19 with apparently less severe impacts in LMIC compared with HIC. Our results suggest that COVID-19 epidemiology is 309 310 similar in the Philippines, while the differences in impacts are likely driven by differences in 311 age and contact structures, with MHS also playing a substantial role in mitigating the 312 outbreak. The Philippines has experienced one of the largest outbreaks of COVID-19 in the 313 Western Pacific Region but also provides an approach that could help other countries relax 314 interventions more safely, which is becoming increasingly important as Northern Hemisphere 315 countries enter winter, when influenza-like illnesses tend to peak.

- 370 through time. The MHS effect value is squared in the model to account for the reduction in
- 371 the probability of an infected person passing on the infection and the probability of a contact
