12 Abstract

- 13 UK 'Lockdown' measures introduced in March 2020 aimed to mitigate the spread of Covid-19.
- 14 Although seeking healthcare was still permitted within restrictions, paediatric emergency
- 15 department attendances reduced dramatically and led to concern over risks caused by delayed
- 16 presentation. Our aim was to gain insight into healthcare decisions faced by parents during the first
- 17 wave of the Covid-19 pandemic and to understand if use of urgent healthcare, self-care, and
- 18 information needs differed during lockdown as well as how parents perceived risks of Covid-19.
- 19 We undertook qualitative telephone interviews with a purposive sample of parents living in the
- 20 North East of England recruited through online advertising. We used a semi-structured topic guide
- 21 to explore past and current healthcare use, perceptions of risk and the impact of the pandemic on
- 22 healthcare decisions. Interviews were transcribed and analysed using Thematic Analysis.
- 23 Three major themes were identified which concerned (i) how parents made sense of risks posed to,
- 24 and by their children, (ii) understanding information regarding health services and (iii) attempting to
- 25 make the right decision. These themes contribute to the understanding of the initial impact of Covid-
- 26 19 and associated restrictions on parental decisions about urgent healthcare for children. These
- 27 findings are important to consider when planning for potential future public health emergencies but
- 28 also in the wider context of encouraging appropriate use of urgent healthcare.

38 Introduction

- 39 Covid-19 cases were first identified in the UK in January 2020 after which they increased
- 40 exponentially. This was followed by a series of government control actions aimed at mitigating the
- 41 spread of the virus which included the closure of non-essential services, followed shortly by a
- 42 national "lockdown"(1).
- 43 These measures including stringent and legally-enforceable social-distancing rules, played an
- 44 important role in controlling Covid-19 in the UK from 23 March 2020 when the core government
- 45 message was to "Stay home, Protect the NHS, Save Lives" (2, 3). This messaging varied throughout
- 46 the trajectory of the pandemic as lockdown restrictions were eased and tightened in response to
- 47 infection rates.
- 48 While seeking healthcare was always exempt from these control measures, in the weeks that
- 49 followed the first national lockdown, there was a sudden and substantial reduction in paediatric
- 50 emergency department attendances (4). Hypothesised explanations included: 1) reduced burden of
- 51 infectious disease – perhaps due to reduced social mixing, 2) fear of accessing hospital, and 3)
- 52 increased self-care at home – perhaps due to reduced school and workplace attendance by children
- 53 and parents (5, 6).
- 54 In April 2020, the Royal College of Paediatrics & Child Health expressed concern over reports of
- 55 delayed hospital attendance leading to a small number of children becoming unwell or dying (7). A
- 56 survey of 4,075 UK Paediatricians (>90% of all UK Paediatricians) reported nine deaths with delay in
- 57 presentation as a possible contributing factor. Around a third of Paediatricians working in
- 58 Emergency Departments (ED)/Paediatric Assessment Units reported witnessing at least one delayed-
- 59 presentation (7). A recent qualitative study highlighted parental fear as a major factor in delaying
- 60 seeking healthcare for children (8).
- 61 We set out to understand parents 'experiences and views on the use of children's urgent healthcare
- 62 services during the first wave of the Covid-19 pandemic. Our objectives were: to understand if and
- 63 how urgent healthcare use, self-care and information needs differed during 'lockdown 'and to
- 64 consider parent perceptions of risks of Covid-19.

66 Methods

67 We adopted a pragmatic qualitative study design as we sought to understand an ongoing real-world 68 issue and we placed an emphasis on 'actionable learning' (9).

- 69 Ethical approval was granted by Newcastle University's Faculty of Medical Sciences Research Ethics 70 Committee (Ref: 1919/2812).

72 Participants and recruitment

- 73 Given the pace of change of the pandemic and associated restrictions, we aimed to collect data
- 74 rapidly. Accessing views of people who are *not* using a service is, by its nature, challenging; we
- 75 therefore sought to gain views from a more general sample of parents on using urgent healthcare
- 76 during the pandemic, being aware that this sample was likely to include people who had and had not
- 77 needed to make urgent healthcare decisions during the pandemic. From 22nd May 2020, we
- 78 recruited parents of children aged 0-8 years living in the North-East of England using a written

- 79 advertisement containing a web link circulated via social media, charity partners, online forums and
- 80 public involvement groups. On clicking this link, participants were asked to complete a consent form
- 81 and a short questionnaire including demographics, previous use of children's emergency services
- 82 and willingness to use these during the pandemic, willingness to participate in an interview, and
- 83 contact details. We purposively sampled based on responses to obtain a maximum variation sample.
- 84 Potential participants were contacted by phone or e-mail. The study rationale was discussed, any
- 85 questions answered and an electronic information sheet was e-mailed.
- 86 Digitally recorded telephone interviews were conducted by male and female researchers; a
- 87 postdoctoral qualitative researcher (MB), a Foundation Interim Year 1(RW) and an Intercalating
- 88 Medical Student (ST). RW and ST received supervision throughout the process. Interviewers
- 89 introduced themselves as members of the research team. Due to the closure of university buildings
- 90 and National regulations permitting leaving home for limited reasons during the data collection
- 91 period, it was not possible to obtain hard-copies of written consent and verbal consent was audio
- 92 recorded instead. We used a semi-structured topic guide including questions on: past and current
- 93 use of children's urgent healthcare and impact of the pandemic on healthcare decisions. The topic
- 94 guide was reviewed regularly to add questions and prompts to explore emerging areas of interest in
- 95 subsequent interviews. Recordings were transcribed verbatim by an external transcription company
- 96 and anonymised to ensure confidentiality. Researchers made field notes after each interview
- 97 summarising main points, reflections and considerations for topic guide refinement.

98 Data analysis

- 99 Data were analysed according to principles of thematic analysis (10). Analysis took place
- 100 concurrently with data collection with all team members involved. Regular team meetings were held
- 101 during the data collection period to review the topic guide, interview process and aid collective
- 102 familiarisation. Researcher fieldnotes fed into these discussions. A provisional coding framework,
- 103 using a mixture of inductive and deductive coding, was developed at whole team read-throughs of
- 104 two transcripts. MB, SB, ST and RW then individually applied this to two further transcripts each
- 105 before refining, agreeing a final framework and producing a codebook which included a brief
- 106 description of each code. This codebook was used to code all transcripts using NVivo 12. Coded data
- 107 were reviewed by all team members individually and discussed before final themes and subthemes
- 108 were agreed. The decision to cease recruitment was made collectively by the research team when it
- 109 was considered that saturation had been reached in terms of additional interviews not requiring
- 110 additional codes (11) or leading to any new themes(12).

112 Results

113 Sample

- 114 We received survey responses from 121 parents. We sampled purposively, based on respondents'
- 115 survey data regarding: age, sex, location, IMD decile, number and age of children, stated willingness
- 116 to use health services during the pandemic and use of healthcare during the pandemic.
- 117 Demographic composition of the sample was reviewed regularly in order to inform subsequent
- 118 invitations to participate in an interview. We approached 25 for interview, four of whom could not
- 119 be contacted after multiple attempts at different times of day. We obtained full informed consent
- 120 and carried out interviews with 21 parents between 29 May and 31 July 2020 lasting around 30
- 121 minutes each (Range: 18-49 minutes). Demographic information for interviewees is shown in Table
- 122

128 Findings

129 Parents raised a range of issues during interviews, with many describing a spectrum of intellectual 130 and emotional difficulties in interpreting information related to Covid-19, and their responsibilities 131 towards family and wider society. For some parents, this had been a particularly difficult period 132 whilst for others, the situation was less challenging to navigate. We identified three major themes 133 relating to risk, information, and decision-making, and provide illustrative quotes accompanied by 134 and IMD decile and the age of the participantsc hildren because these are both well known to 135 influence usage of emergency healthcare services (13). While the motivation for this research had 136 been to understand reasons for the reduction in Emergency Department (ED) use, it became clear 137 from the interviews that parents often referred more widely to services for acute medical conditions 138 which sometimes included healthcare routes such as GPs or walk-in centres.

139

140 Theme 1: Making sense of risk

141 Risk was a major topic in these interviews and was discussed at length by parents. This theme

142 describes parents' conceptualisation of risks related to Covid-19 at a point early on in the pandemic

143 and how these could impact decisions to seek care. Parents differentiated risk *to* children from

144 Covid-19 and the potential risk *from* children to the wider community through passing on the virus.

145 The first concerned the direct risk of harm to children from Covid-19; the second concerned the risk

146 that infected children posed to families and society. Parents also discussed these risks changing over

147 the course of the pandemic and how lockdown measures had the potential to modify risks of

148 requiring health services

- 149 Most parents appeared to regard the risk of their children being seriously affected through
- 150 contracting Covid-19 as small; often citing emerging information as underpinning this view:

- 151 I've read quite a bit about risk to children of coronavirus and so whilst I've still got 152 concern around it, my worry isn't particularly that my children will get it and get 153 *ill from it.* (Interview 3: IMD 3, children aged 10 and 7)
- 154 Views to the contrary were minimal in our data, although some emphasised that even though
- 155 emerging risk data around children were reassuring, this didn't stop them worrying. Parents
- 156 sometimes made reference to the fact that the virus was newly discovered and not fully understood:
- 157 in the back of my mind, it's not well known of what any of this virus is or who it attacks or 158 when, I don't know. It's just like, if I had the personal choice, I wouldn't be exposing myself or 159 *my family at any NHS [hospital], yes.* (Interview 5: IMD 3, child aged 1)
- 160 Parents described concerns that hospitals could be a source of infection. For example, being in a 161 confined space, with young children who were not able to socially distance. These perceptions were 162 described with reference to pre-Covid, as well as the use of EDs during the pandemic . A parent who 163 had used the ED during the early stages of the pandemic recounted how they perceived the physical 164 environment as creating a risk of contracting Covid-19:
- 165 So there was a tiny little waiting room and there was four, I think it was four other children, 166 maybe five other children plus one or two parents each in this tiny room... I'm like, "Could you 167 please open a window?" "No, we're not allowed, you have to stay in here. No, we're not 168 allowed to open a window." We spent four hours, I think. I realise that you didn't say 169 anything about the time, but we spent four hours in a tiny room with three or four other kids, 170 people coming and going, all potentially with Coronavirus. I think, if we were going to catch 171 it, that was probably our most risky bit of exposure in the waiting room. (Interview 2: IMD 9, 172 children aged 8, 4 and 1)
- 173 Although the opposite was described by another parent who felt reassured that the physical 174 environment in a hospital created minimal risk of contracting Covid-19:
- 175 I mean I'm reassured now that I've been, and I've seen how well everything was managed 176 and I mean to be honest, the baby has been referred to *Name of hospital 1*. So, I'm a lot 177 more relaxed about having to take her since being to *Hospital 2* and *Hospital 3*. So, 178 obviously it felt really safe and it felt really clean. (Interview 15: IMD 10, children aged 8, 4 179 and 1)
- 180 Although these data highlight a range of experiences, they suggest that previous experience of 181 emergency health services as well as those during the pandemic had the potential to reassure or 182 cause concern amongst parents. As time progressed, parents perceived that hospitals were likely to
- 183 become better able to manage these risks:
- 184 *I would not be particularly worried about them catching Covid in paediatric* 185 A&E...I think that that would probably not be a high risk situation for them. I 186 imagine now that the hospital is so slick (Interview 4: IMD 10, children aged 6 and 187 3)
- 188 Although most of the discussion of risk to children centred on the potential for them to contract the 189 virus, another issue raised by a parent was that Covid-19 precautions themselves had the potential 190 to be distressing for young children; highlighting the impact of the use of personal protective
- 191 equipment by clinical staff:

192 The biggest impact was on the ward, because *name of son* being three and a half, he's 193 been into hospital before, we had to wait obviously in the bay and he was so, so upset and 194 distressed by the masks. (Interview 21: IMD 5, children aged 9, 7 and 3)

195 Although parents described concerns about their children catching Covid-19 and some worried 196 about the associated risks, these seemed generally to be understood as fairly minimal. On the other 197 hand, parents described worrying about the impact of their child passing on Covid-19 to others.

- 198 Parents described concern that their child could pass the virus on to elderly relatives or the wider 199 community:
- 200 It would be foolish for me to say I don't think there's any danger at all [to my child 201 from Covid-19] but, yes, more that you want to prevent the spread as much as 202 possible (Interview 10: IMD missing, children aged 10 and 8)

203 Some parents spoke of concerns that their child could catch Covid-19 in an ED then potentially pass 204 it on to the wider community. One parent described concern about spreading the virus as well as the 205 implications of self-isolating:

- 206 My concerns would be that any of us could catch it, but I'm not really worried about that. I'd 207 just be more worried about spreading it to the outer community and the implications like of 208 everyone having to self-isolate. (Interview 7: IMD missing, children aged 4 and 2)
- 209 Similarly, a clinical environment could be seen as a potential place where a child could pass the virus 210 to someone vulnerable:
- 211 I'd be reluctant for example to take them into a medical situation in case they were in 212 contact with people who were more vulnerable. (Interview 10: IMD missing, children aged 10 213 and 8)
- 214 Although not directly related to risks of the virus, a further point was made by a small number of
- 215 parents regarding how lockdown measures had the potential to change the likelihood of requiring

216 health services as their children were not in contact with other children and engaging in fewer

- 217 physical activities with potential to cause injuries:
- 218 So, the fact that they weren't interacting, they weren't picking up these colds, they were 219 healthy overall and definitely led to fewer illnesses. And also, the lockdown in general... not 220 the specific nursery, but the fact we weren't going to play parks and running around and 221 stuff as well there was a lot less bruises, cuts, all the things that come with children playing 222 around. (Interview 17, IMD missing, children aged 3 and 1)
- 223 Theme 2: Interpreting information on emergency health services
- 224 This theme focuses on how parents interpreted information about health services during the
- 225 pandemic. Different types of information were described including government public health advice
- 226 as well as the internet and social media. Parents also spoke about misinformation about Covid-19
- 227 procedures in place in EDs.
- 228 Parents described how information, guidance and rules influenced their thoughts and actions on
- 229 taking their child/children to the ED during this period. Most understood that emergency health 230 services remained available throughout:

231 I think there's been enough encouragement that if you've got an unwell child they 232 should be seen. I certainly haven't seen anything to say otherwise. (Interview 17, 233 IMD missing, children aged 3 and 1)

234 However, this was not universal. Several parents interpreted the 'Stay home, Protect the NHS, Save 235 lives 'as a clear signal that the NHS should not be used at all:

- 236 'protect the NHS' had that impact, if there's any worries apart from Covid then 237 stay away, quite a blunt message. (Interview 3: IMD 3, children aged 10 and 7)
- 238 Other parents described the existence of misinformation online, for example one had viewed

239 information stating that children would be separated from parents if they were suspected of having 240 Covid-19 and the potential for this to cause worry.

- 241 There's lots of stuff going round on mums' groups and things online that say, if your child 242 develops Coronavirus symptoms, they will be taken by themselves in an ambulance....and all 243 this stuff which isn't helpful but I don't think that's the case. I don't think hospitals want 244 loads of unaccompanied children loose (Interview 2: IMD 9, children aged 8, 4 and 1)
- 245 While this participant identified this as likely to be untrue, another made reference to maternity 246 services and how the nature of Covid-related service changes was unclear:
- 247 But there's a lot of fear, I think, amongst pregnant women about kind of how birth works 248 and, obviously, not being able to have your partner in. Or the procedure, whether you would 249 have to wear a mask for it and all that sort of stuff. We were lucky enough to have *name of 250 child* just before that happened. But kind of, I wanted to send my husband home for the 251 night to sleep after we had the baby, but I said to him I was scared that he wouldn't be 252 allowed to come back in because the situation was changing so rapidly. (Interview 14: IMD 6, 253 child aged under 1)
- 254 This was echoed by another participant who felt that, although there was good health information 255 available online from the NHS, it wasn't clear how the hospitals were currently functioning under 256 Covid-19 restrictions:
- 257 As I said, the NHS quidance online is really good. If you really want to go and find stuff 258 there's plenty of things available. In terms of what my children are like and how they're 259 doing, I don't feel that there's a lack of information. I just think there's a lack of publicity 260 about what it's like in hospitals at the moment. (Interview 10: IMD missing, children aged 10 261 and 8)
- 262

263 264 Theme 3: Making the right decision

- 265 This theme describes ways in which parents made decisions regarding the use of emergency 266 healthcare for their children. Parents described using their judgement to balance risks and also their 267 desire to behave responsibly and in line with government guidance. Parents who had made 268 healthcare decisions during the pandemic described and reflected on these choices while for others 269 this was a hypothetical scenario.
- 270 All of those who had used the ED during the pandemic had been advised to attend after seeking
- 271 advice from the NHS 111 telephone line. One parent described seeking emergency care due to
- 272 perceiving that the condition was not something that they could manage themselves:

- 273 If it had been just a finger or a cut or something, I probably would have been able 274 to deal with it myself but with it being a head injury I wanted him checked out 275 properly by a professional to make sure that there was no concussion or anything 276 going on. (Interview 13, IMD 6, children aged 9, 5 and under 1)
- 277 While it was clear to most parents that emergency services were available if needed, some 278 confusion was sown by lack of access to other types of NHS care, for example a parent of a newborn 279 reported difficulty accessing healthcare professionals which meant that they did not access any
- 280 services:
- 281 And then with lockdown kind of everybody thought we should be seeing somebody, but 282 nobody wanted it to be them...if that makes sense. So, we kind of just muddled through, 283 basically. And still haven't really had him [child] weighed but are just kind of using our own 284 assessment, which still just feels a little bit like... it's our first baby, so not sure if we're doing 285 things right or not essentially. (Interview 14: IMD 6, child aged under 1)
- 286 Parents described accessing emergency services only when it was deemed absolutely necessary 287 although some highlighted that this approach was no different with their pre-pandemic practice:
- 288 I don't think the criteria would have been very different, I generally would be quite careful 289 about what situations would be appropriate to take them to A&E anyway. (Interview 3: IMD 290 3, children aged 10 and 7)
- 291 Indeed, most parents emphasised that they would not avoid seeking emergency care if their child 292 needed it, regardless of the pandemic. One parent described being so focused on getting medical 293 attention for their child that they didn't think about Covid-19:
- 294 I had kind of forgotten about it [Covid-19] and that sounds really strange but I had a son 295 who, for all intents and purposes, had received a bite from a dog, needed to go and get some 296 medical attention and that was it. (Interview 18: IMD 5, children aged 5 and 1)
- 297 Parents argued that not seeking care for their child was a greater concern than Covid-19.
- 298 I think the risk of not seeking help when you need it is far greater than the risk of being 299 exposed to the Covid virus. (Interview 1: IMD 7, children aged 6 and 1)

300 While for some, decision making was described as being straightforward, other participants referred 301 to situations they had encountered during the pandemic where they found it difficult to decide on

- 302 the best course of action:
- 303 It was a very sort of, 'do I take him, do I not'...[but] I would never forgive myself if 304 I didn't take him. (Interview 13, IMD 6, children aged 9, 5 and under 1)

305 Several parents said that they avoided seeking healthcare for their children during lockdown. One 306 gave a specific example of delaying seeking care to avoid pressurising healthcare professionals and 307 services:

308 That's another thing with my 18 month old, I've actually put off taking her to the 309 GP for quite a while because she's got a limp on one leg and I took her, it will be 310 two weeks on Monday, she went to the GP and I wish I took her sooner but with 311 everything going on, you didn't want to put any extra pressure on the doctors. 312 (Interview 15: IMD 10, children aged 8, 4 and 1)

- 313 Another parent reported deciding against making a follow up appointment after receiving
- 314 a visit from a paramedic, describing a mixture of concerns about availability of
- 315 appointments, but also feeling that there were other patients who may be in greater need:
- 316 ...were aware that the doctors was probably, massively overly used at that point because of 317 all this Covid so we were like we're not going to get an appointment or, even if we do, there's 318 probably somebody who needs it more than us. (Interview 16: IMD 10, children aged 4 and 1)
- 319
- 320 Others echoed this sentiment of increased caution in accessing emergency care; one parent
- 321 described how the pandemic had impacted their decision making criteria in terms of 'raising the
- 322 bar 'for when to seek care, also describing how they would take efforts to self-manage at home:
- 323 That's the big thing, trying to do what you can at home, hoping that we're putting less 324 pressure on the service and then yes, just raising the bar. Do what we can at home so we're 325 less likely to, A, infect ourselves from being there and B, put pressure on the service, yes. 326 Definitely raising the bar. (Interview 2: IMD 9, children aged 8, 4 and 1)
- 327 Similarly, one parent whose child had an existing medical condition and was very accustomed to 328 attending the ED, described trying to find alternatives to avoid having to attend:
- 329 I tried ringing staff earlier on in the day, nobody got back to me because obviously there's a 330 lot going on and I haven't kept on. So, normally I would have just gone straight in, gone into 331 A&E and I just didn't in this instance. I just kept ringing round and round and round until I got 332 hold of a consultant to talk to somebody. (Interview 6: IMD 5, children aged 13 and 9)
- 333 Several parents emphasised the value of accessing health advice prior to attending in-person 334 emergency services, frequently citing NHS 111 but also GPs or opinions of friends in healthcare roles. 335 This was important in providing reassurance that parents were taking the correct course of action:
- 336 Yes, so I used 111 when obviously *name of son* was poorly and I have used it in the past 337 but you know what, I think the times I've used it recently has always been about his viral 338 wheeze, when generally you're not quite happy with his breathing, you want that advice and 339 then they say, actually yes what you're telling me, you probably need to come in. But both 340 instances have been when the GP has not been open, I would probably go to the GP first if 341 they were open and if they weren't, then obviously I wouldn't hesitate to call 111. (Interview 342 21: IMD 5, children aged 9, 7 and 3)
- 343 While no one in our sample described being completely unwilling to using emergency services, one 344 participant described a friend who decided against taking their child for emergency treatment
- 345 because of Covid-19 concerns:
- 346 A friend's child slipped in the bath, he cut his chin open and there as blood all over. She said, 347 "I'm not taking him to the hospital, the risk of Coronavirus, I'm not taking him." So she 348 cleaned his face up and then just got some Elastoplast, whatever, held it together and just 349 made her own little stitchy, sticky things to close the gap. (Interview 2: IMD 9, children aged 350 8, 4 and 1)

354 Discussion

355 Our data provide a snapshot of views of a group of parents during the first wave of the Covid-19 356 pandemic in the UK. This research is part of a growing body of literature which describes short and

357 longer-term concerns about the impact of Covid-19 on the health and wellbeing of children (14-19)

358 While the rapidly changing landscape with regard to government policy and messaging provides a 359 challenging context in which to interpret and report such findings, we believe they are important in 360 contributing towards an understanding of parents' views on accessing emergency healthcare at the 361 beginning of a pandemic and how these views may be impacted by government policy, public health 362 information and messaging. They are also important in terms of ensuring that the learning from the 363 Covid pandemic is used to inform future emergency planning, and access to emergency healthcare

- 364 in normal times.
- 365 We have described how parents weighed up competing information sources, perceptions of risk to
- 366 themselves and to their children, government guidelines and rules, and a desire to reduce burden on
- 367 the NHS, when considering whether to seek emergency healthcare services for their children during
- 368 the Covid-19 pandemic. Whilst parents usually said they would seek care if it was needed, there
- 369 were examples where this was not the case. Parents were less concerned that their child might
- 370 become ill from hospital-acquired Covid-19 than their potential to become infected and then infect
- 371 others. There was considerable divergence in our sample regarding whether the "Stay at Home" and
- 372 "Protect the NHS" government messaging encompassed seeking emergency healthcare.
- 373 Our findings provide explanations for some of the large reduction in emergency healthcare
- 374 utilisation seen in EDs, and complement British Paediatric Surveillance Unit data describing
- 375 perceptions of delayed-presentation to hospital among British paediatricians (5).

376 Previous studies have identified gaps in the ways that parents make decisions about seeking 377 emergency-healthcare for children, with one group producing a patient-information leaflet to 378 address this problem (20). Hesitancy in seeking healthcare during Covid-19 has been previously 379 described in children with cancer (21) and in the general population. In a survey of 1,044 parents in 380 Ireland, 22% of those identifying a need for emergency healthcare for their children did not seek it 381 (22). Others have sought to understand the views of parents accessing vaccination for young 382 children, with parents needing to weigh up multiple competing factors (23), similar to the process 383 described by parents in our study. A French study published before the pandemic described six 384 motives for parents attending the ED, finding that parents were serious and goal-orientated in their 385 seeking of this healthcare (24). Despite arguments to the contrary from professionals, parents would 386 be unlikely to agree that visits for apparent minor-illness were 'inappropriate '(24). Our findings are 387 in accordance; parents took their decision of whether and how to seek healthcare incredibly 388 seriously and described ways in which they tried to reduce healthcare seeking during the pandemic. 389 A questionnaire-based project in Ireland attempted to answer similar questions to our study; in 390 addition to our shared findings of misinterpretation of the 'Stay at home 'messaging and perception 391 of risk, this study reported the importance of parental stress, measured using the stress subscale of 392 the Depression Anxiety Stress Scale (25).

393 Our study adds to this body of literature by describing the views of parents directly and exploring 394 decision-making around seeking urgent care at the beginning of the Covid-19 pandemic. Interviews 395 were done on the telephone, minimising participant inconvenience and maintaining social 396 distancing. One potential limitation is that we did not interview children, who are often active 397 partners in making some of these decisions. The study population was relatively small, and

- 398 represents those with motivation to participate, rather than the whole population. The sample was
- 399 also skewed to a less deprived demographic than the general population. Respondent validation
- 400 methods may have been helpful in ensuring that our interpretation of data were correct from a
- 401 participant perspective.
- 402 Our findings have several implications for providers of paediatric emergency healthcare services,
- 403 both during the current pandemic and in future emergency planning in times of crisis. First,
- 404 providers should recognise the complex decision-making processes that parents perform in
- 405 determining whether and when to seek help. As discussed, this process was likely to have been
- 406 strongly influenced by national Covid-19 messaging. Local providers are well placed to understand
- 407 specific needs of their communities, and provide crucial local context to broad national messaging;
- 408 these providers could consider developing media-messaging, for example via social-media platforms,
- 409 targeted locally to reassure parents. We have discussed the internal 'threshold 'that parents
- 410 described having to reach in order to seek care during the pandemic. This metaphor might also be
- useful for organisations attempting to reduce emergency attendances in other contexts, for example 411
- 412 by redirecting to other elements of the healthcare system.
- 413 Future research should attempt to identify specific groups who are less likely to attend when
- 414 required, so that strategies to optimise use of emergency healthcare services, whilst avoiding harm,
- 415 can be implemented.
- 416 " Stay at home" messages have been used at several points during this pandemic, and may be used
- 417 again in future disease outbreaks. This research suggests that this messaging may have led to
- 418 adverse consequences, the impacts of which require further study. At the very least, we suggest that
- 419 such messaging should be accompanied by clear statements that seeking emergency healthcare
- 420 should always be prioritised. In a post-pandemic landscape, this study may be viewed as part of a
- 421 wider body of literature concerned with longstanding issues of supporting families to make decisions
- 422 regarding appropriate use of health services.
