# 2 Combining Indoor Positioning Using Wi-Fi Round-trip Time with Dust Measurement in the

### 3 Field of Occupational Health

# 27 Abstract

28	[Objectives] The measurement of personal exposure has been attracting increased attention for the
29	control of hazardous substances. Although the combination of location information and personal
30	exposure is considered highly useful, to-this-date, no simple or highly accurate indoor positioning
31	method has been presented. Recently, Wi-Fi round-trip time (RTT) has attracted scientific attention
32	as a highly accurate indoor positioning method. In this study, we investigated the possibility of the
33	use of a combination of this indoor positioning method and small-dust sensors. [Methods] We
34	measured indoor positioning and dust concentration three times during a walk in a simulated factory.
35	A wearable particle monitor was worn on both upper arms, and a smartphone was attached to the
36	helmet for positioning. An ultrasonic humidifier was used to spray sodium chloride solution in the
37	factory. The measurements were conducted three times on different routes on foot (Experiment A, B,
38	C). [Results] In indoor positioning, the error percentages, i.e., measurements that were outside the
39	correct measurement area were 7% (49 s/700 s) in Experiment A, 2.3% (15 s/660 s) in Experiment B,
40	and 7.8% (50 s/645 s) in Experiment C. The dust measurements were also taken without interruption.
41	A heat map was created based on the results of both measurements. [Conclusions] Wi-Fi RTT was
42	able to implement indoor positioning with high accuracy. Thus, the combination of indoor
43	positioning and various sensors can be considered useful for occupational health.

## 52 Background

53	In Japan, dust exposure is assessed by working environment measurements. There are some
54	problems with this method, such as the fact that it does not always reflect the exposure status of
55	workers when they work while moving. Therefore, an amendment to the Working Environment
56	Measurement Standards has been planned to allow personal exposure measurements instead of
57	conventional working environment measurements for some hazardous substances. Personal exposure
58	monitoring is, thus, expected to be used at workplaces where it has been difficult to measure
59	hazardous substances, such as locations where a) temporary or short-term work was conducted, b)
60	source of dust was moving, or c) where work occurred outdoors. Although dust is not subject to
61	personal exposure measurement by law, recent advances in sensor technology have led to the release
62	of compact PM2.5 sensors. These sensors were originally developed for the measurement of air
63	quality, but we believe that they can also be used for the evaluation of personal exposure to dust.
64	Therefore, we developed a wearable particle monitor (WPM), which uses a commercial sensor
65	(HPMA115C0-003, Honeywell International, Inc., New Jersey). Even though the sensor was not
66	calibrated based on strict protocols, the sensor's module (manufactured by Honeywell) has been
67	reported to have a certain level of accuracy. <sup>1</sup> Given that this product has not been officially
68	calibrated, it cannot be used for working environment measurements.

69	When conducting personal exposure measurements, it is necessary to record actions and
70	observations. <sup>2</sup> However, recording accurate records and observations while conducting
71	measurements is not easy, and requires the assignment of a full-time observer. Given that the details
72	of the work may correspond to the location of the worker, recording the location information of the
73	worker may help the recording of the work. Global Navigation Satellite System (GNSS), represented
74	by the Global Positioning System (GPS), is the standard technology for outdoor positioning.
75	However, for indoor positioning, there is no standard technology such as the GNSS for outdoor
76	positioning because the satellite signal cannot be received indoors. Instead, there are several
77	nonstandard methods, such as Bluetooth low-energy beacons, <sup>3, 4, 5</sup> Wi-Fi signals, <sup>4, 6</sup> and various
78	sensor devices. <sup>4</sup> However, these methods have problems in terms of accuracy, and various measures
79	have been proposed to improve their accuracy characteristics. In 2016, the Wi-Fi round-trip time
80	(RTT) distance measurement method was standardized to IEEE802.11mc as a method with higher
81	accuracy than these methods. <sup>7</sup> Using this standard method, distance can be measured with a high
82	accuracy by calculating the distance from the arrival time of radio waves, instead of estimating the
83	distance from the radio wave strength, as in the conventional methods. The Wi-Fi RTT protocol
84	enables positioning without synchronizing the clocks of the two parties, thus eliminating the need to
85	use high-precision clocks, such as cesium atomic clocks, and it can be easily installed by using
86	consumer Wi-Fi access points (APs). There are only a few reports on positioning using this standard,

- 87 but these have been mostly restricted in the field of engineering. Therefore, in this study, we
- 88 investigated the utilization of Wi-Fi RTT and WPM in the field of occupational health based on the
- 89 use of a combination of Wi-Fi RTT and WPM at industrial sites.

- 92 Methods
- 93 This experiment was conducted in August 2020 at a multipurpose simulated factory at the University
- 94 of Occupational and Environmental Health, Japan. The overall layout is illustrated in Figure 1.

## 96 Indoor positioning

97	Indoor positioning was measured using Wi-Fi RTT. We used a Pixel 4 smartphone (Google LLC), a
98	Nest Wi-Fi (Google LLC) router, and three expansion points as APs. Regarding measurement
99	applications, we were unable to find any existing software that matched the requirements of this
100	study. Therefore, we used an open source (MIT License) <sup>8</sup> software developed by Mr. Darryn <sup>9</sup> with
101	our own modifications. The major modifications included the change of the coordinate system of the
102	AP, and the addition of a function to save the log. Moreover, we used the developer mode to
103	overcome the limitation of the number of Wi-Fi scans by the Android OS. The coordinates of the AP
104	locations were determined based on measurements with a GLM 50 C Professional (Robert Bosch

105	GmbH, Gerlingen, Germany). The heights of the AP locations were approximately 1500 mm from
106	the floor. Given that the height was the same for all the APs, the Z coordinate was ignored in this
107	study. The APs were placed as shown in Figure 1. The preliminary experiments determined the
108	positioning to be inaccurate in the area around the glass showcase and the area where the floor
109	material was made of steel. Hence, these areas were covered with paper or cloth. In a previous study,
110	it was reported that the accuracy of the positioning varied depending on the direction of movement
111	because of the body which acted as a shield. <sup>10</sup> Therefore, a selfie stick was fixed to the helmet, and a
112	smartphone was installed. A photograph of the measurer is shown in Figure 2.
113	
114	Confirmation of measurement accuracy
115	Prior to this experiment, we checked the measurement accuracy with the use of a with a smartphone
116	which was placed on a helmet and a selfie stick for Wi-Fi RTT measurements at all point locations
117	from points A to E in Figure 1. Measurements were acquired at each point for one minute each. The
118	coordinates measured by the laser rangefinder were used as the standard, and the deviation of the

119 measurement by Wi-Fi RTT was calculated.

# 121 **Dust measurement**

122 The WPM was used for the dust measurements. One unit of the WPM was fixed to the left and right

123	upper arms of the person who performed the measurement. Given that there was no dust source in
124	the simulated factory, two ultrasonic humidifiers were installed, and a sodium chloride solution (2%
125	and 5%) was sprayed. Commercial salt was used as the solute, and pure water was used as the
126	solvent. Measurements were acquired every second, and cases with zero readings or no records were
127	excluded. After ventilating the room for each measurement, the humidifier was turned on, and
128	measurements started after the elapse of (at least) 3 min.

129

#### 130 **Measurement procedure**

131 Measurements were acquired three times with the use of different routes. The measurer walked the

132designated route at a low speed of approximately 7.62 m/min. Figure 3 shows the walking route at

133the time of measurement.

#### 135**Creation of heat maps**

136A heat map was created from the positioning information using Wi-Fi RTT and the results of dust

- 137 measurements by the WPM. The location information was calculated as the median value of the
- 138 X-and Y-axis coordinates every second. The heat map was created by excluding the coordinate
- 139values outside the original circumference range (a rectangular range consisted of four points: (0,
- 140 -1000), (6000, -1000), (0, 9000), and (6000, 9000)). The dust concentration was determined by using

- 141 the median of the measured values in the area. The heat map was created using Origin 2020 (64-bit,
- 142 SR1 Ver9.7.0.188, OriginLab Corporation, Northampton, Massachusetts, USA).

### 144 **Ethical considerations**

- 145 All measurements in this study were performed by the authors and no subjects were involved.
- 146 Therefore, the study was not reviewed by the Ethics Committee because it was not considered to
- 147 meet the requirements for ethical review.
- 148

### 149 **Results**

- 150 The results of the accuracy verification are shown in Figure 4. The mean deviation (SD) from the
- 151 laser rangefinder position at each point was 1087.9 (133.7) mm at point A, 1000.6 (63.7) mm at
- 152 point B, 748.3 (31.5) mm at point C, 669.2 (94.3) mm at point D, and 918.4 (396.8) mm at point E.
- 153 The results of indoor positioning are shown in Figure 5. In the locations where the measurer could
- 154 not exist, such as behind the showcase or behind the wall, which were "outside of the rectangle
- 155 which comprised the four points of (0, -1000), (6000, -1000), (0, 9000), (6000, 9000)," the error
- percentages were recorded at 7% (49 s /700 s) in Experiment A, 2.3% (15 s /660 s) in Experiment B,
- and 7.8% (50 s/645 s) in Experiment C. The results of the WPM measurements are shown in
- 158 Appendix 1. Figure 6 shows the heat map created by combining the two datasets.

### 160 **Discussion**

161	To assess the accuracy of each experiment, it was found that the error in this measurement system
162	was approximately 1 m. In a previous study, it was reported that the average measurement error of
163	Wi-Fi RTT was 1.4 m in an outdoor experiment in which the measurement points were set in a grid
164	pattern at equal intervals. <sup>11</sup> Another study reported the average measurement error of Wi-Fi RTT to
165	be 0.10 m in an outdoor experiment and 0.23 m in an indoor experiment in which the measurement
166	points were set along a straight line with equal intervals. <sup>12</sup> Although the accuracy in this study was
167	worse than this, it is considered to be good enough for use in the workplace. The accuracy of GNSS
168	positioning using a smartphone has been reported to be approximately 8–10 m, <sup>13</sup> and Wi-Fi RTT is
169	expected to be more accurate than the GNSS if properly configured.
170	We were able to obtain the same path as the walker indoors using the Wi-Fi RTT. Although there was
171	a certain amount of error in the accuracy verification, we were able to measure continually the path
172	of movement, and there was no interruption in the path. The experiments were conducted on three
173	different walking routes, and no remarkable differences were observed in the positioning results of

174 Wi-Fi RTT. It was assumed that the human body influenced the Wi-Fi RTT positioning, as it has

- been reported previously<sup>10</sup>. To overcome this issue, the smartphone was held at a high position. In
- addition, in this study, we coated the glass and metal parts in advance, which were found to degrade

177	the accuracy of measurements in the preliminary investigation. In this regard, it has been assumed
178	that the reflection and refraction of radio waves caused by glass and metal reduces the accuracy.
179	Hence, it is necessary to conduct tests in advance and resolve this issue before using Wi-Fi RTT for
180	measurements in actual workplaces. There have been attempts to create fingerprints using Wi-Fi
181	RTT and utilize machine learning. <sup>14</sup> Accordingly, the accuracy of this method is expected to improve
182	as the technology develops. However, most of the validation studies on the accuracy of Wi-Fi RTT
183	have been conducted in empty plazas or ordinary offices, and it is desirable to conduct these
184	verification studies in industrial settings, such as factories. Although we did not verify the accuracy
185	of the measurement while walking this time, it is presumed that there is a certain degree of accuracy
186	even when walking given that the walking path was measured without interruption (Figure 5).
187	Considering the fact that the mesh of the heat map is 1 m, the measurement was conducted by
188	walking at an extremely low speed. In the actual work site, it is assumed that people will move by
189	walking more quickly. Given that most of the work itself is done in stationary conditions, and the
190	accuracy in such cases has been verified, it is not expected to be a major problem. To expand the
191	usage of indoor positioning, an additional study on accuracy during motion is required.

One of the advantages of Wi-Fi RTT is that it can be used in local networks, while the GNSS

193

195	more than 30 s to obtain orbital information from GNSS satellites, and the accuracy is initially low. <sup>15</sup>
196	Given that Wi-Fi RTT requires only an AP and a smartphone for positioning, it does not require this
197	external connection or orbit information acquisition. Instead, Wi-Fi RTT requires the coordinate
198	information of the AP, which is not a concern as the coordinate information of the AP is already
199	known by the company. This can offer a great advantage in the field of occupational health given
200	that external connections are often difficult to access in companies. In this study, we used Wi-Fi RTT
201	in combination with dust measurement, but the GNSS has already been used in various applications,
202	such as geo-fencing, for disaster prevention. <sup>16</sup> If highly accurate positioning becomes achievable
203	indoors, various applications can be expected to be possible.
204	

Unlike the existing methods, Wi-Fi RTT calculates the distance based on the arrival time of the radio wave rather than on the strength of the radio wave. Theoretically, the radio wave strength attenuates in proportion to the square of the distance, but in reality, this is not always the case owing to the effects of various noise sources. The actual formula for estimating distance using radio wave strength is as follows<sup>17</sup>:

In this formula, RSSI is the strength of the received signal, d is the distance between the transmitter
and receiver, n is a constant that represents the attenuation, and Tx is the output of the transmitter.

213	Moreover, n varies depending on the environment; therefore, it is difficult to uniquely determine it in
214	advance. In contrast, Wi-Fi RTT uses the arrival time, and is thus considered to be less susceptible to
215	noise. However, both methods are affected by the reflection, refraction, and diffraction of radio
216	waves; hence, it is necessary to pay attention to this point. In this study, the smartphone was placed
217	on a helmet to reduce these effects. However, considering safety protocols, it may not be realistic to
218	use this method at the workplace. A more stable fixation method should be considered along with
219	technological advances that make the machine smaller and lighter. In this study, we set the height of
220	all the APs and smartphones to be almost the same by ignoring the Z-axis. However, if each AP is set
221	at a higher position such that the radio wave can reach the smartphone directly without being
222	blocked, more stable positioning may be possible; this possibility requires further verification.

232	company-owned smartphones, this method is not recommended for individually owned smartphones
233	because unlocking is a function for developers. Restrictions may change over time and should be

- 234 monitored carefully.

236 In this study, the dust measurement outcomes of the right upper arm were generally higher than 237those of the left upper arm. The right side of the walking route was closer to the humidifier than the 238 left side, and the results were considered to be consistent with this. Looking over the heat maps of 239 the three experiments, it can be confirmed that the dust concentration near the humidifier with a 5% 240 saline solution (6600, 3600) was higher than in other areas. This can be considered a reflection of the 241 dust emission situation in the experimental environment. In addition, it can be confirmed that the 242 dust concentration near "x = 2000 - 4000, y = 7000 - 9000" is high. In this experiment, the 243humidifier, which is a dust source, was installed at (0, 6400) and (6600, 3600), and resulted in a gap 244 between the dust source and areas of high concentration in the heat map. One of the reasons for this 245 discrepancy may be the influence of errors in the position measurement. Given that the location 246 information acquisition method used in this experiment had certain limitations, it is possible that the 247 location information was recorded at the point at which the measurer did not actually exist, and the 248 location on the heat map associated with a relatively high-dust concentration was shifted. However,

249	it is possible to interpret the results by assuming that the influence of the error in positional
250	measurement was not significant, i.e., the heat map accurately reflected the dust concentration in the
251	environment to some extent. There could be two possible reasons for this. First, the dust may have
252	been carried away by the movement of the measurer to the location in question. This point was
253	visually confirmed during the experiment (including the preliminary experiment), although it has not
254	been precisely verified or evaluated. Second, there is a possibility of the dust being shifted to the
255	location in question by the operation of the ventilation fan in the simulated factory. By creating a
256	heat map of the dust levels, it was possible to visually understand the dust emissions in the
257	environment. It is possible that the high-dust concentrations formed at a distance from the
258	dust-emission source were not fully identifiable by the usual measurement of the working
259	environment. In this study, we used a 1 m mesh, which was more detailed than the 6 m mesh for
260	measurements in the working environment. Although it was not possible to measure all the points
261	simultaneously, it was still possible to obtain data at many points.
262	The ability to visually and easily confirm the distribution of dust by combining location information
263	and dust meter results is considered extremely useful in implementing industrial health activities.
264	There have been reports that aimed to gain an understanding on the distribution of the air dose rates
265	after the accident at the Fukushima nuclear power plant to map the concentration/amount of
266	hazardous substances in combination with location information. <sup>20, 21</sup> However, these reports have

267	used the GNSS in outdoor environments. In the past, indoor positioning was difficult. Therefore, to
268	create these heat maps, it was necessary to determine the position from video camera images, which
269	was very complicated. In addition, personal exposure measurement sometimes involves
270	synchronization of continuous recordings using a real-time monitor with a data logger and video
271	images acquired during work to visually capture the changes in exposure that accompany work
272	changes. <sup>22</sup> In the past, work scenes were filmed and analyzed, but recent studies have been
273	conducted wherein a small camera and a small dust meter were attached to a helmet, and the camera
274	and dust meter were synchronized to assess the dust emission status. <sup>23</sup> Although this approach has
275	been in use for a while, it has not been extensively used in actual occupational health settings. One
276	of the reasons for this is attributed to the fact that as the measurement time increases, more time is
277	required to check the video images during the analysis of continuous recordings of the exposure
278	status and the synchronization of the video images. Therefore, it would be more practical to focus on
279	situations associated with high exposures rather than to check all the situations during the entire
280	measurement period. Our method had a great advantage in that we could overview the entire
281	workplace in a relatively short time. However, with the use of our study's method, if a worker stays
282	in the same place for a long time, the heat map will show only one point; hence, it is necessary to
283	limit the analysis duration or adjust the size of the heat map. In case it is not possible to uniquely
284	link the work location with the work content, a combination of video images can be considered.

285	This study had a few limitations that must be considered. First, measurement in the study was
286	conducted using only one piece of equipment. It was not clear whether measurements obtained from
287	this equipment can be generalized to those obtained from other equipment. However, at present, few
288	devices officially support Wi-Fi RTT in Japan. It is also unavoidable that the most commonly
289	available devices are made by Google. In particular, there are only four APs listed on the Android
290	developer site as Wi-Fi RTT-compliant APs, and three of them are made by Google. <sup>24</sup> The fourth one
291	is made by a company other than Google, but it is a foreign product and cannot be used because it
292	does not have a technical standards compliance certificate in Japan. However, the number of
293	compatible smartphones is gradually increasing, and we expect that this number will continue to
294	increase. Second, we did not conduct simultaneous measurements of the measurer's position using
295	the standard method. Although no large discrepancies between the movement trajectories are
296	presumed, it was not possible to quantitatively evaluate the degree of discrepancy. Given that the
297	accuracy required for use in the workplace is likely to vary from workplace to workplace, additional
298	evaluations are necessary. Third, the simulated factory used in this study had fewer obstructions than
299	a typical factory, and hence, the measurement accuracy may have been overestimated. It is necessary
300	to conduct surveys in more environments, and in certain cases, to combine methods such as
301	fingerprinting for more robust results.

302 High-precision indoor positioning technology is expected to be used in a wide range of applications,

- 303 such as the monitoring and evaluation of the working environment and the vital signs of workers,
- 304 based on its combination with various sensors. Furthermore, this technology is of value in the field
- 305 of occupational health as it can be used to conduct evaluations in various environments and with
- 306 various measurement instruments.

- 309 In this study, we visually clarified the distribution of dust concentration in the workplace in the form
- 310 of a heat map by combining Wi-Fi RTT and WPM. The results in this study indicate that the
- 311 combination of location information and various sensor devices may be beneficial for occupational
- 312 health. Additional developments in this forefront are expected in the future.

- 404 Figure 3. Walking path during the measurement.




410 Figure 5. Indoor positioning results.


- 411 Each dot indicates the position coordinates measured by the Wi-FI RTT. The location information
