Introduction: High intensity interval exercise (HIIE) is performed widely. However, the field possesses limited knowledge regarding the acute HIIE cerebrovascular response. Our objective was to characterize the middle cerebral artery blood velocity (MCAv) response during an acute bout of short interval HIIE in healthy adults. We hypothesized MCAv would decrease below BL 1) during HIIE, 2) following HIIE, 3) and 30-minutes after HIIE. As a secondary objective, we investigated sex differences in the MCAv response during HIIE. **Methods:** Fourteen healthy adults (7 male) completed the HIIE session. The 10-minute HIIE session included alternating 1-minute bouts of high-intensity and low-intensity intervals. MCAv, mean arterial pressure (MAP), heart rate (HR), and expired end tidal carbon dioxide (P_{FT}CO₂), were recorded at BL, during HIIE, following HIIE, and 30-minutes after HIIE. Results: Contrary to our hypothesis, MCAv remained above BL for the HIIE duration. MCAv peaked at the third minute then decreased concomitantly with P_{ET}CO₂. MCAv was lower than BL after HIIE (p=0.03). Thirty minutes after HIIE, MCAv returned to near BL values (p = 0.47). Women showed higher BL MCAv ($\bar{x} = 70.9 \pm 8.1 \text{ cm} \cdot \text{s}^{-1}$) compared to men ($\bar{x} = 59.3 \pm 5.8 \text{ cm} \cdot \text{s}^{-1}$) 1 , p = 0.01). A greater magnitude of MCAv response was observed in men resulting in nonsignificant differences during HIIE secondary to higher workload (p = 0.03). **Conclusions:** Collectively, these findings show that in healthy adults, MCAv remained above BL during a 10-minute short-interval HIIE and returned to resting values 30 minutes after exercise.

Introduction Temporal changes in cerebral blood flow, measured by middle cerebral artery blood velocity (MCAv), have been well characterized during submaximal continuous exercise. (1-4) During steady-state low and moderate intensity continuous exercise, MCAv remains at a consistent rate.(2, 5) As exercise intensifies, MCAv increases in tandem up to anaerobic threshold, (1, 6, 7) thereafter MCAv decreases with high intensity exercise. (1, 4, 6) At the anaerobic threshold, hyperventilation occurs, resulting in decreased partial pressure carbon dioxide (PaCO₂).(8) To attenuate the decrease in PaCO₂, downstream arteriole vasoconstriction occurs causing a decrease in MCAv.(9) While MCAv has been characterized during an acute bout of high intensity continuous exercise.(1, 3) our recent systematic review determined few studies have examined MCAv during an acute bout of high intensity interval exercise (HIIE).(10) HIIE is defined as repetitive short bouts of exercise switching between intervals of high intensity and low intensity recovery. In prepubertal children MCAv decreased below baseline (BL) during an acute 12-minute bout of HIIE with 1-minute intervals.(11) In contrast, healthy adults (average age of 23 years old) showed decreases in MCAv during an acute 20-minute bout of sprint interval exercise with repetitive 30-second sprint intervals at maximal effort with 4.5-minute active recovery. The authors report MCAv remained above BL throughout the duration of HIIE. The longer recovery interval of 4.5 minutes may have allowed for stabilization of PaCO₂, therefore maintaining MCAv above baseline.(12)

Interval exercise at moderate intensity has been proposed to be beneficial for cerebrovascular function in older men due to the low intensity intervals allowing recovery of P_{ET}CO₂ and sustained MCAv.(13) However, sustained MCAv during HIIE has been stated to be counterintuitive due to decreases in expired end tidal carbon dioxide (P_{ET}CO₂).(13) Further, short interval HIIE with 1-minute low intensity intervals may not be enough time to allow for recovery of P_{ET}CO₂, leading to reductions of MCAv. Although this has been suggested, no studies have reported the effects of short interval HIIE on MCAv. To address this gap in knowledge, we proposed to characterize the MCAv response in healthy adults during a single bout of HIIE using 1-minute intervals of high and low intensity. Our primary hypothesis was that MCAv would significantly decrease below BL MCAv during an acute 10-minute HIIE bout. Our secondary hypotheses were that MCAv would be significantly lower than BL MCAv 1) during passive recovery after HIIE and 2) at rest 30minutes after HIIE. Further, we hypothesize that the decrease in MCAv will be related to the change in P_{ET}CO₂. Our previous work identified unique sex-specific trajectories in resting MCAv over the lifespan(14) and to moderate-intensity continuous exercise.(15) Therefore, as a secondary objective, we investigated whether sex differences existed in the MCAv response to HIIE. Methods Individuals were recruited from the surrounding community using flyers. Participants were enrolled in the study if they met the following inclusion criteria: 1) 18-30 years old and 2) low cardiac risk defined by the American College of Sports Medicine (ACSM).(16) The study and all

experimental procedures were approved by the University of Kansas Medical Center Human Subjects Committee. This study is registered on clinical trials.gov (NCT04673994). Prior to the start of study procedures, participants provided written informed consent.

Fifteen healthy adults (7 women, 8 men) completed the study consisting of two visits to the laboratory. The second visit occurred 48 hours to 2 weeks after the initial visit. No adverse events occurred. Due to loss of TCD signal during HIIE, we excluded one male individual from data analysis. Three participants required rescheduling for study visit 2 due to University closure for weather. These individuals completed study visit 2 within one month of the initial study visit. All participants confirmed they refrained from caffeine for 8 hours,(17) vigorous exercise for 24 hours,(18) and alcohol for 24 hours.(19) All participants reported no change in health or physical activity levels between study visits. For women, visits were scheduled between days 1-7 of the menstrual cycle.(20) Study visits were scheduled between 2-5pm to maintain consistency and minimize circadian influence on cerebral blood velocity.(21) All participants were classified as having <50% carotid stenosis.(22) Six out of seven (86%)women reported using birth control medication. Participant characteristics are presented in **Table 1**.

Intensity Interval Exercise. Study Visit 1 We collected demographic information including age, sex, race/ethnicity, body mass index (BMI), self-reported physical activity, current medications, and medical history. Participants completed questionnaires including the ACSM Risk Stratification Screen.(23) TCD Signal Acquisition Following the questionnaires, participants were screened to ensure a MCAv signal on the right and/or left temporal window. Participants were fitted with an adjustable headband that secured bilateral transcranial Doppler ultrasound (TCD) probes (2-MHz, Multigon Industries Inc. Yonkers, New York) with ultrasonic gel onto the temporal region of the participant's head. MCAv signal was acquired using standard probe positioning, orientation, depth, and direction.(24) The TCD depth, gain, power, and probe position were recorded to maintain consistency between study visits. Submaximal Exercise Test Participants performed the total body recumbent stepper (TBRS) submaximal exercise test(25, 26) to determine the estimated maximal workload.(13, 25, 26) Participants were fitted with a heart rate monitor (Polar Electro Inc, New York) and seated on a recumbent stepper (T5XR NuStep, Inc. Ann Arbor, MI). We performed the TBRS submaximal exercise test according to previously published methodology, (25) with the exception that participants were instructed to perform exercise by only using their lower extremities. For the HIIE acute exercise bout,

participants would be exercising with their lower extremities since participants rested their arms on platforms to allow for accurate blood pressure measures. Therefore, we wanted to ensure an accurate workload for exercise prescription. All participants began exercising at 30 watts and stepped at a constant pace between 95-100 steps per minute. Every minute, heart rate (HR) and the rating of perceived exertion (RPE) were measured until termination criteria were met: 1) completion of all stages of the exercise test, or 2) participant requested to stop the test, or 3) participant reached 85% of their age-predicted maximal HR. The TBRS submaximal exercise linear regression equation was then used to calculate the estimated maximal oxygen consumption (estimated $V \square O_{2max}$).(25) The linear relationship between workload and HR (i.e. slope) was plotted and used to determine the estimated maximal watts (estimatedWatt_{max}).(27) Exercise Familiarization

After the TBRS submaximal exercise test, participants rested to allow HR and blood pressure to return to resting values. Individuals participated in the HIIE familiarization, switching between 1-minute high intensity and 1-minute low intensity intervals while maintaining a consistent step rate on the recumbent stepper. Based on previous protocols, intensity for the acute HIIE bout was calculated as 60-80% estimatedWatt_{max} for high intensity intervals and 10% estimatedWatt_{max} for low intensity intervals. (28-31) HR and RPE were measured at the end of each interval. Based on previous recumbent stepper HIIE protocols, a HR limit of 85% of age predicted maximum HR was used.(32) Participants also practiced breathing through their nose during the interval exercise. The familiarization session lasted approximately 10 minutes.




Figure 1. – Protocol Layout of MCAv recordings 1) before HIIE, 2) during HIIE, 3) following HIIE, and 4) 30 minutes after HIIE. L = Low intensity interval. H = High intensity interval.

Carotid Ultrasound Upon arrival to the laboratory, participants underwent a carotid ultrasound scan. Participants rested quietly in a supine position for 20 minutes. We then conducted a bilateral Doppler ultrasound scan of the common, internal, and external carotid artery. Carotid 2D (GE Healthcare LOGIQ Ultrasound, Chicago, IL) images as well as systolic and diastolic velocity measures were sent to a collaborating physician (SXB) for carotid stenosis assessment.(22) MCAv Recordings After completing the carotid ultrasound scan, participants were seated on the recumbent stepper and rested quietly for 20 minutes while the following equipment was donned: 1) TCD headset and bilateral ultrasound probes to measure MCAv, 2) a 5-lead electrocardiogram (ECG; Cardiocard, Nasiff Associates, Central Square, New York) for HR, 3) a nasal cannula attached to a capnograph (BCI Capnocheck Sleep 9004 Smiths Medical, Dublin, Ohio) for expired end tidal carbon dioxide (P_{ET}CO₂) and respiratory rate (RR), 4) a beat-to-beat blood pressure cuff on the left middle finger (Finometer, Finapres Medical Systems, Amsterdam, the Netherlands) for mean arterial pressure (MAP), and 5) a brachial automated sphygmomanometer with a microphone on the right arm (Tango M2; Suntech, Morrisville, NC) to ensure an accurate calibration of the Finometer. The participant's arms were placed on stable platforms at heart level. As in our previous work, the laboratory room was dimly lit and kept at a constant temperature of 22°C to 24°C.(5) Figure 1 details the experimental protocol. Following the BL rest recording, MCAv was continuously recorded during the 10-minute acute HIIE bout. The HIIE bout consisted of

repetitive 1-minute high intensity intervals (60-80% estimatedWatt_{max}) separated by 1-minute low intensity intervals (10% estimatedWatt_{max}).(13, 29) The HIIE MCAv recording started with a 1-minute low intensity interval to prevent a Valsalva Maneuver, which can occur at the start of heavy resistance exercise, eliciting a large transient drop in MAP and MCAv.(33) After 10 minutes of HIIE, resistance was decreased to 15 watts and participants performed a 2-minute active cool-down. Immediately following the cool-down, participants stopped exercise and sat quietly on the recumbent stepper while we collected a 5-minute recording. The final recording lasted 5 minutes and was conducted 30 minutes after HIIE in a seated position.

Raw data were acquired through an analog-to-digital unit (NI-USB-6212, National Instruments) and custom-written software within MATLAB (v2014a, TheMathworks Inc, Natick, Massachusetts). Sampling rate was set at 500 Hz. Raw data were then time aligned and interpolated beat-to-beat using the R spike on EKG as a trigger. Each 5-minute rest recording was averaged separately at: 1)BL, 2) following HIIE, and 3) 30 minutes after HIIE. Each 1-minute interval during the 10-minute HIIE bout was averaged separately.

Data Analysis

Alpha was set a priori at 0.05. Normality was determined using a Shapiro-Wilk test. Consistent with previously published work, the left MCAv signal was used within the analysis to compare time points but if the left MCA signal was not obtainable, then right MCAv was used.(2, 15) To examine the conductance of peripheral blood pressure to the brain via MCAv we calculated the beat-to-beat cerebrovascular conductance index (CVCi = MCAv/MAP)(34). Participant characteristics were analyzed using a one-way ANOVA, Mann-Whitney U test for non-parametric variables, and Fisher's exact test for categorical variables. Differences in the response to HIIE compared to BL were analyzed using a repeated measures ANOVA and post-hoc paired t-test with Bonferroni correction (α < 0.005). Relationships between the change in MCAv, MAP, and $P_{ET}CO_2$ were analyzed using a Spearman's rank correlation coefficients. We used a repeated measures ANOVA with post-hoc paired t-test to detect differences following HIIE and 30-minutes after HIIE compared to BL. Differences in the MCAv response between sex were analyzed using a mixed design ANOVA and post-hoc independent t-test with Bonferroni correction.

Results

MCAv Response to HIIE




Figure 2 - Response to high intensity interval exercise (HIIE, n=14); Middle Cerebral Artery blood velocity (MCAv, cm·s⁻¹), Mean Arterial Pressure (MAP, mm Hg), expired end tidal carbon dioxide ($P_{ET}CO_2$, mm Hg), and cerebrovascular conductance index (CVCi, MCAv/MAP). L = Low intensity interval. H = High intensity interval. Horizontal dashed line represents baseline value. *Indicates significant "rebounding" effect during low intensity compared to previous high intensity interval. † Indicates significant increase compared to previous low intensity interval.

The average MCAv for each interval of HIIE is presented in **Table 2**. Odd integer intervals represent low intensity exercise while even integer intervals represent high intensity exercise, shown in **Figure 1**. Compared to BL, MCAv was significantly higher during intervals 2 through 10 of HIIE (p < 0.001). MCAv peaked at interval 3 and began to decrease throughout the remainder of the acute exercise bout, shown in **Table 2**. Following the high intensity intervals, we observed a "rebounding" response whereby MCAv increased during low intensity intervals,

shown in **Figure 2**. Compared to BL, MCAv was also lower after HIIE (p = 0.03) but returned to BL values at 30-minutes after HIIE (p = 0.47), shown in **Table 3**.

MAP, HR, P_{ET}CO₂ and CVCi Response to HIIE

During HIIE, MAP increased significantly from BL values ($p \le 0.002$), shown in **Table 2**. MAP also significantly increased during the high intensity intervals compared to low intensity intervals (p < 0.005), shown in **Figure 2**. The change in MAP was significantly related to the change in

MCAv between intervals 2 and 3 (r = 0.82, p < 0.001), intervals 3 and 4 (r = 0.62, p = 0.02), and intervals 8 and 9 (r = 0.54, p = 0.045). MAP returned to resting values and was not significantly different from BL, following HIIE (p = 0.97) or 30-minutes after HIIE (p = 0.75), shown in **Table 3**.

Compared to BL, $P_{ET}CO_2$ increased significantly during low intensity intervals 3, 5 and 7 (p <0.003), shown in **Table 2**. Compared to BL, RR increased during HIIE and was increased during high intensity compared to low intensity intervals (p \leq 0.003). Compared to interval 3 (the peak MCAv interval), RR increased during high intensity intervals (p <0.001), which is consistent with the pattern of hyperventilation induced decreases in MCAv shown in **Figure 2**.




Figure 3 – Cerebrovascular conductance index (CVCi, MCAv/MAP) with each heartbeat. L = Low intensity interval H = High intensity interval. CD = Cool Down. Horizontal dashed line represents baseline value. High intensity interval exercise (HIIE) occurred during 0 – 600 seconds (10 minutes). Active cool down occurred between 600-720 seconds (2 minutes). Passive recovery following HIIE occurred between 720 – 1020 seconds (5 minutes).

Due to increased RR (hyperventilation) during the high intensity intervals, P_{FT}CO₂ was not significantly different from BL during high intensity. The change in P_{ET}CO₂ was significantly related to the change in MCAv between intervals 1 and 2 (r = 0.60, p = 0.03), intervals 6 and 7 (r = 0.60, p = 0.03), intervals 6 and 7 (r = 0.60, p = 0.03). = 0.69, p = 0.01), intervals 7 and 8 (r = 0.81, p < 0.001), intervals 8 and 9 (r = 0.53, p = 0.049), and intervals 9 and 10 (r = 0.65, p = 0.01). During recovery, $P_{ET}CO_2$ was significantly lower than BL following HIIE (p = 0.002) and 30-minutes after HIIE (p = 0.02). RR was lower than BL following HIIE (p = 0.02) but returned to BL levels at 30-minutes after HIIE (p = 0.16). CVCi did not significantly change from BL during the acute HIIE bout, following HIIE or 30minutes after HIIE. Following interval 3 (the peak MCAv interval), CVCi decreased during high intensity intervals and increased with low intensity intervals (p < 0.001), shown in **Figure 3**. The slope from interval onset to peak CVCi was calculated during interval 1, 2, 3, 5, 7, and 9. With CVCi decreasing during intervals 4, 6, 8, and 10, the slope from interval onset to nadir CVCi value was calculated. The slopes of the CVCi response were different between high and low intensity intervals following interval 3 (p < 0.001). The first high intensity interval, or interval 2, was faster to peak CVCi (18 \pm 15 seconds) compared to the other high intensity intervals (p \leq 0.001). The time to peak or nadir CVCi was also significantly faster during low intensity intervals compared to high intensity intervals such as: interval 5 and 6 ($\bar{x} = 37 \pm 9$ seconds versus $\bar{x} = 45 \pm 4$ seconds, p = 0.02), and interval 7 and 8 ($\bar{x} = 33 \pm 15$ seconds versus $\bar{x} = 48 \pm 6$ seconds, p = 0.02).

Sex Differences in MCAv Response to HIIE




Figure 4 – Absolute MCAv response to high intensity interval exercise (left) compared to the relative percent change MCAv response (left). Horizontal dashed line represents baseline value.

The MCAv response to HIIE differed between men and women, shown in **Table 4**. Although resting BL MCAv was significantly higher in women compared to men (p = 0.01), the percent change in MCAv was greater in men, shown in **Figure 4**. Therefore, during intervals 4 through 10, MCAv was no longer significantly different between men and women. However, following HIIE and 30-minutes after HIIE, MCAv returned to being higher in women compared to men (p = 0.01). In women, the change in MCAv was related to the change in $P_{ET}CO_2$ between intervals 4

and 5 (r=0.81, p=0.03), intervals 6 and 7 (r=0.90, p=0.01), intervals 7 and 8 (r=0.87, p=0.01), and intervals 9 and 10 (r=0.87, p=0.01). In men, the change in MCAv was related to the change in $P_{ET}CO_2$ between intervals 6 and 7 (r=0.75, p=0.05) and intervals 7 and 8 (r=0.98, p<0.001).

Discussion

Short interval HIIE is widely utilized to improve peripheral vascular health(35, 36) despite minimal research into its effects on the cerebrovascular system.(10) This study provides novel and crucial insight into the MCAv response to rapid and repetitive short interval HIIE in healthy young adults. The primary findings of the study are: 1) MCAv did not decrease below resting values during HIIE, 2) MCAv peaked within 3 minutes of HIIE and began to decrease with high intensity, 3) MCAv rebounded during the low intensity intervals, 4) MCAv decreased below resting values for 5 minutes after HIIE, and 5) resting MCAv was higher in women compared to men, but men had a greater change in MCAv during HIIE.

The primary objective of this study was to characterize the MCAy response during an acute bout of 1-minute interval HIIE in healthy adults. Based on previously published work, (11) we hypothesized that MCAv would decrease below BL MCAv during an acute 10-minute HIIE bout. However, our primary hypothesis was not supported by our findings. While MCAv did not decrease below resting MCAv throughout the HIIE bout, MCAv did start to decrease after 3 minutes of HIIE. Initially, MCAv increased with the onset of HIIE and was moderately correlated with the change in MAP. However, MCAv began to decrease after 3 minutes of HIIE and was moderately correlated with the change in P_{FT}CO₂. Therefore, the initial rise in MCAv could be partially explained by peripheral blood pressure while the latter decrease in MCAv was driven by hyperventilation induced arteriole vasoconstriction. Prior research has demonstrated a decrease in MCAv below BL resting MCAv during 1-minute interval HIIE in young children.(11) In contrast, we did not find a reduction in MCAv below BL MCAv, which could be due to the age of the participants (children versus adults), the high intensity workload (90% versus 70% estimated watt maximum), and the exercise modality (cycle versus recumbent stepper). Our results are supported by previous research performing short sprint interval training in healthy adults that also found no reduction in MCAv below BL resting MCAv.(12) However, the prior study performed 30-second sprint intervals at 200% watt maximum with longer 4.5-minute recovery intervals. Therefore, our study contributes to the existing literature showing no reduction in MCAv below BL during an acute 10-minute bout of short interval HIIE with alternating 1-minute high intensity and low intensity intervals.

While MCAv started to decrease after 3 minutes of HIIE during the high intensity intervals, MCAv increased or "rebounded" during the low intensity intervals. Previous studies measuring MCAv during HIIE have also reported this "rebounding" effect.(11, 12, 34) MCAv "rebounding" during light intensity intervals could be partially explained by P_{ET}CO₂ as they were moderately correlated. MCAv also closely followed the pattern of P_{ET}CO₂ with both measures decreasing during high intensity (hyperventilation) and increasing during recovery. We have also shown increased CVCi during the recovery intervals, showing a potential contribution of MAP to the "rebounding effect". It has been hypothesized that the "rebounding effect" could due to the increase in CVCi, or conductance of MAP to the brain, due to an attenuation of cerebral autoregulation (ability of the brain to maintain homeostasis during blood pressure fluctuations) with an acute bout of high intensity exercise. (12, 18, 34) Others have hypothesized that increased shear stress on the cerebrovascular arterial walls with high intensity exercise could create vasodilatory effects.(12, 37) However, future research measuring dynamic cerebrovascular autoregulation and the cerebrovascular flow mediated dilatory response to short interval HIIE requires further exploration. Our secondary hypotheses were that MCAv would be lower than BL MCAv during passive recovery 1) following HIIE and 2) 30-minutes after HIIE. Our hypotheses were partially supported by our findings. MCAv was lower during the 5-minute rest following HIIE but not at 30-minutes after HIIE. Our findings are supported by previous research also reporting a reduction in MCAv below BL following HIIE.(11) The reduction in MCAv following exercise may be a unique characteristic to HIIE, as a previous study performing 20 minutes of moderate intensity continuous exercise reported no reduction in MCAv after exercise in healthy adults.(38)

The reduction in MCAv cannot be fully explained by P_{FT}CO₂ considering MCAv recovers to BL resting values at 30-minutes after HIIE while P_{ET}CO₂ remains significantly decreased.(11) This could be due to an attenuation of cerebrovascular reactivity to carbon dioxide following an acute bout of HIIE.(10, 39) CVCi Response We are the first to characterize the dynamic CVCi response during HIIE. We report a quick increase in conductance during the first high intensity interval with a subsequently longer time for the remaining high intensity intervals. Similar to Labrecque et al. examining the time to peak MCAv during a 30-second high intensity sprint, (34) we characterized the time to peak (or nadir) CVCi during each 1-minute high intensity and low intensity intervals. We found that the time to peak CVCi was fastest during the first high intensity interval compared to the remaining high intensity intervals. We hypothesize that the longer time to peak/nadir CVCi during high intensity intervals could be a regulatory response attenuating quick fluctuations in CVCi with increased MAP. The slope of the CVCi response was negative during the latter high intensity intervals, due to hyperventilation induced decreases in MCAv. However, CVCi increased or "rebounded" during the low intensity intervals. While prior work has shown a decreased regulatory response following HIIE, (18) further research is needed to determine whether the increase in CVCi or "rebounding effect" is due to an attenuation of the regulatory response during HIIE. Sex Differences Our previous work identified women as having a higher BL resting MCAv compared to men but no significant difference in the MCAv response to moderate intensity continuous exercise. (14,

15) While previous work has been published on the MCAv response to interval exercise, to our knowledge, no one has studied sex differences during short interval HIIE and recovery.(12, 13) Although women had a higher BL MCAv at rest, MCAv was not significantly different during exercise due to a larger MCAv response in men. As observed in **Table 1**, the men worked at a significantly greater absolute workload than women, which we propose influenced the greater MCAv response. The MCAv differences between sex could also be due to young men having a higher resting pulsatility index, as lower MCAv has been hypothesized to be a protective mechanism for the downstream microvasculature.(14, 40) Another potential explanation for the lack of significance during HIIE could be due to women having a greater reactivity to carbon dioxide causing decreases in MCAv, which is supported by strong correlations between the change in MCAv and change in P_{ET}CO₂ in women compared to men.(41) Although we standardized the visits to be within days 1-7 of the follicular phase, we did not directly measure the effects of hormones on MCAv in both women and men in this study.

Limitations

There are limitations for the current study. First, the middle cerebral artery (MCA) diameter could not be directly measured. There is controversy whether MCA diameter is vasoactive with high intensity exercise induced hyperventilation.(42, 43) One study states that MCAv may underestimate changes in cerebral blood flow during changes in P_{ET}CO₂,(44) while another study reports no change in MCA diameter measured through magnetic resonance imaging with a P_{ET}CO₂ change of 7.5mm Hg during hyperventilation.(42) However, due to the difficulty of temporally assessing MCA diameter during high intensity exercise, we assumed the MCA diameter remains constant. Second, HIIE was dosed based on an estimated maximal intensity

rather than directly measuring the anerobic threshold. However, based on the P_{FT}CO₂ response, we believe the HIIE was accurately prescribed. Third, three individuals were also outside the window of 2-14 days between study visits. However, these individuals confirmed no changes to their health or physical activity routine between study visits 1 and 2. Therefore, in the context of this study design in healthy adults, the results were not likely skewed. Lastly, P_{ET}CO₂ was measured via nasal cannula, and breathing strictly through the nose during HIIE could become increasingly difficult. However, a study team member monitored nasal breathing throughout the entirety of the MCAv recordings and acute HIIE bout to ensure adherence to the protocol and appropriate P_{ET}CO₂ values. Future Considerations Prior literature reviews suggest HIIE results in rapid changes (oscillations) in blood pressure that could challenge the cerebrovascular system, particularly those with cerebrovascular impairment. (45) Despite these proposed considerations, high intensity gait training and interval exercise are recommended to improve walking for those with neurological disease. (46) Further, clinical practice guidelines are beginning to include HIIE with short intervals of 30-seconds or 1minute to improve walking outcomes after stroke. (28, 46, 47) The logical next step in this line of research will be to focus on clinical population such as stroke. **Conclusion** During an acute 10-minute bout of HIIE with short intervals, MCAv does not decrease below BL resting MCAv in healthy young adults. However, MCAv falls below BL resting MCAv following HIIE but returns to BL at 30-minutes after HIIE. Further exploration into the

regulatory response and physiological mechanisms contributing to a reduction in MCAv during passive recovery after HIIE is needed. This study contributes novel characterizations of the MCAv response to short interval HIIE in healthy adult controls, including changes in CVCi and sex differences.
