## 39 Abstract

Background: Tuberculosis preventive therapy (TPT) for latent TB infection has had limited success in
 Zimbabwe. The country plans to roll-out the three-month short-course TPT regimen (3HP) to address
 the implementation lag and poor uptake of the 6-9-month regimens. The study measured the level of
 organizational readiness while identifying barriers and facilitators to implement 3HP in four health
 facilities in Zimbabwe.

46 Methods: A convergent, parallel mixed-methods approach was used to collect data from four primary 47 healthcare clinics in Bulawayo and Harare Metropolitan provinces, Zimbabwe. Twenty healthcare 48 providers completed a 35-item, self-administered questionnaire designed on a 5-point Likert scale and 49 developed from the Weiner organizational readiness model .Nine of the providers and five TB program 50 managers took part in 20-30 minute individual semi-structured key-informant interviews . Median 51 scores with interguartile ranges were calculated wherein a score of 3.3 or greater indicated readiness. 52 Differences between facilities were assessed using a Kruskal-Wallis rank test. Qualitative data on 53 barriers and facilitators were transcribed and analyzed using a framework approach.

55 **Results:** Readiness to implement 3HP across the four facilities was positive with a score of 3.8(IQR 3.3-56 4.1). The difference between the best 4.0(IQR 3.8-4.2) and worst-performing facility 3.2(IQR 2.7-3.3) 57 was 0.8 and statistically significant (p=0.039). The low facility score was due to poor contextual factors 58 2.5(IQR 2.0-3.3), task demands 2.6(IQR 2.3-2.9), and resource availability 2.1(IQR 1.5-2.5) scores. Key 59 organizational readiness facilitators included healthcare provider and management buy-in; 60 community willingness to generate demand for 3HP; strong collective capability through task-shifting, 61 alignment with existing primary healthcare programs, perceived benefits, and need for 3HP. Barriers 62 were negative past TPT experiences, suboptimal programmatic monitoring, inconsistent health 63 provider remuneration, inadequate staffing, added workload, and an erratic supply chain across 64 facilities. The organizational communication gap prompts the slow program implementation culture.

66 Conclusions: The varied scores between facilities suggest distinct underlying conditions for readiness.
67 Healthcare provider motivation is temporary based on the inconsistent resource supply, absence of
68 TPT-specific monitoring and evaluation, and daily contextual challenges in facilities that must be
69 addressed. Similar research is necessary for countries yet to implement 3HP to optimize the design or
70 revision of delivery strategies and increase uptake of TPT.

## 73 Introduction

74 Despite significant increased access to treatment, tuberculosis (TB) accounted for 10 million active 75 cases and 1.3 million deaths in 2018 globally [1]. The re-occurrence of the growing burden of active 76 TB disease is driven by latent tuberculosis infection (LTBI), particularly in developing countries. 77 Persons with LTBI harbour Mycobacterium tuberculosis bacilli but are not infectious and cannot 78 spread TB to others [2], however, once infected, individuals are at the highest risk of developing active 79 TB [2]. One-third of the global population are carriers of LTBI which is an estimated 2.3 billion possible 80 new TB cases [2]. The WHO Africa, Western Pacific, and South-East Asia regions have the highest 81 prevalence of LTBI and account for 80% of the cases [2]. Zimbabwe fosters a high LTBI rate of 210 per 82 100 000 population and is one of 12 countries that contribute to 50% of the global TB burden [3, 4]. 83 With 14% of the population living with HIV, more individuals are at the risk of LTBI wherein progression 84 to active TB is high [3, 4].

85 As per WHO, a crucial strategy to prevent and eliminate active TB cases has been the treatment of 86 LTBI through the provision of TB preventive therapy (TPT), specifically daily self-administered isoniazid 87 preventive therapy (IPT)[3]. Provision of IPT is marred with challenges including constrained 88 effectiveness due to toxicity, low completion rates, suboptimal coverage ranging from 2.4% to 73%, 89 TB provider knowledge gaps, conflicting views on the importance of treatment, as well as the 90 uncertainty about the duration of treatment, i.e. whether it should be administered for six months, 91 nine months, 36 months or a lifetime [2, 3]. Shorter, safe regimens are crucial for increasing treatment 92 completion rates and curbing the spread of active TB disease [2,4]. These regimens include 3HR; a 93 daily three-month (90 doses) TPT and 3HP; a weekly three-month (12 doses) TPT of combined 94 rifapentine and isoniazid. The proposed three-month therapy to replace the standard IPT is 3HP as 95 3HR is offered in a few countries, only limited to children and adolescents aged less than 15 years and 96 still administered over a long duration [2]. Additionally, randomized control trials demonstrated that

participants taking 3HP had a threefold likelihood of treatment completion and improved outcomes
compared to participants taking 6-9 month IPT [4]. The WHO, therefore, released the 2019 updated
guidelines for the treatment of LTBI recommending the use of 3HP for people living with HIV (PLHIV)
and contacts of TB cases of any age in place of the standardized daily self-administered IPT [1].

101 In alignment with the updated WHO guidelines, the National HIV/AIDS and TB Control Program under 102 the Ministry of Health and Child Care (MoHCC) of Zimbabwe and partner non-governmental 103 organizations (NGO) set the Tuberculosis national TB strategic plan of 2017-2020 (TB-NSP) which 104 included the provision of 3HP in place of the current 6-month TPT at facility level [4]. The first phase 105 of the program implementation (quarters one and two of 2020) was earmarked for 20 health facilities 106 across five provinces in Zimbabwe [3]. However, the effectiveness and the success of the 3HP program 107 might be a distant reality as there are operational challenges within the National HIV/AIDS and TB 108 Control Program. Performance indicators are not being met including the sub-optimal performance 109 of the current 6-month TPT [3]. Challenges include the shortage of skilled health workers, lack of 110 capacity to recruit additional staff, lack of funding and training to support monitoring of TPT 111 implementation exacerbated by stockouts of essential medication as a result of decades of crippling 112 economic challenges [5]. Persistent IPT drug stockouts, for instance, resulted in the interruption of the 113 TB prevention program [5]. As vital as the change from standard IPT to treatment by 3HP is, the 114 aforementioned challenges could limit the successful implementation of the program.


Organizational readiness (OR) is vital and a necessary precursor to ensure successful implementation of the 3HP program in Zimbabwe. OR is defined as an implementation strategy to indicate the extent to which an organisation is psychologically and behaviourally prepared to implement a new program [6]. For example, an organization has to be willing and capable to implement a program for an effective outcome [6]. Studies indicate that about 50% of programs fail due to poor organisational readiness prior program implementation yet there is a dearth in the literature to indicate organizational readiness to implement the 3HP program among high burden, low-income TB settings such as 122 Zimbabwe [7]. Such a gap in knowledge affects the optimum response to the TB preventive efforts of 123 the country. An example highlighting the need to assess readiness before program implementation is 124 the low utilisation rates of the GeneXpert innovation to improve TB screening in Zimbabwe varying 125 from 50.4% to 63.5% despite its proven cost-effectiveness [5]. Similarly, piloting 3HP in facilities in 126 Zimbabwe without assessing OR, its perceived barriers, and facilitators by staff collectively could 127 present the failure to realize the real impact of 3HP. Therefore, determining OR is key to identify 128 bottlenecks as perceived by the organization's staff that could impede efforts to scale-up and to 129 develop recommendations for better implementation.

The outcomes of this study indicated the readiness to implement 3HP and possible influencing factors within the selected facilities in Harare and Bulawayo Metropolitan provinces. By using this method, we hope the quantitative measurement strengthened by the lived qualitative experiences will identify operational metric challenges of the facilities useful to the National HIV/AIDS and TB Control Program and address issues that might otherwise escalate into obstacles that could impede successful program implementation [6]. This is critical because 3HP is a key TB prevention strategy to offset prior suboptimal IPT implementation efforts [3].

137 To date, no organizational readiness study for the 3HP program has been conducted in the sub-138 Saharan region, including Zimbabwe. The study will contribute towards the theoretical knowledge of 139 implementation readiness before introducing 3HP in facilities and also expand on the lack of 140 consensus on the measurement of readiness. Hopefully, the study will demonstrate the importance 141 of considering readiness at the early stages of program implementation as it serves as a proximal 142 indicator to successful, quality program implementation without undesired consequences. This will 143 encourage monitoring and evaluation of the program at scale-up as well as tightening of potential 144 loopholes in the implementation. Additionally, lessons learnt from the study can be adapted to 145 facilities in the other provinces and later national level to give a more generalizable picture of 3HP 146 implementation.

## 147 Conceptualization of Organizational Readiness

148 In this study, elements in Weiner's (2009) model attempts to understand the collective efforts or 149 behaviour of members in an organization which lead to organizational readiness [6]. In the model, 150 contextual factors, task demands, resource availability, and change valence are mediating elements 151 of organizational readiness as a measure [6]. Change efficacy and change commitment are direct 152 elements affecting organizational readiness [6]. Weiner highlights the importance of the 153 interrelatedness of these factors that may affect readiness to implement a new program. For example, 154 when members are committed, it leads the capability or strife to conduct the program 155 implementation [6]. Change efficacy is based on three enabling factors, including task demands, 156 resource availability and contextual factors of the organization [6] (S1 Figure ).

## 160 Materials and Methods

#### 161 Study Design

This was a convergent, parallel mixed-methods study. Quantitative and qualitative data were collected in the same phase of the research process to measure organizational readiness and to explore barriers and facilitators that may affect readiness to implement 3HP in the four health facilities in Zimbabwe. The elements were analyzed independently, and the findings were triangulated and interpreted together. The purpose of this approach was to illustrate quantitative results with qualitative findings, synthesize complementary results for a more complete in-depth understanding of readiness and to compare multiple levels within the health care system [23].

## 170 Study setting, population, and sampling

171 The National HIV/AIDS and TB Control Program in collaboration with the IMPAACT4TB program aims 172 to pilot 3HP in twenty public health facilities across five provinces in Zimbabwe. In this study, data was 173 collected from four health facilities across Harare and Bulawayo Metropolitan provinces. The facilities 174 in Harare Metropolitan included Highfields polyclinic and Glen Norah Satellite clinic while in Bulawayo 175 Metropolitan, the facilities included were Pumula and Northern Suburbs clinics. The four facilities 176 were purposively selected based on physical location, similar facility sizes with respect to high out-177 patient volumes and same access to technical support. Additionally, Harare and Bulawayo 178 Metropolitan were the only provinces that had infectious disease hospitals that decentralized TB 179 prevention programs to 90% of their clinics, and hence it was expected that relatively higher out-180 patient volumes would access the 3HP intervention here [22].

182 The target population for this study were facility level staff (health facility managers or more 183 commonly referred to as charge nurses, TB nurses and primary care practitioners) that had worked 184 on the frontline and will directly implement the 3HP program. In addition, key informants such as a subset of the health facility staff (Charge nurses, TB nurses and primary care practitioners) as well as
non-frontline personnel within the implementation support structure of the facilities (National level
TB program managers inclusive of TB supply chain manager, the respective provincial-level TB
coordinators from the National HIV/AIDS and TB Control Programs; and TB program managers from
implementing and funding partners).
The study purposively selected 15 KII participants involved in the program that will implement 3HP in

facilities. Concurrently, at each facility level, there was a maximum of 5 staff members involved in TB programs [5] and therefore we administered questionnaires to all 20 participants available at the four facilities. As per Weiner's theory on organizational model guiding the study, readiness is measured at the supra-level and not at individual level [6]. Therefore, the study aggregated individual level data to represent shared perceptions within facilities.

## 198 **Procedures**

199 Data was collected simultaneously among various target groups from February and ended in March 200 2020. Information sessions were held individually with the participants to inform them about the 201 intervention, the aim, objectives and importance of the study. Thereafter, facility level staff (Charge 202 nurses, TB nurses and primary care practitioners) answered hard-copy self-administered 203 organizational readiness questionnaires to measure the level of readiness in implementing health 204 facilities. Concurrently, open-ended semi-structured interview guides were used to understand the 205 barriers and facilitators on the readiness with each of the fourteen (14/15) key informants lasting 206 approximately 20-30 minutes. Written consent for audio recording of interviews and willingness to 207 participate in the study was obtained from each participant. Both the qualitative and quantitative 208 study tools had been pre-tested by the PI in Bulawayo Metropolitan before the main study and there 209 was the need to modify the wording in the instruments for the participants' improved understanding. 210 Changes were channelled into the main study. The interviews were conducted privately by the PI in

three of the main local languages namely English, Shona and Ndebele at the participant workplaces over a period of 5 days in Bulawayo and another 5 days in Harare. Data were collected as audio recordings and field notes. The audio recordings were obtained to allow the investigator enough time to listen and transcribe interviewees' responses accurately. The transcripts were returned to participants for comment and/or correction. Field notes including descriptive and reflective information were captured in a diary by the investigator during or after interviews to ensure richness in the qualitative findings reported, interpreted and discussed.

## 219 Measures

220 The questionnaire used 5 point-Likert scale responses that comprised of eight sections. Section A 221 consisted of demographic characteristics. Section B-E supported an ordinal level of measurement. 222 Section H was the additional comments section consisting of open-ended questions. With regards to 223 section B-E, the Likert technique consisted of a series of statements to which one responded using a 224 scale of possible answers; 5-Strongly agree, 4- Agree, 3- Neutral, 2-Disagree and 1- Strongly Disagree. 225 The questionnaire also included open-ended questions about perceived limitations and 226 recommendations. Given that literature states that there is no standardized organizational readiness 227 questionnaire, the structured questionnaire was developed from the constructs of the Weiner 228 Organizational readiness model [6]. Cronbach's alpha was used to measure the internal consistency 229 (reliability) of the subscales and the composite scale [23]. The overall Cronbach alpha of the readiness 230 scale adopted was 0.92, a score above the threshold of 0.70. While resource availability had a low 231 reliability score of 0.50, change commitment, efficacy, valence, task demands and contextual factors 232 to implement 3HP in the facilities all had reliability scores of 0.76, 0.84, 0.93, 0.73 and 0.82 respectively 233 (S2 Table).


#### **Data Analysis**

236 Data from the hard-copy questionnaires was captured using REDcap by both the PI and the data 237 collector and exported into STATA 16 for statistical analysis. Cross-tabulations were performed in 238 STATA to describe the characteristics of the facilities and socio-demographics of staff. Results were 239 reported as frequencies and percentages for categorical data and means (standard deviation) or 240 medians (interquartile range) for numerical data. Responses from the organizational readiness 241 questionnaire which used Likert scale responses to measure the degree of agreeableness to 242 statements were presented descriptively using median scores due to non-normally distributed sub-243 scales, based on the Shapiro-Wilk test. Subscale median scores > 3.3 indicated areas of strength which 244 translate to the idea of "readiness" in that the respondents generally agree that the facility has the 245 attribute in a given subscale. Conversely, scores < 3.3 show areas of weakness and need attention 246 prior to change efforts. The Kruskal-Wallis rank test was used to test differences within and between 247 the facilities. The significance level was set at p-value <0.05.

249 All interview data were combined with the responses to the open-ended questions in the 250 questionnaire. The data were analysed as outlined by the framework method reported by Gale et al 251 [25].Once all the data was coded using the analytical framework, data was manually summarized in a 252 matrix through the charting process using Microsoft excel. The matrix compromised of one row per 253 participant and one column per code. Data was abstracted from transcripts for each participant and 254 theme, summarized using verbatim words and inserted into the corresponding cell in the matrix. The 255 study found MAXQDA software to be invaluable at this stage for quick and easy retrieval of indexed 256 data for specific themes within each transcript. Characteristics of KII participants including gender, 257 duration in current position, program area and level of organization were retrieved and presented.

## Results

259	The survey participants (S1 Table 1) included nurses (73.7%, n=14), charge nurses (15.8%, n=3) and
260	primary care practitioners (10.5%, n=2). There were more females (84.2%, n=16) as compared to the
261	males (15.8%, n=3). Majority of facility 1 respondents were aged above 50 years (80.0%, n=4), while
262	the majority of the respondents in facility 3 were aged between 40 – 50 years (60.0%, n=3) and
263	similarly in facility 4, most of the respondents were aged between 40 – 50 years (50.0%, n=2). There
264	were no participants (0%, n=0) who had provided TB services for $6 - 11$ months however most had
265	provided TB services for more than 2 years (79%, n= 15) with 100% of the facility 3 respondents having
266	provided more than 2 years of TB service. Between the two provinces, Bulawayo Metropolitan had
267	slightly more respondents in the facilities (52.6%, n=10) compared to Harare Metropolitan (47.4%, n=
268	7) (S1 Table).

## 275 Level of organizational readiness in the four facilities

- 276 The overall OR median score across the four facilities was 3.8 (IQR 3.3 4.1) above 3.3, the chosen
- 277 cut-off point for an acceptable level of readiness (S2 Table).
- 278

279 At the individual facility level, a total of three of the four facilities had median scores above the 280 readiness cut-off point. Facility 4 within Harare Metropolitan province was below the cut-off of 3.3 as 281 it had an OR median score of 3.2 (IQR 2.7 - 3.3). Low median scores were presented in the facility's 282 contextual factors 2.5(IQR 2.0 – 3.3), task demands 2.6 (IQR 2.3 – 2.9) and resource availability 2.1(IQR 283 1.5 - 2.5). The change commitment 3.7 (IQR 3.1 - 4.2), change efficacy 3.3 (IQR 2.8 - 3.6) and change 284 valence scores 4.2 (IQR 3.3 – 4.8) of facility 4 were above the cut-off. Alternatively, Facility 3 within 285 Harare province had the highest OR median score of 4.0 (IQR 3.8 – 4.2) although it presented a low 286 resource availability median score of 3.0 (IQR 2.8-3.3). Consequently, Bulawayo Metropolitan's facility 287 1 had a high level of readiness with an OR median score of 3.9 (IQR 3.9 - 4.0). The facility presented 288 high median scores in the change commitment, efficacy, valence, contextual factors, task demands. 289 Nevertheless, facility 1 presented a low median score of 2.8 (IQR 2.5 – 3.3) in the resource availability. 290 Facility 2 in Bulawayo Metropolitan province had an acceptable OR median score of 3.6 (IQR 3.4 - 4.1) 291 however a low resource availability median score of 2.8(IQR 2.5 - 3.3).

292

Significant differences were noted in the overall OR scores between the four facilities (p=0.039) (S2 Table 2). Within Harare province, significant differences were identified between facility 3 and 4 (p=0.016) wherein facility 3 readiness score was the highest compared to facility 4 which presented the lowest score below the threshold. Although there were no statistically significant differences in the change commitment , change efficacy, valence and task demands scores within provinces and between the four facilities across the provinces; significant differences were identified in the contextual factors between facility 3 and facility 4 within the Harare province (p= 0.016) and in the

- 300 contextual factors between all of the four facilities (p=0.011). Marginal significant differences were
- 301 found in the resource availability scores between the two Harare facilities (p = 0.048) (S2 Table).

## **305 Perceived Barriers and Facilitators**

- 306 Six (n=6) TB nurses and three (n=3) charge nurses were among those interviewed at facility level.
- 307 Additionally, five (n=5) program managers from the implementation support structure of the facilities
- 308 (National , provincial and NGO levels) were interviewed. Four participants were male while ten were
- 309 female. Work experience ranged from 1 to 17 years.

### 310 Change Commitment

- 311 Facilitators
- 312 The managers in the TB program believed that there was an overall stakeholder buy-in and willingness
- 313 to commit to the program change. A program manager with 3 years' experience believed that *"it is*
- 314 *worthwhile to change to the 3HP."* Similarly, most facility staff were optimistic and they expressed
- 315 willingness for implementation. A facility 1 TB nurse reported that
- 316
- 317 "We are positive, and we are willing to adapt to the program and implement it."
- 318
- Managers also generally reported excitement through demand generation for 3HP created by organizations and civil societies and patients. *"We have been working with a lot of community support organizations and civil societies. They have also been generating demand in communities and so yah I can definitely say there is a lot of excitement... So, this is not just health care workers pushing it to patients but actually patients coming in to ask to receive this therapy in place to the current one they are on, "* explained a TB program manager from a partnering NGO.

326 Barriers

327 Commitment was indicated to be temporary and contingent on factors including unsatisfactory
 328 remuneration and an inconsistent supply chain management in the facilities. For example, a program
 329 manager stated that

331	"The shortage of medicines can draw back the motivation of health care workers."
332	
333	Facility 1 staff reported burnouts due to workload therefore rewards were necessary to motivate
334	them. A charge nurse reported that
335	
336	"When it comes to burnouts, [pause] they will be complaining that they are tired and
337	they will not be motivatedThe incentives motivate them."
338	
339	Although most of the facilities indicated conditional commitment, facility 4 respondents were not
340	willing to implement the program due to their perceived on-going facility issues. "Considering we have
341	our own challenges already yeah I don't think people will quickly embrace it, " explained a TB nurse.

- 358 In a bid to increase acceptance and accountability, management aimed to sensitize "90 to 100%"
- of the staff in facilities.
- 360
- 361 Barriers
- 362 Both levels of participants reported negative staff attitudes.
- 363 "... we had negative attitudes from the service providers and then the patients
  364 themselves... knowing the possibilities of the adverse events." (IDI 1).
- 365 "The problem is that most of the nurses have attitude towards those patients. I am sorry
- 366 to say (uhm) but that is very natural. Attitude towards those TB patients with the fear
- 367 that they will catch TB in the process of nursing them... " (IDI 12).
- 368

The staff also reported a lack of confidence in the momentum. A TB nurse described that "...the kickstart will be okay but on the way you find some problems cropping up...like there can be no medicines for some time." Additonally, there remains a challenge of misinterpretation of the Ministry guidelines. A TB medicines supply chain manager explained that

- 373 "...we realized that the staff were initiating people on the current regimen yet they were
  374 not eligible...so the staff had everything and the eligibility criteria but their
  375 interpretation of that eligibility criteria was different and so those are some of the things
  376 that we need to put into consideration."
- 377 Both the management and facility level staff also stated that the informal nature of the 378 communication within the program caused a communication gap. A MoHCC manager 379 acknowledged explained that
- 380 "We write memos from national to province, province to district, district to facility. If there
  381 is break in the communication channel, it is possible to get to a facility and they tell you

382that they have not received that communication, so they are not doing anything about

383 it."

384

385 Participants reported that program coordination is affected by the flexi-hour system where nurses 386 rotate and only work two days a week. Nurses are transferred for the next rotation immediately after 387 familiarizing themselves with the day-to-day management of the program, and the next person 388 replacing has to familiarize with that work station again. A TB nurse explained that 389 "Now the rotations that are there, the TB nurses or the OI nurses that are there are so 390 used to the routine. Everything is smooth sailing and then you have to be changed... I'm 391 said to go to maternity then somebody new has to come here to OI and start adapting to 392 this whole thing. For a while that would be a challenge." 393 394 Lastly, systematic challenges including a poor monitoring and evaluation system was reported by all 395 the respondents as there was said to be '...a great need for management to work with facilities on the 396 ground' at the early stages of implementation to enable strengthened data management and 397 reporting.

398

## 399 Change Valence

400 Facilitators

401 A positive factor was the perceived program appropriateness which was the relevance and 402 compatibility of the 3HP innovation to address problems within the existent program. A TB program 403 manager stated that *"we do believe a lot of issues from the previous regimen , IPT will be addressed…"* 404 Similarly, the change effort was perceived as a need and was described to be timely as to alleviate 405 medicine stockouts that facilities were experiencing. *"The timing is right…we are running short of the* 406 *current IPT medicines,"* explained a TB nurse.

408 Additionally, all facility staff expressed that the program would be regarded as a priority. A charge409 nurse echoed this as follows,

- 410 "TB is one of the priorities in any council clinic so I believe if 3HP is a prevention strategy
  411 as part of TB programs, it would be a priority here."
- 412

413 The staff further discussed the relative advantages the program may offer such as lower costs 414 and risk of mortality for their clients. A TB nurse and focal person believed that "...it actually 415 brings with it a lot of relief, to the community in the sense that it provides low cost strategy in 416 the long run. Patients are not required to continue coming to the clinic because treatment 417 duration will be cut down which reduces the frequency of visits so it is less transport cost for 418 them." Facility staff also believed that the program would be of beneficial value to them and 419 their health indirectly as they feel the treatment may reduce the risk of TB transmission within 420 their workspace.

- 421
- 422 Barriers
- 423 The recurring perception was that if patients were not interested nor valued the regimen, the program

424 implementation would be negatively affected regardless of high valence among facility staff. This was

- 425 a focal point for seven of the fourteen participants, and examples of their responses included:
- 426 "Yes, we are saying 3HP will produce good results but the challenge comes on clients...
- 427 *clients are already complaining of taking a lot of pills"* (IDI 14).
- 428

The 3HP pill burden is huge...So for us we might be happy that it is a short regimen but
the burden then comes to the patient or the recipient of care. They are the ones who are
going to decide whether they are willing to take 10, 13 tablets once a week at once or
they want to take 1 or 2 tablets every day for 6 months." (IDI 2).

- 433 The trade-off between a higher pill burden over a shorter period of time versus lower pill burden over
- 434 a long period of time could affect the patient value of the program change.

435

#### 436 Task Demands

- 437 Facilitators
- 438 Managers reported that staff in the facilities will be provided with the materials and tools necessary
- 439 to guide them with little effort required. A MoHCC program manager explained that
- 440 " A lot of printed flow charts will be stuck on the walls of the facilities...even without
- 441 opening the book but by just looking on the wall, they can see any SOP and they will be
- 442 easily guided."
- 443

444 A provincial manager anticipated smooth integration of programs as rendered previously and stated 445 that *"we have implemented programs in the past very well...the IPT was already integrated so we* 

446 would think we will have no problems integrating this TPT into the program." Overall, management

- 447 expressed positive insights in contrast to facility.
- 448

449 Barriers

450 Regardless of the perceived basic effort reported by the managers, there was an anticipated challenge 451 of increased workload, specifically registers with the introduction of the 3HP program amongst the 452 staff in all of the facilities. A charge nurse explained that "complex registers" strained their workload 453 and reported that 454 *"Each program comes with new registers... we have so many registers besides our work* 

- 455 to enter...we have to fill this register, now I go to the EPI program there are registers, you
- 456 go to the OI program a heap of them and now the TPT [laughter]. That's the only
- 457 challenge we can really have with the work load..."
- 458

459	Although some facilities reported that the increased workload was due to facility staff
460	shortages, a MoHCC program manager stated that the workload should not be a challenge as
461	staff were expected to "synchronize their activities, to harmonize their service provisions and
462	provide services under a one stop shop approach"

463

- 464 The second barrier included time constraints within the staff schedules. A charge nurse reported that
- 465 there was an inability to complete all their tasks and stated that they "...cannot help all of the patients

466 in a day, the ratio of all patients to health personnel is hectic."

467

## 468 **Contextual Factors**

- 469 Facilitators
- 470 Managers stressed that the importance of the initial implementation phase was for management to

471 show support to their facilities which in turn will allow for staff to follow suit and support their TPT

472 patients. A MoHCC program manager echoed and explained this

- 473 " ... we will continue to visit facilities and make sure that whenever they come across
- 474 patients, they will support them the same as we get support. That is the importance of
- 475 this initial phase."

476 Moreover, management and staff both also believed that facilities are accustomed to research and

- 477 innovation which will facilitate change implementation. A charge nurse explained that
- 478 "People are not resistant to change. There are a lot of programs that are coming, and
- 479 they are dynamic and there is need to move we cannot stay in one place."

480

481 Barriers

482 Support and managerial oversight is inconsistent in facilities affecting facility staff. Support of staff in

483 terms of their wellbeing was no longer made available as in the past which exposes them to infectious

484	TB patients. They explain that they are "exposed waiting to get sick." A TB nurse and focal person
485	described that managerial oversight is inconsistent affecting facility staff.

- 486 "Visit us periodically. Not just introducing a program and go [laughing]...In the [name of
- 487 organization] program it is also a TB program, we only did a workshop last year. They are
- 488 not following up on us."
- 489

490 Facilities also stated that they have experienced negative encounters such as adverse effects on

491 patients while implementing TPT programs which the managers reported that they are aware it can

- 492 impact staff confidence. A TB nurse recounts her experience
- 493 "What happened here at the clinic...there are these bad side effect that happened to our
- 494 patients eeeh [ shakes head] ... one of my colleagues, we were together in the room when
- 495 a patient developed [pause], it was like a syndrome or something like that. The patient is
- 496 in a wheelchair till today, whenever they come to clinic, we feel bad. What if it happens
- 497 to me that I am the one with two or more that are put in wheelchairs?"
- 498
- 499 The managers believed that the whole organization *"…has not been performing well in the last few*
- 500 years" regarding TPT and the culture of slow program implementation in the facilities could affect this
- 501 program change. A nurse gave an example;
- 502 "At times they take long because of the availability of the drug for example introducing
- 503 [name]. It was introduced in 2015, we only started giving it last year [laughs] as in 2019.
- 504 Four years later."

505

## 506 **Resource Availability**

507 Facilitators

508 Managers at national level reported that efforts at central level were made for the program's smooth

509 logistic flow in facilities.

510	"We look at our plan holistically and based on what we can get , we start off by initiating
511	10% of our clients and monitor the progress. That is how we see that our supply and
512	programming match. This reduces ruptures within the supply in our programsthere is
513	also a mechanism in place where facilities can place emergency orders from the central
514	stores and depending on the province they are in, there is a turnaround time of about two
515	weeks" (IDI 3)
516	The NGO program manager also explained the importance of partnerships between
517	organizations and the Ministry for the program's funding.
518	"We also made sure to choose sites supported by PEPFAR to ensure sustainability of this
519	work. One; because these are supported in terms of staffing, and two; TPT scale up is a
520	priority with PEPFAR"
521	
522	Barriers
523	Despite the efforts to improve the logistic flow at national level, provincial managers and staff stressed
524	that the irregular supplies of the 6-month IPT program affected their perception of the change effort.

- 525 "...there were erratic supplies of late...the logistic flow was not good. You find that drugs are
- 526 plenty in one province and in another there is nothing."

527

528 Staff reported recurring human resources shortages at facility level whereas management stated that 529 *"there is high turnover of the staff...they leave the facilities after being trained."*. Moreover, staff 530 reported a lack of incentives and irregular remuneration due to management not being favourable of 531 the concept. Additionally, the NGO program manager reported that production capacity and 3HP 532 pricing were external barriers to the supply chain beyond control.

533 "The supplier's capacity did not turn out to be what they had initially committed [pause]
534 so they could not commit to the volumes that our country needed... another thing was
535 that the drug price ... these are things that delayed rollout at country level."

536	It was further stated by the manager that "we anticipate further delays now with the COVID-
537	19 pandemic." Nevertheless, provision for sustainable funding after the initial implementation
538	phase remains unclear as the program heavily relies on partnering and actively present NGOs
539	within the facilities. An application for funding towards the scale-up of the program was still in
540	the development stages. The partnering NGO recommended that "clear commitment for
541	funding would enable the program to include all eligible patients without adjustment of the
542	guidelines" (S3 Fig ).



## 562 **DISCUSSION**

- The findings from this study identified fundamental facilitators and barriers which will prompt further planning and improvement to the 3HP program prior to implementation in the four facilities. The improvements could influence implementation effectiveness.
- 566

## 567 Level of Organizational Readiness to Implement

568 Three of the four facilities (facility 1,2 and 3) welcomed and saw a need to implement the intervention. 569 Our findings are supported by the measurements of readiness scores per facility which were above 570 the threshold. We believe the high scores demonstrated that staff in the three facilities were most 571 likely to collectively commit and demonstrate a more consistent, high quality use of the intervention 572 [6]. The results led to a similar conclusion in Shaw et al's study where high readiness scores reflected 573 the degree of commitment and efficacy among facilities towards implementing a telemedicine 574 behavioural program [15]. This is consistent with a South African study that used readiness scores to 575 indicate that four of five schools collectively valued a combined HIV and nutrition intervention highly 576 enough to commit to its implementation. Similar to our study, the two mixed methods studies used 577 adapted context-specific tools to measure readiness [6, 15]. Although this is widely accepted, an 578 apparent limitation is that the tools were adapted from contexts outside of the clinical or health fields 579 due to limited healthcare readiness studies [31]. It is worthy to further note that literature indicated 580 a paucity of studies assessing the level of readiness to implement 3HP in the Zimbabwean context and 581 the few studies on 3HP implementation were based in high-income countries such as Canada.

582

583 Our results also demonstrated that facility 4 of Harare Metropolitan province was not ready to 584 implement 3HP compared to the other 3 facilities. Additionally, staff in the facility qualitatively 585 indicated that "... we have our own challenges already...I don't think people will quickly embrace it." 586 At this stage of understanding, Weiner's theory suggests that low readiness reflects the need for 587 additional support before implementation to curb the facility potentially resisting change, putting less 588 effort, persevering less in the face of challenges, and exhibiting compliant intervention utilisation [6]. 589 Our finding also showed that the low readiness in facility 4 was due to low contextual factors, task 590 demands and resource availability. The result of our study is then compared to Shaw et al's study 591 which found non-readiness in facilities due to a lack of commitment [15] and due to contextual factors 592 including leadership, fidelity, costs and partnerships in another review [32]. The difference in the 593 studies is attributed to the main limitation of the inconsistency of constructs measured which may 594 impact readiness to implement. For example, our study did not account for leadership whereas 595 Rubenstein et al's study used the CFIR framework which found the construct to be key in the non-596 readiness of facilities [33]. However, a review suggested that there is no gold standard in readiness 597 studies as existing issues were tailored to specific studies, interventions and settings [34]. From this 598 standpoint, we believe our study is the first to contribute important findings specific to the 3HP 599 intervention and possibly other TB program readiness studies.

601 Our findings on the difference in facility scores at least hinted that each facility had specific underlying 602 conditions for readiness to implement 3HP. For example, one Harare Metropolitan province facility 603 had the highest readiness score while the other was not ready and had the lowest score among all of 604 the facilities. The difference between the two facilities was due to varying contextual factors and the 605 availability of resources which was supported by the qualitative findings as well. This is consistent with 606 two previous studies whereby intervention sites differed in readiness due to varying resource 607 availability and reported contextual conditions such as past experiences in implementing programs 608 per the specific setting [33]. It is worth discussing that our study's approach of including facility staff 609 plus supplemental qualitative accounts from different levels of management provided more detail on 610 the varying conditions that lead to readiness as compared to Rubenstein et al's study that indicated a 611 limitation of only including reflections from facility leaders as a representation of the facilities [33].

## 613 Perceived Barriers and Facilitators of Organizational Readiness

The findings demonstrated that change commitment, efficacy and valence were key facilitators of readiness to implement 3HP. The key barriers emanating were task demands, contextual factors and resource availability.

## 618 Change Commitment

619 Change commitment was high among all the facilities and the finding was qualitatively supported by 620 the perception that there was overall buy-in from stakeholders. This result ties well with previous 621 studies that indicated that shared interest and commitment between managers and staff were found 622 to be important precursors for a successful intervention [19, 25,6]. Although staff in the study 623 indicated that they were motivated, there was the possibility of temporary buy-in dependent on issues 624 such as inconsistent staff remuneration, increased work load and an inconsistent supply chain in 625 facilities. This is challenging and has led to frequent strikes in Zimbabwe among frustrated health care 626 workers disrupting implementation of programs [35]. A similar pattern of findings were obtained in 627 Zhang et al's study suggesting that discrepancies between the current and desired conditions within 628 an organization overshadowed the high change commitment for programs [26]. Notwithstanding, our 629 study had limited time and resources therefore was conducted at one-point in time as compared to 630 the aforementioned previous study that measured readiness at the pre-adoption, pre-631 implementation and post-implementation stages of the program [26].

## 633 Change Efficacy

There was high collective capability (efficacy) scores which paralleled positive qualitative findings such as the availability of refresher trainings, task-shifting of services, the anticipated basic and clear process of the implementation in facilities. However when comparing our results to those of older studies, it was indicated that efficacy may potentially be affected by varying factors. Firstly, although 638 staff may report high efficacy to perform tasks, it is possible that they may not be able to create 639 meaningful change due to the inability to mobilize resources in an efficacious manner for the desired 640 implementation effort [6]. Secondly, the efficacy to collectively perform tasks can be affected by 641 commitment and vice versa. For instance, Keshni (2020) stated that readiness is likely to be high when 642 members not only feel confident to perform tasks but also want to do so [14]. Similarly, we 643 demonstrated that the lack of confidence to implement previous TPT was attributed to by negative 644 staff attitudes. Therefore our findings contribute to the idea that efficacy is interrelated to 645 commitment. Lastly, apparent systematic challenges such as task co-ordination and flexi-working hour 646 system in the facilities may affect efficacy. In this case, our finding lends support to earlier studies 647 which popularly explain that discrepancies in efficacy are due to the differentiated roles in facilities 648 (i.e. nurses, charge nurses, administrators and medical directors) [21, 28]. Therefore for future work, 649 it is worthy to note that some questions in readiness tools may have more of a clinical meaning for 650 participants, for example in our study that were majorly nurses as compared to other studies that had 651 mostly leaders who may have more of an administrative meaning [28].

#### 653 Change Valence

654 Measured scores were supported by recurring textual findings that indicated that staff collectively 655 valued the program highly. Staff felt that the previous suboptimal TPT implementation would be 656 alleviated by the benefits of 3HP implementation, considered it a core priority within all facilities and 657 comprehended it enough to commit to its implementation. This is warranted by staff acknowledging 658 that they were willing (commitment) to implement the program because change in programs was 659 urgently needed for the well-being of their patients. Our findings therefore indicate the link between 660 change valence and commitment to positively influence readiness to implement. Our study is in line 661 with Weiner's theory (2009) and Keshni et al's study whereby change commitment was proposed as 662 a major function of change valence, that is, if organizational members value the change then the they 663 will want to implement the change [6,14]. However, the main limitation is that individual perceptions

664 are given in each study instead of collective staff perceptions of the program value which may 665 implicate consistent, cross-situational relationship between change valence and organizational 666 readiness. Future studies need to indicate if change valence resulting from different individual reasons 667 might be as potent in readiness outcomes as change valence resulting from commonly shared reasons. 668 Additionally, although the study reported high valence, facilities stated the challenge of an oversight 669 of patient input on the value of the 3HP program. In line with our findings, a study posited that 670 patients are often omitted from the implementation planning phase yet their value of the intervention 671 holds a considerable amount of weight with regards to the implementation outcomes and program 672 performance [15]. The patients' perceptions would reflect if change valence truly influences readiness 673 to implement despite the acceptable overall change valence score.

674

#### 675 Task Demands

676 Our findings showed recurring challenges mostly in facility 4 despite staff having anticipated little 677 effort to offer the new regimen and a smooth integration of program activities within existing HIV/TB 678 programs. Barriers as described by the staff included increased workload in the form of paperwork 679 instead of availing the underutilized electronic system. The increased workload was mostly attributed 680 to a lack of human resources in the facility as staff recommended that increased human resources 681 could offset the strained workload. Shea et al's study findings were consistent with our findings and 682 similarly recommended for the recruitment of more staff plus provision of additional support to 683 improve readiness levels [28]. Another identified challenge was that staff may not have devoted time 684 for the program within their overwhelmed schedule which might impede implementation. Keshni et 685 al's study explains that if the facility is not inclusive of implementation efforts in the staff schedules, 686 slow implementation will occur [14]. Our study recommends that facilities should develop and 687 implement work transition plans to develop continuity plans which would mitigate both barriers 688 presented with regards to task demands.

## 690 **Contextual Factors**

691 Our study quantitatively confirmed that the facilities had distinct, acceptable contextual conditions 692 however the qualitative findings detailed a myriad of challenges particularly in facility 4. For instance, 693 support in facilities was rendered by key stakeholders however it was inconsistent and a further lack 694 of support for the staff's wellbeing was reported which both led to their negative attitudes. Izudi 695 revealed that TB staff commonly present negative attitudes due to fear of contraction of TB from their 696 patients affecting their performance to carry out tasks [29]. The provision of routine testing for staff 697 implementing the TB program in facilities was recommended by staff in our study. Another challenge 698 was the slow implementation of programs, for example facilities reported 4 year delays after trainings 699 to implement programs. Additionally, our results suggest that the high number of adverse events 700 associated with TPT contributed to the negative past experiences in facilities. We believe these 701 combined could result in staff not embracing the innovation and therefore could impede readiness 702 just as Amatayakul concluded that negative experiences could deter facilities from reaching 703 organizational readiness [30]. The difference in studies, however, is that our findings go beyond to 704 show that negative past experiences negatively affect the staff's value of the program and their 705 capability to implement it. Therefore, our findings contribute further to readiness evidence in 706 demonstrating that contextual factors affect valence and efficacy which are proximal factors for 707 readiness. Nevertheless, our study was guided by Weiner's framework as compared to Amatayakul's 708 study which is guided by the Consolidated Framework for Implementation Research (CFIR) with 709 different constructs [3]. Although facilities faced multiple contextual barriers, the staff indicated that 710 they are accustomed to research and its rapidly changing nature which may contribute towards 711 acceptance of implementation efforts.

## 713 **Resource Availability**

714 Resource availability was not at a sufficient level for the implementation effort to occur effectively 715 which was supported by identified qualitative barriers. Recurring challenges were the shortage and 716 the inequitable distribution of staff as observed between facilities 3 and 4. The finding may be 717 warranted by the smaller number of staff that were available in facility 4 as compared to the other 718 facilities in the study. It was recommended that facilities should allocate personnel to serve as 719 implementation champions to facilitate the process as similarly suggested by Ochurub, Bussin, Goosen 720 [19]. We further demonstrated the lack of staff incentives that negatively impacted willingness. It is 721 generally accepted that incentives and rewards increase job satisfaction, teamwork, as well as help 722 staff, feel equipped to undertake a new initiative [14]. Alternatively, Scaccia et al's [25] findings argue 723 that staff may be motivated enough to work with whatever resources are available. The difference in 724 study contexts may have led to the difference in conclusions therefore we believe that contextual 725 conditions may play a key role in facilitating implementation despite resource inadequacy. However, 726 given poor contextual conditions in Zimbabwe's health care system [36], our study argues for more 727 planning and the actual provision of resources to enhance facilities' chances of readiness to 728 implement.

729

Managers explained that unforeseen, external issues occur such as 3HP pricing and production capacity delays exacerbated by the onset of the COVID-19 pandemic which cannot be resolved at the country level. This is broadly in line with a study that highlighted the unexpected disruption in the implementation of HIV programs in Sub-Saharan African countries due to priority shifts at the start of the pandemic [37]. It is worthwhile to note there were positive aspects identified by managers which may overcome unforeseen consequences such as the early forecasting and quantification of supplies; and fostered partnerships for funding for the first phase of implementation.

## 738 Strengths and Limitations of the Study

739 The main limitation of the proposed study rests primarily on the sample size particularly the survey 740 sample which may not be statistically representative however the aim was firstly to analyse at the 741 facility, not the individual level and to strengthen understanding of the social processes involved in 742 implementation therefore sample size is of less concern. Although the sample size was large enough 743 to measure OR in the study, it restricted further additional statistical analysis. Notwithstanding, 744 Weiner, suggests that OR measures should be descriptive and not evaluative (6). Moreover, the 745 generalizability of the results may be limited to the four facilities that were operated by the same 746 entities however as in implementation science, the key is to draw on lessons learned to inform policy 747 and implementation approaches in similar contexts(6).

748

749 Although the ORIC tool was adapted to suit the study context and design, the resource availability 750 subscale was slightly below the threshold Cronbach alpha level. However due to the shown acceptable 751 overall Cronbach alpha scale indicating the tool's high reliability in consistency, the subscale was 752 retained. Another limitation is construct bias wherein the selected Weiner OR conceptual model to 753 guide the study may have omitted other constructs that affect readiness including implementation 754 climate (14). Additionally, constructs within the conceptual model overlap and are not always discrete. 755 Future studies are required to improve OR models and their constructs. Nevertheless, the current 756 study provides insight into readiness factors that relate to the implementation of a TB preventive 757 therapy which has received little attention thus far.

758

The study employed mixed methods which provided several merits. The combination and triangulation of the quantitative and qualitative analysis methods facilitated understanding the complexity of organizational readiness to implement 3HP. The quantitative helped measure the level of readiness and its factors as a useful benchmark of the sites. The qualitative offered insight into the challenges and influences of readiness. The interviews were held until saturation was achieved which
is important in exhaustively underscoring the reasons for the measured scores in facilities.

# 766 Conclusion

767 In conclusion, three of the four facilities were ready to implement 3HP in Harare and Bulawayo 768 Metropolitan province. Facility four of Harare Metropolitan province was not ready to implement due 769 to low task demands, contextual and resource availability factors. Each facility had differing strengths 770 and weaknesses to be deemed ready to implement the intervention, but these would likely not be 771 revealed without triangulation of OR scores and interview data. Potential factors that could either 772 facilitate or hinder effective implementation were identified to allow enhancements to be made to 773 the intervention implementation strategy. Facilitators identified were change commitment, efficacy 774 and valence which should be considered in developing the steps towards meeting acceptable 775 readiness levels to implement 3HP in facilities. The barriers included were task demands, contextual 776 factors and resource availability.

777

778 The study findings demonstrate the necessity for further research to assess OR prior to 3HP TPT 779 implementation in health facilities. Considering the limitation to generalize our findings, the study 780 should be scaled up in other high TB settings in Zimbabwe as well as the other high TB burden 781 countries yet to implement 3HP. Although implementation of the TPT program change will be 782 staggered into phases, our study assessed readiness at one point in time as opposed to continuous 783 assessment. We recommend the periodic evaluation of readiness within health facilities for optimal 784 delivery of the program to ensure successful implementation. It is worthwhile to note that conditions 785 for readiness per facility can differ therefore OR is critical for efforts to carefully attune 786 implementation according to the strengths and barriers present at each facility. Moreover,

- policymakers need to take into account that facilities with less readiness to implement may require
- 788 more flexibility to reach the intended program merits.
