Correlation between the environmental parameters with outbreak pattern of COVID-19: A district level investigation based on yearlong period in India

Abstract –

The present study has investigated the role of regional meteorology and air quality parameters in the outbreak pattern of COVID-19 pandemic in India. Using the remote sensing based dataset of 12 environmental variables we correlated infective case counts at a district level in India. Our investigation carried out on the circumstantial data from more than 300 major affected districts in India and found that air quality parameters are playing very crucial role in this outbreak. Among the air pollutants, O<sub>3</sub> was better correlating with infection counts followed by AOD, CO, NO<sub>2</sub>, BC and SO<sub>2</sub>. We also observed that among the weather parameters air temperature, incoming shortwave radiation, wind speed are positively and significantly associate with outbreak pattern and precipitation and humidity are negatively correlated with confirmed cases; only cloud cover has no significant relation. We noted that coastal districts in the both coast of India and districts located in the plain and low-lying areas have experienced bitter situation during this pandemic. Our study suggests that improving air quality with proper strict regulations and complete lockdown during the peak of pandemic could reduce the misfortune in all over India.

## 1 Introduction

2 In the 21st century, the world has been battle-scarred by the pernicious ordeal of coronavirus  
3 disease (COVID-19) since early 2020. By the end of March, 2021, a total of 152,006,071  
4 confirmed cases with a death toll of 3,193,315 have been registered all over the world  
5 (<https://www.worldometers.info/coronavirus/>). This pneumonia infection caused by Severe  
6 Acute Respiratory Syndrome CoronaVirus-2 (SARS-CoV-2) had initially broken out in  
7 Wuhan, Hubei province, China during late 2019 (Guan et al., 2020; Liu et al., 2020a; Wu and  
8 McGoogan, 2020; Zhu et al., 2020a; Zu et al., 2020) and gradually spread all over the world  
9 (Bertuzzo et al., 2020; Gorbalenya et al., 2020). Contemplating the hasty unfurl of this virus  
10 and its human-to-human transmissibility from contagion (Wang et al., 2020a; Wang et al.,  
11 2020b; Wang et al., 2020c), the World Health Organization (WHO) declared this disease to  
12 be a global pandemic on March 11, 2020. India, the domicile of 17.7% of the total world  
13 population had noted its very first COVID-19 confirmed case on January 27, 2020, and  
14 afterwards a total of 12,220,717 cases have been confirmed by the end of March, 2021 with a  
15 death count of 162,960 (<https://www.covid19india.org/>).

16 Worldwide sundry clinical inspections of COVID-19 have diagnosed respiratory droplets and  
17 fomites from contaminated persons as the spawn agent of this lethal disease (Alag, 2020; Ge  
18 et al., 2013; Huang et al., 2020a; Jana et al., 2020; Jung et al., 2021; Kunz et al., 2020;  
19 Sathian et al., 2020; Tuttle, 2020). Umpteen researchers also reported about analogous  
20 symptoms of this disease to MERS and SARS (Holshue et al., 2020; Perlman, 2020; Tan et  
21 al., 2005; Wang et al., 2020c). Since the SARS-CoV-2 virus initially causes respiratory  
22 damage and this disease has very close similarities to the influenza in terms of various  
23 symptoms like Fever, Cytokine storm syndrome, diffuse alveolar damage, Lymphopenia,  
24 Coagulation, and immunocompromised conditions (Harapan et al., 2020; Khorramdelazad et  
25 al., 2021; Larsen et al., 2020; Li et al., 2021), a few researchers have already exhorted about  
26 significant association of environmental parameters to COVID-19 transmission (Azuma et  
27 al., 2020; Bherwani et al., 2020; Eslami and Jalili, 2020; Gupta and Pradhan, 2020a; Kifer et  
28 al., 2021; Rume and Islam, 2020; Saadat et al., 2020; Shakil et al., 2020). Mention Worthy,  
29 earlier shedload of studies have conjectured about conspicuous impact of weather conditions  
30 on dissemination of respiratory viruses and its seasonality (D'Amato et al., 2018; Pica and  
31 Bouvier, 2012; Price et al., 2019). There are also a few global as well as regional studies that  
32 had been carried out in the context of China, USA, England, Germany, Spain, Italy,  
33 Indonesia, Iran, Pakistan, Bangladesh, India, and found significant correlation between  
34 weather parameters and the COVID-19 cases (Ahmadi et al., 2020; Chen et al., 2021; Fadli et  
35 al., 2020; Ficaretola and Rubolini, 2021; Gupta et al., 2020a; Gupta and Pradhan, 2020b; Islam  
36 et al., 2020; Liu et al., 2020b; Ma et al., 2020; Mehmood et al., 2021; Nottmeyer and Sera,  
37 2021; Oliveiros et al., 2020; Qi et al., 2020; Tosepu et al., 2020). On a contrary, a few studies  
38 have also reported that meteorological observations are not significantly associated with the  
39 outbreak pattern (Iqbal et al., 2020; Jahangiri et al., 2020; Jamil et al., 2020; Mollalo et al.,  
40 2020; Shi et al., 2020; Xie and Zhu, 2020). Studies carried out by Bochenek et al., 2021;  
41 Borah et al., 2020; Briz-Redón and Serrano-Aroca, 2020; Emediegwu, 2021; Guo et al.,  
42 2021; Gupta et al., 2020b; Mecenas et al., 2020; Runkle et al., 2020; Şahin, 2020; Sil and  
43 Kumar, 2020 suggested that warm and humid condition seem to foreshorten the proliferation

44 of COVID-19. On the other hand, (Al-Rousan and Al-Najjar, 2020; Awasthi et al., 2020;  
45 Bashir et al., 2020a; Fawad et al., 2021; Gupta and Pradhan, 2020a; Kumar and Kumar, 2020;  
46 Pani et al., 2020; Sangkham et al., 2021; Selcuk et al., 2021; Sharma et al., 2021) reported  
47 that hotter days might be more susceptible for COVID-19 dissemination while the role of  
48 humidity was still incongruous (Aidoo et al., 2021; Auler et al., 2020; Gupta et al., 2020c;  
49 Kumar, 2020; Yuan et al., 2021). Menebo, 2020 found negative association between  
50 precipitation and COVID-19 cases, contrary to Byass, 2020; while Gunthe et al., 2020 found  
51 no significance of precipitation and cloudiness for this outbreak.

52 Studies have enunciated that frequent short-term exposure to air pollutants could aggrandize  
53 the likelihood of symptomatic acute respiratory infections among adults (Kim et al., 2018;  
54 Kirwa et al., 2021; Xing et al., 2016). Chauhan and Johnston, 2003; Zhang et al., 2019a had  
55 reported that moderate and long-term exposure to imprudent volume of the oxidant air  
56 pollutants like Ozone (O<sub>3</sub>), Nitrogen di-Oxide (NO<sub>2</sub>) have the potential to exacerbate the  
57 inflammatory effects of the viral and bacterial respiratory infections. Insufflating such air  
58 with prohibitive concentration of Particulate Matters (PM) and Carbon Monoxide (CO) have  
59 been also inculpated for escalating the risk of cardiovascular and respiratory diseases, and  
60 contributing to the mortality rate inclusively (Huang et al., 2018; Khaniabadi et al., 2017; Liu  
61 et al., 2018; Yang et al., 2020a). Recent studies have stated that both short-term and long-  
62 term exposure to different air pollutants including PM (PM<sub>2.5</sub>, PM<sub>10</sub>), Sulphur di-Oxide  
63 (SO<sub>2</sub>), CO, O<sub>3</sub> and NO<sub>2</sub> could contribute significantly to the higher rates of COVID-19  
64 infections in different parts of the world (Ali and Islam, 2020; Bourdrel et al., 2021; Coker et  
65 al., 2020; Gujral and Sinha, 2021; Jain et al., 2021; Li et al., 2020; Lin et al., 2020; Ma et al.,  
66 2021; Matthew et al., 2021; Mele et al., 2021; Sharma et al., 2021; Suhaimi et al., 2020; Wu  
67 et al., 2020), therefore positively associated with the conveyance of COVID-19. O<sub>3</sub> is also a  
68 salient precursor of hydroxyl radical (OH), thus it also entices the concentration of SO<sub>2</sub> and  
69 CO (Logan et al., 1981; Thompson, 1992). On the other hand, the carbonaceous pollutants  
70 i.e. CO and BC and OC, which also includes the primary and secondary organic carbon, are  
71 mainly produced during different anthropogenic activities of biomass burning and fossil fuel  
72 combustion, with relatively little contribution from various natural sources (Li et al., 2016;  
73 Prabhu et al., 2020; Schmidt, 2011; Wang et al., 2019; Winiger et al., 2016; Zhang and  
74 Wang, 2011). Though the source mechanism of these carbonaceous agents are presumably  
75 analogous, its spatial concentration differs due to the complex physio-chemical  
76 transformation in wayward meteorology (Saliba et al., 2010; Vautard et al., 2007). AOD, an  
77 illustrious indicant of Particulate Matter pollution (Chudnovsky et al., 2014; Engel-Cox et al.,  
78 2004; Gupta et al., 2021; Karimian et al., 2016), accounts columnar concentration of gaseous  
79 and liquid airborne particles has not been often related to such malady study. Since the  
80 significant relation between prevailing weather conditions and regional pollution level is well  
81 demonstrated by various studies, it becomes very crucial to behold the role of meteorology  
82 and air quality togetherly to conceive the seasonality of such savage seizure of coronavirus.

83 Scanty studies have been carried out on the importance of freshen air for the melioration of  
84 human health and to elude any convalescence (Cragg et al., 2016; Kampa and Castanas,  
85 2008; Manisalidis et al., 2020; White et al., 2019). Likewise, scarcely any study has been  
86 fanatical about the significance of weather parameters on COVID-19 recovery, even though

87 93.88% of the sufferers have been healed in India, slightly lesser than the global recovery rate  
88 (97.42%) till March 31, 2021. Since a handful of studies had reckoned that the inferior air  
89 quality had efficaciously swayed to aggravate the COVID-19 emanation, hence it becomes  
90 also requisite to investigate whether the convivial air quality has been benevolent to  
91 convalesce the COVID-19 patients in India. Till date, seldom study might have inspected the  
92 yearlong period of pandemic situation while minimal have rendered any estimation on this.  
93 Therefore, the present study has been firmed to analyse the association of COVID-19  
94 incidences (i.e. transmission) and recovery cases with weather and air quality parameters  
95 across the country, as well as proffered a comparative assessment for estimating confirm and  
96 recovery cases availing the non-linear complex relationship.

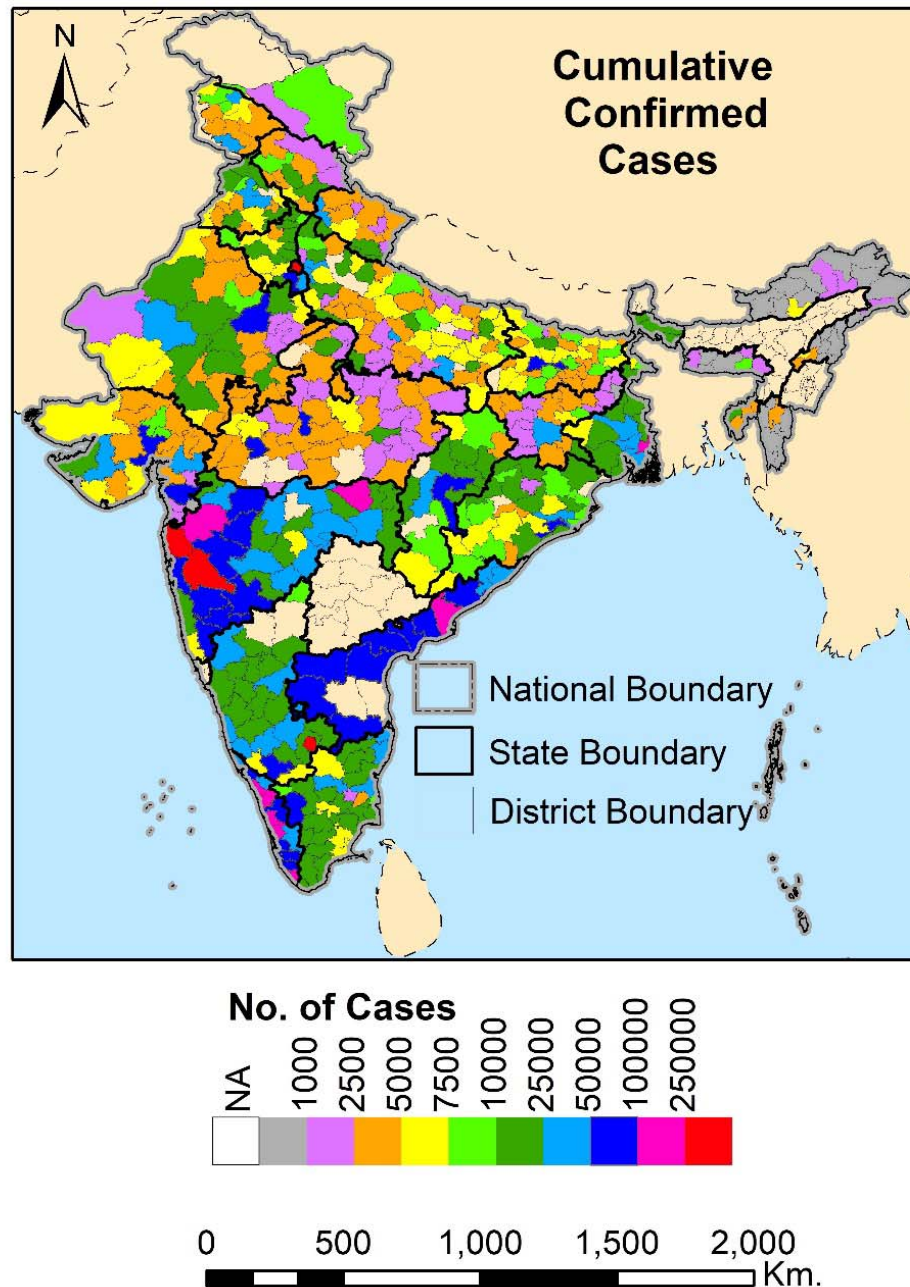
## 97 Data and Methodology

98 Counts of Confirmed and Recovered cases for all the available districts in India have been  
99 acquired from <https://www.covid19india.org/>. The 2nd wave of COVID-19 in India has  
100 prominently surged April, 2021 onwards, hence we have obtained our study for the period  
101 throughout the 1st wave of COVID-19 only. During March, 2020 these counts were too  
102 craggy, therefore we acquired data only for the period of April, 2020 to March, 2021. Spatial  
103 data for total six different meteorological parameters - 2-m Air Temperature (AT), Bias-  
104 corrected Total Precipitation (PRC), Specific Humidity (Hm), Cloud Cover (CLD), Incoming  
105 Short-wave Radiation (ISWR), Wind Speed (WS), and six different air quality parameters -  
106 Aerosol Optical Depth (AOD), Tropospheric Column Nitrogen di-Oxide (NO<sub>2</sub>), Total  
107 Column Ozone (O<sub>3</sub>), Surface concentration of Carbon Monoxide (CO), Sulphur di-Oxide  
108 (SO<sub>2</sub>) and Black Carbon (BC) have been incorporated in the present study. Remote Sensing  
109 based datasets are highly useful for various environmental studies (Bhatt et al., 2021; Das et  
110 al., 2017; Das and Gupta, 2021; Gupta et al., 2020b; Gupta et al., 2019; Moniruzzam et al.,  
111 2018; Nanda et al., 2018; Rousta et al., 2020), hence we have used such dataset from  
112 different sources. Monthly mean of these twelve environmental variables were further  
113 processed in ArcGIS software, adjoined and related with the monthly cumulative counts of  
114 confirmed and recovery cases for each months for each of those selected districts.

## 115 Infections and recoveries during 1st COVID-19 waves in India

116 The district wise spatial distribution of COVID-19 confirmed cases and recoveries during the  
117 1st COVID-19 wave (up to March, 2021) are shown in Figure 1. It shows that 35.03%  
118 districts had noted cases within the range of 10,000 to 1,00,000; while only 3.05% districts in  
119 India registered more than 1 lakh cases during this study period. Noteworthy, most of the  
120 districts have registered counts of infective cases within the range of 2500-5000 following the  
121 range of 10000-25000. Comprehensively, 21 states registered more than 1 lakh infected  
122 cases; among them only Maharashtra and Kerala had registered more than 10 lakh cases. The  
123 spatial distribution of cases also depict that the coastal districts were more anguished by  
124 misfortune than the districts located in the interior part of the country whereas the districts  
125 from the Himalayan Mountains and its foothills had lesser strife during this pandemic. The  
126 temporal pattern of daily cases of infections, recoveries, deceased, and test positivity (%)  
127 from all over the country were shown in Figure 2a. It depicts that the peak of pandemic was  
128 during the early September, 2020 when the daily death counts and confirmed cases were

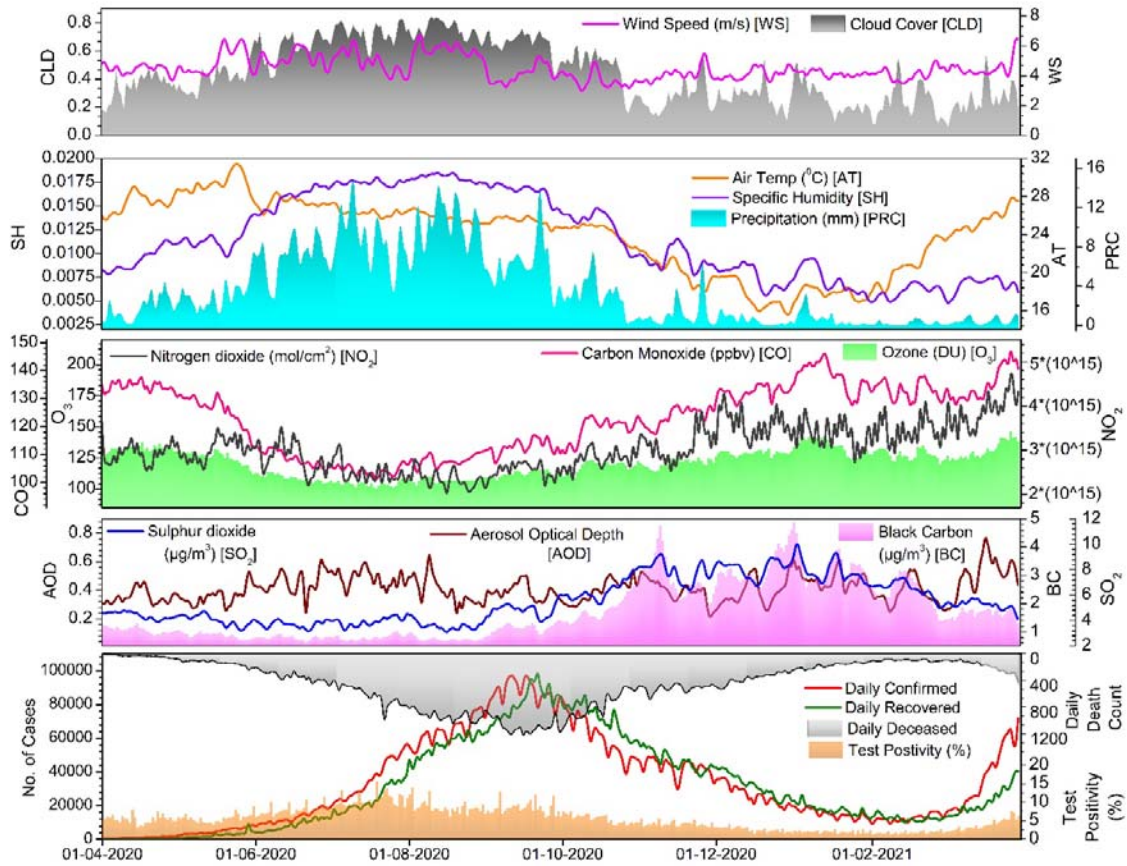
129 highest, however daily test positivity was highest during July. These trends were at their  
130 trough during the winter followed by the post-monsoon seasons but again started to incline  
131 since March, 2021.

136 Pearson's correlation test

137 Pearson's correlation technique was applied to explore the degree of association of  
 138 environmental parameters with infected and recovered cases at 95% confidence interval using  
 139 equation 1. A correlogram is also being prepared to better represent the interrelation of the  
 140 variables of the input dataset.

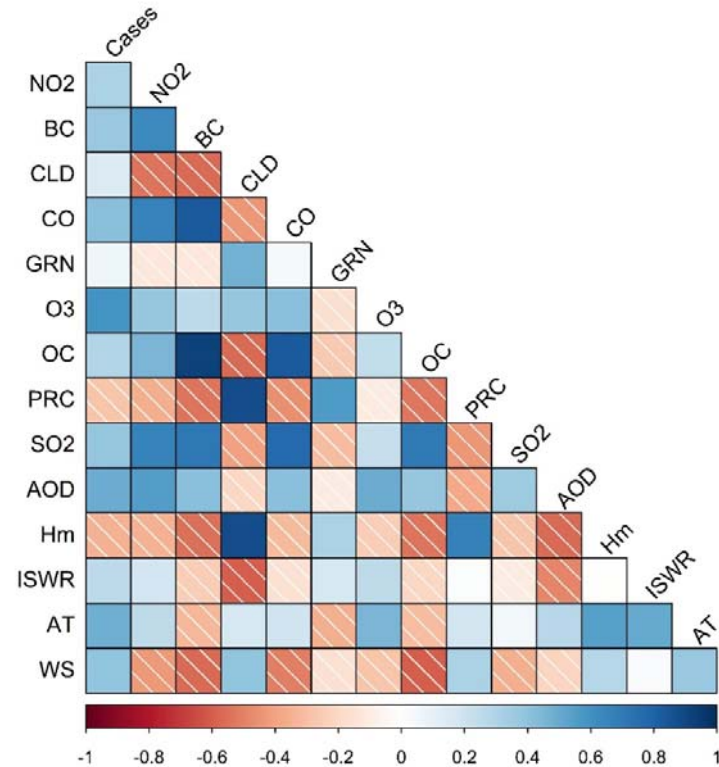

142 Here,  $r$  is the correlation coefficient,  $En$  represents the environmental variables,  $C$  denotes  
 143 the count of confirm and recovery cases individually.

144 **Results and Discussion**

145 Pearson's correlation test (Figure 3) found that confirmed cases have significantly ( $p < 0.05$ )  
 146 positive correlation with the AT (0.483), ISWR (0.268) and WS (0.391), negative association  
 147 with Hm (-0.304) and PRC (-0.288); however positive but non-significant ( $p > 0.05$ ) relation  
 148 with CLD (0.109). It depicts that areas with areas with comparatively higher AT with greater  
 149 ISWR and drier atmospheric conditions (lower humidity and lesser precipitation) seem to  
 150 register more infected cases in India, quite similar to what was observed by Aslam et al.,

151 2020 and Islam et al., 2020 over Pakistan and Bangladesh respectively. Since the Indian  
152 landmass is located in the tropical latitudes of the Northern Hemisphere where the regional  
153 ISWR is higher than the global average ISWR during April to September (Hatzianastassiou et  
154 al., 2005), thus avails to put up the air temperature during these summer months. Thus, it may  
155 indirectly help viruses to spread out at higher temperature conditions. On the other hand,  
156 Dowell, 2001; Lowen et al., 2007 had shown that the transmission of respiratory virus via  
157 aerosol could be suppressed by higher humid conditions, but enhanced under dry conditions.  
158 Barreca, 2012; Dalziel et al., 2018 also suggested that low-humidity levels could be  
159 considered as an imperative risk factor for respiratory infection diseases (Tellier, 2006).  
160 Thus, the summer conditions become more susceptible for this viral transmission in India. A  
161 few studies such as Coccia, 2021; Rendana, 2020; Rosario et al., 2020 have opined that  
162 higher wind could lower the emanation of the virus, however we found persuasive correlation  
163 between wind and COVID-19 cases in India, thus agreeing to Babu et al., 2020; Gautam et  
164 al., 2021. Another crucial reason behind this might be that the districts located near and along  
165 the western coast in Kerala, Maharashtra as well as the districts of Tamilnadu, Andhra  
166 Pradesh and Odisha located in the eastern coast of India catalogued maximum cases during  
167 May to July, 2020 which is the onset duration of monsoon over Indian subcontinent, thus  
168 experience higher wind from the sea-side towards the land. Liu et al., 2020c had suggested  
169 that the rapid weather variability might result in an increase in respiratory infections in  
170 warming climatic conditions; moreover, study by Moriyama and Ichinohe, 2019 had found  
171 that higher ambient temperature could restrain the adaptive immune response to a virus  
172 infection which also could be accorded through the present study.

175 In agreement of numerous scientific research conducted in the last two decades, the link  
 176 between environmental pollution and chronic illnesses mainly the cardiovascular and  
 177 respiratory diseases are quite comprehensible (Andersson et al., 2020; Chauhan and Johnston,  
 178 2003; Ghude et al., 2016; Mehta et al., 2013; Orru et al., 2017; Zhang et al., 2019b;  
 179 Ciencewicki and Jaspers, 2007). In the current study we found all the seven air quality  
 180 parameters to be significantly and positively correlated with confirmed cases. Figure 4  
 181 depicts that monthly confirmed cases was better correlated with monthly average  
 182 concentration of O<sub>3</sub> (0.595) followed by AOD (0.497), CO (0.414), NO<sub>2</sub> (0.383), BC (0.374)  
 183 and SO<sub>2</sub> (0.325). It confers that concentration of oxidant pollutants had a significant impact  
 184 on COVID-19 transmission in Indian scenario. Earlier studies had conjectured the O<sub>3</sub> as a  
 185 mighty oxidant (Nuvolone et al., 2018; Turner et al., 2015; Zhang et al., 2019c). Likewise,  
 186 exposure to NO<sub>2</sub> has been found to be associated with the increasing risk of acute respiratory  
 187 tract infections (Munawer, 2018; Suryadhi et al., 2020; Valko et al., 2007). On the other  
 188 hand, CO is thoroughly soluble in the bloodstream (Power, 1968). It becomes toxic when  
 189 blood reacts with haemoglobin (Badman and Jaffé, 1996; Schraufnagel et al., 2019). There  
 190 were several hotspots observed in the northern IGP and eastern India contributing detestable  
 191 amounts of CO and NO<sub>2</sub> that could be held accountable for the appalling air quality in those  
 192 regions as it might have significantly swayed the exposed individuals to get intensely infected  
 193 by the coronavirus. Therefore, higher concentration of O<sub>3</sub> along with its precursors (CO and  
 194 NO<sub>2</sub>) could be held noxious for such awful viral emanation especially over northern and  
 195 eastern part of India. Thus we agreed with Bashir et al., 2020; Li et al., 2020; Pansini and



196 Fornacca, 2020; Zhu et al., 2020b; Zoran et al., 2020 about the significance of O<sub>3</sub>, with CO  
197 and NO<sub>2</sub> pollution regarding the COVID-19 emanation. Furthermore, in developing countries  
198 like India, the organic fuel based power generation and daily household combustion activities  
199 are commonly observed which often results in excessive emission of SO<sub>2</sub> and carbonaceous  
200 pollutants such as CO and BC. A beguiling study by Hahon et al., 1985 with a rigorous  
201 snooping on mice had found that the severity of influenza virus infection was better  
202 recognizable with a prominent exposure to diesel engine emissions and coal dusts. In the  
203 present study, we have found a rich correlation between pollutants emitted due to fossil fuel  
204 combustion and COVID-19 outbreak patterns. Till date, a minimal study has obtained SO<sub>2</sub>  
205 and BC to investigate the surging of COVID-19. The pathophysiological corroboration  
206 cogently conveyed pathways of various diseases arose from SO<sub>2</sub> and NO<sub>2</sub> pollution  
207 (Brunekreef and Holgate, 2002; Chen et al., 2015; Kampa and Castanas, 2008). The elevated  
208 concentration of SO<sub>2</sub> can shorten the lung function, causing suffocation, wheezing, coughing,  
209 and also arouse the exasperation in the tissues inside the nose and the throat (Feuyit et al.,  
210 2019) (Chen et al., 2007; Kelsall et al., 1997). It was quite distinctive that higher SO<sub>2</sub> and  
211 coronavirus outbreak were experienced over IGP, Odisha, coastal areas of Gujarat and  
212 Maharashtra. The spatial distribution of BC also depicts an approximate pattern of higher  
213 concentration over IGP and eastern coast of Odisha. In various parts of the world, these  
214 pollutants have been adjudged as an indicator of adverse health effects (Janssen et al., 2011;  
215 Segersson et al., 2017; Tobias et al., 2014). It becomes virulent (Bourdrel et al., 2017; Kampa  
216 and Castanas, 2008), thus damaging the lung functions (Jacobson et al., 2014; Paulin and  
217 Hansel, 2016; Paunescu et al., 2019; Valavanidis et al., 2008; Xu et al., 2018a). Therefore, it  
218 can be quite distinctive that the ensued elevated pollution due to outrageous fossil fuel  
219 consumption could cause the neighbourhood to be less immune and predisposed to severe  
220 respiratory infection like COVID-19 (Kyung and Jeong, 2020; Suhaimi and Jalaludin, 2015;  
221 Thurston et al., 2017), hence prominently associated with pulmonary diseases (Anenberg  
222 Susan C. et al., 2010; Peters et al., 2001; Rosenthal et al., 2013). Since PM concentration  
223 can't be directly assessed through Satellite based observations (Gupta et al., 2021, 2006;  
224 Gupta and Christopher, 2009; Li et al., 2015), we correlated satellite derived AOD with  
225 infective cases over several districts during the study period, and found that the IGP was  
226 limned with exorbitant AOD where the coronavirus outbreak was also quite austere. Earlier,  
227 Spekreijse et al., 2013; Zhao et al., 2019 recommended the strong possibilities of airborne  
228 transmission of respiratory virus via fine dust particles. Recently, Comunian et al., 2020;  
229 Tang et al., 2020 also discussed the evidence of SARS-CoV-2 virus transmission via dust  
230 particles. Therefore, considering the elevated AOD over semi-arid north-west India along  
231 with scorching summer conditions, and the infective cases from Rajasthan, Punjab, Haryana  
232 and Uttar Pradesh during April-June. Interaction between the meteorological parameters and  
233 air pollutants' concentrations are quite complex and varying seasonally, and often influenced  
234 by the local physiography including the topographic variations such as location of mountains,  
235 valleys, or the presence of substantial water bodies such as large rivers, and lakes (Benjamin,  
236 1975; Eum et al., 2015; Hewson and Olsson, 1967; Mahapatra et al., 2019; Prabhu et al.,  
237 2020; Saikawa et al., 2019; Zhang et al., 2018). During summer, the rising AT and  
238 comparatively lesser SH ominously abet the pollutants' concentration by physio-chemical  
239 transformation (Analitis et al., 2018; Jayamurugan et al., 2013; Sario et al., 2013), henceforth

240 make warmer days commendatory for such virus infections. While comparing with the long  
241 term average conditions, many studies had acknowledged the imposition of four tier  
242 countrywide lockdown for relatively cleaner air in India during April to mid of June, 2020  
243 (Gupta et al., 2020d; Naqvi et al., 2021; Nigam et al., 2021; Singh and Chauhan, 2020;  
244 Venter et al., 2020). Even though we found that the IGP followed by the coastal districts of  
245 West Bengal, Odisha, Andhra Pradesh, Maharashtra, Kerala, Tamilnadu had inhaled quite  
246 bad air where each states had registered more than 30,000 cases during that period.  
247 Intriguingly, the temporal trends of pollutants showed comparatively higher concentration  
248 during winter and post-monsoon seasons, while the infections were relatively lesser in both  
249 those seasons. Therefore, it suggests that the shoddy air quality could not be discretely  
250 blameworthy for coronavirus dissemination in India, rather bad air with successively  
251 increasing AT in summer environment could be held responsible.

## 252 Conclusion

253 Our conscientious study suggests that the summer tropical environment in India may spare a  
254 more affirmative condition for SARS-CoV-2 transmission, agreeing with Sajadi et al., 2020;  
255 Xie and Zhu, 2020. Instead of squashing the COVID-19 curve, higher air temperature may  
256 significantly assist an augment in pandemic predicament in India. Comparatively higher wind  
257 in drier areas could indulge the virus to unfurl more, as also observed by Aidoo et al., 2021;  
258 Babu et al., 2020. Besides, the negative correlation between precipitation and infections, also  
259 discerned by Mansouri Daneshvar et al., 2021, illustrates the relevance of prevailing  
260 atmospheric conditions in dissemination of this pandemic. Scientific communities'  
261 acquiescence on the adverse impact of air quality on crude mortality is inevitable in any well-  
262 being circumstances across the world (Bentayeb et al., 2015; Davidson et al., 2005).  
263 Foreseeably, the poor air quality was perceived to be significantly correlated with the  
264 COVID-19 dissemination during the study period. The positive correlation between coal  
265 blazed pollution and COVID-19 outbreak, as well as the negative association between the  
266 recovery count from this disease and prevailing regional pollution levels stoutly suggest that  
267 the exorbitant air pollution due to bounteous non-renewable energy generation and its  
268 perpetual consumption might perturb the inbred immunity of residents in circumjacent area,  
269 and hinder them also in agile recovery from this disease. The concurrent health tribulation and  
270 the interconnection of diseases affecting multiple organs are also decisively discerned during  
271 COVID-19 infections. During or in a later stage of treatment, several patients are also  
272 condemned to various post-syndrome infections mostly related to cardiovascular and  
273 respiratory disorders which might be the ramifications of virulent vulnerability to the gaseous  
274 pollution. Hence it altogether asserts that the environment needs to be ameliorated immensely  
275 by its standards to alleviate such deadly pandemic. The injurious impact of traffic pollution  
276 has also been discussed through various global and regional studies (Gauderman et al., 2007;  
277 Laumbach and Kipen, 2012; Urman et al., 2014). The pre-eminence of weather parameters on  
278 air quality is indubitable and evinced globally (Bhaskar and Mehta, 2010; Fisher, 2002;  
279 Yansui Liu et al., 2020e; Panofsky and Prasad, 1967; Qin et al., 2020; Seo et al., 2018; Zhang  
280 et al., 2015), hence its significant association with COVID-19 dissemination during a year-  
281 long period over India has been certainly revealed through the present study.
