

Genetic regulation of *OAS1* nonsense-mediated decay underlies association with risk of severe COVID-19

ABSTRACT

Genomic regions have been associated with COVID-19 susceptibility and outcomes, including the chr12q24.13 locus encoding antiviral proteins OAS1-3. Here, we report genetic, functional, and clinical insights into genetic associations within this locus. In Europeans, the risk of hospitalized vs. non-hospitalized COVID-19 was associated with a single 19Kb-haplotype comprised of 76 *OAS1* variants included in a 95% credible set within a large genomic fragment introgressed from Neandertals. The risk haplotype was also associated with impaired spontaneous but not treatment-induced SARS-CoV-2 clearance in a clinical trial with pegIFN- λ 1. We demonstrate that two exonic variants, rs10774671 and rs1131454, affect splicing and nonsense-mediated decay of *OAS1*. We suggest that genetically-regulated loss of *OAS1* expression contributes to impaired spontaneous clearance of SARS-CoV-2 and elevated risk of hospitalization for COVID-19. Our results provide the rationale for further clinical studies using interferons to compensate for impaired spontaneous SARS-CoV-2 clearance, particularly in carriers of the *OAS1* risk haplotypes.

TEXT

The complex response to pathogens, such as SARS-CoV-2, the causative agent of COVID-19, is likely determined by the interplay between host and pathogen factors. Variability in clinical outcomes of COVID-19 has prompted the search for host genetic factors to elucidate underlying disease mechanisms and guide optimal treatment options. Recent genome-wide association studies (GWAS) have reported a series of genetic variants in distinct loci associated with COVID-19 susceptibility and increased risk of hospitalization or severe disease compared to the general population^{1,2}.

The associated locus at 12q24.13^{1,2}, marked by rs10774671, harbors three genes encoding antiviral 2',5'-oligoadenylate synthetase (OAS) enzymes — OAS1, OAS2, and OAS3 — which are interferon-inducible effectors activating the latent form of ribonuclease L (RNaseL)^{3,4}. Activation of the RNaseL pathway leads to degradation of viral RNA, inhibition of virus replication, and cell death³. A 185 Kb-haplotype spanning *OAS1*, *OAS2*, and *OAS3* was reported as introgressed into genomes of modern humans from the Neandertal and Denisova lineages⁵⁻⁷. The risk of severe COVID-19 was associated with rs10774671-A allele capturing the non-Neandertal haplotype^{1,2}. Alleles of rs10774671 affect splicing of 3' terminal exons of *OAS1*. Specifically, the rs10774671-G allele creates a new splicing site for inclusion of exon 6, creating a transcript for a protein isoform of 46 kDa known as OAS1-p46. Other splicing sites are utilized in the absence of G allele (and presence of A allele), creating transcripts for other *OAS1* isoforms, including OAS1-p42⁸. Notably, rs10774671-A allele was also associated with impaired spontaneous clearance of West Nile virus infection⁹ and decreased basal OAS enzyme activity in unstimulated peripheral blood mononuclear cells (PBMCs) from healthy individuals⁸. Additionally, rs10774671-A, as well as

linked alleles of other variants in this region have been associated with chronic hepatitis C virus infection¹⁰, impaired SARS-CoV clearance¹¹, and increased susceptibility to several autoimmune conditions - multiple sclerosis^{12,13}, Sjögren's syndrome¹⁴, and systemic lupus erythematosus^{15,16}.

A linked variant, rs4767027 ($r^2=0.97$ with rs10774671 in Europeans), has been reported as a protein quantitative trait locus (pQTL) for OAS1 blood levels in the general population¹⁷.

Because OAS1 levels were decreased in the presence of rs4767027-C allele (linked with the GWAS rs10774671-A risk allele), this suggested that OAS1 deficiency could underly the risk of severe COVID-19¹⁷. However, the factors regulating OAS1 expression were not explored.

Here, we sought to explore the underlying mechanism of the COVID-19 GWAS locus at 12q24.13. In case-case analyses in 1555 individuals of European ancestry, we refined the associations of the Neandertal and other haplotypes with COVID-19 severity. Further, we employed a series of bioinformatics and experimental approaches to demonstrate the combined effects of two associated variants on post-transcriptional regulation of *OAS1* expression through nonsense-mediated decay (NMD). By analysis in a clinical trial with recombinant interferon lambda (pegIFN- λ 1)¹⁸, we demonstrated that the *OAS1* haplotype associated with an elevated risk of hospitalized COVID-19 was also associated with impaired spontaneous but not pegIFN- λ 1-induced clearance of SARS-CoV-2. These results offer a molecular mechanism underlying the COVID-19 related genetic associations within the 12q24.13 locus and suggest the utility of further pursuit of treatment with pegIFN- λ 1 or other interferons to compensate for deficiencies in spontaneous clearance in carriers of the *OAS1* risk haplotypes.

RESULTS

Case-case analyses within the 12q24.13 locus refine the associations with COVID-19 outcomes

We investigated the 116Kb region (hg38, chr12: 112,901,422-113,017,487) within the 12q24.13 locus, which includes *OAS1*, *OAS2*, and *OAS3* genes. In COVID-19 Host Genetics Initiative (HGI) GWAS meta-analysis², rs10774671 (hg38, chr12:112919388-G-A) was reported as the lead variant in this region for associations with critical disease (A2 analysis, $p=1.1E-12$), hospitalized disease (B2, $p=1.51E-09$), and reported SARS-CoV-2 infection (C2, $p=2.09E-11$), all compared to the general population². However, rs10774671 was not associated with hospitalized vs. non-hospitalized disease (B1, $p=0.80$) (release r5, COVID-19 HGI Browser <https://app.covid19hg.org/>).

We analyzed 366 genotyped or imputed variants from this region in an independent set of 1555 patients of European ancestry from COVNET. A 32Kb linkage disequilibrium (LD) block ($r^2>0.8$ with rs10774671) spanning *OAS1* and *OAS3* included 125 variants associated with $p=1.72E-04$ to $4.22E-06$ comparing all hospitalized vs. non-hospitalized patients (**Table S1, Figure 1a**). Applying the Sum of Single Effects (SuSiE) analysis¹⁹, we identified two credible sets, each predicted to include at least one effect variant with 95% certainty. The lead rs10774671 was included in a credible set of 76 variants, all in $r^2>0.9$ with the lead rs10774671 and spanning *OAS1*; the second credible set included 12 *OAS3* variants in low LD with the first set, possibly indicating an independent but weaker signal (**Table S1, Figure 1b**).

A similar analysis limited to 1167 patients with hospitalized severe vs. non-hospitalized disease identified an additional set of 24 variants with suggestive associations ($p=0.045-0.0049$, **Table**

S1, Figure 1c). This set included three missense variants in moderate or low LD with rs10774671: an *OAS1*-exon 3 rs1131454 (Gly162Ser, OR=1.36 (1.07-1.74, $p=0.014$, $r^2=0.73$ with rs10774671), a common *OAS3*-exon 6 rs2285933 (Ser381Arg, OR=1.47 (1.11-1.94), $p=0.0066$, $r^2=0.18$) and an uncommon European-specific *OAS3*-exon 2 rs12819767 (Arg65Trp, OR=2.73 (1.13-6.52), $p=0.024$, $r^2=0.009$). The SuSiE analysis was not informative for this outcome due to less significant associations precluding generation of 95% credible sets (data not shown).

The 125 variants within the *OAS1/OAS3* LD block formed only two common haplotypes – the risk (61.9%) and non-risk (33.6%). The non-risk haplotype included alleles defining the Neandertal haplotype²⁰, which spans >97Kb of this region (**Figure 1d**). Our *OAS1* credible set of 76 variants further limited the potentially causal region of this haplotype to 19Kb within *OAS1* (**Table S1A**). From this credible set, we selected four directly genotyped variants spanning a 4.2Kb region (rs10774671, rs1131476, rs2660, and rs4766664) and capturing the Neandertal haplotype in Europeans. In a comparison to the Neandertal haplotype (GGGT), there was only one common risk haplotype formed by these variants (AAAG, OR=1.51 (1.25-1.83), $p=3E-05$, $n=1555$) (**Table S2, Figure 1e**).

Analyses of the extended haplotypes (adding three additional variants associated with severe disease to the core four-variant haplotype) demonstrated that rs12819767-T and rs2285933-G alleles increased and rs1131454-G allele decreased the associations with severe disease of the core risk haplotype (AAAG, **Table S3, Figure 1e**). In smaller sets of patients of non-European ancestries (483 African, 166 admixed-Hispanic, and 103 East-Asian), none of these variants or their haplotypes showed significant associations (**Table S4-S8**). Thus, in Europeans, the risk of hospitalized disease was largely associated with one non-Neandertal haplotype comprising a

95% credible set of 76 *OAS1* variants, while investigation in other populations awaits larger studies. Additional *OAS1* and *OAS3* missense variants and their corresponding haplotypes might be further contributing to the association with severe COVID-19.

***OAS1* allelic protein isoforms have comparable anti-SARS-CoV-2 activity**

Our analyses suggested that in Europeans at least one effect variant for the risk of hospitalized disease is included in the 95% credible set of 76 *OAS1* variants. This set included four missense variants (rs1131476, rs1051042, rs2660, and rs11352835) and one splicing variant (rs10774671). Additionally, an *OAS1* missense variant rs1131454 was included in a haplotype associated with severe disease. The alleles of rs10774671 create distinct protein isoforms *OAS1*-p42 (A-allele) and *OAS1*-p46 (G-allele)⁸, but the functional effects of other associated *OAS1* variants, especially in the context of *OAS1* protein isoforms, have not been explored.

To test the anti-SARS-CoV-2 activity of *OAS1* proteins generated by the risk and non-risk haplotypes, we generated four expression constructs corresponding to *OAS1*-p42 and p46 proteins (**Figure 2a**). We transiently overexpressed all *OAS1* plasmids in a lung epithelial cell line A549-ACE2 stably expressing ACE2, the SARS-CoV-2 receptor. To control for endogenous interferon response to the plasmids, we transfected cells either with a control *GFP* plasmid or individual *OAS1* plasmids and, after 48 hours, infected cells with SARS-CoV-2 for 24 hours (**Figure 2b**). The A549-ACE2 cells were highly infectable by SARS-CoV-2, but viral loads were similarly decreased by overexpression of all *OAS1* plasmids (**Figure 2c, Table S9**). Thus, in A549-ACE2 cells, proteins produced by similar amounts of *OAS1* plasmids provided comparable anti-

SARS-CoV-2 activity, without a detectable functional impact of the splicing (rs10774671) or missense (rs1131454, rs1131476, and rs1051042) variants (**Figure 2c**).

OAS1-p42 and OAS1-p46 proteins have been shown to localize to the cytosol and the trans-Golgi compartment, respectively²¹. By confocal imaging of endogenous OAS1 proteins in IFN β -treated cells, we confirmed that OAS1-p46 produced in HT1376 cells (rs10774671-GG) was enriched in the trans-Golgi compartment. In contrast, OAS1-p42 produced in A549 cells (rs10774671-AA) appeared exclusively cytosolic (**Figure 2d-h**). Despite differences in intracellular localization of OAS1 protein isoforms, determined by the splicing variant rs10774671, our results do not support their differential anti-SARS-CoV-2 activity.

***OAS1* expression is regulated by a splicing enhancer created by missense variant rs1131454**

The risk rs10774671-A allele was associated with lower OAS1 blood levels in the general population¹⁷. To explore whether this difference can be detected on mRNA level as well, we quantified the expression of *OAS1* isoforms in various RNA-seq datasets. Expression of *OAS1-p46* (created by rs10774671-G allele) was higher than of other *OAS1* isoforms in all datasets tested - adjacent normal tissues from TCGA (**Figure S1**), nasal epithelial cells infected with Rhinovirus (**Figure S2a**), pulmonary alveolar type 1 cell-based organoids infected with SARS-CoV-2 (**Figure S2b**), and in PBMCs from COVID-19 patients (**Figure S2c**).

Higher expression of the *OAS1-p46* isoform could be due to its enhanced transcription regulated by rs10774671 or its linked variants. However, based on analyses of chromatin profiles in three cell lines by ATAC-seq and H3K27ac ChIP-seq or chromatin interactions by Hi-C, we did not observe evidence for regulatory elements within the associated region (**Figure S3**).

Similarly, we did not detect chromatin interactions involving this region by Hi-C in a monocytic cell line THP-1 at baseline or after treatment with IFN β (**Figure S4**). Therefore, we excluded transcriptional regulation of *OAS1* expression by rs10774671 or its linked variants and considered post-transcriptional mechanisms.

As an indication of a potential imbalance in transcript production or stability, we evaluated allele-specific expression of transcribed *OAS1* variants. Specifically, we analyzed heterozygous samples from nasal epithelial cells – mock or *in vitro* infected with Rhinoviruses, and PBMCs from COVID-19 and non-COVID-19 patients. Using allele-specific RNA-seq reads, we analyzed two transcribed variants linked with rs10774671 - rs2660 in exon 6 ($r^2=0.96$ in Europeans, included in *OAS1-p46* and *p48* transcripts) and rs1131454 in exon 3 ($r^2=0.72$ in Europeans, included in all *OAS1* transcripts). For both variants, the counts of RNA-seq reads with G alleles were significantly higher than reads with A alleles (**Figure 3a**). In most cases, rs1131454-G is linked with the rs10774671-G allele and included within the Neandertal haplotype. However, rs1131454-G also exists in the less common haplotype with the risk rs10774671-A allele. We analyzed samples heterozygous for rs1131454 (AG) but homozygous for the risk alleles of rs10774671 (AA) and rs2660 (AA). Analysis of haplotypes of these three variants in different datasets showed higher expression in samples with the GAA compared to AAA haplotypes, indicative of allele-specific expression for rs1131454. The expression of both *OAS1-p46* and *OAS1-p42* transcripts was increased in the presence of exon 3 rs1131454-G allele (**Figure 3b-f**).

By visual examination of RNA-seq plots, we noted different lengths of *OAS1* exon 3 (labeled as Short and Long, **Figure 4a**), created due to alternative splicing through cryptic acceptor (~15-25 % reads) and donor (~5% reads) splice sites. Splice-QTL analyses showed increased canonical

splicing and reduced alternative splicing of exon 3 in the presence of the rs1131454-G allele (**Figure 4b-d**). By *in-silico* analysis, we predicted that the rs1131454-G allele creates a putative exonic splicing enhancer/silencer (ESE/ESS) (**Figure 5a**). To test this prediction, we generated allele-specific mini-genes with the A or G alleles of rs1131454 (**Figure 5b**). By RT-PCR in two cell lines (A549 and T24), we detected increased splicing of Long exon 3 in the mini-gene with the non-risk rs1131454-G allele (**Figure 5c, d**). Based on these results, we conclude that the functional effect of the missense variant rs1131454 could be related to creating an allele-specific ESE/ESS regulating splicing of *OAS1* Short and Long exon 3 isoforms.

***OAS1* transcripts are eliminated by allele-specific nonsense-mediated decay**

To explore the impact of exon 3 splicing on *OAS1* transcripts, we performed long-read Oxford Nanopore RNA-sequencing in A549 and HT1376 cells at baseline and after treatment with IFN β (**Figure S5**). Reads with alternatively spliced exon 3 were included in all *OAS1* transcripts (**Figure S6**). The combination of *p42* and *p46* isoforms and Short and Long exon 3 created several transcripts; all of these transcripts, except for *p46*-Long exon 3 isoform, had premature termination codons (PTCs, **Figure S6**). Prematurely terminated transcripts might be targeted by nonsense-mediated decay (NMD). To test this, we analyzed RNA-seq data for HeLa cells (rs10774671-AA, *OAS1-p42*) after siRNA-mediated knockdown (KD) of NMD pathway genes – *SMG6* and *SMG7*. The siRNA-KD of *SMG6* and *SMG7* resulted in upregulation of both alternative (Short) and canonical (Long) isoforms of exon 3, confirming that all *OAS1-p42* transcripts are targeted by NMD (**Figure 6a,b**).

To test whether increased expression of *OAS1-p46*-Long could be due to its protection from NMD, we performed siRNA-KD of *SMG6*, *SMG7*, and *UPFI* (another component of the NMD pathway) in two cell lines - A549 (*OAS1-p42*) and HT1376 (*OAS1-p46*) and analyzed mRNA expression of Long and Short exon 3 as a readout (**Figure 6c**). In A549 cells, the triple-KD resulted in a significant increase in expression of both the Short and Long exon 3 versions of the *OAS1-p42* isoform (**Figure 6d,e**). However, in HT1376 cells, we observed a modest but significant increase of expression only of *OAS1-p46*-Short but not *OAS1-p46*-Long isoform (**Figure 6f,g**). We conclude that, unlike all other isoforms, the non-risk *OAS1-p46*-Long isoform is NMD-resistant. Because *OAS1* isoforms are created by haplotypes with rs1131454 and rs10774671 alleles, their combinations can contribute to the variation in NMD of *OAS1* transcripts.

***OAS1* haplotypes are associated with impaired spontaneous clearance of SARS-CoV-2 that can be compensated by interferon treatment**

Increased NMD of *OAS1-p42* transcripts, especially those with rs1131454-A allele, will result in significantly reduced *OAS1* baseline expression levels. Early interferon signaling is important for mounting an efficient antiviral response²². For some infections, such as with SARS-CoV-2, that either do not induce sufficient interferon response or use various ways to counteract it, this deficit in the magnitude or delayed timing of the response could be crucial²³⁻²⁶. Interferon treatment has been proposed for mitigating SARS-CoV-2 infection, especially at an early infection stage^{27,28}. To explore whether interferon treatment could prevent or mitigate infection *in vitro*, we treated infection-permissive intestinal cells Caco2^{29,30} (heterozygous both for rs10774671 and rs1131454) with IFN β or IFN- λ cocktail four hours before or after SARS-CoV-

2 infection. All treatments significantly decreased viral loads (**Figure 7a,b, Table S10**). In the same cells, *OAS1* expression was only minimally induced by SARS-CoV-2 alone but was strongly induced by pre- and post-treatment with both interferons (**Figure 7c, Table S11**). Interferon-induced expression of both *OAS1*-p42 and p46 isoforms was also detectable by Western blotting (**Figure S7**). These results suggested that interferons can induce robust immune response even in SARS-CoV-2 infected cells, inducing expression of both *OAS1*-p42 and *OAS1*-p46 isoforms and compensating for any loss of their expression due to NMD.

To investigate whether this can be relevant in clinical settings, we analyzed data from a clinical trial in which patients with mild outpatient COVID-19 were treated with a single subcutaneous injection of pegIFN- λ 1 or saline placebo¹⁸. We genotyped *OAS1* variants rs1131454, rs1074671, and rs2660 (capturing main *OAS1* haplotypes associated with COVID-19 outcomes in our case-case analyses) in genomic DNA of 58 participants. In multivariable analyses, baseline viral load was not associated with age, sex, race, treatment group, or *OAS1* haplotypes. Only baseline viral load and treatment group (placebo/treatment) were significantly associated with the viral decline in longitudinal analyses (**Table S12**). In the placebo group, which represents spontaneous viral clearance, compared to the GGG haplotype (*OAS1*-p46, Neandertal, non-risk), the association of AAA haplotype (*OAS1*-p42-A, risk) with an impaired viral loss showed similar trends at several days, reaching significance at day 5 and 10 post-treatment (**Figure 7d, Table S12**). However, the viral loss was not associated with *OAS1* haplotypes in the treatment group, indicating that pegIFN- λ 1 treatment overcame the deficit in *OAS1* expression associated with the AAA haplotype (**Figure 7d, Table 12**). Thus, the *OAS1*-AAA haplotype was associated with

both increased risk of hospitalized COVID-19 and impaired spontaneous clearance of SARS-CoV-2.

DISCUSSION

Interindividual variability in response to SARS-CoV-2 infection resulting in the range from asymptomatic to fatal disease requires an urgent understanding of the underlying molecular mechanisms. Results of our cases-case analyses in individuals of European ancestry confirmed the genetic association within chr12q24.13 locus initially reported comparing patients with COVID-19 to the general population². We fine-mapped the risk of hospitalized disease to a 19Kb-haplotype that included 76 *OAS1* variants forming a 95% credible set for association in this region. In functional analyses, we showed that alleles of two *OAS1* variants - a splicing variant rs10774671 and a missense variant rs1131454 in exon 3 regulate expression levels of *OAS1* through NMD. We demonstrated that the *OAS1* haplotype most targeted by NMD was associated with the lowest baseline *OAS1* expression, increased risk of severe COVID-19, and impaired spontaneous clearance of SARS-CoV-2, which could be compensated by early treatment with pegIFN- λ 1.

A 185Kb-haplotype was reported as introgressed into the genomes of modern humans from the Neandertal and Denisova lineages of non-African ancestors^{5-7,20}. It was hypothesized that the introgression of this haplotype was beneficial, perhaps by protecting humans from select pathogens; several associations with immune-related phenotypes reported for individual variants comprising this haplotype⁸⁻¹⁶ supported this idea. However, all these studies explored only one or a few variants, not providing sufficient clarity on the extent of the protective part of

the Neandertal haplotype or the plausible molecular mechanisms underlying its protective effect. The analysis of COVID-19-related outcomes affords a unique opportunity to address these questions. Based on the COVID-19 GWAS meta-analysis, a 97Kb block of linked variants ($r^2 > 0.8$) associated with hospitalized disease compared to the general population was nominated as a potentially protective part of the Neandertal haplotype²⁰. Based on association and credible set analyses, we further narrowed this fragment to a 19Kb-region, which included 76 *OAS1* variants in $r^2 > 0.9$ with the lead variant rs10774671 and comparably associated with the hospitalized disease.

Because rs10774671-G allele, associated with protection from severe COVID-19^{1,2}, creates the *OAS1*-p46 protein isoform (vs. *OAS1*-p42 and some other isoforms), this marker can be considered the lead functional variant in the *OAS1* credible set^{8,9}. Previous reports²¹ and our results showed that *OAS1*-p46 expression is enriched in trans-Golgi compartments, while *OAS1*-p42 is expressed in the cytosol. Targeting *OAS1* to endomembrane structures may benefit response to pathogens that hide from cytosolic pattern recognition receptors³¹. Virus-induced formation of complex membrane rearrangements originating from the endoplasmic reticulum was demonstrated as the mechanism used by plus-strand RNA flaviviruses (such as West Nile, hepatitis C, Dengue, Yellow Fever, and Zika viruses) to evade sensing and elimination³¹. Trans-Golgi localization of *OAS1*-p46 would support enhanced sensing and clearance of flaviviruses, contributing to the strong differences in antiviral activities observed between *OAS1*-p42 and p46 isoforms²¹.

It was hypothesized that coronaviruses and SARS-CoV-2 specifically might use a similar mechanism to evade the immune response³². In embryonic kidney cells stably expressing ACE2

(HEK293-ACE2), SARS-CoV-2 was cleared in the presence of both OAS1 protein isoforms but more efficiently in the presence of OAS1-p46 than OAS1-p42²¹. We tested the functional effects of rs10774671 and several linked missense *OAS1* variants by creating corresponding *OAS1* plasmids. In A549-ACE2 cells used as our experimental model, all *OAS1* plasmids provided a similar anti-SARS-CoV-2 response. The presence of the C-terminal OAS1-p46 CaaX motif, which is responsible for trans-Golgi targeting, was insufficient to explain differences in antiviral activities of OAS1-p42 and OAS1-p46²¹. Furthermore, OAS1-p42 and OAS1-p46 were similarly functional as enzymes activating the antiviral RNaseL pathway²¹. These protein isoforms overexpressed in A549 cells similarly blocked *in-vitro* replication of Dengue virus via an RNaseL-dependent mechanism³³. Overall, previous and our results suggest that both OAS1-p42 and OAS1-p46 have anti-SARS-CoV-2 activity, which is likely to be context-dependent, such as determined by the requirement of localization to specific cellular compartments for viral sensing, and expression levels of each isoform.

Our expression analyses showed that in all datasets explored, mRNA expression of *OAS1-p46* transcript was on average 3.9-fold higher than *OAS1-p42*. We did not find evidence for transcriptional regulation of *OAS1* expression but demonstrated that *OAS1* expression is regulated by NMD differentially affecting *OAS1* isoforms. By creating an NMD-resistant *OAS1-p46* transcript, the non-risk rs10774671-G allele plays the major role in preserving the *OAS1* expression. Additionally, we identified rs1131454 within exon 3 of *OAS1* as the second variant contributing to the regulation of *OAS1* NMD. Although rs1131454 is a missense variant in exon 3 (Gly162Ser), it did not appear to have a functional impact on the enzymatic activity of recombinant OAS1 proteins³⁴ and in our anti-SARS-CoV-2 assays. Instead, the non-risk

rs1131454-G allele of this variant creates an ESE/ESS to include the Short vs. Long forms of exon

3. Although NMD targets all *OAS1-p42* transcripts, transcripts with rs1131454-G allele are partially rescued from NMD. Because the *OAS1-p46* transcripts always carry the rs1131454-G allele, they are most NMD-resistant. Trans-Golgi accumulation of OAS1-p46 coupled with its increased expression due to the combined effects of non-risk rs10774671-G and rs1131454-G alleles may significantly enhance the antiviral activity of OAS1, offering a functional mechanism underlying the association of the Neandertal haplotype with COVID-19 outcomes.

We observed a decrease in SARS-CoV-2 expression after treating cells with interferons (either IFN β or IFN- λ cocktail) before or after infection, suggesting that interferons can overcome insufficient viral clearance. Indeed, in a clinical trial with pegIFN- λ 1, we observed that spontaneous but not the interferon-induced clearance of SARS-CoV-2 was associated with *OAS1* haplotypes. Thus, our results suggest that spontaneous clearance of SARS-CoV-2 impaired in the presence of specific *OAS1* variants can be compensated for by treatment with interferons. Although this treatment accelerated viral clearance in all patients, patients with the risk *OAS1* haplotype (AAA for rs1131454-A, rs10774671-A, and rs2660-A) would benefit from this treatment the most because of their impaired ability to clear the virus without treatment. In our clinical trial, patients were treated with a single subcutaneous injection of pegIFN- λ 1¹⁸. Due to the restricted expression of receptors, IFN- λ 1, a type III interferon, is well tolerated without causing systemic side effects often associated with administration of type I interferons³⁵. Inhaled nebulized type I interferons, IFN β -1a³⁶ and IFN- α 2b^{37,38}, are also tested as an early treatment for SARS-CoV-2 infection, with promising results.

The strengths of our study include genetic analyses evaluating outcomes in individuals with laboratory-confirmed COVID-19 and integrated analyses of multiple genomic datasets (e.g., RNA-seq, ATAC-seq, ChIP-seq, and Hi-C) supported by experimental testing of our hypotheses. In addition, we analyzed multi-variant haplotypes in association studies with COVID-19 severity and a clinical trial with pegIFN- λ 1. The extensive multi-method investigation provides strong plausibility for our findings. Of multiple associated genetic variants, we identified rs10774671 and rs1131454 as most functional within *OAS1* for clearance of SARS-CoV-2 and COVID-19 severity. However, we cannot exclude additional functional variants, especially in non-European populations, in which we had low statistical power for genetic analyses. Some of the associations with severe COVID-19 might be related to the function of *OAS3*, which we did not explore. Specifically, in Europeans, we identified two missense *OAS3* variants that might be independently contributing to the risk of severe disease. The activity of *OAS1* and *OAS3* enzymes might be synergistic but cell type and condition-dependent, which further genetic and functional studies should explore. Our study did not explore the genetics of immune response to SARS-CoV-2 variants.

Overall, we propose that non-risk alleles of two variants (rs10774671-G and rs1131454-G) protect *OAS1* transcripts from NMD (**Figure 8**). The rs10774671-G allele has the major role by generating the *OAS1*-p46 isoform, while rs1131454-G additionally and independently contributes by creating an ESE that increases inclusion of Long exon 3, thus protecting both *OAS1*-p46 and *OAS1*-p42 from elimination by NMD. The non-risk G alleles of both variants create the most abundant and NMD-resistant *OAS1* isoform (*OAS1*-p46-Long). In contrast, the risk A alleles of both variants create the NMD-vulnerable and low-expressed isoform (*OAS1*-

p42), while the haplotype with rs10774671-A but rs1131454-G allele creates the *OAS1-p42* isoform with an intermediate NMD resistance and expression levels (**Figure 8**). Deficient spontaneous clearance in individuals carrying these risk *OAS1* haplotypes can be compensated by early treatment with interferons, which should be further explored in clinical trials.

METHODS

Patients from COVNET

Patients were recruited by several studies participating in COVNET: Large-scale Genome-wide Association Study and Whole Genome Sequencing of COVID-19 Severity

(<https://dceg.cancer.gov/research/how-we-study/genomic-studies/covnet>), based on ethical approvals by corresponding institutions and informed consents provided by patients. COVID-19 diagnosis was confirmed based on positive viral testing or serology. Sample collection occurred pre-emergence of SARS-CoV-2 variants. Detailed demographic and clinical records were

provided by the participating studies and independently reviewed by COVNET team. Outcomes were defined as mild (non-hospitalized) COVID-19, hospitalized moderate (not requiring mechanical ventilation) and hospitalized severe (mechanical ventilation or death due to COVID-19).

We used data and samples from a clinical trial (NCT04354259), in which patients with mild outpatient COVID-19 received a single subcutaneous injection of 180 µg pegIFN-λ1 or saline placebo¹⁸. DNA was extracted from PBMCs of all participants and genotyped for 3 *OAS1* variants – rs1131454, rs10774671, and rs2660 representing main risk and non-risk haplotypes. SARS-CoV-2 RNA decline (viral copies, log₁₀) at baseline and several days after treatment were analyzed in relation to *OAS1* haplotypes, adjusting for relevant covariates.

Analysis of COVNET data

COVNET DNA samples were analyzed by AmpFLSTR Identifiler and then genotyped for 712,191 variants using the Global Screening Array version 2.0 (GSA2, Illumina) by the Cancer Genomics Research (CGR) Laboratory, DCEG/NCI. Samples exceeding an estimated contamination rate > 20% by VerifyIDintensity, an autosomal heterozygosity deviation FHET within +/- 0.20, a missing call rate >2%, and sex-discordant samples were excluded. Variants deviating from Hardy–Weinberg equilibrium ($p < 10e-6$), with a minor allele frequency < 0.01, an overall genotyping rate < 95%, or differential missingness between cases and controls (p-value cutoff 0.001) were excluded. Additionally, whole-genome sequencing data generated by contributing studies were used for a subset of samples. Sex, relatedness and population groups (European, African, admixed-Hispanic and East-Asian) were determined based on genetic analyses for all patients.

All genotyped variants were used for principal components analysis (PCA) with GCTA (v1.93.0 beta) to generate the first 20 eigenvectors, separately for each ancestry.

Imputation of additional variants was performed using the Michigan Imputation Server with the Minimac4 algorithm. We imputed the whole chromosome 12 based on population-specific reference panels: the Trans-Omics for Precision Medicine (TOPMed) reference panel was used for individuals of European ancestry; the Consortium on Asthma among African-ancestry populations in the Americas (CAAPA) reference panel was used for individuals of African ancestry; the American admixture population from Phase 3 of the 1000 Genomes Project (AMR-1KGP) reference panel was used for individuals of Hispanic-ancestry; and the Genome Asia pilot (GAsP) reference panel was used for individuals of East Asian-ancestry. Imputed variants with $R^2 > 0.9$ were retained for further analyses. SNPs rs10774671, rs1131454, and rs2285933 were directly genotyped with TaqMan assays in all non-European populations due to low imputation quality for these variants and in a subset of European individuals to confirm high concordance with imputed genotypes.

Each variant coded as 0, 1, or 2 based on the counts of the variant allele was analyzed for association using logistic regression with glm function with binomial family and logit link in R software (v4.0.4). For haplotype analyses, ShapeIT (v2.r837) software was used to phase the selected variants using the genetic map file for chromosome 12 with recombination frequencies for GRCh38/hg38. Haplotype association analyses using logistic regression were done with PLINK (v1.07), with a custom selection of a reference haplotype. Both single-variant and haplotype analyses were performed adjusting for sex, age, squared mean-centered age, and the first 20 principal components as covariates to control for population stratification. Summary

statistics for association analyses for hospitalized vs. non-hospitalized patients of European ancestry were used to generate 95% credible sets using Sum of Single Effects (SuSiE) R package (v0.9.26)¹⁹, where the R2 LD matrix was generated from the genotype data using the genetics R package (v1.3.8.1.3). LD plots were generated with Haploview 4.2.

Cell lines

Details for all cell lines used in this work are presented in **Table S13**. Cell lines were either used within 6 months after purchase or periodically authenticated by microsatellite fingerprinting (AmpFLSTR Identifier, ThermoFisher) by the Cancer Genomics Research Laboratory/DCEG/NCI. All cell lines were regularly tested for mycoplasma contamination using the MycoAlert Mycoplasma Detection kit (Lonza).

TaqMan genotyping

Genotyping of rs10774671, rs1131454, rs2660, and rs2285933 was done using TaqMan genotyping assays (**Supplementary Table S14**), with 2x TaqMan expression Master Mix (Qiagen) and 2-5 ng of genomic DNA in the 5- μ l reactions in 384-well plates on QuantStudio 7 (ThermoFisher). Positive controls (HapMap samples with known genotypes) and negative controls (water) were included on each 384-well plate.

Plasmids

Plasmids with a FLAG-tag for *OAS1-p46-G* (ID: OHu21619D, rs1131454-G, rs1131476-G, rs1051042-G) and *OAS1-p42-A* (ID: OHu29197D, rs1131454-A) were purchased from GenScript. QuikChange II site-directed mutagenesis kit (Agilent 200523) was used to generate plasmids *OAS1-p42-G* (rs1131454-G) and *OAS1-p46-A* (rs1131454-A, rs1131476-A, rs1051042-C) using

mutagenesis primers (**Table S14**). Sequences of original and modified plasmids were confirmed by Sanger sequencing.

SARS-CoV-2 infections

SARS-CoV-2 (strain BavPat1) was obtained from the European Virology Archive, amplified in Vero E6 cells, and used at passage 3. Media was removed from plated cells, and SARS-CoV-2 (MOI 3) was added to cells for 1 hour at 37°C; then the virus was removed, cells were washed 1x with PBS, and fresh media was added back to the cells. RNA from harvested cells was extracted using RNeasy kit (Qiagen), cDNA was generated with iSCRIPT reverse transcriptase (BioRad) from 250 ng of total RNA, and qRT-PCR was performed using SYBR Green assays (iTaQ SYBR Green buffer, BioRad) or TaqMan expression assays (**Table S14**) and as previously described^{29,30}.

A549-ACE2 cells (2.0×10^5 cells) were seeded in 12-well plates 24 hrs before transfection. Cells were transfected with the indicated *GFP* or *OAS1* plasmids using Lipofectamine 2000. Media was replaced 6 hrs post-transfection, and cells were infected with SARS-CoV-2 at an MOI=3 for 1 hr 48 hrs post-transfection. Following infection, fresh media was added, and SARS-CoV-2 replication was monitored for 24 hrs post-infection.

Caco2 cells (7.5×10^4) were seeded in 48-well plates for 20 hrs, then media was removed, and interferons were added to the wells for 4 hrs. Media with interferons was collected and added back after infection with SARS-CoV-2 for 1 hr. Alternatively, Caco2 cells were infected with SARS-CoV-2 for 1hr first and then 4 hrs post-infection media with the virus was replaced with

media with interferons for the indicated time. Interferon treatment: 2000 IU/mL of IFN β or 300 ng/mL (a cocktail of 100ng each of IFN- λ 1, IFN- λ 2 and IFN- λ 3).

Confocal microscopy

HT1376 bladder cancer cell line (rs10774671-GG genotype, OAS1-p46 isoform) and A549 lung cancer cell line (rs10774671-AA genotype, OAS1-p42 isoform) were plated on 4-well chambered slides (2×10^4 cells per well, LabTek) for 24 hrs. Cells were left untreated or treated with 2ng/ml IFN β (R&D System) for 24 hrs. Cells were then washed twice with PBS and fixed with 4% paraformaldehyde (BD Biosciences) for 30 min. After rinsing twice in PBS and permeabilization buffer (BD Biosciences), cells were incubated with permeabilization buffer for 1 hr. Fixed cells were incubated with mouse anti-Golgin-97 antibody (1:250 dilution, ThermoFisher, A-21270) for 3 hrs at room temperature, washed, and then stained with anti-rabbit Alexa Fluor 488 (1:500 dilution, ThermoFisher, A21202). Cells were then incubated with rabbit anti-OAS1 antibody (1:100 dilution, ThermoFisher, PA5-82113) overnight, washed, and stained with anti-rabbit Alexa Fluor 680 (1:500 dilution, ThermoFisher, A10043). Slides were mounted with antifade mounting media with DAPI (Thermo Fisher) and imaged at 63x magnification on an LSM700 confocal laser scanning microscope (Carl Zeiss) using an inverted oil lens. Colocalization and correlation coefficients between OAS1 and Golgin-97 expression were generated with LSM700 Zen software by analyzing randomly imaged fields of view (5-7 fields) containing at least 7 cells from IFN β -treated wells. The linear relationship between the expression of OAS1 and Golgin-97 at every pixel with protein expression was determined with Pearson's correlation coefficient³⁹. Cells with less than 10 analyzed pixels were excluded due to very low expression

of either protein, making the correlation data unreliable. Mander's overlap coefficients were also calculated³⁹, which factor in the total number of pixels of either protein.

RNA-seq analysis of data from NCBI SRA and TCGA

RNA-seq datasets were accessed from the NCBI sequence read archive (SRA) by using SRA command-line tools. SRA datasets analyzed in this study are listed in **Table S15**. Briefly, the raw FASTQ files were aligned with STAR version 7.1.31 to the reference human genome assembly (hg38). Low-quality sequencing files with $\leq 80\%$ of mappable reads were excluded from further analyses. BAM slices were indexed and sliced to include 117 Kb of the *OAS1-3* genomic region, chr12:112,901,893-113,019,729, hg38. For TCGA, BAM slices for the *OAS* gene locus were generated through the NCI Genomics Data Commons portal accessed on 25 November 2020, using standard workflow (https://docs.gdc.cancer.gov/API/Users_Guide/BAM_Slicing/).

Estimation of RNA-seq read counts specific to *OAS1* isoforms

Expression of *OAS1* isoforms - *p42*, *p44*, *p46*, and *p48* was quantified based on unique RNA-seq reads. Specifically, RNA-seq BAM slices were processed using the R package ASpli version 1.5.1 with default settings, and exon and exon-exon junction specific reads were quantified and exported in a tab file format. For *OAS1* isoforms - *p44*, *p46*, and *p48*, RNA-seq reads specific to their unique last exon-exon junctions were used for quantification. For the *p42* isoform, which does not have a unique exon-exon junction, sequencing reads corresponding to its unique 3' UTR (extension of exon 5) were used as a proxy for quantification. For normalizing the expression, junction reads were divided by 50 (average length of an RNA-seq read), and *p42* 3' UTR exon reads were divided by 317 bp, corresponding to its length. The mean expression of

each isoform was calculated from samples with ≥ 3 RNA-seq reads supporting the unique splice junction or exon.

Analysis of ATAC-seq, ChIP-seq, and Hi-C data of cell lines

The ATAC-seq, H3K27ac ChIP-seq, Hi-C, and RNA-seq raw data for SW780, HT1376, and SCABER bladder cancer cell lines were downloaded from NCBI SRA (ID: PRJNA623018) using the SRA tools. For ATAC-seq and H3K27ac ChIP-seq analysis, the FASTQ files were aligned to hg19 using Encode-DCC ATAC-seq-pipeline (<https://github.com/ENCODE-DCC/atac-seq-pipeline>) and chip-seq-pipeline2 (<https://github.com/ENCODE-DCC/chip-seq-pipeline2>) with default settings. The output bigwig files were then uploaded to the UCSC genome browser for visualization. For RNA-seq analysis, the FASTQ files were mapped to hg19 using STAR aligner (<https://github.com/alexdobin/STAR>) with default settings. The output sorted BAM files were indexed using SAM tools (<https://github.com/samtools/>). For Hi-C, FASTQ files were processed using Juicer (<https://github.com/aidenlab/juicer>) by selecting relevant restriction cutting sites such as Mbo I/Dpn II and aligned to hg19. The chromatin loops in Hi-C data were detected using Hiccups in Juicer tools with default settings. The same procedure was applied to analyze Hi-C data for THP-1 monocytic cell line untreated or treated with INF β for 6 hrs. The Hi-C and chromatin interaction files were visualized in the UCSC genome browser (<https://genome.ucsc.edu>). Integrative data analysis was performed to identify open chromatin marks and chromatin interactions between potential genetic variant co-localizing with enhancers and promoters of *OAS1*, *OAS2*, and *OAS3* within the COVID-19-associated genetic locus.

Genotyping and allele-specific expression analysis from RNA-seq data

RNA-seq BAM slices were genotyped for *OAS1* exonic variants with an IGV command-line tool using 21 bp sequence centered at each variant. For each variant, a 10% threshold of allele-specific reads was used for genotype calling.

Analysis of exonic splicing enhancer activity affected by rs1131454 within *OAS1* exon 3

The allele-specific 27 bp sequence (GUCAGUUGACUGGC[A/G]GCUAUAACUA) centered on rs1131454 was used for the prediction of exonic splicing enhancer (ESE)/silencer (ESS) motifs using the Human Splicing Finder (HSF, www.umd.be/HSF3/). The binding sites for alternative splicing factors were depicted with a bar graph. Exontrap mini-genes were generated for alleles of rs1131454. Specifically, allele-specific sequences of exon 3 with 100 bp of flanking intronic sequences and overhangs for restriction sites (Xho1 and Not1) were custom-synthesized as gene fragments (IDT, **Table S16**). These fragments were cloned in sense orientation in Exontrap vector pET01 (MoBiTec) using XhoI and NotI restriction sites and validated by Sanger sequencing. The A549 and T24 cells were seeded in a 12-well plate at a cell density of 2×10^5 and transfected after 24 hrs with 200 ng of allele-specific mini-genes using Lipofectamine 3000 transfection reagent (Invitrogen) in 3 biological replicates. At 48 hrs post-transfection, cells were harvested, and total RNA was extracted with QIAcube using RNeasy kit with on-column DNase I treatment (Qiagen). cDNA was prepared for each sample with 500 ng of total RNA using SuperScript III reverse transcriptase (Invitrogen) and a vector-specific primer: 5'-AGGGGTGGACAGGGTAGTG-3'. cDNA corresponding to 5 ng of RNA input was used for each RT-PCR reaction. Two common primer pairs were used for characterizing splicing products of allele-specific mini-genes (**Table S16**). Only primer pair 1 (FP vector exon 1: GGA GGA CCC ACA AGG TCA GTT; and RP exon 3: GCTG CTT CAG GAA GTC TCT CTG) identified alternative splicing

events corresponding to endogenous exon 3 splicing between vector exon 1 and insert after PCR-amplified products were resolved by agarose gel electrophoresis. The specific bands were cut out from the gel, purified, and validated by Sanger sequencing. The ratio of alternative splicing products was calculated based on band intensity using densitometry, and fold changes were calculated between two allele-specific mini-genes.

Oxford Nanopore RNA-seq

A549 or HT1376 cells (2×10^6 per sample) were seeded in T25 flasks overnight. The next day media was replaced with either media containing 2 ng/mL IFN β (treated) or normal media without IFN β (mock). Total RNA was prepared from cells 24 hrs post-treatment using the RNeasy Mini Kit (Qiagen). PolyA+ RNA was enriched from total RNA using the Dynabeads mRNA Purification Kit (Invitrogen). cDNA libraries were prepared from 200 ng of PolyA+ RNA using the Direct cDNA Sequencing Kit (Oxford Nanopore), according to the PCR-free 1D read protocol for full-length cDNA (Oxford Nanopore, SQK-DCS109), with some modifications. Specifically, RNase Cocktail Enzyme Mix (ThermoFisher) was used during the RNA digestion step after the first-strand synthesis; all reaction amounts for reverse transcription reactions up to the second-strand synthesis step were doubled; from second-strand synthesis up to adapter ligation, reactions were 1.5x of original amounts; during adapter ligation, 35 μ l Blunt/TA Ligase Master Mix was used instead of the recommended 50 μ l, and nuclease-free water was excluded. Final libraries were loaded into MinION Fluidics Module flow cells (Oxford Nanopore, FLO-MIN106D), and sequencing was carried out on GridION MK1 and MinION MK1C instruments (Oxford Nanopore) for 3 days, using default parameters.

The FASTQ files generated by Nanopore GridION long-read sequencer were trimmed using Porechop (<https://github.com/rrwick/Porechop>) and aligned to the hg19 genome using Minimap2 (<https://github.com/lh3/minimap2>) with -ax splice command. The output SAM files were then converted to indexed, sorted BAM files using SAM tools (<https://github.com/samtools/>). The BAM files were visualized with the UCSC genome browser.

Analysis of nonsense-mediated decay (NMD) of *OAS1* isoforms

We downloaded RNA-seq data for HeLa cells (*OAS1*-p42 expressing) with and without siRNA-mediated knockdown of NMD genes – *SMG6* and *SMG7* (SRA:PRJNA340370). The FASTQ files were aligned with STAR aligner (<https://github.com/alexdobin/STAR>) with default settings followed by quantification of isoforms-specific reads for alternative splicing junctions of *OAS1* exon 3 with adjacent exons. The data was also visualized as sashimi plots using Integrative Genome Viewer. We also generated a triple-knockdown (tri-KD) by transfecting A549 (*OAS1*-p42 expressing) and HT1376 (*OAS1*-p46 expressing) cells with siRNAs – scrambled (negative control) and targeting genes for the NMD pathway (*SMG6*, *SMG7*, and *UPF1*). After 48 hrs, cells were harvested, and total RNA was isolated using an RNeasy kit with on-column DNase I treatment (Qiagen). Subsequently, cDNA for each sample was prepared from equal amounts of RNA using the RT² First-Strand cDNA kit (Qiagen). TaqMan assays were used to confirm the knockdown of each gene, using the expression of *HPRT1* as an endogenous control (**Table S14**). Detection of *OAS1* exon 3 splicing events was done with custom expression assays (**Table S14**). For each condition, experiments were performed in biological triplicates, and expression was quantified in four technical replicates on QuantStudio 7 (Life Technologies) using TaqMan Gene Expression buffer (Life Technologies). Genomic DNA and water were used as negative controls

for all assays. Expression was measured as C_t values (PCR cycle at detection threshold) and calculated as dC_t values normalized by endogenous control and ddC_t values normalized by a reference group of samples.

Western blotting

Cells (Caco2, HT1376, A549, and HBEC) were plated in 6-well plates (5×10^5 cells per well) and were untreated or treated with IFN β (1ng/ml), IFN γ (2ng/ml) or IFN- $\lambda 3$ (100ng/ml) for 24 hrs. Cells were lysed with RIPA buffer (Sigma) supplemented with protease inhibitor cocktail (Promega) and PhosSTOP (Roche) and placed on ice for 30 min, with vortexing every 10 min. Lysates were pulse-sonicated for 30 s, with 10 s burst-cooling cycles, at 4°C, boiled in reducing sample buffer for 5 min and resolved on 4–12% Bis-Tris Bolt gels and transferred using an iBlot 2 (ThermoFisher). Blots were blocked in 2.5% milk in 1% TBS-Tween before staining with rabbit anti-OAS1 antibody (1:200, Thermo Fisher, PA5-82113) and rabbit anti-GAPDH antibody (1:500, Abcam, ab9485). The signals were detected with HyGLO Quick Spray (Denville Scientific) or SuperSignal West Femto Maximum Sensitivity Substrate (ThermoFisher) and viewed on a ChemiDoc Touch Imager with Image Lab 5.2 software (Bio-Rad).

Bioinformatic analyses

We utilized the computational resources of the NIH Biowulf supercomputing cluster (<http://hpc.nih.gov>) and specific packages for R version 3.6.2.

Data availability

Summary statistics for all genetic analyses is provided in Supplementary Tables. Individual genotypes will be submitted to dbGAP. Dataset for Oxford Nanopore RNA-seq was deposited to

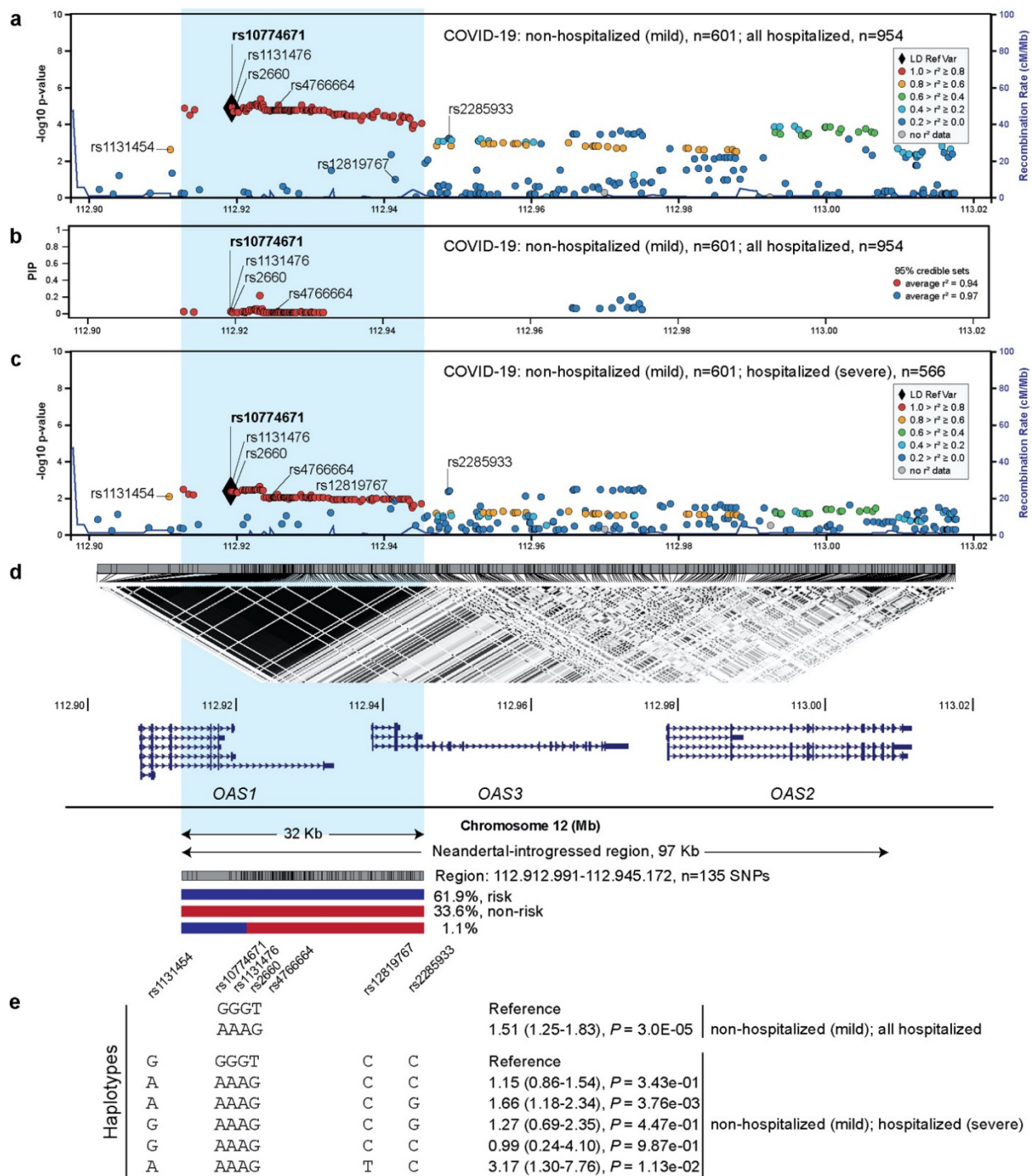


Figure 1. Association analyses within the chr12q24.13 region in relation to COVID-19 outcomes in patients of European ancestry.

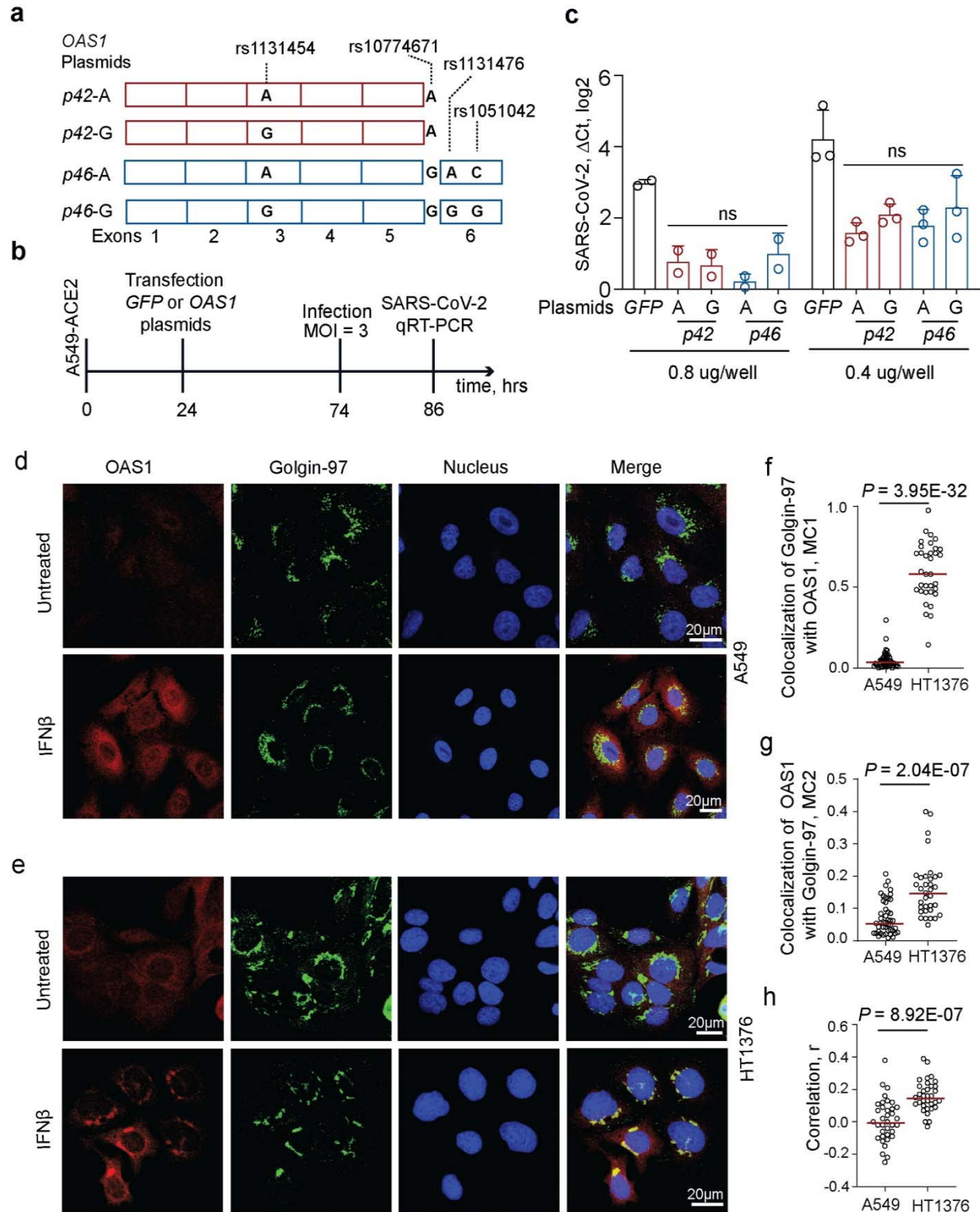


Figure 2. Anti-SARS-CoV-2 activity and subcellular localization of OAS1-p42 and p46 isoforms.

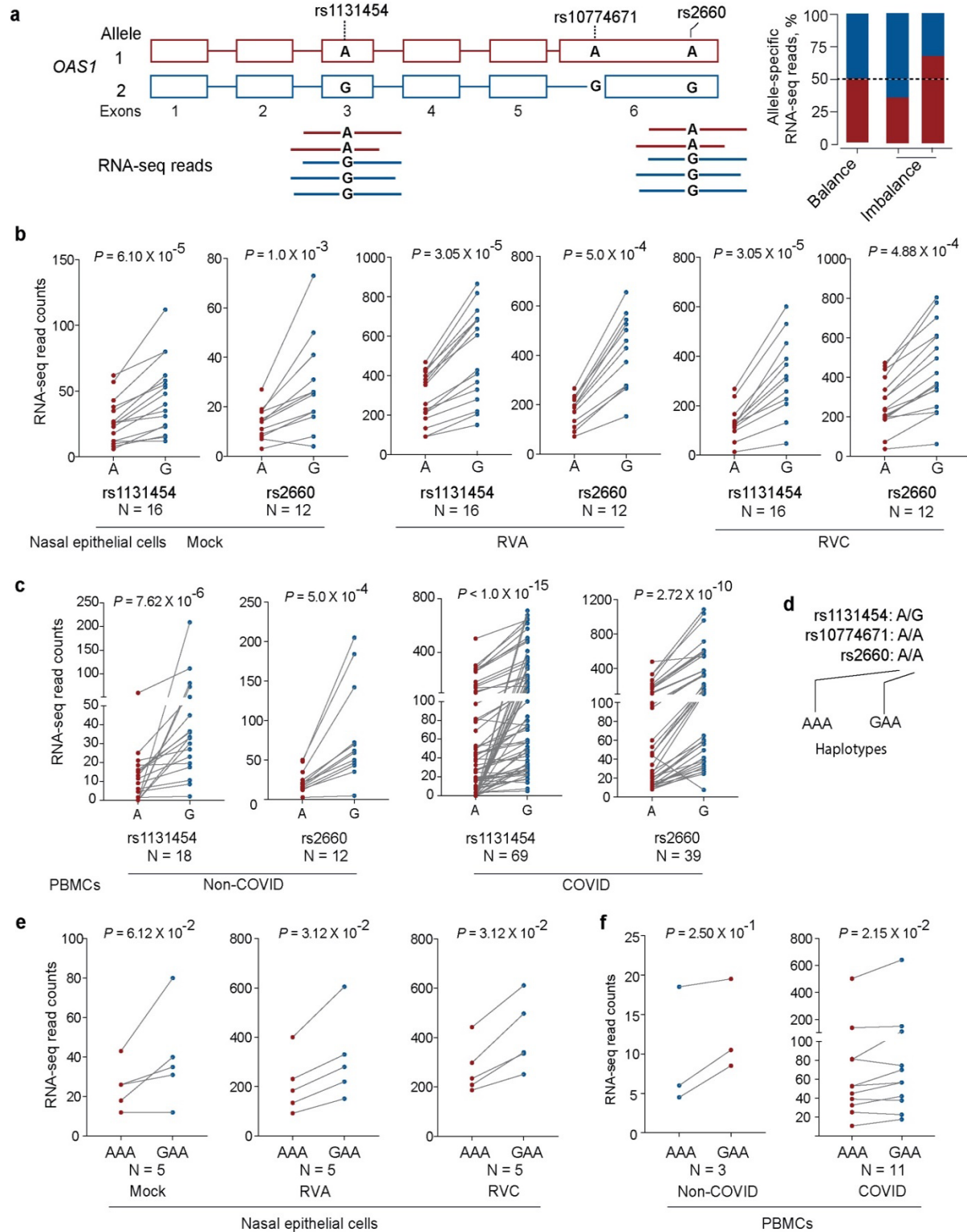


Figure 3. Allelic expression imbalance of *OAS1* transcripts.

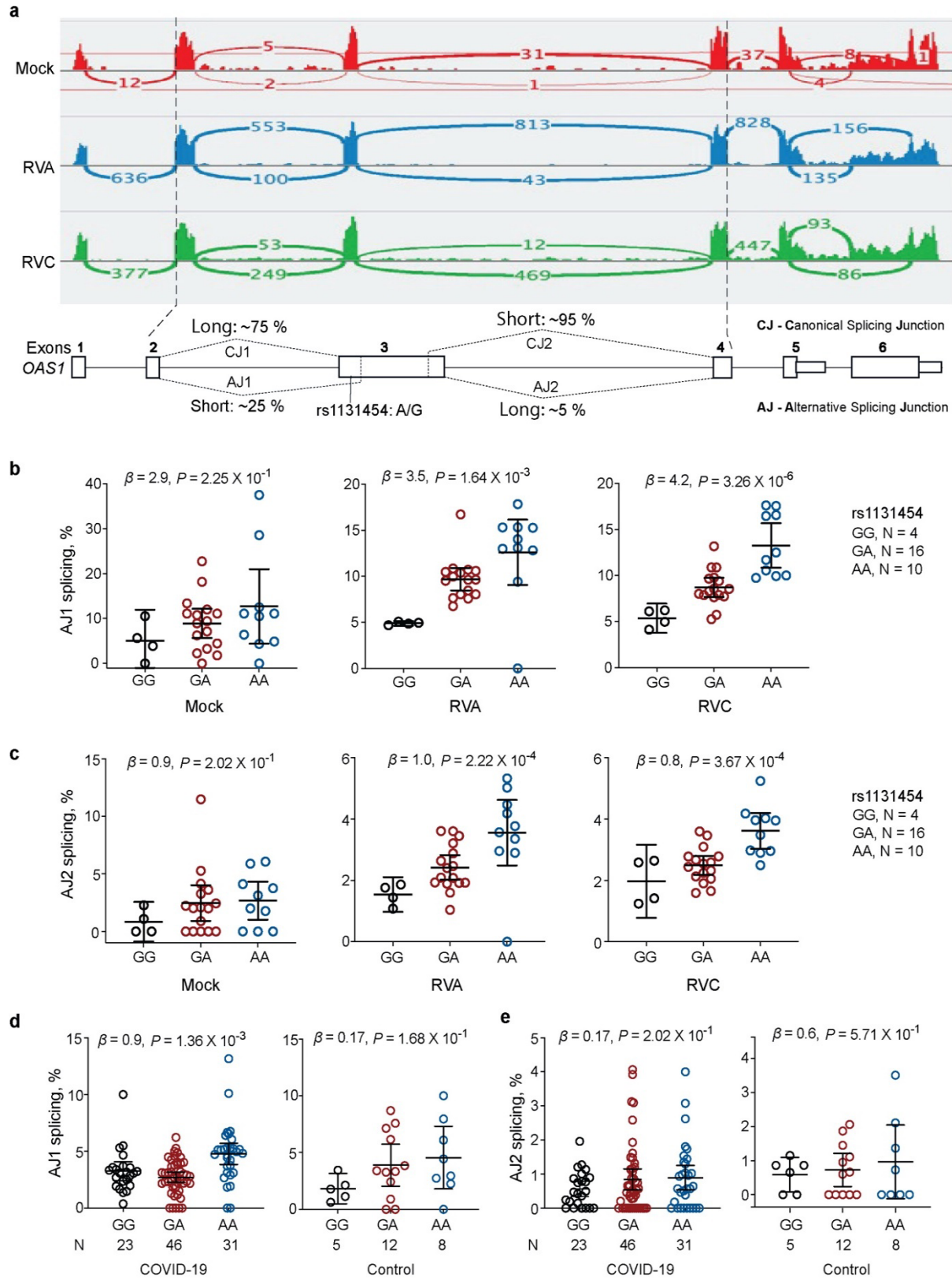


Figure 4. Splicing of *OAS1* exon 3 is associated with rs1131454

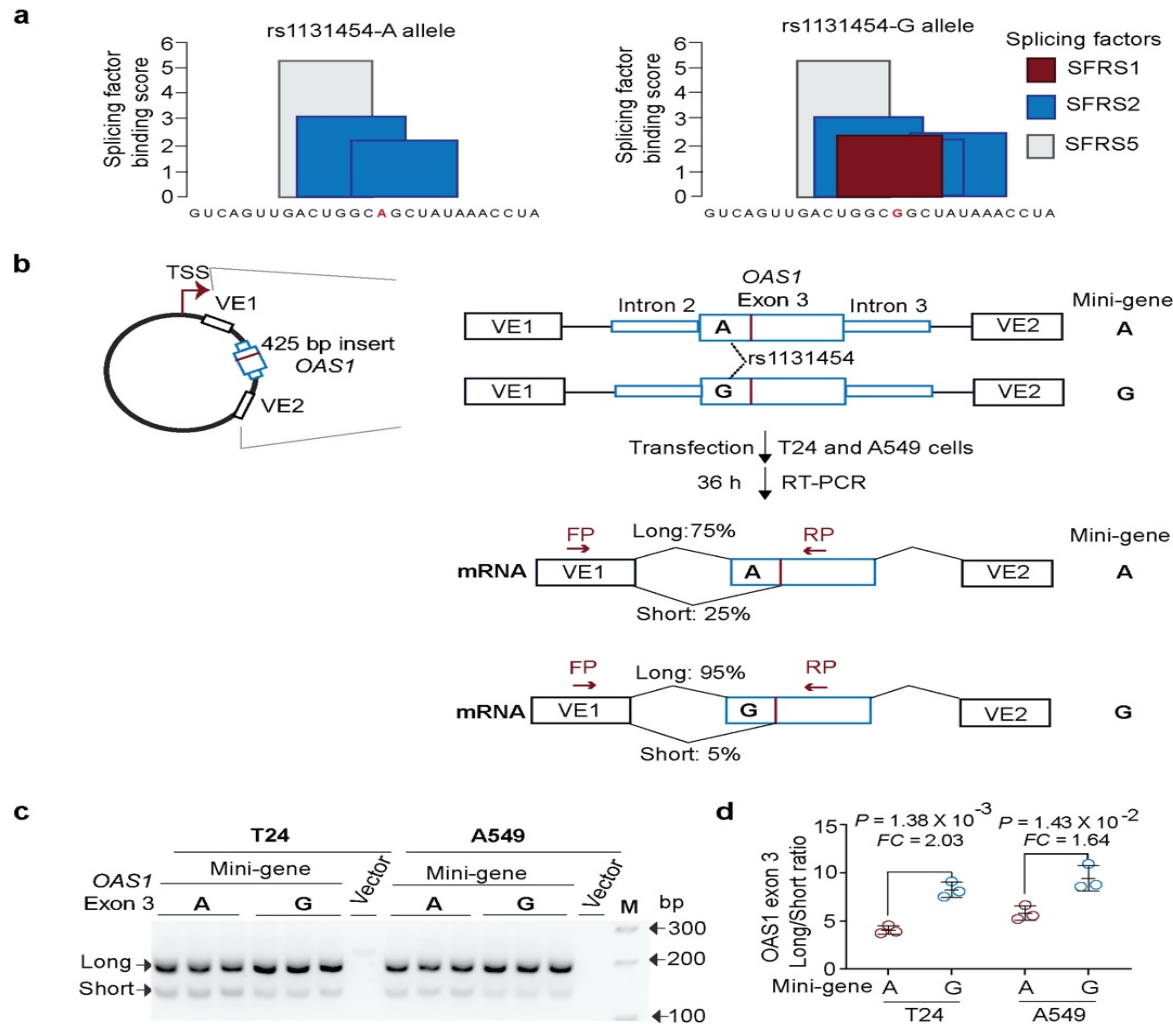


Figure 5. Exontrap assays demonstrate the functional effect of rs1131454 on *OAS1* exon 3 splicing.

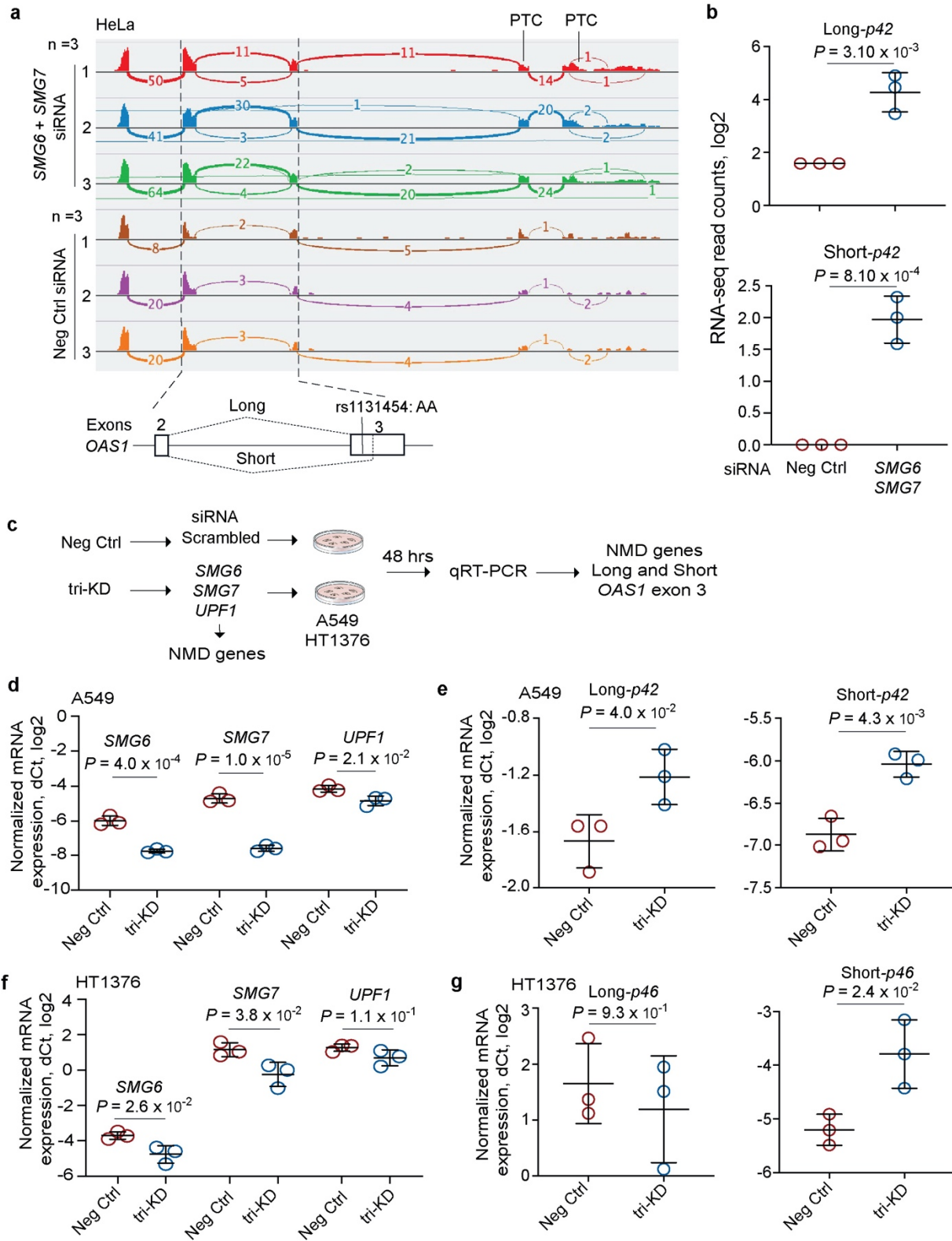


Figure 6. Nonsense-mediated decay targets *OAS1* isoforms with Short exon 3 upregulated by risk rs1131454-A allele.

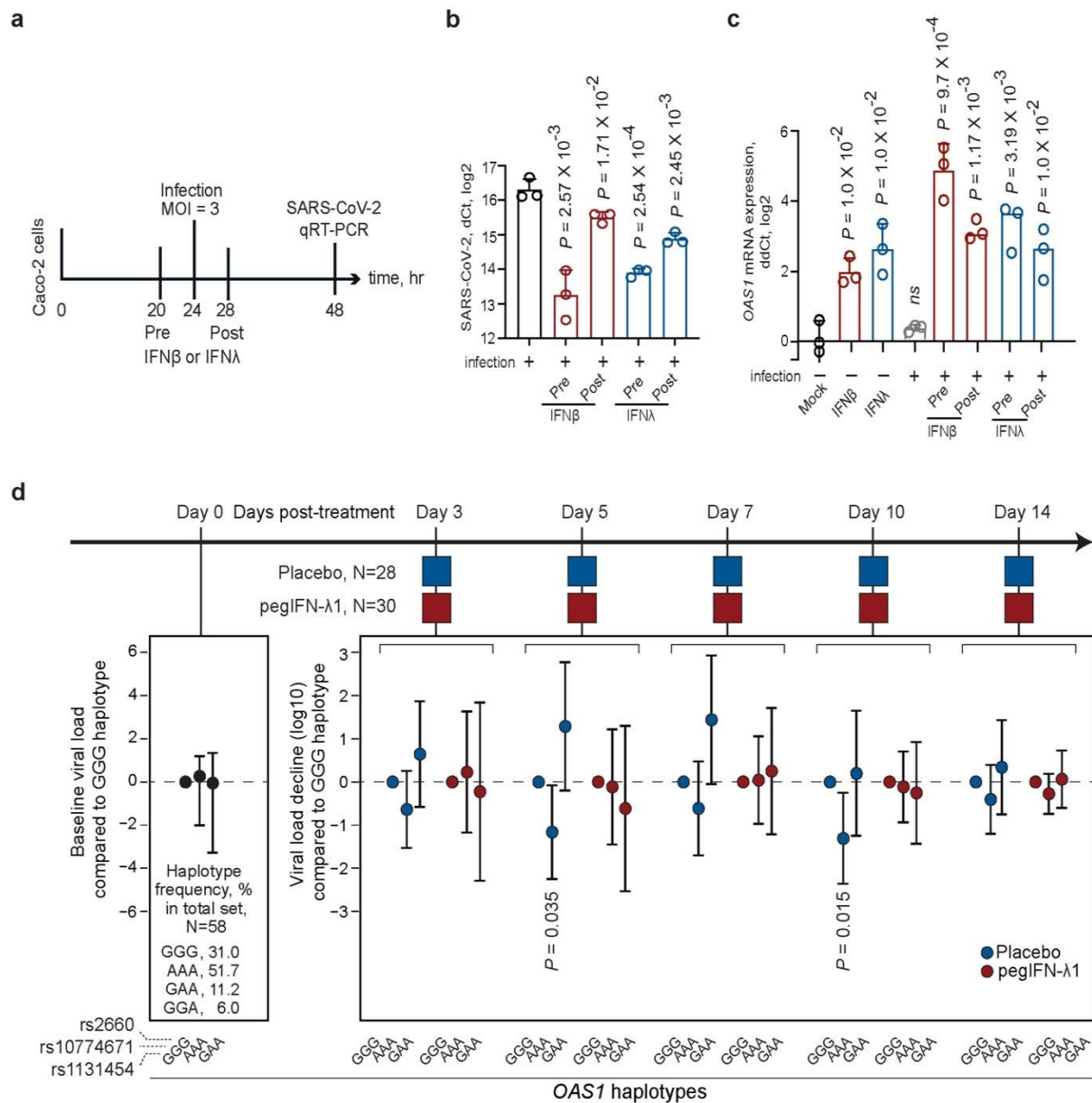


Figure 7. Effects of interferons on SARS-CoV-2 viral loads *in vitro* and in patients in a clinical trial.

copies per ml) was evaluated at indicated days compared to day 0. The viral load decline is presented comparing to *OAS1*-GGG haplotype (rs1131454-G, rs10774671-G, rs2660-G) and adjusting for age, sex, and viral load at day 0 (complete results are shown in **Table S12**).

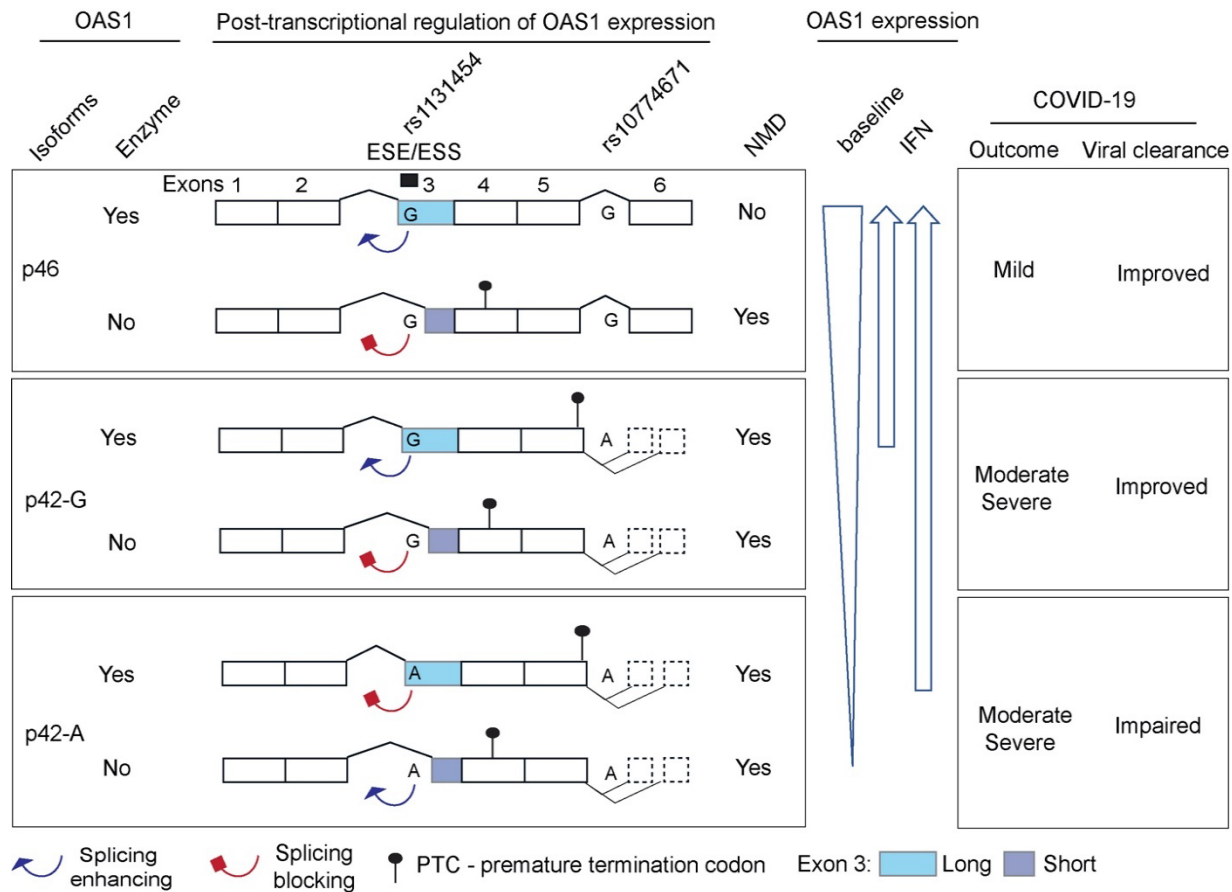


Figure 8. The proposed model for mechanisms underlying association between *OAS1* genetic variants and COVID-19 outcomes.

Two *OAS1* variants – exon 3 missense variant (*rs1131454*-A/G, Gly162Ser) and splice site variant (*rs10774671*-A/G) determine the structure and expression levels of *OAS1* isoforms. Alleles of the splicing variant *rs10774671* define the *OAS1* isoforms – *OAS1-p42* (A allele) and *OAS1-p46* (G allele). Alleles of *rs1131454* create an exonic splicing enhancer/silencer (ESE/ESS) for splicing of the canonical/Long vs. alternative/Short exon 3. Transcripts with Short exon 3 are terminated by premature stop codons (PTCs) within exon 4 and efficiently targeted by nonsense-mediated decay (NMD). The stop codon for *OAS1-p42* is located within exon 5, followed by several additional exons creating *OAS1-p44* and *OAS1-p48* isoforms, making this stop codon a PTC. Thus, *OAS1-p42* is also targeted by NMD, albeit less efficiently compared to transcripts with PTCs in exon 4. The combined splicing effects of *rs10774671*, which creates alternative *OAS1* isoforms and *rs1131454*, which regulates the inclusion of Short or Long exon 3 and thus the

introduction of additional PTCs result in variable degradation of *OAS1* transcripts by NMD. At baseline, the expression is highest for *OAS1-p46* and the lowest for *OAS1-p42-A*. However, treatment with IFNs may compensate for NMD, allowing *OAS1-p42* protein to reach expression levels comparable to *OAS1-p46*. Thus, the effects of genetic variants on *OAS1* expression can be compensated by IFN treatment to overcome impaired viral clearance leading to severe COVID-19.

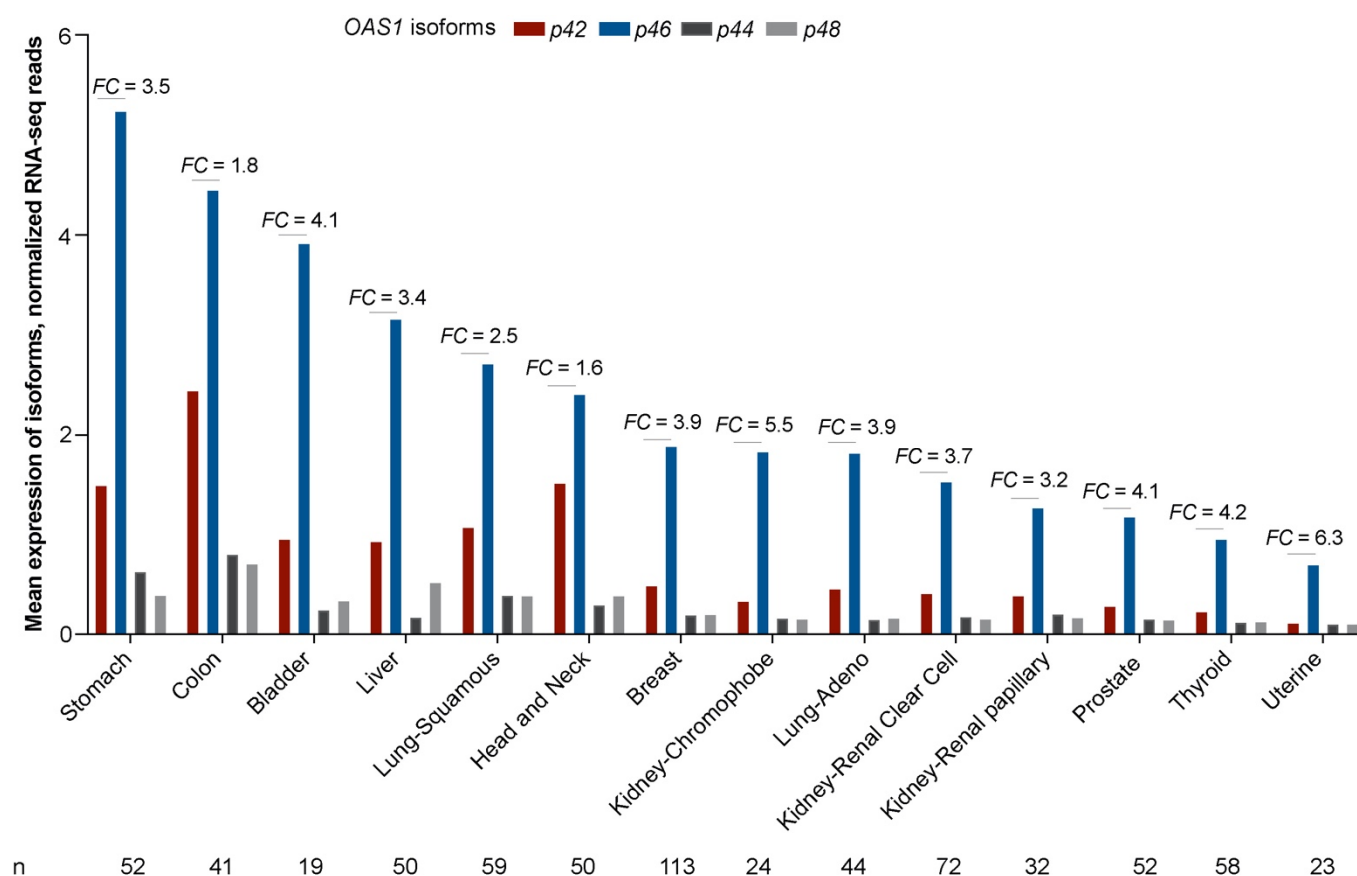


Figure S1. Mean expression levels of *OAS1* isoforms in adjacent normal tissues in TCGA.

Expression of *OAS1* isoforms was analyzed in RNA-seq data in The Cancer Genome Atlas (TCGA), using tumor-adjacent normal tissues with RNA-seq data in ≥ 15 samples. RNA-seq reads for each *OAS1* isoform were calculated based on unique splice junctions (*OAS1*-p44, p46, and p48) or unique 3' UTR (p42). For normalization, the total number of RNA-seq reads for exon-exon junctions for p44, p46 and p48 was divided by 50 (length of an RNA-seq read) and unique RNA-seq reads for p42 exon 5 by its length (317 bp). The mean expression levels of each isoform were calculated from all the samples with ≥ 3 RNA-seq reads. Overall, the mean expression of *OAS1*-p46 is higher than *OAS1*-p42, with an average fold change (FC) of 3.9 across tissues.

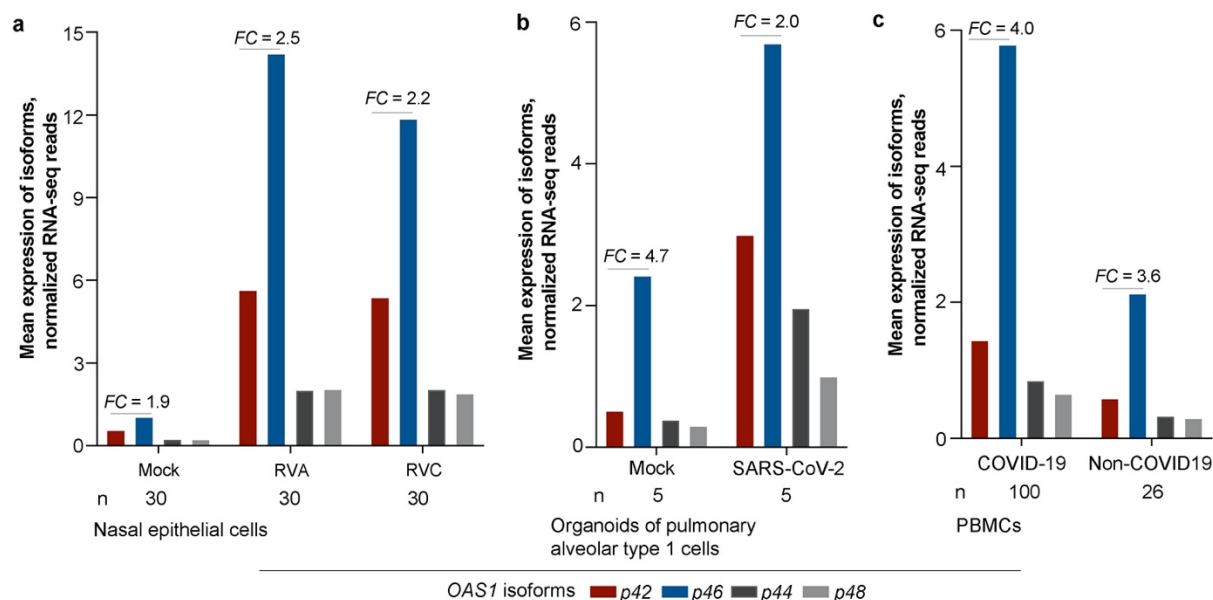


Figure S2. Mean expression levels of *OAS1* isoforms in nasal epithelial cells, pulmonary alveolar cells and PBMCs.

Expression of *OAS1* isoforms was analyzed in RNA-seq data of **a**) nasal epithelial cells (SRA PRJNA627860), **b**) organoids of pulmonary alveolar type 1 cells (SRA PRJNA673197), and **c**) PBMCs (SRA PRJNA660067). The bar graphs show the mean expression levels of each *OAS1* isoform normalized as described in **Figure S1**. The expression of *OAS1-p46* is higher than *OAS1-p42* in all cell types and conditions tested.

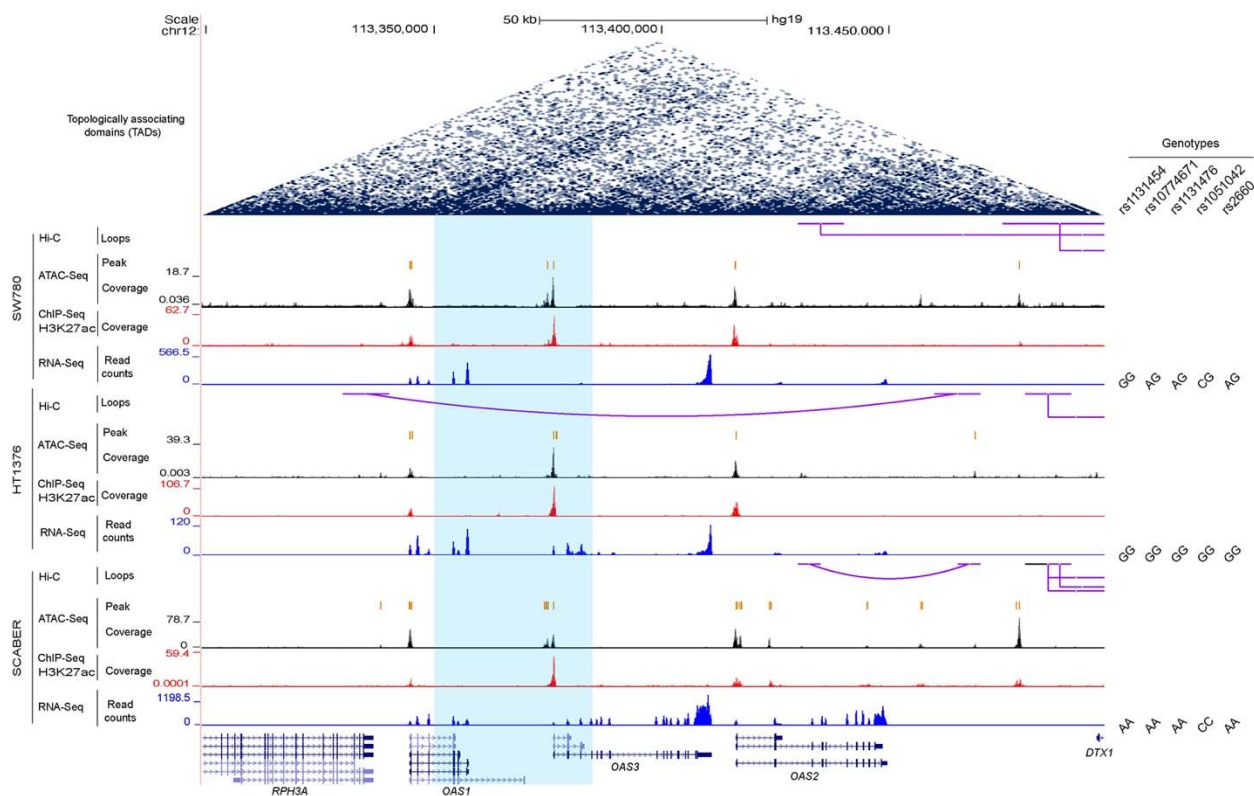


Figure S3. Multi-omics profile of the *OAS1/OAS3/OAS2* genomic region.

Multi-omics data for genome-wide Hi-C, ATAC-seq, H3K27ac ChIP-seq, and RNA-seq of three bladder cancer cell lines (SRA PRJNA623018) were analyzed and visualized using UCSC genome browser. *OAS1*, *OAS2*, and *OAS3* expression was observed in all samples, but there is no evidence of open chromatin, enhancer activity, or chromatin interactions within the LD block (blue shading) that includes top 125 variants associated with hospitalized vs. non-hospitalized COVID-19 in Europeans (Figure 1).

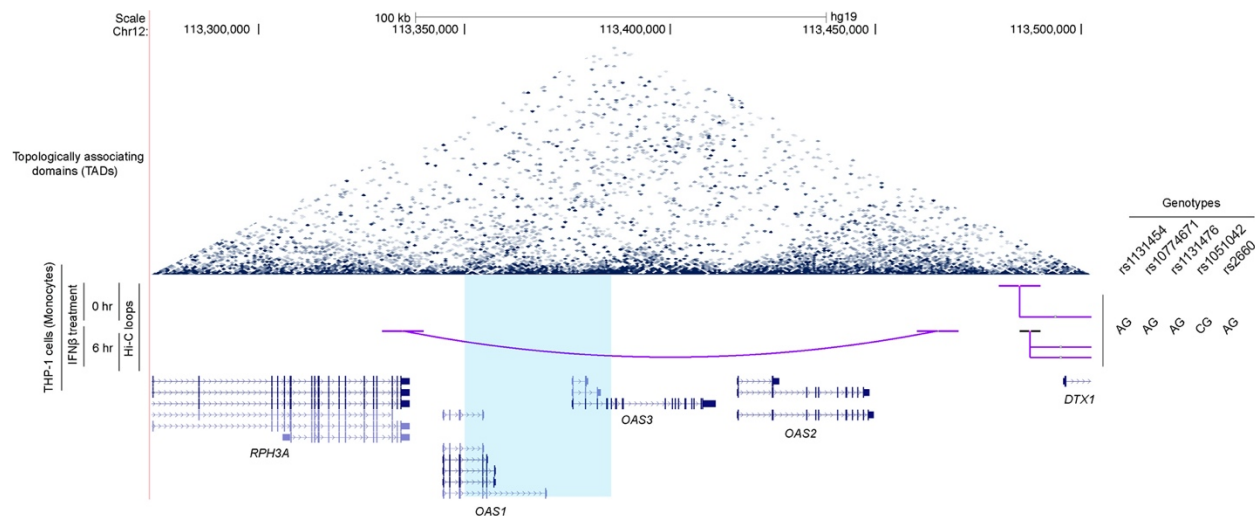


Figure S4. Hi-C chromatin interaction analysis in the *OAS1/OAS3/OAS2* genomic region.

Chromatin interaction (Hi-C) data for the THP-1 monocytic cell line untreated and treated with IFN β for 6 hrs (SRA PRJNA401748) were analyzed and visualized using UCSC genome browser. No chromatin interactions were detected with the LD block (blue shading) that includes top 125 variants associated with hospitalized vs. non-hospitalized COVID-19 in Europeans (**Figure 1**).

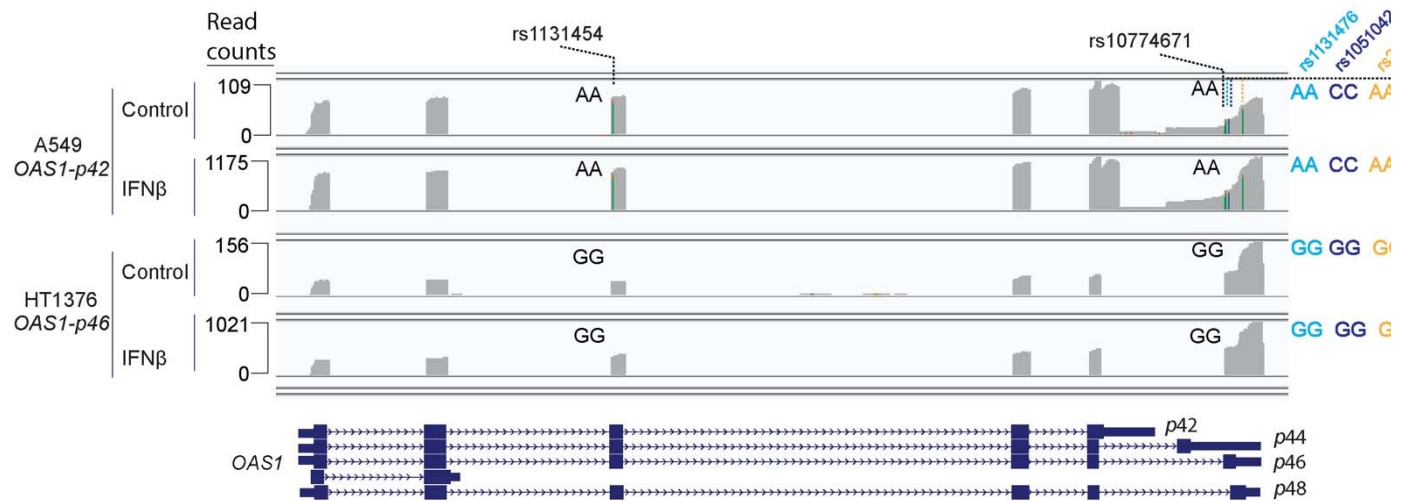


Figure S5. Long-read sequencing of *OAS1* transcripts in A549 and HT1376 cells with and without IFN β treatment.

The A549 (rs10774671-AA, *OAS1*-p42) and HT1376 (rs10774671-GG, *OAS1*-p46) cells were treated with IFN β or PBS (control) for 48 hrs. Total RNA was harvested and subjected to long-read sequencing with Oxford Nanopore. In both cell lines, the expression of *OAS1* isoforms was strongly induced by IFN β treatment. The IGV plots show auto-scaled profiles with read counts indicating maximum coverage in the window. Genotypes of transcribed variants are indicated.

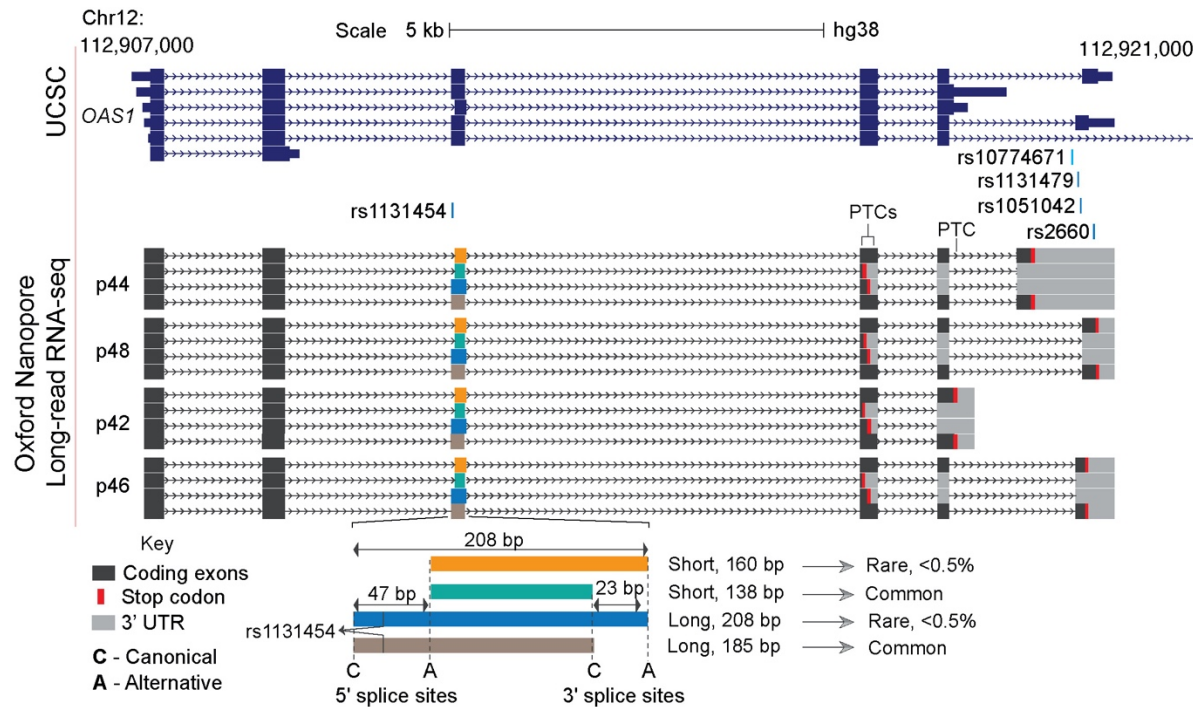


Figure S6. Long-read sequencing of *OAS1* transcripts demonstrates functional consequences of alternative splicing of exon 3.

UCSC genome browser view shows the known *OAS1* transcripts and full-length sequences of *OAS1* isoforms determined by long-read RNA-seq with Oxford Nanopore (Figure S5). Splicing patterns of *OAS1* exon 3 depend on two acceptor and two donor splice sites that define the Short and Long exon 3 isoforms. Two common exon 3 isoforms are Short (138 bp) and Long (185bp), and rare (<5% reads) exon 3 isoforms are Short (160 bp) and Long (208 bp). The inclusion of common Short (138 bp) or rare Long (208 bp) exon 3 isoforms results in premature termination codons (PTC) in exon 4. The stop codon of canonical *p42* isoforms presented by rare Short (160 bp) and common Long (185 bp) isoforms is located within exon 5 and functions as a PTC due to the inclusion of additional exons creating *p44* or *p48* isoforms. All transcripts with PTC are targeted by nonsense-mediated decay (NMD) with a variable extent of degradation depending on specific isoforms.

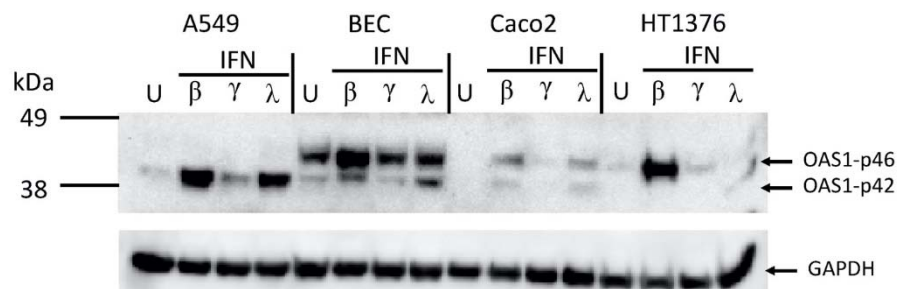
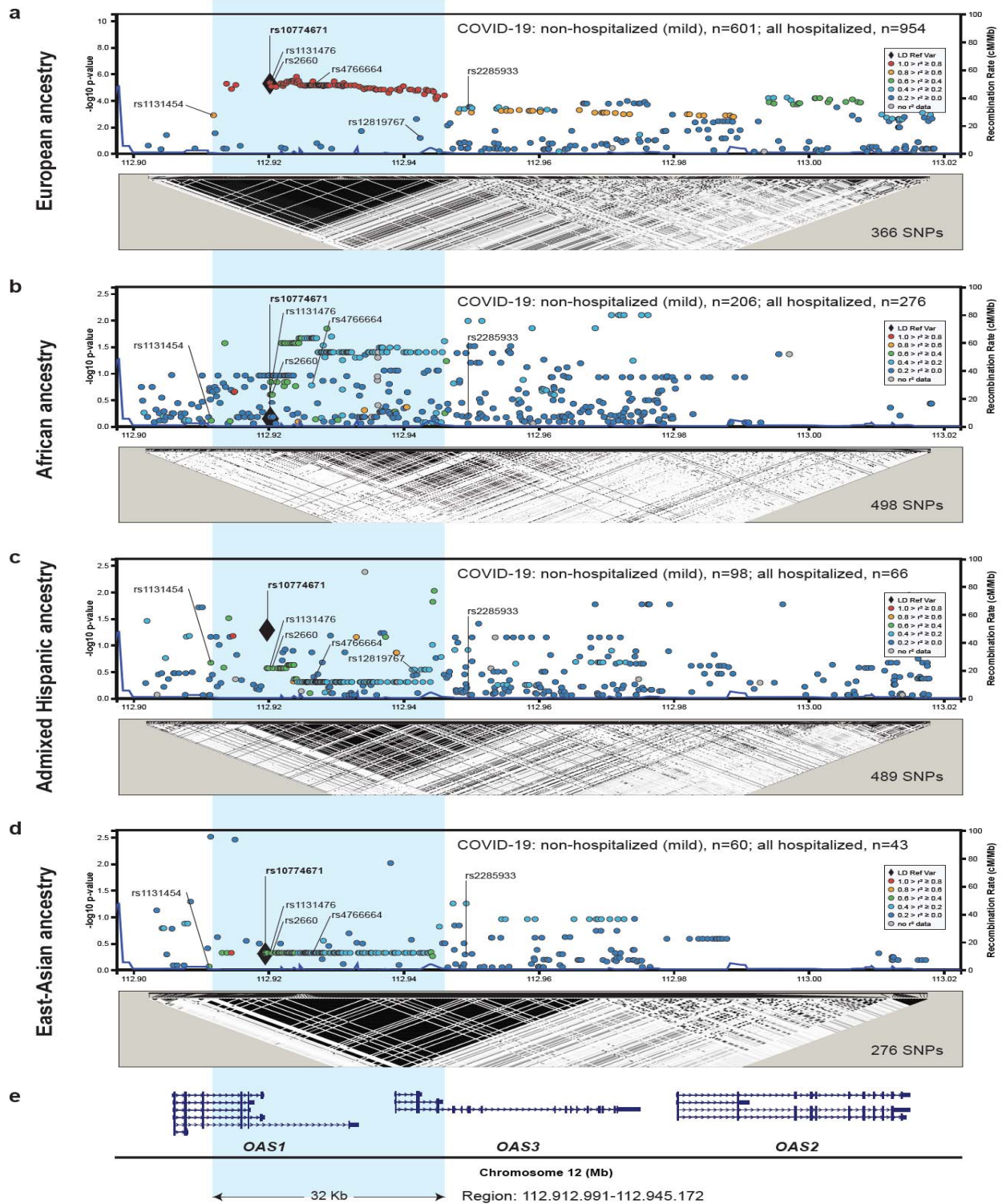


Figure S7. Western blot analysis of expression of endogenous OAS1-p42 and p46 protein isoforms in human cell lines.

Four cell lines with different genotypes of rs10774671: A549 (AA), primary bronchial epithelial cells BEC (AG), Caco2 (AG), and HT1376 (GG) were treated with interferons – IFN β (2ng/mL), IFN γ (2ng/mL) or IFN- λ 3 (100 ng/mL) for 48 hrs. Similar amounts of protein lysates were used for Western blot with C-terminal OAS1 antibody. Only two isoforms, OAS1-p42 and p46, were detected, with p46 protein being dominant in heterozygous cell lines. In homozygous cell lines, the protein expression of p42 and p46 appeared comparable after IFN treatment.

Association analyses and LD plots (r^2) in patients with non-hospitalized (mild) vs. hospitalized COVID-19 in patients of **a)** European ancestry (n=1555); **b)** African ancestry (n=483); **c)** Admixed Hispanic ancestry (n=166); and **d)** East-Asian ancestry (n=103). **e)** location of *OAS1*, *OAS3*, and *OAS2* reference transcripts. Haplotype analysis of four core variants within the 32 Kb LD block (hg38: chr12:112912991-112945172), marked by blue shading, tagging the Neandertal haplotype in Europeans. Association results comparing the main risk vs. main non-risk (Neandertal) haplotypes. Full association results for individual variants and haplotypes are provided in **Tables S4-S8**.
