# Differences in the genetic architecture of common and rare variants in

## childhood, persistent and late-diagnosed attention deficit hyperactivity

## disorder

**ABSTRACT** 

Attention deficit hyperactivity disorder (ADHD) is a neurodevelopmental disorder, with onset in childhood ("childhood ADHD"), and around two thirds of affected individuals will continue to have ADHD symptoms in adulthood ("persistent ADHD"). Age at first diagnosis can vary, and sometimes ADHD is first diagnosed in adulthood ("late-diagnosed ADHD").

In this study, we analyzed a large Danish population-based case-cohort generated by iPSYCH in order to identify common genetic risk loci and perform in-depth characterization of the polygenic architecture of childhood (N=14,878), persistent (N=1,473) and late-diagnosed ADHD (N=6,961) alongside 38,303 controls. Additionally, the burden of rare protein truncating variants in the three groups were evaluated in whole-exome sequencing data from a subset of the individuals (7,650 ADHD cases and 8,649 controls). We identified genome-wide significant loci associated with childhood ADHD (four loci) and late-diagnosed ADHD (one locus). In analyses of the polygenic architecture, we found higher polygenic score (PGS) of ADHD risk variants in persistent ADHD (mean PGS=0.41) compared to childhood (mean PGS=0.26) and late-diagnosed ADHD (mean PGS=0.27), and we found a significant decreased genetic correlation of late-diagnosed ADHD with inattention (r<sub>g</sub>=0.57) compared to childhood ADHD (r<sub>g</sub>=0.86). These results suggest that a higher ADHD polygenic risk burden is associated with persistence of symptoms, and that a later diagnosis of ADHD could be due in part to genetic factors. Additionally, childhood ADHD demonstrated both a significantly increased genetic overlap with autism compared to late-diagnosed ADHD as well as the highest burden of rare protein-truncating variants in highly constrained genes among ADHD subgroups (compared to controls: beta=0.13, P=2.41x10<sup>-11</sup>). Late-diagnosed ADHD demonstrated significantly larger genetic overlap with depression than childhood ADHD and no increased burden in rare protein-truncating variants (compared to controls: beta=0.06). Overall, our study finds genetic

heterogeneity among ADHD subgroups and suggests that genetic factors influence time of first

ADHD diagnosis, persistence of ADHD and comorbidity patterns in the sub-groups.

**INTRODUCTION** 

Attention deficit hyperactivity disorder (ADHD) is a childhood neurodevelopmental disorder

characterized by age-inappropriate levels of hyperactivity, impulsivity and inattention. The disorder

affects around 5-6% of school-age children, and around 3% of adults<sup>1,2</sup>. It is a complex disorder with

both environmental and genetic factors contributing to the risk. Genetics explain a large part of the

etiology with an estimated twin heritability of 0.74<sup>3</sup>, and the contribution from common genetic

variants is substantial, explaining 22% of the phenotypic variance<sup>4</sup>.

Around two-thirds of children diagnosed with ADHD will continue to have symptoms in adulthood<sup>5</sup>,

which is referred to as "persistent ADHD". Persistent ADHD is associated with more severe

outcomes compared to the one-third of individuals that don't have ADHD as adults (remitters), e.g.

increased risk of substance use disorders<sup>6,7</sup>, nicotine dependence<sup>8</sup> and comorbidity with other

psychiatric disorders<sup>9-11</sup>. Several studies have reported a lower heritability for persistent ADHD than

for childhood ADHD<sup>12,13</sup>, however these findings have been questioned due to methodological

differences of assessment between children and adults 12,14. It has also been suggested that persistence

of symptoms has a genetic risk component specific to persistence rather than base line symptoms 15

and that a trajectory of persistent symptoms is associated with a high load of common ADHD risk

variants<sup>16</sup>.

According to the ICD10 diagnosis criteria, ADHD is a childhood onset disorder, and the behavioral

symptoms should be present prior to 7 years of age (prior to 12 years of age according to DSM-5

diagnosis criteria) with a duration of at least six months. However, the disorder is often diagnosed in

adolescence and can also be diagnosed in adult life. ADHD symptoms such as hyperactivity and

inattention are believed to have continuous distributions in the population, with diagnosed ADHD

representing the extreme end, which is supported by genetic findings<sup>4</sup>. The symptoms have an

impairing impact on an individual's life when the accumulation of environmental and genetic risk

factors exceeds a threshold. Age at first diagnosis might therefore differ depending on when this

threshold is passed. Environmental factors influencing this could be age-related, such as increased

educational demands in college or university, resulting in "late-diagnosed ADHD" (i.e. diagnosis in

adulthood). Age at first diagnosis might also be influenced by genetic factors affecting symptom

heterogeneity and/or severity, and a recent study found individuals with late-diagnosed ADHD to

have a burden of common ADHD risk alleles at a level comparable to individuals without ADHD<sup>17</sup>.

However, the sample size was very small (N=98 for late-diagnosed individuals), and further

investigations is needed in order to elucidate the impact of genetics on age at first diagnosis and

determine whether individuals diagnosed with ADHD in adulthood differ genetically from

individuals diagnosed as children.

We have previously performed a large genome-wide association study (GWAS) to evaluate the

genetic architecture of childhood and persistent ADHD including in total 17,149 ADHD cases and

32,411 controls<sup>18</sup>. The genetic correlation between the two groups was high ( $r_g = 0.81$ ) suggesting

that childhood and persistent ADHD to a large extent have the same underlying genetic architecture,

however we also noticed that the genetic correlation was significantly different from 1 (P=0.02),

suggesting that further dissection of the genetic architecture might reveal genetic differences.

Moreover, in that study all adult individuals with ADHD were grouped together, meaning that the

persistent group consisted of individuals diagnosed in childhood with persisting symptoms in

adulthood and individuals diagnosed as adults (i.e. late-diagnosed ADHD). Further subgrouping of

individuals with ADHD depending on age at first diagnosis could therefore reveal unknown

information about the genetic architecture underlying the disorder and comorbidities.

In this study we perform in-depth characterization of the polygenic architecture of childhood, persistent and late-diagnosed ADHD in a large Danish population-based cohort of ADHD cases and controls generated by iPSYCH<sup>19</sup>. We observe a higher polygenic burden of ADHD risk variants in persistent ADHD compared to childhood and late-diagnosed ADHD, and find a decreased genetic correlation of late-diagnosed ADHD with ADHD symptoms (inattention and hyperactivity), compared to childhood ADHD. Several significant differences in genetic overlap of ADHD subgroups with other phenotypes are identified, including an increased load of autism risk variants in individuals with childhood compared to late-diagnosed ADHD and a larger genetic overlap of

persistent and late-diagnosed ADHD with depression compared to childhood ADHD. Finally,

analyses of exome-sequencing data show a significant increased burden of rare protein truncating

variants in highly constrained genes in childhood and persistent ADHD compared to controls. This

at a rate that that was twice as high as observed for late-diagnosed ADHD, which did not show

significant enrichment.

**RESULTS** 

**Sample characteristics** 

Individuals with ADHD were identified in the large nation-wide population-based case-cohort

established by iPSYCH<sup>19</sup> consisting of 133,296 genotyped individuals. Individuals with ADHD were

identified by information in the Danish Psychiatric Central Research Register<sup>20</sup> (ICD10 diagnosis

code F90.0). ADHD cases were divided into three groups depending on age at first diagnosis: (1)

childhood ADHD (N=14,878), defined as individuals diagnosed with ADHD before 18 years of age

when the register information was obtained (2016) (2) persistent ADHD (N=1,473), defined as

individuals that received an ADHD diagnosis as a child (younger than 18 years of age) and again as

adults (older than 18 years of age) and (3) late-diagnosed ADHD (N=6,961), defined as individuals

with ADHD that received their first diagnosis as adults (older than 18 years of age). Controls were

randomly selected from the same nationwide birth cohort and not diagnosed with ADHD (N=38,303).

The sample sizes given above are the number of individuals which remained after quality control (see

methods).

The sex distribution was different in the three groups, as females composed 23% of childhood ADHD

cases, 36% of persistent ADHD cases and 41% of late-diagnosed cases, and the male/female ratio

was significantly different among all three groups (Supplementary Table 1).

Also, comorbidity patterns were different in the three groups. Autism spectrum disorder was very

frequent in childhood (23% comorbid) and persistent (18% comorbid) ADHD compared to late-

diagnosed ADHD (6.2% comorbid) (Supplementary Table 2). The adolescence/adulthood onset

disorders schizophrenia, bipolar disorder and major depressive disorder were more frequent among

individuals with persistent and late-diagnosed ADHD. As much as 27% of individuals with late-

diagnosed ADHD had comorbid major depressive disorder (Supplementary Table 2).

Genome-wide association analyses of ADHD subgroups

We conducted a GWAS for each of the three ADHD subgroups against the same control group. The

analyses were restricted to a genetically homogenous sample of unrelated individuals with European

ancestry and high-quality genetic variants, and corrected for relevant covariates (sex and ancestry

covariates).

Four genome-wide significant loci were identified in the GWAS of childhood ADHD located on

chromosome 1, 5, 18 and 20 (Table 1, Supplementary Figure 1.A. Supplementary Figure 2. A-D).

These consisted of two new ADHD risk loci (on chromosomes 18 and 20) and two known risk loci

(on chromosomes 1 and 5), identified in our previous GWAS meta-analysis of ADHD<sup>4</sup>, which

included an earlier and smaller iPSYCH sample than analyzed here. One genome-wide significant

locus was identified for late-diagnosed ADHD on chromosome 7, located in FOXP2 (Table 1,

Supplementary Figure 1.B. Supplementary Figure 2.E). No genome-wide significant loci were found

for persistent ADHD, which was expected due the low number of cases.

SNP-heritability and genetic correlations between ADHD subgroups

We estimated the SNP heritability (h<sup>2</sup><sub>SNP</sub>) using best guess genotypes and GCTA<sup>21</sup> and found the

highest  $h^2_{SNP}$  in the persistent group ( $h^2_{SNP}=0.29$ ), followed by late-diagnosed ADHD ( $h^2_{SNP}=0.27$ )

and childhood ADHD (h<sup>2</sup><sub>SNP</sub>=0.24) (Supplementary Table 3). None of the estimates were

significantly different (Supplementary Table 3).

Pair-wise genetic correlations between ADHD subgroups were estimated using bivariate GREML

implemented in GCTA and non-overlapping controls (see methods). A high genetic correlation was

found between childhood and persistent ADHD (r<sub>g</sub>=0.82, SE=0.08), as well as between persistent and

late-diagnosed ADHD (r<sub>g</sub>=0.77, SE=0.08), while the genetic correlation between childhood ADHD

and late-diagnosed ADHD was moderate (r<sub>g</sub>=0.64, SE=0.03), but not significantly lower than the

other two correlations (Supplementary Table 4).

ADHD polygenic risk load in childhood, persistent and late-diagnosed ADHD

The polygenic risk load of common variants associated with ADHD risk in the three ADHD

subgroups was evaluated by polygenic score (PGS) analyses. ADHD-PGS was generated using a 5-

fold cross-validation approach (see online methods) and regressed on the three ADHD subgroups and

controls while including relevant covariates in a multiple regression. All groups demonstrated a

highly significant increased ADHD-PGS load compared to controls (Supplementary Table 5). The

highest mean ADHD-PGS was found for persistent ADHD (mean=0.41, SE=0.95), followed by late-

diagnosed ADHD (mean=0.27; SE=0.98) and then childhood ADHD (mean=0.26, SE=0.96)

(Supplementary Table 5). ADHD-PGS load in persistent ADHD was significantly higher childhood

ADHD (P=3.0x10<sup>-4</sup>) and nominally significantly higher than late-diagnosed ADHD (P=0.02).

In order to replicate the findings, we performed PGS analysis in a Spanish sample consisting of 453

individuals with childhood ADHD, 270 with persistent ADHD, and 889 with late-diagnosed ADHD

and 3,440 controls. We did not replicate the findings observed in the iPSYCH data, however the

differences were non-significant with trends in the opposite direction when comparing to controls

(ADHD-PGS childhood ADHD: beta=0.27, SE=0.05; persistent ADHD: beta=0.21, SE=0.06; late-

diagnosed ADHD: beta=0.19, SE=0.04).

Genetic overlap with ADHD symptoms in the general population

Genetic overlap with ADHD symptoms in the general population was estimated, using results from

GWASs of ADHD subgroups and results from GWAS meta-analyses of measures of inattention and

hyperactivity (N=43,117) in the general population (Zayates et al. unpublished data). Inattention and

hyperactivity were highly correlated with both childhood ADHD (rg\_inattanetion=0.86, SE=0.08;

rg\_hyperactivity=0.95, SE=0.08) and persistent ADHD (rg\_inattention=0.87, SE=0.14; rg\_hyperactivity=~1,

SE=0.15) (Supplementary Table 6), but showed a considerably lower correlation with late-diagnosed

ADHD (rg\_inattention = 0.57, SE = 0.08; rg\_hyperactivity=0.59, SE=0.07). The genetic correlations of ADHD

symptoms with childhood and persistent ADHD were not different from one, while the genetic

correlations with late-diagnosed ADHD were significantly lower than one (P<sub>diff 1 inattention</sub>=7.66x10<sup>-8</sup>;

P<sub>diff\_1\_hyperactivity</sub>=4.71x10<sup>-9</sup>; Supplementary Table 6).

We also carried out PGS analyses to test for enrichment in the three ADHD subgroups of variants

associated with inattention and hyperactivity. We identified a nominally significantly lower PGS for

hyperactivity in late-diagnosed ADHD compared to childhood ADHD (P=0.04; Supplementary Table

8

7).

## Genetic overlap with psychiatric disorders and other phenotypes

The observed differences in comorbidity patterns with other psychiatric disorders could reflect age differences among the groups, but they could also be influenced by differences in the genetic architecture. In order to evaluate whether genetics influence the different comorbidity patterns, we performed genetic correlation and PGS analyses for major psychiatric disorders (schizophrenia<sup>22</sup>, bipolar disorder<sup>23</sup>, major depressive disorder<sup>24</sup>, autism spectrum disorder<sup>25</sup>, anorexia<sup>26</sup>, obsessive compulsive disorder<sup>27</sup>, cannabis use disorder<sup>28</sup> and alcohol use disorder<sup>29</sup>). We found positive genetic correlations of ADHD subgroups with autism, schizophrenia, bipolar disorder, major depressive disorder, alcohol use disorder and cannabis use disorder and negative genetic correlations with obsessive compulsive disorder and anorexia (Figure 1, supplementary Table 8), in line with previous findings (e.g<sup>4</sup>). We identified a significantly higher genetic correlation of childhood ADHD with autism (r<sub>g</sub>=0.48, SE=0.05) compared to late-diagnosed ADHD (r<sub>g</sub>=0.27, SE=0.06) (Jack knife comparison P-value = 4.9x10<sup>-4</sup>), and a significantly (P=8.7x10<sup>-7</sup>) higher genetic correlation of depression and alcohol use disorder with late-diagnosed ADHD (rg\_depression=0.69, SE=0.04; rg alcohol use disorder=0.45, SE=0.04) compared to childhood ADHD (Pdiff depression= $8.7 \times 10^{-7}$ ; P<sub>diff\_alcohol\_use disorder</sub>=3.8x10<sup>-5</sup>) (Figure 1, Supplementary 9 Table 8). The PGS results demonstrated the same pattern, with a significantly increased autism-PGS in childhood ADHD compared to latediagnosed ADHD (P=7.87x10<sup>-7</sup>), higher PGS in persistent and late-diagnosed ADHD compared to  $childhood\ ADHD\ for\ depression\ (P_{childhood\_vs\_persistent} < 0.1x10^{\text{-}15};\ P_{childhood\_vs\_late\text{-}diagnosed} = 1.95x10^{\text{-}9})$ and cannabis use disorder (P<sub>childhood\_vs\_persistent</sub>=9.02x10<sup>-5</sup>; P<sub>childhood\_vs\_late-diagnosed</sub>=1.42x10<sup>-5</sup>) and significantly increased PGS in late-diagnosed ADHD compared to childhood ADHD for schizophrenia (P=2.22x10<sup>-4</sup>) and bipolar disorder (P=9.34x10<sup>-7</sup>) (Figure 1, Supplementary Table 9). Additionally, we performed genetic correlation and PGS analyses for phenotypes representing domains which previously<sup>4</sup> demonstrated high genetic correlations with ADHD: cognition

(educational years<sup>30</sup>), overweight (BMI<sup>31</sup>), reproduction (age at first birth<sup>32</sup>), mortality (maternal age

of death<sup>33</sup>) and sleep (insomnia<sup>34</sup>). We identified stronger negative genetic correlations of late-

diagnosed ADHD compared to childhood ADHD for educational years (Pdifference=1.7x10-5; rg\_late-

diagnosed=-0.61, SE=0.03; rg\_childhood=-0.46, SE=0.03), increased age at first birth (Pdifference=8.9x10<sup>-5</sup>;

rg\_late-diagnosed=-0.73, SE=0.04; rg\_childhood=-0.54, SE=0.04) and increased age at mother's death

 $(P_{difference}=2.6x10^{-4} r_{g\_late-diagnosed}=-0.79, SE=0.10; r_{g\_childhood}=-0.48, SE=0.08)$  (Figure 1,

Supplementary Table 8). Furthermore, we identified a significantly less negative PGS in childhood

ADHD compared to persistent and late-diagnosed ADHD for number of educational years

(Pchildhood\_vs\_persistent=8.02x10<sup>-8</sup>; Pchildhood\_vs\_late-diagnosed=4.35x10<sup>-14</sup>) and a less negative PGS for age at

first birth for childhood ADHD compared to late-diagnosed ADHD (Figure 2, Supplementary Table

9).

Except for autism and OCD, the highest PGS was observed for persistent ADHD (Supplementary

Table 10); however, due to the smaller sample size of this group compared to the other two groups,

we had limited power to detect differences in PGS load for this group compared to the other two

groups.

Burden of rare deleterious variants in childhood, persistent and late-diagnosed ADHD

We have recently demonstrated an enrichment of rare deleterious variants in highly constrained genes

(genes intolerant to loss of function mutations) in ADHD cases compared to controls<sup>35</sup>. We wanted

to explore this further by evaluating the load of rare protein truncating variants (rPTVs) in the three

ADHD subgroups. For this we used whole-exome sequencing data available for a subset of the

iPSYCH cohort (childhood ADHD, N=4,987; persistent ADHD, N=748; late-diagnosed ADHD,

N=1,915; controls, N=8,649). The burden of rPTVs and rare synonymous variants (rSYN) in the three

ADHD subgroups was tested in three gene sets: (1) "highly constrained genes", genes being

evolutionary intolerant to loss of function mutations with pLI > 0.9<sup>36</sup> (3,488 genes), (2) "*de novo* constrained genes", the subset of highly constrained genes that overlap another gene-set of 285 genes found to be enriched with de novo mutations in individuals with neurodevelopmental disorders<sup>37</sup> (241 overlapping genes) and (3) "low constrained genes", genes being tolerant to loss of function mutations with a pLI < 0.1 (9,662 genes). The load of rPTVs was comparable for childhood and persistent ADHD in both highly constrained genes (childhood ADHD beta=0.13, SE=0.02; persistent ADHD beta=0.12, SE=0.04) and *de novo* highly constrained genes (childhood ADHD beta=0.1, SE=0.02; persistent ADHD beta=0.09, SE=0.04), but lower in late-diagnosed ADHD (highly constrained: beta=0.06, SE=0.03; *de novo* highly constrained: beta=0.03, SE=0.03) (Supplementary Table 11, Figure 3). We only identified significant enrichment in rPTVs in childhood and persistent ADHD in highly constrained genes (P<sub>childhood\_ADHD</sub>=2.41xa10<sup>-11</sup>, P<sub>persistent\_ADHD</sub>=1.90x10<sup>-3</sup>). No pairwise comparisons of rPTV load were significant, but a tendency towards a higher burden of rPTVs in childhood compared to late-diagnosed ADHD was observed (P=0.096). For comparison we did not find any enrichment of rSYNs in either highly constrained or *de novo* constrained genes or an enrichment in of rPTVs in low constrained genes (Figure 3, Supplementary Tables 11).

**DISCUSSION** 

In this study we identified differences in the genetic architecture of childhood, persistent and late-diagnosed ADHD based on unique data from a large population-based large Danish cohort. We identified four genome-wide significant loci associated with childhood ADHD, two of them novel ADHD risk loci located on chromosome 18 and 20. The chromosome 18 index variant is located *DCC*, a gene recently linked to the general liability to psychiatric disorders in a large cross-disorder study by the Psychiatric Genomics Consortium<sup>38</sup>, and thus does not seem specific to ADHD. The chromosome 20 locus is intergenic, and the index variant has previously shown genome-wide

significant association with weight-related phenotypes<sup>33</sup>. These are the first loci associated with

childhood ADHD, as our previous meta-analysis of childhood ADHD<sup>18</sup> did not reveal significant

loci. Additionally, we identified a genome-wide significant locus associated with late-diagnosed

ADHD in FOXP2. When this locus was first reported as a risk locus for ADHD<sup>4</sup>, it received a lot of

attention due to the role of FOXP2 in cognition, language and speech development<sup>39-41</sup>, and recently

we also found *FOXP2* to be a risk gene for cannabis use disorder<sup>28</sup>. The results reported here suggest

that the association of FOXP2 with ADHD is driven to a larger extent by late-diagnosed ADHD

(OR=1.11) than childhood ADHD (OR=1.05).

When assessing the polygenic architecture, we identified the highest SNP heritability for persistent

ADHD (Supplementary Table 3). In concordance with this we also observed the highest polygenic

risk load for ADHD and ADHD symptoms (inattention and hyperactivity) in individuals with

persistent ADHD, which was significantly higher than observed for childhood ADHD

(Supplementary Table 5 and 6). This observation is consistent with the hypothesis that individuals

with a higher genetic risk load for ADHD also are those that will continue to have ADHD symptoms

as adults. This is also supported by a previous study reporting that ADHD-PGS is associated with

persistence of ADHD symptoms across childhood and adolescence in the general population 16, and a

recent study reporting higher ADHD-PGS in persistent ADHD compared to late-diagnosed ADHD

(however not significantly different)<sup>17</sup>. We were not able to replicate our findings in a Spanish cohort.

Lack of replication could be due to replication cohort size or differences in the way cases have been

selected. The iPSYCH cohort is population-based and thus reflects the genetic architecture across

cases with ADHD in the entire Danish population, whereas the Spanish cohort is a smaller clinical

dataset that might be influenced by unknown ascertainment biases.

The genetic correlation of childhood ADHD with persistent ADHD was high (r<sub>g</sub>=0.82) and at the

same level as reported previously (r<sub>g</sub>=0.81)<sup>18</sup>, while the genetic correlation of childhood ADHD with

late-diagnosed ADHD was considerably lower (r<sub>g</sub>=0.65). This suggests some differences in the

polygenic architecture of childhood and late-diagnosed ADHD. A part of this could be due to a lower

load of variants associated with hyperactivity and inattention in individuals with late-diagnosed

ADHD, since we observed a higher genetic correlation of ADHD symptoms with childhood and

persistent ADHD compared to late-diagnosed ADHD. However, only significant for inattention. The

same pattern was observed in the PGS analyses where we found a higher PGS for inattention in

childhood and persistent ADHD than in late-diagnosed ADHD, however pair-wise comparisons only

revealed nominally significant higher PGS for hyperactivity in childhood ADHD compared to late-

diagnosed ADHD. Our results therefore suggest that a part of the explanation for a later diagnosis of

ADHD could be genetic, so late-diagnosed individuals genetically are less predisposed to be

inattentive and hyperactive and thus their ADHD could be unnoticed until later in life.

The comorbidity pattern in the three groups differed, with a higher comorbidity of autism spectrum

disorder among childhood (23%) and persistent ADHD (18%) compared to late-diagnosed ADHD

(6.2%), in line with previous reports concerning comorbid autism among children with ADHD<sup>42</sup>. We

found a significant genetic overlap between ADHD and autism as previously reported<sup>25,43</sup>, and the

observed comorbidity patterns were reflected in the genetic analyses where we found a significantly

higher genetic correlation of autism with childhood ADHD compared to the genetic correlation with

late-diagnosed ADHD, as well as higher PGS-autism in childhood ADHD compared to late-

diagnosed ADHD. Therefore, childhood ADHD seems genetically more related to autism than late-

diagnosed ADHD is related to autism.

The comorbidities of psychiatric disorders with onset in adolescence/adulthood were higher among

persistent and late-diagnosed ADHD (Supplementary Table 2). Part of this result is likely due to the

age difference, since many individuals in the childhood group are too young to develop these

disorders. However, our results suggest that age alone cannot explain the different comorbidity

patterns. Genetics might play a role, as we in general observe a higher genetic correlation or PGS for

several of the disorders (schizophrenia, bipolar disorder, alcohol use disorder, cannabis use disorder

and depression) in persistent and late-diagnosed ADHD compared to childhood ADHD (Figure 1 and

2, Supplementary Table 8 and 9). Depression was particularly striking, where analyses revealed large

differences with a significantly higher PGS in individuals with persistent and late-diagnosed ADHD

compared to childhood ADHD. The high comorbidity of depression among adults with ADHD is

well known, but the causes are not. It has been suggested that ADHD in itself could be a risk

factor<sup>44,45</sup>, but genetics is also considered a risk factor due to the previously reported high genetic

correlation of ADHD and depression<sup>4</sup>. Our results suggest genetic heterogeneity among ADHD cases

where individuals with persistent and late-diagnosed ADHD are at higher risk for getting comorbid

depression due to the underlying genetic architecture of the disorder in these groups.

In analyses of five selected phenotypes representing domains highly genetically correlated with

ADHD<sup>4</sup> we observed the highest genetic correlations and highest PGS load in persistent ADHD,

followed closely by late-diagnosed ADHD and lowest in childhood ADHD (except for BMI),

suggesting a similar polygenic architecture of persistent and late-diagnosed ADHD for these

phenotypes (Figure 1 and 2). These results also support the idea that the negative outcomes associated

with persistent ADHD such as decreased school performance<sup>46</sup> and sleep problems<sup>47</sup>, are influenced

by genetics to a greater extent than in childhood ADHD.

We found a significantly increased burden of rPTVs in persistent and childhood ADHD compared to

controls in highly constrained genes, but no increased burden in late-diagnosed ADHD. Additionally,

there was a tendency towards a significantly higher burden of rPTVs in de novo highly constrained

genes in childhood ADHD compared to late-diagnosed ADHD. These findings suggest that when

considering rPTVs, which are variants expected to have higher impact on the disorder than common

variants, the genome of individuals with late-diagnosed ADHD is less burdened. When considering

both common and rare variants, the emerging picture suggests that childhood ADHD is genetically

more similar to autism (high genetic correlation with autism and increased rPTV burden), whereas

late-diagnosed ADHD genetically is more similar to depression (high genetic correlation with

depression and no significant increase in rPTVs in highly constrained genes compared to controls;

Supplementary Table 11).

In summary, our results are population-based and thus reflect the genetic architecture of ADHD and

comorbidity patterns across ADHD subgroups in the Danish population. Persistent ADHD

demonstrated the highest load of ADHD risk variants, while late-diagnosed ADHD was less enriched

for variants associated with hyperactivity and inattention and did not, unlike childhood and late-

diagnosed ADHD, demonstrate an increased burden of rPTVs compared to controls. This suggests

that genetics in part might explain why some individuals are diagnosed late as adults. The comorbidity

pattern for other psychiatric disorders differed among the groups, and our results suggest that the

higher comorbidity of adult onset psychiatric disorders among individuals with persistent and late-

diagnosed ADHD is not only due to those individuals being older, but also due to a higher genetic

risk. Conversely, childhood ADHD demonstrated a higher genetic overlap with autism and higher

burden of rPTVs in highly constrained genes than the other two groups. Overall, our study finds

genetic heterogeneity among ADHD subgroups and suggests that genetic factors influence time of

first ADHD diagnosis, persistence of ADHD into adulthood and comorbidity patterns.

Methods

Sample characteristics

Individuals included in the study were identified in a large nationwide population-based case-cohort

established by iPSYCH<sup>19</sup> in total comprising 133,296 genotyped individuals, among which 91,378

are cases diagnosed with at least one of six mental disorders (i.e. schizophrenia, bipolar disorder,

major depressive disorder, autism spectrum disorder, ADHD, anorexia) and the remaining

population-based controls. Samples were selected from a baseline birth cohort comprising all

singletons born in Denmark between May 1, 1981, and December 31, 2008, who were residents in

Denmark on their first birthday and who have a known mother (N = 1,472,762). ADHD cases were

diagnosed by psychiatrists at in- or out-patient clinics according to the ICD10 criteria (F90.0

diagnosis code) identified using the Danish Psychiatric Central Research Register<sup>20</sup>. Diagnoses were

given in 2016 or earlier for individuals at least 1 year old. Cases were divided into three groups

depending on age at first diagnosis: (1) childhood ADHD, defined as cases diagnosed with ADHD

and were less than 18 years of age in 2016 (N=15,338 before QC), (2) Persistent ADHD defined as

cases having received an ADHD diagnosis as child (less than 18 years of age) and again as adults

(after 18 years of age) (N=1,709 before QC) and (3) late diagnosed ADHD, defined as individuals

having received an ADHD diagnosis as adults (after 18 years of age) (N=7,815 before QC). Controls

were randomly selected from the same nationwide birth cohort and not diagnosed with ADHD

(N=45,398 before QC). The study was approved by the Danish Data Protection Agency and the

Scientific Ethics Committee in Denmark.

Testing for difference in the female/male ratio between ADHD subgroups was done using a chi-

square test. Information about comorbidity for other major psychiatric disorders was obtained from

the Danish Psychiatric Central Research Register<sup>20</sup>: autism spectrum disorder (ICD10 diagnosis code

F84), schizophrenia (ICD10 diagnosis code F20), bipolar disorder (ICD10 diagnosis codes F30-F31),

major depressive disorder (ICD10 diagnosis codes F32-F33), obsessive compulsive disorder (ICD10

diagnosis code F42), anorexia (ICD10 diagnosis codes F50), alcohol use disorder (ICD10 diagnosis

code F10.1-F10.9), cannabis use disorder (ICD10 diagnosis code F12.1-F12.9).

Genotyping and QC

The study subjects identified in the registers were linked to their biological sample (dried blood spots)

stored in the Danish Newborn Screening Biobank<sup>48</sup>, by the use of the personal identification number<sup>49</sup>

assigned to all individuals with residence in Denmark. DNA was extracted from the dried blood spots

and whole genome amplified in triplicates as described previously<sup>50,51</sup>. Genotyping of the iPSYCH

samples were done in two rounds. In round one (iPSYCH1), 79,492 individuals were genotyped using

Illumina's Beadarrays (PsychChip; Illumina, CA, San Diego, USA) according to the manufacturer's

protocols. In round two (iPSYCYH2) 53,804 individuals were genotyped using Illuminas Global

Screening array. iPSYCH genotypes were a result of merging call sets from two different calling

algorithms, GenCall<sup>52</sup> and Birdseed<sup>53</sup> which were used to call genotypes with minor allele frequency

(MAF) > 0.01. iPSYCH2 genotypes were called using GenTrain V3.

Following genotyping, all data processing, quality control, and downstream analyses were performed

at our secure server at Aarhus University (GenomeDK (http://genome.au.dk)).

Stringent quality control was applied to the data to the full iPSYCH sample. Only individuals with

high call rate (> 0.95) were included, and only genotypes with high call rate (>0.98), no strong

deviation from Hardy-Weinberg equilibrium ( $P > 1 \times 10^{-6}$  in controls or  $P > 1 \times 10^{-10}$  in cases) and low

heterozygosity rates (| Fhet | <0.2) were included. Genotypes were phased and imputed using the

Haplotype Reference Consortium<sup>54</sup> data as the imputation reference panel, while pre-phasing was

done using Eagle v2.3.5<sup>55</sup> and imputation using Minimac3<sup>56</sup>.

Relatedness and population stratification were evaluated for ADHD cases and controls using merged

data from iPSYCH1 and iPSYCH2 and a set of high quality markers (best guess genotypes with MAF

>0.05, HWE P>1x10<sup>-9</sup>, SNP call rate >0.99, imputation info score (INFO) >0.9), which were pruned

for linkage disequilibrium (LD) ( $r^2 < 0.1$ ) resulting in a set of 37,986 pruned variants (markers located

in long-range LD regions defined by Price et al.<sup>57</sup> were excluded). Genetic relatedness was estimated

using PLINK v1.9<sup>58,59</sup> to identify first and second-degree relatives ( $\hat{\pi}$  >0.2), and one individual was

excluded from each related pair (cases preferred kept over controls). Genetic outliers were identified

for exclusion based on principal component analyses (PCA) using EIGENSOFT<sup>60,61</sup>. After the first

PCA, the PCs from a set of individuals born in Denmark for three generations were used as a reference

for generating an ellipsoid based on information from the first 6 PCs and their standard deviations (8

SDs were used). Those who fell outside this ellipsoid were removed. Then the PCA was then repeated

and the new PCs were used as covariates to correct for any remaining population substructure in the

subsequent analyses. After quality control, the number of included individuals is: (1) childhood

ADHD; N=14,878 (2) persistent ADHD; N=1,473 (3) late diagnosed ADHD; N=7,188. After QC the

control group contained 38,3030 individuals.

**GWAS** 

We performed GWASs for each ADHD subgroup (childhood N=14,878 cases, persistent N=1,473

cases, late-diagnosed N=7,188 cases) against a common set of controls (N=38,3030). We used

merged iPSYCH1 and iPSYCH2 high quality best guess genotypes (MAF>0.01, INFO>0.80;

N=5,826,893 variants) and logistic regression and corrected for population structure using 10 PCs

from PCA and a covariate for genotyping round (iPSYCH1 or iPSYCH2). The analyses were

performed using PLINK1.9<sup>58</sup>.

SNP-heritability and genetic correlation between ADHD subgroups

SNP-heritability for each ADHD subgroup was estimated using a genotype relatedness matrix only

including high quality variants present in both iPSYCH1 and iPSYCH2 (N=5,826,893 variants). The

SNP heritability was estimated for each group against the same controls (N=38,3030) using univariate

GREML implemented in GCTA<sup>21</sup> and a population prevalence of childhood ADHD of 0.05, of

persistent ADHD and of 0.03 and late-diagnosed ADHD of 0.03. In order to test for difference in

SNP-heritability estimates among groups, we also derived estimated using non-shared controls

(control numbers: childhood controls: 24,443, persistent controls 2,289, late-diagnosed controls

11,571). Testing for difference in SNP-heritability was done using a z-test.

Genetic correlations between ADHD subgroups were calculated using bivariate GREML analysis in

GCTA and non-shared controls.

PGS analyses of ADHD and other phenotypes

The polygenic scores for ADHD were generated using a 5-fold cross-validation approach, similar to

what we did previously<sup>4</sup>. In short, the sample was split into five groups, aiming for approximately

equal numbers of ADHD cases within each group. We then conducted five leave-one-out analyses,

with each leave-one-out analysis using four out of five groups as training datasets for estimation of

effect sizes with respect to ADHD risk. These effect sizes were then used to estimate PGS for the

remaining target group. Indels and variants in the extended MHC region (chromosome 6: 25-34 Mb)

were also removed. Only independent variants were used to generate the score, and clumping of the

training data was done on the summary statistics employing PLINK and the flags -clump-p1 1, -

clump-p2 1, -clump-r2 0.1 and -clump-kb 500. PGS were estimated for each individual in the target

sample using a range of P-value thresholds in the training data (5x10<sup>-8</sup>, 1x10<sup>-6</sup>, 1x10<sup>-4</sup>, 1x10<sup>-3</sup>, 0.01,

0.05, 0.1, 0.2, 0.5, 1.0), multiplying the natural log of the odds ratio of each variant by the allele-

count of each variant. Whole genome PGS were obtained by summing values over variants for each

individual. For each of the five groups of target samples PGS were standardized (subtracting the mean

and dividing by the standard deviation).

PGS for ADHD symptoms and 13 other phenotypes (schizophrenia, autism, bipolar disorder, alcohol

use disorder, cannabis use disorder, obsessive compulsive disorder, anorexia, depression, educational

years, mother's age at death, body mass index, age at first birth and insomnia) were generated using

summary statistics from large GWASs of the phenotypes (see Supplementary Table 9 for references)

and the approach described above (without 5-fold cross validation). The data on ADHD symptoms

(inattention and hyperactivity/impulsivity) come from a genome-wide association meta-analysis on

up to 43,117 children and adolescents (Zayats et al. unpublished data). In the PGS analyses P-value

thresholds in the training GWASs that captured most variance (estimated by Nagelkerke's  $R^2$ ) in the

target data when pooling all ADHD cases together were used as threshold for analyses of PGS load

in the subgroups (threshold information in Supplementary Table 9).

We tested for difference in PGS load among ADHD subgroups using multi-nominal regression with

ADHD coded as four factors: controls, childhood, adulthood, and persistent and we included

covariates to correct for genotyping round and 10 ancestry principal components. Correction for

multiple testing was done separately for the following three analyses: (1) PGS-ADHD load among

subgroups correcting for three pair-wise comparisons, (2) PGS load for ADHD symptoms (inattention

and hyperactivity) correcting for six pair-wise comparisons and (3) PGS load for 13 other phenotypes

correcting for 39 pair-wise comparisons.

PGS analysis in the Spanish cohort consisting of 453 individuals with childhood ADHD, 270 with

persistent ADHD, 889 with late-diagnosed ADHD and 3,440 controls was done using the same

approach as above. A detailed description of ADHD diagnosis procedures for these samples can be

found in Rovira et al. 18. Exclusion criteria for patients were: IQ<70, having pervasive developmental

disorders, schizophrenia or other psychotic disorders, adoption, sexual or physical abuse, birth

weight<1.5 kg and any significant neurological or systemic disease that might explain ADHD

symptoms. Comorbid oppositional defiant disorder, conduct disorder, depression and anxiety

disorders were allowed unless determined to be the primary cause of ADHD symptomatology.

Genetic correlations with ADHD symptoms and other phenotypes

Genetic correlations of the three ADHD subgroups with ADHD symptoms and the 13 phenotypes

listed above were calculated using summary statistics from GWASs and LD score regression<sup>62</sup>. The

intercept was restricted to 1, when calculating rg with ADHD symptoms as no sample overlap and

population stratification was present.

Statistical difference between two rg estimates was calculated using the block jackknife method

implemented in the LD score regression software<sup>62,63</sup>. The genome was divided in 200 blocks and

jackknife delete values were calculated by excluding one block at a time. The jackknife deleted values

were then used to calculate corresponding jackknife pseudo values. Based on the mean and variance

of the jackknife pseudovalues, Z-score and corresponding P-values were computed, testing the null

hypothesis that the difference between the genetic correlations is equal to zero. Test for difference in

the genetic correlation from one, was done using a z-test.

Correction for multiple pair-wise comparisons, was done separately for the following two

evaluations: (1) difference in rg of ADHD subgroups with ADHD symptoms correcting for six pair-

wise comparisons and (2) rg difference of ADHD subgroups with 13 other phenotypes correcting for

39 pair-wise comparisons.

Burden of rPTVs in childhood, persistent and late diagnosed ADHD

Whole exome-sequencing (WES) data were available for a subset of the iPSYCH samples. It has

previously been shown that WES of DNA from dried blood spots results in high quality data<sup>64</sup>. DNA

was extracted from dried blood spot samples of the study subjects and whole genome amplified in

triplicates<sup>50,51</sup>, the coding regions of the genome were extracted using the llumina Nextera capture kit

and sequencing was performed in multiple waves (Pilot 1, Wave 1, Wave 2 and Wave 3) using the

Illumina HiSeq platform at the Genomics Platform of the Broad Institute.

Part of the data (Pilot 1, Wave 1, Wave 2) were also included in the recent study by Satterstrom et al.<sup>35</sup>, which looked at the overall burden of rPTVs in ADHD, and the same quality control procedure was used in this study, including all data (Pilot 1, Wave 1, Wave 2 and Wave 3). In short, the raw sequencing data were aligned to the reference genome Hg19 using the BWA<sup>65</sup>. Calling of genotypes was done using the best practice recommended by the Genome Analysis Toolkit<sup>66</sup> (GATK) v.3.4. Most QC steps were performed using Hail 0.1 (Hail Team. Hail 0.2. https://github.com/hail-is/hail). All variants annotated to ACMG<sup>67</sup> genes were removed due to Danish legislation. Samples were removed if they lacked complete phenotype information, sex inconsistencies of the imputed sex with the reported sex, if they were duplicates or genetic outliers identified by principal component analysis, if they had an estimated level of contamination >5% or if or if they had an estimated level of chimeric reads >5%. The number of individuals after QC were: childhood ADHD, N=4,987; persistent ADHD, N=748; late-diagnosed ADHD, N=1,915; controls, N=8,649. Only autosomal genotypes were included in our analyses. Genotypes were removed if they did not pass GATK variant quality score recalibration (VQSR) or had read depth <10 or >1,000. Homozygous alleles were removed following if they had reference calls with genotype quality <25, homozygous alternate alleles with PL(HomRef) (i.e. the phred-scaled likelihood of being homozygous reference) less than 25 or <90% reads supporting alternate allele. Heterozygote alleles were removed if they had PL(HomRef) <25 or <25% reads supporting the alternate allele, less than <90% informative reads (i.e. number of reads supporting the reference allele plus number of reads supporting the alternate allele less than 90% of the read depth), or a probability of the allele balance calculated from a binomial distribution centered on 0.5 less than 1x10<sup>-9</sup>. After the application of these basic genotype filters, variants with a call rate <90% were removed, then samples with a call rate <95% were removed and then removal of variants with a call rate <95%. Between the sample call rate filter and the final variant call rate filter, one of each pair of related samples was removed,

defining relatedness as individuals with a pair-wise pi-hat value ≥0.2. After QC, the number of

individuals were: childhood ADHD, N=4,987; Persistent ADHD, N=748; Late-diagnosed ADHD,

N=1,915; controls, N=8,649.

Following QC variants were annotated using SnpEff <sup>68</sup> version 4.3t with the command line 'SnpEff

GRCh37.75 input.vcf.gz'. The variants were also annotated with gnomAD<sup>69</sup> exomes r2.1.1 database

using SnpSift<sup>68</sup> version 4.3t. Variants were only included if they were located in consensus high-

confident coding regions with high read depth in both iPSYCH data and gnomAD dataset (80% of

the samples in both datasets had at least 10× sequencing coverage in the region). Variants were

defined as rPTVs if they were annotated as having large effects on gene function (nonsense variant,

frameshift, splice site) and being rare in the sample defined as having an allele count no greater than

5 across the combination of our iPSYCH (n=16,299) and non-Finnish Europeans in the

nonpsychiatric gnomAD exome database (n=44,779).

The burden of rPTVs and rSYNs in the three ADHD subgroups and controls were tested in two gene

sets (1) Highly constrained genes (N=3,488), defined as genes being highly intolerant to loss of

function mutations having a pLI score > 0.9<sup>36</sup> (2) de novo highly constrained genes (N=241), defined

as highly constrained genes which overlap with another set of genes (N=285) previously found to be

enriched with *de novo* mutations in individuals with neurodevelopmental disorders<sup>37</sup>. For comparison

we also tested a set of 9,662 evolutionary low constrained genes, i.e. having a pLI score < 0.1. Testing

for enrichment in rPTVs and rare synonymous variants in the three groups compared to controls was

done using multiple logistic regression with all groups included in the same regression model. We

corrected the analyses using covariates: birth year, sex, first ten principal components from ancestry

principal component analysis, number rSYN, percentage of target with coverage > 20x, mean read

depth at sites within the exome target passing VQSR, total number of variants, sequencing wave.

Testing for enrichment of rPTVs in ADHD subgroups compared to controls was corrected for nine

tests (three groups x three gene sets, i.e. new P-value threshold=0.02), and tests for difference between groups were corrected for nine pair-wises comparisons (three gene-sets x three pair-wise comparisons for each set).






Figure 1. Genetic correlation estimated using LD score regression of childhood, persistent and latediagnosed ADHD with major psychiatric disorders and phenotypes representing domains with high genetic correlation with ADHD. Horizontal bares represent standard errors. \*indicates significant difference in the genetic correlation observed for childhood ADHD when compared to late-diagnosed ADHD (P<0.0013).
