

1 **Persistence of child marriage in rural Bangladesh and impact on maternal and perinatal**
2 **health: findings from a health and demographic surveillance system**

12 **ABSTRACT**

13 **Objectives**

14 To describe temporal trends in child marriage between 1990 and 2019 in a rural sub-district of
15 Bangladesh and characterize relationships between age, time to pregnancy, complications during
16 delivery, and perinatal mortality.

18 **Design**

19 Health and demographic surveillance system.

20

21 **Setting**

22 Baliakandi sub-district, Bangladesh.

23

24 **Participants**

25 56,155 female residents.

27 **Main outcome measures**

28 Annual proportion of marriages to female residents under 18 years of age, time between first
29 marriage and pregnancy, proportion of births with complications during delivery, and odds of
30 perinatal mortality.

32 **Results**

33 Between 1990 and 2010, the proportion of marriages to female residents under 18 years of age
34 decreased from 71% to 57%. Most notably, marriages to females aged 10 to 12 years dropped

35 from 22% of all marriages to 3%. In 2019, 53% of all marriages were to females under 18 years.
36 The estimated time between first marriage and pregnancy did not differ by female age at
37 marriage. By 365 days after marriage, the cumulative incidence of pregnancy was approximately
38 50% for each age group. Adolescent girls were more likely to experience complications during
39 delivery with at least one complication reported for 36% of mothers aged 13 to 15 years, 32% of
40 mothers aged 16 to 17 years, and 23% of mothers aged 18 to 34 years (χ^2 test, $P < 0.001$).
41 Compared to adults, births among females aged 13 to 15 years were more likely to result in
42 stillbirths (odds ratio 2.23, 95% confidence interval 1.19 to 4.16) and births among females 16-
43 17 years were more likely to result in early neonatal deaths (odds ratio 1.57, 95% confidence
44 interval 1.01 to 2.42).

46 **Conclusions**

47 Child marriage persists in Baliakandi. Over half of all marriages were to child brides and only
48 minor reductions were seen over the past decade. Pregnancies were common among adolescent
49 girls with no evidence of delayed pregnancy after marriage. Compared to adults, adolescents
50 were more likely to experience complications during delivery and perinatal death. Preventing
51 child marriage has substantial social and health benefits for girls and, by doing so, will also
52 contribute to Bangladesh's commitment to reduce child mortality.

54 **INTRODUCTION**

55 In 2019 alone, approximately 5.2 million children under-five died worldwide[1]. While
56 remarkable reductions in mortality have been observed over the past two decades among older
57 children, progress has been slow in reducing neonatal deaths, which now account for nearly half

58 of all under-five mortality [1]. Even less progress has been made in preventing stillbirths.
59 Globally, an estimated 2 million babies are stillborn at 28 weeks or more of gestation each year
60 [2]. Current trends in under-five mortality and stillbirths suggest we will not achieve our global
61 targets set for 2030, which includes the Sustainable Development Goal (SDG) target of 25
62 under-five deaths per 1,000 live births [1] and the Every Newborn Action Plan target of 12
63 stillbirths per 1,000 total births [2].

64 Girls who become pregnant during adolescence are at increased risk for experiencing a
65 perinatal death [3] and for obstetric complications including pregnancy-induced hypertension,
66 obstructed labor, obstetric fistula, and postpartum hemorrhage [4–7]. These complications during
67 pregnancy and childbirth are the leading cause of death among adolescent girls [8].
68 These risks are exacerbated by the persistent practice of child marriage [9], a human rights
69 violation that profoundly impacts one of the most vulnerable populations: adolescent girls. Child
70 marriage, defined as the formal or informal union of a child under 18 years of age [10],
71 disproportionately affects girls, particularly in low- and middle-income countries [11], and
72 contributes to severe social, developmental, and reproductive harms [12]. Although extensive
73 global efforts have been made to end child marriage, progress has been stagnant in recent years.
74 In 2018, 21% of women aged 20-24 years worldwide were married before 18 years of age and, at
75 the current rate, it would take at least 50 years to end child marriage, decades past yet another
76 SDG target [11].

77 Globally, an estimated 16 million girls aged 15 to 19 become pregnant each year and
78 90% of these adolescent pregnancies occur within marriage [9]. Given societal and familial
79 pressures to bear children immediately after marriage in many communities [12], marriage often

80 means the beginning of a sexual relationship for children who are still in the process of maturing
81 both physically and cognitively [3].

82 Some of the highest rates of child marriage are found in Bangladesh. In 2018, 59% of
83 women aged 20 to 24 years were married before 18 years of age and 28% of married adolescents
84 aged 15 to 19 reported a pregnancy [13]. In 2017, the Child Health and Mortality Prevention
85 Surveillance (CHAMPS) network established a health and demographic surveillance system
86 (HDSS) in Baliakandi, a rural sub-district of Bangladesh with approximately 216,000 residents
87 [14]. We used the Baliakandi HDSS to characterize temporal trends in child marriage in this
88 rural region of Bangladesh. We examined whether pregnancy was delayed for newly married
89 adolescents and examined the relationship between maternal age, complications during delivery,
90 and perinatal mortality.

92 **METHODS**

93 **Health and demographic surveillance system**

94 We used data from an ongoing HDSS established in Baliakandi, Bangladesh. Baseline surveys
95 were conducted between March and August 2017 during which household and
96 sociodemographic data were collected from all residents. Married females under 50 years of age
97 completed a birth history questionnaire either during baseline surveys or after in-migration.

98 Four to six data rounds were conducted every year between September 2017 and
99 February 2020, during which we identified key demographic events including marriages,
100 pregnancies, pregnancy outcomes, deaths, and out-migrations. As missed demographic events
101 can be identified in subsequent data rounds, we used HDSS data as of February 2020 for events
102 that occurred between September 2017 and August 2019 for most analyses. Each year, we

103 observed consent rates at or greater than 99% among approximately 52,000 households. Given
104 regular follow up, missing data were uncommon for variables included in this analysis.
105 Individuals with missing data were excluded from relevant analysis and the total missing was
106 noted in the results. Additional details on the Baliakandi HDSS are described by Cunningham et
107 al [14].

108 We defined stillbirth as fetal demise at or after 28 weeks of estimated gestational age and
109 early neonatal death as death within the first 7 days after live birth. Stillbirths and early neonatal
110 deaths were considered perinatal deaths.

111

112 **Age at marriage among female residents**

113 We estimated the annual proportion of marriages to children among female residents married
114 between 1990 and 2019 using data from birth history questionnaires and marriage events
115 identified data rounds between September 2017 and December 2019 (Supplementary figure 1).
116 The age difference between partners was calculated among first marriages that occurred in
117 Baliakandi between September 2017 and December 2019.

118

119 **Time between first marriage and childbearing**

120 We estimated time between first marriage and pregnancy among female residents under 35 years
121 of age who remained in Baliakandi for at least 180 days after marriage (Supplementary figure 1).
122 Females who in-migrated after marriage were excluded from the analysis as marriage dates were
123 limited only to the month and year and dates were collected retrospectively, which could
124 introduce systematic bias through misreporting [15]. The last menstrual period was used as a
125 proxy of pregnancy date. We used Kaplan-Meier estimates to examine the relationship between

126 the age at first marriage and time between marriage and pregnancy. Age was categorized as 12-
127 15 years, 16-17 years, and 18-34 years. To explore potential bias introduced by out-migration,
128 we compared the age of female residents who exited Baliakandi within 180 days of first marriage
129 and those who remained for at least 180 days after first marriage. We further restricted survival
130 analysis to female residents who remained in Baliakandi for at least 365 days after marriage.

131

132 **Maternal age at birth and perinatal death**

133 We used logistic regression to estimate the association between maternal age at birth and
134 perinatal death among all singleton births that occurred between September 2017 and August
135 2019. We used multinomial logistic regression to estimate the association between maternal age
136 at birth and stillbirths and early neonatal deaths (Supplementary figure 2). Age was categorized
137 as 13-15 years, 16-17 years, and 18-34 years. We repeated the model after adjusting for parity
138 and household wealth. Household wealth was categorized as a quintile based on the
139 Demographic and Health Survey (DHS) wealth index score [16].

140

141 **Complications during delivery**

142 In December 2018, we supplemented the Baliakandi HDSS with detailed pregnancy surveillance
143 (Supplementary figure 2). All pregnant women identified during data rounds were contacted
144 within 3 days of giving birth to collect information on complications during delivery. We
145 estimated the frequency of complications during delivery by maternal age at birth for all
146 pregnancy outcomes between January and August 2019. For live births, we estimated the
147 frequency of preterm births, defined as birth before an estimated gestational age of 37 weeks.

148 Gestational age was estimated using the last menstrual period. Chi-squared test and Fisher's
149 exact test were used to test for statistical differences by maternal age.

151 **RESULTS**

152 **Age at marriages among female residents**

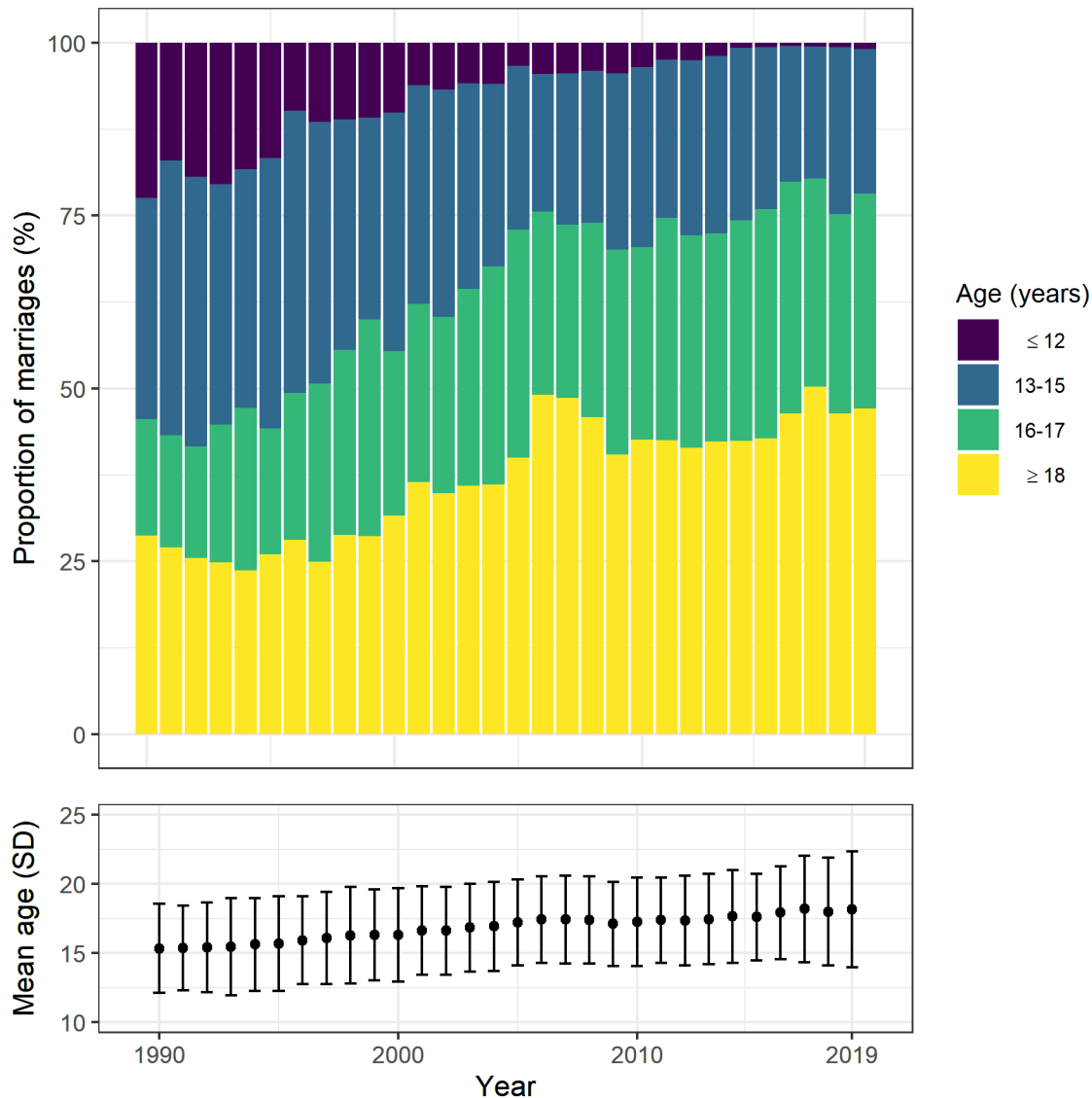
153 A total 56,155 female residents of Baliakandi were married between 1990 and 2019 and all had
154 age at marriage. Among female residents married in 1990, 71% were married before 18 years of
155 age (915/1,284). This proportion dropped to 57% among female residents married in 2010
156 (1,185/2,063). Between 1990 and 2010, the proportion of marriages to females under 13 years
157 decreased from 22% (288/1,284) to 3% (72/2,063), females aged 13 to 15 years decreased from
158 32% (411/1,284) to 26% (538/2,063) and females aged 16 to 17 years increased from 17%
159 (216/1,284) to 28% (575/2,063) (Figure 1). The mean age at marriage increased from 15.3 years
160 (standard deviation (SD) 3.2) to 17.3 years (SD 3.4).

161 Between 2010 and 2019, the overall proportion of marriages to female residents under 18
162 years dropped from 57% (1,185/2,063) to 53% (1,698/3,210). The proportion to females under
163 13 years decreased from 3% (72/2,063) to 1% (28/3,210), females aged 13 to 15 years decreased
164 from 26% (538/2,063) to 21% (671/3,210), females aged 16 to 17 years increased from 28%
165 (575/2,063) to 31% (999/3,210). The mean age at marriage increased from 17.3 years (SD 3.4) to
166 18.2 years (SD 4.2).

174 A total 3,860 first marriages were identified in Baliakandi between September 2017 and

175 August 2019. Among all first marriages, males were a median of 8 years (interquartile range

176 (IQR) 5 to 10) older than their female spouses. The median age difference was 9.5 years (IQR 8

177 to 12) for females married before 13 years of age, 9 years (IQR 6 to 12) for those married at

178 ages 13 to 15 years, 8 years (IQR 6 to 10) for those married at ages 16 to 17 years, and 6 years
179 (IQR 3 to 9) among those married at ages 18 to 34 years. We excluded one female resident with
180 missing spouse age.

181

182 **First marriages and out-migration**

183 A total 3,764 female residents under 35 years of age reported first marriages in Baliakandi
184 between September 2017 and August 2019 (Supplementary table 1). Younger brides were more
185 likely to be in the lowest household wealth quintile: 25% among ages 10 to 15 years (271/1,077),
186 20% among ages 16-17 years (227/1,150), and 15% among females ages 18 to 34 years
187 (236/1,537) (χ^2 test, $P < 0.001$). We excluded one resident with missing household wealth data.

188 Out-migration was common among newly married females with 51% (1,940/3,764)
189 exiting Baliakandi within the first 180 days of marriage (Supplementary table 1). This proportion
190 included females with less than 180 days of follow up by end of August 2019. Most out-
191 migrations occurred immediately after marriage with 45% of newly married women
192 (1,694/3,764) out-migrated within a week of marriage. Out-migrants were less likely to be child
193 brides (1,090/1,940, 56%) compared to those who stayed in Baliakandi (1137/1,824, 62%; χ^2
194 test, $P < 0.001$).

195

196 **Time between first marriage and pregnancy**

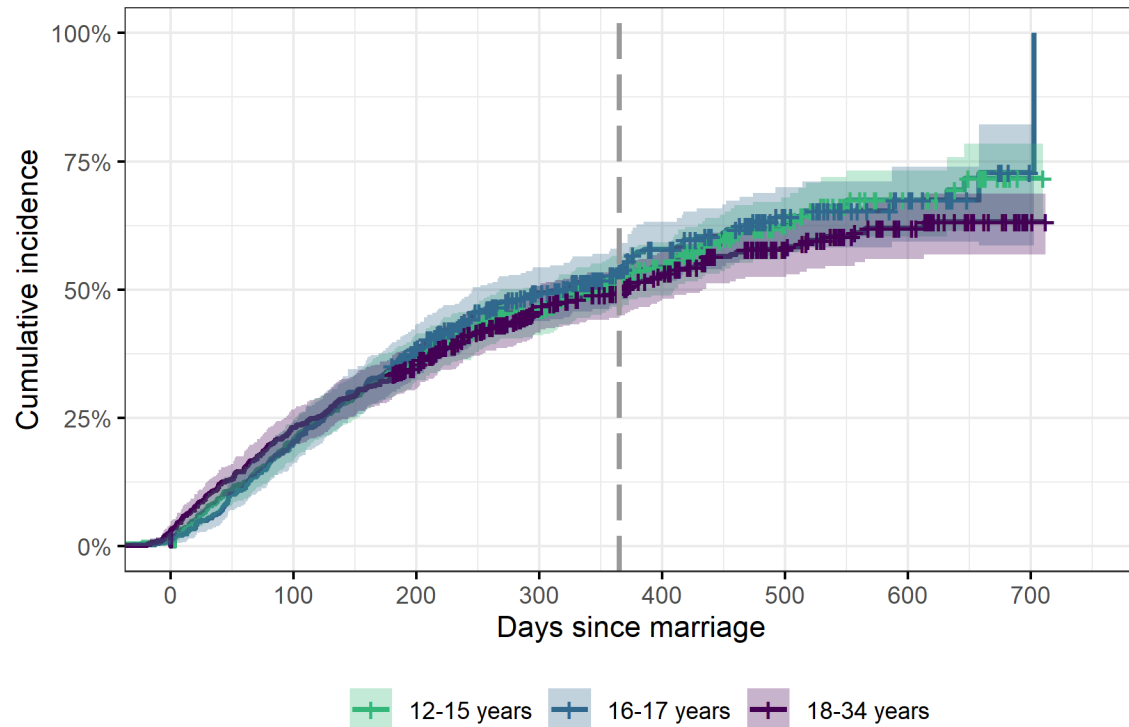
197 As pregnancies could not be captured among out-migrants, we estimated time between first
198 marriage and pregnancy for 1,320 female residents who were newly married in Baliakandi
199 between September 2017 and August 2019 and remained in Baliakandi for at least 180 days after
200 marriage. Fifty-four percent (715/1,320) reported at least one pregnancy by August 2019. This

201 proportion includes females with less than 180 days of follow up after marriage. The mean time
202 to pregnancy or end of follow up was 264 days. Thirty-three percent (239/715) of first
203 pregnancies were among females married at ages 12 to 15 years, 29% (209/715) were among
204 those married at ages 16 to 17 years and 37% (267/715) were among those married at ages 18 to
205 34 years.

206 Time between marriage and pregnancy was estimated using the last menstrual period. We
207 estimated Kaplan-Meier cumulative incidence curves stratified by age at marriage and did not
208 find a statistically significant difference by age in the timing of pregnancy (log-rank test,
209 $P=0.535$) (Figure 2). Within 365 days of marriage, approximately half of all newly married
210 females had a pregnancy: 52% (95% confidence interval (CI) 47 to 57%) among those married at
211 12 to 15 years, 53% (95% CI 48 to 59%) among those married at ages 16 to 17 years and 50%
212 (95% CI 45 to 54%) among those married at ages 18 to 34 years. Results were similar after
213 restricting the analysis to female residents who remained in Baliakandi for at least 365 days after
214 marriage (supplementary table 1).

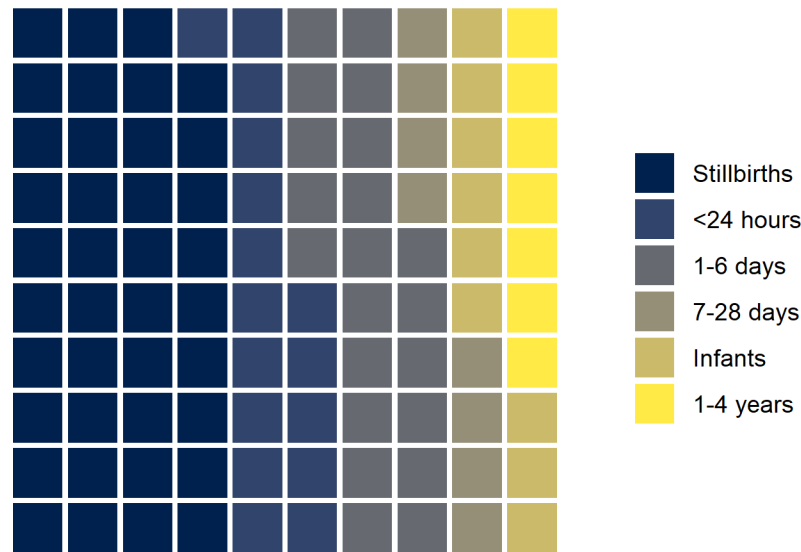
222 **Pregnancy outcomes and perinatal deaths**

223 We identified a total 10,345 pregnancy outcomes in Baliakandi between September 2017 and
224 August 2019: 269 (3%) among females aged 12 to 15 years, 863 (8%) among females aged 16 to
225 17 years and 9,213 (89%) among females aged 18 years or older. Pregnancy outcomes included
226 1,018 (10%) miscarriages/abortions, 217 (2%) singleton stillbirths, and 9,024 (87%) singleton
227 live births. Outcomes of multiple gestations included 75 (1%) twin live births, 10 (0%) twin
228 births with at least 1 stillbirth, and 1 (0%) triplet live birth.

229 We identified a total 446 perinatal deaths. Two hundred thirty (52%) were stillbirths, 96
230 (22%) were neonatal deaths that occurred within 24 hours after birth, and 120 (27%) were early
231 neonatal deaths that occurred after 24 hours (Figure 3). Nineteen (4%) perinatal deaths were
232 among females aged 13 to 15 years, 48 (11%) were among females aged 16 to 17 years, 282
233 (63%) were among females aged 18 to 29 years, and 97 (22%) were among females aged 30

234 years and above. There were no perinatal deaths among females under 13 years of age. This
235 resulted in perinatal mortality rates of 79 perinatal deaths per 1,000 total births among females
236 aged 13 to 15 years, 62 perinatal deaths per 1,000 total births among females aged 16 to 17, 42
237 perinatal deaths per 1,000 total births among females aged 18 to 29 years, and 58 perinatal deaths
238 per 1,000 total births among females aged 30 years and above.

244 **Maternal age at birth and perinatal mortality among singleton births**
245 To examine the relationship between maternal age at birth and perinatal mortality, we restricted
246 our analysis to singleton births among female residents under 35 years of age (Table 1). Among
247 singleton births identified between September 2017 and August 2019, 2% (198/8,806) were

248 stillbirths and 2% (188/8,806) ended in early neonatal deaths. The estimated stillbirth rate was 22
 249 stillbirths per 1,000 singleton births and the estimated early neonatal mortality rate was 22 deaths
 250 per 1,000 singleton live births. Eighty-four percent of perinatal deaths were among females
 251 under 30 years of age (324/386) and 52% were among first-time mothers (202/386). Fifty-one
 252 percent were among first-time mothers under 30 years of age (198/386).

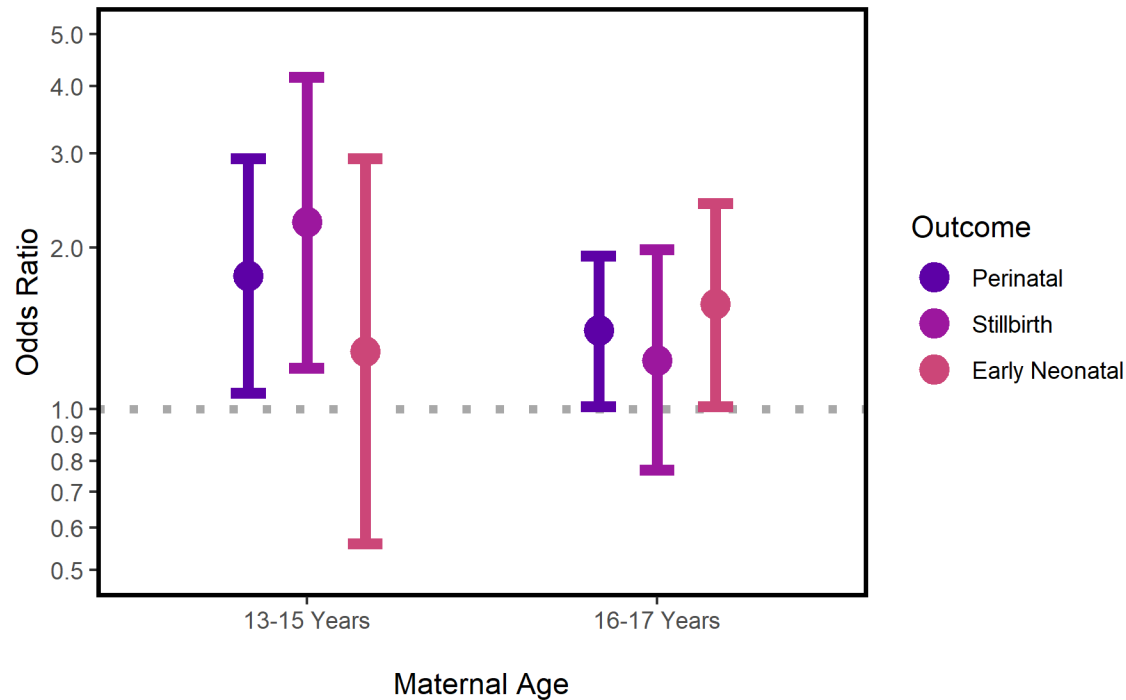
256 *No singleton births were reported among mothers under 12 years of age. Births among women over 34 years were
 257 excluded.

258

259 Compared to females aged 18 to 34 years, the odds of perinatal death were higher for
260 females aged 13 to 15 years (odds ratio (OR) 1.77, 95% CI 1.07 to 2.93) and females aged 16 to
261 17 years (OR 1.40, 95% CI 1.01 to 1.93) (Figure 4). When we considered stillbirths and early
262 neonatal deaths as separate outcomes, females aged 13 to 15 years had higher odds of stillbirth
263 (OR 2.23, 95% CI 1.19 to 4.16) and females aged 16 to 17 years had higher odds of early
264 neonatal death (OR 1:57, 95% CI 1.01 to 2.42), compared to females aged 18 to 34 years (Figure
265 4). Associations were no longer statistically significant for stillbirths (adjusted odds ratio (aOR)
266 1.77, 95% CI 0.92 to 3.38) and early neonatal deaths (aOR 1.28, 95% CI 0.80 to 2.04), after
267 adjusting for household wealth and parity (Supplementary table 2).

275 **Complications during delivery**

276 Information on complications during delivery were collected through detailed pregnancy
277 surveillance for 3,286 singleton births of a total 3,311 singleton births (99%) that occurred
278 between January and August 2019 among female residents who were under 35 years of age at
279 birth. Complications were common in Baliakandi regardless of maternal age, with 24% of all
280 births (803/3,286) reporting at least one complication, including prolonged/obstructed labor,
281 birth trauma or difficult delivery, and heavy bleeding during delivery (Table 2). Nineteen percent
282 (610/3,286) involved unplanned hospital admissions. Nineteen percent all live births (604/3,223)
283 were considered preterm based on estimated gestational age and 38% (180/604) of preterm births
284 involved pre-labor cesarean sections.

294 Compared to females aged 18 to 34 years, adolescents were more likely to experience at
295 least one complication during delivery (χ^2 test, $P<0.001$) and have unplanned admissions (χ^2 test,
296 $P<0.001$). Among specific complications, obstructed or prolonged labor, birth trauma or difficult
297 delivery, and heavy bleeding during delivery were more common among females under 18 years
298 of age, compared to those aged 18 to 34 years (χ^2 test or Fisher's exact tests, all $P<0.050$).

299

300 **DISCUSSION**

301 Using data from a HDSS covering approximately 216,000 residents in a rural sub-district of
302 Bangladesh, we found almost no change in the proportion of marriages to child brides over the
303 past decade. In 2019, more than half of all marriages were still to child brides. However, we note
304 substantial increases in the age of child brides. We found no evidence of postponed pregnancies
305 for child brides. Half of all newly married females became pregnant within a year of marriage,
306 including adolescents.

307 Complications during delivery were common in Baliakandi regardless of maternal age.
308 However, they were more likely to occur in adolescent pregnancies. Over a quarter of deliveries
309 among adolescent girls involved an unplanned hospital admission and around a third reported
310 complications, including those related to physical immaturity [3]. Common complications
311 included prolonged or obstructed labor, birth trauma or difficult deliveries, and heavy bleeding,
312 which can lead to severe, long-term urologic, gynecologic and neurologic injuries as well as
313 secondary infertility [17–19].

314 Adolescent pregnancies were more likely to end in perinatal death than pregnancies
315 among adult women. Risk of perinatal death could partially be explained by parity and

316 household wealth. Adolescent mothers were more likely to be nulliparous, which is associated
317 with increased risk of obstetric complications and perinatal death in Bangladesh [20,21]. Further,
318 less wealthy families were more likely to have child brides as well as perinatal deaths, perhaps
319 due to poor nutrition, lack of resources, and less access of health care [22–25].

320

321 **Strengths and weaknesses of this study**

322 A notable strength of this study was the use of HDSS data to investigate child marriage. Most
323 quantitative studies of child marriage in South Asia are based on Demographic and Health
324 Surveys [26,27] or other cross-sectional surveys [28]. Unlike cross-sectional samples, the
325 Baliakandi HDSS prospectively collected key information such as dates of birth, marriage,
326 pregnancies, and births through frequent data rounds, leading to more accurate reporting and
327 estimates. In Matlab, Bangladesh, which hosts a similar HDSS originally established in 1966
328 [15], almost two-thirds of female residents aged 15 to 29 years misreported their age at first
329 marriage in cross-sectional surveys, with the average reported age nearly 2 years younger than
330 true values in the HDSS [29]. While the exact causes of underreporting were unknown, it may
331 have been driven by a desire to reduce dowry costs, which increase with the bride’s age, and to
332 meet the “preferred age” of brides, which is typically under 20 years [29,30]. If similar
333 underreporting is true for Baliakandi, we may have underestimated child marriage in years prior
334 to 2017 given marriages dates were collected retrospectively for this period. Our estimates did
335 not include female residents who out-migrated nor those who died during this period. While it is
336 unclear how these deaths might impact our estimates, out-migration may have led to
337 underestimates. Our findings from 2017 to 2019 suggest newly married brides who out-migrate
338 were more likely to be child brides than those we remained in Baliakandi. Lastly, our estimates

339 of time between first marriage and pregnancy may have been influenced by downward bias as
340 adult brides were more likely to out-migrate soon after marriage.

342 **Comparison with other studies**

343 Our findings from Baliakandi were consistent with larger national trends described in the
344 Bangladesh DHS [13]; child marriage remains a pervasive and persistent human rights violation
345 in Bangladesh and little progress has been made in recent years. Over half of all marriages still
346 involve child brides [13]. Associations between adolescent pregnancies and perinatal death were
347 consistent with earlier studies which used the Bangladesh DHS. These cross-sectional studies
348 showed adolescent pregnancies were associated with increased risk of stillbirths and neonatal
349 mortality [21,31]. Associations between maternal age and obstetric complications were
350 consistent with a prior study conducted in northwest Bangladesh [20].

351 The preterm birth rate in Baliakandi was consistent with national estimates, which is one
352 of the highest in the world [32]. One potential explanation was the common practice of elective
353 cesarean sections in Baliakandi, which may be driven by increased practice without medical
354 indication, especially among private facilities, by a fear of vaginal deliveries, and the belief that
355 cesarean deliveries are safer for the mother and baby [33,34].

357 **Policy implications and conclusions**

358 Bangladesh has one of highest rates of child marriage in the world [13], even with legislation
359 prohibiting child marriage in existence since 1929 [35]. Critics argue progress may be further
360 hindered by recent legal exceptions introduced in the 2017 Child Marriage Restraint Act, which

361 permits child marriage under ambiguous circumstances that are “in the best interests of the
362 minor” [36].

363 Globally, 90% of adolescent pregnancies occur within marriage [9]. Although
364 childbearing should be delayed among adolescent girls to protect the health of the mother and
365 newborn [3,12,37], our study showed no evidence of postponed pregnancy among child brides in
366 Baliakandi. Adolescent pregnancies are likely driven by the social value placed on childbearing
367 for newly married wives in Bangladesh and the prospect of improving one’s status within the
368 husband’s family through childbirth [38,39]. Many newly married adolescents lack power and
369 social status to negotiate delays in pregnancy, coupled with a lack of knowledge or
370 misconceptions of contraceptives. One example of misconceptions is that contraceptives can lead
371 to infertility [39]. In contrast, wives who delay childbearing often experience stigma of perceived
372 infertility, abuse by in-laws, and rumors of infidelity [38]. These dynamics may drive low
373 contraceptive use and unmet family planning needs seen among adolescent pregnancies [13].
374 Adolescent pregnancies are more likely to experience obstetric complications such as prolonged
375 and obstructed labor, which can cause long-term physical consequences [17–19] as well as
376 devastating psychosocial disabilities even after treatment, as girls deal with shame, stigma, and
377 rejection by their families and communities [17].

378 The problem of child marriage is daunting; it is a practice deeply rooted in social and
379 gender norms and sustained by gender inequality, poverty and insecurity [12,40–42]. However,
380 encouraging commitments have been made to end child marriage in Bangladesh, such as the
381 UNFPA-UNICEF Global Programme to End Child Marriage, which involves targeted actions in
382 12 focus countries with high burdens of child marriage, including Bangladesh [43]. Recent
383 evaluations of the Global Programme show all global targets have been met or surpassed in the

384 first phase (2016 to 2019). Targets include developing life skills and comprehensive sexuality
385 education among adolescent girls, supporting continued formal or non-formal education among
386 adolescent girls, increasing awareness of the benefits of preventing child marriage in
387 communities, supporting health and protection systems, developing national plans of action, and
388 generating data to accelerate ending child marriage [44]. Further, findings from large randomized
389 control trials such as BALIKA in Bangladesh suggest various interventions such as education
390 support, gender rights awareness training, and livelihood training can lead to large reductions in
391 child marriage. Villages assigned to one of the three aforementioned interventions showed a 25
392 to 30% reduction in risk of child marriage compared to control villages [45].

393 Only by accelerating ongoing commitments and promoting additional widespread
394 interventions we can truly eliminate child marriage within the next decade. By addressing child
395 marriage, we improve the health of two groups of children: adolescent mothers and their
396 newborns. We can prevent a chain of harmful social, developmental, and reproductive harms that
397 have lasting impacts on adolescent girls while mitigating the global burden of stillbirths and
398 neonatal deaths.
