### 28 Abstract (239/250)

30 **Purpose:** To determine the relationship between anthropometric measures and corneal refractive
 31 power (CRP).

32

33 Methods: Participants from the 1999-2008 United States National Health and Nutrition

- 34 Examination Survey (NHANES) visual exam with demographic, ocular, and anthropometric data
- 35 (20,165 subjects) were included. Cases with steep cornea were defined by corneal power  $\geq$  48.0
- diopters (n = 171) while controls had dioptric power < 48.0 D (n = 19,994). Multivariable
- analyses were performed for pooled and sex-stratified populations. Separate models assessed
- 38 body mass index, height, and weight in relation to steep cornea.
- 39

40 Results: A relationship between BMI and steep cornea in the pooled population was not detected

- 41 (P for trend = 0.78). There was a strong inverse relationship between height and steep cornea in
- 42 the pooled population (P for trend <0.0001) and women (P for trend <0.0001). For every 1-inch
- 43 increase in height, there was a 16% reduced odds of steep cornea in the pooled population (OR,
- 44 0.84; 95% CI: 0.78-0.91). There was also a significant inverse relationship between weight and
- 45 steep cornea in the pooled population (P for trend = 0.01) and in men (P for trend = 0.02). For
- 46 each 10-pound increase in weight there was a 7% reduced odds of steep cornea (OR, 0.927; 95% 47 Cl. 0.882, 0.075) in the pooled analysis
- 47 CI: 0.882-0.975) in the pooled analysis.

49 **Conclusions:** Greater height and greater weight were associated with a lower risk of steep 50 cornea. These findings can contribute to an improved understanding of the pathogenesis of

- 51 corneal ectasias.

#### 55 Introduction:

56 Corneal refractive power (CRP) is an important clinical parameter in clinical practice for 57 patients seeking refractive or cataract surgery. High corneal refractive power can indicate 58 pathologic processes such as corneal ectasias like keratoconus and pellucid marginal degeneration.<sup>1,2</sup> There is an intimate relationship between CRP and other ocular components 59 60 such as axial length, anterior chamber depth, and lens thickness, with evidence that the eye often achieves emmetropia despite differences in these parameters.<sup>3,4</sup> While there is a defined 61 relationship between other ocular components and CRP, the relationship between CRP and 62 anthropometric features is less clear. 63

- 64 Previous studies have explored these relationships and found variable results.<sup>5–10</sup> Lee
- 65 found an inverse relationship between corneal steepness and height after adjusting for
- 66 confounders.<sup>9</sup> Wong et al.'s population-based study in Singapore demonstrated the same results,
- as well as a positive relationship between weight and hyperopic refractions.<sup>10</sup> While these studies
- 68 suggest evidence of an inverse relationship between CRP/corneal radius and height, few papers
- 69 have specifically examined anthropometric parameters in patients on patients with high CRP, a
- 70 population which may represent those with corneal pathology. To date, the Central India Eye and
- 71 Medical Study, the Beijing Eye study, and the Singapore Epidemiology of Eye Diseases Study
- have specifically examined anthropometric parameters on patients with steep corneas. $^{6-8}$
- 73 However, these studies did not account for the confounding effects between the various
- anthropometric measures, had smaller sample sizes, and looked at ethnically homogenous
- 75 populations.
  - The purpose of the current study was to investigate the relationship between
- anthropometric features and steep corneas (those with a spherical dioptric power of  $\geq$  48 D)
- vising the National Health and Nutrition Examination Survey (NHANES). In doing so, we aimed
- 79 to use methodology designed to assess the independent associations of height and of weight with
- 80 CRP.

#### 83 Methods:

# 84 Data Sources

- 85 We used data from the 1999-2008 National Health and Nutrition Examination Survey
- 86 (NHANES). The NHANES has been described previously. Briefly, it is a nationally
- 87 representative survey of the US civilian, noninstitutionalized population with data on
- 88 demographics, lifestyle, anthropometric measures, and also ocular health.<sup>11</sup>
- 89 The 1999-2008 NHANES was reviewed and approved by the National Center for Health
- 90 Statistics Research Ethics Review Board. All participants provided written informed consent.

# 91 Study Population Selection

- 92 We included all NHANES participants who met the following criteria: they took part in the
- 93 visual exam; provided demographic data (age, gender, race, education, socioeconomic status)
- 94 and general health information (on asthma, hypertension, and diabetes); anthropometric
- 95 measures (height, weight); were older than 20 years (to account for continuing changes in
- 96 height<sup>12</sup>); and had not had cataract or refractive eye surgery.

# 97 Anthropometric Measurements

- 98 During visits at the mobile examination center, trained health technicians directly measured
- 99 anthropometric features. A stadiometer was used to measure standing height to the nearest 0.1
- 100 centimeter. Weight was measured to the nearest 0.1 kilogram using a Toledo digital scale
- 101 (Mettler-Toledo Inc.).

# 102 Outcome Measures

- 103 Participants were examined using an autorefractor (NIDEK ARK-760; Nidek Co Ltd, Tokyo,
- 104 Japan) in order to measure keratometry power in both eyes. For each eye, the dioptric power of
- 105 the cornea was averaged across the meridians. Patients were examined in a non-cycloplegic state
- 106 with final values from an average of three measurements.<sup>13</sup> We defined steep cornea as a
- 107 spherical dioptric power  $\ge$  48.0 diopters D in the eye with higher dioptric power. This cutoff was
- 108 chosen for consistency with prior studies defining steep corneas as keratometry values  $\geq$  48 D.<sup>6,8</sup>

# 109 Statistical Analysis

- 110 We used multivariable logistic regression models to assess the association of the primary
- 111 exposure of an anthropometric measure (while adjusting for covariates of demographic factors
- and comorbidities as discussed further below) with the outcome variable of the presence of steep
- 113 cornea. All analyses took into account NHANES survey design. SAS statistical software version
- 114 9.2 (SAS Institute, Cary, NC) and R statistical software version 1.1 (R Foundation, Vienna,
- 115 Austria) were used for analysis.

# 116 Anthropometric Measures

117 Uncorrelated Height and Weight analysis:

- 118 Although BMI incorporates both height and weight, we were interested in assessing the
- 119 independent associations of height and weight with steep corneas. Thus we performed a
- 120 regression of height with weight as the exposure. This regression was used to calculate residuals
- 121 of height that were centered at the median height of the population (66 inches) providing an
- 122 uncorrelated height. For gender-specific analyses we repeated this process and centered at the
- median heights for men (69 inches) and women (64 inches). The resulting uncorrelated height
- 124 and weight were included in a multivariable model to determine their association with steep
- 125 cornea. This same process was repeated for weight residuals centered at the median weight of the
- 126 entire population (172 lbs) and in gender-stratified analyses for men (187 lbs) and women (157
- 127 lbs).

## 128 Regression Models

- 129 We fit multivariable logistic regression models with primary exposures of (1) BMI, (2) height,
- 130 and (3) weight, and an outcome of the presence (vs. absence) of steep cornea. The first model
- 131 had a primary exposure of BMI (bucketed into 5 categories), adjusting for gender, race,
- 132 educational level, socioeconomic status, age, and comorbidities (asthma, HTN, and diabetes).
- 133 The second model had a primary exposure of height adjusting for uncorrelated weight and the
- 134 same covariates. The third model had a primary exposure of weight adjusting for uncorrelated
- height and the same covariates. These models were repeated with primary exposures as
- 136 continuous variables to assess for linear relationships. Given the substantially larger range of
- 137 weight as compared to height or BMI, weight was assessed as a continuous variable per 10
- 138 pounds. Outliers (1 case and 82 controls) in terms of measured data for BMI, height, and weight
- 139 that were 3 times the interquartile range greater than the third quartile or lesser than the first
- 140 quartile were not included in the analysis shown.<sup>14</sup> Sensitivity analysis was conducted with
- 141 outliers included (data not shown) and is further described in the results.
- 142 In order to assess the role of gender with each of the three primary exposures, three approaches
- 143 were used: (1) gender was adjusted for as a covariate in multivariable regressions with the
- 144 pooled analyses; (2) multivariable models with an interaction term between gender and the
- 145 primary exposure were assessed; and (3) models were assessed for the entire population and then
- 146 repeated with gender stratification.

#### 147 **Results**

- Among 20,165 individuals, 171 cases of steep corneas were identified. In the overall population
- 149 (Table 1), the mean age for controls was 46 years (range, 20-85; 95% CI 45.8-46.9) and for cases
- 150 was 44 years (range, 20-85; 95% CI 41.4-47.1). Women comprised 52% (95% CI 50.9-52.2) of
- the overall population. Notably, there were more women among cases (68%; 95% CI 59.2-76.8)
- than controls (51%;95% CI 50.8-52.0). There were also more individuals with asthma in cases
- 153 (23%; 95% CI 14.0-32.5) than among controls (13%; 95% CI 12.2-13.5).
- 154 There were notable differences in sex-stratified analysis (Table S1). Among women, there were
- 155 more cases with asthma (28%; 95% CI 16.6-39.2) than controls (15%; 95% CI 13.6-15.5).
- Among men, there were more cases who were non-Hispanic whites (83%;95% CI 74.5-90.7)
- than controls (73%; 95% CI 70.2-75.3). All differences were adjusted for in multivariable
- analysis.

## 159 The relationship between body-mass index and steep cornea (Table 2)

- 160 A relationship between categories of BMI and steep cornea was not detected in the pooled
- 161 population in categorical analysis (p for trend = 0.78). A relationship between linear BMI and
- 162 steep cornea was also not detected (p=0.86).
- 163 In sex stratified analysis, there was a nonsignificant negative relationship between categorical
- BMI and odds of steep cornea in men (p for trend = 0.21). When BMI was considered as a
- 165 continuous variable, each unit increase in BMI was associated with a 6% reduced odds of steep
- 166 cornea in men (OR, 0.94; 95% CI 0.878-0.995). While inclusion of outliers did change the
- 167 borderline significance of this association, it did not meaningfully change the reduced odds of
- 168 steep cornea in men per unit increase in BMI (OR, 0.95; 95% CI 0.889-1.006). Analysis of the
- 169 BMI categories (p = 0.33, for trend) and of linear BMI showed no significant associations with
- 170 steep cornea in women (p = 0.45). When using the existing categories (Table S1), there was not a
- 171 significant interaction between BMI and gender in association with steep cornea (p = 0.41, Table
- 172 S2) in categorical analysis.

# 173 **The relationship between height and steep cornea** (Table 3)

- 174 There was an inverse relationship between categories of height (adjusted for weight residuals)
- and steep cornea (p for trend <0.0001) in the pooled population. Compared to participants  $\leq 62$
- inches, for those in the 65.1 67-inch category there was a 61% reduced odds (OR, 0.29; 95%
- 177 CI 0.16-0.55) of steep cornea and in the tallest category  $\geq$  70.1 inches there was a 82% reduced
- 178 odds (OR, 0.18; 95% CI 0.07-0.47). The relation between linear height and steep cornea was
- robust (p<0.0001). For every 1-inch increase in height adjusted for weight residuals, there was a
- 180 16% reduced odds of steep cornea (OR, 0.84; 95% CI 0.78-0.91).

- 181 In gender specific analysis, this relationship between height adjusted for weight residuals and
- 182 steep cornea was also significant in women. For every 1-inch increase in height there was a 19%
- 183 reduced odds of steep cornea (OR, 0.81; 95% CI 0.74-0.88; p<0.0001).
- 184 The relationship between height adjusted for weight residuals and steep cornea in men showed
- 185 equivocal results. In multivariable analysis, only one category of height (69.1-71 inches) showed
- 186 an inverse relationship with steep cornea (OR, 0.25; 95% CI: 0.09-0.70) compared to the
- 187 reference category (≤66 inches) in men. There was a borderline significant association between
- 188 height and steep cornea in men when assessed for a linear relationship (OR, 0.88; 95% CI 0.76-
- 189 1.01; p =0.074).
- 190 We explored a potential gender-height interaction in relation to steep cornea in several
- 191 multivariable models. When height was treated as a continuous variable, no significant
- 192 interaction was found (interaction coefficient -0.03; 95% CI -0.08 to 0.03, p=0.35; Table S3).
- 193 Further, when we readjusted the categories for the inherent differences in height between men
- and women no significant interaction was noted (p=0.59; Table S5).

#### 195 **The relationship between weight and steep cornea** (Table 4)

- 196 There was an inverse relationship between categories of weight (adjusted for height residuals)
- and steep cornea (p for trend = 0.011) in the pooled population. While there is a trend between
- 198 categories of weight and their association with steep cornea, only the highest category of weight
- 199 (200.1 lbs+) showed a statistically significant inverse relationship with steep cornea (OR, 0.45;
- 200 95% CI: 0.24-0.85) compared to the reference category ( $\leq 140$  lbs). When weight was considered
- as a linear variable, every 10-pound increase in weight had a 7% reduced odds of steep cornea
- 202 (OR, 0.927; 95% CI: 0.882-0.975; p= 0.0038).
- 203 In sex stratified analysis, there was not a significant association between weight adjusted for
- height residuals and steep cornea in women in both categorical (p=0.75) and linear analyses per
- 205 10-pound increase (p= 0.64). Among men, for each 10-pound increase in weight there was 12%
- 206 reduced odds of steep cornea (OR, 0.885; 95% CI: 0.809-0.968; p=0.0083). While there were
- 207 modest differences in the associations of steep cornea and weight in sex-stratified analysis, there
- 208 was not a significant interaction between weight and gender in relationship to steep cornea
- 209 (interaction coefficient 0.02; 95% CI -0.01 to 0.04, p = 0.16, Table S4).

#### 212 Discussion

This retrospective cross-sectional study found a substantial inverse association between height and steep cornea. Notably, this relationship, when adjusting for uncorrelated weight, was significant in the total population and in women. Weight, adjusted for uncorrelated height, was also inversely associated with steep cornea in the total population and in a sex-stratified analysis for men, but not for women. There was no significant association between BMI and steep cornea. Height had the strongest association with steep cornea; for each 1-inch increase in height

Height had the strongest association with steep cornea; for each 1-inch increase in height there were 16% lower odds of steep cornea in the pooled population, while in women there was a 19% reduction. Studies in India and Singapore have identified a similar inverse relationship between height and corneas with K>48, even after adjusting for other variables.<sup>6–8</sup> The Beijng eye study had similar results until adjustment for other ocular characteristics (i.e. axial length, cylindrical refractive error, etc.). None of these three studies used residuals to de-correlate the height and weight variables. Our study, in context of those that have shown a similar relationship, suggest a possible genetic relationship between height and steep corneas.

226 There is a complex connection between corneal curvature/steepness and other ocular 227 features such as axial length and anterior chamber depth. Longer axial lengths are often 228 associated with flatter corneas and shorter axial lengths are associated with steeper corneas, in an effort of the eye to achieve emmetropization. It has been theorized that those with shorter height 229 230 may also have smaller axial lengths, and secondarily develop steeper corneas. It has also been 231 speculated that educational status is associated within better nutrition and taller height, which 232 may lead to myopia and longer axial length. Previous researchers have examined these relationships.<sup>7,9,10</sup> Wong et al. found that that height had a strong correlation to multiple ocular 233 234 parameters (axial length, corneal curvature, anterior chamber and vitreous chamber depth) that is 235 independent of education, weight, gender, and other systemic and lifestyle factors. Lee et al also 236 found that height was independently associated with corneal curvature after controlling for 237 education, gender, and age.<sup>9</sup> Our study also showed that the effect of height persists after 238 adjusting for education, race, and socioeconomic status, challenging the hypothesis of education 239 being a surrogate marker for height, better nutrition and longer axial lengths.

240 Although other studies used the term "keratoconus (KCN)" interchangeably with K >48, 241 we felt that using this definition would mis-classify many individuals. Keratoconus is a clinical 242 diagnosis that relies on both the clinical exam and corneal imaging findings (either tomography 243 or topography). Using a diopter cut-off value may result in people with corneal scars being 244 incorrectly labeled as having KCN, but also may miss those with early disease. Nonetheless, 245 many people in our analysis likely did have true KCN, and the relationship between KCN and 246 height warrants discussion. There are known associations between connective tissue disorders, with varying height relationships, and KCN, suggesting an underlying role of connective tissue 247 dysfunction.<sup>2,15</sup> Notably, reports of greater prevalence of mitral valve prolapse in individuals 248 249 with KCN when compared to controls suggest that alterations in collagen subtypes during embryogenesis may lead to changes in the corneal stroma as well as mitral valve formation.<sup>15–17</sup> 250 251 There may be a genetic basis for the association between height and KCN as both height and 252 central corneal thickness (strongly associated with KCN) have substantial heritability with

estimates up to 80% and 95%, respectively.<sup>18,19</sup> Further study of this association may elucidate
these genetic underpinnings.

255 Estrogen may contribute to the association of steeper corneas and shorter height. Estrogen plays an important role in the development of height promoting early epiphyseal 256 growth plate closure and resulting in shorter height.<sup>20,21</sup> In genetic studies, estrogen receptor 257 polymorphisms have been associated with decreased height.<sup>22,23</sup> Healthy women have also 258 demonstrated changes in corneal curvature and thickness during the menstrual cycle, menopause, 259 and with topical estrogen therapy.<sup>24–26</sup> Although most studies on estrogen and corneal 260 topographic changes are predominantly in women, further study is needed to characterize 261 262 estrogen effects on corneal topography in men.

263 While our analyses did not identify notable interactions between anthropometric features 264 and gender in relationship to steep cornea, this may have been due to limited sample size and 265 further in the case of height, inherent gender differences in distributions. Prior studies have reported the relationship between gender and steep cornea and anthropometric features.<sup>6–8</sup> Some 266 267 studies found that once height was included, a gender association with steep cornea was no longer significant, similar to what we found.<sup>6–8</sup> Our findings on the confounding effects of height 268 or weight on the relationship between gender and steep cornea (see supplement) may provide 269 insight on these differing associations.<sup>27–29</sup> Further investigation with case-control studies may 270 271 enable detection of associations and interactions between anthropometric features and gender in 272 people with steep corneas.

273 In addition to the inverse relationship between height and steep cornea, we also found a 274 significant association between weight and steep cornea; there was a 7% reduced odds of steep 275 cornea per 10 pound increase in weight. Similarly, in men there was a 12% reduced odds of steep 276 cornea per 10 pound increase in weight. A potential biological basis for this relationship may be 277 related to hormones. Prolactin, which is found at higher levels in patients with obesity, and the 278 related prolactin induced protein, may mediate transcription, translation, and organization of keratin in the cornea.<sup>30–33</sup> Interestingly, prolactin induced protein levels are downregulated in 279 280 tears, saliva, and corneal fibroblast cells from individuals with KCN compared to healthy individuals.<sup>30</sup> 281

282 There was no meaningful association between BMI and steep cornea in our pooled 283 analysis. In men, a modest association between BMI and steep cornea was detected; they were 284 found to have a 6% reduced odds of steep cornea per unit increase in BMI. Finally, there were no significant categorical interactions with gender and BMI (p = 0.41) or gender and weight (p =285 0.61) in steep cornea. There are mixed findings in the literature regarding the relationship 286 between steep cornea and BMI.<sup>6–8</sup> Although some studies<sup>6–8</sup> similarly did not find an association 287 between BMI and steep cornea, another paper from Israel by Eliasi et al. found a strong 288 289 relationship between KCN (as defined by patients with K >48) and BMI. <sup>5</sup> While both our study 290 and that of Eliasi adjust for age, their narrow age inclusion criteria (16-19.9 years old) may be 291 contributing to the differences in our findings.

292 Our study has several limitations. First, although we adjusted our models for a number of

important confounding factors, the NHANES did not collect other ocular parameters such as
CCT or axial length, which have been included as covariates in other studies.<sup>6–8</sup> This may be
needed to better understand their role in this association. Finally, we cannot draw causal
inferences from our analyses with the cross-sectional data of the NHANES. We acknowledge
this limitation and further studies using different methodologies will be needed to address causal
relationships.
Strengths of this study included the use of uncorrelated height and weight in analyses to

assess their independent associations with steep cornea. This allowed greater power to detect
 associations with steep cornea and enables stronger associations to be identified. The NHANES

302 has highly standardized and calibrated methodology allowing for accurate and direct

303 measurements of anthropometric features and keratometry, both of which were measured in the

304 same visit. <sup>34</sup> Further, our analysis used multiple logistic regression to account for a number of

305 covariates including age, race, education, socioeconomic status, and comorbidities (asthma,

306 hypertension, and diabetes). Finally, the NHANES database multilevel complex sampling

307 methodology enables findings applicable to a nationally representative US population.

308 In conclusion, there is an inverse association between height, independent of weight, and 309 steep cornea. There is also an inverse relationship between weight, independent of height, and

310 steep cornea. Further study of the relationships of height and weight with steep cornea may yield

311 mechanistic insight into the pathogenesis of corneal ectasias as well as genetic correlations.
