23 Abstract

24	Awareness of Human Immunodeficiency Virus (HIV) status improves health outcomes in
25	HIV infected children, yet disclosure is often delayed by hesitant caregivers. This qualitative
26	investigation explored how 30 caregivers responded to a HIV Disclosure study conducted
27	between 2017 and 2020 at Chris Hani Baragwanath Academic Hospital, Soweto, South
28	Africa. Caregivers were assisted in disclosing to their children, aged 7-13 years; followed by
29	a sub-sample of caregivers interviewed to elaborate on findings.1) Barriers to disclosure
30	included caregivers being ill-equipped, fear of negative consequences and children
31	considered lacking emotional or cognitive readiness. 2) Deflecting diagnosis and the need
32	for medication motivated caregivers to disclosure. 3) Apprehension was evident during
33	disclosure, however, overall disclosure was a positive experience with the support of the
34	healthcare providers. These results highlight the significant role healthcare providers play in
35	supporting caregivers through the disclosure process and how, in turn, this has a positive
36	impact on the community as a whole.

Introduction

40 The increase in Antiretroviral Therapy (ART) coverage led to a decline in HIV related 41 deaths of children in Southern Africa, now making Human Immunodeficiency Virus (HIV) a 42 chronic condition that requires comprehensive multidisciplinary care (1-10). Disclosing HIV 43 status to perinatally-infected children remains a challenge despite evidence suggesting that 44 it improves health and emotional outcomes (2, 3, 8-15). The SADoH (16) suggests that 45 partial disclosure takes place from 3 years to 9 years of age, and full disclosure is to take 46 place from 10 years of age. Furthermore, this process should be followed-up. The WHO 47 (4) suggests disclosing to school going children between 6 and 12 years of age (16). The 48 World Health Organisation (WHO) and the South African National Department of Health 49 (SANDoH) encourage a comprehensive approach to disclosure which ensures the child's 50 physical, emotional, cognitive and social well-being is safeguarded by pre-disclosure not 51 being completed in front of the child and children of school going age to be made aware of 52 their caregivers' HIV status (4, 10, 11, 13, 16). Despite this, studies have shown that many 53 children are unaware of their HIV status and that their caregivers are hesitant to disclose to 54 them (17).

55 Disclosure has far reaching psychosocial implications (18). Caregivers and their HIV-56 infected children live as a part of a greater "whole". In accordance with Social Learning 57 Theory, an individual is a member of his/her immediate family, extended family, culture, 58 peer group, school and country. Not only do they influence their environment but they are 59 directly influenced by the attitudes, perspectives and behaviours of others (19, 20). 60 Caregiver attitudes towards HIV and disclosure are shaped by their personal experiences 61 within the environment and the attitudes of those around them. This, in turn, shapes when 62 and how disclosure is addressed in their own families (15, 20, 21). The literature has 63 identified several barriers to disclosure including: social stigma; fear of discrimination; the 64 impact on the child's emotional/psychological well-being; fear of the child's resentment;

65	untimely disclosure of HIV status to others; exposure of the caregiver's "personal secrets";
66	and caregiver's lack of knowledge on how and when to approach the disclosure questions
67	(4, 13, 16, 17, 22-27). A recent study in Ghana (28) reported that caregivers lacked
68	knowledge on how to disclose to their children, and that this poor knowledge was the main
69	reason for delayed disclosure.
70	Few mothers were reported as being confident in their ability to disclose their status due to
71	social stigma and the possibility of this stigma being passed onto their children (21).
72	Mothers more effective in disclosing their own statuses had better relationships with their
73	children and this in turn improved the children's adjustment to the new knowledge of their
74	mother's HIV status (29, 30). The VUKA study, which focused on pre-adolescent children
75	awareness of their HIV status and family members, emphasised the importance of family
76	involvement in mental health and health promotion interventions (31). Improvements in
77	mental health, behaviour, HIV treatment knowledge and medication adherence, stigma and
78	communication between the child and family members involved were noted (31).
79	Therefore, interventions aimed at assisting mothers disclose their child's HIV status to their
80	children in a developmentally appropriate manner may also improve the mother's
81	confidence in disclosing her own status.
82	We developed a study that guided caregivers through disclosure and explored their
83	responses and interactions with their children before and after disclosure, and psychometric
84	investigations of the impact of the disclosure process on the child's emotional state and
85	adaptive behaviour (29). This 78-week study used disclosure material (30-32) to
86	standardise the process across all participants, with both the caregivers and healthcare
87	providers directly involved.

Here we present the caregivers' motivation for and response to each stage of the disclosure
process. As the caregiver is at the core of the disclosure or non-disclosure issue, it is

- 90 important to understand their responses and perceptions and use these to shape future
- 91 interventions.

92 Methods

93 Study Setting and Participants

94 The disclosure study was conducted between 2017 and 2020 at the Perinatal HIV 95 Research Unit (PHRU), Chris Hani Baragwanath Academic Hospital, Soweto, South Africa. 96 In keeping with both the SANDoH and WHO guidelines, children between the ages 7-13 97 years, who had not been previously fully disclosed to were recruited along with their 98 caregivers. Caregivers who attended PHRU clinics with their children were approached 99 and children, who were not disclosed to or had received partial disclosure, and their 100 caregivers were invited to participate in the study. During the first study session the 101 caregivers were seen without the child participants and provided with information about the 102 study process. The participating caregivers provided consent and following this the child 103 participants were asked to provide assent (32). Thirty caregivers (i.e. the child's biological 104 parent, legal guardian, foster parent, or another person that was responsible for the 105 protection and promotion of the child's health, well-being and development) participated in 106 the main study. Following the completion of the main study in 2020, a sub-sample of 15 107 caregivers were invited to participate in the in-depth interviews where they shared their 108 perspective of the disclosure program. These participants were purposely sampled to 109 ensure the capture of a broad range of experiences.

Study Procedures

Study visits took place over 78 weeks, alternating between disclosure counselling sessions (completed week 72) and psychometric sessions (completed week 78), six weekly. The counselling sessions were led by healthcare providers, trained by the study Principle Investigator to use the "Right to Care Mini Flipster" (33) and the Joint United Nations

116	Programme on HIV and AIDS (UNAIDS) (34) disclosure material. The initial pre-disclosure
117	session was attended by the caregiver and the healthcare provider. During this session the
118	caregiver was provided with more information and prepared for the disclosure process. The
119	child and the caregiver participated together in the sessions that followed, facilitated by the
120	healthcare provider. The healthcare provider made notes about the process during each
121	session.
122	
123	The initial sessions provided education about health, the immune system and the
124	importance of medication adherence. The following sessions then assessed the child's
125	knowledge about HIV and unclear concepts were revised. Based on the child's
126	comprehension of these sessions, full disclosure was done by the caregiver with the

127 support of the healthcare provider. Disclosure counselling sessions focused on children's

128 feelings, made them aware of their support structures, and emphasised their own agency in

their care. The process was individualised and flexible, allowing for additional visits,

revisiting of topics, and accelerating or decelerating the process.

131

132 Following the completion of the main study (between nine and 15 months after full-

disclosure), a subset of 15 caregivers were invited to participate in the in-depth, structured

134 interviews aiming to better understand their experiences of the disclosure study. Purposeful

135 sampling was used to ensure a wider age range, both female and male perspectives, as

136 well as the perspectives of one caregiver who discontinued the study. Two participants

discontinued the study, both never receiving full disclosure. One child's caregiver was no

longer contactable after week 24. The other child's caregiver was unavailable after week

139 48 but did consent to participating in the in-depth interviews.

140

141 Consent was obtained and in-depth interviews were conducted with 15 caregivers.

142 Interviewers were proficient in counselling and conducting interviews. They received

training on the interview schedule and were fluent in the spoken local languages of the

- 144 participants and English. As they were also familiar with the participants' culture, it was
- unlikely that cultural barriers would have skewed participant answers.

146 **Tools**

147 **Counselling Tools**

- 148 This study provided developmentally appropriate disclosure counselling using the "Right to
- 149 Care" Disclosure Tool and the United States Agency for International Development (USAID)
- 150 / U.S. President's Emergency Plan for AIDS Relief (PEPFAR) Disclosure booklets were
- used to standardise the disclosure process. The "Right to Care" Disclosure tool (33)
- 152 consists of two developmentally appropriate flipster books: "Preparing Children for Pre-
- 153 Disclosure Through Play" utilises stories, activities and songs to teach the younger child,
- below 12 years of age, about germs, healthy living and illness; and "Mini-flipster: Disclosure
- 155 Tool for Adolescents Ages 12 & Up" explores the topics of Pre-Disclosure, Full-Disclosure
- and Post-Disclosure using the Socratic method of questioning. These tools were used
- 157 together and developed to assist caregivers in the disclosure process.

Disclosure Counselling Form (DCF)

- The DCFs were specifically developed by the research team for this study to record disclosure progression, provide progress notes and information regarding who accompanied the child. After each counselling session, the healthcare provider completed a DCF; recording their observations regarding the caregiver's and the dyads' interaction, and information provided by the caregiver during the session. The DCF was used to maintain structure and was also introduced to identify any psycho-social difficulties which could be addressed immediately.

168 Data Collection

169 Healthcare provider's observations of the counselling sessions

170

171 The healthcare providers (a social worker, counsellor or nurse) noted their observations on 172 the DCF after each disclosure counselling session for each participant (approximately 6 173 visits). This qualitative component relied on the healthcare providers' detailed observations 174 of the caregivers' and the children's responses and behaviour during the counselling 175 sessions. Any other relevant information that arose on the day was also recorded on this 176 form. 177 178 The DCFs provided healthcare provider perspectives and observations throughout each 179 stage of the disclosure process. There is little information in the literature regarding 180 caregivers' reactions to the disclosure process and it was felt to be a valuable addition to 181 the area of disclosure. As this could be considered to be subjective and from the 182 perspective of the healthcare provider it was felt that it would be pertinent to include the in-183 depth interviews in this study as they explored specific themes more deeply providing a 184 richness to this study.

186 **In-Depth Interviews**

An in-depth, structured interview guide was developed by the research team. Open-ended questions were used to elicit the perspectives of the caregivers on the disclosure process. The interviews were developed and formulated with the purpose of understanding the challenges and concerns caregivers had around disclosing to their children before joining the disclosure study; the disclosure process itself; and to identify any concerns and parenting challenges that may arise in the future. These interviews were conducted by a registered counsellor and research psychologist. The registered counsellor did the

psychometric assessments with the participants and had minimal contact with the caregivers. The research psychologist was not involved in the main study. The interviews took approximately 30-40 minutes to complete. Caregivers were interviewed primarily in English. However, questions were clarified and participants were able to respond in their language of preference (English, isiZulu or seSotho) and with their consent, audio recordings were made. The recordings were later transcribed and all transcriptions were translated into English for analysis.

201 Data Analysis

202 Information regarding barriers to disclosure, as well as observations relating to the

203 caregiver and their response to the intervention from both the DCF's and in-depth interview

transcriptions were analysed manually using content analysis. The analytic approach

205 included the development of a code book, reviewing of the codes, coding and interpreting

the data in order to describe, compare, categorise and conceptualise (35, 36).

207 Four analysists (a Clinical Psychologist, Psychiatrist, Research Psychologist and

208 Registered Counsellor) independently reviewed and familiarised themselves with copies of

209 the DCFs and interview transcripts. The analysts represented different cultural backgrounds

and ages, and counselling fields and areas of expertise. Thus being experienced in

211 interpreting subtle emotional nuances in responses and ensuring trustworthiness, credibility

and reliability in the data interpretation. This assisted with improving the likelihood that

213 cultural or training bias would unduly influence perceptions of results when coding data.

214 Furthermore, none of the analysts were counsellors in the study, reducing the likelihood of

215 bias when interpreting the data.

Initially, analysts working individually identified main ideas (meaning units) within the DCFs.
These identified meaning units were discussed in the group and once agreed upon, the
code book was developed. The data was then coded and codes of similar content or
context were grouped together. These codes and categories were again compared across

- analysts, merging common codes to formulate a single tabulation of categories.
- 221 Discrepancies were discussed until consensus was reached. The categories were used to
- re-evaluate the data and to quantify the frequency of categories noted. Themes were then
- 223 identified and the categories were grouped within the themes. The in-depth interview
- transcripts were treated independently, developing a separate code book and coding the in-
- 225 depth interviews after the analysis of the DCFs had been completed. Similarities and
- 226 differences between the two sets of data were identified and combined to provide a more
- 227 complete understanding of the caregivers' reasons for not disclosing to their children before
- joining the program.
- 229 Caregiver demographics were analysed using descriptive statistics.

230 Ethics/Protection of Human Subjects

- 231 Ethical approval to conduct this study was obtained from the University of the
- 232 Witwatersrand Human Research Ethics Committee (HREC, reference number 170107),
- 233 Johannesburg. Informed consent was obtained from all caregivers and assent was obtained
- from all child participants in the Disclosure Study.

235 **Results**

236 Study Population (See Table 1)

237 Thirty HIV positive child and caregiver dyads were enrolled into the study The median age

of the caregivers were 39.05 (IQR = 34-49). The majority of the caregivers (90%, 27/30)

- were biological parents and predominantly mothers (24 mothers vs 3 fathers), and the
- remaining 3 were grandmothers or aunts. However, during the study one father was unable
- to continue and the child was then accompanied by their mother; a second participant's
- 242 mother was unable to complete the study and the father attended the final counselling
- 243 session. In both cases this was due to employment commitments. Twenty-eight caregivers

- 244 were HIV-infected themselves and 27 were receiving ART. The majority of the adults were
- unemployed (67%) and 83% a secondary level of education.

- 249 Of the 15 caregivers who participated in the in-depth interviews, the majority were mothers
- 250 (13 mothers vs 2 fathers) with a median age of 38,08 years (IQR = 34-43). Thirteen of 15
- 251 caregivers had fully disclosed to their children by the end of the study. One participant
- 252 completed all study visits but due to their young age and insufficient concept
- 253 comprehension, the participant did not receive full disclosure. Moreover, the remaining
- 254 dyad discontinued the study prior to full disclosure.
- 255 Three central themes, related to the caregivers' experience of disclosure, emerged during
- analysis: their barriers towards disclosure; their reason for disclosing through the study; and
- the caregivers' response to disclosure.

258

259 1. The caregivers' reservations to disclosure of the child's

260 HIV status (See Table 2)

- 261 Caregivers were asked at the first disclosure counselling session what had prevented them
- from disclosing their child's HIV status to them. This open-ended question, recorded on the
- 263 DCFs, was identified as a central theme during the content analysis. These reasons were
- 264 further supported by the in-depth interviews. Three sub-themes were identified:
- 1.1) Caregiver practically ill-equipped to disclose
- 266 1.2) Fear
- 267 1.3) Lack of emotional readiness

277 1.1 Caregiver practically ill-equipped for disclosure

278 The most common reason for not disclosing (43%, 13/30 caregivers) was that they felt that 279 the children were still too young and that younger children would not be able to understand 280 HIV/AIDS. There was, however, no reference to a particular age at which the child would be 281 "ready" or why they thought the child wouldn't understand the information. Although the 282 caregivers indicated that the participants were too young to undergo disclosure, this was 283 better associated with the caregivers' own insecurities and inadequacies in their ability to 284 disclose to their children. During the interviews this was explored and caregivers gave age 285 ranges between 11-18 years as an appropriate age for disclosure as they would have a 286 better understanding of seriousness of HIV and the implications for their lives. 287 Almost three quarters (70%, 24/30) of caregivers felt ill-equipped to disclose, citing 288 challenges in communicating with their children about their illness. Eleven caregivers (37%, 289 11/30) reported a lack of confidence in their own HIV knowledge restricted their ability to 290 disclose to their children. Some caregivers did not know what and how much information to 291 share, and how much detail to include about the illness. Others were concerned that they 292 were uncertain of their ability to respond and/or handle questions that would arise after 293 disclosure. During the in-depth interviews, four of the 15 caregivers elaborated on this lack

294 of confidence in their HIV knowledge.

300 **1.2 Fear**

Fear was a common reason for not disclosing in 40% of the caregivers (12/30). This was

302 confirmed during the in-depth interviews. Fear of stigma, rejection from their child and fear

- 303 in itself were equally reported.
- Ten caregivers expressed fear of stigma. Five (50%, 5/10) had not disclosed prior to the
- 305 study because they were concerned about how others would react to the child disclosing
- their status; another two (20%, 2/10) expressed concerns about how family would react to
- finding out that the child was HIV positive; and three (30%, 3/10) were afraid of the child

308 being unable to maintain confidentiality ("keep the secret") about their status.

- 309 Fear of social stigma was also evident during the in-depth interviews where one of the
- 310 caregivers stated:
- 311 *"We were scared and afraid that he would go about talking about it in the neighbourhood.*

312 Scared of being stigmatised" (caregiver of participant 028, interview).

Furthermore, five caregivers (17%, 5/30) cited a fear of rejection from their children after

- disclosure. During the in-depth interviews, this fear of rejection was not only limited to the
- 315 caregiver being rejected by the child but also to the child being rejected by other family
- 316 members
- 317 "I was scared to tell him he is HIV+ because it is only him that is infected ... I thought that if
- the other two knew he was HIV they might distance themselves from him and not allow him
- to be part of them" (caregiver of participant 031, interview).

- 320 Generalised fear was observed in three caregivers (10%, 3/30), related to how the child
- 321 would react to being disclosed to (i.e. running away or responding negatively to the news).
- 322 Two other caregivers (7%, 2/30) were afraid to broach the subject of HIV and disclosure.
- 323 This was reiterated during the in-depth interviews where the caregivers spoke of being
- afraid to broach the subject and one expressed concern that disclosing to the child would
- 325 lead to worse consequences.
- 326 "How would I explain to him what is HIV? And what if he gets angry and kills himself"
- 327 (caregiver of participant 005, Interview).

328 **1.3 Lack of Emotional Readiness**

- 329 Guilt was the most common emotion preventing disclosure with caregivers describing
- 330 feelings of guilt at having infected their children with HIV. This was evident during the in-
- 331 depth interviews where some of the caregivers expressed their guilt and/or shame around
- 332 their children's status:
- 333 "Because I feel ashamed when I look at her always neh. And I was having that thought how
- am I going to tell her" (caregiver of participant 006, Interview)
- However, anxiety was only overtly observed in one caregiver (3%, 1/30) who appeared
- anervous about the child learning of her status.
- Almost 10% (9/30) of caregivers also felt the need to be emotionally prepared before
- disclosing to their children. This ranged from one caregiver not feeling "ready" to broach
- 339 disclosure to another who was still struggling with her own HIV diagnosis. Two other
- 340 caregivers had only recently discovered their child's HIV status when their child had been
- 341 admitted to hospital for illness. These caregivers were not emotionally prepared to address
- 342 disclosure with their children and later discontinued the study.

2. Reasons why caregivers chose to disclose through the

344 intervention

- 345 During the in-depth interviews the caregivers were asked what prompted them to participate
- in the Disclosure study. Two sub-themes were evident when analysing their answers:
- 347 2.1 To explain why the child was taking medication
- 348 2.2 The need for assistance in disclosing and normalising the situation

349 **2.1 Explanations for why the child was taking medication**

- 350 All participants in the disclosure study were on ARV treatment with the majority of the
- 351 participants having been on treatment for most of their lives. Out of the 15 caregivers
- interviewed, nine (60%) expressed that their children were asking why they were taking
- 353 medication.
- 354 "The reason I brought him to disclosure is that maybe he will get information about why he
- has to drink the pills and further tell him his HIV status" (caregiver of participant 005,
- 356 interview)
- 357 The lack of disclosure had led to caregivers misleading their children about the necessity
- 358 for the medication. Children were told that they were taking medication for ailments such
- as Asthma, Bronchopneumonia, TB, Bronchitis, Tonsillitis and for the flu. Additional
- 360 reasons included that they were health supplements and vitamins which would keep them
- 361 from falling down often, getting injured, and to help them grow bigger and/or stronger. The
- 362 caregivers also commented that at times their children would not adhere to the medicine
- 363 regime and "lie" about having taken their medication
- 364 "she would give me stories/excuses when she was supposed to take her medication"
- 365 (caregiver of participant 018, interview).

366 **2.2 The need for assistance in disclosing and normalising the**

367 situation

- 368 Seven of the 15 (47%) caregivers interviewed expressed a need for assistance from more
- 369 knowledgeable sources when disclosing to their children, as they, in particular the
- 370 healthcare providers, would provide the necessary objectivity, support, information and
- have the ability to normalise the situation.
- 372 "I also needed some external help, if I can say so, to make him feel there is nothing wrong
- 373 with whatever is happening or whatever is going on ... I needed someone to assure him,
- besides me, to assure him that all's good and that he's good." (caregiver of participant 001,
- 375 interview)
- By normalising the situation, the healthcare providers are able to put into words the fears and apprehensions the caregivers are experiencing. Through their understanding, support and ability to educate the caregivers, the caregivers are able to develop the ability to address disclosure with their children. Furthermore, the acceptance of status by both the healthcare providers and caregivers, as well as the knowledge that being HIV positive is not a death sentence or something to be ashamed about, assists the child in accepting their status.

383 3. The caregivers' response to the Disclosure program

- Throughout the study, the healthcare providers recorded their observations of how the caregivers responded to the various stages of the disclosure program on the DCFs.

390 Caregivers' response Pre-Disclosure

The response was perceived by healthcare providers to be both negative and positive with six caregivers (6/30, 20%) reported to be anxious, and five (5/30, 17%) being hesitant. On the other hand, five (5/30, 17%) expressed their happiness and appreciation to be part of the process.

395 Caregivers response during Full Disclosure

- 396 Negative responses were more evident than positive ones with the most common during
- this period being anxiety or unease (6/30, 20%). One caregiver's anxiety during this time
- 398 appeared to be counter-productive during the session, having a negative impact, instead of
- being calming and encouraging, the caregiver's own anxiety resulted in deflecting attention
- 400 from the participant at a crucial stage of disclosure to that of the caregiver.
- 401 However, some caregivers responded positively, encouraging and reassuring the child.

402 Caregivers response Post-Disclosure

403 At their post-disclosure visits, the caregivers had more positive (23%, 7/30) than negative

responses (7%, 2/30), including satisfaction with their child's progress. Others reported

relief that their children knew their status. One felt that the disclosure study was so helpful
that she even decided to disclose to her other child. Other observations made included
improved dyad relationships, understanding the importance of being responsible for the
administration of medication and good nutrition. However, two caregivers (7%, 2/30)
responded negatively, and were observed as being emotionally distant.

410 **Discussion**

411 This qualitative investigation described the response of caregivers to the disclosure process 412 aimed to assist them to disclose to their children's HIV+ status to them. Caregivers 413 indicated that, prior to the study, they were reluctant to disclose to their children due to 414 feeling ill-equipped to address the subject, being afraid and not being emotionally ready. 415 They were motivated to disclose during this study as medication adherence was becoming 416 problematic and they felt more comfortable with a healthcare provider present to assist with 417 disclosure and normalise the situation. Initially they presented as being both anxious and 418 grateful for the study. As the study progressed to full disclosure, many caregivers reacted 419 negatively with anxiety to the intervention. However, following full disclosure feelings of 420 relief and satisfaction with their child's progress was noted. This study also empowered a 421 caregiver post-disclosure to independently disclose to her other child.

422 The caregiver's attitudes towards HIV and HIV disclosure is shaped by their personal 423 experiences within the environment and the attitudes of those around them, as surmised by 424 social learning theory (27). This disclosure study allowed disclosure to occur in a contained 425 environment under the nurturing and non-judgemental guidance of the healthcare provider. 426 Healthcare providers modelled positive behaviours for both caregiver and child during 427 disclosure, and guided the caregiver on how to disclose. This made the process less 428 stigmatising, positive and open, and provided a safe space where trust was fostered. 429 Perceptions that HIV should not be stigmatising and allowing caregivers space to gain

430 confidence in their ability to manage disclosing to their children and also in talking about

431 their own status were reinforced.

432 The healthcare providers' ability to model healthy attitudes towards HIV and reduce 433 negative emotions around disclosure, taught caregivers how to model the same behaviour 434 for their children. This was especially evident in reflections from the caregivers where they 435 dealt with their own HIV status during the disclosure study. By applying social learning 436 theory, addressing the negative attitudes and stigmatization held within the wider 437 community the study could shift the caregiver's experience of their own disclosure, reduce 438 their anxiety and shame, and thus encourage more positive responses towards HIV self-439 disclosure. Through this, children may learn not to fear the disease, and have less adverse 440 responses when disclosed to (12, 39, 46). 441 Initially, many caregivers responded to the intervention with anxiety, concern that their 442 children were too young for disclosure, fear of negative consequences, as well as a lack of

443 confidence in their own knowledge of HIV. This is consistent with other studies (10, 23, 26,

444 41-45), indicating a need to address the stigma still highly present in our communities that

445 contributes to secrecy around HIV. The fear of stigma from others also leads to self-

stigmatisation, making it difficult for caregivers to accept their own diagnosis, and in turn

447 projecting that unacceptance and stigma onto their child (13, 23, 39). This emphasises the

need to equip healthcare providers to prepare and support caregivers throughout the

disclosure process (27, 28, 43, 44, 47).

Previous research cited the caregivers' fear of disclosure having a negative impact on children's mental health but once disclosed to, the child was described as having lower anxiety and depression scores (26, 29, 40, 41-46). Early research reflected the fear of dying, and the portrayal of HIV-related deaths in the media was seen as another barrier to disclosure (41, 42). However, medical advancements and wider accessibility to ART may explain why this was not seen in our study. Importantly, two caregivers only discovered

456	their child's status when the child was admitted to hospital for illness prior to joining the
457	PHRU Wellness Clinic shortly before the study began. Consequently, both discontinued the
458	study. This emphasises the need to ensure that caregivers feel supported and have
459	accepted their own diagnosis and that of their child before disclosure. It also stresses a
460	need for community education to reduce the spread of misinformation (13, 23, 39).
461	Non-adherence was the most prominent motivation to disclose in this study. Prior to
462	disclosure, caregivers would mislead their children about the need for medication and
463	deflect diagnosis to maintain adherence. However, caregivers noted that these strategies
464	were losing effect and realised the need to disclose. Improved adherence was noted in
465	several cases in our study. This with subsequent improvement in the child's wellbeing is in
466	keeping with previous findings (13, 39, 47-50).
467	The need to normalise the child's HIV status was another prominent motivating factor for
468	disclosure. This concurs with studies that reported that children deserve the right to know
469	their status (47, 49). Caregivers in this study stated that they required the assistance of the
470	more knowledgeable healthcare providers in disclosing and normalising HIV to their
471	children. Similarly, other studies have found that most caregivers either preferred

healthcare providers to disclose to their children, or required support from knowledgeable

473 healthcare providers during disclosure (4, 47, 50). This emphasises the significant role

474 healthcare providers play in the disclosure process and is in accordance with other

475 literature and recommendations made by WHO.

476 Given the barriers experienced by the caregivers prior to disclosure, an initial negative

response early in the disclosure process is not surprising. However, this sample of

478 caregivers had an almost equal number of negative and positive responses towards

disclosure initially. Post-disclosure found caregivers responding positively with satisfaction

480 and relief to the process. A sense of improved confidence, HIV knowledge and caregiver-

481 child relationships were observed. Healthcare providers played a critical role in supporting

482	the caregiver during disclosure, alleviating their anxieties and building their confidence.
483	Furthermore, improved communication also assisted caregivers in becoming more
484	comfortable talking about their own HIV status. Similarly, another HIV intervention study
485	reported caregivers felt that the program made equipped them better to answer questions
486	and to handle disclosure (51, 52).
487	Limitations in this study included: 1) positive responses may reflect a sampling bias, as
488	these caregivers were willing and open to participate in both the main study and the sub-
489	study. This could indicate a comfort and familiarity with the HIV clinic staff as most had
490	been attending the clinic prior to the study. 2) Caregivers may have also provided socially
491	desirable answers during the in-depth interviews due to familiarity with the interviewers from
492	interactions during regular clinic visits. 3) A wide range of emotional responses were also
493	not captured in the DCFs, a limitation when using observational reports. However, the in-
494	depth interviews that followed the disclosure program, did allow the researchers to gain
495	further insight into some of the DCF observations. 4) This study has a predominant female
496	perspective as most of the experiences and views were of female caregivers, and the
497	DCF's were completed and analysed by a female team. However, in many interventions
498	mothers are often the caregivers accompanying the child to the HIV interventions.
499	Regardless of these limitations, this study has added to the very limited literature regarding
500	caregiver's reactions during disclosure especially in South Africa where the largest

501 population of people living with HIV reside.

502 Understanding the reservations and motivations caregivers have towards disclosure can 503 make an impact in shaping future HIV disclosure interventions. Many disclosure studies 504 have focused on the children not their caregivers. This study suggests the need to design 505 interventions with support structures in place that assist the caregiver through the 506 disclosure process during and following full disclosure to the child. This study also 507 highlighted the need for caregivers to be educated on the benefits of disclosure and risks of 508 non-disclosure. Moreover, positive behaviours and attitudes modelled by healthcare

- 509 providers play a significant role in assuring the caregiver during disclosure, and can start
- 510 alleviating the effects of stigma from the community.
