# 1 Seroconversion rate and socioeconomic and ethnic risk factors for SARS-CoV-2

- 9 Abstract:
- 10 Introduction: Socioeconomic and ethnic background have been discussed as possible risk
- 11 factors for SARS-CoV-2 infections in children. Improved knowledge could lead way to
- 12 tailored prevention strategies and help to improve infection control.
- 13 Methods: Observational population-based cohort study in children (6mo. 18 ys.) scheduled
- 14 for legally required preventive examination and their parents in a metropolitan region in
- 15 Germany. Primary endpoint was the SARS-CoV-2 seroconversion rate during study period.
- 16 Risk factors assessed included age, pre-existing medical conditions, socioeconomic factors,
- 17 and ethnicity.
- 18 Results: 2124 children and their parents were included. Seroconversion rates among
- 19 children in all age groups increased by 3-4-fold from 06/2020 to 02/2021. Only 41% of

20 seropositive children were symptomatic. In 51% of infected children at least one parent was

- 21 also SARS-CoV-2 positive.
- 22 Low level of parental education (OR 3.13 (0.72-13.69)) significantly increased the risk of
- 23 infection. Of the total cohort, 38.5% had a migration background. Specifically, 9% were of
- 24 Turkish and 5% of Middle Eastern origin. These children had the highest risk for SARS-CoV-
- 25 2 infections (OR 6.24 (1.38-28.12) and 6.44 (1.14-36.45) after adjustment for other risk
- 26 factors.
- 27 Discussion: Seroprevalence of SARS-CoV-2 infections in children increased by 3-4-fold
- 28 within the study period. Frequently, more than one family member was infected. Children
- 29 from families with lower socioeconomic status were at higher risk. The highest risk for SARS-
- 30 CoV-2 infection was identified in families with Turkish or Middle Eastern background. Culture
- 31 sensitive approaches are essential to improve infection control and serve as a blueprint for
- 32 Vaccination strategies in this population. NOTE: This preprint reports new research that has not been certified by peer review and should not be used to guide clinical practice.

#### 35 Main text

#### 36 Introduction:

- 37 The rate of SARS-CoV-2 infections in children has been discussed controversially during the
- 38 first months of the pandemic. Children are frequently oligo- or asymptomatic and, therefore,
- 39 have been undertested and underdiagnosed. Seroconversion studies, however, reveal that
- 40 the rate of SARS-CoV-2 infections in adults and children are similar [1].
- 41 Most infections probably take place in households where contacts are most intense [2].
- 42 Cramped living conditions and poverty have been associated with a higher rate of SARS-
- 43 CoV-2 infection both in adults and children as well as increased morbidity and mortality [3,4] .
- 44 Ethnic origin has also been described as a risk factor for hospitalization for COVID19 in
- 45 children in the US [5,6]. Moreover, socioeconomic factors have been identified as risk factors
- 46 for SARS-CoV-2 infection [3,7].
- 47 This study in an unselected asymptomatic paediatric population in a Western German
- 48 metropolitan region with about 40% of families with migration background had been set up to
- 49 identify risk factors for SARS-CoV-2 infection in children and adolescents.

## 51 Methods:

52 Study design and participants:

In a standardized approach from 06/2020 to 02/2021 all asymptomatic children and 53 adolescents who attended outpatient paediatric practices in three regions of Western 54 Germany for scheduled mandatory routine examinations (U-Untersuchungen) from 6 months 55 to 18 years of age and their parents were invited to participate in the study. Participants and 56 their parents were asked to fill in a tablet-based guestionnaire available in 5 different 57 languages. Questions included former SARS-CoV-2 infections, medical history as well as 58 information on socioeconomic and migration background (Germany/Western Europe, Turkey, 59 Middle East, America, Eastern and Southern Europe, and Asia). Education level was defined 60 as the highest level of education of one of the parents/guardians. High level of education 61 included high school/grammar school (Fachhochschule/Abitur), medium level education 62 general secondary school (Realschule) and low-level education included education up to 63 primary school/basic secondary school (Grundschule/Hauptschule). No educational degree 64 formed a fourth group. Information on chronic diseases and medication was obtained from 65 parents and verified by matching with medical charts. 66

67 Serum samples were analysed for SARS-CoV-2 IgM and IgG antibodies (ECLIA, Roche).

- 68 The target variable was SARS-CoV-2 infection given by seropositivity or positive PCR test,
- 69 respectively. We aimed at comparing demographics (age, sex), underlying medical
- 70 conditions, socioeconomic and migration background between children and adolescents with
- 71 and without evidence of SARS-CoV-2 infection.

## 72 Statistical Analysis:

- 73 Descriptive statistics are depicted in tables 1 and 2. Demographic and clinical parameters
- 74 (table 1) are presented along with univariate odds ratios reported with 95% confidence
- 75 intervals. In addition, the impact of migration background has been analysed with adjusted
- 76 random effect logistic regression (cf. table 3). Thereby, we adjusted for the ratio of number of
- 77 available rooms to the number of persons living in the same household as well as for the
- 78 highest educational level within the family. The ratio has been introduced to account for the
- 79 correlation between number of rooms and number of persons following the rational that the
- 80 available space per person is the essential factor. Within the Corkid study, some families
- 81 participated with more than one child. Therefore, we included a random effect in our model
- 82 given by a family ID. Insignificance of other factors has been shown by a likelihood ratio-
- 83 based model reduction process. For the random effect analysis, the Ime4 software package
- 84 within statistical programming language R has been used [8]. P-values less than 0.05 were
- 85 considered statistically significant.
- 86 Results:

# 87 Demographics and Clinical Characteristics

- 88 In this cohort, initially 2848 children and adolescents were asked to participate, 25% refused,
- 89 mainly because of fear of drawing blood.
- 90 Of the remaining 2124 (1019 girls; 48%) with medium age 7.1 years [0.6-18], 58 (2.78%) had
- 91 evidence of SARS-CoV-2 infection. There were no clinical differences to SARS-CoV-2
- 92 negative children. Also, the number of children with pre-existing conditions (13% vs 18%) did
- 93 not significantly differ between the groups. 24 of the 58 infected children (41.3%) did not
- 94 recall any infection during the preceding three months.
- 95 Clinical characteristics of the participants are displayed in table 1.

## 98 Socioeconomic and migration background

- 99 Within the study cohort, 766 (38.5%) children and adolescents had a migration background
- see table 2). Whereas 4.5% of children and adolescents with a migration background had
- 101 evidence of SARS-CoV-2 infection, only 1.6% of children with Western European
- 102 background had evidence of infection (OR 2.78 [1.63-4.74]). Details of socioeconomic and
- 103 migration background of participants are shown in table 2a and table 2b.
- 104 A random effect logistic regression yields the results listed in table 3. Specifically, the highest
- 105 risks for infection were detected in children of Turkish (OR 6.24 [1.38-28.13], p=0.017) and
- 106 Middle Eastern (OR 6.44 [1.14- 36.45], p=0.035) origin, respectively.
- 107 In the Asian population seroprevalence was also high (OR 16.6 [1.07-250]), but because of
- 108 the small number of participants (1.4% of the cohort) from this region of origin this result
- 109 must be interpreted with caution.
- 110 Other risk factors relevant for risk adjustment, although below significance, included low level
- 111 education of the parents (OR 3.13 [0.72-13.69]) and crowded living conditions inversely
- 112 expressed by rooms per person (OR 0.35 [0.72-13.69]). Of note, these two factors turn out to
- 113 have statistically significant effects in univariate analyses (see table 3).

## 122 Discussion:

123 This large population-based study identifies seroconversion rates and risk factors for SARS-

124 CoV-2 infections in asymptomatic children and adolescents, attended legally required

- 125 preventive examinations. Our key findings are:
- less than half of seropositive participants of all age groups did recall symptoms of
   infection suggesting that more than half of SARS-CoV-2 infections go unnoticed [9].
- the incidence of SARS-CoV-2 infections is significantly higher in families of Turkish or
   Middle Eastern decent independent of other risk factors i.e. after adjustment for other
   socioeconomic confounders.

Our cohort had increasing seroprevalence rates from 0.5% in Mid-2020 to almost 6% in the
beginning of 2021 like other seroprevalence data from German or Swiss school cohorts
[10,11]. The dynamics in increase of seroprevalence of SARS-CoV-2 infections matches well
with national data of acute SARS-CoV-2 infection in the same geographic region [2,12]. As
shown before [2] infection rates have been comparable across all age groups in keeping with
the findings of other authors [1,6].

137 It is not surprising, that the known exposure to SARS-CoV-2 positive individuals doubled the

138 risk for seroconversion. In most families, at least one parent also has evidence of SARS-

139 CoV-2 infection, which is slightly more than described in other cohorts [13,14]. However,

140 50% of these SARS- CoV- 2 exposed children did not develop evidence of infection.

141

142 Recent study from the US state that socioeconomically disadvantaged children, especially

143 those from ethnic minorities, are at higher risk of infection [3,5,6]. Adult data from the UK and

144 the US also show increased morbidity and mortality from SARS-CoV-2 in adults from ethnic

145 minorities and with poor socioeconomic status. [4,7]. Limited access to healthcare systems

146 and migration background might also play a role in spreading the disease [15,16].

147 The most relevant risk factor for SARS- CoV- 2 infection in our study population is a Turkish

148 or Middle Eastern migration background. Although socioeconomic factors confound the

149 factor of migration history to some extent, our findings result from an adjusted regression

150 model and are therefore independent of educational standard and housing conditions.

Reasons for this observation could include different family and social structures favouring 151 closer contacts and therefore increasing the risk of transmission as described in a tight knit 152 Jewish Orthodox community in the US by Gaskell et al. [17]. Apart from that, language as 153 well as cultural barriers might play a role [7]. Visiting friends and relatives in countries with 154 155 higher incidence of infection might also further increase the risk. Scepticism regarding politics and health authorities are an additional issue, especially in prevention and vaccination 156 programs [1]. To approach these families, tailored, culture sensitive strategies need to be 157 developed and can serve as a blueprint for vaccination programs. 158

Limitations: Paediatric patients were recruited only from three regions (counties) in Western Germany and not all paediatric practices in the area participated. In addition, initially low seroprevalence rates could have introduced a bias. Genetic risk factors could predispose certain populations to infections with SARS- CoV-2, which was not considered in this study. The proportion of children from Turkish families, in contrast to those of other origins, was lower than expected at 9% (see table 1), whereas ca. 20% of the families in the regions studied are of Turkish origin. However, this rather indicates an underestimation of the true

166 infection rate in this group. Another limitation might be the use of surrogate parameters for

167 the assessment of living conditions and income like number of rooms etc. Different

168 educational grades might have posed difficulties in answering questions about educational

169 status and might have also led to an underestimation of the corresponding risk factor. We

170 attempted to reduce a possible bias through semi structured interviews to validate the

171 answers drawn from the internet-based questionnaire.

172

173 <u>Conclusions:</u>

174 This study shows that poor socioeconomic status and Turkish or Middle Eastern migration

175 background are independent risk factors for SARS-CoV-2 infection in a population-based

176 cohort of children and adolescents in Germany.

Targeted interventions and tailored prevention strategies in these groups are necessary to
improve infection control and to protect these vulnerable populations from excess morbidity
and mortality. They could serve as a blueprint for vaccination programs and there is need to
shift the focus of politics accordingly.
