

1 **Multiplex PCR Assays for Identifying All Major SARS-CoV-2 Variants**

Abstract

Variants of Concern (VOC) of SARS-CoV-2, including Alpha, Beta, Gamma, Delta, and Omicron threaten to prolong the pandemic leading to more global morbidity and mortality. Genome sequencing is the mainstay of tracking the development and evolution of the virus, but is costly, slow, and not easily accessible. A multiplex qRT-PCR assay for SARS-CoV-2 was developed, which identifies all VOC as well as other mutations of interest in the viral genome, eight mutations total, using single nucleotide discriminating molecular beacons in a two-tube assay. The presented variant molecular beacon assay showed a limit of detection of five copies of the viral RNA, with 100% specificity. Twenty-six SARS-CoV-2 positive patient samples were blinded and tested using this assay. When testing patient samples, the assay was in full agreement with results from deep sequencing with a sensitivity and specificity of 100% (26/26). We have used our design methodology to rapidly design an assay which detects the new Omicron variant. This Omicron assay was used to accurately identify this variant in 17 of 33 additional patient samples. These qRT-PCR assays identify all currently circulating VOC of SARS-CoV-2 as well as other important mutations in its Spike protein coding sequence. These assays can be easily implemented on broadly available five-color thermal cyclers and will help track the spread of these variants.

38 Introduction

39 The COVID-19 pandemic has changed the world, leading to at least 5.3 million deaths and many permanent
40 injuries, with over 271 million cases worldwide as of 20 December 2021

41 (<https://www.who.int/emergencies/diseases/novel-coronavirus-2019>, date of last access: 12/20/2021).

42 Despite advances in diagnosis and vaccination, the emergence of SARS-CoV-2 variants threatens to keep the
43 pandemic going¹. The World Health Organization and the US Centers for Disease Control (CDC)

44 (<https://www.cdc.gov/coronavirus/2019-ncov/variants/variant-info.html>), date of last access: 12/20/2021)

45 have identified SARS-CoV-2 Variants of Concern (VOCs), which lead to increased disease severity

46 (<https://www.gov.uk/government/publications/nervtag-paper-on-covid-19-variant-of-concern-b117>, date of
47 last access: 12/20/2021), increased transmission², and immune/vaccine evasion³⁻⁵. Variants of Interest (VOIs)

48 have also been identified that present theoretical risks because they possess mutations similar to the

49 mutations in the VOC. Specific frequently occurring mutations have also been identified which can affect

50 therapeutic antibody treatments for patients infected with such variants⁶. These new variants and

51 substitutions necessitate new tools for their detection and tracking⁷.

52 Currently, the most common technique to identify, classify, and track variants of SARS-CoV-2 is deep

53 sequencing^{8,9}. While sequencing is accurate and can identify each mutation present in a sample, it is costly,

54 slow, and requires specialized instruments and interpretation when compared to other genotyping

55 techniques, such as Polymerase Chain Reaction (PCR)¹. Although, PCR assays target preselected mutations,

56 they are cheaper and more accessible than sequencing for the genotyping of SARS-CoV-2, and they yield faster

57 results. These methods may permit better tracking of variants as they spread throughout populations over

58 time, especially in resource limited settings¹.

59 Several SARS-CoV-2 variant genotyping PCR assays have been developed. They utilize TaqMan probes as those

50 from Thermo Fisher Scientific (Waltham, MA), sloppy molecular beacon probes followed by melting temperature

51 analysis⁹, and several other strategies such as PerkinElmer's PKamp (Waltham, MA), and Aldatu Biosciences
52 (Watertown, MA). However, most of these assays either target single mutations per reaction or lack the
53 appropriate number of targets to thoroughly characterize SARS-CoV-2. Simple assays that detect multiple
54 mutations at the same time are needed for identification of circulating VOCs, VOIs, and for the identification
55 of specific mutations.

56 Our approach is to create a multiplex assay for SARS-CoV-2 variants by exploiting the superior selectivity and
57 self-quenching characteristics of molecular beacons. Molecular beacons can be designed to selectively bind to
58 a mutant target sequence, while avoiding the wild-type sequence, which differs from the mutant by a single
59 nucleotide substitution. The interaction of a molecular beacon with its target is inherently more specific than
60 linear oligonucleotides that do not have a stem and loop structure, because target binding requires the
61 dissociation of the stem, which is thermodynamically costly¹⁰. The utility of this discriminatory power has been
62 previously demonstrated in real-time PCR for a number of applications^{11,12}.

63 Here we present a two-tube multiplex qRT-PCR assay that identifies current VOCs by detecting eight different
64 mutations in the SARS-CoV-2 spike protein. We selected mutations that have been shown to increase immune
65 escape, avoid neutralization, and increase transmissibility. Targeting these causative mutations is fruitful,
66 because these strains may mutate and lose certain coincidental mutations, but mutations that increase
67 transmission and immune evasion are likely to be maintained. Also, by targeting these types of mutations, it is
68 possible to detect new variants that arise from combinations of previously confirmed mutations, as is the case
69 of VOC Omicron. We also describe a molecular beacon design process that can be used to rapidly produce
70 allele discriminating assays for new variants as they arise. As a proof of this design process, we created a new
71 assay within two weeks for accurately identifying the Omicron variant.

32 **Materials and Methods**

33 **Synthetic RNA targets**

34 RNA standards of the SARS-CoV-2 whole genome and variant spike proteins were provided by Exact
35 Diagnostics through Bio-Rad Laboratories, Hercules, CA (catalog numbers COV019, COV019CE, COVA, COVB,
36 COVE, COVG). Additional spike protein RNA sequences, such as those containing the E484Q and T478K
37 mutations and the omicron spike RNA, were generated from a double-stranded synthetic DNA (gBlock) from
38 Integrated DNA Technologies (Coralville, IA). A 5'-T7 promoter was appended to it, which enabled
39 transcription by T7 RNA polymerase, which was performed using the HiScribe™ T7 High Yield RNA Synthesis Kit
40 (New England Biolabs, Ipswich, MA). The RNA produced was purified with a Monarch RNA Cleanup Kit, 50 µg,
41 (New England Biolabs) and by denaturing polyacrylamide gel electrophoresis, eluting the band of correct size
42 in gel elution buffer (400 mM NaCl, 20 mM Tris-HCl (pH 8.0), and 1 mM EDTA). The concentration of the eluted
43 RNAs was determined by a NanoDrop spectrophotometer (Thermo Fisher Scientific).

44 **Primer Design**

45 Primers were designed by using the primer3 server¹³. 200 nucleotides surrounding the mutation of interest on
46 either side of the SARS-CoV-2 genome was used as input, the target-binding region of the molecular beacon
47 was used as the hybridization probe, and the amplicon size was set between 50 to 300 nucleotides. The
48 sequences of all the primers that were used in the assay are shown in Table 1.

49 **Design and characterization of single nucleotide discriminating molecular beacons**

50 A key consideration in the design of single-nucleotide discriminating molecular beacons is that the melting
51 temperature (T_m) of the probe-target hybrid with the perfect target (in the present case, the mutant
52 sequence) is minimally above, only 3 to 7 °C, the annealing temperature of the PCR (which is the temperature
53 at which fluorescence will be monitored). This makes it so that the mismatched hybrid (in the present case,
54 the wild-type sequence) will not appreciably bind to the molecular beacon at the fluorescence monitoring
55 temperature. Furthermore, the melting temperature of the stem of the molecular beacon should be above the
56 detection temperature.

07 We designed our primers so that they will function at the PCR annealing temperature of 58 °C. We selected a
08 region of sequence around the site of each mutation such that the T_m of the perfect probe-target hybrid was
09 above the annealing temperature, but that the mismatched single-nucleotide polymorphism had a T_m lower
10 than the annealing temperature. These T_m 's were predicted by using the DINAMelt¹⁴ two-state melting
11 hybridization server with the following parameters: 0.25 μ M oligonucleotide concentration, $[Na^+]$ = 60 mM,
12 $[Mg^{2+}]$ = 3 mM, for DNA at 58 °C.

13 After deciding upon the target binding region, a hairpin stem was created by appending 5 or 6 nucleotides on
14 either side (with 4 to 5 G:C pairs) such that they are complementary to each other, but not complementary to
15 the target. In addition, we ensured that the 5' nucleotide is not a guanosine, because that could lead to
16 fluorescence quenching due to the 5' position of the fluorophore. These sequences were then ordered from
17 either LGC Biosearch Technologies (Petaluma, CA) or from Eurofins (Luxembourg City, Luxembourg). They
18 were purified by HPLC through a PRP-3 Reversed Phase HPLC Column (Hamilton Company, Reno, NV) in a
19 Beckman System Gold HPLC System (Fullerton, CA). The desired fractions were then ethanol precipitated and
20 resuspended in water, and their concentration was determined by NanoDrop spectrophotometer. The
21 sequences of all molecular beacons that were used in the assay are shown in Table 1.

22 To determine if the designed sequences could sufficiently discriminate the alleles at the annealing
23 temperature of the PCR assay, we measured the fluorescence of the molecular beacons in the presence of
24 either a mutant target, a wild-type target or, no target, under the buffer conditions that are expected to be
25 present during PCR. Each 25 μ L thermal denaturation reaction contained 20 mM Tris-HCl (pH 8.4), 50 mM KCl,
26 1.5 mM $MgCl_2$, 1 μ M oligonucleotide target, and 0.4 μ M molecular beacon. The fluorescence intensity of each
27 reaction was measured at every degree in the appropriate fluorescence channel as the temperature was
28 lowered from 95 °C to 30 °C (decreasing 1 °C/10 seconds) in a Bio-Rad CFX96 Touch Real-Time PCR Detection
29 System.

30 Melt curve signals were normalized, for each molecular beacon. The difference between a normalization point
31 and the other melt curve fluorescent signals was subtracted from the raw fluorescent intensity values and
32 then all values in that channel were divided by the maximum intensity for that molecular beacon, to derive
33 relative fluorescence units, which range between 0 and 1. These data are shown in Figure S1.

34 **Optimizing the concentrations of the qRT-PCR multiplex primers and molecular beacons**

35 qRT-PCR was performed with TaqMan Fast Virus 1-Step Master Mix (No ROX) to optimize conditions, and
36 TaqPath™ 1-Step Multiplex Master Mix (No ROX) (both from Applied Biosystems, Waltham, MA) for final
37 experiments and patient samples.

38 Asymmetric PCR was performed for each amplicon, where the primer generating the strand complementary to
39 the molecular beacon (labeled reverse) was in 5-fold excess over the other primer (labeled forward). All
40 molecular beacons were designed in the same forward strand direction. G:T mismatches can be discriminated
41 from each other by switching the strand being interrogated to the complementary strand¹⁵. The molecular
42 beacon and primer concentrations were adjusted by trial and error, for sufficient amplification and signal. The
43 final working concentrations of each of the components for each tube are listed in Table 1 along with their
44 sequences.

45 Each reaction had a final volume of 20 μ L comprised of TaqPath or TaqMan Master 1-Step Mix (No ROX),
46 water, and primers and probes as previously described. 15 μ L of this complete master mix was pipetted into
47 each PCR tube, and then 5 μ L of sample was added and mixed, before running on the thermal cycler.

48 **Assay sensitivity and specificity**

49 The sensitivity of the assay was determined by preparing dilution series of *in vitro* transcribed targets, which
50 were diluted 10-fold from 1,000 copies/ μ L to 0.1 copies/ μ L. 5 μ L of each of these dilutions were combined
51 with 15 μ L of completed master mix per reaction. The tubes were sealed, briefly shaken, spun down at 800 g

52 for 1 min. and then run on a Bio-Rad CFX96 Touch Real-Time PCR Detection System with the TaqPath or
53 TaqMan Fast specified thermal cycler conditions, and with an annealing temperature of 58 °C. Specificity of
54 the assay was determined by comparing the known sequences of the *in vitro* transcribed targets with the
55 signals in these dilution series. For patient samples, sensitivity and specificity were determined by comparing
56 this assay's results to sequencing results, which are the gold standard.

57 **Collection of patient samples and sequencing**

58 Patient mid-nasal swabs were collected for clinical testing in 1 ml of DNA/RNA Shield Reagent (Zymo, Irvine,
59 CA). 400 µL aliquots were used for RNA extraction using the Kingfisher Flex magnetic bead extraction system
60 (Thermo Fisher Scientific) and the Zymo Quick RNA/DNA Magbead kit (Zymo) per manufacturer's instructions.
61 qRT-PCR screening was performed using 2 µL of purified RNA, TaqPath 1-step Multiplex Master Mix (No ROX)
62 and an in-house validated multiplex screening assay. This screening assay, outlined in Figure S2, detects
63 conserved sequences in the *N* and *RdRp* genes of SARS-CoV-2, along with human *ACTB* (*β-actin*) mRNA, with
64 high sensitivity. The primers and molecular beacons targeting regions in the *RdRp*, *N*, and human *ACTB* genes
65 were modified and adapted from previously validated assays¹⁶ ([https://www.cdc.gov/coronavirus/2019-
66 ncov/lab/rt-pcr-panel-primer-probes.html](https://www.cdc.gov/coronavirus/2019-ncov/lab/rt-pcr-panel-primer-probes.html)), date of last access: 12/7/2021), and are listed in Table 2. Samples
67 were run on a Quantstudio 7 (Thermo Fisher Scientific). Amplicon sequencing was performed using the Ion
68 AmpliSeq SARS-CoV-2 Insight Research Panel (Ion Torrent, Guilford, CT). Each library contained six samples,
69 one positive control sample and one no template control. Barcoded libraries were prepared using the
70 Ampliseq Kit for Chef DL8 and Ion 530 Kit-Chef (Ion Torrent). Sixteen libraries were combined to run on a
71 single Ion 530 chip. Templates were prepared using the Ion 530 Chef Reagents template kit. Sequencing was
72 performed on the Ion S5XL instrument with Ion S5 Sequencing Solutions and Reagents (Ion Torrent). Sequence
73 data was analyzed for on-target and mean depth of coverage using the SARS_COV_2_Coverage Analysis plug-
74 in v1.3.0.2 (Ion Torrent). FASTA files were created using the IRMA report plug-in v1.3.0.2 (Ion Torrent).

75 Sequence data and corresponding metadata were uploaded to GISAID and are included as supplementary
76 data. Aliquots of purified RNA samples no longer needed for diagnosis were deidentified and transferred to
77 Rutgers's laboratory for initial testing of the multiplex variant molecular beacon assay.

78 **RNA Purification from inactivated SARS-CoV-2 Virus**

79 10,000 copies of each inactivated Variant of Concern SARS-CoV-2 virus from ZeptoMetrix (Buffalo, NY)
80 (catalog# NATSARS(COV2)-VP) was treated with proteinase K in a 210 μ L reaction (1% SDS, 25 mM EDTA, 10
81 mM Tris pH8.3 and 20 μ g proteinase K (Thermo Fisher, catalog #25530049)) at 45°C for 30min, to decrosslink
82 the protein matrix entrapping the viral RNA. After the addition of 1-2 μ g of yeast carrier tRNA (Roche, Basel,
83 Switzerland, catalog #10109495001), purification of the RNA was performed using the QIAgen RNeasy Mini kit
84 (catalog #74104).

35 **Multiplex qRT-PCR with samples**

36 RNA purified patient and inactivated virus samples were tested in a similar manner to how we tested the
37 assay's sensitivity and specificity. 5 μ L of each sample was combined with 15 μ L each completed master mix
38 using TaqPath and run as mentioned before.

39 **qRT-PCR analysis and plotting**

40 Data generated from the CFX96 Touch Real-Time PCR Detection System was analyzed with Bio-Rad's CFX
41 Maestro Software Version 2.0, which corrects for fluorescence drift, subtracts the baseline, and fits curves to
42 each qRT-PCR signal. Threshold cycles (C_t) were determined via a manually specified single threshold of our
43 analyzed data, which was clearly above all negative control signals. For the specificity plots, fluorescent signals
44 were normalized by dividing all values by the highest fluorescent value in each channel for the respective
45 tubes.

46 **Results**

Design of a two-tube, eight mutation, multiplex qRT-PCR assay for SARS-CoV-2 Variants

In our assay, SARS-CoV-2 variants were identified by probing the coding region of the spike protein transcript for the presence of eight different point mutations, as detailed in Figure 1. Since only the mutants are expected to yield a positive signal, we included an additional set of primers and molecular beacons for a conserved region of the viral *N* gene in Tube one as a positive control for the presence of the virus. Since the multiplexing capacity of common thermal cyclers is 4 or 5 colors, we divided the assay into two tubes. The colors of the molecular beacons and the locations of the primers are indicated in Figure 1A. In Tube one, there were three amplicons, and in Tube two, all four targets were present in the same amplicon.

Even though individual isolates of each variant may possess other mutations, we focused on sets of mutations that are functionally the most important. By using *in vitro* binding and epidemiological data of how these mutations affect immune evasion and binding to the ACE2 receptor^{2-5,17,18}, we chose to identify the mutations shown in Figure 1: d69-70, K417N/T, L452R, T478K, E484K/Q, and N501Y. We also chose these mutations such that a single mutation in Tube one is sufficient to identify the VOCs, which of course is subject to change as the virus evolves. The mutations targeted in Tube two complete the identification of the VOCs and identify other common mutations, which are useful for identifying other variants.

The variant molecular beacon assay is specific for the identification of common SARS-CoV-2 variant mutations

Before assembling our multiplex assay, we designed molecular beacons for each targeted mutation, determined their thermal denaturation profiles, and tested them in monoplex PCRs. To determine whether the molecular beacons were allele discriminating at the annealing temperature, we determined the thermal denaturation profiles of the molecular beacons by themselves, and together with mutant or wild-type targets. In these experiments, the targets were synthetic oligonucleotides, and they were used in a molar excess above the molecular beacon concentration. A representative profile is shown in Figure 2, and the profiles of all the

20 molecular beacons are shown in Supplementary Figure 2. Although, the window of discrimination varies
21 somewhat from molecular beacon to molecular beacon, all of our molecular beacons permitted single
22 nucleotide discrimination (see Figure 3A). After qualifying the molecular beacons in this manner, we
23 performed a set of monoplex PCR assays for each mutation, using wild-type targets and mutant targets in
24 alternate reactions.

25 When all the monoplex reactions indicated successful amplification and allele discrimination, we assembled two
26 multiplex reactions that included all the primers and molecular beacons, as detailed in Figure 1. To demonstrate
27 the specificity of the multiplex assays, six pairs of reactions were carried out, in which each reaction received
28 5,000 copies of either the wild type, B.1.1.7 (Alpha), B.1.351 (Beta), P.1 (Gamma), B.1.427 (Epsilon), or E484Q
29 and T478K (Kappa/Delta)-containing spike RNA sequences. The targets were *in vitro*-transcribed RNAs
30 corresponding to a portion of the spike protein, or commercially available RNA standards, as detailed in
31 methods and in the legend to Figure 3. The results of these reactions are presented in Figure 3A, where the
32 targets are indicated inside the panels, and the color response of each molecular beacon is indicated by the
33 color of the line. This data shows that when the wild-type SARS-CoV-2 genome is present, only the *N* gene
34 positive control signal occurs. When testing spike RNAs containing the variant mutations, the correct mutations
35 were identified. For example, the Beta variant (B.1.351) contains not only the uniquely identifying K417N
36 mutation, but also the N501Y and E484K mutation.

37 **The variant molecular beacon assay can detect at as few as five copies of viral RNA**

38 To demonstrate the sensitivity of the variant molecular beacon assay, PCR assays were initiated with serial
39 dilutions of each target. The results are shown in Figure 3B. Each dilution series tested from 5,000 copies to
40 0.5 copies. Where a clear signal was present, the threshold cycle was determined by a manually identified
41 single threshold for each channel. Reactions starting with as little as five copies yielded a detectable signal in
42 each case. The correlation coefficients between the logarithm of the copy number and the threshold cycles in

each case are each greater than 0.98, showing a very strong exponential relationship between the two. These results also indicate that in Tube one, which contains four pairs of primers, the amplification of multiple different amplicons does not interfere with each other, which would diminish sensitivity.

Inactivated virus and patient sample strains of SARS-CoV-2 are accurately identified

After demonstrating the specificity and sensitivity of the variant molecular beacon assay with *in vitro*-transcribed RNAs, we performed this assay on RNA purified from inactivated virus obtained from ZeptoMetrix (Buffalo, NY). As can be seen in Figure 4A, our assay identified each of the mutations as listed in Figure 1B for the respective VOC. We next tested a set of patient samples (RNA extracted from mid-nasal swabs) that were SARS-CoV-2 positive, as identified by a multiplex screening assay, which we previously developed (Figure S2). After being identified as positive for SARS-CoV-2 by this assay, the samples were sequenced to identify all mutations present in the strains' genomes, this sequencing data is available online at <https://data.mendeley.com/datasets/v3n2dzt8st/1>. Afterwards, the RNA extracted from the samples were then provided to Rutgers in a blinded manner for variant identification.

These RNA samples were tested using the two-tube variant molecular beacon assay, as described above.

Figure 4B shows the threshold cycles for each molecular beacon target in each sample. All samples tested positive for the *N* gene positive control signal. Two samples were identified as the Alpha variant (B.1.1.7 with d69-70 and N501Y), two samples were identified as the Epsilon variant (B.1.427/429 with only L452R), eight samples were identified as the Delta variant (B.1.617.2 with L452R and T478K), ten samples had the E484K mutation, although not associated with any VOCs, and four samples had none of the targeted mutations and therefore are not any of the currently identified VOCs.

After strain identification was performed with the variant molecular beacon assay, the results were compared with sequencing data, which was in complete agreement. Our results indicate 100% sensitivity and specificity of the assay as tested so far. It is also notable that one of the samples possessed an L452Q mutation, which is

56 similar to the L452R mutation, but the L452R molecular beacon did not show a fluorescent signal due to the
57 L452Q mutation, further confirming the specificity of the results of our single nucleotide discriminating
58 molecular beacons.

59 **Design and implementation of an Omicron identifying molecular beacon assay**

70 The recent emergence of the omicron variant, which possesses over 30 mutations in the spike protein,
71 necessitates the design of a new identifying single nucleotide discriminating molecular beacon. Since a
72 number of Omicron mutations occur in the target regions of the two-tube assay, it is not feasible to
73 incorporate uniquely Omicron specific molecular beacons into the two-tube assay discussed above in a
74 straightforward manner. Therefore, a new two-color Omicron specific assay was designed by targeting the
75 E484A mutation, which is unique in the Omicron variant (represented in Fig. 5A), along with N gene detection.
76 Previous studies have also shown that this mutation is important for immune evasion¹⁹. The melt curve for the
77 designed molecular beacon is shown in Figure 5B, which shows high specificity for its intended target at the
78 annealing temperature of the assay of 58°C. Next the sensitivity was tested using *in vitro*-transcribed Omicron
79 spike fragment RNA, similar to what was done previously. The results in Figure 5C show the sensitivity to
80 detect 50 copies of the RNA target. The sequences of probes and primers are listed in Table 3 and the
81 amplicon schematic is shown in Figure 5A. This Omicron assay was tested against the other VOC sequences
82 and the results in Figure 5D show clear identification of the Omicron variant, with no signals from any other
83 target sequences. We then tested thirty-three recent patient samples identifying seventeen of them as
84 Omicron (Figure 5E). These samples were also analyzed using the TaqPath COVID-19 Multiplex Diagnostic
85 Solution assay (ThermoFisher, Waltham, MA) in which Omicron variant fails to produce a S gene specific signal
86 because one of the primers binds in the Omicron variant's d69-70 mutation. This S gene dropout data was
87 provided to Rutgers in a blinded manner and upon comparison it was found to be in complete agreement,

38 indicating high accuracy of our assay. However, in contrast with TaqPath COVID-19 Multiplex Diagnostic
39 Solution assay our assay yields a positive signal for a unique mutation in the Omicron variant.

30 Discussion

31 Molecular beacons designed to differentiate point mutations are an ideal tool for genotyping on a global scale
32 due to their ease of design and production. In the case of newer emerging variants, molecular beacons can
33 quickly be synthesized and validated for that variant's identification, which can help to monitor strains, and
34 improve patient care via epidemiological tracking. Utilizing the outlined strategy, molecular beacons for new
35 targets can be designed and added to the assay in two or three weeks. This assay not only enables the
36 identification of the four variants of concern and many variants of interest, but since it targets many known
37 mutations that confer increased transmission and immune evasion, it will be able to identify new variants that
38 recombine with existing mutations. An example of the assay's ability to pick up newer variants lies in the Delta
39 variant's mutations, which include the L452R mutation that is also present in the Epsilon variant as can be
40 seen in Figure 1B.

41 Due to the specificity of the molecular beacons, other mutations in the target region do not elicit false-positive
42 signals. Evidence of this is found in the lack of signal in one of the samples which contained the L452Q
43 mutation, as identified by sequencing. More evidence of the specificity is in the clean differentiation of the
44 K417T and K417N mutations, as well as the E484Q, E484K, and E484A mutations, where these signals only
45 become positive in the presence of their respective mutations. This specificity enables precise identification,
46 but also comes with the downside that mutations in the binding region of the molecular beacon could result in
47 false-negative signals. Despite this, if other mutations do arise near the uniquely identifiable mutations, such
48 as in the case of the Omicron variant, this can be accounted for by either designing different molecular
49 beacons, or by introducing degenerate nucleotides into the current molecular beacons.

L0 This study is limited by the number of patient samples tested. In the cases where a variant harbors multiple
L1 mutations in the target regions of molecular beacons of the two-tube assay, false negatives may result due to
L2 the high specificity of molecular beacons. However, in such situations a completely new assay can be easily
L3 assembled with equal ease as was demonstrated in the case of Omicron variant in Figure 5.

L4 This assay introduces the sequences of many useful molecular beacons for the identification of point
L5 mutations in SARS-CoV-2. These variant molecular beacon assays are most useful as a screening tool for
L6 positive SARS-CoV-2 patient samples which can identify all major VOC (see Figure 1B). The primers and
L7 molecular beacons can also be combined in varying combinations to test for other pathogens, they can be
L8 added to current assays, and they can be used with human RNA controls as were added in the multiplex
L9 COVID-19 multiplex screening assay (see Supplementary Figure S2). These assays can then be used to test for
L10 the most common variants in a region or to directly test human samples as a single pathogen/COVID-19
L11 variant identification test in general practice.

L12 Here we describe multiplexed molecular beacon assays for the classification of SARS-CoV-2 variants via their
L13 identifying functional mutations. We have shown that the assay clearly differentiates between the different
L14 SARS-CoV-2 variant sequences, and accurately classifies patient samples that have been identified by deep
L15 sequencing technologies and S gene dropout assays. All primer and probe sequences used in this assay are
L16 listed in Tables 1 and 3 to facilitate SARS-CoV-2 variant genotyping on a larger scale, and to address the public
L17 need for variant tracking.

33 **Figure 2. –** The florescence of the T478K discriminating molecular beacon, as a function of temperature, in the
34 presence and absence of targets. When no target is present, dotted line, the fluorescence increases as
35 temperature rises due to the helical order of the stem giving way to a random-coil configuration, separating
36 the fluorophore from the quencher, and resulting in fluorescence. When the molecular beacon binds to its
37 target its stem dissociates which turns on its fluorescence. Due to the higher binding strength of the perfect
38 probe-target hybrid, solid line, compared to the imperfect probe-target hybrid, dashed line, the imperfect-
39 probe target hybrid dissociates at a lower temperature. The PCR monitoring temperature (58°C) is indicated
40 by the vertical dashed line and the window of good discrimination by the shaded area.

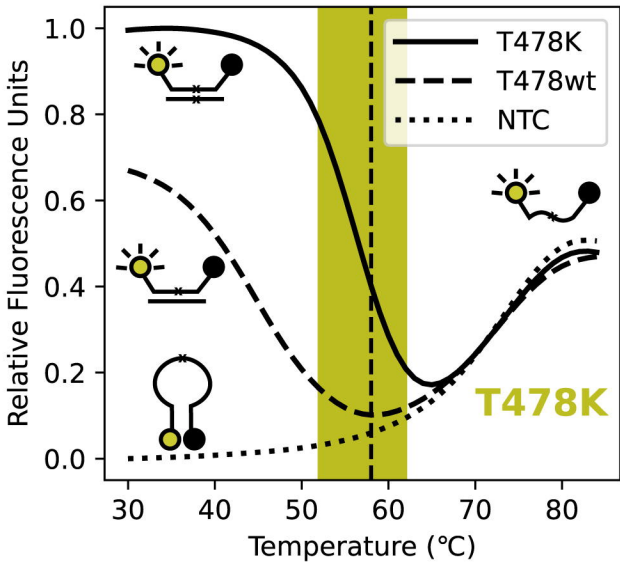

48 and T478K mutations, which are from the B.1.617 (Kappa) and B.1.617.2 (Delta) variants. This Kappa/Delta

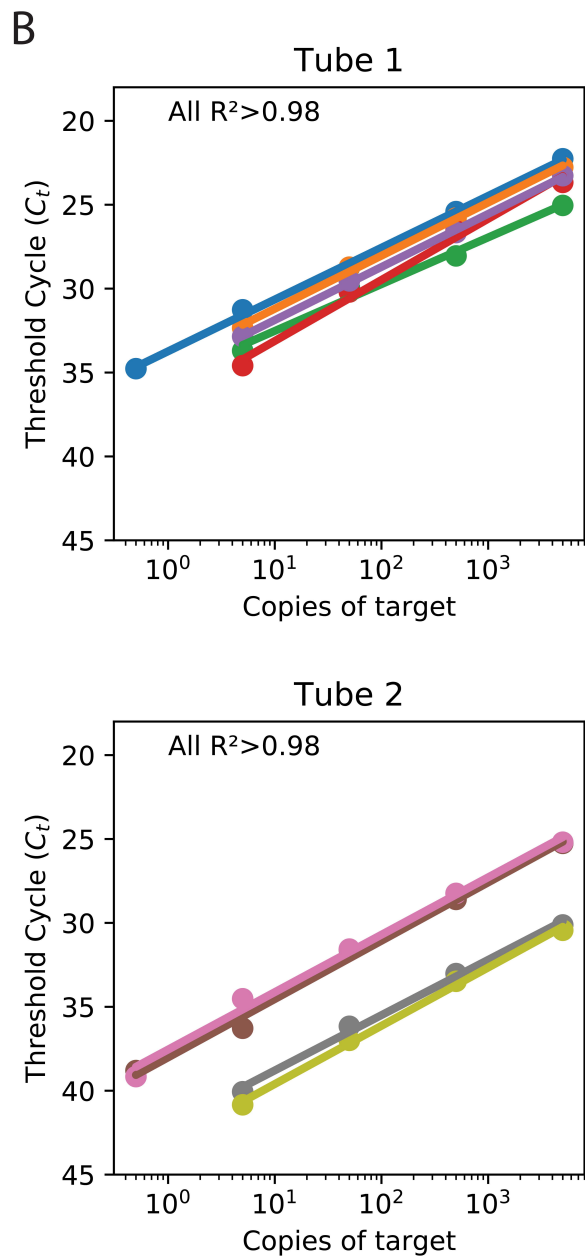
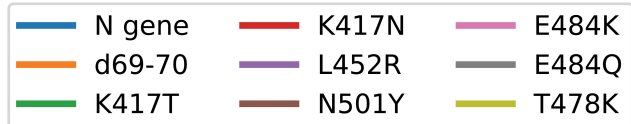
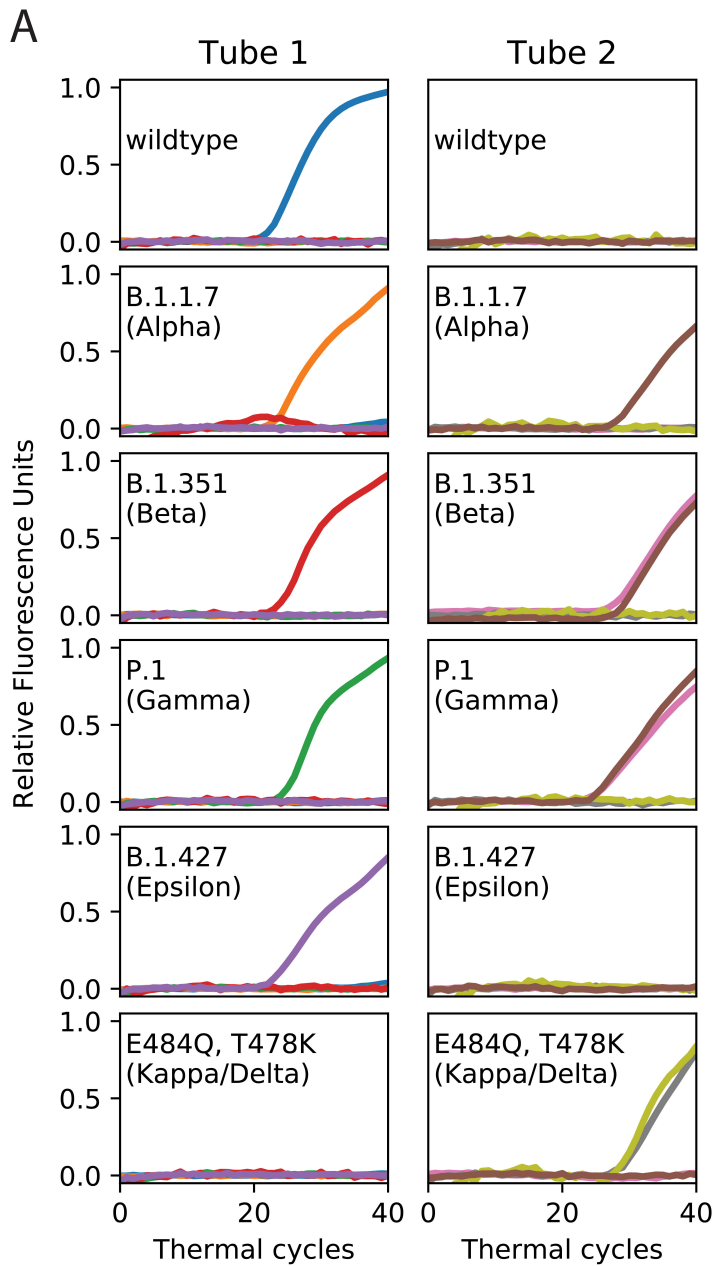

49 Spike RNA fragment was generated and used due to the lack of commercially available *in vitro*-transcribed
50 RNA's at the time. **B.** Sensitivity analysis was run by diluting templates containing the specified mutations from
51 5,000 copies down to 0.5 copies per reaction. The C_t values are plotted against the template copy number and
52 the correlation coefficients of the natural log of the copy number to the C_t are greater than 0.98 for all
53 amplification products, with around a 3 C_t delay between 10-fold dilutions, both as expected.

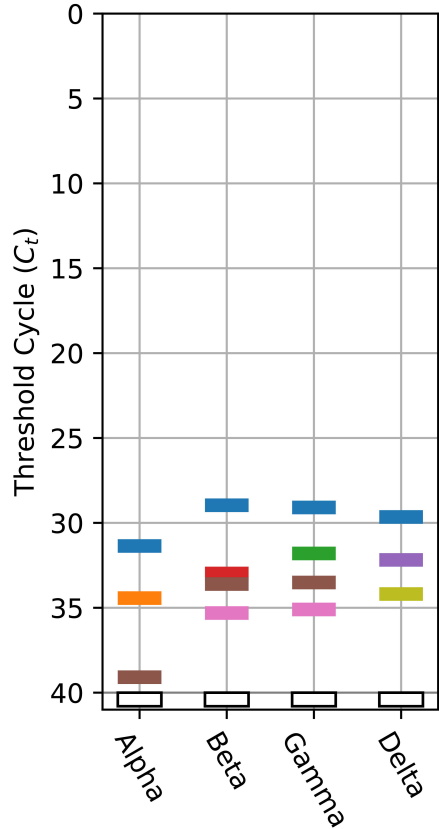

56 Virus samples. All VOC virus samples tested were accurately identified as shown in Figure 1B. **B.** Patient

58 indicates the presence of the specified mutation, which can be used to identify the variants of the virus. For
