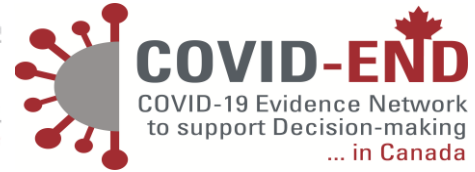

Abstract

Context. More than 18M people worldwide (150K Canadians) are living with Long COVID resulting in debilitating sequelae and disabilities that impact their quality of life and capacity to return to work. A new care model is needed for persons living with this complex and multi-systemic disease.

Objectives: What is the best-available evidence about care models for persons living with Long COVID?

Design: Rapid Living Systematic Review.

Method: We systematically searched seven electronic databases (MEDLINE, Embase, Web of Science, COVID-END, L-OVE, CDRS and WHO Ovid) on May 27th, 2021. Two independent reviewers screened titles, abstracts and full text. We included studies reporting on 1- persons living with Long COVID and 2- proposing a specific care model (i.e., dedicated clinic, care pathway). We extracted characteristic of studies (e.g., countries, study design, age group), referral pathways targeted (e.g., hospitalized, community), reporting of the care model implementation with number of patients, clinical settings of care model (e.g., primary care), healthcare professions included in the care model, care model principles (e.g., person-centred care) and care model components (e.g., standardized symptoms assessment). We used descriptive statistics and frequency count.

Results: We screened 2181 citations, read 65 full text and included 12 eligible articles reporting on care models for Long COVID. Half studies were from the United Kingdom. 7 out of 12 models reported conceptual models without a description of implementation. All but one model was designed for discharge and long-term follow-up of hospitalized patients and half models were designed for non-hospitalized or patients who lived with the disease only in the community. Nine out of 12 care models included primary care, 8 out of 12 included specialized clinics and all studies included rehabilitation services. A total of 30 healthcare professions and medical specialties were proposed for staffing Long COVID services. More than half studies proposed multidisciplinary teams, integrated/coordination of care, evidence-based care and patient-centred care as key care model principles. Standardized symptom assessment, follow-up system and virtual care were the most frequent care model components.

Conclusion: The implementation of care models for Long COVID is underway in several countries. Care models need to include both hospitalized and non-hospitalized patients. A complete care model for this population appears to design a care pathway integrating primary care, rehabilitation services and specialized clinics for medical assessment. The entry into care pathways is likely possible through a centralized referral system. It is possible to design sustainable and equitable care pathways for Long COVID in Canada integrated in current infrastructure.

Care Models for Long COVID : A Rapid Systematic Review

Summary

An estimated 150K Canadians, mostly women, are facing debilitating sequelae and disabilities from Long COVID that impact their quality of life and capacity to return to work. A new care model is needed for persons with this complex and multi-systemic disease. We identified international care models describing the integration of primary care, rehabilitation services and specialized assessment clinics for Long COVID.

Implications

Limited evidence from this review of international care models for Long COVID point out to a care model for the Canadian context that should be co-designed with patients, clinicians, decision makers and researchers, and include: 1- A coordination unit to centrally receive referrals from both hospitalized and community-based patients; 2- Training of primary care teams to screen and support medical needs; 3- Integrated local multidisciplinary rehabilitation services; and 4- Access to medical specialty clinics for advanced testing and diagnoses.

What is the current situation?

- More than 150K Canadians are with living the affliction of Long COVID, the patient-led term to describe long-term consequences of COVID-19. Long COVID is a multi-systemic and unpredictable disease impacting quality of life and return to work in middle aged population. To avoid widespread long-term disabilities impacting public health, Canadian provinces are seeking to organize a sustainable and equitable care model for Long COVID.

What is the objective?

- To provide the best-available evidence about care models for persons living with Long COVID.

How was the review conducted?

- We systematically searched seven electronic databases (MEDLINE, Embase, Web of Science, COVID-END, L-OVE, CDRS and WHO Ovid) on May 27th, 2021.
- Two independent reviewers screened title, abstract and full text.
- We included studies reporting on 1- persons living with Long COVID (post-hospitalized and community based) and 2- a specific care model (i.e., dedicated clinic, care pathway).
- We extracted characteristic of studies, referral pathways, clinical settings of care model, healthcare professions included in the care models, care model principles, care model components and reporting of the care model implementation.

What did the review find?

- We found 12 international care models for Long COVID that covers follow-up of patients discharged following a hospitalization and patients who had lived the infection in the community.
- Most reported elements included in these care models were a coordination unit, primary care pathways, access to multidisciplinary rehabilitation and specialized medical services.
- The impact and costs of these care models are not yet reported.

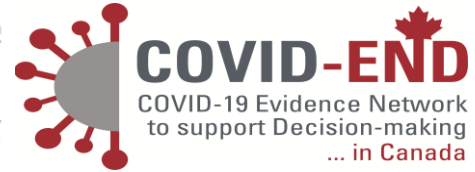

Context

Even if the pandemic ended today, more than 18M people worldwide (150K Canadians) would still be living the affliction of Long COVID, the patient-led term to describe long-term consequences of COVID-19. Long COVID translates into symptoms that develop during or following an infection from COVID-19 and continue for 4 weeks or more^{1,2}. Update from the Office of National Statistics in the United Kingdom on April 1st, 2021, shows that 13.7% of all cases will exhibit symptoms longer than 12 weeks³. The extensive online survey of Patient-Led Research for COVID-19 marked a turning point: 3,762 people living with Long COVID described more than 50 symptoms over 10 body systems that persisted over 6 months⁴. All patients, hospitalized or not, are at risk of developing debilitating sequelae and many continue to experience complex symptoms 12 months after the infection with uncertain prognosis⁴⁻⁶.

In Canada, specialized post-COVID clinics are a rare occurrence. Primary care is in a precarious state and regions lack knowledge and organizational readiness. Physicians and nurses are often untrained to diagnose and refer patients to appropriate services. Community-based physical and occupational therapists are frequently unaware of safety issues regarding rehabilitation after COVID-19. On June 10th, 2021, the CIHR Knowledge Mobilization Forum "Moving Forward Together: Recognizing Lived Experience, Optimizing Appropriate Rehabilitation and Enabling Research on Post COVID-19 Condition ('Long COVID') in Canada" taught us the experience of care from persons living with Long COVID: stigmatization by clinicians, financial insecurity, lack of recognition by insurances and fearful prognosis. People with Long COVID need patient-centered and evidence-based care to prevent long-term disabilities. A new care model for the Canadian context is needed for persons with this complex disease⁷.

Research question

What is the best-available evidence about care models for persons living with Long COVID?

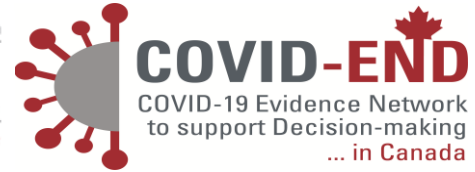
Methods

We performed a rapid systematic review following the Joanna Briggs Institute's Manual for Evidence Synthesis⁸ and report our findings according to the PRISMA guidelines⁹.

Literature Search

We systematically searched seven databases: MEDLINE, Embase, Web of Science, COVID-END, L-OVE, CDSR, and WHO Ovid. An experienced medical information specialist (Skidmore) developed and tested the search strategies through an iterative process in consultation with the review team. Using the multifile option as well as the deduping tool in Ovid, we searched Ovid MEDLINE®, including Epub Ahead of Print, In-Process & Other Non-Indexed Citations, and Embase Classic+Embase. We also searched Web of Science (Core Collection) and the Cochrane Database of Systematic Reviews. We completed a rapid grey literature search by scanning key healthcare organizations' websites (ex: NHS) to identify unpublished care models for Long Covid. We executed all searches on May 27th, 2021.

The search strategy included terms related to 1- Long COVID and its currently known variation (e.g., post-Covid syndrome) and 2- Care models (e.g., clinics model, pathways). We used a mixture of



controlled vocabulary (e.g., “COVID-19”, “Long Term Adverse Effects”, “Recovery of Function”) and free-text terms (e.g., “long COVID”, “longhaul”, “chronic symptoms”) and applied filters for care models. We did not apply any date or language restrictions. See Appendix 3 for a copy of the search strategies as executed. We downloaded and deduped the records using EndNote 9.3.3 (Clarivate) and uploaded to DistillerSR (Evidence Partners).

Eligibility Criteria

Our inclusion criteria (PICO) were as followed:

-
- Population:** Persons living with Long COVID (children and adults) or healthcare professionals managing Long COVID. We included all definition of persistent symptoms of COVID-19 (e.g., post-COVID syndrome).
- Intervention:** Care models (including pathways, trajectories, frameworks or structured clinics) to organise health care services for Long COVID.
- Comparator:** Natural recovery, usual care models, inter-jurisdiction models comparison if available.
- Outcomes:** Any outcomes or specifically system-level outcomes (e.g., cost, access, quadruple aim), patient-level outcomes (e.g., specific PROMS related to symptoms), clinician-level outcome (e.g., satisfaction with the care pathways).
- Study design:** Any design.
- Settings:** Any setting.

Study Selection

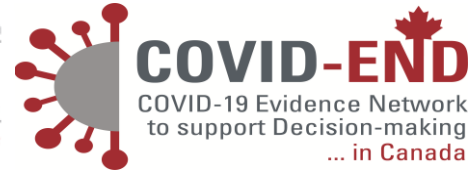
We developed and pilot-test standardized forms for titles & abstracts and full text screening. Study selection was conducted by pairs of two reviewers independently. Discrepancies were resolved by discussion or by a third senior reviewer. We conducted a pilot exercise with 10 citations for each phase.

Data Extraction

We developed a standardized form for data extraction, which we piloted on 3 articles. All data was extracted by one of two reviewers and a third reviewer verified all extracted data. Discrepancies was resolved by discussion or by a third senior reviewer. We extracted characteristic of studies (e.g., countries, study design, age group), targeted referral pathways (e.g., hospitalized, community), reporting of the care model implementation with number of patients, clinical settings of care model (e.g., primary care), characteristics of the care model (ex: funding, staffing, etc.), healthcare professions included in the care models, care model principles (e.g., person-centered care), care model components (e.g., standardized symptoms assessment) and any collected outcomes.

Risk of Bias Assessment

As a rapid review, we identified and described best evidence of care models. We did not completed risk of bias assessment since most studies were conceptual papers.



Data Synthesis

We analyzed the extracted data using a traditional content analysis and performed a thematic analysis to classify emerging themes regarding best practices surrounding care models (see definition in Appendix 2). We present our results in a narrative format.

Stakeholders' Engagement

Three knowledge users from the Alberta Health Services actively participated in this rapid review. They were involved in defining the research topic and objectives. They received a weekly update via email communications. We engaged one patient-partner who helped reviewed the PICO, data extraction, reporting and read all final material.

Results

Literature Search

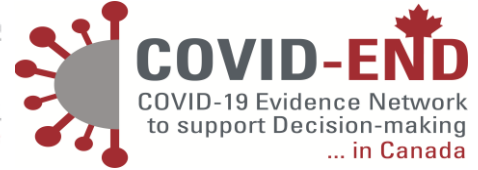


Figure 1. PRISMA Flow Diagram

We identified 2184 citations, screened 1806 titles and abstract, 65 full text and included 12 articles reporting on care models for Long COVID (Figure 1) ¹⁰⁻²¹.

Characteristics of Included Studies

Of the 12 included studies (Table 1), six were from the United Kingdom and three from the United States. Seven were descriptive studies of care models concepts, two were literature review with a proposed model, one was a qualitative study, one was a cross-sectional survey and one study reported a service evaluation of a proposed post-Covid clinic. All studies reported on adult population and one model included children. All studies covered care models for post-hospitalized patients and six studies further reported on care models for patients in the community. Seven studies reported having implemented their care model in clinical settings. All studies included rehabilitation services, nine integrated primary care and eight had a specialty care component.

Care Models Principles

We identified a total of 22 different principles (Table 2). The five most common principles included multidisciplinary teams (92%), integrated care (67%), self-management (58%), coordination of care (58%) and evidence-based care (58%).

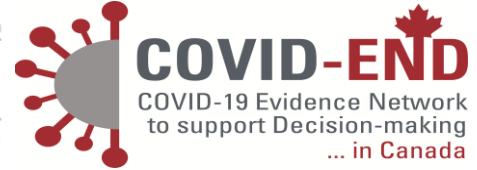
Care Models Components

We identified a total of 10 distinct care model components (Table 3). The five most common components included standardized symptom assessment (92%), referral system (83%), follow-up system (83%), virtual care (83%), and home-base care (58%).

Healthcare Professionals and Medical Specialties Included in Care Models

We identified all healthcare professionals and medical specialties included in care models (Table 4). The ten professionals most embedded in these models included pulmonary/respiratory specialists (100%), cardiovascular specialists (92%), psychiatry and psychology (83%), physiotherapy (83%),

occupational therapy (75%), social work (75%), neurology specialists (75%), primary care physicians (58%), nutrition (58%) and speech and language therapists (50%).

Impact

None of the included studies provided impact analysis. *Heightman et al.* conducted a service evaluation of the first 12-month experience of the first UK dedicated post-COVID clinic in the United Kingdom. Their analysis is limited to healthcare utilization (e.g., diagnostic tests) of 1325 assessed individuals and showed similar rates of onward specialist referrals between non-hospitalized and hospitalized patients and incapacity of 50% of the cohort to return to work full-time at their first assessment.

Costs

The “National guidance for post-COVID syndrome assessment clinics” from the United Kingdom is the only included reference to document a nation-wide investment in Long COVID care. The total investment to set-up 89 post-Covid clinics was £34 million (58.5M\$CAN) between December 2020 and April 2021. A new guidance document (unreported at the time of our search strategy) providing cost to extend services in the United Kingdom model is explained below.

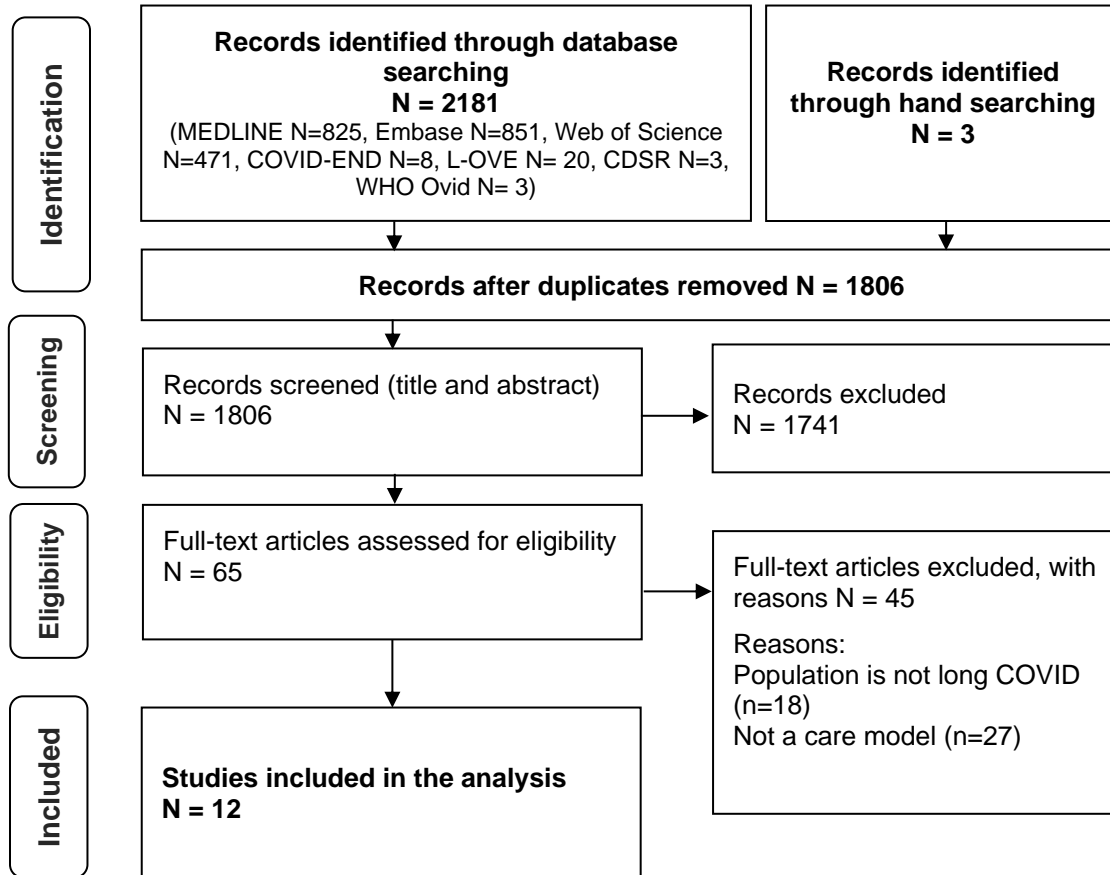

Discussion

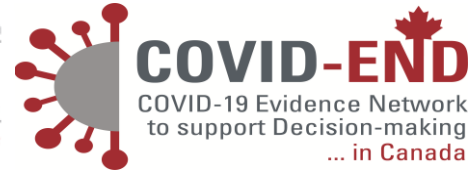
The objective of this rapid systematic review was to describe the best-available evidence about care models for persons living with Long COVID. We found 12 international care models that followed patients discharged following a hospitalization and patients who had lived the infection in the community. The most reported elements in these care models included coordination units, primary care pathways, access to multidisciplinary rehabilitation and specialized medical services. The impact and long-term costs of these care models are not yet established. Overall, evidence remains scarce.

Initial care models that emerged in the early months of the pandemic were centered on “post-COVID clinics”^{10, 13, 14, 22}. These clinics were vital in the ecosystem for Long COVID as they allow specialized assessment and act as a gateway for medical diagnoses. Unfortunately, shortcomings started appearing such as long waiting lists, difficulties training clinicians, barriers to access for patients with fatigue living outside city areas, absence of integrated multidisciplinary rehabilitation and long-term funding sustainability, warranting a more integrated care model for Long COVID. Critical and central to this proposed integrated care model was primary care^{13, 22-27}.

While we identified frequent care model principles and components, most were not thoughtfully described, limiting our understanding of the underlying structure to be put in place. Particularly, most model proposed a place for primary care for the long-term management of Long COVID without describing its execution. This further creates uncertainties around impact and cost, and how to appropriately implement and scale-up these care models. Future research will need to describe and demonstrate how each proposed principles and components are implemented and link to observed outcomes. Furthermore, only a small sample of studies reported estimated costs of these care models. This lack of information prevents from determining the impact and cost-effectiveness of implementing these models.

A wide diversity of healthcare professionals and medical specialties have been proposed to care for Long COVID. While we observed trends concerning the commonly proposed team members to care for Long COVID, identifying a more defined core will be essential to designing a care model that is efficient, feasible, and scalable. Indeed, some models presented advocated for the inclusion of numerous (>10) medical specialists and health professionals in the care of a patient, which with the current health setting and staff shortage may render such model unfeasible. Future research should aim to determine the exact implication of each proposed healthcare professions and the parameters of their implication in the care models (i.e., objective of the role, number of interventions).

Lastly, quality standards for patient-centered care were proposed throughout the identified models, highlighting the need for and importance of high-quality and personalized care. Unfortunately, these standards were not operationalized nor measured in the reported models. Identifying processes and outcomes that matter to patients suffering from Long COVID and are centered around their goals toward recovery will be critical.



Limitations

As a rapid review, we did not search all available databases and grey literature and some existing care models may have been missed. The search strategy was not duplicated by a second information specialist and may have missed relevant articles. We did not conduct a systematic risk of bias appraisal as most included article reported only descriptive and conceptual underpinnings of care models for Long COVID.

Contextualization

As June 18th, 2021, the province of Alberta had 231K cases of COVID-19. Given conservative estimates that 13.7% of cases will continue to experience persistent symptoms impacting quality of life for at least 12 weeks, the Alberta Health System could face a surge of 32K cases of Long COVID. Many of these patients may require care for at least one year.

Unfortunately, at this point in time, the evidence regarding best practices and effectiveness of care models for Long COVID remains scarce. Based on our limited findings and the current context that warrants immediate action, the Alberta Health Services could invest in the co-design with patients, clinicians, decision makers and researchers of a care model for Long COVID integrated in its current infrastructure. The care model could include four elements: 1- A coordination unit to centrally receive referrals from both hospitalized and community-based patients (e.g., leverage AHS's centralized phone infrastructure with proposed standardized assessment instead of dedicated new clinics as access points (UK model)), 2- Training of primary care teams to screen and support medical needs, 3- Integrated local organization of multidisciplinary rehabilitation teams and 4- Access to medical specialty clinics for advanced testing and diagnoses. These four elements can work as a network putting the needs of each person living with Long COVID at the center. The Infographic (next page) schematize this possible care model. As for cost, the United Kingdom announced a total investment of 230M\$CAN to care for an estimated 1.1M Long COVID cases. At scale for Alberta, projections could require a 6.7M\$ investment for 2021-2022 fiscal year.

APPENDIX 1 - Inspiring Practices Showcase

Our review presents a descriptive overview of international care models for Long COVID. Here we provide more detailed vignettes of key care models specifically for primary care, rehabilitation services and post-discharge speciality clinics.

The NHS Post-COVID-19 Clinics

Country: United Kingdom.

Description: Nationwide integrated care pathways that include post-COVID-19 assessment clinics.

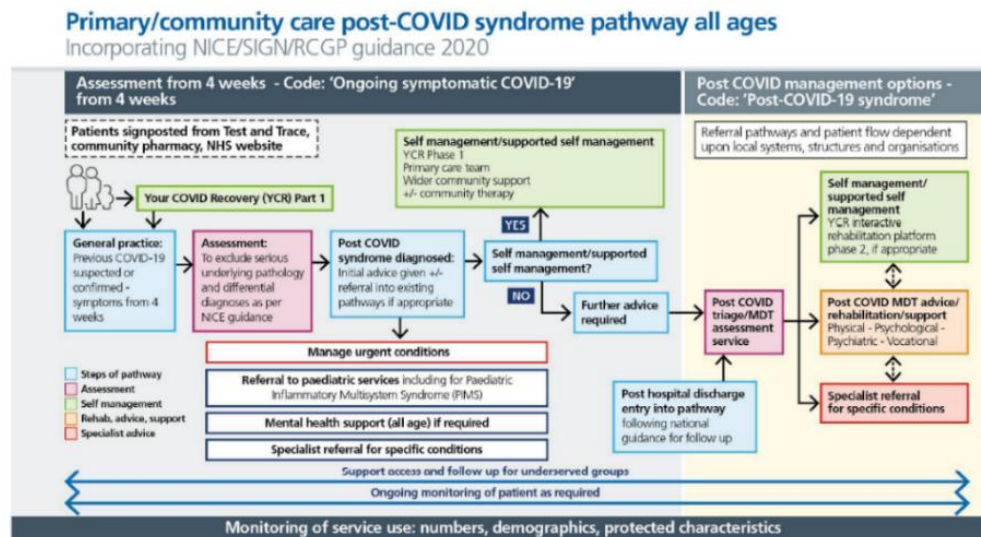
Population: Adults & children, ongoing and post-COVID-19, for community and post-discharged patients.

Model Principles: Patient-centered care, accessibility and equity, integrated and shared care, continuity of care, one-stop-shop, multidisciplinary teams.

Model Components: Standardized holistic symptoms assessment, patient needs assessment, triage, referral and follow-up system, shared decision making, self-management, patient education, patient support and advocacy groups, training for healthcare professionals, PROMs/PREMs evaluation, clinical information system, telehealth and virtual care, research partnership.

Setting: Primary care, speciality care, rehabilitation.

Funding: £10 million (October 2020), £24 million (March 2021 to 2022), £50 million for research.

The PACT / OPTIMAL Post-COVID-19 Clinics

Country: United States.

Description: Multidisciplinary post-COVID-19 clinics at two academic health systems, Johns Hopkins and the University of California-San Francisco.

Population: Adults, ongoing and post-COVID-19, for community and post-discharged patients.

Model Principles: Patient-centered care, integrated and shared care, multidisciplinary teams, continuity of care, one-stop-shop, asynchronous care, evidence-based care, quality improvement, research partnership.

Model Components: Standardized holistic symptoms assessment, referral and follow-up system, patient needs assessment, case management, patient navigator, community of practice, PROMs evaluation, training for healthcare professionals, clinical information system, home-based care, telehealth and virtual care.

Setting: Primary care, speciality care, rehabilitation.

Costs: Cost-neutral for initial implementation, currently seeking funding for staff and additional physical space.

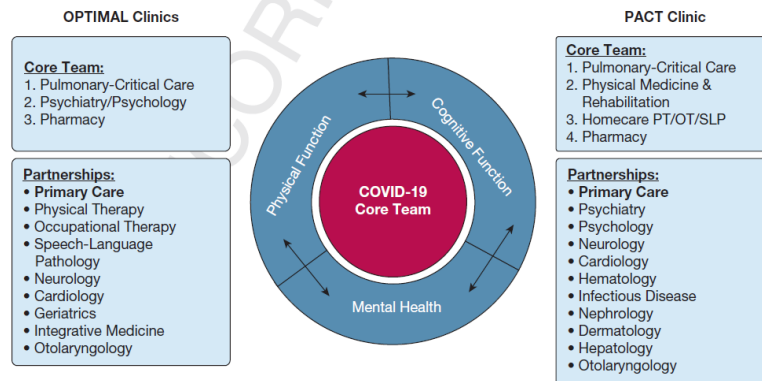
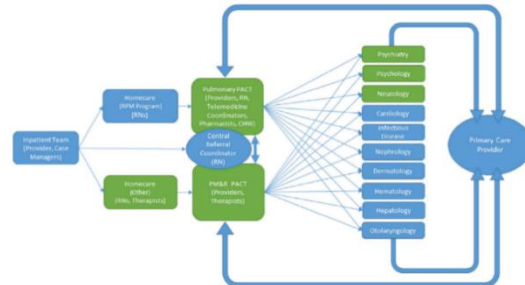
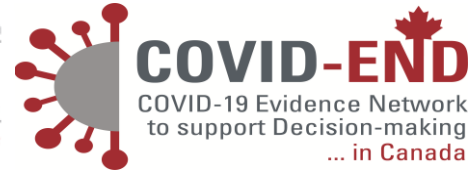


Figure 1 – Organizational structure of PACT and OPTIMAL post-COVID-19 clinics. OPTIMAL = pOst-covid-19/PosT-Icu MultidisciplinAry cLinic; PACT = postacute COVID-19 team.

The Leeds Rehabilitation Pathway

Country: United Kingdom.

Description: Community rehabilitation pathway using a telephone screening tool and a multidisciplinary team for complex case management.

Population: Adults, ongoing and post-COVID-19, for community and post-discharged patients.

Model Principles: Integrated and shared care, continuity of care, multidisciplinary teams.

Model Components: Standardized holistic symptoms assessment, referral and follow-up system, patient education, self-management, case management, telehealth and virtual care.

Setting: Primary care, speciality care, rehabilitation.

Costs: Not reported.

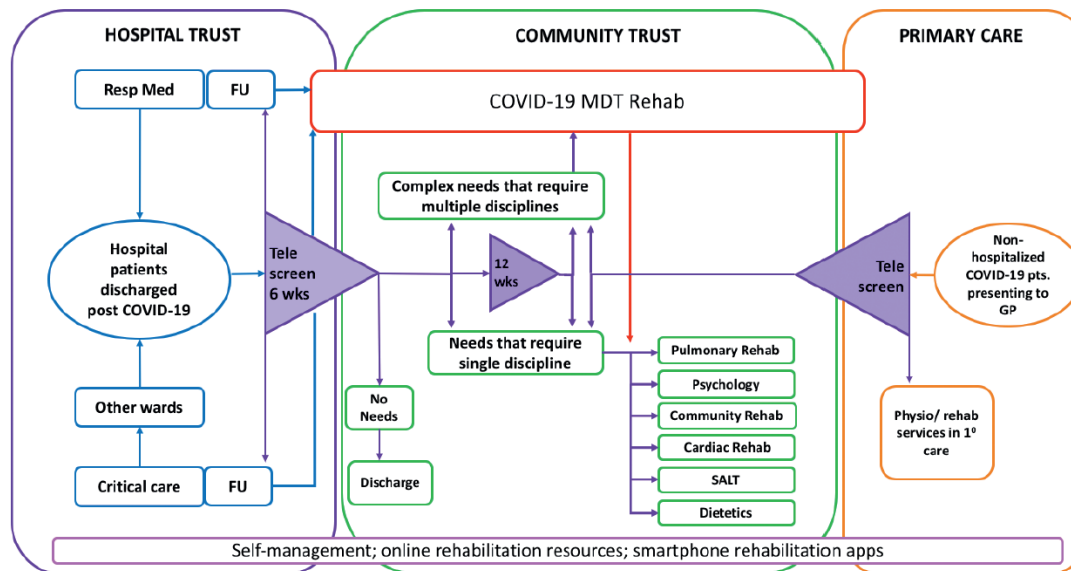
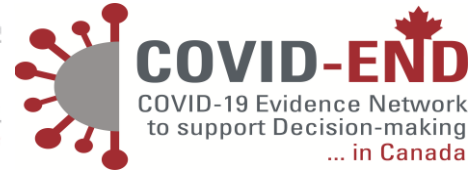


Fig. 1. COVID-19 rehabilitation pathway showing nodal points of telephone screening and links to rehabilitation services. Resp Med: respiratory medicine; FU: follow-up; SALT: speech and language therapist; MDT: multidisciplinary team; 10: primary; GP: general practitioner.

APPENDIX 2 - Definitions

Care model principles

Patient-centered care

"Providing care that is respectful of, and responsive to, individual patient preferences, needs and values, and ensuring that patient values guide all clinical decisions."³²

Shared decision making

"An approach where clinicians and patients share the best available evidence when faced with the task of making decisions, and where patients are supported to consider options, to achieve informed preferences."³³

Patient education

"The process of influencing patient behavior and producing the changes in knowledge, attitudes and skills necessary to maintain or improve health."³⁴

Self-management

"Self-management support is the help given to people with chronic conditions that enables them to manage their health on a day-to-day basis."³⁵

Integrated care

"Health services that are managed and delivered so that people receive a continuum of health promotion, disease prevention, diagnosis, treatment, disease-management, rehabilitation and palliative care services, coordinated across the different levels and sites of care within and beyond the health sector, and according to their needs throughout the life course."³⁶

Multidisciplinary teams

"A multidisciplinary team involves a range of health professionals, from one or more organisations, working together to deliver comprehensive patient care."³⁷

Shared care

"The joint participation of primary care physicians and specialist care physicians in the planned delivery of care for patients with a chronic condition, informed by an enhanced information exchange over and above routine discharge and referral."³⁸

Continuity or coordination of care

"The delivery of a 'seamless service' through integration, coordination and the sharing of information between different providers."³⁹

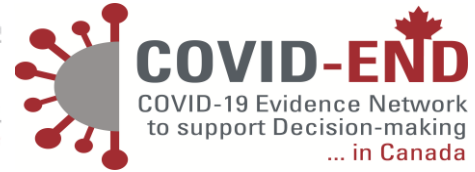
Case management

"The term 'case manager' is generally used to describe a care professional that promotes upstream approaches to health care and facilitates individualized care coordination for those with complex and chronic health conditions. (...) Case managers are often known to conduct patient assessments; patient identification and outreach; care planning and coordination; and service evaluation."⁴⁰

Patient navigator

"A partnership between a patient or caregiver and a navigator (e.g. registered nurse or peer) that seeks to proactively guide patients through the healthcare continuum to facilitate timely access to care and foster self-

management and autonomy through education and emotional support. (...) Patient navigation typically employs an individualized, holistic approach to help patients navigate through a range of health care services"⁴⁰

One-stop-shop

This means that the patient sees all care team members and subspecialists in the same clinical visit.

Asynchronous care

Type of telehealth care that use "store-and-forward technologies to collect health data that can be transmitted and interpreted later"⁴¹. For example, the use of technology to remotely monitor patient outcomes with mobile apps.

Evidence-based care

"An approach to decision making where a clinician uses the best evidence available, in consultation with the patient (evidence-based patient choice), to decide upon which option best suits the patient."⁴²

Community of practice

"Groups of people who share a concern, a set of problems, and a passion about a topic, and who deepen their knowledge and expertise in this area by interacting on an ongoing basis."⁴³

Quality improvement

"The combined and unceasing efforts of everyone—healthcare professionals, patients and their families, researchers, payers, planners and educators—to make the changes that will lead to better patient outcomes (health), better system performance (care) and better professional development."⁴⁴

PROMs evaluation

Patient-reported outcome measures (PROMs). "PROMs are measurement tools that patients use to provide information on aspects of their health status that are relevant to their quality of life, including symptoms, functionality, and physical, mental and social health."⁴⁵

Training for healthcare professionals

Training for healthcare professionals that is planned in the care model (ex: information about long covid symptoms, assessment tools, referral pathways, etc.)

Research partnerships

Incorporating research aspects into the care model to study long covid or to evaluate the impact of the care model for long covid.



Care model components

Decision support for healthcare professionals

The care model reports the use of decision supports for healthcare professionals. These include, for example, clinical decision support systems or decision trees. "Clinical decision support systems (CDSS) are computer-based programs that analyze data within EHRs to provide prompts and reminders to assist health care providers in implementing evidence-based clinical guidelines at the point of care."⁴⁶

Clinical information system

The care model reports the use or adaptation of a clinical information system to facilitate the management of Long Covid. For example, EMR adaptations, including forms specific for Long Covid, etc.

Triage system

Process by which patients are assessed and prioritized based on specific criteria.

Standardized symptoms assessment

Using standardized tools to assess patient's symptoms.

Social determinants assessment

A step in the care model that involves assessing the patient's psychosocial needs, such as employment/return to work, food security, housing situation, etc.

Referral system

Process by which patients are directed to other healthcare professionals to receive other type of care or tests (ex: referral to speciality care).

Follow-up system

Process by which a healthcare professional or a care coordinator is keeping track on how the patient is doing after treatments end (ex: a structured follow-up care plan).

Patient support groups

"A group of people with common experiences and concerns who provide emotional and moral support for one another."⁴⁷

Home-based care

Care or services that are provided at home, out of the hospital.

Telehealth / virtual care

Care or services that are provided over the phone or the Internet (on a computer, etc.).
