47 Abstract

48 Objectives: It remains unknown whether healthy lifestyle attenuates the detrimental
49 effects of urinary monohydroxy polycyclic aromatic hydrocarbons (OH-PAHs) on
50 aging. This study aims: 1) to examine the associations of OH-PAHs and lifestyle with
51 Phenotypic Age Acceleration (PhenoAge.Accel), a novel aging measure, respectively;
52 and 2) to evaluate the potential interaction effects of OH-PAHs and lifestyle on
53 PhenoAge.Accel.

Methods: Cross-sectional data of 2579 participants (aged 20-84 years, n=1292
females) from the National Health and Nutrition Examination Survey for years 20012010 were analyzed. A lifestyle index was constructed based on five components
(drinking, smoking, body mass index, physical activity, and diet), ranging from 0 to 5.
We calculated PhenoAge.Accel using algorithms developed previously. General
linear regression models were used to examine the associations.

Results: We observed strong associations of OH-PAHs and lifestyle with
PhenoAge.Accel. For instance, one unit increase in ∑NAP (sum of 1- and 2hydroxynaphthalene) was associated with 0.37 year (95% confidence interval [CI]:
0.26, 0.48) increase in PhenoAge.Accel. We did not observe statistically significant
interaction effects between OH-PAHs and lifestyle on PhenoAge.Accel. After
stratified by sex, we observed strong associations as well as statistically significant
interactions of OH-PAHs and lifestyle with PhenoAge.Accel among females.

67 **Conclusions:** Both OH-PAHs and lifestyle were independently associated with 68 phenotypic aging and there were statistically significant interactions between OH-69 PAHs and lifestyle on phenotypic aging among females. The findings highlight the 70 importance of adherence to a healthy lifestyle to attenuate the detrimental effects of 71 exposures to PAHs on phenotypic aging among females.

77 1. Introduction

78 Polycyclic aromatic hydrocarbons (PAHs) are pivotal components of air 79 pollutants, as they are produced by incomplete combustion of organic materials such 80 as tobacco, fossil fuels, and even through cooking (Kim et al. 2013). Multiple 81 potential pathways (e.g., dermal absorption (McClean et al. 2004), ingestion (Veyrand 82 et al. 2013), inhalation (Zhang et al. 2014)) have led to widespread general population 83 exposure to PAHs. PAHs are metabolized through the liver and excreted in urine and 84 feces with an average half-life of < 30h in the human body (Buckley and Lioy 1992; 85 Motorykin et al. 2015). Because of the short half-life of PAHs, many metabolites in 86 urinary samples have been identified as proper biomarkers of recent exposure to 87 PAHs (Grainger et al. 2006). Existing evidence has shown that exposure to PAHs 88 increases risk of many chronic diseases, including cardiovascular disease (Burstyn et 89 al. 2005), diabetes (Stallings-Smith et al. 2018; Wang et al. 2019), and respiratory 90 illness (Abdel-Shafy and Mansour 2016).

91 Aging is a critical risk factor for many chronic diseases (Kennedy et al. 2014). 92 As a complex process, aging represents changes in body composition, homeostatic 93 mechanisms, energetics, and brain health over time (Ferrucci et al. 2018), which could 94 be reflected by multisystem clinical chemistry biomarkers. We have recently 95 developed a novel aging measure, Phenotypic Age Acceleration (PhenoAge.Accel), 96 derived from nine chemistry biomarkers (Levine et al. 2018; Liu et al. 2018). 97 PhenoAge.Accel has been demonstrated to capture morbidity and mortality risk 98 across diverse subpopulations in the US (Liu et al. 2018). Given the close connection 99 between aging and chronic diseases, it is intuitive to speculate that PAHs increase the 100 risk of chronic diseases partially through accelerating the phenotypic aging process, 101 which is in line with the Geroscience paradigm (Kennedy et al. 2014).

102 Of note, aging is strongly responsive to many other risk factors, e.g., modifiable 103 lifestyle factors. We have shown that a healthy lifestyle index consisting of non-104 drinking, a healthy diet, doing exercise, non-smoking and healthy body mass index 105 (BMI) was significantly associated with an aging measure derived from chemistry 106 biomarkers in Chinese oldest-old population (Jin et al. 2021). Together with other 107 studies (Astuti et al. 2017; Robinson et al. 2020), we highlight the importance of 108 adherence to a healthy lifestyle to slow aging in daily life. Hence, it is intriguing to 109 examine the role of lifestyle in the potential associations between PAHs and 110 phenotypic aging. We hypothesize that there would be an interaction effect of PAHs 111 and lifestyle on phenotypic aging. In other words, the strength of the detrimental 112 effects of PAHs on phenotypic aging would be attenuated in persons with a healthy 113 lifestyle.

114 Therefore, we analyzed data from the National Health and Nutritional 115 Examination Surveys in 2001-2010 (NHANES 2001-2010) to examine the 116 associations of PAHs and lifestyle with PhenoAge.Accel, a novel aging measure; and 117 to evaluate the potential interaction effects of PAHs and lifestyle on PhenoAge.Accel. 118

120 2. Materials and Methods

121 2.1. Study Population

122 Briefly, NHANES is a program designed to assess the health and nutritional 123 status of civilian in the US, using a complex, multistage sampling procedure. Through 124 examinations in a Mobile Exam Center (MEC) and at-home interviews, NHANES 125 collected a large amount of information (e.g., demographics, socioeconomic status, 126 dietary, and health-related questions, and medical and physiological measurements) 127 from a nationally representative sample biennially in counties across the country. 128 Details of the procedures, study design and recruitment for NHANES are provided by 129 the Centers for Disease Control and Prevention (CDC) (NHANES website: 130 https://www.cdc.gov/nchs/nhanes/index.htm). The protocol of NHANES was 131 approved by the National Center for Health Statistics Research Board.

132 Five waves of NHANES (2001-2002, 2003-2004, 2005-2006, 2007-2008, 2009-133 2010, with information on both PAHs and PhenoAge) were combined and used in this 134 study (N = 52195). Participants with missing data on blood biomarkers for calculating 135 PhenoAge (who did not provide blood samples, N=42488), on education level (N =136 11), poverty income ratio (PIR, N = 666), and urinary creatinine (Cr, N = 70) or did 137 not provide urine samples for testing urinary PAHs (N = 6250) were excluded. For 138 each PAH, we excluded the outliers whose values (after correction by creatinine) 139 were higher than mean + 3 standard deviation (SD) or lower than mean - 3 SD. The 140 final analytic sample included 2579 participants aged 20-84 years (Figure S1).

142 2.2. Measurements of OH-PAHs and creatinine in urine

143 Our analyses included eight urinary monohydroxy polycyclic aromatic 144 hydrocarbons (OH-PAHs) and created five summarized urinary PAH measurements 145 through grouping them by parent PAH (Grainger et al. 2006): Naphthalene (1- and 2-146 hydroxynaphthalene, Σ NAP); Fluorene (2- and 3-hydroxyfluorene, Σ FLU); 147 Phenanthrene (1-, 2-, and 3-hydroxyphenanthrene, Σ PHE); Pyrene (1-hydroxypyrene, 148 Σ PYR) and Σ OH-PAH (sum of eight OH-PAHs). Details of sample collection and 149 measurements were described elsewhere (NHANES website). In brief, participants' 150 spot urinary specimen was collected at MEC, stored at -20° C and then transferred to 151 CDC laboratory for analysis. After enzymatic hydrolysis and solid-phase extraction, 152 OH-PAHs were analyzed through isolate dilution capillary gas chromatography 153 combined with mass spectrometry. The percentage of OH-PAHs above the analytical 154 limit of detection (LOD) was > 98% in NHANES 2001-2010 waves. Considering the 155 majority of the LODs for OH-PAHs vary across NHANES waves, we utilized the 156 method provided by the CDC and assigned the maximal LOD divided by the square 157 root of two to any PAH below the corresponding LOD in each wave. The LOD of

each PAH is published in the Laboratory Procedure Manual for each NHANES wave(Brockmeyer et al. 2018; Fan et al. 2021).

Urinary creatinine was measured by clinical analyzer and the LOD remained constant at 1 mg/mL (NHANES website). For urinary creatinine below the LOD, we applied 1 mg/mL to the maximal LOD divided by the square root of two. In all analyses, we used urinary creatinine to adjust for urinary dilution (Li et al. 2021). The distributions of the urinary concentrations of OH-PAHs were skewed; and thus, each PAH used in our analysis was transformed by urinary creatinine and log conversion.

167 2.3. Lifestyle index

As done in previous studies (Jin et al. 2021; Li et al. 2018b; Li et al. 2020), a lifestyle index was calculated by combining five components: drinking, smoking, BMI, physical activity, and diet. Each component was assigned a point of 0 or 1; and thus, the lifestyle index ranged from 0 to 5, with higher points indicating a healthier lifestyle. Lifestyle was classified as three categories according to the index: unhealthy (lifestyle index = 0 or 1), middle (lifestyle index = 2 or 3) and healthy (lifestyle index = 4 or 5) in analysis.

175 The five components were collected by structured questionnaires or physical 176 examination. For drinking, frequency and volume of current alcohol consumption 177 were self-reported. According to the dietary guidelines in the US, we assigned a point 178 of 1 to males who consumed alcohol two drinks or fewer every day and females who 179 consumed alcohol one drink or fewer every day (Zhang et al. 2021); otherwise, we 180 assigned a point of 0. For smoking, we assigned a point of 1 to participants who 181 reported that they smoked less than 100 cigarettes in a lifetime (non-smoking); 182 otherwise, we assigned a point of 0. BMI was calculated as weight in kilograms 183 divided by height in meters squared. We assigned point of 1 to participants whose 184 BMI was higher than 18.5 kg/m² and lower than 25.0 kg/m². For physical activity, we 185 assigned a point of 1 to participants whose metabolic equivalent (MET) score was in 186 the top tercile (Zhang et al. 2021). For diet, an in-person 24-hour dietary recall at the 187 MEC and a follow-up 24-hour dietary recall by phone 3 to 10 days later were 188 conducted by the NHANES interviewer. Dietary quality was assessed using the 189 Healthy Eating Index-2010 (HEI-2010), a validated measurement for how well diets 190 abide by the 2010 Dietary Guidelines for Americans (Bowman SA; Kirkpatrick et al. 191 2018). HEI-2010 ranges from 0 to 100, with higher values indicating healthier diets 192 that more closely align with the 2010 Dietary Guidelines for Americans 193 (Kinderknecht et al. 2020). Participants whose HEI-2010 falling into the top two fifths 194 of distribution were assigned a point of 1; otherwise, they were assigned a point of 0 195 (Li et al. 2018b; Li et al. 2020).

197 2.4. Phenotypic Age Acceleration (PhenoAge.Accel)

198 We developed PhenoAge based on data from NHANES III (Levine et al. 2018; 199 Liu et al. 2018). PhenoAge was calculated from chronological age (CA) and nine 200 biomarkers (i.e., creatinine, albumin, [log] C-reactive protein, glucose, alkaline 201 phosphatase, lymphocyte percent, red cell distribution width, mean cell volume, and 202 white blood cell count) which had been selected through a Cox Proportional Hazards 203 Elastic Net model for mortality based on ten-fold cross-validation. PhenoAge (unit in 204 years) represents person's expected age within the population, which is consistent 205 with a person's estimated hazard of mortality as a function of his/her chemistry 206 biomarkers profile (Levine et al. 2018; Liu et al. 2018). The equation to calculate 207 PhenoAge is shown below:

As mentioned above, we calculated a novel aging measure, PhenoAge Acceleration (PhenoAge.Accel), defined as residual from a linear model when regressing PhenoAge on CA. PhenoAge.Accel represents phenotypic aging after accounting for the effect of CA, i.e., a person is phenotypically older (younger) if his/her PhenoAge.Accel>0 (<0) than expected based on his/her CA (Levine et al. 2018; Liu et al. 2018).

- **217** *2.5. Covariates*

218 Obtained through structured questionnaires, our covariates included CA, sex 219 (male and female), race/ethnicity (non-Hispanic White, non-Hispanic Black, Mexican 220 American, and others), education level (less than high school (HS), HS/general 221 educational development (GED), above HS Grad), PIR (< 1, 1-3, \geq 3) (You et al. 222 2021).

224 2.6. Statistical analyses

We presented basic characteristics of the participants in total and by sex, using mean ± SD for continuous variables and numbers (percentage) for categorical variables. The correlation between each PAH was analyzed using scatter plot and Pearson's coefficient matrix.

229 We used general linear regression models to examine the associations of OH-230 PAHs and lifestyle with PhenoAge.Accel, respectively. To account for the complex 231 sampling procedure, we considered PAH weight (provided by NHANES) in analyses. 232 We considered two models. In Model 1, we adjusted for CA and sex. In Model 2, we 233 additionally adjusted for race/ethnicity, education level, and PIR. To examine the 234 interaction effect of OH-PAHs (two categories: high and low using median as the 235 cutoff) and lifestyle category (unhealthy, middle, and healthy) on phenotypic aging, 236 we added cross-product terms and tested the statistical significance in Model 1 and 2. 237 To better explicitly illustrate the possible interaction effects, we first examined the 238 associations between OH-PAHs and PhenoAge.Accel, stratified by lifestyle category, 239 and this could suggest the potential modifying effect of lifestyle. Second, we 240 constructed six subgroups by OH-PAHs (two categories) and lifestyle category, and 241 re-examined the associations between OH-PAHs and PhenoAge.Accel, using the 242 group with "unhealthy lifestyle" and "high" OH-PAHs as the reference. We 243 documented the coefficient and corresponding 95% confidence interval (CI).

Given the established sex differences in health effect of ambient air pollution (Shin et al. 2022), we repeated the analyses above stratified by sex. Moreover, to test the robustness of our findings, we performed a sensitivity analysis by replacing the PAH weight with the blood weight (provided by NHANES) and repeated analyses.

All analyses were performed using SAS version 9.4 (SAS Institute, Cary, NC)
and R version 4.1.1. Statistically significance was defined as a two-tailed P value < 0.05.

253 **3. Results**

254 3.1. Basic characteristics of study participants

Table 1 shows the basic characteristics of the participants. The mean CA (\pm SD) of study participants was 48.2 \pm 17.6 years. A total of 1292 participants were female. In all participants, the mean values of \sum NAP, \sum FLU, \sum PHE, \sum PYR, and \sum OH-PAH were 6.5 \pm 2.0, 0.9 \pm 2.0, -0.6 \pm 1.9, -0.3 \pm 0.9, and 6.5 \pm 5.8 (ng/g Cr), respectively. As shown in Figure S2, a strong correlation between each two of PAHs was revealed. The mean value of PhenoAge (\pm SD) was 42.5 \pm 19.6 years; and PhenoAge.Accel roughly exhibits a normal distribution (Fig. 1).

266 3.2. Associations of OH-PAHs and lifestyle with PhenoAge.Accel

In Table 2, after adjustment for CA and sex (Model 1), we observed that all OH-PAHs were significantly associated with PhenoAge.Accel (all P < 0.05). For instance, one unit increase in \sum NAP was associated with 0.37 year (95% CI: 0.26, 0.48) increase in PhenoAge.Accel and one unit increase in \sum OH-PAH was associated with 0.13 year (95% CI: 0.10, 0.17) increase in PhenoAge.Accel. After further adjusting for race/ethnicity, education level, and PIR in Model 2, the statistically significant associations of OH-PAHs with PhenoAge.Accel were maintained.

As shown in Table 2, compared to participants with an unhealthy lifestyle, those who with a middle lifestyle (β = -1.89, 95% CI: -2.48, -1.30) and a healthy lifestyle (β = -4.24, 95% CI: -5.00, -3.48) had lower level of PhenoAge.Accel. Similar results were observed in Model 2.

279 3.3. The interaction effects of OH-PAHs and lifestyle on PhenoAge.Accel

We did not observe statistically significant interactions of OH-PAHs and lifestyle on PhenoAge.Accel (data not shown). However, our results suggested that lifestyle might attenuate the effects of OH-PAHs on PhenoAge.Accel. As shown in Figure 2, the association between \sum OH-PAH and PhenoAge.Accel was statistically significant ($\beta = 0.10$, P = 0.026) among participants with an unhealthy lifestyle, but the association was non-significant ($\beta = -0.01$, P = 0.917) for participants with a healthy lifestyle.

Among six subgroups constructed by OH-PAHs (by median, two categories) and lifestyle (three categories), we observed that subgroups with a healthy lifestyle had the lowest level of PhenoAge.Accel regardless of a high or low PAH (Figure S3).

301 *3.4. Additional analysis*

Table S1 shows the significant associations of OH-PAHs and lifestyle with
PhenoAge.Accel in males and females. For instance, one unit increase in ∑NAP was
associated with 0.44 year (95% CI: 0.28, 0.60) increase in PhenoAge.Accel among
males and 0.32 year (95% CI: 0.16, 0.31) increase in PhenoAge.Accel among females.
Interestingly, we observed statistically significant interactions between several OH-

307 PAHs and lifestyle (e.g., P for interaction = 0.029 for $\sum NAP *$ lifestyle category) on 308 PhenoAge.Accel among females (Table S2). As shown in Figure 3, stratified by 309 lifestyle, for females with an unhealthy lifestyle, we observed a significant association 310 between OH-PAHs and PhenoAge while we did not observe similar associations for 311 females with a middle or healthy lifestyle. In sensitivity analyses, we replaced the 312 PAH weight with the blood weight and found that the results were maintained when: 313 (1) re-examining the associations of urinary OH-PAHs and lifestyle with 314 PhenoAge.Accel (Table S3); (2) re-examining the associations of urinary OH-PAHs 315 and lifestyle with PhenoAge.Accel stratified by sex (Table S4); (3) re-examining the 316 interaction between OH-PAHs and lifestyle stratified by sex (Table S5); (4) re-317 examining the associations of urinary OH-PAHs with PhenoAge.Accel by lifestyle 318 category (Figure S4); (5) re-examining the associations of urinary OH-PAHs with 319 PhenoAge.Accel by sex and lifestyle category (Figure S5); and (6) re-examining the 320 joint associations of OH-PAHs and lifestyle with PhenoAge.Accel (Figure S6).

331 4. Discussion

Based on the data from NHANES 2001-2010, we found that OH-PAHs and lifestyle were independently associated with PhenoAge.Accel. We also found interaction effects of several OH-PAHs and lifestyle on PhenoAge.Accel among females. Since accelerated aging indicates adverse health issues in later life, our findings highlight the importance of adherence to a healthy lifestyle, particularly for females who are exposed to high PAHs.

338 For the first time, we demonstrated that high PAHs were associated with 339 accelerated phenotypic aging. Qiao et al (Qiao et al. 2017) revealed the adverse effect 340 of PAHs on skin aging. Pavanello et al (Pavanello et al. 2020) suggested that certain 341 preventable everyday life exposures to PAHs reduce leucocyte telomere length and 342 mitochondrial DNA copy number, which were associated with increased risks of 343 mortality and age-related diseases. Studies have reported that exposure to PAHs was 344 associated with accelerations of DNA methylation age (Li et al. 2018a). Though our 345 findings complement these results to some extent, PhenoAge.Accel represents a 346 multisystem aging process, with complex underlying biological mechanisms. Our 347 findings may provide an exciting new avenue for investigating the underlying 348 biological mechanisms of how air pollutions induce aging-related adverse health 349 outcomes (including age-related diseases and mortality) through aging.

350 The detrimental effects of exposures to PAHs on phenotypic aging were 351 attenuated by a healthy lifestyle in females, which has not been reported previously. 352 Although some results did not reach the statistical significance, the trend was 353 observed when examining the association of PAHs with phenotypic aging stratified 354 by sex (Fig. 2). For example, detrimental effects of PAHs on phenotypic aging in a 355 subgroup with an unhealthy lifestyle were not observed in a subgroup with a healthy 356 lifestyle. The findings have important public implications, suggesting adaption to a 357 healthy lifestyle to attenuate the detrimental effect of exposure to air pollutions (e.g., 358 PAHs) on phenotypic aging among females. However, chance findings cannot be rule 359 out when interpreting the results given the relatively small sample size of the stratified 360 analyses by sex.

361 One plausible underlying biological mechanism of the interesting interaction 362 effect of PAHs and lifestyle on phenotypic aging is related to oxidative stress and 363 inflammation. Higher exposure to PAHs could result in increased oxidative stress 364 (Zhu et al. 2021) and oxidative DNA damage (Kuang et al. 2013), two key 365 determinants of aging process. PAHs can induce inflammatory response in the body 366 including elevating high C-reactive protein levels (a marker reflecting the systemic 367 inflammation and was included in calculation of PhenoAge) (Farzan et al. 2016). 368 Interestingly, many components included in our lifestyle index have been 369 demonstrated to be associated with inflammation or oxidative stress as well, such as 370 diet quality (de Castro Mendes et al. 2020), physical activity (Tu et al. 2020) and BMI. 371 For instance, adipose tissue can produce proinflammatory cytokines (TNF- α , IL-1 β 372 and IL-6) related to persistent inflammation and oxidative stress, and adipokines

(leptin, adiponectin, plasminogen activator inhibitor, and macrophage migration
inhibitory factor) which mediate the inflammatory response (Fain 2006). Building on
the above evidence, we speculate that high PAHs were associated with accelerated
phenotypic aging, partially through increased oxidative stress and inflammation.

377 There are several strengths in this study. First, NHANES employs thorough 378 quality control and quality assurance procedures to ensure the validity of the data. 379 Second, we concentrated on a lifestyle index rather than a single component, to 380 comprehensively capture the complex relations of many lifestyle factors. Third, the 381 study outcome, PhenoAge.Accel, is not simply a measure of mortality; instead, it may 382 be a marker that could track the aging process before diseases become clinically 383 evident. Thus, the findings have more public health implications in terms of disease 384 preventions in community settings.

385 However, this study has some limitations. First, information on several lifestyle 386 components was self-reported; and thus, recall bias is possible. Second, the level of 387 PAHs in spot urine was performed by a single measurement; and thus, intra-person 388 variability and long-term average exposure may not be reflected. Third, the temporal 389 relationships between PAHs, lifestyle and phenotypic aging cannot be determined 390 given the cross-sectional study design. Fourth, the analytic sample was selected based 391 on multiple criteria such as with information on both PAHs and PhenoAge; and thus, 392 was relatively small (for stratification analysis) and might be biased to some extent. 393 Finally, although we included many covariates, there may still be residual and 394 unmeasured confounders.

397 5. Conclusions

398 In this sample of an US population, for the first time, we demonstrated that both 399 OH-PAHs and lifestyle were independently associated with phenotypic aging and 400 there were statistically significant interactions between OH-PAHs and lifestyle on 401 phenotypic aging among females. The findings provide important insights into the 402 underlying biological mechanism of how exposure to PAHs and lifestyle accelerate 403 aging. Furthermore, the findings highlight the importance of adherence to a healthy 404 lifestyle to attenuate accelerated phenotypic aging, which has significant public health 405 implications.
