

# Vaccination under the Pandemic and Political Support\*

## Abstract

This paper examines the impact of COVID-19 vaccination on political support. We exploit the age-based COVID-19 vaccine roll-out in Japan where those aged 65 years and older are strictly prioritized. A regression discontinuity design based on a large-scale online survey reveals that COVID-19 vaccination increases favorable opinions of the vaccination progress in municipalities and infection control measures of municipal governments whereas there is no significant effect on support for the central government. We also find that the effect is more pronounced among people with chronic diseases and those with low socioeconomic status. These results suggest that both reciprocal motives and political information play an important role in the evaluation of public policies.

# 1 Introduction

The interaction between government policies and political support has been a central issue in both political science (Dahlberg and Johansson, 2002; Rudolph and Evans, 2005; De La O, 2013; Marshall, 2019) and public economics (Manacorda et al., 2011; Linos, 2013; Labonne, 2013). Under a public health crisis like the COVID-19 pandemic, the government’s infection control measures directly affect people’s lives and livelihoods, and these policies attract attention from the public. Since the outbreak of the pandemic, the news headlines around the world have been dominated by how many people are infected and killed by COVID-19, how the government responds to it, and what it will take to overcome the pandemic. As a result, there have been a number of studies examining intended and unintended consequences of government policies against the pandemic, such as social distancing measures and economic stimulus packages. However, despite the high profile of the government policies against the pandemic, their political consequences have remained largely unknown.<sup>1</sup>

This paper explores how COVID-19 vaccination affects people’s political support for the government. Among many measures to control the pandemic, vaccination is one of the most effective intervention. The timing of vaccine approval, the availability of vaccines, and the speed of vaccine dissemination, are all strongly linked to government policies and thus politics (Bokemper et al., 2021). For example, 78% of Americans believe that the COVID-19 vaccine approval process was driven more by politics than science (Meyer, 2020). Furthermore, so-called “vaccine nationalism” has been prevailed among developed countries because how well the government secured COVID-19 vaccines for its own country was considered as a signal for its political competence (Fidler, 2020; Katz et al., 2021). While COVID-19 vaccination was accelerated due to political motivation in developed countries, it is not clear whether vaccination has led to political support for the government.

To estimate the causal impact of COVID-19 vaccination on political support, it is necessary to find exogenous variations of vaccination status among the population. In practice, however, it is difficult to find such a situation because vaccination uptake is largely influenced by people’s

self-selection. To overcome this difficulty, we exploit an age-based COVID-19 vaccine roll-out in Japan. Elderly people are at higher risk of hospitalization and death when infected with COVID-19 (CDC, 2022). Therefore, like many other countries, the Japanese government decided to prioritize elderly people to receive the vaccine. Specifically, the elderly born before April 1, 1957, who have reached or will reach the age of 65 during the fiscal year 2021, were able to be vaccinated before younger people. This age-based prioritization has resulted in exogenous variation in vaccination rates around the age 65 threshold during the vaccine dissemination phase. Our study exploits the sharp variation in vaccination rates at the age cutoff to causally estimate the political impact of COVID-19 vaccination.

We conducted an online survey to obtain information on people's vaccination status and political opinions. Our survey was conducted in August 2021, when the difference in vaccination rates between those aged 65 and older and under 65 was the greatest. The survey responses were collected from 30,892 elderly individuals within three years of age around the cutoff age of 65. In addition to vaccination status and political opinions, we also collected various information on respondents' demographics, health behaviors, and health outcomes. This information enables us to examine which demographics are associated with the political impact of vaccination and how vaccination affects people's health behavior and health outcomes.

Using the survey data, we adopt a fuzzy regression discontinuity (RD) design to estimate the impact of COVID-19 vaccination on political support for the municipal and central governments. The first stage estimates indicate that at the age 65 threshold, the vaccination rate jumps by 29.3 percentage points. Based on the significant first stage impact, our fuzzy RD estimation reports the following main results. First, COVID-19 vaccination significantly increases favorable opinions of vaccination progress in municipalities and infection control measures of the municipal government, while there is no significant effect on support for the central government. The difference in the effects between municipal and central government is likely to reflect the institutional setting in Japan where municipal governments play a primary role in establishing the vaccine delivery system for elderly people.

Second, when respondents are divided by health condition based on the presence or absence of chronic diseases, those with chronic diseases are more likely to increase political support due to vaccination. It is widely known that people with pre-existing health conditions are at greater risk of hospitalization and death from infection with COVID-19. Therefore, those with

chronic diseases might be more appreciative of vaccination than those without and take their own vaccination status as important political information. We also find that people with a high level of interpersonal trust increase their support for the government more than those with low trust levels. Given that interpersonal trust is closely associated with reciprocity (Ostrom and Walker, 2003; Altmann et al., 2008)<sup>2</sup>, these results also suggest that people increase their political support through reciprocal motivation toward the government.

Third, people with lower socioeconomic status (SES) are more likely to increase their political support through vaccination. Specifically, the political impact of vaccination is more pronounced among those with low income and those without a college degree. One interpretation of these results is that people with lower SES have limited knowledge about the government policies (Angelucci and Prat, 2021). Therefore, these people may be more likely to update their political knowledge about the government policies by their own benefit. These results are also consistent with theoretical predictions about voter behavior when they have limited information about government abilities (Rogoff, 1990; Manacorda et al., 2011).

This paper contributes to the literature that analyzes the interaction between government policy and political support using one of the most important public health policies during the COVID-19 pandemic: vaccination. We take advantage of the fact that COVID-19 vaccination is a universal public policy that targets the general population. In particular, by analyzing the political responses of people with different health status, personal values and SES, we examine the mechanisms by which people increase their political support for governments that provide public services. Considering that most of the previous studies have focused on people with particular SES and had limited statistical power to explore the mechanisms, examining multiple mechanisms of political support is an important contribution of our study.

Previous studies have focused mainly on the political impact of public policies targeting people from certain socioeconomic backgrounds, especially the economically disadvantaged population. Manacorda et al. (2011) and De La O (2013) respectively examine the impact of cash transfer to the poor people on their political support for the government in Uruguay and Mex-

ico.<sup>3</sup> These studies find that government transfers to the disadvantaged people significantly increase their political support for the government. [Manacorda et al. \(2011\)](#) argue that the increased political support among poor people is mainly attributed to the insufficient information about the competence of incumbent, as indicated by a model of rational but poorly informed voters ([Rogoff, 1990](#)).<sup>4</sup> Furthermore, other studies indicate the importance of pure psychological motivations among voters including the reciprocal relationship between voters and politicians ([Hahn, 2009](#); [Finan and Schechter, 2012](#)), rather than rational decision making among voters ([Rogoff, 1990](#)). Based on the estimation using individual attributes, our analysis provides evidences in favor of both political information and reciprocal motives in people's political support: People with low SES and high interpersonal trust are more likely to increase their political support indicate the importance of political information and reciprocal motives, respectively.

This paper is organized as follows. Section 2 presents the age-based priority policy for COVID-19 vaccination in Japan. Section 3 discusses mechanisms of why COVID-19 vaccination can affect people's political opinions. Section 4 describes our survey data and presents descriptive statistics. Section 5 explains empirical strategies applying RD design. Section 6 reports estimation results for the political impact of COVID-19 vaccination. Section 7 discusses other potential effects of COVID-19 vaccination and presents estimation results for robustness checks. Section 8 concludes this paper.

## 2 Background

### 2.1 Age-based Priority Rule and Vaccination Trends

This section describes the COVID-19 vaccine delivery system in Japan. As in many countries, vaccination is considered to be particularly effective in controlling COVID-19 infection in Japan. Against the backdrop of the public expectations for vaccines, the Japanese government made the spread of the vaccine a top priority in the fight against COVID-19. However, the spread

of vaccine lagged behind other developed countries because of the slow progress of regulatory approval (Matsui et al., 2021; Kosaka et al., 2021). After the vaccines were approved,<sup>5</sup> the Japanese government rushed to purchase the vaccine from pharmaceutical companies, and vaccination for the general public began in April 2021.

A major feature of the COVID-19 vaccination policy in Japan is the age-based priority, which is called the “Older-people-first Policy” (Matsui et al., 2021).<sup>6</sup> The Japanese government decided to give priority to elderly people to receive the vaccine because they are known to be at higher risk of severe disease and death when infected with COVID-19. Specifically, the Japanese government has made it possible for elderly people born before April 1, 1957, who have reached or will reach the age of 65 during the fiscal year 2021, to be vaccinated before younger people.<sup>7</sup> Based on this priority, each municipal government allowed the elderly people to receive the vaccine before the younger ones. Municipalities that have finished vaccinating elderly people will proceed to vaccinate young ones.

Although the diffusion of vaccines in Japan lagged behind other developed countries, the central government began mass vaccination programs in earnest. Prime Minister Yoshihide Suga promised the public on May 13 to vaccinate 36 million elderly citizens aged 65 and older by the end of July 2021.<sup>8</sup> Starting in early June 2021, vaccination rates began to rise rapidly. Figure 1 plots the vaccination rate for the second shot among the population aged 65 and older and those under 65, based on publicly available government official data. Among people aged 65 and older, vaccination rates have increased from 0.1 percent on June 1 to 79 percent on July 31. Among those under 65, the diffusion of vaccines lagged behind the elderly population because of the priority rule based on the threshold of age 65.<sup>9</sup>

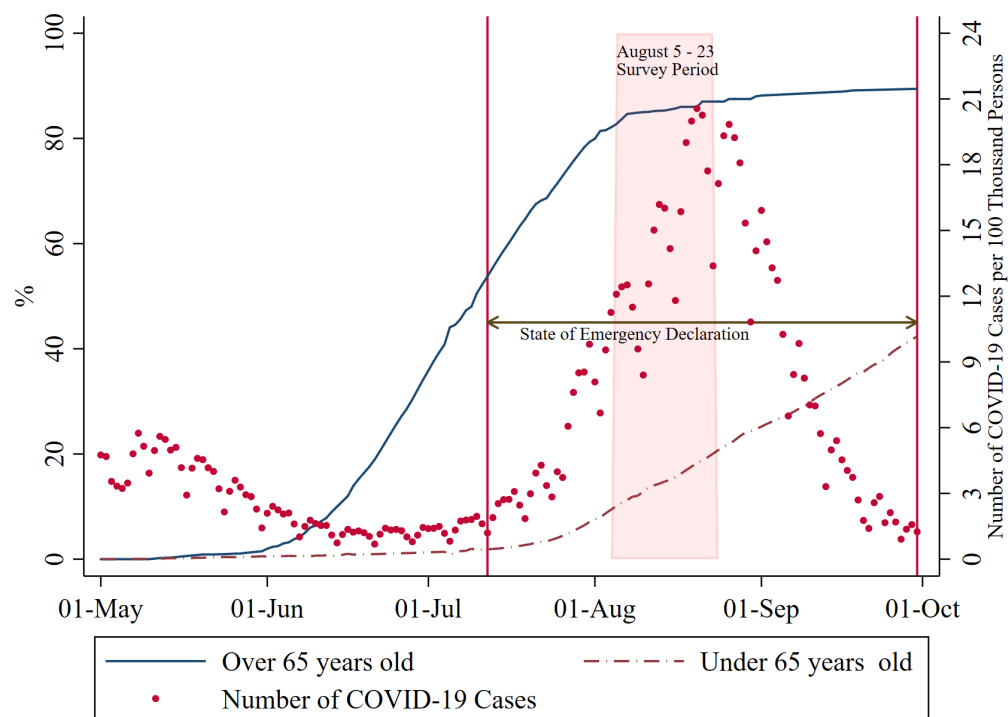

The difference between vaccination rates of the second dose among people aged 65 and older and those under 65 were maximized in early August. On August 6, the next day when our original survey began, the vaccination rate of the second dose among people aged 65 and older and under 65 was 83% and 11%, respectively.

Figure 1 also shows the number of infected people per 100 thousand (red dots). While vaccination of the elderly had increased since early June, COVID-19 infection spread in August because of the spread of the Delta variant. To control the infection, the state of emergency was declared in Tokyo on July 12 and was extended to 21 prefectures in late August, the peak of the outbreak. Eventually, the state of emergency was lifted on September 30, following a rapid decrease in the number of infected people.

## 2.2 Role of Municipalities in Vaccination Progress

While the central government is responsible for securing and distributing the vaccine to municipalities, each municipal government is responsible for administering the vaccination. First, each municipal government is responsible for preparing vaccination sites and providing vaccines based on the priority. The municipal governments worked with local hospitals and clinics to prepare medical facilities and mass vaccination sites where vaccinations could be given. For residents to make an appointment for vaccination, they need to receive a coupon sent by the municipal government.

Second, each municipality is responsible for securing human resources for vaccination in cooperation with the local medical association and needs to provide a high daily allowance for doctors and nurses. In Japan, only doctors and nurses are legally allowed to inject the COVID-19 vaccine, so the lack of human resources has been a major obstacle to the spread of the vaccine. Many municipalities had difficulty in securing enough qualified human resources for COVID-19 vaccination because doctors and nurses must also provide their regular medical care (Kosaka et al., 2021).

Reflecting the crucial role of municipalities in vaccination progress, there was a large regional variation in vaccination rates. Appendix Figure A1 show the prefecture-level map on the difference of the vaccination rate from the mean value for each age group. In these figures, we confirm modest regional disparities in the vaccination rate of the second dose. For example, there appears to be a large disparity in vaccination rates in the middle of mainland Japan.

## 3 COVID-19 Vaccination and Political Support

### 3.1 Reciprocal Motive

In this section, we offer explanations on why COVID-19 vaccination can influence people's political opinions. Previous studies have shown that reciprocal relationships between voters and politicians plays a crucial role in the political process (Finan and Schechter, 2012; Hahn, 2009).<sup>10</sup> If the government policy is favorable to some voters, the beneficiaries may feel grateful

and may want to reward the government. In the case of COVID-19 vaccination, people may increase their support for the government in gratitude for being given priority vaccination or being able to take the vaccine.

An important feature of COVID-19 is that people with certain diseases are more likely to get severely ill from the infection. Therefore, there are significant benefits from vaccination especially for those with underlying medical conditions. Given that the benefits of vaccines vary by health status, vaccination may be more likely to increase political support among people with poorer health status because of reciprocal motive toward the government.

Considering reciprocal motives, a person with a personality that values reciprocity might be more likely to increase political support for the government due to vaccination. Here, we pay attention to people's interpersonal trust. Our hypothesis is that people with a high level of interpersonal trust also have high reciprocity toward the government, and that such people are more likely to increase their support for the government by receiving public services. Reciprocity is a key aspect of interpersonal trust (Ostrom and Walker, 2003; Fukuyama, 1996).<sup>11</sup> As Ostrom and Walker (2003) pointed out that "the levels of trust and reciprocity and reputations for being trustworthy are positively reinforcing", it is plausible to expect a positive relationship between interpersonal trust and reciprocity. In fact, several empirical studies revealed the close relationship between them. For example, Altmann et al. (2008) conducted a laboratory experiment and find a strong positive correlation between a person's reciprocity and her trusting behavior.<sup>12</sup>

### 3.2 Political Information and Socio-Economic Status

In addition to reciprocity, the political information people have could also play an important role in their political support. Modern political economy models have formulated the relationship between government policy and political support as a consequence of voters' learning about the government's capabilities (Rogoff, 1990; Manacorda et al., 2011). Because of various information

constraints, voters have limited ability to understand the true consequences of government policies. Under this asymmetric information, voters use the related outcomes as signals to infer them.

To put it in the context of COVID-19 vaccines, people may infer the ability of government on vaccine policies and other infection control measures based on whether or not they were able to get vaccinated. The above theoretical model implies that whether vaccination leads to support for the government policies depends on how much people know about policies in advance. For example, if people knew the exact vaccination progress in their municipalities and nationwide, vaccination would not influence political support for them. On the other hand, people may not be aware of the exact vaccination progress in their municipalities and across the country. They may also overestimate their vaccination status and use this information as a signal to infer overall vaccination progress. In this case, getting vaccinated can lead to support for the governments.

The importance of political information also suggests that the political impact of vaccination depends on personal attributes such as socioeconomic status (SES). For example, less educated people may not have accurate information about the prevalence of vaccines and may be more likely to change their support for the government based on their vaccination status. [Angelucci and Prat \(2021\)](#) investigate information inequality about political news by SES groups. They find that people with high SES have more accurate information than those with low SES and that socioeconomic factors matter more than partisanship in determining information levels. Therefore, we also analyze which socioeconomic factors drive the political impact of COVID-19 vaccination.

## 4 Data

### 4.1 Online Survey

To gather the necessary information for our analysis, we hired an internet-survey company called Cross Marketing Inc., which is one of the largest survey companies in Japan. They employed random sampling from about 4,790,000 people across the nation who had preregistered as potential survey participants. Our survey was conducted from August 5 to 23, 2021, around

the time when the difference in vaccination rates between people aged 65 and older and those under 65 was greatest as shown in Figure 1. We targeted people born between April 1954 and March 1960, in other words, those who were between the ages of 62 and 67 at the end of the fiscal year 2021 (March 2022). The survey was sent to 54,356 married survey registrants and we gathered 30,892 responses. In our survey, we asked a wide range of questions related to vaccination, political opinions, health awareness and behaviors, and SES. In the following, we explain about the main variables used in the analysis.

**Vaccination status.** The COVID-19 vaccine is supposed to be given twice, three to four weeks apart. We asked the survey participants how many times and when they had been vaccinated. If they had not been vaccinated, we asked whether they were planning to be vaccinated.

## 4.2 Dependent Variables

**Political opinions.** The main outcome variable in our analysis is people’s political opinions related to the pandemic. As discussed in Section 2, the central government and municipal government played different roles in the supply of vaccines in Japan. Therefore, we asked respondents about their political opinions of both the central government and the municipal government.

We measure respondents’ support for the government by asking their opinions about government policies against the pandemic. As for the central government, we asked about various policies including the supply of vaccines. For example, we asked respondents what they thought of some descriptions such as “Vaccinations are progressing well across the country.” and “The government’s response to the pandemic has been successful.” with a 5-point Likert scale ranging from 1 for “agree” to 5 for “disagree”. Similar questions were used for the municipal government. We use descriptions such as “Vaccinations are progressing well in your municipality.” and “Your municipality has adequate measures to prevent COVID-19 infection.”<sup>13</sup>

**Health behaviors and mental health.** Vaccination may change people’s awareness of COVID-19 and their daily behaviors. We ask about the compliance of daily infection prevention behaviors such as hand-washing and mask-wearing, as well as the frequency of high-risk behaviors such as attending large group events and eating at restaurants. From these questions, total scores on infection preventive behaviors and high-risk behaviors are calculated. Also, we use Kessler Psychological Distress Scale (K6) to evaluate the mental health of respondents (Kessler et al., 2003). Detailed definitions and descriptive statistics on each item are reported in Appendix Table A3.

### 4.3 Variables for Subsamples Analysis

**Chronic diseases.** According to the Centers for Disease Control and Prevention (CDC), people with certain medical conditions are more likely to get severely ill from COVID-19<sup>14</sup>. To obtain information on the health status, we asked whether respondents have the following chronic diseases: hypertension; diabetes; bronchitis/pneumonia; angina; myocardial infarction; stroke (cerebral infarction or cerebral hemorrhage); chronic obstructive pulmonary disease (COPD), cancer, and chronic pain.

**Interpersonal Trust.** To measure interpersonal trust, many previous studies have used people’s trust in their neighbors (Rotter, 1967; Yamagishi, 1988; Siegrist and Bearth, 2021). In this study, we use a scale proposed by Siegrist and Bearth (2021). The following 4 items were used to measure respondents’ interpersonal trust: 1) “If given the chance, most people in your city would try to take advantage of you”; 2) “Most people in your city are too busy looking out for themselves to be helpful”; 3) “Most people in your city are honest”; 4) “Most people in your city tell a lie when they can benefit from doing so”.<sup>15</sup> The respondents could indicate their agreement with the statements, using the scale of 1 (do not agree at all) to 7 (completely agree). The total score ranges from 7 to 28 and a higher value indicates a higher level of interpersonal trust.

**Socioeconomic status.** It is well known that people’s political opinions differ according to their SES. We use educational background and income as indicators of SES. For education, we use whether or not a person has a college degree as an indicator of educational background. For income, we asked respondents what their annual household income would have been in 2020. We also allowed for responses such as “I don’t know” or “I don’t want to answer” in terms of income.

## 4.4 Descriptive Statistics

Table 1 reports descriptive statistics for all respondents, people who are eligible for priority vaccination (PV) for elderly people (over age 65), and those who are not eligible for PV (under age 65). Our online survey received responses from a total of 30,892 people, of which 13,852 were eligible for PV and 17,040 were not eligible for PV.

Because of the age-based priority rule, COVID-19 vaccination rates vary widely between people aged 65 and older and those under 65. We use the fraction of people who completed two doses as vaccination rates. While vaccination rates for people under 65 is a little over 50%, it reaches nearly 87% for those aged 65 and older. As a result, the difference in vaccination rate between the two groups amounts to over 36%.

The fraction of women is 23% because there are more men than women registered for the survey. The fraction of college graduates is nearly 60%, and there is no significant difference between the two groups. The employment rate and annual income of people under 65 is higher than that of people aged 65 and older. This is probably because more people retire at an older age. In addition, 45% of the respondents have chronic diseases listed in Section 4.3, and older people are more likely to have those. The subjective efficacy of the COVID-19 vaccine, interpersonal trust, and trust on scientists do not differ between the two groups.<sup>16</sup> Regarding subjective efficacy of the COVID-19 vaccine, respondents of our survey believe that the COVID-19 vaccine prevents 79.6 % of fully vaccinated persons from becoming severe conditions.<sup>17</sup>

Descriptive statistics for political opinions are the mean value of a 5-point Likert scale

ranging from 1 for “agree” to 5 for “disagree” for each political description. Descriptions (a) and (b) are related to municipal government policies against the pandemic, and descriptions (c) and (d) represent ones for the central government. Based on the mean value, there does not appear to be a significant difference in political opinions between the two groups. Although the mean values suggest that the eligibility of PV has little effect on respondents’ political opinions, the simple comparison is of course affected by various confounding factors. In the following section, we describe how to identify the effect of eligibility of PV and vaccination status on political opinions using regression discontinuity design.

## 5 Empirical Strategy

### 5.1 Identification

We identify the political impact of COVID-19 vaccination by exploiting the age-based priority policy. The Japanese government has made it possible for people born before April 1, 1957, who have reached or will reach the age of 65 during the fiscal year 2021, to be vaccinated before younger people. We use year-month of birth to determine if the respondent is eligible for priority vaccination (PV). For example, people born in March 1957 are eligible for PV whereas people born in April 1957, whose birthdays are one month later, are not. For simplicity, we will refer to the year-month of birth threshold as the “age 65 threshold”.

At the age 65 threshold, only the vaccination rate changes because of the voluntary nature of vaccination and the opportunity for younger people to be vaccinated earlier. People who are not willing to be vaccinated will not be vaccinated, even if they are over the age 65 threshold. As discussed in Section 2, in municipalities that finished vaccinating people aged 65 and older earlier, those under age 65 have an opportunity to receive COVID-19 vaccination earlier. Therefore, the age 65 threshold does not completely determine vaccination status but rather influences the probability of vaccination.

The age-based priority is useful to identify the political impact of vaccination while excluding confounding factors. It is noteworthy that the age 65 threshold represents whether or not a person will *turn 65 within the fiscal year 2021*. Some social security systems in Japan also use age 65 as a threshold for their eligibility. However, the timing of the change in these eligibilities is *when a person turns 65*. For example, the eligibility for some pensions and public long-term care insurance changes at the timing of the birthday of 65.<sup>18</sup> Hence, the age 65 threshold for vaccination differs from the thresholds for other systems and excludes the political impact other than vaccination.

We use whether the person is older than the age 65 threshold as an instrumental variable (IV) for her vaccination status. Because our running variable is age-in-month, it is fairly unlikely that we have general manipulation problem around the threshold. The institutional

feature explained above implies that the age 65 threshold should affect outcomes only through vaccination status, which is a desirable property of IV. We will statistically check the validity of identification in Section 6.1. The COVID-19 vaccine is supposed to be given two doses, three to four weeks apart. As for vaccination status, we use whether a respondent had received two doses of vaccine or not. Therefore, we estimate the effect of two completed doses of COVID-19 vaccination on political support for the government.

## 5.2 Estimation

Our estimation strategy relies on the fuzzy RD design using the eligibility for PV as an instrument for vaccination status. In our baseline specification, the effect of COVID-19 vaccination on political support and other outcomes is expressed as:

$$Y_i = \alpha_0 + \beta_0 \text{Vaccine}_i + f_{ol}(m_i)\mathbb{1}\{m_i < 0\} + f_{or}(m_i)\mathbb{1}\{m_i \geq 0\} + \varepsilon_i, \quad (1)$$

where  $Y_i$  is the outcome variable for political opinions or other responses of respondent  $i$ . The variable  $\text{Vaccine}_i$  stands for a dummy variable which is equal to 1 if the respondent  $i$  has received two doses of the COVID-19 vaccine. The variable  $m_i$  represents age-in-months and is normalized to zero at the age 65 threshold. Therefore, the respondent  $i$  is eligible for PV for elderly people if  $m_i \geq 0$ . We use  $m_i$  as a running variable in this estimation. The functions  $f_{ol}(\cdot)$  and  $f_{or}(\cdot)$  respectively signify the function of the running variable  $m_i$  on the left and right side of the threshold. The parameter of interest is  $\beta_0$ , denoting the effect of COVID-19 vaccination on political opinions and other outcomes.

The first-stage regression is

$$\text{Vaccine}_i = \alpha_1 + \beta_1 \mathbb{1}\{m_i \geq 0\} + f_{1l}(m_i)\mathbb{1}\{m_i < 0\} + f_{1r}(m_i)\mathbb{1}\{m_i \geq 0\} + \varepsilon_i, \quad (2)$$

where a dummy variable  $\mathbb{1}\{m_i \geq 0\}$  takes a value 1 if  $m_i \geq 0$  and respondent  $i$  is eligible for PV. The dummy variable is used as an instrument for vaccination status. The function  $f_{1l}(\cdot)$  and  $f_{1r}(\cdot)$  respectively signify the function of the running variable  $m_i$  on the left and right side of the threshold. For estimation, we adopt nonparametric local linear and local quadratic regressions with robust confidence intervals proposed by [Calonico et al. \(2014\)](#)



Another important parameter is the political impact of eligibility of PV. The reduced-form specification of above model is

$$Y_i = \alpha_2 + \beta_2 \mathbb{1}\{m_i \geq 0\} + f_{2l}(m_i) \mathbb{1}\{m_i < 0\} + f_{2r}(m_i) \mathbb{1}\{m_i \geq 0\} + \varepsilon_i. \quad (3)$$

The parameter  $\beta_2$  represents the impact of eligibility for PV on political opinions and other outcomes. This parameter corresponds to the one from a sharp RD, which is equivalent to the discontinuity at the age 65 threshold in each figure of outcomes.

The above specifications do not control covariates  $X_i$  because the RD design can identify the parameter of interest without controlling those variables if the continuity assumption holds. We check the continuity assumption of predetermined characteristics in the following section. The advantage of this specification is that respondents with missing covariates can be included in the estimation. In particular, about 20% of respondents in our survey did not provide income information, but these respondents can also be used for estimation. As a robustness check, we also report estimation results when we control for various covariates such as gender, income, employment, education level, health status, and living areas but this estimation comes at the expense of sample size.

## 6 Empirical Results

### 6.1 Continuity Tests

As a validity check for RD design, we examine the continuity of running variable and various predetermined characteristics at the age 65 threshold. Appendix Figure A2 presents the result of density test for age-in-month and show that there is no significant change in the density of age-in-month at the threshold.

Appendix Table A2 reports estimates for the continuity test for covariates and we find that almost all characteristics do not significantly change at the threshold. These results strongly support the continuity assumption of our RD design. The only exception is the change in the fraction of college graduates at the 5% significance level. However, there is no institutional reason for the college graduation rate to change at the threshold and this may reflect the noise

of our data. We find an irregular value at the threshold on this variable, which may drive the result. To check this possibility, we show the results of donut-hole RD (Barreca et al., 2016) by excluding respondents who were born just one month before and after April 1, 1957. Estimates for the donut-hole RD indicates no statistically significant jump including college graduates. These results show that there are no significant discontinuities in key characteristics at the threshold.<sup>19</sup>

## 6.2 Complier Characteristics

The IV estimator identifies the local average treatment effect (LATE), which is the effect of COVID-19 vaccination on the “complier” subpopulation. In our context, compliers are people who receive vaccination only when they are eligible for PV. Before moving to the main results, we check the complier characteristics to clarify which people our estimator focuses on.

To do this, we adopt a method proposed by Marbach and Hangartner (2020) and plot the characteristics of each player in Appendix Figure A3.<sup>20</sup> Always (never) takers are persons who (do not) take the COVID-19 vaccine regardless of their eligibility for PV. In short, compared with never-takers, compliers have more faith in the efficacy of the COVID-19 vaccine and more trust in scientists. Compliers believe that the COVID-19 vaccine prevents more than 80% of fully vaccinated persons from becoming severe conditions, but never-takers believe that it is about 66%. Also, the score for trust in scientists is 16% higher for compliers than for never-takers.<sup>21</sup> These results indicate that our fuzzy RD design estimates the effect of COVID-19 vaccination among a less anti-vaccine, more science-trusting population.

## 6.3 First Stage Results

Next, we examine how the eligibility of PV affects vaccination rates. As in many other countries, receiving two doses of COVID-19 vaccination is officially recommended in Japan because the first dose is considered insufficient to develop an antibody. Figure 2 presents, for each age-

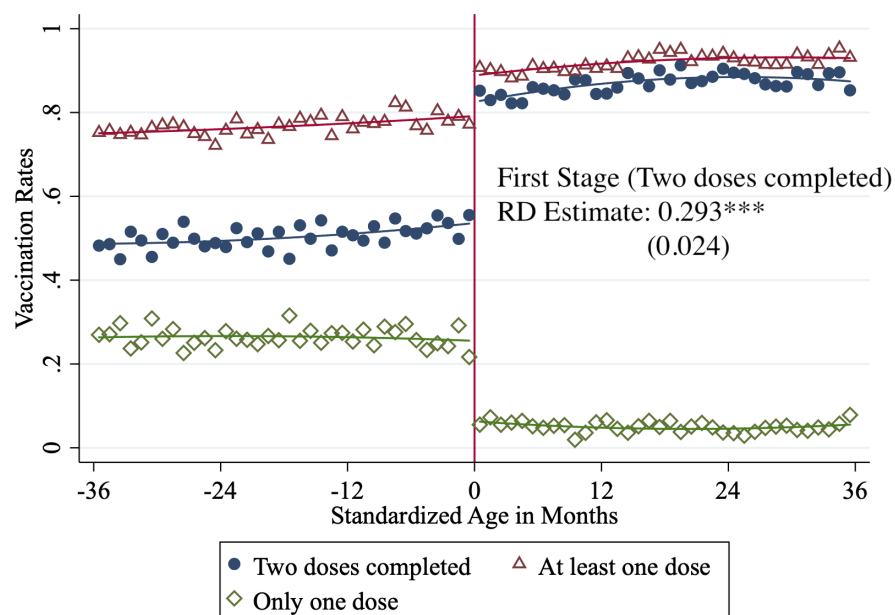

in-month, the percentage of respondents who received two doses, at least one dose, and only one dose. The horizontal axis represents the age-in-month standardized to zero at the age 65 threshold. That is, people who are right to the threshold are eligible for PV.

Figure 2 shows that the eligibility of PV significantly affects vaccination rates. Among those who are not eligible for PV, about 80% have received at least one dose, but only half have completed two doses. Then the age 65 threshold changes these vaccination rates. The most obvious change is in the percentage of respondents who completed two doses. The RD estimate indicates that the eligibility of PV increases the percentage of respondents who completed two doses by 29.3 percentage points. Compared with the mean just before the cutoff age (54%), this increase amounts to more than 50 percent increase in vaccination rates for two doses. The percentage of respondents who have received at least one dose also increases at the threshold. By contrast, the percentage of those who have received only one dose decreases at the threshold, which reflects the increases in those who have received the second dose because of the eligibility of PV.

In estimation, we use whether a respondent has completed two doses of COVID-19 vaccina-

tion as the variable of interest (vaccination status) because it is widely believed that completing two doses is necessary to develop an antibody. Thus the first stage estimates represent the effect of eligibility of PV on the probability of completing two doses. It is important to note that our estimation strategy cannot separately identify the effect of the first dose and the effect of the second dose. This is because, as shown in Figure 2, the eligibility of PV (instrumental variable) affects both the probability of receiving the first dose and the probability of receiving the second dose. Our IV estimates for the parameter of interest in equation (1) represents the effect of COVID-19 vaccination, which is a mixture of the effect of the first dose and the effect of the second dose.

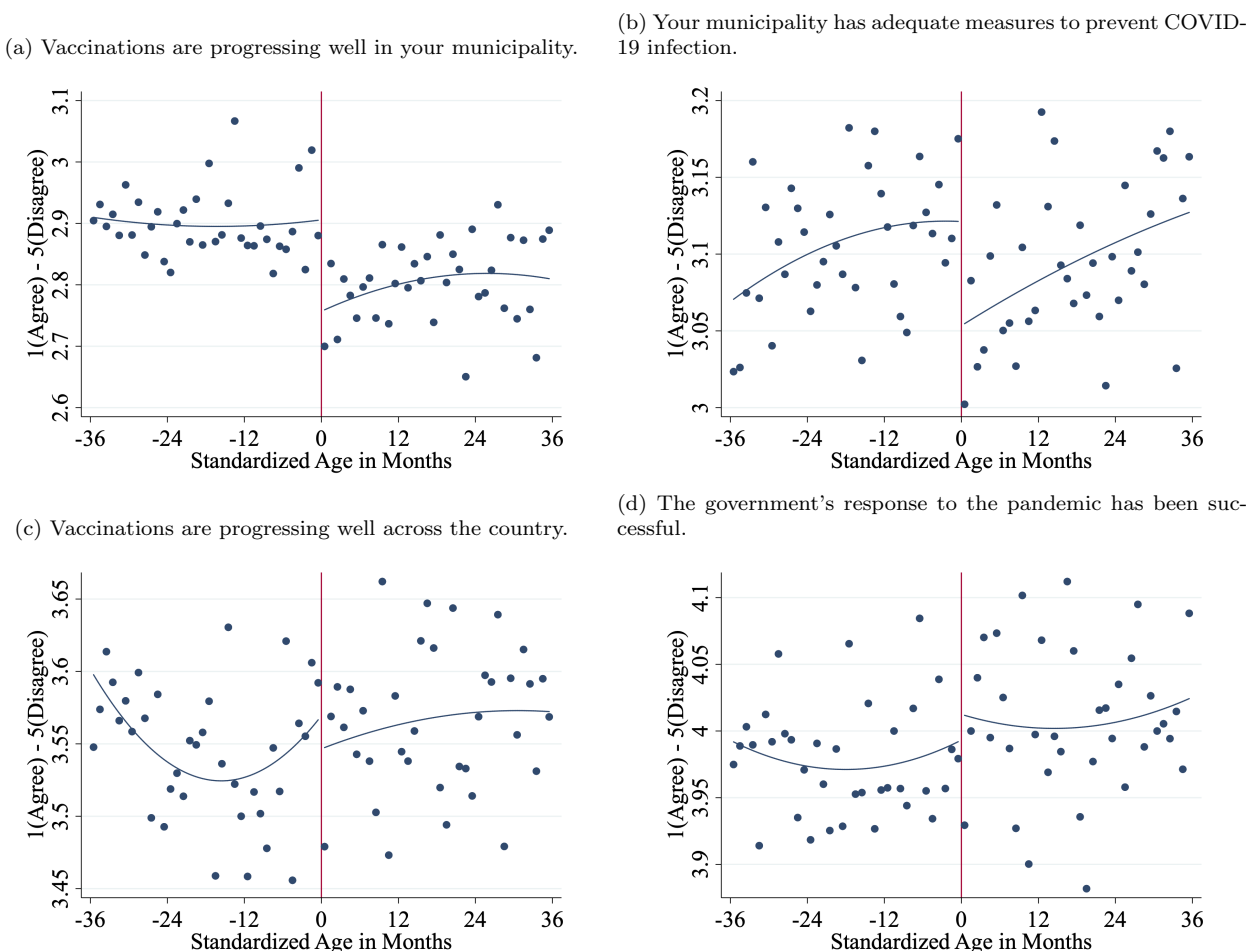
## 6.4 The Political Impact of COVID-19 Vaccination

In this section, we show estimation results for the political impact of COVID-19 vaccination. Figure 3 graphically presents the relation between the eligibility of PV and political support regarding government COVID-19 policies. Panel (a)-(b) represents the support for municipal government and Panel (c)-(d) represents ones for the central government. Each outcome is represented with a 5-point Likert scale ranging from 1 for “agree” to 5 for “disagree”. Based on our political descriptions, the lower the outcome value, the higher the political support.

One important takeaway from Figure 3 is that while the eligibility of PV increases political support for infection control measures by municipalities, it does not affect support for policies by the central government. The discontinuity of outcome at the threshold in Panel (a) shows that the eligibility of PV increases respondents’ favorable opinions on the progress of COVID-19 vaccination in their municipalities. Panel (b) also shows that the eligibility of PV increases favorable opinions on infection control measures by municipalities. On the other hand, outcomes in Panel (c) and (d) have no discontinuity at the threshold. These figures indicate that the eligibility of PV do not have a significant impact on respondents’ opinions on the progress of COVID-19 vaccination nationwide and the central government’s responses to the pandemic.

Table 2 presents estimates for the effect of COVID-19 vaccination on political opinions based on the fuzzy RD design. The first and third columns respectively present fuzzy RD estimates from the local linear regressions and from the local quadratic regression using the robust confidence intervals proposed by Calonico et al. (2014). The descriptions (a)-(d) correspond to the

ones in Figure 3 Panel (a)-(d). Estimates for description (a) indicate that COVID-19 vaccination increases favorable opinions on the progress of vaccination in a municipality by 0.65-0.73 points and these are statistically significant (Note that negative estimates imply increases in political support.). These estimates are equivalent to 22.8–25.4% of the mean of outcome value. Similarly, estimates for description (b) indicate that COVID-19 vaccination increases favorable opinions on municipal government’s infection control measures by 0.41–0.45 points and these are also statistically significant. These estimates are equivalent to 13.1–14.6% of the mean of outcome value. In contrast, as presented in Figure 3, COVID-19 vaccination does not significantly affect opinions on policies by the central government. The fact that estimates for

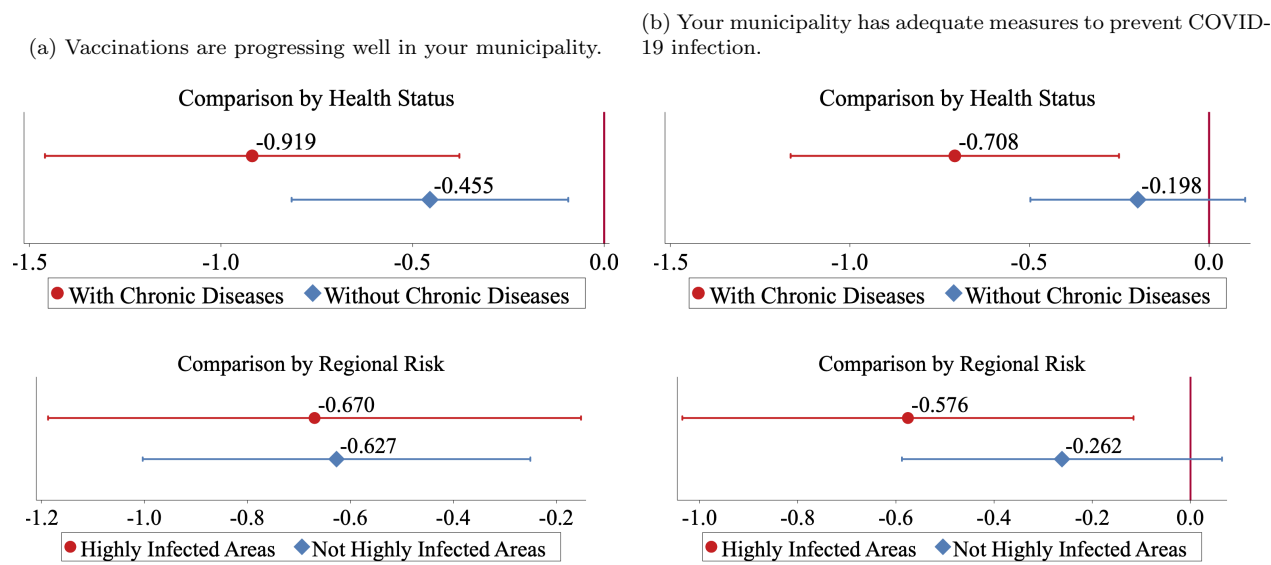

descriptions (c) and (d) are not statistically significant implies that opinions on the progress of vaccination nationwide and on the central government’s responses to the pandemic are largely unaffected by one’s COVID-19 vaccination status.

The above results suggest that the COVID-19 vaccination may have made the efforts of municipal governments to deal with the pandemic more visible. Each municipal government is responsible for administering the COVID-19 vaccination program (securing medical personnel, preparing vaccination sites, distributing vaccination coupons, etc.). Receiving a vaccination coupon and getting vaccinated at a vaccination site might make the effort of municipal government more visible and served as important political information about their policies against the pandemic. Although the central government is responsible for securing COVID-19 vaccines and delivering them to each municipality, it is not directly involved in the actual implementation of vaccination. The estimation results that COVID-19 vaccination does not influence opinions on the central government policies may indicate that vaccination does not make the efforts of the central government visible.

## 6.5 COVID-19 Vaccination and Reciprocity

### 6.5.1 Health Risks

In the following section, we explore factors that drive the impact of COVID-19 vaccination on the political support for the municipal government. First, we examine the influence of people's health risk. It is widely known through government and media publicity that people with underlying medical conditions are more likely to become critically ill from COVID-19. The upper panel of Figure 4 presents estimates for people with and without any of the chronic diseases listed in Section 4.3. Comparing these estimates, people with chronic diseases are more likely to increase favorable opinions on the progress of vaccination and adequacy of infection control measures in their municipality through COVID-19 vaccination. These estimates may reflect the fact that people with chronic diseases are more likely to be grateful for vaccination and take it as important political information. Therefore, the greater impacts on people with chronic diseases may indicate the importance of reciprocal motivation in political support for the municipal government.

The large variation in estimates by health risk with COVID-19 suggests that there may be regional differences in the political impact of COVID-19 vaccination. As a general characteristic

of infectious diseases, the risk of COVID-19 infection is higher in large, densely populated areas. We divide respondents' living areas into highly infected areas and other ones at the prefecture level and separately estimate the political impact of COVID-19 vaccination.<sup>22</sup> The lower panel of Figure 4 compares estimates for the two areas. The estimation results indicate that people living in highly infected areas are more likely to increase favorable opinions of infection control measures by municipalities, but the impact on opinions of vaccination progress is almost identical between the two groups. Therefore, in terms of risk from COVID-19, an individual's health condition was a more important factor in the political impact of vaccination than the risk of infection in living areas.

### 6.5.2 Interpersonal Trust

Given the positive reinforcement between interpersonal trust and reciprocity (Ostrom and Walker, 2003) and empirical evidence on their positive correlation (Altmann et al., 2008; Dohmen et al., 2008), people with high interpersonal trust might increase their political support for the government through reciprocal motives.

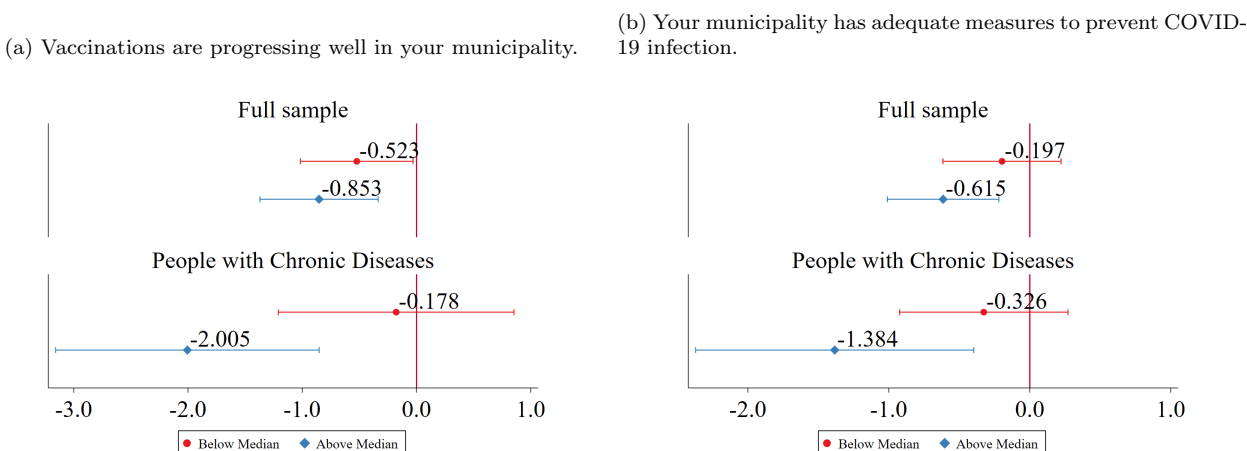
To investigate the relationship between interpersonal trust and political support, we split the sample based on the quartile of the interpersonal trust score and estimate using each sample. We also report the results on the persons with chronic diseases because the political impact of vaccination is much larger among this subsample. The results are summarized in Figure 5. In this figure, the lower (higher) order of the quartile represents the lower (higher) level of interpersonal trust. Panel (a) in Figure 5 shows a clear gradient of the political impact of vaccination by the level of interpersonal trust among persons with chronic diseases. In the first quartile group, the point estimate on the impact of vaccination is very close to zero (-0.153), supporting the null effects of vaccination among persons with the lowest level of interpersonal trust. However, estimates increase as the level of trust increases: Among the fourth quartile group, the estimate is -1.377 which is the highest in the absolute term and statistically significant. In Panel (b), we do not find a clear gradient according to the level of trust, but the estimates are generally higher among persons with a higher level of trust. These results also suggest that people might increase their political support through reciprocal

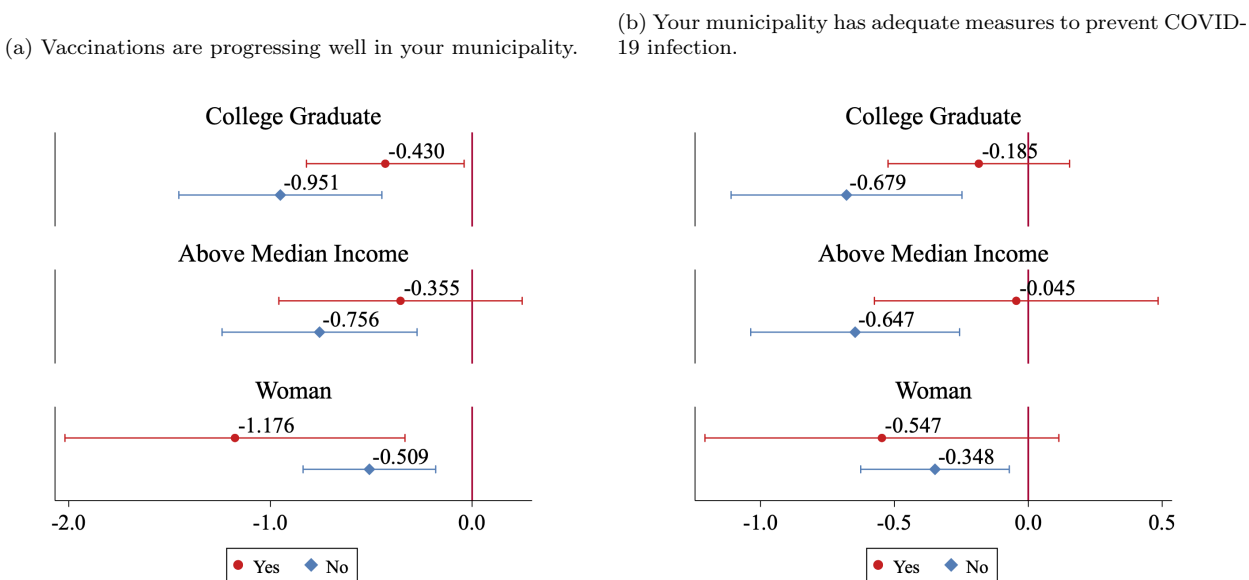
motivation.

## 6.6 Socioeconomic Status and Political Support

The relation between SES and political behavior has long been a central agenda of political science. To examine which people change their political opinions because of vaccination, we estimate the political impact of COVID-19 vaccination for each SES group. We use educational background and income as main components of SES. For education, we divide respondents based on whether they had a college degree. For income, we divide respondents according to whether their household income is above the median among the respondents. We also investigate whether the political impact of COVID-19 vaccination varies by gender.

Figure 6 summarizes the local linear estimates by SES, gender, and the level of interpersonal trust for the same outcomes as in Table 2. With this estimation, we find a substantial difference in the political impact of COVID-19 vaccination by SES. Most importantly, people with low SES are more likely to increase political support because of their own vaccination uptake. Estimates in Panel (a) indicate that those without a college degree and those with lower incomes are more likely to have a favorable opinion of vaccination progress in their municipality. The relation between SES and the political impact of vaccination becomes even more pronounced for infection control measures by municipalities. Estimates in Panel (b) show that COVID-19

vaccination significantly increases favorable opinions of infection control measures by municipalities among those without college degrees and those with low incomes. In contrast, estimates for those with college degrees and those with high incomes are statistically insignificant.

The above estimates indicate that when evaluating government policies, people with low SES are more likely to overvalue their personal experiences than those with high SES. The vaccination status of a single person is supposed to provide little information on the overall vaccination progress and the adequacy of infection control measures. However, if people have limited knowledge about policy consequences in advance, they may evaluate government policies based on their personal experiences, such as having been vaccinated. [Angelucci and Prat \(2021\)](#) empirically show that people with low SES tend to have less accurate information about political news than those with high SES. Our findings can be interpreted as a result of information inequality about government policies by SES: Estimates in Figure 6 suggest that people with lower SES have limited prior political knowledge and that COVID-19 vaccination significantly updates their political opinions. By contrast, those with higher SES may have had sufficient prior political knowledge and thus their political opinions were not affected by vaccination. Estimates in Panel (d) also indicate that, regardless of people's SES, COVID-19 vaccination does not have enough political impact to justify the central government's response to the pandemic.

Previous studies have shown that people with low SES tend to have poorer health than those with high SES (Cutler et al., 2011). In addition, high SES individuals behave more prosocially and trust more (Andreoni et al., 2021). Therefore, our subsample analysis may have confused the two factors of the political impact of vaccination: reciprocal motive and political knowledge. For a more careful interpretation of our subsample analysis, we check the correlation between variables related to reciprocal motive and political knowledge. Table 3 presents correlation coefficients and indicate that variables related to reciprocal motive (chronic diseases, interpersonal trust) and ones related to political knowledge (college graduate, income) are not strongly correlated in our sample. Thus, it can be argued that both reciprocal motive and political knowledge are important factors of the political impact of vaccination.

Another important finding is that the political impact of COVID-19 vaccination varies by gender. In particular, estimates in Panel (a) show that women are more likely than men to increase their favorable opinion of the progress of vaccination in their municipality. The gender difference can be attributed to several reasons. First, it is possible that women are less informed about the government policies in advance. Existing studies show that women are typically less knowledgeable about politics and government than their male counterparts (Lizotte and Sidman, 2009). Therefore, women might be more likely to update their political opinions because of vaccination. Second, it is also possible that women expressed more gratitude to the government for vaccinations because women are generally more reciprocal than men (Croson and Buchan, 1999).

## 7 Discussion

### 7.1 Vaccine, Health Behaviors, and Mental Health

There are other possible mechanisms for the impact of COVID-19 vaccination on political support. One hypothesis is that vaccination may have improved people’s quality of life (QOL), which in turn may have increased their political support. To test this hypothesis, we examine whether COVID-19 vaccination affects people’s lifestyles and mental health. During the pandemic, people have been constrained in social interactions to prevent the spread of infection. For example, people were forced to refrain from eating and drinking in restaurants and participating in large-scale events due to the high risk of infection. The easing of behavioral restrictions due to vaccination may improve people’s QOL and lead to their political support for the government. It is also possible that vaccination reduces the fear of COVID-19 and relieves psychological stress (Agrawal et al., 2021), which may contribute to increased political support.

Table 4 presents estimates for the impact of COVID-19 vaccination on lifestyles and mental health. We examine people’s lifestyles in terms of infection prevention and high-risk behaviors. Both behaviors are quantified by the total score of the responses to questionnaire items summarized in Appendix Table A3.<sup>23</sup> For example, infection prevention behaviors include how careful they are about washing hands and wearing masks, while high-risk behaviors include how often they visit restaurants and participate in large-scale events.

Estimates in Table 4 indicate that COVID-19 vaccination does not significantly affect both infection prevention and high-risk behaviors regardless of respondents’ health condition. These estimates seem counterintuitive, but could be explained by the fact that the infection situation worsened during our survey period. As shown in Figure 1, our survey period coincided with the period of the sharpest increase in the number of infected people in Japan since the beginning of the pandemic. People’s vigilance against COVID-19 was at its peak during this period, as many patients were infected with COVID-19 and became severely ill but could not be hospitalized because of the overwhelmed health care system. As a result, people may not have relaxed their vigilance even though they had been vaccinated. Another factor that made it difficult to

take high-risk behaviors was the declaration of the state of emergency. The state of emergency restricted the business hours of restaurants and other establishments, and large-scale events were refrained from being held. COVID-19 vaccination may not have increased high-risk behaviors because these behaviors were restricted regardless of vaccination status.

Our estimates also indicate that COVID-19 vaccination does not have a significant impact on mental health. According to estimates for all respondents, vaccination slightly reduces the fear of COVID-19 and improves mental health, but these estimates are not statistically significant. A possible reason is that the spread of the infection during the survey period continued to restrict people's activities, and the vaccination did not sufficiently alleviate the psychological stress.

The results above, together with those in section 6, imply that people consider the fact that

they were able to get vaccinated to be important. Please remember that COVID-19 vaccines are given to those who want to receive them in the first place. Also, as discussed in section 6.2, compliers believe in the high efficacy of vaccines and have a high level of trust in science. Because of these facts, people should have a favorable perception of receiving vaccine, even if it did not significantly improve their QOL or mental health. Therefore, the political impact of COVID-19 vaccination is mainly due to the fact that people were able to get the vaccine itself, and not due to changes in lifestyle or mental health.

## 7.2 Comparisons by Risk Preferences

The political impact of COVID-19 vaccination can also depend on people’s risk preference. Risk-averse people may take vaccination as more important political information because they want to reduce their risk of infection with COVID-19 compared to those who are not. In Section 6.4, we show that people at high risk of severe disease due to COVID-19 infection (i.e. those with chronic diseases) are more likely to increase their political support because of vaccination. In addition to actual health risks, how people perceive risk may also influence the significance of the political impact of COVID-19 vaccination.

To examine this hypothesis, we use respondents’ risk preferences measured by the Arrow-Prat absolute risk aversion. Following the existing literature, our survey elicit risk preferences using a hypothetical lottery.<sup>24</sup> Specifically, respondents are asked how much they would be willing to pay for a hypothetical lottery where there is a 50% chance of winning 100,000 JPY (1,000 USD) and a 50% chance of receiving nothing. Respondents are presented with eight different prices in ascending order, from 10 JPY (0.1 USD) to 50,000 JPY (500 USD). For each price, respondents are required to choose whether they buy a lottery or not. Therefore, the reservation price for the lottery should be between the price at which the respondent switches from “buy” to “do not buy”. We define the reservation price as the midpoint of the two prices. The Arrow-Prat measure of absolute risk aversion is calculated based on the reservation price.<sup>25</sup>

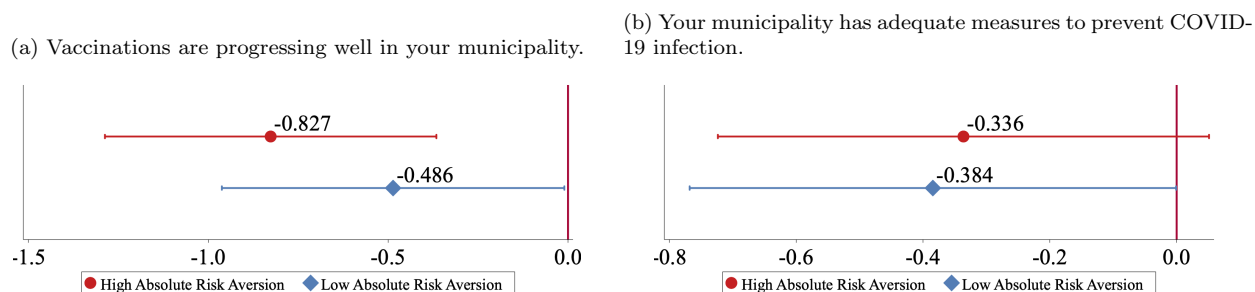
We divide the respondents into two groups based on whether their absolute risk aversion

is higher than the median among respondents or not and compared the estimates. Figure 7 presents estimates of the two groups. The differences between the two groups are evident in their views on the vaccination progress in municipality as shown in Panel (a): Receiving COVID-19 vaccination, only people with high absolute risk aversion significantly increase favorable opinions of vaccination progress. In contrast, Panel (b) show that the effect of COVID-19 vaccination on views on infection control measures by municipalities is almost the same between the two groups. These results indicate that not only actual health risks (chronic diseases) but also how people perceive risk (risk preferences) is a possible factor in the political impact of COVID-19 vaccination, especially for vaccination progress.

### 7.3 Robustness Check

While our RD estimation does not control covariates, the parameter of interest can be identified because the continuity assumption holds. Nonetheless, we report estimates based on estimation controlling respondents' characteristics as a robustness check. We additionally control for gender, income, having a job or not, college graduates or not, having chronic diseases or not, and living in highly infected areas or not.

We also conduct placebo tests using a series of alternative age-in-month thresholds. Specifically, we use age-in-months ranging from 12 months (one year) before and after the true threshold as alternative thresholds. After changing the threshold intentionally, we implement the RD analysis based on local linear regression one by one.

The results of the specification with covariates and the placebo test are summarized in the Appendix B.1 and B.2, respectively. In short, our main results are mostly unchanged even when we control for covariates. The results of the placebo test also show that discontinuous changes in the political support at the age 65 threshold are not due to chance.

## 8 Conclusion

During the COVID-19 pandemic, a variety of infection control measures against COVID-19 has been implemented around the world. These policies are of great interest to the public because they are closely related to people's lives and livelihoods. Despite the great attention, we have very limited knowledge about the political consequences of the infection control measures. This paper examines the political impact of COVID-19 vaccination, which is arguably one of the most effective infection control measures. We conducted a large-scale online survey in a timely manner and implemented RD design by exploiting the age 65 threshold for priority vaccination in Japan. Our survey was conducted at a time when the difference in vaccination rates between those aged 65 and older and those under 65 was greatest.

Our RD estimates provide some important insights into the political impact of COVID-19 vaccination. First, COVID-19 vaccination increases favorable opinions of the vaccination progress in municipalities and infection control measures of municipal governments, while there is no significant effect on policies by the central government. The sharp contrast might reflect the primary role of municipal governments in vaccination roll-out and that their efforts become visible because of vaccination.

Second, people with chronic diseases increase political support more than those without. Because the health benefits of vaccination are high for these people, vaccination may be more appreciated by those at high risk of severe disease from COVID-19 infection. In addition, people with a high level of interpersonal trust increase political support, but those with the lowest level of trust do not significantly change their political opinions. Given the close relationship between interpersonal trust and reciprocity (Ostrom and Walker, 2003; Altmann et al., 2008), this result also suggests that reciprocal motives play an important role in the political evaluation of public policies.

Third, people with low SES are more likely to be politically influenced by COVID-19 vac-



ination, increasing their favorable opinions of policies by municipal governments. Previous research has shown that people with low SES tend to have less political knowledge than those with high SES (Angelucci and Prat, 2021). Our estimates indicate that COVID-19 vaccination significantly updates political information among those with less political information. This result is consistent with the theoretical prediction of voters' learning about government policies based on rational but poorly informed voters (Rogoff, 1990; Manacorda et al., 2011).

Our study focused on voters' evaluations of the government policies, but how the government responds to voters' evaluations can also be an important issue. Especially in a public health crisis such as the COVID-19 pandemic, governments have an incentive to make policies that the public wants in order to maintain support for themselves. Government policies and the public's evaluation of them interact with each other, and this interaction determines the long-term consequences of the policies. It is beyond the scope of this study to analyze the interaction, but this is an important avenue for future research.

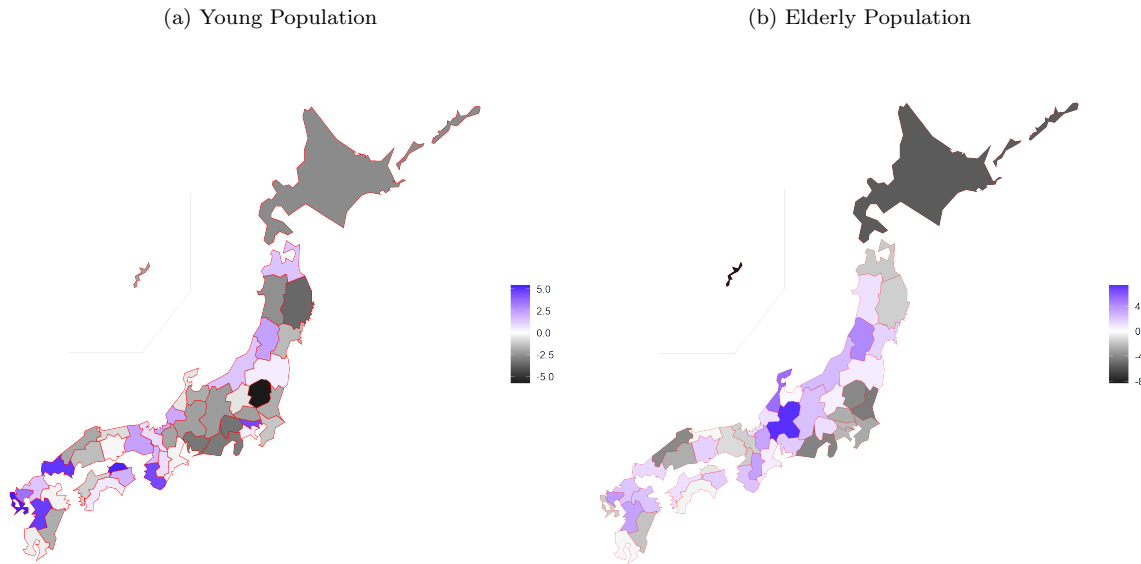

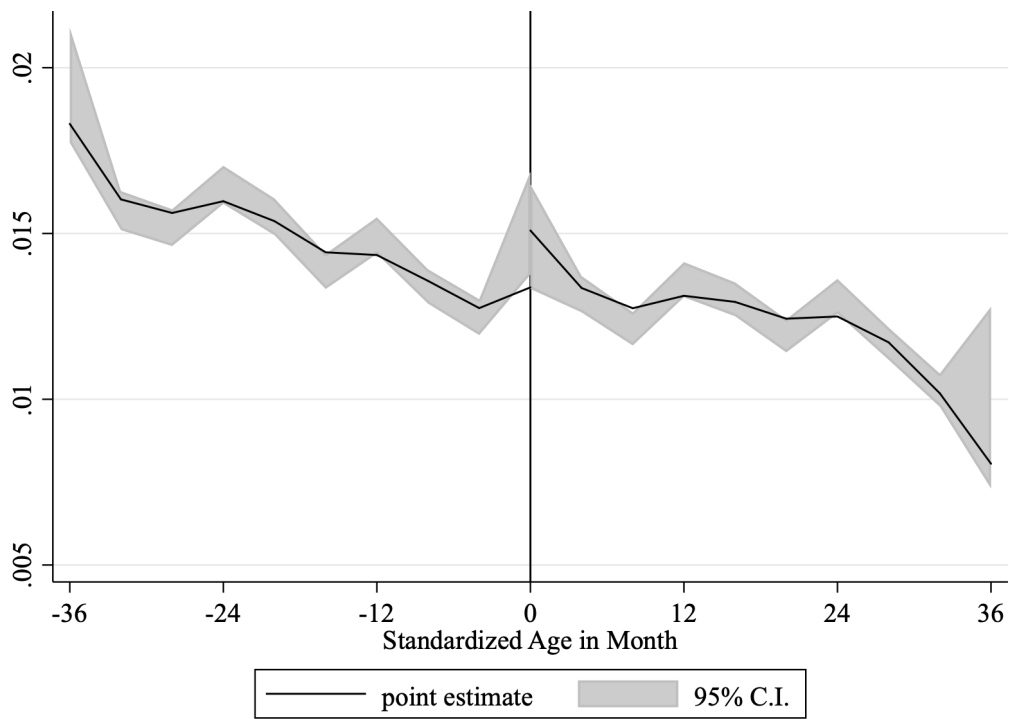


Figure A1: Regional Disparity in Vaccination Rate



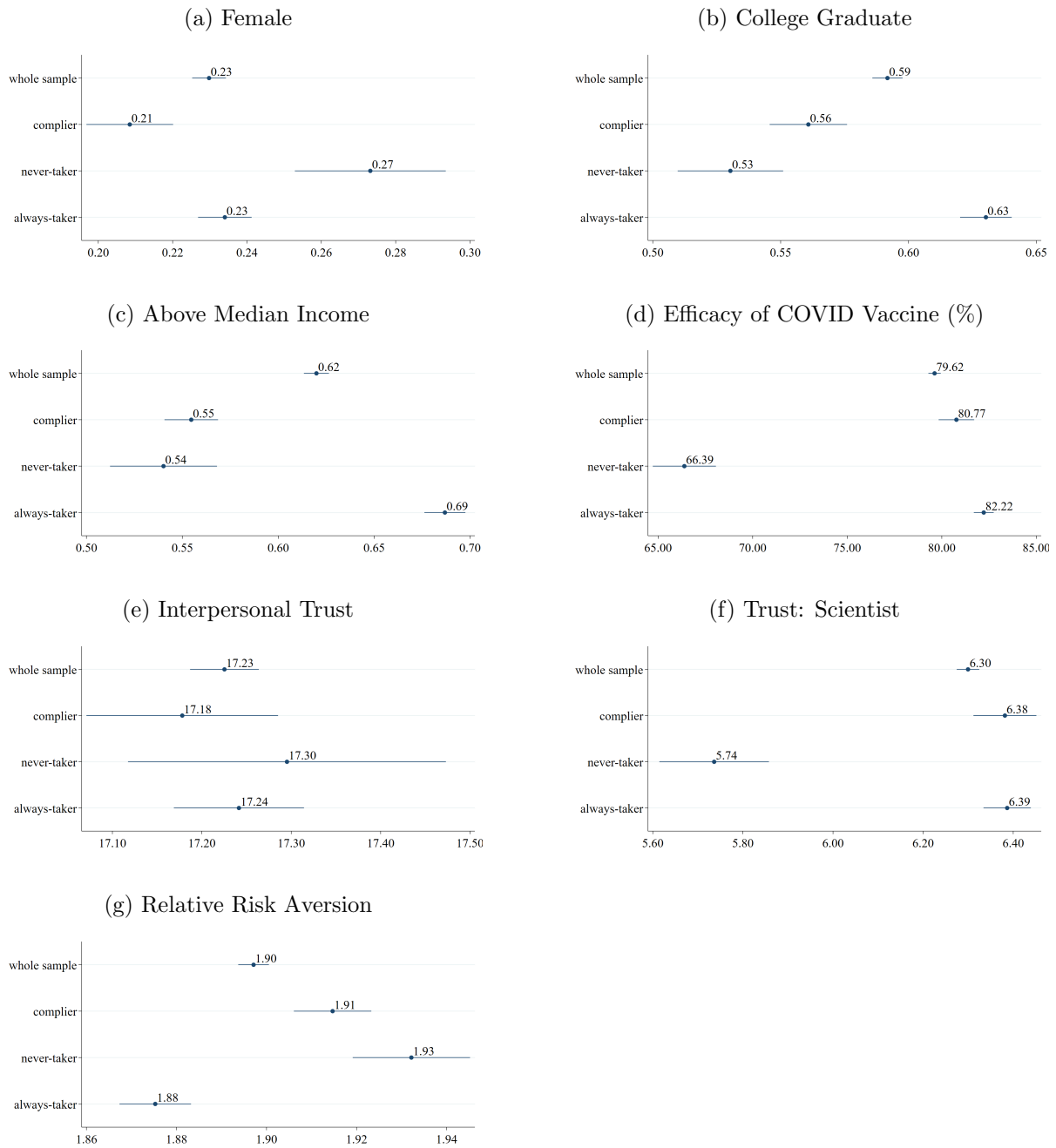

## B Robustness Checks

### B.1 Specification with Covariates

Appendix Table B1 corresponds to Table 2 and presents estimates when controlling for gender, income, having a job or not, college graduates or not, having chronic diseases or not, and living in highly infected areas or not. The sample size of this estimation is smaller than that of the main results because about 20% of respondents do not provide their income information.

Estimates in Appendix Table B1 indicate that our main empirical findings are robust to changes in regression specification. Although estimates for infection control measures by municipal governments are slightly less significant, COVID-19 vaccination increases favorable opinions of the municipal government policies against the pandemic. The estimates also show that COVID-19 vaccination does not affect support for policies by the central government.

Appendix Figure B1 corresponds to Figure 4 and Appendix Figure B2 corresponds to Figure 6. These estimates show that even when we control covariates, people with chronic diseases and low SES are more likely to increase political support due to vaccination. Although the comparison by the regional risk shows ambiguous results, this result reinforces the argument that individual health risk is more important for the political impact of vaccination than regional infection risk. Appendix Table B2 and Appendix Figure B3 respectively correspond to Table 4 and Figure 7. Both estimates control for the covariates described above. COVID-19 vaccination does not significantly affect people's health behaviors and mental health, and the difference in estimates by risk preference is small.

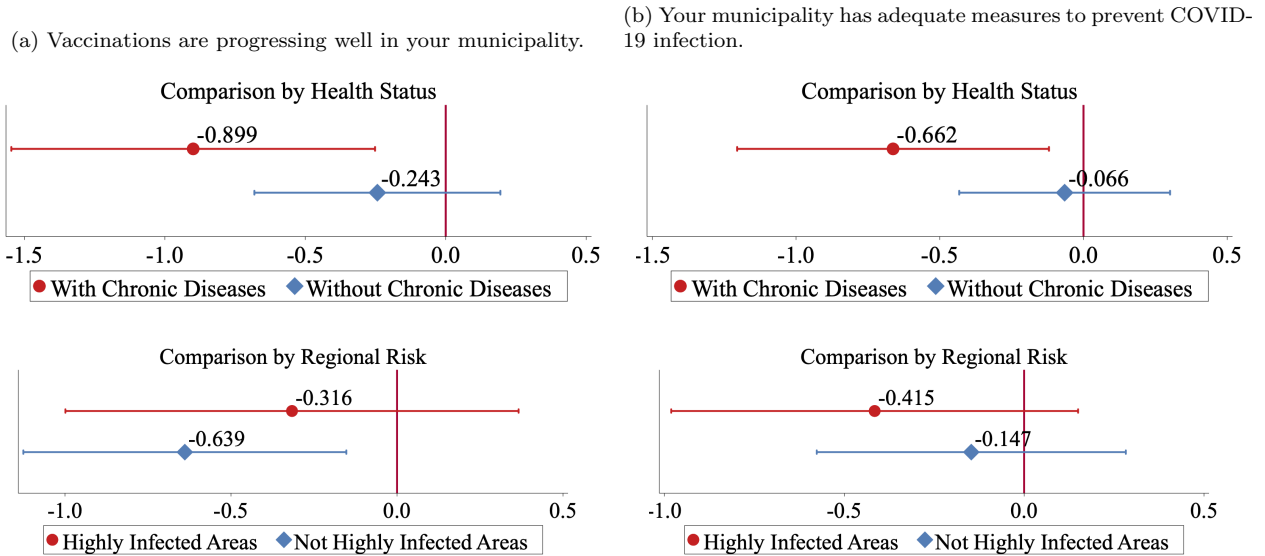

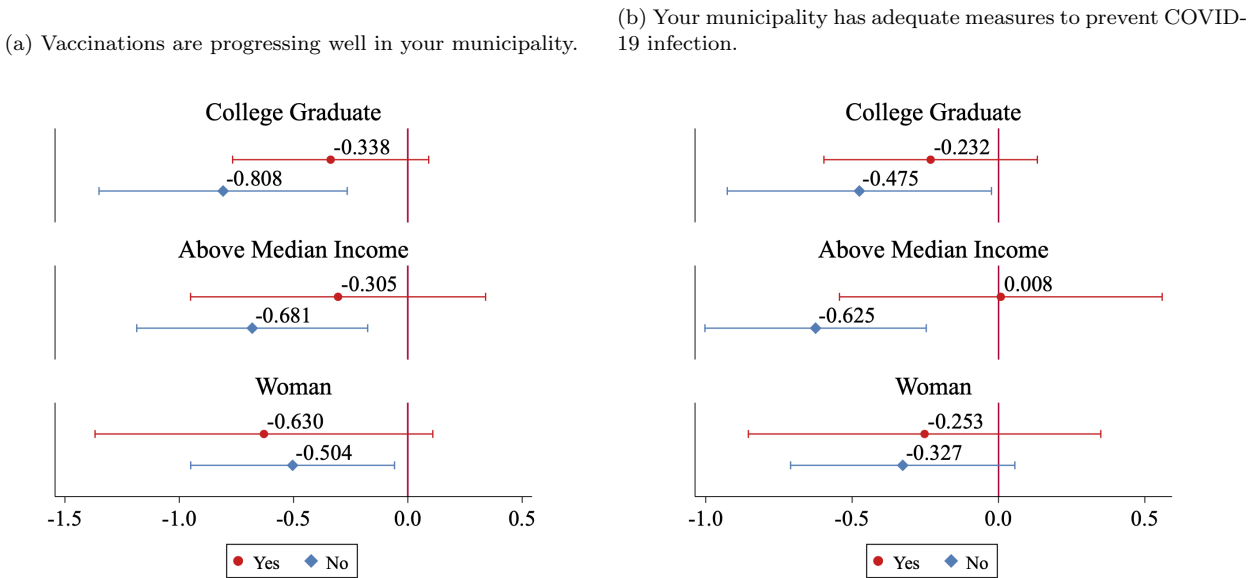

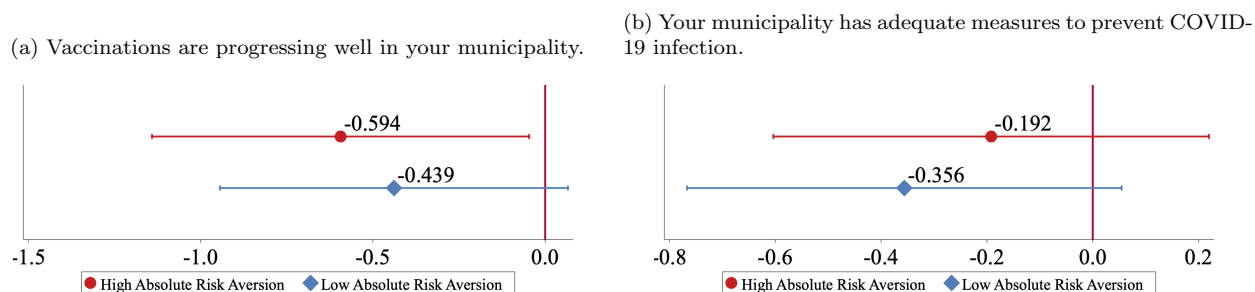
Figure B2: SES and Political Support (Control Covariates)

## B.2 Placebo Test

The results of the placebo tests on vaccination rate and main political outcomes are summarized in Figure B4. Figure Panel (a) in B4 shows the results of vaccination rates. In the horizontal axis, “0” represents the true cut-off month (i.e., April 1, 1957), and negative(positive) sign means that the threshold is moved to several months before(after) April 1, 1957. Here, we see large and statistically significant jump when we set the threshold at “0”, indicating that our result on the vaccination rate is not driven by chance.<sup>26</sup> In addition, we find that RD estimates on the two main outcomes on political support for municipal governments are statistically significant when we adopt “true” threshold. This also indicates that our results on these outcomes are not explained by the noises and irregular measurement errors around the threshold. On the two outcomes on political support for central governments, we see no statistically significant jumps in all alternative threshold points.

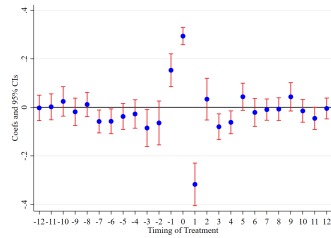
Next, we implement the same placebo test for covariates. In continuity tests for covariates in Table A2, we find statistically significant changes in the fraction of college graduates, while it turns out to be null effect when we implement Donut-hole RD. Figure Panel (b) in B5 shows that, though RD estimate at “true” threshold is statistically significant, we find many statistically significant results on this covariate. For example, we find statistically significant effects when we set the threshold at “3”, “5”, and “9”. This suggests that data on the fraction

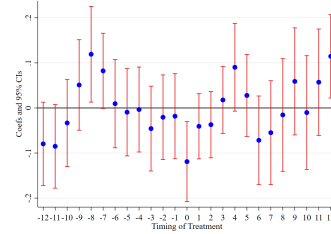
of college graduates in this dataset are somewhat noisy and the statistically significant effects on this variable do not necessary indicate causal effects.

Figure B4: Vaccination Rate and Political Outcomes

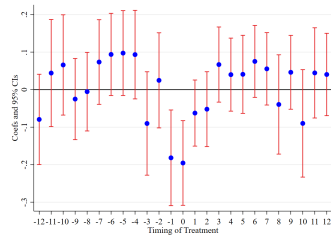
(a) Vaccination Rate



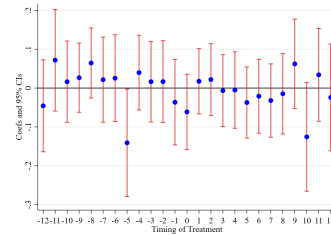
(b) Vaccinations are progressing well in your municipality.



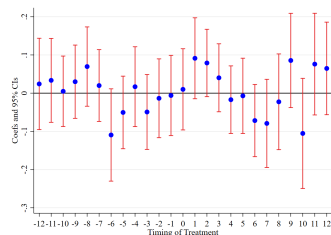
(c) Your municipality has adequate measures to prevent COVID-19 infection.



(d) Vaccinations are progressing well across the country.

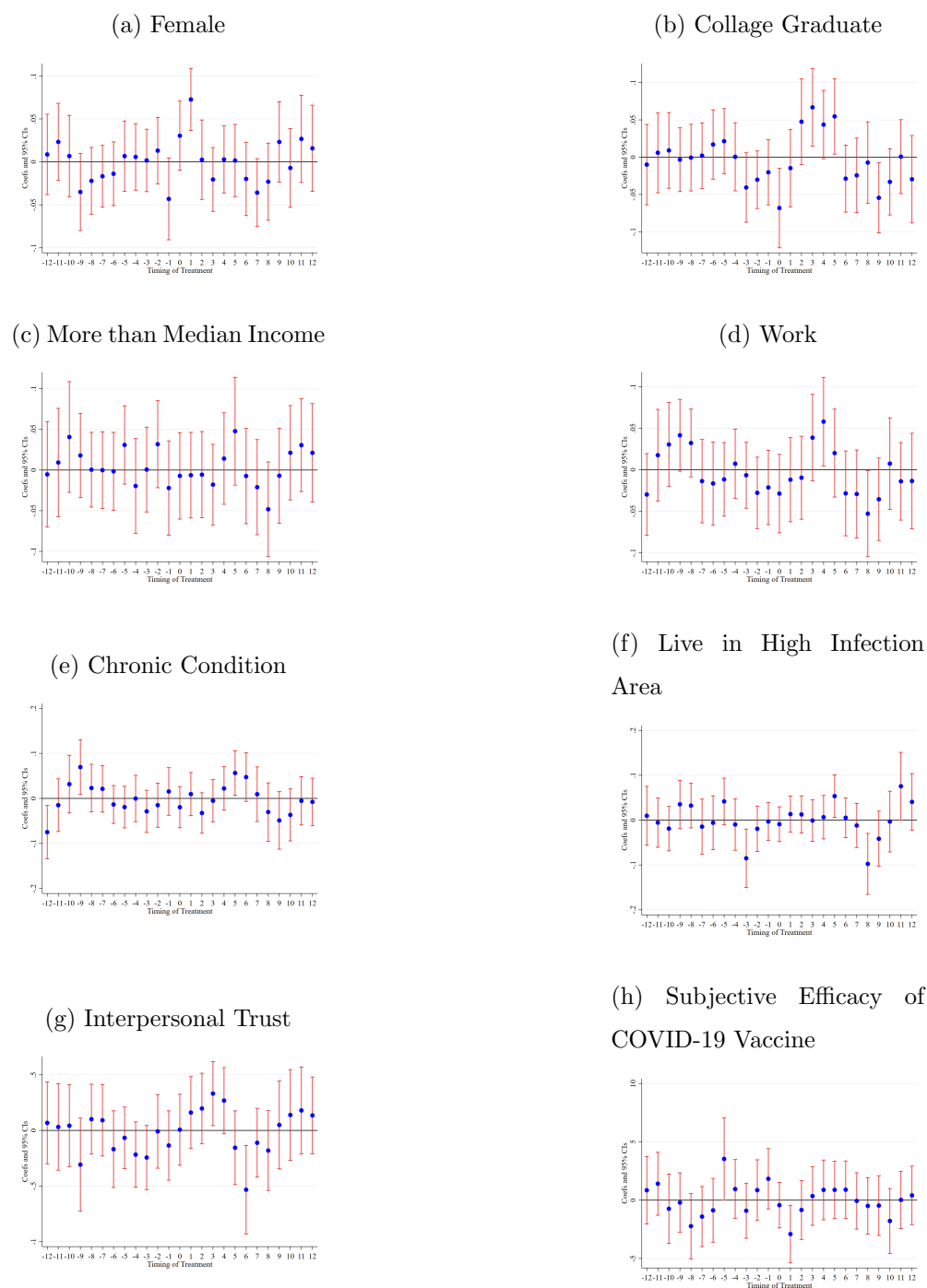


(e) The government's response to the pandemic has been successful.
