# 25 Acute temporal effect of ambient air pollution on common

# congenital cardiovascular defects and cleft palate: a case-crossover study

28 Abstract

29 This symmetric bidirectional case-crossover study examined the association between short-30 term ambient air pollution exposure during weeks 3-8 of pregnancy and certain common congenital 31 anomalies in Ulaanbaatar, Mongolia, between 2014 and 2018. Using predictions from a Random 32 Forest regression model, authors assigned daily ambient air pollution exposure of particulate matter 33 <2.5 um aerodynamic diameter, sulphur dioxide, nitrogen dioxide, and carbon monoxide for each 34 subject based on their administrative area of residence. We used conditional logistic regression with 35 adjustment for corresponding apparent temperature to estimate relative odds of select congenital 36 anomalies per IQR increase in mean concentrations and quartiles of air pollutants. The adjusted 37 relative odds of cardiovascular defects (ICD-10 subchapter: Q20-Q28) was 2.64 (95% confidence 38 interval: 1.02-6.87) per interquartile range increase in mean concentrations of particulate matter <2.5 39 um aerodynamic diameter for gestational week 7. This association was further strengthened for cardiac septal defects (ICD-10 code: Q21, odds ratio: 7.28, 95% confidence interval: 1.6-33.09) and 40 41 isolated ventricular septal defects (ICD-10 code: Q21.0, odds ratio: 9.87, 95% confidence interval: 42 1.6-60.93). We also observed an increasing dose-response trend when comparing the lowest quartile 43 of air pollution exposure with higher quartiles on weeks 6 and 7 for Q20-Q28 and Q21 and week 4 44 for Q21.0. Other notable associations include increased relative odds of cleft lip and cleft palate 45 subchapter (Q35-Q37) and PM<sub>2.5</sub> (OR: 2.25, 95% CI: 0.62-8.1), SO<sub>2</sub> (OR: 2.6, 95% CI: 0.61-11.12), 46 and CO (OR: 2.83, 95% CI: 0.92-8.72) in week 4. Our findings contribute to the limited body of 47 evidence regarding the acute effect of ambient air pollution exposure on common adverse birth 48 outcomes.

## 49 Background

50 Congenital anomalies pose a significant risk of global infant mortality, life-long illness, 51 disability and have a heavy burden on resource-scarce countries. Worldwide estimates show that 52 about 13% of total mortality among children under five years of age was due to congenital anomalies 53 (CA) in 2016 (World Health Organization, 2017). The most common forms of major CA include 54 congenital heart defects, cleft lip and palate and neural tube defects. Although CA are a global 55 problem, 94 percent of births with severe congenital malformations and 95 percent of the mortality 56 among these children occur in middle and low-income countries. Maternal health and other risk 57 factors such as poverty, a higher proportion of older mothers, and a larger frequency of 58 consanguineous marriages partly explain this significant difference. In terms of aetiology, about half 59 of all major CA are unknown and hypothesized to have multiple causal factors, including 60 environmental exposures (Christianson et al., 2005).

61 Our previous work looking at the short-term effect of air pollution on the occurrence of 62 stillbirth (Enebish et al., 2022) found a significantly increased risk of exposure to high air pollution 63 on days 3 and 6 prior to delivery of a stillbirth. In comparison to stillbirth, there have been a 64 significant number of studies investigating the association between air pollution and CA. Ritz et 65 al. used data from the California Congenital anomalies Monitoring Program to look at associations 66 between CA and average monthly ambient air pollution. To our knowledge, it was the first attempt 67 to explore these associations using case-control design with individual-level data for confounding 68 controls. They found an increased risk of cardiac ventricular septal defects with a dose-response 69 trend as well as increased risks for several other CA (B. R. Ritz et al., 2002). Since then, research 70 groups in the US and around the world have conducted a significant number of case-control studies 71 investigating the association, including Texas (Gilboa et al., 2005), New Jersey (Marshall et al., 2010), 72 California (Padula et al., 2013), Taiwan (Lin et al., 2014), the UK (Dadvand et al., 2011; Dolk et al.,

73 2010; Rankin et al., 2009), Australia (Hansen et al., 2009), Israel (Agay-Shay et al., 2013), Spain 74 (Schembari et al., 2014), and Italy (Gianicolo et al., 2014). The results of these studies varied 75 considerably, probably due to design heterogeneities derived from different case ascertainment 76 procedures and exposure assessment methodologies. A few reviews have attempted to synthesize 77 the findings and found suggestive evidence of increased congenital cardiac anomaly risk associated 78 with NO<sub>2</sub>, SO<sub>2</sub>, and PM<sub>2.5</sub> (Vrijheid et al., 2011) as well as a significant association between NO<sub>2</sub> and 79 coarctation of the aorta (Chen et al., 2014). While these studies utilized state or country-wide 80 congenital anomaly surveillance systems for outcome ascertainment, the exposure assessment was 81 usually limited to either spatial gradient based on distance from monitoring stations or temporal 82 gradient based on gestation periods. This kind of exposure assessment may lead to substantial 83 exposure misclassification, exacerbating the residual confounding problem of using registry data 84 with limited covariate information.

85 Although the biological mechanism of how air pollutants may cause congenital anomalies is 86 unknown, several plausible pathological pathways have been proposed based on laboratory studies. 87 Several studies showed that polycyclic aromatic hydrocarbons (PAH) products attach to DNA, 88 activating DNA repair processes and producing DNA adducts, changing gene function and altering 89 foetal development (Perera et al., 1999). Oxidative stress and inflammatory cytokines triggered by air 90 pollution can adversely affect the foetus via a change in placental functions such as trophoblast 91 proliferation and differentiation as well as apoptosis (Jonakait, 2007; Kannan et al., 2006; Slama et 92 al., 2008). The other possible mechanisms relate to phenotypical changes caused by air pollution due 93 to epigenetic processes such as DNA methylation and acetylation, histone modifications, and 94 microRNA expressions (Baccarelli & Bollati, 2009; Hou et al., 2012). Some studies demonstrated 95 that decreased placental or global methylation is associated with increased PM2.5 and PAH 96 (Herbstman et al., 2012; Janssen et al., 2013).

97	Ulaanbaatar (UB), the capital city of Mongolia, has hazardous levels of air pollution during
98	winter due to more than half of its residents burning coal for domestic heating, combined with an
99	atmospheric inversion that traps emissions within the breathing zone. Infant mortality rates in
100	Mongolia have substantially declined in the last 20 years: 63.4 per 1000 live births in 1990 to 13.4 per
101	1000 live births in 2018. However, the proportion of deaths due to congenital anomalies has
102	increased from 12.7 percent in 2014 to 16 percent in 2018 (Comprehensive Survey of the Status of Maternal
103	and Child Morbidity and Mortality, and Prevalence of Congenital Anomalies in Mongolia - $V$ , 2019). We have
104	seen some alarming results indicating high attributable mortality (Allen et al., 2013) due to air
105	pollution and a strong correlation with miscarriage (Enkhmaa et al., 2014) in the city. Previously, we
106	have mitigated the exposure measurement limitations (inadequate and unreliable monitoring
107	network) of a resource-poor country like Mongolia by utilizing machine learning algorithms for
108	exposure assessment (Enebish et al., 2020). Also, the authors used an electronic surveillance
109	database to ascertain outcomes to overcome the constraints of an overworked and underfinanced
110	healthcare system (Enebish et al., 2022).
111	The objective of the current study was to investigate the short-term effects of ambient air
112	pollution on the risk of delivering a new-born with select common congenital anomalies in
113	Ulaanbaatar, Mongolia. Specifically, we examined 1) different gestational weeks of exposure periods

and 2) risks of select congenital anomalies according to ICD-10 for both continuous and categorical(dose-response) exposure.

## 116 Methods

Ulaanbaatar city registered about 200,000 live births between 2014 and 2018. During this
period, there were 1487 cases of CA which resulted in a rate of 7.3 per 1000 live births. This rate is
slightly lower than the national average of 8.1 per 1000 live births. The current study includes CA

occurring between January 1, 2014, and December 31, 2018, in UB. The Institutional Review Boards
at the Health Sciences Campus of USC and the Children's Hospital Los Angeles and the Medical
Ethics Committee of the Ministry of Health of Mongolia approved the study design and methods.

123 Study population

124 We obtained individual-level CA data from the Surveillance Department of the National Center for Maternal and Child Health of Mongolia (NCMCH). In 2014, the Ministry of Health 125 126 established the department to set up a nationwide active surveillance system for maternal and child 127 health indicators such as maternal mortality, stillbirth, and congenital anomaly. The study team 128 acquired data between 2014 and 2018 from the CA data collection form enumerated in the 129 electronic database. The translated version of the data collection form for CA can be found in 130 Supplemental Materials. The following information was abstracted from the form: maternal age, residential address, education, occupation, parity, smoking status, folic acid usage, date of birth, 131 132 foetal gender, weight, and gestational age. Gestational age was defined by the best obstetric estimate 133 variable in the birth record, which combines the last menstrual period and ultrasound parameters, as 134 is commonly accepted in clinical practice for gestational age estimation. The WHO defines 135 congenital anomalies as structural or functional anomalies that occur during the intrauterine period 136 and can be identified prenatally, at birth, or sometimes may only be detected later in infancy (Joint 137 WHO-March of Dimes Meeting on Management of Birth Defects and Haemoglobin Disorders 138 (2nd : 2006 : Geneva et al., 2006). For the current study, eligible cases were singleton births, having a 139 maternal residential address in one of the six central districts, and were non-chromosomal CA 140 (Figure 1) having one of 7 CA categories. However, due to a low number of cases, we were only able 141 to analyse five subchapters of ICD-10 chapter Q00-Q99 (Congenital malformations, deformations, 142 and chromosomal abnormalities), one major diagnosis, and one isolated defect (Table 1) in this 143 study (World Health Organization, 2004). We also added Khoroo (small administrative unit of the

- 144 city) level variables such as percentage of households with internet connectivity (a proxy for
- socioeconomic status), percentage of Ger (traditional portable dwelling) households, and a number
- 146 of stoves per square kilometre based on the residential Khoroo of each subject.

#### 149 Exposure data

150 We used daily air pollution estimates derived from a previously developed and validated 151 spatiotemporal model, linking them to the residential Khoroo and averaging over the week for the 152 relevant dates of each CA case. We also calculated apparent temperature using atmospheric 153 temperature and wind speed or relative humidity based on the atmospheric temperature of 154 corresponding weeks to control it. The authors covered the details of our prediction models 155 (Enebish et al., 2020) and how we applied them to an adverse reproductive outcome (Enebish et al., 156 2022) in our previously published works. In addition to continuous exposure measures, we 157 calculated quartiles of each pollutant assigned to our control and case periods to look at the dose-158 response gradient.

#### 161 Study design

162 The symmetric bidirectional case-crossover design was used to estimate the relative odds of 163 specific CA associated with each interquartile range (IQR) increase in mean pollutant concentrations 164 and 2nd-4th quartile compared to the lowest quartile. We used a case-crossover design with a 165 different referent period selection method in our previous work on the association between stillbirth 166 and ambient air pollution (Enebish et al., 2022). The current study utilizes symmetric bidirectional 167 referent selection instead of time-stratified referent selection. Unlike time-stratified referent 168 selection, bidirectional selection creates non-localizable referent windows, which means that the 169 conditional logistic regression estimating equations are somewhat affected by overlap bias. However, 170 Janes et al. noted that the bias is usually small, particularly for symmetric bidirectional designs (Janes 171 et al., 2005). This control selection method still allows us to control long-term and seasonal time 172 trends by design. We could not use more robust time-stratified referent selection because there is no 173 identifiable single event date for congenital anomalies due to their nature. Instead, we considered 174 susceptible gestational weeks as our case periods and the weekly averages with a one-week wash-out 175 period in both directions as control periods. We looked at gestational weeks 3-8 as susceptible 176 periods since most active foetal organ development happens during this time, thus making them 177 vulnerable to environmental teratogens. For instance, we designated week one and week five as

controls when we considered week three as our case period in our analyses. Gestational weeks were
determined based on conception dates which we calculated by subtracting gestational weeks at birth
from the birth dates of each subject.

#### 181 Statistical analysis

182 We used conditional logistic regression to estimate the effect of ambient air pollution ( $PM_{2.5}$ , 183  $SO_2$ ,  $NO_2$ , and CO) on the occurrence of the selected CA during vulnerable periods of gestation. 184 Like our previous study on stillbirth, we estimated log odds of each CA per IRQ increase in 185 continuous measures and quartiles with the lowest as a reference in categorical measures. All models 186 were adjusted for the weekly mean apparent temperature of corresponding gestational weeks to 187 control time-dependent confounding. Confounders such as age, socioeconomic status, and 188 comorbidity were considered unchanged in the short term and therefore controlled by study design. 189 Ambient air pollution exposure quartiles were examined to determine whether there are identifiable 190 dose-response curves for any of the CA and determine their shape. We evaluated influential 191 gestational weeks of exposure based on the magnitude and pattern of the observed risk estimates 192 and their confidence interval widths. All statistical modelling and geospatial computing were 193 performed in R version 3.6.2 (R Core Team, 2019) using packages "tidyverse" (Wickham et al., 2019), "sf" (Pebesma, 2018), and "survival" (Therneau & Grambsch, 2000). 194

## 195 **Results**

After applying the inclusion and exclusion criteria, our study population consisted of 968
congenital anomaly cases between 2014 and 2018 (Figure 1). We show the demographic and
residential factors of the study subjects by CA groups in Table 2. About one in five mothers were 35
years or older, and most of them had graduated college or trade school (61%) and were employed
(63%). Only about 6% of the mothers reported smoking, while 43% had used folic acid supplements
within the first 12 weeks of gestation. Most mothers had previously given birth (65%), and the foetal

202 gender was majority male (58%). Regarding residential Khoroo characteristics, more mothers were

- 203 from Khoroos with less connectivity to the internet, more Ger households, and higher stove density.
- 204 There were no substantial differences between CA groups for any demographic or residential
- characteristics.

208	Odds ratio (OR) estimates and their 95% confidence intervals (95% CI) for each IQR
209	increase in mean pollutant concentrations for every CA group examined by different gestational
210	weeks are shown in Tables 3 and 4. We observed significantly increased relative odds (OR: 2.64,
211	95% CI: 1.02-6.87) of cardiovascular defects (Q20-Q28) per IQR increase in mean $PM_{2.5}$
212	concentration in week 7 (Table 3). This association with $PM_{2.5}$ was strengthened in the subgroup of
213	cardiac septal defects (OR: 7.28, 95% CI: 1.6-33.09) and isolated ventricular septal defects (OR: 9.87,
214	95% CI: 1.6-60.93). We also obtained similar significantly increased relative odds of cardiac septal
215	defects (OR: 3.12, 95% CI: 0.99-9.82) and isolated ventricular septal defects (OR: 3.96, 95% CI:
216	1.05-14.93) per IQR increase in mean concentrations of CO in week 7. The relative odds of the
217	association between $PM_{2.5}$ and ventricular septal defects were increased on week 4 (OR: 6.01, 95%)
218	CI: 1.04-34.7) as well (Table 3). Other notable associations include increased relative odds of cleft lip
219	and cleft palate subchapter (Q35-Q37) and $PM_{2.5}$ (OR: 2.25, 95% CI: 0.62-8.1), SO <sub>2</sub> (OR: 2.6, 95%
220	CI: 0.61-11.12), and CO (OR: 2.83, 95% CI: 0.92-8.72) in week 4 (Table 4). We did not see
221	consistent effects on any of the other ICD-10 CA subchapters.

Estimates of relative odds and their 95% CI derived from comparing the lowest quartile of

237 PM<sub>2.5</sub> concentration with 2nd-4th quartiles are presented in Figures 2-6. Our primary goal was to

238 visually show the general trend of dose-response for different types of CA instead of specific

numbers due to the instability of effect estimates caused by a small sample size. For brevity, we
show estimates of the short-term effect of PM<sub>2.5</sub> on cardiovascular, musculoskeletal, cardiac septal,
and ventricular septal defects (VSD) as examples. We observed dose-response patterns for weeks 6
and 7 for cardiovascular and cardiac septal defects, but for VSD, the increasing dose-response trend
occurred in week 4. A less pronounced dose-response trend was observed in weeks 4 and 8 for
musculoskeletal anomalies and cleft lip and palate. We found similarly suggestive dose-response
patterns in different pollutants, gestational weeks, and congenital anomalies (results not shown).

#### 256 Discussion

257 We found a considerably increased short-term risk of cardiovascular defects, particularly 258 cardiac septal defects, associated with per IQR increase in mean concentrations of PM2.5 and CO in 259 gestational week 7. This association was further observed to have dose-response gradients when 260 using categorical exposure measures. Although there have been multiple studies looking at the 261 association between ambient air pollution and congenital anomalies in recent years (Girguis et al., 262 2016; Huang et al., 2019; Lavigne et al., 2019; Vinceti et al., 2016; Zhang et al., 2016; Zhao et al., 263 2018), our results contribute substantially to the evidence base on short-term effects of air pollution 264 on congenital anomalies by looking at susceptible periods of foetal development at fine temporal 265 detail. To our knowledge, this is the first study to utilize case-crossover design to control for time-266 invariant confounders in examining the association between ambient air pollution and congenital 267 anomalies.

268 The findings of our study suggest that there may be differential effects of air pollutants 269 within the critical period of foetus development (weeks 3-8). This is corroborated by embryological 270 studies on lab animals showing specific stages of organ development. For instance, neural crest cells 271 start migrating to develop endocardial tubes at the start of the fourth week, resulting in ventricular 272 septation and outflow tract formation by weeks 7 and 8 in cardiac development (Gittenberger-de 273 Groot et al., 2005). There is also evidence of teratogen-induced oxidative stress in earlier weeks 274 affecting later developments of cardiac structures via apoptosis among migrating cells (Morgan et al., 275 2008) or different pathway of neural crest cells (Jain et al., 2011). Therefore, it is possible that 276 harmful air pollutant exposure at a particular gestational week may not present itself in the form of 277 CA until later weeks. Additional experimental studies to elucidate this relationship are needed.

278 In contrast to previous studies, we could not look at isolated congenital anomalies except for 279 VSD due to the small sample size in each of the ICD-10 subchapters. This is important since it is 280 unlikely that a specific air pollutant would affect all types of anomalies and that even single, isolated 281 anomalies could have multifactorial aetiology (B. Ritz, 2010). With that said, our finding of an 282 association between cardiovascular defects and particulate matter is consistent with several earlier 283 case-control studies (Agay-Shay et al., 2013; Huang et al., 2019; Padula et al., 2013; Stingone et al., 284 2014; Zhang et al., 2016). Most of the previous literature on the topic considered somewhat coarse 285 temporal resolution when it comes to vulnerable periods of development by using either monthly 286 averages of the first three months of pregnancy or average of gestational weeks 3-8. Below we 287 compare our results to a few studies examining specific gestational week exposures. Stingone et 288 al. examined maternal exposure to criteria air pollutants and congenital heart defects using the US 289 National Congenital Anomalies Prevention Study data. They used both 1-week and 7-week averages 290 of pollutants using the closest monitoring station to the maternal residence and found several 291 individual exposure-weeks associations that were not identified from 7-week averages (Stingone et 292 al., 2014). Specifically, the association between VSD and particulate matter was stronger in week 293 three than in week 4 in our categorical exposure findings (Figure 6). Two studies from Wuhan, 294 China, looked at the association between air pollution and the risk of congenital heart defects (Zhang et al., 2016) and oral clefts (Zhao et al., 2018). Zhang et al. found monotonically increasing 295 296 relative odds of VSD per  $10\mu g/m^3$  increase in mean PM<sub>2.5</sub> concentration during gestational weeks 7-297 10. This is somewhat comparable to our finding of significant association between VSD and per 298 IQR increase in the mean concentration of PM<sub>2.5</sub> in week 7. On the other hand, Zhao et al. reported 299 an increased risk of oral cleft associated with per  $10\mu g/m^3$  change in PM<sub>2.5</sub> in gestational weeks 4-9. 300 In contrast, we found increased relative odds of cleft lip and cleft palate subchapter and PM<sub>2.5</sub>, SO<sub>2</sub>, 301 and CO in week 4 (Table 4).

302 In order to interpret our findings in the context of current literature, we must keep in mind 303 the emission source of air pollution in UB. As we noted before, the dominant source is domestic 304 coal combustion due to the need for heating and cooking in Ger districts during harsh winters 305 exacerbated by atmospheric inversion and lower mixing height during cold seasons. This is an 306 important and distinct emissions source as compared to manufacturing in developing countries and 307 vehicular emission in developed countries. The composition of particulate matter may be 308 substantially different from compositions in other countries, and this may differentially affect the 309 susceptible windows of organ development with regards to specific CA. Considering this and the 310 relatively homogenous population of Mongolia, the generalizability of our study results may be 311 limited. However, despite these differences, it is suggestive to see partially consistent results with 312 previous studies.

313 Estimating personal exposure via prediction modelling based on scarce ground-level 314 monitors will inevitably lead to measurement error in exposure regardless of the model performance. 315 In addition, we were only able to predict air pollution exposure based on the residential 316 administrative unit (Khoroo) at the time of delivery. However, a recent study on the effect of 317 residential mobility during pregnancy on air pollution exposure misclassification found a minor 318 impact (Warren et al., 2018). Measurement errors resulting from the above reasons will be non-319 differential and will likely lead to underestimating the risk. The other limitation of our study was the 320 inadequate sample size for investigating the effect of air pollutants on isolated congenital anomalies 321 rather than ICD-10 subchapters that covered an extensive range of congenital anomalies with 322 possibly differing aetiologies. This was unavoidable due to the relatively recent establishment of the National Surveillance Department in Mongolia and will only strengthen as time goes by. 323

324	This study observed increased relative odds of select CA with short-term, higher exposure to
325	air pollutants at specific periods of gestation critical for organogenesis. Some of the associations
326	were only on specific weeks. They had a dose-response trend, which suggests that accounting for
327	temporal and spatial variability may lead to a better understanding of how and when air pollutants
328	affect CA risk. Future studies in this research area should focus on improving exposure assessment,
329	incorporating a multipollutant approach, and ascertaining more isolated congenital anomalies to
330	facilitate the investigation into different susceptible windows of various congenital anomalies.
