# What (if anything) is going on? Examining longitudinal associations between social media use and mental ill-health among young people

# Abstract

Objectives: In mid-adolescence, to 1) examine cyclical associations between social media use and mental ill health by investigating longitudinal and bidirectional associations, dose response relationships, and changes in social media use and in mental health; 2) assess potential interaction effects between social media use and mental health with pre-existing early life vulnerabilities. Methods: Longitudinal data on 12,114 participants from the Millennium Cohort Study on social media use, depressive symptoms, self-harm and early life risk factors were used. Results: We found little support for the existence of cyclical relationships between social media use and mental health. Where detected, effect sizes were small. Dose response associations were seen in the direction of mental health to social media (depressive symptoms 1 time OR=1.22, 2 times OR=1.71; self-harm 1 time OR=1.17, 2 times OR=1.53), but not for social media to mental health. Changes in social media use and changes in mental health were not associated with each other. We found no evidence to suggest that either social media use or mental health interacted with pre-

existing risk for mental ill health.

Conclusions: Findings highlight the possibility that observed longitudinal associations between social media use and mental health might reflect other risk processes or vulnerabilities and/or the precision of measures used. More detailed and frequently collected prospective data about online experiences, including those from social media platforms themselves will help to provide a clearer picture of the relationship between social media use and mental health.

# Introduction

Young people's mental ill-health is a growing public health challenge <sup>1-4</sup> with deteriorations seen over the last decade, and it is likely that a range of factors underly these trends. Higher rates of mental ill health such as depression and anxiety, have coincided with the increased uptake of certain types of digital technology use, for example social media. There has been much scientific, as well as public interest in the potential for a causal role between social media use and mental ill-health particularly among young people. Overall, findings point to, at most, modest associations between the amount of time spent on social media platforms and mental ill-health, <sup>5-9</sup> and where gender differences have been examined findings suggest associations are more apparent for girls, especially in early adolescence.<sup>5,6,10,11</sup>

However, there are clear limitations in the research undertaken to date, and important questions remain about i) whether these associations reflect causal effects, ii) the magnitude and direction of associations, and iii) whether there are vulnerable young people at particular risk of experiencing mental ill-health and potentially problematic social media use. To address these questions, studies need to tackle key limitations of extant research. Firstly, most findings are cross sectional and have shown between-group comparisons,<sup>6,8</sup> thus preventing examination of potentially cyclical associations – it is possible that poor mental health in the first instance leads to higher social media use which in turn may lead to more mental health problems.<sup>9,11-14</sup> Secondly, findings mostly use measures of time spent on social media platforms which in itself tells us little about individual experiences. For instance, if time spent on these platforms promotes connectedness and social support then it is unlikely to impact negatively on mental health. Conversely, experiences such as upward social comparisons, fear of missing out and negative interactions are most likely to be tied to poor mental health.<sup>15,16</sup> Thirdly, few studies integrate measures of underlying risk for mental health problems such as structural disadvantage and adverse psychosocial circumstances<sup>17-20</sup> and it may be that there are interplays between aspects and experiences of online environments with underlying

off-line vulnerabilities that exacerbate or mitigate extant risk.<sup>21</sup> In this paper we address some of the key limitations that have plagued prior studies by: a) looking longitudinally at social media use and mental health within individuals; b) using measures of different types of experiences on social media in addition to time spent on platforms e.g. compulsive use, and feeling happier and more connected than in real life; and c) investigating whether there is interplay between online experiences and pre-existing off-line vulnerability for mental ill-health and potentially problematic social media use.

Given the size of the public health challenge posed by mental ill health among young people, coupled with lifelong implications<sup>22</sup>, identifying potentially modifiable risk factors has the potential for substantial societal benefits across the lifecourse. If online experiences including those encountered on social media platforms are found to play a causal role, even a modest one, then it will be critical in developing preventive strategies.

This paper has two broad aims, the first is to tease apart the potential cyclical nature of associations between social media use and mental ill health (measured using depressive symptoms and self-harm) in mid-adolescence. We do this in three ways, by: i) assessing longitudinal and bi-directional pathways between social media use and mental ill-health in early and later adolescence; ii) investigating whether there are cumulative associations at play in either or both directions i.e. looking at whether 'heavy' social media use throughout adolescence is associated with mental ill-health in later adolescence, and vice versa; and iii) examining whether changes in social media use are associated with changes in markers of mental ill-health, and vice-versa. Our second aim is to assess potential interaction effects between social media use and experiences, and the impact of a range of pre-existing risk factors for adolescent mental ill-health. Here we consider the social determinants of young people's mental health, including structural factors - socioeconomic disadvantage,<sup>20</sup> and special educational needs and disability;<sup>19</sup> and proximal psychosocial factors - parental mental health,<sup>17</sup> physical punishment,<sup>23</sup> and bullying.<sup>18</sup> We examine these associations in

both directions, by investigating whether associations between different aspects of social media use (lengthy hours, compulsiveness, feeling happier and more connected than in real life) with mental health interact with pre-existing vulnerability factors.

To do this we make use of data from the UK Millennium Cohort Study (MCS), a longitudinal nationally representative cohort. For all analyses we exploit the longitudinal design of the MCS by making use of multiple data sweeps. Our research questions (as depicted in Figure 1) are as follows: RQ1 Are there (a) longitudinal and (b) bi-directional pathways between social media use and mental ill-health in mid-adolescence from age 14 to age 17?

RQ2 Are there cumulative associations between social media use and mental ill-health in either or both directions?

RQ3 Are changes in social media use between ages 14 and 17 associated with changes in markers of mental ill-health, and vice-versa?

RQ4 Do different aspects of social media use (lengthy hours, compulsiveness, feeling happier and more connected than in real life) interact with pre-existing vulnerability for mental ill-health, and vice-versa?

# Methods

# Millennium Cohort Study

The MCS is a UK nationally representative prospective cohort study of children born into 19244 families between September 2000 and January 2002 (<u>http://www.cls.ioe.ac.uk/shared/get-</u><u>file.ashx?id=1806&itemtype=document</u>). Participating families in receipt of Child Benefit (98% of the population at the time of sampling) were selected from a random sample of electoral wards with a stratified sampling design to ensure adequate representation of all four UK countries, disadvantaged and ethnically diverse areas. The first sweep of data was collected when cohort members were

around 9 months and the subsequent six sweeps of data were collected at ages 3, 5, 7, 11 14 and 17 years.

At ages 7, 11, 14 and 17 cohort members were interviewed, and at all data collection sweeps their carers were interviewed during home visits. Cohort members self-completed computer assisted questionnaires in private including items about social media use, mental health, and relationships with family and peers. Carers (the majority of whom were cohort member's parents and for ease throughout are referred to as parents) answered questions about their socioeconomic circumstances, parenting strategies, and cohort member's wellbeing throughout childhood including whether they had any disabilities and special educational needs. Interview data were available for 76.3% of families when cohort members were aged 14, and 73.6% of families when cohort members were aged 17.

# Mental ill-health

We include two indicators of mental ill-health: depressive symptoms and self-harm.

*Depressive symptoms* At age 14 participants completed the Short Mood and Feelings Questionnaire – short version (SMFQ) from which a summed score was created. The SMFQ comprises 13 items on affective symptoms in the last 2 weeks (see Box 1). At age 17 participants completed the Kessler – 6 items (see Box 1) from which a sum score was created. While the two measures predominantly capture symptoms of depression, there are some differences in the numbers and types of symptoms included with the 13-item SMFQ covering more symptoms by virtue of its length. Five items on each measure capture similar symptoms (hopelessness, restless/fidgety, worthlessness, depressed/miserable, too much effort). Sensitivity analyses conducted with these common symptoms yielded similar results to those using full measures. We use continuous depressive symptom measures - z scores (DS z), and a binary indicator of depressive symptoms with a cut point

of 1 standard deviation above the mean to indicate a 'high' level of symptoms at both ages. In addition, sensitivity analyses using binary depressive symptom measures based on 'caseness' cut points from the original measures ( $\geq$  12 for SMFQ, and  $\geq$  13 for Kessler – 6) yielded similar results to those using +1SD measures.

*Self-harm* At age 14 participants were asked "In the past year have you hurt yourself on purpose in any way?" (yes vs no), and at age 17 participants were asked "During the last year, have you hurt yourself on purpose in any of the following ways?: Cut or stabbed yourself; Burned yourself; Bruised or pinched yourself; Taken an overdose of tablets; Pulled out your hair; Hurt yourself some other way" – answering yes to any of these was coded in a summary variable as reported self-harm.

Social media (SM) use At ages 14 and 17 respondents were asked about their average hours of social media use on a weekday (for details of response categories see Box 1). The item used was developed by the Millennium Cohort Study team and is similar to items used in other large surveys including the UK Household Longitudinal Study and Ofcom. We use a continuous measure where possible to conserve statistical power, and a binary indicator to denote heavy SM use of ≥5 hours for some analyses. At age 17 respondents were asked an additional two questions capturing different aspects of social media experience – compulsiveness and connectedness– using, to what extent do you agree with the following statements? "I think I am addicted to social media" and "I'm more connected and happier online than I am in real life", respectively. Responses were on a four point scale strongly agree through strongly disagree which we collapse to create binary variables, agree vs disagree.

*Early lifecourse vulnerabilities* We generate variables to capture structural and psychosocial risk for poor adolescent mental health. Socioeconomic disadvantage was measured by the number of times

cohort member families had an income below the poverty threshold (60% of median household income) between sweep 1 (9 months) and sweep 6 (age 14), collapsed to create a categorical variable (0/1-3/4-6 times). Special educational needs and disabilities (SEND) was measured from items asked from ages 5 through 14 years ('gets help (in school) due to disability/problem' and 'has school told you your child has special needs') to generate a variable - ever vs never. Parental mental health was measured using an average of parental Kessler-6 scores between age 3 and age 14. In the event one parent was not present in the household, only the other parent's score was averaged. Physical punishment was measured using 'How often smacks child when naughty' between age 3 and 7 years, collapsed to create a binary variable (ever vs never). Experienced bullying by peers and siblings was measured using questions about frequency at ages 11 and 14 years. We use separate variables for peer (ever vs never) and sibling (ever, never, no siblings).

*Covariates* We adjust for confounding variables in line with prior research<sup>5,6</sup>: age, family structure (one vs two parent) at age 14, emotional symptoms at age 11 (in last 4 weeks worried; sad; afraid or scared – items were used to create a summed score), in addition to the early lifecourse risk factors already described – socioeconomic disadvantage, SEND, parental mental health, and physical punishment. We did not adjust for experiences of bullying as in the case that causal processes are at play this has the potential to lie on the pathway between social media use and mental health.

Study sample and missing data We analyse data on singleton-born cohort members for whom data on at least one marker of mental health or social media use are observed at either age 14 or age 17 (N=12,114). The largest percentage of missing data is the non-response of social media use at age 17 (43% missing), as these questions were collected in the young person online questionnaire (CAWI), completed after the home visit at age 17, which has a lower response rate than the face-to-face survey. The amount of missing data for each variable before imputation is shown in Supplementary Table S1. To deal with missing data for all variables we use multiple imputation by chained equations, which account for uncertainty about missing values by imputing several values for each missing data point. We impute 50 data sets, and report consolidated results from all imputations using Rubin's combination rules.<sup>24</sup> Findings from sensitivity analyses with an analytic sample using listwise deletion are consistent with those using imputed data.

# Statistical analysis

Given the potential for gender differences in associations of interest we performed tests for interaction, but results indicate no differences thus we present gender adjusted findings for young women and men combined throughout. For all analyses, two indicators of mental health: depressive symptoms (depressive symptoms z scores, or a binary measure) and self-harm (binary) are analysed separately. All estimates are weighted with sample and non-response weights provided with the data.

RQ1 Are there (a) longitudinal and (b) bi-directional pathways between social media use and mental *ill-health in mid adolescence from age 14 to age 17?* We first estimate a longitudinal regression model between social media use and mental health to test whether age 14 social media use is associated with mental health problems at age 17 (adjusting for confounders). We then further adjust for mental health at age 14 hence estimating whether age 14 social media use is associated with change in mental health between age 14 and age 17. Similar models are estimated for the opposite direction, that is whether mental health at age 14 is associated with social media use at age 17. Second, a cross-lagged panel model (path analysis) is used to investigate bi-directional associations between social media use and mental health. Cross-lagged models for depressive symptoms z score and self-harm are estimated using the generalised structural equation model (GSEM) command in Stata,<sup>25,26</sup> which allows for continuous measures to be modelled using linear

regression, and the use of logistic regression models for binary measures. We present models with adjustment for confounders (Model 1). Concurrent covariance/correlation cannot be used in a GSEM model, and thus two different models, with depressive symptoms z score or self-harm as the dependent variable (Model 2) and with social media hours as the dependent variable (Model 3), are shown.

RQ2 Are there cumulative associations between social media use and mental ill-health in either or both directions? Using logistic regression models we test whether cumulative heavy social media use (5 hours or more per day) is associated with age 17 mental ill-health and whether cumulative mental ill-health is associated with age 17 heavy social media use. We generate three count variables for a) the number of times cohort members were heavy social media users, or b) had depressive symptoms, or c) self-harm (0/1/2 times).

# RQ 3 Are changes in social media use between ages 14 and 17 associated with changes in mental illhealth, and vice-versa?

Here we estimate change in the dependent variable (DV) contingent on change in a particular independent variable (IV), i.e. 'treatment' effects, in the following four scenarios:

1. change in depressive symptoms z scores as the DV regressed on movement from non-heavy social media use at age 14 to heavy use at age 17 as the IV adjusted for age 14 social media hours.

2. onset of self-harm at age 17 as the DV regressed on change in social media hours adjusting for age 14 social media hours, and the sample for this model is restricted to those not reporting self-harm at age 14.

Looking at the other direction of influence:

3. change in social media hours as the DV regressed on change in depressive symptoms score from age 14 to 17, adjusting for age 14 depressive symptoms score.

4. change in social media hours as the DV regressed on onset of self-harm at 17; as for scenario 2 the sample is restricted to those not reporting self-harm at age 14.

*RQ4 Do different aspects of social media use interact with pre-existing vulnerability for poor mental health, and vice-versa?* First, we test age 17 cross-sectional associations between three aspects of social media use – hours, compulsiveness, feeling happier and more connected on social media than in real life – with mental health. Models first show the bivariate association between each aspect of social media use with mental health, and then mutually adjusted (with all 3 aspects entered together) associations are shown. Second, we test for interactions between social media use or mental health with markers of early life vulnerability by including an interaction term. We considered 6 early life vulnerability factors in combination with three social media exposures (hours, compulsiveness, more connected than in real life) and two mental health outcomes (depressive symptoms and self-harm) equalling 36 tests for interaction in each direction, 72 in total. To correct for false discoveries of multiple comparisons, we use the FDR correction<sup>27</sup> with a corrected p<0.001 threshold.

#### Results

Weekday hours spent on social media increased between ages 14 (mode=1-2 hours) and 17 (mode=3-5 hours) (Figure 2). Depressive symptoms and self-harm were associated with hours spent on social media. There were variations in the shape of these cross sectional associations by age, but overall, higher depressive symptom scores (Figure 3a) and higher prevalences of self-harm (Figure 3b) were observed among participants reporting more than 3 hours daily use.

Are there longitudinal, and bi-directional pathways between social media use and mental illhealth from age 14 to age 17? Social media hours at age 14 years were not associated with changes in either mental health outcome between ages 14 and 17 years, and similarly mental ill-health (whether depressive symptoms or self-harm) at age 14 was not associated with changes in social media use between ages 14 and 17 years (Table 1, Models 1 to 3). We did not observe associations in cross-lagged pathways between social media at 14 and mental health outcomes at age 17, and vice versa between mental health at 14 and social media use at age 17 (Figures 4 and 5 - single headed arrows represent directional associations/assumed causal relations).

# Are there cumulative associations between social media use and markers of mental health in either or both directions?

We observed weak support for dose-response associations in the direction of mental health to social media use though confidence intervals often overlap unity (Figure 6). For example, the odds of heavy social media use were as follows: depressive symptoms at 1 time OR=1.22, and at 2 times OR=1.71; self-harm at 1 time point OR=1.17, and at 2 time points OR=1.53.

In the opposite direction, i.e. social media to mental health, there was no evidence of cumulative effects, the odds of depressive symptoms for heavy social media use were - at 1 time OR=1.30, and 2 times OR=1.32; and for self-harm at 1 time OR=1.24, and at 2 times OR=1.36.

# Are changes in social media use between age 14 and age 17 associated with changes in mental health and vice versa?

Overall, estimates were in the expected direction, although the magnitude of these associations were small and confidence intervals included the null (Table 2).

Do different aspects of social media use interact with prior vulnerability for poor mental health, and vice-versa? First, we tested cross-sectional associations between three aspects of social media use – hours of use, compulsiveness, feeling happier and more connected on social media than in real life with mental health outcomes at age 17 (Table 3). In mutually adjusted models feeling happier and more connected than in real life was strongly associated with both higher depressive symptom scores (coefficient=0.55) and self-harm (OR=2.15), but associations for compulsive use and hours of use were attenuated. We found little evidence of interactions when looking at associations between early life risk factors and mental health and these different aspects of social media use (Supplementary Tables S2-S3).

### Discussion

Among young people aged 14-17 years living in the UK, we found little support for the existence of cyclical relationships between social media use and mental health. Two of the three approaches used to test this hypothesis yielded estimates weakly supportive of a cyclical association, but effect sizes were small. Firstly, in longitudinal models, when we accounted for confounding variables, observed pathways were attenuated; secondly, there was a hint of dose response associations in the direction of mental health to social media, but not for social media to mental health; thirdly changes in social media use and changes in mental health were not consistently associated with each other. These findings highlight the very real possibility that there is no causal link between hours of social media use and mental ill-health in either direction. However, null findings might reflect the relevance of the measures available as length of time spent online might not matter so much, rather it is the nature of online encounters and experiences that are most likely to have an impact on young people's mental health. Further here, in cross sectional analysis we found that young people who reported feeling happier and more connected online than in real life had higher levels of depressive symptoms and were more likely to report self-harm. On the other hand reported compulsive use was not associated with mental ill health when covariates were taken into account. Another potential explanation is due to the timeframe under study as there were three years between data

collections and we might not expect to detect associations over this relatively lengthy gap in observations. We found no consistent evidence to suggest that either social media experiences or mental health in youth interacted with early life risk for mental ill health.

In keeping with other longitudinal studies, where we did detect associations, these were modest in size. <sup>5,7,9,11-14,28</sup> If a true association were to exist between social media use and mental health the potential underlying mechanisms are likely to be complex, and not necessarily related to the number of hours of use. On one hand, there are undoubtedly numerous benefits to be gained from using social media including making connections, social support and information acquisition. On the other hand, there could be downsides resulting from upward social comparisons, fear of missing out, negative interactions and encountering troubling content.<sup>15,16</sup> Our observation that young people with sustained poor mental health are likely to spend more time using social media is consistent with studies showing that depressed youth seek help and support online.<sup>29,30</sup> It has been proposed that associations between use of social media and mental health might be particular to sub-groups. Interestingly, we did not find evidence to support the hypothesis that social media use compounds effects of early life off-line risk.<sup>21</sup> To test this hypothesis we examined a range of social determinants of mental health for young people, but there was no evidence to suggest that dimensions of social media use looked at in the present study interacted with off-line risk.

Our study has distinct strengths. Firstly, we used data from a large scale representative contemporary UK setting making our findings generalisable to the wider adolescent population in the UK. Secondly, we were able to examine associations longitudinally using multiple statistical methods, with different strengths and limitations, hence allowing us to present a multi-faceted and nuanced view of these associations - by investigating bidirectional associations (RQ1), considering dose response relationships (RQ2), and by looking at changes in both social media use and in mental health (RQ3). Thirdly, we were able to integrate data into our study not typically used on this

research topic, for instance, on different aspects of social media use, including young people's experiences, in addition to a range of early life risk factors for poor adolescent mental health (RQ4). To our knowledge, this is the first paper to have investigated the potential for interaction effects of social media with multiple aspects of early life vulnerability for poor adolescent mental health.

On the other hand, our study has distinct limitations, including that self-reported data of time spent on social media is crude and lacks accuracy,<sup>31</sup> and use may be especially difficult to estimate in time categories as social media are not clearly delineated, unlike other forms of screen activities such as TV viewing and playing games. It may be that there is a risk of reporting bias for time spent on social media among young people experiencing mental ill health such that they under or over report time spent.<sup>32</sup> However, the questions used were similar to those from other large-scale population based surveys including the UK Household Longitudinal Study<sup>5</sup> and Ofcom<sup>33</sup> and estimates of time spent using social media presented in our paper are consistent with those reported from other UK studies.<sup>5,34</sup> We were able to go beyond self-reported time use to incorporate measures of experiences – compulsion and of feeling happier and more connected than in real life – however these measures were only available for a single time point preventing causal inference. Another limitation was that the measures of mental health used were different across time points thus potentially introducing measurement error. The relatively lengthy time lapse between data collections is also a limitation for the current study as it may be that shorter intervals between observations would have yielded different findings. Finally, as with most observational studies, there is the possibility that any positive findings could be a function of unmeasured confounding.

### Conclusions

There are many benefits to be gained for young people by engaging online but there may well be downsides too. The findings of our study highlight the possibility that any observed association between social media and mental health might reflect other risk processes or vulnerabilities. Thus, our findings, and those of others, highlight the likely complexity of mechanisms at play. Future research using more detailed and frequently harvested objectively collected prospective data including those from social media platforms themselves, along with more detailed accounts of online experiences, will help to provide a more comprehensive picture of the relationship between social media use and young people's mental health. Given the short- and long-term implications of having poor mental health, improving our understanding of underlying processes could help identify opportunities for interventions with benefits across the lifecourse.
