4 Abstract

5	Survey measurements of sexual orientation have become increasingly common in national
6	population surveys although validation of these measurements is rare and inherently problematic.
7	We instead assess the <i>reproducibility</i> of parallel measurements from two independent samples of
8	the USA population made in the 2008-2018 General Social Surveys and the adult probability
9	subsets of the 2013-2018 National Health Interview Survey (Ns = 12,098 and 190,113).
10	Restricting analysis to the categories gay/lesbian, bisexual, and straight, we obtain similar
11	estimates of the proportion of the U.S. population who consider themselves gay/lesbian (NHIS:
12	1.59% vs. GSS: 1.93%, $p = 0.059$) but not bisexual (NHIS: 1.03% vs. GSS: 2.90%, $p < 0.001$).
13	Fitting multinomial logistic regression models controlling for year, gender, birth cohort,
14	education, and race, we find that compared to the NHIS, the GSS had 1.248 (p=0.022) times
15	higher relative odds of eliciting a response of Gay-Lesbian (vs. Straight) and 2.980 (p<0.001)
16	times higher relative odds of eliciting a response of Bisexual (vs. Straight). Expanding the model
17	by adding 3-way interaction terms for orientation-by-predictor-by-survey, we find that we cannot
18	reject the null hypothesis that <i>trends</i> over time and across subpopulations in reporting of sexual
19	orientation were statistically equivalent for the two survey programs.

23 **1. Introduction**

Since the 1990s, survey measurements of sexual orientation have become increasingly common in population surveys of sexual behavior in the USA, Europe, and elsewhere [1-4]. Assessments of the accuracy of such measurements are infrequent, however, and can be problematic.

There is a large literature documenting the ways in which seemingly trivial variations in survey 27 protocols can induce substantial discrepancies in the measurements obtained. These include seemingly 28 minor variations in question wording, context, mode of administration, etc. [5-7]. This problem has been 29 long known to affect so-called "objective" measurements (e.g., personal bankruptcy [8]) in which the 30 notion of a measurement's "true value" can be logically sustained. In those instances it is theoretically 31 possible to attempt validation by comparing survey reports to a presumed veridical record (e.g., 32 comparing survey reports of personal bankruptcy to court records). This is not to say, of course, that such 33 comparisons can be easily (or ever) accomplished for every objective phenomenon; consider for example 34 35 the difficulty of validating reported condom use at last sex. While partner reports might seem to provide 36 a reasonable strategy, there are inherent limitations to this approach, e.g., in the case of anonymous hook-37 ups.

This problem becomes even more difficult for subjective measurements where there is simply no veridical record that can be used to validate survey reports of: how happy someone is, their approval of the President, or their sexual orientation [9]. A preliminary question, however, can be fruitfully attacked without taking on the epistemological challenges posed by "validation". That question is the *reproducibility* of the survey measurements of the subjective phenomena that is at issue. For us it is the reproducibility of survey measurements of sexual orientation.

In the present instance we have the benefit of two independent series of surveys that measured the reported sexual orientation of the U.S. adult population. These measurements come from the 2008 to 2018 waves of the biennial General Social Survey [10] and the 2013 to 2018 waves of the annual National Health Interview Survey [11,12]. These data sources have two important advantages for assessing the reproducibility of survey measurements of sexual orientation. First, they are well-regarded surveys of large probability samples of the U.S. population (Ns across available years =12,098 GSS, and

50	190,113 for the probability adult segment of the NHIS samples; it should be noted that while the GSS
51	conducted a total of 13,794 interviews in 2008 through 2018, only 12,098 respondents were included in
52	survey segments that included the Sexual Orientation question.) Second, these survey programs were
53	conducted by well-trained staffs of survey interviewers and other survey professionals.
54	The NHIS program is the USA's premier health interview survey. Begun in 1957, the NHIS is
55	designed "to secure accurate and current statistical information on the amount, distribution, and effects of
56	illness and disability in the United States and the services rendered for or because of such conditions"
57	(https://www.cdc.gov/nchs/nhis/about_nhis.htm, accessed January 13, 2020). This survey program
58	annually draws large representative samples of the USA population and uses U.S. Census Bureau
59	interviewers to conduct interviews. For example, in the 2018 survey, 29,839 households were included in
60	the NHIS sample [11, p. 20]. One probabilistically selected adult from each sampled household was
61	selected for inclusion in the adult probability component of the NHIS. In 2018 that yielded 25,417
62	completed interviews. This component of the 1997 through 2018 NHIS is the focus of all of our NHIS
63	analyses (unweighted annual Ns range from 21,781 to 36,697).
64	The GSS Program is a major representative sample survey of adults residing in households in the
65	USA. It has been conducted since 1972 as part of the National Science Foundation's National Data
66	Program for the Social Sciences [10]. The GSS is conducted using in-person interviews conducted by
67	professional interviewers employed and supervised by the National Opinion Research Center at the
68	University of Chicago. GSS surveys were conducted annually between 1972 and 1994 and biennially in
69	subsequent years. These surveys have included "a standard core of demographic, behavioral, and
70	attitudinal questions, plus topics of special interest. Among the topics covered are civil liberties, crime
71	and violence, intergroup tolerance, morality, national spending priorities, psychological well-being,
72	social mobility, and stress and traumatic events" [13].
73	Beginning in 1988, the GSS has included questions on sexual behaviors; in 2008 a question on
74	sexual orientation was added. The GSS sexual orientation data from 2008 through 2018 provide the basis
75	for our comparative analyses. The 2008-2018 GSS drew probability samples of US households and

- between 1,974 and 2,867 adults in 2008 through 2018. (In the 2016 and 2018 GSS the sexual orientation
- 78 question was only asked of a randomly selected two-thirds of the survey sample.)

- 80 2. Materials and Methods
- 81 2.1 Questioning
- 82 While the sexual orientation question was quite similar in the two survey programs, there was a
- 83 minor difference in the question stem and a more substantial difference in the response categories that
- 84 were offered (see Table 1). There were also substantial differences in the introductory texts and questions
- 85 preceding the sexual orientation measurement and in the methods of question administration.

94 95	Using video-CASL the GSS administered the sexual orientation question and a range of

96	questions on sexual behaviors including a variety of questions on number, gender, and types
97	(friend, spouse, date, sex worker, etc.) of sexual partners in lifetime and during recent years (1, 5,
98	etc.), frequency of sex, condom use, injection drug use, cocaine use, etc. [14]. In the video-CASI
99	procedure, interviewers do not ask the survey questions, but rather the questions are shown on
100	the screen of a laptop computer and respondents reply using the laptop computer's mouse or
101	keyboard. Thus the interviewers are unaware of the questions being asked and the responses the
102	interviewee gives. Dedicated keys on the laptop's keyboard (as well as categories shown on the
103	laptop screen) allow respondents to answer "Don't Know" or to refuse to respond to the
104	question)
105	A number of randomized survey experiments ([15-17] report substantial differences in
106	the reporting of sensitive behaviors when CASI survey technologies are used in place of human
107	interviewing. However, a carefully conducted, randomized experiment by NCHS [18] did not
108	find substantial differences in responses to the NHIS sexual orientation question using audio-
109	CASI versus the NHIS "showcard" protocol described here.
110	2 2 Response Categories
111	
112	The GSS sexual orientation question asks which of the offered response options "best describes
113	you" while the NHIS sexual orientation question similarly asks which option "best represents
114	how you think of yourself". The response categories, however, diverged more substantially. The
115	GSS offered the response categories: Gay, Lesbian or Homosexual; Bisexual; and Heterosexual
116	or straight. The NHIS, however, also offered the explicit response categories: "4. Something
117	else" and "5. I do not know the answer" while the GSS does not explicitly offer similar options.
118	36 of the 12,098 respondents in the 2008-2018 GSS were coded as responding "Don't
119	Know" (weighted 0.31% , se = 0.05%) on the sexual orientation question. In contrast, 1,259 of

120	190,113 of NHIS respondents chose the offered option of "5 I do not know the answer"
121	(weighted 0.67%, se = 0.03%). A further difference is found for the "something else" response
122	category. The GSS did not offer this option forcing respondents to choose among the three
123	substantive response categories or to provide no response. In the NHIS, 636 of 190,113
124	respondents chose the offered answer category: "4 Something else" (weighted 0.32%, se =
125	0.02%).

- 127 2.3 Differences in the Population Surveyed.

While both survey programs provide broadly representative samples of the adult 128 population of the USA, one minor divergence should be noted. The GSS sample is limited to the 129 130 *household* population while the NHIS sample covers the entire civilian non-institutionalized population. So, for example, the NHIS includes a dormitory component in its sampling frame 131 while the GSS does not. As a crude check of the impact of this variation, we compared NHIS 132 estimates of sexual orientation with and without the non-household segment of the NHIS sample. 133 Since only 0.95% of the NHIS adult probability sample (unweighted N = 1,739 of 183,020) were 134 non-household residents, it is not surprising to find (see Appendix Table B) that the estimates are 135 136 virtually identical.

Since language barriers are a potential reason for non-response in both survey programs,
it is important to note that both survey programs conducted interviewing in both English and
Spanish in 2008 - 2018.

141 *2.4 Combining Samples.*

For our reproducibility analysis, we analyze a combined data set containing data from 6 142 biannual GSS surveys (2008, 2010, 2012, 2014, 2016, and 2018) and from 6 annual NHIS 143 144 surveys (2013 to 2018).

145 The combination of these files is not as straightforward as merely concatenating the two data files and ensuring that variable names and response categories are made equivalent. While 146 that would be sufficient for two simple random samples of the population, it unfortunately is not 147 adequate for these two complex probability samples. In particular, we must ensure consistency 148 in the handling of weights and the variables required for calculation of the effects of the complex 149 sample designs used in each of these survey programs. (Weights include adjustments for 150 sampling factors and in the NCHS post-stratification adjustments for the impact of survey 151 nonresponse. The GSS did not employ such post-stratification adjustments for non-response 152

[19].)

For the analyses reported in this article, a composite GSS-NHIS data file was created. 155 First new weights were constructed for each wave of the NHIS (2013, 2014 ... 2018) and GSS 156 survey (2008, 2010... 2018). These new weights for survey respondents were computed as the 157 158 originally assigned weight divided by the mean of all weights for that wave of the survey. As a check on the accuracy of this step, we inspected all permutations of Survey-by-Wave to ensure 159 that the sum of the new case weights equaled the unweighted sample sizes for each of these 160 permutations — as well as for the total survey samples. Strata and PSU numbering were 161 unaltered from the original survey datasets. 162

2.6. Statistical Analyses. 164

165	We begin our analyses by reporting the number and percentages of GSS and NHIS
166	respondents who were recorded as choosing each substantive response plus those providing non-
167	substantive responses, e.g., refusals to answer. We then attempt direct comparisons of response
168	distributions obtained in the two survey programs using alternative methods for handling
169	discrepant responses in the two survey programs, e.g., the lack of an explicit "Don't Know"
170	response category in the GSS.
171	Subsequently, we test the congruence of the results of the two survey programs in
172	monitoring trends in reported sexual orientation over time and birth cohorts and across
173	sociodemographic subsets of the population. All analyses were performed using Stata version 15
174	[20] and employ Stata's svy procedures to take account of the complex sample designs of these
175	surveys in estimating results for the U.S. adult population.
176	
177	3. Results
178	3.1 Full Response Distributions.
179	The first panel of Table 2 shows results for the full set of response categories for both the
180	GSS and NHIS measurements across all years in which the questions were asked, i.e., annually in

181 2013-2018 in the NHIS and biennially in 2008-2018 in the GSS. For this initial analysis, we will

182 not synchronize the time periods used in the two surveys.

100	12 Not summiningly, we find that there is notable discorresement in the results obtained by
189	Not surprisingly, we find that there is notable disagreement in the results obtained by
190	these two measurement programs. A primary source of this disagreement arises from the much
191	higher population percentage that was not asked the sexual orientation question because either:
192	
193	In the NHIS, they discontinued the survey before reaching the sexual orientation question
194	(2.19%), or
195	
196	In the GSS, they discontinued the survey before reaching the self-administered sexual
197	behaviors section of the GSS survey or did not complete this section due to refusal or
198	some other reason and thus were coded as not ascertained (IAP, 9.51%). (The GSS
199	Director has noted that "[the GSS dataset] does not have a variable that delineates refusal
200	to do the SAQ [self-administered questionnaire], although that is what most of the IAP
201	probably are (Tom Smith, personal communication, March 4, 2020)".
202	
203	The relatively large percentage of GSS respondents refusing the sexual behavior section of the
204	survey may reflect the wide range of sensitive information that was requested by this GSS
205	section, e.g., number, gender, and types of sexual partners, frequency of sex, etc. This variation
206	in measurement mechanics perturbs all other results. This is troublesome given our focus on a
207	relatively rare characteristic of the population, i.e., the prevalence of non-heterosexual
208	orientations.
209	As a rough correction for this measurement variation, the lower panel of Table 2 shows
210	estimated prevalence based only on respondents who were asked the sexual orientation question.
211	Both survey programs estimate that 94% to 96% of the U.S. population describes themselves as

212	13 heterosexual or straight while approximately 1.6% to 1.7% of the population describes itself as
213	gay or leshian. An additional 0.5% to 1.5% of the population is classified as refusing to respond
213	
214	to the sexual orientation question. There is, however, less agreement on estimates of the
215	population classifying themselves as bisexual. Although the percentages are low, the GSS
216	estimates more than double the prevalence of self-reported bisexuality in the U.S. population
217	compared to the NHIS survey program (GSS: 2.21%, se = 0.16% ; NHIS: 0.95%, se = 0.03% ;
218	p<0.001)
219	Some discrepancies in these estimates might be expected given the variation in the
220	protocols used by the two survey programs. We note, for example, that the NHIS program
221	included an explicit category ("something else") for respondents who did not feel comfortable
222	using the three sexual orientations: straight, gay-lesbian, or bisexual. In addition, the mode of
223	survey administration varied between the two survey programs.
224	In addition, we note differences in question wording and administration. NHIS
225	interviewers asked the question, "Which of the following best represents how you think of
226	yourself?" with respondents choosing their response category from a flashcard. In contrast, the
227	GSS program used video-CASI to administer the sexual orientation and other sensitive questions.
228	(A small number of GSS sexual orientation measurements were made by telephone. In 2008, 39
229	of these GSS measurements were made in interviewer-administered telephone interviews.) In the
230	video-CASI mode of administration, the survey interviewer does not ask the question nor hear
231	the respondent's choice of a response. This variation in survey mode may have affected the
232	measurements by, among other things, affecting respondents' willingness to provide an accurate
233	report of their sexual orientation.
234	It is also possible that variations in survey administration may have affected the salience
235	of non-substantive response options. In the GSS video-CASI administration, respondents were
236	told to press one of two keys on their laptop if they either did not know the answer to the

237	question or did not wish to provide an answer. In contrast, NHIS respondents were offered an
238	explicit option on the flashcard of "I do not know the answer" but no explicit refusal option.
239	These and other variations in survey protocol might account for the incomplete equivalence in
240	the point estimates obtained by the two survey programs shown in Table 2.
241	A common analytic response to non-equivalence in the response categories offered by
242	two measurement programs is to focus analysis on the common substantive responses. In the
243	present case an analyst might keep the three substantive response categories (straight, gay-
244	lesbian, and bisexual) and drop all cases in which respondents gave a non-substantive response,
245	i.e., don't know, "something else", or refused to respond. As shown in Table 2 (lower panel),
246	estimates for these non-substantive response categories total 1.55% for the NHIS and 1.85% for
247	the GSS. While these are fairly trivial percentages, it should be borne in mind that the estimated
248	size of the (self-described) gay/lesbian and bisexual subpopulations are only 3 to 4%.
249	
250	3.2 Simple Analyses Restricted to Three Substantive Response Categories.
251	As shown in Table 3, restricting analysis to the three substantive categories of
252	gay/lesbian, straight, and bisexual, produces quite similar estimates of the proportion of the U.S.
253	population who consider themselves gay or lesbian. The NHIS yields an estimate of 1.59%
254	(se=0.06%) which is only modestly different from the estimate produced by the GSS (1.93%,
255	se=0.17%), and that difference is of borderline statistical significance ($p = 0.059$).
256	Approximately similar results are found when males and females are considered separately. For
257	males, the NHIS estimates that 1.81% (se=0.09%) identify themselves as gay while the GSS
258	estimates this percentage as 2.13% (se= 0.28% ; p = 0.277). For females, similar results are
259	obtained with the NHIS estimating that 1.30% (se=0.08%) of females identify as lession and the
	obtained with the 14113 estimating that 1.5776 (se=0.0876) of females identify as resolation and the

However, similar equivalence is not found for estimates of the percentage of the U.S. 269 population identifying as bisexual (p < 0.001). Overall, the NHIS survey program estimates that 270 1.03% (se=0.05%) of the U.S. population identifies as bisexual while the GSS survey program 271 yields an estimate that is more than twice as high (2.90%, se=0.26%). Roughly similar 272 discrepancies are found when men and women are considered separately with the GSS bisexual 273 estimates being two to three times higher than the NHIS estimates; see Table 3). 274 275 It should be noted that this non-equivalence is not eliminated by focusing on the contrast between respondents reporting a "straight" sexual orientation versus those reporting a "non-276 straight" orientation, i.e., gav/lesbian or bisexual. Overall – as might be inferred from Table 3 – 277 the GSS estimates that a higher percentage of the U.S. population identifies with a "non-straight" 278 279 orientation than does the NHIS (4.83% vs. 2.62%, p < 0.001).

280

281 3.3 Testing Reproducibility with Controls for Sociodemographic Factors

We refined and expanded the foregoing analyses by fitting multinomial logistic regression 282 models that predict our 3-category outcome variable (gay, straight, bisexual) as a function of the 283 survey making the measurements plus five control variables. These control variables were: the 284 year the survey was conducted, and the respondent's gender, birth cohort (in decades), education, 285 286 and race. The latter four predictors have been shown in previous research to be associated with reporting of alternative sexual orientations and/or behaviors (e.g., Turner et al., 2005; England et 287 al., 2016). For these analyses we restricted our sample to the three years (2014, 2016, 2018) in 288 which both the NHIS and GSS surveys collected respondents' reports of their sexual orientation. 289 Table 4 presents the results of this analyses. In this analysis the response "straight" is the 290 base outcome. The entries in this table show the estimated relative odds of the responses: (1) gay 291 vs. straight, and (2) bisexual vs. straight, adjusted for the other predictor variables in the model. 292

- Our results indicate that compared to the NHIS, the GSS has 1.248 (p=0.022) times higher
- relative odds of eliciting a response of Gay-Lesbian (vs. Straight) and 2.980 (p<0.001) times
- ²⁹⁵ higher relative odds of eliciting a response of Bisexual (vs. Straight). Overall, this result indicates
- that the discrepancies observed in our simpler analyses (Table 3) are not eliminated by the
- inclusion of the five control variables nor the restriction of our analysis to the three years in
- which both surveys made measurements.

317	In passing we note that this analysis replicates many aspects of previous findings. Thus
318	we note monotonic increases across birth cohorts in the relative odds that respondents will
319	choose the categories gay-lesbian and bisexual versus straight. These results are quite startling
320	although they are consistent with past research [21-22]. Thus compared to the 1930s, birth
321	cohort, members of the 1990s cohort have 4.3 (p<0.001) times higher relative odds of reporting a
322	gay-lesbian orientation and 12.1 (p<0.001) times higher odds of reporting a bisexual orientation.
323	We similarly find that compared to men, women have 0.78 ($p < 0.001$) times lower relative odds
324	of reporting a gay-lesbian orientation but a 2.50 times ($p = 0.001$) higher relative odds of
325	reporting a bisexual orientation.
326	Controlling for other factors in the model, higher levels of education were associated with
327	increased relative odds of reporting a gay-lesbian (vs. straight) orientation but a similar result is
328	not found for reporting of a bisexual orientation. Thus persons with a college degree and post-
329	college education had 2.43 and 3.38 (ps<0.001) times higher relative odds of reporting a gay-
330	lesbian (vs. straight) orientation' A parallel result is not found for reporting a bisexual
331	orientation. Surprisingly, this analysis reveals that reported sexual orientations varied
332	significantly across the three years in which the surveys were conducted when other variables are
333	controlled. Most noticeably, relative to respondents in 2014, respondents in 2016 had 1.23
334	(p=0.033) higher relative odds of reporting a bisexual (vs. straight) orientation and respondents
335	in 2018 had 1.43 (p<0.001) times higher relative odds of reporting a bisexual (vs. straight)
336	orientation. This analysis also reveals a significant association of race with reported sexual
337	orientation. Respondents of "other" races (i.e., not black or white) had 0.72 lower relative odds
338	than whites $(p = 0.018)$ of reporting a gay-lesbian orientation (vs. straight) and borderline lower
339	relative odds (0.74, p=0.063) of reporting a bisexual (vs. straight) orientation. Black respondents
340	also had 0.77 (p=0.017) times lower relative odds than whites of reporting a bisexual orientation

although the difference in relative odds of reporting gay/lesbian orientations was not statistically significantly (1.11, p = 0.301).

343

344 *3.4 Reproducibility of Predictor-by-Orientation Associations.*

While the observed disagreements in point estimates of the sexual orientations reported 345 by the U.S. population are noteworthy and sociodemographic controls do not eliminate that 346 disagreement, it can be argued that this does not detract from one of the most important uses of 347 such data — monitoring trends over time and variations across subpopulations in sexual 348 orientations. Indeed, since the measurement protocols used by the two surveys are not fully 349 equivalent, some non-equivalence in these estimates of sexual orientation should be expected. 350 The measurements may nonetheless provide equivalently reliable and important indicators of 351 352 trends in sexual orientations in the population over *time and across subpopulations*. To test this possibility, we expanded the foregoing multinomial logistic model (Table 4). 353 This expanded model added 3-way interaction terms for orientation-by-predictor-by-survey to 354 allow that the two surveys might produce different point estimates of sexual orientation while 355 testing the hypothesis that *trends* over time and across subpopulations in reporting of sexual 356 orientation were statistically equivalent for the two survey programs. This model (Appendix 357 Table A) includes the same five predictor variables shown in Table 4 but adds estimates of 3-way 358 interactions of Survey-by-Predictor-by-Orientation. Estimates of these terms provide tests of the 359 hypotheses that the patterns of Orientation-by-Predictor association found by the two survey 360 361 programs are statistically equivalent. For example, the *sexual orientation by year by survey* interaction term tests the hypothesis that the two survey programs yield statistically equivalent 362 363 estimates of trends in reported sexual orientation over the years 2014, 2016, and 2018. Similarly, the sexual orientation by birth cohort by survey interaction term tests the hypothesis that the two 364 surveys produce statistically equivalent estimates of variation in reported sexual orientations 365

across birth cohorts. The remaining 3-way orientation-by-predictor-by-survey terms provide
 similar tests of statistical significance of the remaining interactions.

The full set of results for this analysis are shown in Appendix Table A. (Since these tests 368 used our expanded model with five additional interaction terms [see Appendix Table A], the 369 estimated relative odds for the main effects are not identical to those reported in Table 4.) It will 370 be seen that none of the 3-way interaction terms were statistically significant. These null results 371 provide an important part of the answer to our basic question about the reproducibility of sexual 372 orientation findings from the two survey programs. We have previously seen that there are 373 statistically significant variations in the two surveys' point estimates of sexual orientation and 374 that these differences remain even when a variety of sociodemographic controls are applied. 375 Nonetheless, the measurements from these two survey programs do not yield significantly 376 different conclusions about trends in the population's reported sexual orientations over time or 377 birth cohort nor in the patterns of association between the population's reported sexual 378 orientations and the other sociodemographic variables included in our model. 379

381 **4. Discussion**

Our analysis benefits both from the large, well-executed probability samples used by the 382 GSS and NHIS survey programs and from the well-trained and experienced interview and survey 383 staffs used by these survey programs. While the univariate distributions of social characteristics 384 of the U.S. population are often of minor interest, that has not been the case for estimates of the 385 386 sexual orientation. Controversies about the size of the U.S. population with non-heterosexual preferences date back, at least, to the 1948 publication of Kinsey et al.'s Sexual Behavior in the 387 388 Human Male [23]. That volume famously estimated that "10 per cent of the males are more or less exclusively homosexual ... for at least three years between the ages of 16 and 55. (p. 651, 389 *emphasis in original)*" That figure was both politically controversial and scientifically suspect 390

391 given the non-probability nature of Kinsey et al.'s sample and other deficiencies in this pioneering work [24]. 392 Subsequent to Kinsev et al.'s companion publication on women [25], relatively little new 393 empirical quantitative research was published on sexual behaviors in the U.S. population. The 394 onset of the HIV/AIDS epidemic in the 1980s began to remedy this deficiency by the end of the 395 1980s. Reports from the Institute of Medicine and the National Academy of Sciences [26-28] 396 helped bring pressure on the National Institutes of Health to fund the needed research on the 397 398 sexual behavior of the U.S. population although political opposition slowed these efforts both in the USA [29] and the UK [2]. 399 The subsequent surfeit of survey data in the 1990s and beyond provided much missing 400 information on the variety of sexual behaviors in the U.S. and other populations. The present 401 article advances this effort by providing an evaluation of the reproducibility of an important 402 series of such measurements made by two major survey programs in the USA. 403 404 4.1 Congruence of Measurements 405 The data we analyze do not arise from a planned experiment but rather from the fortuitous 406 coincidence of two survey programs measuring the same population characteristic in the first two 407 decades of the 21st century. As we noted previously, the measurement methods used by the two 408 survey programs were not identical in a variety of ways. For example, 409 The interview mode varied: video-CASI in the GSS vs. interviewer administration using 410 • flashcards in the NHIS; 411 412 The response categories were more extensive in the NHIS including "Something Else", • 413 and an explicit "I don't know the answer" category; 414 The GSS administered a battery of questions on a variety of sexual behaviors, and some 415

respondents opted out of this entire battery of sexual questions. In contrast, missing 416

420	Not surprisingly, the point estimates from the two survey programs are not statistically equivalent
421	(Table 2). "Not ascertained," for example, was a much more common response for the GSS
422	battery of questions (9.5% population estimate) than for the NHIS question (2.2% population
423	estimate). When these responses are purged from the analysis, there still remain some substantial
424	differences. Most notably, the estimated percentage of the population classified as bisexual is
425	more than twice as high in the GSS as in the NHIS (2.21%, se = 0.16% vs. 0.95% , se= 0.03% ; see
426	Table 2, lower panel). In addition, even when persons refusing the sexual behavior module are
427	excluded from the GSS, the estimated percentage of the population refusing to provide their
428	sexual orientation was almost three times higher in the GSS (1.51%, se = 0.15%) versus the
429	NHIS (0.53%, se=0.02%).
430	It can be argued that the most important target variables for our analysis is the estimated
431	percentage of the U.S. population that describes itself as gay or bisexual. One common –
432	although perhaps not ideal – approach to this question is to restrict analysis to the three
433	substantive response categories: straight, gay, or bisexual. This analysis strategy (Table 3) does
434	not, however, produce statistically equivalent estimates from the two surveys (p < 0.001),
435	however the estimated percentage of the population classified as gay/lesbian is not significantly
436	different for either the population as a whole (NHIS: 1.59%, se= 0.06%; and GSS:
437	1.93%,se=0.17%; $p = 0.059$) or for males and female considered separately (see Table 3). A
438	relatively large discrepancy arises, however, for the estimated proportion of the U.S. population
439	describing itself as bisexual. Overall, the GSS estimates are more than double those made from
440	the NHIS program (2.90%, se=0.26% vs. 1.03%, se=0.05%). This difference is particularly
441	pronounced for women (GSS: 4.07%, se=0.42% vs. NHIS: 1.42%, se=0.08%).

442	While the observed <i>discrepancies</i> in our survey estimates are less than two percentage
443	points, they are noteworthy because the population characteristics of interest – prevalence of gay
444	and bisexual orientations – are equally small, i.e., 1 to 4 percent. Following a suggestion by
445	England et al. [22], we refined our analysis by adding controls for a variety of factors that are
446	known to influence (reported) sexual orientation. We did find that each of these control variables
447	had a significant statistical association with reporting of sexual orientations. But, the overall
448	discrepancy between the NHIS and GSS survey estimates still remained highly significant (p $<$
449	0.001) when these control variables are introduced into our multinomial model. In particular, the
450	GSS population estimates report 1.25 higher relative odds of reporting a gay/lesbian orientation
451	(vs. Straight) than the NHIS and 2.98 higher relative odds of reporting a bisexual (vs. Straight)
452	sexual orientation.

453

454 4.2 Congruence of Estimated Association between Sexual Orientation and Sociodemographic
455 Predictors.

Further analyses indicate that these inter-survey discrepancies do not contaminate conclusions about the associations between sexual orientations and time or our other predictor variables (birth cohort, education, etc.). The formal test of this hypothesis (Appendix Table A) fit a multinomial model that included all five 3-way interactions of sexual orientation-by-predictorby-survey. None of these interactions were found to be statistically significant.

This result suggests that while the two survey programs *did not yield equivalent point estimates* of the proportion of the USA population reporting different sexual orientations, the survey programs do yield equivalent conclusions about changes in reporting of sexual orientations over time and across subgroups of the USA population defined by birth cohort, gender, education, and race.

468 **5. Implications**

469	The foregoing analyses demonstrate that these measurements of sexual orientation in the
470	US population meet a basic test for all scientific measurements. In particular, these two
471	independent series of measurements do not show statistically significant divergences in their
472	estimates of the association between variations in sexual orientations reported over time or their
473	association with the four other sociodemographic predictors included in our model. The
474	measurements themselves do, however, show statistically significant divergences in their point
475	estimates of the proportion of the U.S. population reporting different sexual orientations. In
476	particular, the General Social Survey produces markedly higher estimates of the proportion of the
477	U.S. population labeling themselves as bisexual.
478	These results have two implications for the use of these data. First, analysts can have
479	some confidence in conclusions regarding both trends over time and the association between
480	reported sexual orientation and sociodemographic factors regardless of which of these surveys
481	generated the data. Second, the significant variation observed in point estimates implies that it
482	would be foolhardy to simply merge estimates from these two surveys.

483

484 *5.1. Limitations*

As noted previously, our analysis benefits both from the large samples surveyed by each 485 survey program and the high-quality field operations that were used. We do note, however, three 486 serious limitations on our conclusions. First, our analysis was restricted to using only five 487 predictor variables: time, gender, birth cohort, education, and race. It is quite possible that we 488 might have reached different conclusions about the congruence of patterns of association if 489 different or additional sociodemographic predictors had been used. Second, our analysis of trends 490 over time is, by necessity, restricted to the three years in which the surveys' measurements 491 coincided (2014, 2016, 2018). Finally, our analysis does not provide a convincing explanation of 492 why the General Social Survey produced markedly higher estimates of the percent of U.S. adults 493

- this anomaly may reflect the impact of the GSS survey context, e.g., asking respondents to report 495
- on the numbers of male and female sex partners they had since age 18 or the fact that bisexual 496

- 2020). Future research should follow up on these speculations. 498
