Introduction. Stenosis of an organ/tissue primary artery may produce ischemia, malfunction
or only reduce blood flow reserve. Despite incomplete hemodynamic understanding of critical arterial stenosis, degree of diameter stenosis continues to be an index for patient management. This study aims to use conservation of energy to; quantitate the arterial pressure gradient produced by stenosis, determine organ/tissue perfusion pressure, blood flow and reserve as a function of degree of diameter stenosis and identify critical diameter stenosis, if it exists. Methods. A three-component system is considered, parallel stenotic artery and collateral circulation supplying organ/tissue. Energy analysis of arterial stenosis gives the pressure gradient produced and stenosis vascular resistance. Organs/tissues intrinsically autoregulate g radient produced and stenosis variables vascular regulate interiorganisme. blood flow when perfusion pressure is greater than threshold value. System energy analysis defines collateral vascular resistance and gives perfusion pressure, blood flow and reserve as a function of diameter stenosis. Renal and internal carotid artery (ICA) stenosis provide numerical function of diameter stems in human and internal carotid artery (ICA) stendard provide numerical

Results.The magnitude of stenosis energy dissipation, K, is a fourth power function of

stenosis diameter with a steep slope between 65% and 80%, (K = 67 to 625). Systems without collaterals, $C = 0$, have discrete critical stenosis values within this range. Renal critical stenosis is 74% (K = 233). Systems with poor collaterals, $C < 1$, have critical stenosis from 65% to 99% depending on collateral magnitude. Critical ICA stenosis begins at 70% and up to 99%, (K = 132 to ∞). Degree of cerebral ischemia is non-linearly inversely proportional to collateral magnitude, C. Systems with good collateral circulation, $C > 1$, do not have critical stenosis, including the ICA (cerebral hemisphere). In these systems stenosis progression reduces blood flow reserve but does not produce ischemia.

Conclusion. Critical diameter arterial stenosis may or may not exist for specific organ/tissue systems depending on the magnitude of collateral circulation.

Introduction

In 1981 we reported that critical internal carotid artery (ICA) diameter stenosis, based on
intraoperative blood flow measurements. was approximately 60%¹. Several discussants intraoperative blood flow measurements, was approximately 60% ⁻. Several discussants
correctly pointed out that the relationship between blood flow and pressure make quantification of critical arterial stenosis difficult and one considered critical arterial stenosis "pursuit of an impossible goal". failed because collateral blood flow reduced measured ICA flow and the calculated critical stenosis value. Decades later the critical stenosis problem remains inadequately analyzed as does the effect of arterial stenosis on organ/tissue hemodynamics in general. One might expect success using modern computational fluid dynamics (CFD) to numerically solve a complex fluid mechanics problem that includes stenosis turbulent flow, but this is not the case $2,3$. The observation that pipe diameter produces a decrease in pressure (pressure gradient) in proportion to the lumen area was made by Poiseuille centuries ago. Much later It was found that decreasing stenosis area in animal arteries increases pressure gradient 4.5 . Some investigators recognized the value of using conservation of energy to capture stenosis turbulence $6,7$ but fail to consider critical stenosis in the context of recipient organ/tissue. Standard CFD based on the law of conservation of momentum Navier-Stokes equations inadequately quantitates turbulent flow even when including Reynolds stresses. Conversely, the law of conservation of energy encompasses turbulence and may provide a solution for the effect of arterial stenosis on specific body organ/tissues. Recent studies demonstrate that stenosis produced turbulent kinetic energy (TKE) can be quantitively measured by magnetic resonance imaging (MRI), is not reversible back to pressure energy and dissipated locally 8,9 . Directly measured aortic valve and vessel stenosis pressure gradients correlate well with MRI measured TKE dissipation 10 . This information plus the necessity to consider arterial stenosis in the context of specific artery-collateral-organ/tissue systems are the basis for this study.

Methods

Hemodynamic Energy. Energy generated by the left ventricle and delivered to systemic
organs/tissues is ≈99% pressure energy and ≈1% kinetic energy. For cardiac output of 4.5 liters/minute with mean aortic pressure 100 mmHg, pressure energy is ≈1.0 watts/sec versus 0.011 watts/sec of kinetic energy. In normal body systems, blood flow is laminar and hemodynamic energy is primarily dissipated efficiently in body organs/tissues by parallel small artery branches, arterioles and pre-capillaries. Conversely, arterial stenosis converts pressure energy to TKE that is dissipated, reducing organ/tissue perfusion pressure. The hemodynamics of turbulent blood flow is poorly understood and incompletely modeled by both CFD 3 and of turbulent blood flow is poorly understood and incompletely modeled by both CFD $^\circ$ and

Assumptions and Definitions.Blood is assumed to be an incompressible, homogenous and isotropic fluid. Volume blood flows, Q, and pressures, P, are mean values. Systemic blood pressure, P_a , is arterial pressure minus venous pressure, a normalization. The artery has cylindrical lumen area A (diameter D) with a concentric stenosis of lumen area a (diameter d). System hemodynamic input pressure energy is P_aQ , and the 1% input kinetic energy is neglected. Vascular resistance, R, a defined calculated variable, is pressure gradient, ΔP , divided neglected. component energy system is analyzed; stenotic artery anatomically in parallel with collaterals supplying organ/tissue blood flow. Hemodynamic energy is dissipated by the vascular resistances; stenosis, R_s , collateral, R_c , and organ/tissue, R_o . Fractional percent diameter stenosis (F%DS, X) is the independent variable.

Numerical calculations are centimeter, gram, second (CGS) units. Pressure is mmHg $1mmHg = 1,333$ dyne/cm), blood flow is cm/sec, energy is dyne cm/sec (erg/sec) = 10^{-7} watts and blood density is 0.994 g/ml.

Arterial Stenosis Energy Dissipated and Vascular Resistance, R_s. stenosis, X, values from 65% to 80% diameter stenosis (slope of curve approximately 37:1). The wide variance in stenosis produced kinetic energy is associated with a narrow range of degree of stenosis. Over 98% of stenosis produced kinetic energy is turbulent, irreversible back to pressure energy and dissipated in the stenosis zone. Vascular stenosis resistance, defined as the ratio of pressure gradient to flow, is $R = \Delta P/Q$. Arterial stenosis vascular resistance is $R_s =$ $Q_s/[1/(1 - X)^4] - 1/2A^2 = Q_sK/2A^2$, where the subscript sindicates arterial stenosis resistance Q_s{[1/(1 – X)*] – 1}/2A² = Q_sK/2A² , where the subscript _s indicates arterial stenosis resistance
and blood flow. This result, like K, stands-alone and is universally applicable to body systems. Organ/tissue Vascular Resistance, R_o . Organ/tissues control blood flow by intrinsically autoregulating perfusion pressure energy to meet metabolic energy requirements. The lower autoregulation threshold perfusion pressure (P_{cut}) means that organs/tissues have two blood flow zones depending on perfusion pressure. Lassen's measurements of normal human cerebral blood flow autoregulation $14,15$ with an ischemic perfusion pressure threshold of 50mmHg is illustrated in Figure 1. Renal autoregulation lower threshold for normal glomerular filtration is \approx 80mmHg and for ischemia is \approx 60mmHg. In the autoregulation zone, vascular resistance is $R_o = P_p/Q_n$, where Q_n is normal blood flow and P_p is perfusion pressure. If organ/tissue P_p falls below autoregulation pressure threshold, P_{cut} , blood flow is linearly pressure dependent, $R_o = P_{cut}/Q$ and $Q < Q_n$.

Collateral Vascular Resistance, R_c . Many organs/tissues have both a primary artery and collaterals. Kidneys are essentially entirely dependent on renal artery blood flow and accessory renin arteries supply isolated kidney segments. Brain has a complex blood supply with both primary arteries and collaterals primarily the circle of Willis. In Figure 5 the perfusion pressure curves in the autoregulation zone ($P_p > P_{cut}$) illustrates the decrease in reserve energy density and blood flow reserve as stenosis progresses and collateral magnitudes $C = 0$, 0.33, 1.0 and 2.0.

In the perfusion pressure zone $P_p < P_{cut}$ blood flow is proportional to P_p . Energy conservation is $P_a = R_oQ = (P_{cut}/Q_n)Q$ where $Q = Q_s + Q_c$, $Q < Q_n$ and the slope is Q_n/P_{cut} . When $C > 0$ but < 1.0, the solution for Q as a function of X is a solvable quadratic not included in Figure 5. In the absence of collateral blood flow $(C = 0)$ Q is a linear function of P_p, per the Lassen model in Figure 1.

Critical Arterial Stenosis. Critical arterial stenosis is defined as the percent diameter stenosis at which further stenosis progression reduces organ blood flow below normal into the ischemic zone. Kidneys are a major solid organ with both closely autoregulated normal blood flow and essentially no collateral flow. Assuming renal artery blood flow 9.0 ml/sec, normal renal artery diameter 0.60cm, mean systemic arterial pressure 110mmHg and an autoregulation ischemic threshold pressure 60mmHg, $X_{crit} = 0.744$ or 74.4% diameter stenosis. For a pressure threshold of 80mmHg for onset of increased renin production and glomerular filtration dysfunction, the critical diameter stenosis is 70.9%. These values have a 95% confidence interval (CI) of approximately 3% for wide variance of normal anatomic and hemodynamic variables. This is illustrated in Figure 4.

Cerebral hemispheres are major solid organs with closely autoregulated normal blood flow and highly variable between human collateral vascular resistance. In the absence of collateral blood flow and assuming normal internal carotid blood flow 6.25 ml/sec, normal diameter 0.50cm, mean systemic arterial pressure 100mmHg and autoregulation threshold 50mmHg, critical internal carotid artery (ICA) diameter stenosis is 0.704 or 70.4% with 3%CI. Based on clinically measurements mean internal carotid stump pressures is approximately 50 mmHg when normalized to $P_a = 100$ mmHg, and cerebral collateral vascular resistance is close to hemisphere resistance, $C = 1$. For the approximate 50% of individuals with $P_{\text{stump}} < 50$ mmHg (P_{stump} adjusted to $P_a = 100$ mmHg) and collateral vascular resistance $C < 1$, (poor collaterals), critical ICA stenosis increases from 70% to 100% as C increases from 0 to 1.0. Conversely, if collateral blood flow is adequate to maintain normal cerebral flow with internal carotid collateral blood flow is adequate to maintain normal cerebral flow with internal carotid

Arterial Stenosis Blood Flow. When collaterals are present, the energy relationship

between collateral and arterial blood flow is $Q_c/Q_s = R_s/R_c$ and $Q = Q_c + Q_s$. For example, when cerebral hemisphere perfusion pressure equal to or greater than threshold 50 mmHg, blood flow is normal and $Q_c = Q_n - Q_s$. For ICA diameter stenosis of 50%, 60%, 70%, 74% and 80% the corresponding ICA blood flows (Q_s and % of normal) are 5.80ml/sec $(93%)$, 5.41 $(87%)$, 4.45 $(71%)$, 3.85 $(62%)$ and 2.74 $(44%)$. Individuals with below average collateral blood flow, $C < 1.0$, have a lesser decrease in ICA blood flow. approximate 50% of individuals with good collaterals (C > 1.0 and P_{stump} >50 mmHg) have a significant decrease in ICA blood flow. Similarly, these individuals will have much less energy dissipated in the stenosis zone (energy = P_pQ_c) than those with C < 1.0. Good collateral flow reduces both stenosis pressure gradient ($P_a - P_p$) and blood flow Q_s as stenosis progresses. Discussion
Arterial stenosis reduces recipient organ/tissue's perfusion pressure and blood flow reserve. If collaterals are absent, $C = 0$, there is a discrete critical stenosis value. Renal artery ischemic critical stenosis is 74%, as in Figure 4. If collaterals are poor, $C < 1.0$, critical stenosis for body critical stems is α , β in Figure 4. If collaterals are pool, β = 1.0, critical stems, α

| organ/tissues range from ≈65% to 99%, in proportion to collateral magnitude. For cerebral hemispheres this is 73% to 99%, as in Figure 5. If collaterals are good, $C > 1.0$, there are no critical values and reserve blood flow is available at occlusion, as also illustrated in Figure 5.

Turbulent vessel flow is an incompletely understood phenomena. Classical fluid mechanics is primarily based on momentum conservation that inadequately models arterial turbulence resulting in incomplete solutions, even with CFD. Conservation of energy requires stenosis TKE produce a pressure gradient. While unlikely to be original, the universal stenosis magnitude, $K =$ $\{ [1/(1-|X|^4 - 1] \}$, where X is F%DS, is energy conservation valid. relationship between stenosis produced pressure gradients and stenosis area turns out to be area squared, diameter to the forth power. The relationships between organ/tissue perfusion pressure and blood flow as a function of X are illustrated in Figures 3, 4 and 5. Critical arterial stenosis, if exists, depends on the magnitude of collateral blood flow.

The defined magnitudes of stenosis energy, K, and collateral circulation, C, simplify presenting and understanding result. The K variable is specific for an organ/tissue system's degree of artery stenosis. While K ranges from zero to infinity, the independent variable, X, ranges from zero to one, or 0% to 100% diameter stenosis. The C variable is specific between individuals and within an individual's organ/tissue systems. Collateral circulation is a major determinant of X_{crit} . In the absence of collateral circulation C = 0, X_{crit} occurs when dissipated arterial stenosis energy negates autoregulation reserve energy, as for renal. When collateral circulation is present with increasing C magnitude up to 1.0, (C > 0, C < 1.0), X_{crit} increases up to 0.99, (99% stenosis). When collateral circulation is adequate to prevent organ/tissue 0.99, (99% stenosis). When collateral circulation is adequate to prevent organ/tissue

autoregulation from being depleted and C > 1.0 if the artery occludes, blood flow is adequate to prevent ischemia and provide reserve.

Potential Clinically Useful Results. Much of physical and biological science and resulting technology are based on models. They are considered good, but not necessarily correct if they are useful. A model is useful for both understanding and guidance for future investigation if it represents reality based on and consistent with clinical observation 18 .

Arterial stenosis generated kinetic energy magnitude, K, is appliable to any artery, as is stenosis vascular resistance. It can be easily modified for percent area stenosis allowing other stenosis geometries but not length. Collateral magnitude, C, is body organ/tissue system specific and individual specific for collateral blood flow potential. Critical arterial stenosis is a function of many variables including systemic arterial pressure. Hypertension may be beneficial in protecting organs/tissue with no or poor collaterals and arterial stenosis from ischemia. Common femoral/external iliac arteries likely have poor collaterals and may have critical stenosis values. Conversely, at rest an isolated superficial femoral artery stenosis has no critical value or produce ischemia, even with occlusion. However, exercise increases lower extremity metabolic energy requirements and collateral blood flow producing ischemic symptoms.

Progressive stenosis decreases artery blood flow, Q_s , in proportion to the magnitude of collateral potential, as in Figure 6. Degree of arterial stenosis determined from ICA ultrasound velocities measurements may be underestimated, particularly if collateral flow is good. If degree of stenosis accurately measured by imaging is significantly higher than that estimated by ultrasound velocities, collateral flow is probably good. This may have some bearing on the important clinical problem of determining stroke risk and management recommendations for important clinical problem of determining stroke risk and management recommendations for

individuals with asymptomatic ICA stenosis. Good collateral blood flow potential is predicted to both prevent cerebral ischemia, even if the ICA occludes, and reduce stenosis zone energy dissipation. The magnitude of turbulent energy dissipation may impact stenosis plaque stability. A decrease in ICA plaque zone TKE is potentially a further asset of good collaterals in individuals with asymptomatic carotid arterial stenosis.

Limitations, Assumptions. While results appear complex, the analysis is relatively simple, algebraic without calculus or CFD. Blood flow and pressure are assumed to be steady, not pulsatile and out of phase. The validity of using turbulent kinetic energy produced by arterial stenosis to determine stenosis pressure gradient was confirmed by MRI for the aortic valve and phantom vessels $8-10$. While kinetic energy in normal arteries is laminar, mild stenosis of 30% -50% diameter produce almost entirely turbulent kinetic energy $19,20$. Prior to these findings several attempt to describe arterial stenosis hemodynamics based on energy revert to a laminar flow momentum models or use empirical/experimental estimates to inadequately deal with turbulence $2,4,6$. Similar incomplete results were obtained using CFD turbulence models 3 .

Normal artery-collateral-organ/tissue systems have efficient laminar blood flow. The standard for estimating transition from laminar to turbulent flow is Reynolds number, Rn¹¹. For steady flow in a pipe transition Rn is 2000 to 2500. Based on Womersley number 21 and turbulent energy cascade transition 22 , vessel turbulent Rn are 400 to 500, close to the laminar Rn for renal and ICA examples. Depending on magnitude, stenosis dissipated TKE may clinically produce an audible bruit (frequency near 20 cycles/second) and/or a palpable thrill.
