### 63 **Objective**

- 64 Anecdotal reports and a small number of research studies suggest possible behavioral
- 65 improvements in children with autism spectrum disorders (ASD) during a fever. However,
- 66 previous studies rely largely on retrospective reports of this phenomenon. Establishing a robust
- 67 association between fever and reduction of ASD-related symptoms would promote opportunities
- 68 for the development of innovative therapeutic interventions for children with ASD.

## 70 Methods

- 71 Prospective data were collected from 141 children with ASD and 103 typically developing (TD)
- 72 controls using parent responses to an 11-item behavioral survey. Behaviors when no illness was
- 73 present, during a fever, the week after a fever, and during non-febrile illnesses for TD and ASD
- 74 children were compared. Profiles of cases in which caregivers reported consistent behavioral
- 75 improvements during fever are described.

## 77 Results

- 78 Data indicated worsening social, emotional/behavioral, and somatic symptoms during a fever
- 79 regardless of diagnosis, with children with ASD demonstrating greater worsening of behaviors
- 80 during a fever than TD children. Three children (all with ASD) out of 244 demonstrated
- 81 consistent behavioral improvements during a fever; these children had a range of cognitive and
- 82 adaptive skills.

# 84 Conclusions

- 85 Children with ASD had stronger negative responses to fever than TD children. These findings
- 86 contradict previous literature suggesting behavioral improvements for children with ASD. While
- 87 improvements may occur for some children, it does not appear to be a common phenomenon.
- 88 Additional research is needed to elucidate the nature of behavioral improvements in the subset of
- 89 children with ASD who may respond positively to fever.

| 90  | Anecdotal reports suggesting the possibility of behavioral improvements in children with                     |

| 91  | autism when they experience a fever have been made for years. <sup>1</sup> Yet, there is surprisingly little |
| 92  | published data examining these effects. The largest study to date used retrospective caregiver-              |
| 93  | report data from a sample of over 2000 children with autism spectrum disorder (ASD) from the                 |
| 94  | Simons Simplex Collection (SSC). Seventeen percent of families reported improvements in                      |
| 95  | autism symptoms during a fever. <sup>2</sup> This subgroup had less speech, lower nonverbal IQs, higher      |
| 96  | levels of autism symptoms, higher levels of restricted and repetitive behaviors, and higher                  |
| 97  | parent-reported levels of stereotypies, inappropriate speech, hyperactivity, and irritability as             |
| 98  | measured on the Aberrant Behavior Checklist (ABC) <sup>3</sup> , compared to children whose caregivers       |
| 99  | did not report behavioral improvements. However, this study relied solely on retrospective                   |
| 100 | parent-report and was collected in response to just one (arguably leading) question: "Does your              |

aware that this study was testing behavioral responses specifically to fevers, which couldincrease the possibility of biased reporting.

114 The current study aimed to investigate, prospectively, the association between autism and 115 behavioral improvements during fever and non-febrile medical events in children with and 116 without ASD. Parent reports were collected at baseline (i.e., no illness), during fevers, and during 117 non-febrile illnesses in a sample of 141 children with ASD and 103 TD controls. We set out to 118 understand the degree to which children with ASD have unique responses to fevers by asking the 119 following questions: (1) Do participants exhibit behavioral changes during a fever? 125 This study included 244 children; 141 were diagnosed with ASD, and 103 were TD. The 126 majority of participants (70%) were male. The parent-reported racial/ethnic breakdown of the 127 participants is as follows: 55% White, 16.4% Asian, 5.3% Black, 17.6% Mixed Race, and 5.7% 128 American Indian, Pacific Islander, or Other; 24.6% identified as being Hispanic. Table 1 presents 129 the demographic characteristics of those who had a fever and those who did not, by diagnosis. 130 Children were recruited through research databases, word-of-mouth referrals, and flyers 131 posted in local autism clinics, pediatric offices, daycares, and schools in the greater Los Angeles, 132 San Francisco, and New York areas. Inclusion criteria included being between the ages of 2 to 7 133 years, having had a fever in the previous 12 months, and independently walking. If recruited for 134 the ASD cohort, parents were asked to provide documentation of a clinical ASD diagnosis for

138 **Procedures** 

Event reporting and behavioral tracking data were collected through a smartphone application developed for the current study. During the initial study visit, research staff provided the participating parent with instructions on how to download and operate the application used for data collection. Parents and children completed a battery of questionnaires, and assessments described below.

144 Behavioral tracking lasted for three months. Once per week (at a time when no event had 145 occurred), parents were asked to complete the behavioral survey; these data were collected as 146 baseline measures of behavior. Parents also used the app to report on medical events, as well as 147 other "out of the ordinary" life events that occurred, such as non-routine vacations. If parents 148 reported an event, they were asked to explain the event that transpired and complete the 149 behavioral survey (see Supplement 1). Each time parents submitted an event and/or completed 150 the behavioral survey, they were asked to take and report their child's temperature. Non-medical 151 data were collected to conceal the specific aims and hypotheses of the study (pertaining to 152 behavioral responses to fever) and prevent biased reporting. To address the aims of the current 153 study, only data regarding medical events were analyzed.

After the three-month data collection period concluded, participants completed a subset of questionnaires. Compensation was provided to all participating families. Researchers acquired informed consent from parents with approval from the University of California, Los Angeles

## 160 Event and Behavioral Survey Reporting via App

161 All event data were coded into one of five categories: baseline, fever, week-after-fever, 162 non-fever medical, and other. Baseline data are those that parents submitted once per week at a 163 time when no event had occurred. Fever data are defined as medical events in which the parent 164 reported the child to have a fever  $\geq$  100.0 degrees Fahrenheit. Week-after-fever data are defined 165 as data that were reported in the 7 days succeeding the final fever report. These data were 166 considered separately from baseline to examine whether the effects of fever may last beyond the 167 fever itself and to prevent confounding the baseline data. Non-fever medical data are defined as 168 any medical event (e.g., gastrointestinal issues, sore throat) that occurred without a coinciding 169 fever. "Other" data are defined as various "out of the ordinary" events that were not medical in 170 nature.

171 The behavioral survey, created by the study team, was comprised of 11 questions 172 regarding the child's mood and behavior. The survey asked parents to rate, on a five-point Likert 173 scale, how much the child exhibited a certain behavior compared to usual behavior. Lower scores 174 indicated less than usual and higher scores indicated more than usual. For data analysis, 175 questions nine and ten (i.e., irritability and anxiety) were reverse coded to ensure that scores of 176 five indicated lessening behavioral symptoms (i.e., less irritability and less anxiety). For ease of 177 interpretability, all items were then recoded to scores from -2 to 2; negative scores indicated 178 worsening symptoms, and 0 represented the same as usual.

| 180 | We collected various measures to characterize the sample and examine individual   |

| 181 | differences in behavioral responses to fever. The PPVT-4 <sup>5</sup> is an assessment of receptive                     |
| 182 | vocabulary for individuals between the ages of 2 years, 6 months through adulthood. If a child                          |
| 183 | was unable to obtain a basal score on the PPVT-4, the nonverbal subtests (Visual Reception and                          |
| 184 | Fine Motor) of the Mullen Scales of Early Learning (MSEL) <sup>6</sup> were administered. These tests                   |
| 185 | were administered to provide an estimate of cognitive ability. Standard scores from the PPVT                            |
| 186 | were used, whereas age equivalents from the MSEL were used to calculate a ratio   |
| 187 | IQ/developmental quotient. <sup>7</sup> The Vineland-3 <sup>8</sup> is a semi-structured parent interview that assesses |

- 198 Statistical Analyses
- 199 Preliminary Analyses

Factor Analyses of Behavioral Survey. Exploratory factor analysis (EFA) with oblique rotation was employed to generate the latent constructs measured by the behavioral survey. EFA demonstrated that a three-factor structure fit best for the survey items: Factor 1 ("Social

203 Behaviors") consisted of six items: happy/cheerful, talk to others, physically active,

social/interested, communicating ideas, and play; Factor 2 ("Emotional and Behavioral

205 Problems") consisted of three items: anxious, managing behaviors, and irritable; Factor 3

206 ("Somatic Symptoms") consisted of two items: eat and sleep (see Supplement 2 for detailed

207 results). The average rating of the items within each factor was calculated to represent factor

208 scores because the number of items loading on each factor differed.

### 209 Sample Characteristics

Descriptive statistics regarding demographic and behavioral characteristics of the sample were generated. Independent samples t-tests were used to compare these characteristics between the ASD and TD cohorts (see Table 1).

#### 213 Multilevel Modeling

214 Parent-report behavioral ratings across multiple days nested within participants were 215 used. Multilevel models with behavioral rating factor scores as outcomes were used to account 216 for the nesting and to capture both fixed and random effects at two levels of analysis. Level 1 217 focused on within-individual effects; we tested whether parents were more likely to report 218 children's behaviors to deviate (positively or negatively) from what they usually exhibited on 219 days when they experienced a fever, and the week after a fever, as compared to behaviors at 220 baseline. Level 2 focused on between-individual effects; we tested whether the within-person 221 association between behavioral changes and fever conditions differed for the ASD vs. TD 222 samples. Sequential multilevel models were specified in SAS PROC Mixed to address the 223 research questions respectively. Model fit indices (i.e., AIC, BIC, smaller values mean better 224 model fit), variances explained, and parameter estimates of the fixed and random effects in each 225 model are reported.

226 To address research questions of behavioral changes across fever conditions: First, the 227 intraclass correlation (ICC) of each factor score was computed to reflect how much of the total 228 variation in behavioral ratings was accounted for by individuals through the unconditional model 229 (Model 1) with no predictors. Second, to test the effect of fever conditions, we estimated separate 230 two-level models with each of the three factor scores as the outcome variable. We included the 231 fixed effect of the fever condition variable (three categories: baseline, fever, and week-after) 232 with baseline as the reference condition at Level 2 (individual level), and the random intercept at 233 Level 1 to capture random between-individual variability in children's average level of 234 behavioral changes on the factors and the random slope of between-individual variability in 235 associations between fever conditions and behavioral changes (Model 2). Third, we added the 236 fixed effect of diagnosis (with TD as the reference) and the interaction effect of diagnosis and 237 fever condition to Model 2 (Model 3). Model 3 estimates were used to determine the main effect 238 of diagnosis on behavior rating factor scores and to examine whether children with ASD were 239 affected differently by fever conditions than TD children. Lastly, multi-level models were fitted 240 to test the behavioral changes during fever compared to during non-febrile illnesses, and whether 241 these changes differed by diagnosis.

### 242 Case Analysis of Children with Behavioral Improvement During Fever

We describe profiles of cases in which caregivers reported behavioral improvements (score of 5 indicating clear changes) on the same behavioral survey item(s) across at least two separately reported fevers.

#### Results

247 Descriptive Analyses of Behavioral Ratings

248Table 2 presents the average number of baseline, fever, week-after-fever, and non-febrile249illnesses reported for children, by diagnosis. On average, parents provided 8 baseline survey250reports, plus 2 during a fever, 1.5 the week after a fever, and 2.5 during non-febrile medical251illnesses. A similar proportion of parents of children with and without ASD (50 and 41,252respectively) reported at least one fever event ( $M_{FeverReports} = 2.04$ ); fewer parents completed253behavioral survey ratings in the week after a fever compared to all other conditions.

#### 255 Behavioral Changes During Fever vs. Baseline

256 Multilevel modeling revealed a significant main fixed effect of fever condition on all 257 three factors, suggesting that children's social, emotional/behavioral, and somatic symptoms all 258 worsened during a fever compared to baseline (see Table 3 for test statistics). When comparing 259 behaviors during the week after a fever to baseline, the only significant difference was in 260 emotional and behavioral problems (Factor 2; see Table 3). The random slopes of fever 261 conditions on behavior changes across all three factors were significant, suggesting that fever 262 conditions differed for all types of behaviors (see Table 3). The fixed and random effect of fever 263 condition explained 67% of the variance in Factor 1 behavioral ratings, 36% in Factor 2, and 43% in Factor 3 (see Table 3 for pseudo  $R^2$  values). 264

There was no overall effect of ASD diagnosis for any of the behavioral rating factor scores. However, a significant interaction was observed for all three behavioral factor scores. Compared to TD children, children with ASD were reported to have worse social (Factor 1) and somatic (Factor 3) factor scores during fever than during baseline. Children with ASD also showed worse emotional/behavioral problems (Factor 2) during the week after a fever compared

- to baseline (ps<.05). However, no significant improvements in model fit were observed when the
- 272 main effect of ASD diagnosis and the interaction effect were added.

## 273 Behavioral Changes During Fever vs. Non-febrile Illness

- 274 Multilevel models comparing behavioral changes during a fever to non-febrile illnesses
- 275 demonstrated that caregivers reported their children to have worse social and
- emotional/behavioral factor scores during fever than during non-febrile illnesses (see Table 4 for
- test statistics). The addition of the main fixed effect of diagnosis and the interaction effect of
- diagnosis and condition did not improve model fit for any of the behavioral rating factor scores.

## 280 Cases with Behavioral Improvements During Fever

Figure 1 depicts the proportion of participants who reported positive, negative, and no changes in response to each behavioral survey item. Three participants, all with ASD between the ages of 2-7, showed consistent positive changes on the same behavioral survey items during at least two fevers. Two participants were reported to be less irritable and have behaviors that were easier to manage during two out of two or three fevers. The third participant was reported to be less anxious and less irritable during two out of two fevers. Table 5 depicts the SRS-2, Vineland-3, and PPVT-4 scores of theses participants.

#### Discussion

Results suggest that children with and without ASD demonstrate similar patterns of behavioral changes in response to fever. In general, children in both groups were reported to exhibit worse social, emotional/behavioral, and somatic symptoms, with these negative changes

294 even more pronounced among children with ASD. These findings are opposite to numerous 295 anecdotal reports and at least two empirical studies suggesting behavioral improvements during 296 fever in children with autism.<sup>4</sup> Nevertheless, our finding that three children with ASD 297 demonstrated behavioral improvements in response to fever suggest that, while it is certainly not 298 the norm, a small subset of children may indeed be positively affected by fever. 299 Previous data from the SSC reported that improvements associated with fever were more 300 likely to occur in children with lower cognitive abilities and higher levels of restricted and 301 repetitive behaviors. In contrast, many of the children in the current sample diagnosed with ASD 302 had average or near-average cognitive abilities, which may help explain differences in fever 303 responses in our sample. Yet, the three individuals who had consistent behavioral improvements 304 with fevers varied in terms of cognitive and adaptive abilities. Their clear individual differences 305 complicate potential conclusions about phenotypic patterns related to behavioral improvements 306 during a fever for this sample. 307 It is possible that predictors of improvement are not at the phenotypic level but, rather, at the 308 biological level. Some hypothesized mechanisms for improvement in autism symptoms during

fever include the role of the locus coeruleus,<sup>12</sup> inflammatory processes in the cerebellum,<sup>13</sup> and

310 hypothalamic responses to thermoregulation.<sup>14</sup> Additional research could elucidate the nature of

311 the association between fever and behavioral changes in children with ASD. If this phenomenon

312 could be detected reliably in a subset of children with ASD, innovative therapeutic interventions

313 could be developed from an understanding of the neuronal systems involved in symptom

314 improvement as a response to fever. However, given the apparent rarity of this phenomenon,

315 much larger sample sizes would be needed if researchers wanted to identify subgroups of

316 individuals who respond positively to fever.

| 317 | The ability to compare behavioral changes during a fever to during non-febrile illnesses was       |

| 318 | a noteworthy strength of this study's methodology. Results demonstrated that most participants,    |
| 319 | TD or ASD, exhibited worsening social and emotional/behavioral symptoms during a fever             |
| 320 | compared to non-febrile illnesses. This suggests that it could be the fever itself or possibly the |
| 321 | severity of the illness which we did not rate, as opposed to general immune responses, that are    |
| 322 | associated with behavioral changes.  |
| 323 | This study had a number of limitations. Our sample size was relatively small, leading to           |
| 324 | limited power in analyses. Additionally, future studies could include a more diverse sample with   |
| 325 | children who are older and have varying cognitive abilities.                                       |
| 326 | Conclusions  |
| 327 | This study demonstrated that both TD children and those with ASD display worsening                 |
| 328 | social, emotional and behavioral, and somatic symptoms during fever, even when compared to         |
| 329 | non-febrile illnesses. Furthermore, children with ASD were more affected by fevers (i.e., greater  |
| 330 | worsening of symptoms) than TD children. Our findings suggests that, while behavioral              |
| 331 | improvements during fever may happen for a small subgroup of children with ASD, it likely is       |
| 332 | not the norm.  |




