COVID-19 booster vaccination during pregnancy enhances maternal binding and neutralizing antibody responses and transplacental antibody transfer to the newborn (DMID 21-0004)

Key Points:

Question: What is the immune response after COVID-19 booster vaccination during pregnancy and how does receipt of a booster dose impact transplacental antibody transfer to the newborn?

Findings: Receipt of COVID-19 mRNA vaccines during pregnancy elicited robust binding and neutralizing antibody responses in the mother and in the newborn. Booster vaccination during pregnancy elicited significantly higher antibody levels in mothers at delivery and cord blood than 2-dose vaccination, including against the Omicron BA.1 variant.

Meaning: COVID-19 vaccines, especially booster doses, should continue to be strongly recommended during pregnancy.

Abstract:

Importance: COVID-19 vaccination is recommended during pregnancy for the protection of the mother. Little is known about the immune response to booster vaccinations during pregnancy.

Objective: To measure immune responses to COVID-19 primary and booster mRNA vaccination during pregnancy and transplacental antibody transfer to the newborn.

Design: Prospective cohort study of pregnant participants enrolled from July 2021 to January 2022, with follow up through and up to 12 months after delivery.

Setting: Multicenter study conducted at 9 academic sites.

Participants: Pregnant participants who received COVID-19 vaccination during pregnancy and their newborns.

Exposure(s): Primary or booster COVID-19 mRNA vaccination during pregnancy.

Main Outcome(s) and Measure(s): SARS-CoV-2 binding and neutralizing antibody (nAb) titers after primary or booster COVID-19 mRNA vaccination during pregnancy and antibody transfer to the newborn. Immune responses were compared between primary and booster vaccine recipients in maternal sera at delivery and in cord blood, after adjusting for days since last vaccination.

Results: In this interim analysis, 167 participants received a primary 2-dose series and 73 received a booster dose of mRNA vaccine during pregnancy. Booster vaccination resulted in significantly higher binding and nAb titers, including to the Omicron BA.1 variant, in maternal serum at delivery and cord blood compared to a primary 2-dose series (range 0.55 to 0.88 log₁₀ higher, p<0.0001 for all comparisons). Although levels were significantly lower than to the prototypical D614G variant, nAb to Omicron were present at delivery in 9% (GMT ID50 12.7) of Pfizer and 22% (GMT ID50 14.7) of Moderna recipients, and in 73% (GMT ID50 60.2) of boosted participants (p<0.0001). Transplacental antibody transfer was efficient regardless of vaccination regimen (median transfer ratio range: 1.55-1.77 for binding IgG and 1.00-1.78 for nAb).

Conclusions and Relevance: COVID-19 mRNA vaccination during pregnancy elicited robust immune responses in mothers and efficient transplacental antibody transfer to the newborn. A booster dose during pregnancy significantly increased maternal and cord blood antibody levels, including against Omicron. Findings support continued use of COVID-19 vaccines during pregnancy, including booster doses.

Introduction

Pregnant individuals are at increased risk of severe disease after SARS-CoV-2 infection.^{1,2} Infants younger than 6 months of age who become infected with SARS-CoV-2 are at increased risk of hospitalization.³ COVID-19 vaccination during pregnancy is critical to mitigate the burden of disease for mothers and their infants.⁴ In October 2021, pregnant individuals became eligible for booster vaccinations, yet the response to a booster dose has not been well characterized.⁵

In this prospective cohort study, we measured the antibody response to COVID-19 mRNA vaccines in pregnant participants and antibody levels in cord blood. Here, we report an interim analysis of the effect of booster vaccination in a subset of mothers and on transplacental antibody levels in the newborn.

Methods

This U.S. (United States)-based multicenter study enrolled pregnant participants with and without medical comorbidities from July 6, 2021 to January 31, 2022. Eligible participants received a primary 2-dose series of Pfizer-BioNTech (Pfizer) or Moderna mRNA-1273 (Moderna) vaccine, or a booster dose of either vaccine, at any time during pregnancy as per current recommendations. Sera for antibody assays were derived from maternal blood collected pre- and post-vaccination (from 2 weeks post-vaccination to delivery), and maternal and cord blood collected at delivery. Detailed protocol and study procedures are described elsewhere (DMID 21-0004).⁶

Immunogenicity

Binding immunoglobulin G (IgG) levels to full-length Spike (Spike) and to the receptor binding domain (RBD) of Spike evaluated using the validated Meso Scale Discovery (MSD) V-PLEX® SARS-CoV-2 Panel 2 IgG assay (MSD #K15383U)⁷ were bridged to international standards and reported as Binding Antibody Units (BAU/mL). SARS-CoV-2 neutralizing antibody (nAb) titers expressed as the serum inhibitory dilution required to achieve 50% neutralization (ID50) were evaluated by the live virus focus reduction neutralization titer (FRNT) assay with viruses representing SARS-CoV-2 Spike mutation

D614G and Delta and Omicron (BA.1) variants as described previously.⁸ Detailed assay methods are in Supplementary Materials. Transplacental antibody transfer was evaluated by calculating the ratio of specific antibody levels in maternal and cord blood sera at the time of delivery.

Statistical Analysis

Medians and interquartile ranges (IQRs) for binding IgG and ID50 nAb levels were summarized by study visit and vaccine type. Differences in antibody levels between groups at delivery were tested using regression analyses controlling for days since last vaccine dose, as well as sensitivity analyses that were restricted to participants with vaccination in the same time interval between last vaccination and delivery.

Results

This report includes the first 240 pregnant participants who gave birth and their newborns: 100 Pfizer (102 infants) and 67 Moderna (68 infants) 2-dose vaccine recipients, and 73 booster dose participants (75 infants) (Table 1). Booster doses were mostly homologous with the primary series (80.8%). The median age of participants was 34 years (range, 22-51). Participants completed their primary 2-dose series at a median of 17.1 weeks of gestation, while booster vaccination was received at a median of 28.6 weeks of gestation. Post-vaccination sera were collected at a median of 18.7 (range: 1.6-33.3) weeks following completion of the 2-dose series and 6.0 (range: 1.1-19.9) weeks following the booster dose. The interval (median weeks) between last vaccine dose and delivery was shorter for booster dose recipients (10.4) than primary 2-dose recipients (21.7). Overall, 7.8% of primary 2-dose recipients and 16.4% of booster dose recipients had prior laboratory confirmed SARS-CoV-2 infection.

SARS-CoV-2 binding antibodies

Serum binding IgG to Spike and RBD were detected in all primary 2-dose and booster dose recipients at the post-vaccination and delivery visits, and in all cord blood samples (Figure 1). Significantly higher antibody levels were measured post-vaccination and at delivery in participants who received a booster vaccination during pregnancy compared to those who received only a primary 2-dose series. At delivery,

the geometric mean titer (GMT) of IgG to Spike in booster vaccine recipients was 2,201 BAU/mL (n=73), 9.3-fold higher than in those receiving two doses of Pfizer (GMT 236 BAU/mL, n=100), and 4.6-fold higher than in those receiving two doses of Moderna (479 BAU/mL, n=67) vaccines (Figure 1). Booster vaccination also elicited significantly higher levels of Spike IgG in cord blood, where the GMT was 3,290 BAU/mL, 8.9-fold and 4.2-fold higher than in cord blood from those vaccinated with two doses of Pfizer (GMT 369 BAU/mL) or Moderna (GMT 792 BAU/mL), respectively (Figure 1). Similar trends were observed for RBD IgG in cord blood and at the post-vaccination visit to both Spike and RBD IgG (Figure 1, Table S1).

Overall, the booster group and their infants had ~ $0.6 \log_{10}$ higher Spike and RBD IgG levels at delivery compared to the combined primary mRNA vaccine group (Pfizer and Moderna) after adjusting for days since last vaccination (p<0.0001) (Table S1). Sensitivity analyses showed similar results (data not shown).

SARS-CoV-2 neutralizing antibodies

Significantly higher nAb titers to D614G were measured post-vaccination in pregnant participants who received a booster (GMT ID50 630.3) compared to those receiving a primary 2-dose series (GMT ID50 62.2 for Pfizer, 192.5 for Moderna) (Figure 2). High nAb titers persisted at delivery and were detectable in 100% of boosted participants (GMT ID50 446.4), compared to 68% (GMT ID50 49.9) and 96% (GMT ID50 179.5) of participants receiving 2 doses of Pfizer or Moderna, respectively (Figure 2, Tables S1, S2). While nAb titers to Omicron were present in only 9% (GMT ID50 12.7) of Pfizer and 22% (GMT ID50 14.7) of Moderna dosed participants at delivery, 73% (GMT ID50 60.2) of boosted participants had detectable nAb titers to Omicron (p<0.0001). Neutralizing activity against Delta was intermediate between D614G and Omicron.

Neutralizing antibody titers to D614G were also significantly higher in cord blood in the booster group (GMT ID50 742.5) compared to participants receiving 2 doses of Pfizer (GMT ID50 77.1) or Moderna

(GMT ID50 134.7) (p<0.0001). Notably, nAb titers to Omicron were significantly higher in cord blood from the booster group (88% response rate, GMT ID50 109.2) compared to those receiving 2 doses of Pfizer (14% response rate, GMT ID50 13.3) or Moderna (22% response rate, GMT ID50 14.6) (p<0.0001). Sensitivity analyses showed similar results (data not shown).

Transplacental antibody transfer

Efficient transplacental transfer was observed with both primary and booster vaccination during pregnancy, with median antibody transfer ratios between 1.55 and 1.77 for binding IgG and between 1.00 and 1.78 for nAb (Table S3).

Discussion

In this large, multicenter observational cohort study, robust antibody responses to mRNA COVID-19 vaccines were detected in pregnant participants immunized across all gestational ages. The substantial increase in binding and neutralizing antibody titers measured in mothers and newborns at the time of delivery after a booster vaccination is a key finding which supports the administration of booster doses during pregnancy. This response was also observed in the nAb response to Omicron BA.1 where levels were significantly higher in booster recipients at delivery and in cord blood compared to those receiving a primary 2-dose series only. This finding is particularly relevant given the persistence of Omicron and its subvariants in this phase of the pandemic. However, the nAb levels to Omicron were significantly lower than to the vaccine-matched D614G variant, as expected and observed in non-pregnant populations.⁹ While the effect of prior maternal infection with SARS-CoV-2 on antibody responses, particularly against Omicron and in the booster vaccination group, cannot be precisely ascertained in this observational study, the proportion of previously infected mothers was small. This potential effect will be assessed in the full study cohort. Additionally, maternal binding IgG antibodies against both Spike and RBD SARS-CoV-2 proteins were efficiently transferred across the placenta and concentrated in the infant. This latter finding is particularly important given high hospitalization rates among infants <6 months old during the recent

Omicron surge.³ Transplacental antibody transfer is a key component of newborn protection from SARS-CoV-2 infection and parallels demonstrated neonatal protection from respiratory pathogens such as influenza and pertussis.¹⁰

Given the observational design, the timing of vaccination during pregnancy was not pre-specified and the timing of sera collection post-vaccination was opportunistic. However, this investigation purposefully took a real-world scenario and inclusive enrollment approach and our analyses controlled for interval between vaccination and delivery to assess immune responses at the time of delivery. Thus, these data are generalizable and help delineate the potential impact of vaccination throughout pregnancy. Based on the effect of vaccination in non-pregnant populations, our study suggests likely heightened protection to mothers and newborns from booster doses during pregnancy.

Currently, pregnant women are not included among the risk groups targeted for a second booster dose of vaccine.¹¹ While an absolute correlate of protection is still unknown, increases in antibody responses in adults have correlated with protection from symptomatic and severe COVID-19. Our findings support that COVID-19 mRNA vaccines should continue to be recommended during pregnancy with a clear emphasis on the sizable response to booster administration.

Titers were bridged to international standards and reported as Binding Antibody Units (BAU/mL). Box plots represent median (horizontal line within the box) and interquartile range; GMT is displayed at the top of each panel and the dashed line is the cutoff for positivity (17 BAU/mL).

Figure 2. SARS-CoV-2 nAb activity of maternal and cord blood sera by study group and study visit.

Pregnant participants received a 2-dose series of an mRNA vaccine (top – Pfizer, middle – Moderna) or a booster mRNA vaccine (bottom panel). Sera derived from maternal blood collected pre- and post-vaccination and at delivery, and cord blood, were evaluated for neutralization of D614G, Delta, and Omicron (BA.1) variants. Each point represents the GMT ID50 from two duplicates per specimen (within the same assay run). A value equivalent to half the lower limit of detection (LLOD = 20) was assigned to observations with no detectable response. A specimen was considered as having a positive response if at least one of the duplicates was above the LLOD. Box plots represent median (horizontal line within the box) and interquartile range. Response rate (% with responses > 20 ID50), GMT, and GMT fold reduction compared to D614G are displayed at the top of each panel.

Supplemental Methods

Supplemental Methods 1: SARS-CoV-2 Binding Antibody Assay Methods

The humoral immune responses to SARS-CoV-2 vaccination and durability of vaccine-induced antibodies (Ab) in pregnant women and their infants were assessed with a quantitative, high throughput multiplexed binding antibody assay. Serum IgG against SARS-CoV-2 Spike protein, and S1 receptor binding domain (RBD) were measured using the Meso Scale Discovery (MSD) V-PLEX® SARS-CoV-2 Panel 2 IgG assay (MSD #K15383U) according to manufacturer's instructions. The MSD V-PLEX assays have been validated¹ by the manufacturer and have been employed in numerous studies to evaluate antibody responses to SARS-CoV-2 infection and/or vaccination.¹⁻⁷

MSD multiplex assays function similarly to a traditional ELISA; however, multiple antigens are bound to distinct spots in a single well of a 96-well plate, thereby allowing for the simultaneous measurement of specific Ab against multiple antigens. Assays were performed according to manufacturer's instructions. In brief, SARS-CoV-2 Plate 2 (MSD #N05380A-1) assay plates, MSD Blocker A solution (MSD #R93AA-2), and Diluent 100 (MSD #R50AA-3) were removed from 4°C storage and allowed to acclimate to room temperature (RT). Reference Standard 1 (MSD #C00ADK-2), Serology Controls (MSD #C00ADK-2), and serum samples were removed from -80°C storage, thawed on ice, and allowed to come to RT. Assay plates were blocked by adding 150 µL/well of Blocker A for 30-120 mins on microplate shaker (700 rpm) in RT incubator (22°C). After blocking, plates were washed three times with 150 µl/well 1X phosphate buffered saline and 0.05% Tween-20 (PBS-T). Serum samples were initially diluted to 1:5,000 in Diluent 100 and added to plates in duplicate (50 µL/well). Serology Controls 1.1, 1.2, and 1.3 were added undiluted to each plate in duplicate (50 µL/well). Seven-point Calibrators and a blank (Diluent 100 only) were prepared from dilution of Reference Standard 1, diluted 1:10 in Diluent 100 and 4-fold serially diluted. Calibrators were included in duplicate (50 μ L/well) on every plate. Plates were incubated for 2 h with 700 rpm shaking in RT incubator and subsequently washed with PBS-T as described above. Ab were detected with a conjugated SULFO-TAGTM Anti-Human IgG Antibody (MSD #D21ADF-3) diluted (1X) in Diluent 100. Detection

Ab was added at 50 μ L/well to all wells. Plates were again incubated for 1 h with 700 rpm shaking in RT incubator and were then washed with PBS-T. MSD GOLD Read Buffer B (MSD #R60AM-3) was added to plates (150 μ L/well), and plates were immediately read on the MSD QuickPlex SQ 120 reader. The instrument discharged an electrical current through the plate and measured the electrochemiluminescence (ECL) signal emitted by the bound detection Ab on each distinct antigen.

The raw data (ECL signals) were analyzed using MSD Discovery Workbench Version 4.0 software, which automatically subtracted the mean ECL signal of the blanks from sample data to generate adjusted ECL signals. The Workbench software generated a standard curve for each antigen by fitting the ECL signals from the 7-point calibrations curve (i.e., serial dilution of Reference Standard 1) to a four-parameter logistic (4PL) regression model. Ab concentrations in arbitrary units (AU)/mL of the Serology Controls and diluted sera were determined by the Workbench software. ECL signals were backfitted to the standard curve, and final Ab concentrations in undiluted samples were dilution corrected (calculated Ab concentration x sample dilution factor). The mean Ab result (AU/mL) of duplicates was reported.

Prior to testing IDCRC 21-0004 samples, quality control (QC) parameters and acceptance criteria were established, and an in-house standard operating procedure (SOP) was prepared by UMB. Goodness of fit (R2) of the 4PL regression was assessed in Workbench: for an assay to be accepted R2 was \geq 0.98. Additionally, the %Recovery of each point in each standard curve was examined. Acceptable %Recovery was defined as 80-120%. The acceptable ranges of the Serology Controls were defined as \pm 20% of the known Ab concentrations (Ab concentrations in AU/mL provided by MSD). The maximum variation of calculated Ab concentrations allowed between duplicates in standards or controls was a coefficient of variation (%CV) \leq 20%. If the standards or controls did not satisfy these criteria, then an assay or an entire plate was repeated.

For serum samples, if the %CV between duplicates was >25%, the test was repeated. If the adjusted ECL

signal of a sample was outside of the assay range (automatically determined by Workbench), then the sample was retested for that assay at an appropriate dilution. If the adjusted ECL signal was above the upper limit of quantification (ULOQ), the sample was repeated at a higher (less concentrated) dilution. Conversely, if the signal was below the lower limit of quantification (LLOQ) for an assay, the sample was repeated using a lower (more concentrated) dilution. ULOQ and LLOQ for each assay were tabulated by multiplying the upper and lower limits of detection (LOD) (determined by the manufacturer) by the lowest (1:100) and highest (1:100,000) sample dilutions allowed, respectively. If all plate and sample QC criteria were satisfied, the mean calculated Ab concentration (AU/mL) was reported for a sample. Additionally, the results were reported in WHO international units. Reference Standard 1 was calibrated against the WHO International Standard (NIBSC code: 20/136) by the manufacturer and a conversion factor for each antigen was provided to allow for conversion from MSD AU/mL to WHO/NIBSC binding antibody units (BAU/mL).

Additionally, a positivity cut-off for SARS-CoV-2 spike IgG in serum was established. Spike IgG levels were measured in historic sera (i.e., collected prior to the emergence of SARS-CoV-2, n=49) and post-COVID vaccination serum samples (n=183) with MSD V-PLEX Panel 2 as described above. Using a receiver operating characteristic (ROC) curve, S IgG (BAU/mL) and associated variables were analyzed. A Spike IgG cut-off value of 17 BAU/mL (resulting in 100% specificity and sensitivity to detect positive samples) was established.⁸ A similar positivity cut-off level has been reported in the literature.^{1,9,10}

Supplemental Methods 2: Live Virus Focus Reduction Neutralization (FRNT) Assay

<u>Cell Lines.</u> VeroE6-TMPRSS2 cells used in the FRNT assay were generated and cultured as previously described.¹¹

Viruses. For the FRNT assay, the EHC-083E (SARS-CoV-2/human/USA/GA-EHC-083E/2020) variant was isolated and propagated as previously described.¹² hCoV-19/USA/PHC658/2021 (herein referred to as the B.1.617.2 variant or Delta) was derived from a nasal swab collected in May 2021.¹¹

hCoV19/EHC_C19_2811C (referred to as the B.1.1.529 variant or Omicron) was derived from a midturbinate nasal swab collected in December 2021. This SARS-CoV-2 genome is available under GISAID accession number EPI_ISL_7171744. All viruses used in the FRNT assay were deep sequenced and confirmed as previously described.¹¹

FRNT assays were performed as previously described.^{6,11,13} Briefly, samples were diluted at 3-fold in 8 serial dilutions using DMEM in duplicates with an initial dilution of 1:10 in a total volume of 60 µl. Serially diluted samples were incubated with an equal volume of D614G, B.1.617.2 or B.1.1.529 (100-200 foci per well based on the target cell) at 37° C for 45 minutes in a round-bottomed 96-well culture plate. The antibody-virus mixture was then added to VeroE6-TMPRSS2 cells and incubated at 37° C for 1 hour. Postincubation, the antibody-virus mixture was removed and 100 µl of pre-warmed 0.85% methylcellulose (Sigma-Aldrich, #M0512-250G) overlay was added to each well. Plates were incubated at 37° C for either 18 hours (D614G, B.617.2) or 40 hours (B.1.1.529) and the methylcellulose overlay was removed and washed six times with PBS. Cells were fixed with 2% paraformaldehyde in PBS for 30 minutes. Following fixation, plates were washed twice with PBS and permeabilization buffer (0.1% BSA and 0.1% Saponin in PBS) was added to permeabilized cells for at least 20 minutes. Cells were incubated with an anti-SARS-CoV spike primary antibody directly conjugated to Alexaflour-647 (CR3022-AF647) for 4 hours at room temperature or overnight at 4°C. Cells were washed three times in PBS and foci were visualized on an ELISPOT reader. Antibody neutralization was quantified by counting the number of foci for each sample using the Viridot program.¹⁴ The neutralization titers were calculated as follows: 1 - (ratio of the mean number of foci in the presence of sera and foci at the highest dilution of respective sera sample). Each

specimen was tested in duplicate. The FRNT-50 titers were interpolated using a 4-parameter nonlinear regression in GraphPad Prism 9.2.0. Samples that do not neutralize at the limit of detection at 50% are plotted at 10 and was used for geometric mean and fold-change calculations.

<u>Unit of analysis</u>: Neutralization titers reported as below the lower limit of detection (LLOD) were assigned a value equivalent to half the LLOD. For FRNT, the unit of analysis was obtained as the Geometric Mean of the duplicate titers. Positive response (at the sample level) was defined as titers above the LLOQ or at least one of the duplicate titers above the LLOQ.
