

1 **Availability of Priority Maternal and Newborn Health Indicators: Cross-sectional**
2 **Analysis of Pregnancy, Childbirth and Postnatal Care Registers from 21 Countries**

7 **Abstract**

8 **Background:** Data from national health management information systems (HMIS) are essential
9 for routinely tracking progress toward national and subnational objectives, programmatic
10 decision-making, planning and review, and ultimately to improve quality of care. It is through an
11 in-depth understanding of the data elements captured in patient registers, as building blocks of
12 national HMIS indicators, that it is possible to improve standardization in data collection and
13 measurement of key indicators to help track progress towards achieving maternal and newborn
14 health goals.

15 **Methods and findings:** This analysis was done through a review of antenatal (ANC), childbirth
16 and postnatal (PNC) registers from 21 countries across five world regions. Between July and
17 October 2020, various country-based maternal and newborn experts, implementing agencies,
18 program managers, and ministries of health personnel were contacted and requested to share
19 the current versions of the registers. Both paper-based and electronic registers were obtained.
20 Twenty ANC registers, eighteen childbirth and thirteen PNC were analyzed. Both longitudinal and
21 cross-sectional ANC and PNC registers were reviewed, while the childbirth registers included in
22 the review were all cross-sectional. For the ANC registers 11/20 (55%) and for PNC registers 7/13
23 (54%) were longitudinal. In four countries the registers were electronic (Norway, Sweden, USA,
24 West-Bank - Palestine), while the rest was paper-based. There was great variation in the number

25 of data elements included from each register reviewed ranging from 24 in Nepal’s childbirth
26 register to 188 in Eswatini’s ANC register. These findings are presented in four broad categories
27 (Pregnancy, Childbirth, Postnatal care, and Mortality outcomes), with subheadings in each
28 category.

29 **Conclusion:** This analysis highlights some areas in where there are data gaps as we work to
30 reduce preventable maternal, newborn deaths and stillbirths and deliver high-quality, equitable
31 care. Programme managers and health workers need this data to monitor the performance of
32 their national health system and to guide the continuous improvement of health care services
33 for women and newborns. The results of this analysis will complement additional work and help
34 to inform the standardization of pregnancy and childbirth registers and provide information for
35 other countries seeking to introduce indicators in their health systems.

37 **Introduction**

38 The global burden of maternal deaths is estimated at 810 women dying each day from
39 preventable conditions related to pregnancy and childbirth^{1,2}. Although there was 38% reduction
40 in the maternal mortality ratio (MMR) between 2000 and 2017, the current MMR of 211 deaths
41 per 100,000 live births remains unacceptably high especially, with two-thirds of the deaths
42 occurring in low-to middle- income countries (LMICs)¹. At the same time, the number of stillbirths
43 is rising especially in Sub-Saharan Africa, increasing from 0.77 million in 2000 to 0.82 million in
44 2019. In some high-income countries – despite very low levels of neonatal mortality – more
45 stillbirths than neonatal deaths occur, and in some cases, even surpass the number of infant
46 deaths.^{2,3}. Most maternal and newborn deaths are preventable if proper preventive measures

47 are in place. In many settings poor quality of care is a greater contributor to poor health outcomes
48 than care coverage and it is estimated that about half of the maternal deaths and 58% of the
49 newborn deaths could be averted with quality health care⁴. Maternal and newborn mortality is
50 considered to be proxy indicator of limited access to quality healthcare service delivery in a
51 population. Avoidable maternal and newborn health inequalities arise because of the socio-
52 cultural and socio-eco- political circumstances in which a woman and her newborn grow, live,
53 work, and age, and the systems put in place to deal with illness⁵.

54 The data needed for routine program implementation monitoring and evaluation are gathered
55 through a variety of modalities, with health facility registers being an important source of
56 information to document events around antenatal care (ANC), childbirth, and postnatal care
57 (PNC), hence the need to periodically assess their content and utility⁶. However, there are
58 challenges related to using the current disjointed data collection and reporting systems which in
59 part included focus on meeting the needs of specific funders, poorly developed health
60 information systems (HIS), and inadequate human resources capacity⁷. Furthermore, health data
61 are often recorded and/or collated by clinicians who have to deal with high patient caseloads
62 especially those working in the public sector, which might lead to staff burnout, compromised
63 data quality and well-being of the patients⁸. Health facility data have been reported to have
64 many shortcomings which include poor quality, inaccuracies, incompleteness and not reporting
65 on time through the routine health information systems⁹⁻¹⁶.

66 National health management information systems (HMIS) are also essential for decision-making
67 aiming to improve the quality of care, and routinely tracking progress toward national and
68 subnational objectives, including patient management objectives, for which data cannot be

69 collected otherwise¹⁷. The majority of national maternal and newborn health indicators can be
70 reported through the HIS (and are used by countries to track their progress toward local and
71 national goals). One such commonly used indicator which serves as a marker of service utilization
72 is proportion of women attending at least four ANC visits during pregnancy. Data elements used
73 to compute this indicator are captured at the facility level and reported monthly by all facilities
74 using the established reporting channels in the country, often flowing from facility to subnational
75 and then to national level, with consolidation of data along at the national level^{19,20}.

76 RHIS is often weak in most low- and middle-income countries, with limitations in the representativeness
77 and quality of routine and health facility data¹⁷. In many LMICs countries, routine data are captured
78 through use of printed paper registers, and only available through electronic platforms in
79 summary form, using software such as the district health information system (DHIS2)^{21,22}. On the
80 other hand, high-income countries such as Denmark, Norway, Sweden, and United States of
81 America have robust electronic data capture systems²³⁻²⁶.

82 Analysis of antenatal care , childbirth and postnatal care registers is an important step towards
83 gaining a deeper understanding of key data elements related to maternal and newborn health in
84 the national HMIS across the world with a view towards promoting standardization in data
85 collection, analysis, and use²⁷. This paper reports on analysis of key data elements in registers of
86 countries whose data sources were collected and reviewed, describes differences in the way data
87 elements are captured, and highlights opportunities for inclusion of some critical data elements
88 that are not currently collected in registers.

90 **Methodology**

91 The approach used in this review of registers was informed by previous similar work that focused
92 on maternal, newborn and child survival^{13,27}. Selection of the countries to be included in the
93 review was guided by the findings of literature review conducted prior to embarking on the
94 analysis of the registers as well as the availability of the records. Countries included in this review
95 had some literature published related to antenatal care, childbirth, or postnatal care registers. A
96 few countries especially those from regions where published literature was not available, were
97 added to the list to present a more global perspective, taking into account the geographical
98 distribution. In the end, twenty-one countries drawn from five regions (Africa, Europe, South-
99 East Asia, Eastern Mediterranean, and the Americas), were included in the review (Table 1).

100 ***Gathering the Registers***

101 Between July and October 2020, various country-based maternal and newborn experts,
102 implementing agencies, program managers, and ministries of health personnel were contacted
103 and requested to share the current versions of the ANC, childbirth, and PNC registers available
104 to them. These materials were shared in various formats such Microsoft Excel and Word,
105 portable document format (PDF), images, and links to websites. Both paper-based and
106 electronic registers were obtained from 21 countries through different methods, primarily
107 electronically. For the paper-based registers, the years of their production ranged from
108 between 2015 to 2020. For some of the electronic registries, no specific dates could be assigned
109 to when they were produced. However, majority had some time-periods documented in
110 various ways; for example, the medical birth register of Sweden reviewed spans the period
111 1967 to 2018^{23,24,28}.

112

113 For materials that were not in English, these were translated into English prior to review and
114 data abstraction. Since the registers are revised periodically, the most recent versions of the
115 documents available for each country were analyzed. The ANC and PNC registers reviewed
116 were in both cross-sectional and longitudinal (i.e. All visits for an individual recorded on the
117 same page in the register) formats. 11/20 (55%) of ANC registers and 7/13 (54%) of PNC
118 registers analyzed were longitudinal. All childbirth registers reviewed were cross-sectional
119 (table 1). Registers even from the same country were not linked to each other; they were siloed
120 by the type of care.

126 ***Capturing the Data Elements***

127 A Microsoft Excel worksheet was used to store key data elements manually extracted from
128 each register for each country. These data included; name of the data source, year of
129 production, format (cross-sectional or longitudinal), and the data elements contained. For each
130 country file, separate worksheets were generated for ANC, childbirth (or labour and delivery),
131 and PNC data elements. Thereafter, all data elements contained in the register were marked
132 under the appropriate worksheets, organized in logical sections such as demographics, medical
133 history, laboratory investigations, client outcomes and/or services offered. Abstraction of the
134 information was done in a standardized manner by one person (MK) over a period of three
135 months. Data quality checks were conducted through a second review of select registers from
136 the 21 countries.

137 ***Analysis and Synthesis of Content***

138 Following completion of the data abstraction into the individual country worksheet, a summary
139 file with three worksheets (ANC, childbirth, PNC) was generated. This process was done in a
140 stepwise manner as follows:

141
142 **Step 1** – Five categories were generated for summarizing the data, and corresponding
143 worksheets in the Microsoft Excel file generated: Pregnancy, Lab tests and investigations, Birth
144 outcomes and treatment, and PNC.

145 **Step 2** - Country names were listed alphabetically, forming the rows.

146 **Step 3** - The column headings were generated by identifying the common data elements
147 present in a majority of the registers. Some key data elements that are either denominators or

148 numerators of key maternal and newborn health indicators were also included, whether they
149 were present in many registers or not..

150 **Step 4** – Summary data were captured from each country file by marking a “check” in the
151 appropriate cell if the data element or term listed on the column heading was present in the
152 country file.

153 **Step 5** – The content of the data elements captured was further categorized into logical
154 categories, guided by standard definitions of key maternal and newborn indicators.

155 **Step 6** – As the process of capturing the summary data progressed, some data elements were
156 added and steps 3-5 were reviewed, with corresponding adjustments being made to the data
157 summary categories identified.

158 **Step 7** – Sub-analysis of registers from four countries (Ghana, Kenya, Nigeria, and Zambia)
159 across two time periods (2017/8 and 2019/20) was done to identify changes in format and
160 content or data elements included. These countries were selected because data on their
161 registers were available from prior similar review conducted in 2018¹¹; this enabled
162 comparison of data between two points in time. We looked for the presence or absence of
163 twenty-seven data elements that are critical to monitoring maternal and newborn services
164 across the continuum of care, from pregnancy to PNC.

167 **Results**

168 The findings on the analysis of the similarities and differences on how key data elements are
169 captured in different registers from 21 countries are presented. There was great variation in the

170 number of data elements included from each document reviewed ranging from 24 in Nepal’s
171 delivery register to 188 in Eswatini’s ANC register. These findings are presented in three broad
172 categories (Pregnancy, Childbirth, Postnatal care, and Mortality outcomes), with subheadings in
173 each category.

174 ***Pregnancy***

175 Of the 20 countries whose ANC registers were reviewed, age, name of the woman, ANC number
176 assigned at the facility or a personal identifier, and residential address were the most
177 commonly recorded data elements (Figure 1). In a few countries, information on the husband
178 or baby’s father including name (Afghanistan) and citizenship (Sweden) is recorded. Some
179 other vital information recorded, usually during the first ANC visit, include woman’s relevant
180 medical history such as hypertension and diabetes in 13/20 (65%) of the countries, and
181 complications from past pregnancies in 7/20 (35%) of the countries. Recording of behavioural
182 or practices such as smoking, use of alcohol or drugs is documented in in five countries, all
183 located either in Europe or the Americas.

189 ***Utilization of antenatal care services***

190 Countries that used longitudinal ANC registers routinely document between five and eight or
191 more visits, whereas those using electronic formats (Norway, Sweden, USA, and West Bank –
192 Palestine), have capacity to record many more visits, one visit per row. For the countries using
193 cross-sectional registers, they record the first visit as “New visit” and subsequent visits in a

194 separate column as “Revisit”. In some cases, the actual visit number was entered, for example
195 3rd visit, while in some cases, there was a column to capture 4+ visits in 8/20 countries.

196 *Routine examination during ANC visits*

197 During each ANC visit, a variety of measurements are taken and recorded, allowing for
198 comparison of a current visit to previous visits in order to identify or monitor possible early
199 danger signs. In over half of the countries examined, routine data elements recorded during a
200 given visit included: gestational age, blood pressure, weight, height, and haemoglobin level or
201 pallor/ anaemia. The less commonly recorded parameters included: fetal heart tones/sounds,
202 presentation of the baby, and the mother’s nutrition status (Table 2).

205 ***Malaria in pregnancy***

206 In countries where malaria is endemic, documentation of the doses of intermittent preventive
 207 treatment in pregnancy (IPTP) for management of malaria in pregnancy was included in 7/20
 208 (35%) of the registers reviewed. Four of the seven countries document at least four doses while
 209 the other three record three doses. Provision of bed nets was included in 9/20 (45%) of the ANC
 210 registers reviewed (Table 3). Two countries had columns to document malaria treatment
 211 provided.

213 *Prevention of mother to child transmission (PMTCT) of HIV and STIs*

214 Pregnancy is a period when specific measures can be taken to prevent a baby born to a HIV-
 215 infected woman from being infected. In addition, screening and treating mothers with sexually
 216 transmitted diseases like syphilis can protect the baby from such infections both in-utero or
 217 after birth. The HIV status of the mother was documented in 10/20 (50%) of countries where
 218 ANC registers were reviewed. ANC registers from nine countries (45%) document whether the
 219 mother is on antiretroviral therapy (ART). Three countries (Eswatini, Kenya, and Uganda)
 220 document the WHO stage of disease. The same three countries also have space to document
 221 whether the pregnant woman is on cotrimoxazole to prevent opportunistic infections.
 222 Regarding syphilis, 7/20 (35%) of the countries record treatment of syphilis (Table 4).

223

224 *Nutrition and micronutrients supplementation*

225 Nutrition interventions are key to ensuring the good health of the mother and normal growth
 226 of the unborn baby. Provision of health promotion and prevention messages to the mother
 227 through nutrition counseling is documented in 9/20 (45%) of the countries. Regarding

228 micronutrients, six countries document provision of iron and folate supplementation separately
229 (Guyana, Indonesia, Kenya, Norway, Tanzania, Uganda, and Zambia), while eight countries have
230 them combined in one column. Provision of Vitamin A and calcium are recorded in one country
231 each, Norway and Zimbabwe, respectively. Related to nutrition, deworming is recorded in only
232 six countries (Figure 2).

237 *Family planning counselling and screening*

238 Family planning counseling provided during pregnancy was documented in five countries. At
239 the same time, discussion around the birth plan is recorded in five countries (Afghanistan,
240 Argentina, Sweden, USA, and Zimbabwe). Screening for gender-based violence (GBV) is
241 documented in Afghanistan, while breast cancer screening through physical examination is
242 recorded in Zambia.

243 *Routine Laboratory tests and other investigations done during ANC*

244 Majority of the countries capture data on laboratory tests and investigations conducted
245 routinely most of them during each ANC visit. The most commonly recorded tests in the
246 countries reviewed are: hemoglobin level; Syphilis testing; Urinalysis for sugar or proteins; HIV
247 test ; and blood grouping as shown in table 4. Six countries document Tuberculosis screening.
248 Hepatitis B testing is recorded in four countries. Pap smear is one of the investigations done
249 that are documented only three countries. Ultrasound and status of the baby is recorded in six
250 countries.

251 ***Childbirth***

252 The care received by the mother from the moment of admission to discharge after delivery is
253 recorded mostly in a maternity register. However, some other information such as the personal
254 identifying information of the mother medical history is recorded in supplemental documents
255 such as ANC card or other records retained by the client. The estimated date of delivery and
256 last known menstrual period dates are not consistently documented in the maternity register.

257 ***Monitoring of mother and the fetus during labor***

258 Eighteen country childbirth registers or source documents were reviewed. The information
259 captured in the registers distinguished between vaginal deliveries, assisted deliveries, and
260 cesarean section deliveries in the register. Information in the register on whether a partograph
261 was used is recorded in four countries, as shown in table 5.

262 The data elements in the partograph were not part of this review. Use of a uterotonics
263 (Oxytocin, Ergometrine or Misoprostol) immediately after delivery is documented in 11/18
264 (61%) countries, while use of magnesium sulphate in the management of pre-eclampsia/
265 Eclampsia is recorded in three countries. Complications of Childbirth are documented in 14/18
266 (78%) countries. The complications documented include vaginal tears, blood loss or need for
267 transfusion, retained placenta, obstructed, or prolonged labor, ruptured uterus, and sepsis
268 (Figure 3).

279 * Guyana register did not capture data on any of the six key data elements related to childbirth, but had space to
 280 capture data on name of the service provider and other treatments. Burkina Faso and Zimbabwe did not have
 281 childbirth registers to be analyzed.

284 *PMTCT during childbirth*

285 The labor and delivery period is another window of opportunity to implement PMTCT, similar to
 286 the pregnancy period. However, documentation of HIV status of the mother is not commonly
 287 included in many maternity or childbirth registers. In this review, five countries (Afghanistan,
 288 Eswatini, Guyana, Kenya, and Malawi) capture data on either HIV testing at delivery or the HIV
 289 status at admission. Partner HIV status is even less documented, only in Kenya and Malawi.
 290 Similarly, very few countries document HIV testing for the baby, CD4 count and viral load

291 monitoring of the mother in the childbirth registers (only Kenya and Uganda). Guyana and
292 Kenya are the only countries that record syphilis testing in childbirth.

293 *Best practices in newborn care*

294 The newborn's first hour of life requires key lifesaving interventions to implemented immediately
295 postpartum to ensure the survival of the baby. For newborns experiencing difficulty in breathing at
296 birth, resuscitation is documented in eight countries while breastfeeding within the first hour is
297 recorded in six countries out of the 18 childbirth registers reviewed. The practice of skin-to-skin is
298 documented in Kenya, and immediate cord care through application of either chlorohexidine or
299 chloramphenicol is recorded in Ghana, Kenya, and Nigeria.

300

301 In 15 out of the 18 countries, live births are clearly recorded, distinguishing them from fetal and
302 newborn death. The sex and weight of the baby are recorded in 10 and 12 countries, respectively. The
303 Apgar score is recorded in 10 countries, with most of them categorizing by the time the assessment was
304 done; one, five, or 10 minutes after birth. Recording of birth deformities is done in five countries as
305 shown in table 6.

307 * The seven countries whose childbirth registers were analyzed that are not shown in table 6 because the registers
 308 do not capture data on any of the eight data elements related to newborn care during the first hour of birth, are:
 309 Afghanistan, Bolivia, Eswatini, Guyana, Indonesia, Nepal, and Norway.

310

311 *Services provided to mother prior to discharge*

312 Health promotion intervention provided to the mother prior to discharge include counseling on
 313 infant and young child feeding in Afghanistan, Nigeria, Norway, and Tanzania. Regarding family
 314 planning counseling, only three countries capture these data (Bolivia, Nigeria, and Tanzania).
 315 Distinction is made in Zambia between exclusive breastfeeding (EBF), replacement feeding (RF),
 316 and mixed feeding (MF). In Tanzania, the type of postpartum family planning method selected
 317 by the woman is documented. In some registers, the level of detail includes whether the
 318 method is provided pre-discharge.

319 **Mortality and Newborn Outcomes**

320 Childbirth or labour and delivery registers are the sources of data on maternal and newborn
321 outcomes. Results from the analysis of maternal and neonatal death as presented for the same
322 18 countries.

323 *Maternal death*

324 In 14 out of 18 countries (78%), data on the status of mother at discharge (alive or died) are
325 captured in separate columns, except for Nigeria, Sweden, and Uganda, where “maternal
326 death” column is not included as a separate column. Data of mothers who dies are captured
327 through an open text field. About In about half of the countries, there is open-ended space to
328 record the cause of death, the last column in the register. In some other countries like in
329 Tanzania, maternal deaths are recorded under “discharge” summary, the status of the mother
330 being designated as either alive or dead.

331

332 *Fetal and newborn death*

333 Where the death of the baby occurs before birth, this is recorded as fetal death. Nigeria and
334 Norway have codes to record abortion. Regarding stillbirths, 11/18 (61%) of the countries
335 distinguish between fresh and macerated stillbirths. Bolivia and Malawi do not make such
336 distinctions, although stillbirths are reported (Table 7). The timing of newborn death is
337 recorded in different ways across the registers. Half the countries document early death
338 occurring less than 7 days after delivery. In Norway which uses an electronic register, there are
339 separate codes for recording early neonatal death (less than7 days) versus death occurring

340 after 7 days, but before 28 days. South Sudan and Zambia have spaces to record newborn
341 deaths whose timing is unspecified (Table 7).

344 **Postnatal Care**

345 *Utilization and timing of postnatal care visits post-discharge*

346 Some countries record the date of the visit and the date of birth therefore making it possible to
 347 calculate the visit timing. In countries using cross-sectional registers, service providers count
 348 the number of visits from a mother-held record, the number of the visits a woman has
 349 attended, then enter the visit number in the postnatal care register. The timing of the PNC visit

350 was categorized as day of birth or immediate care after birth, within 48 hours or day 2, day3-6,
351 days 7-14, and at six weeks (Table 16). The schedule of reporting varied widely across countries,
352 with countries like Zambia using incredibly detailed schedule as follows: 1st hour, 6th hour, 12th
353 hour, 18th hour, 24th hour, 48th hour, 6th day, and 6th week. In some countries, the timing of the
354 visit was unspecified.

355

356 *Routine checks during postnatal period*

357 Routine clinical checks, counseling, laboratory tests are done on the mother while the child
358 receives immunization and routine checks. Blood pressure is recorded in PNC registers of five of
359 the countries reviewed, while complications related to childbirth are recorded in seven
360 countries. Some of the complications documented are postpartum haemorrhage, lochia
361 (excessive or foul smelling), and presence of a fistula. Examination of the site of cesarean
362 section is recorded in Zambia and Kenya). The mother's hemoglobin level is recorded as such or
363 anaemia/ pallor. Some of the less commonly documented practices include examination of the
364 vagina, breast, and the uterus.

365

366 *Screening and counseling services*

367 The most common type of counseling services during postnatal visits is on family planning and
368 nutrition counseling for both the mother and the baby. Nutrition counseling includes
369 information on EBF, RF, and MF. Micronutrient supplementation provided mainly iron and
370 foliate is recorded in 9/13 (70%) of the countries whose PNC registers were analyzed.

371 Postpartum family planning is recorded in 8/13 (62%) of the countries. Screening for TB,
 372 cervical cancer, and STIs is recorded in 3, 2, and 1, countries, respectively.

373 *PMTCT during the postnatal period*

374 The postnatal period provides another opportunity for PMTCT so that infants born to HIV-
 375 infected mother remain uninfected. HIV testing is recorded in the PNC registers of six of the
 376 countries analyzed while information on whether the mother is on ART is recorded in five
 377 countries. Couple testing and the HIV status of the mother’s partner is recorded in Kenya and
 378 Zambia only (Table 8).

382 *Postnatal care for the newborn*

383 In addition to documenting the immunizations provided to the newborn so that she or he is on
 384 schedule as per the national immunization schedule, routine checks primary focus on newborn
 385 danger signs or complications such as jaundice and failure to gain weight as expected. PNC
 386 registers of five of the countries included in the analysis record newborn danger signs.

387 Regarding preventing HIV infection, ART prophylaxis for the newborn is recorded in four
388 countries (Afghanistan, Eswatini, Tanzania, and Zambia), and it is only in Eswatini where
389 provision of early infant male circumcision is recorded.

390 *Sub-analysis of registers from Ghana, Kenya, Nigeria, and Zambia*

391 Results of analysis of registers from four countries (Ghana, Kenya, Nigeria, and Zambia) where
392 the 2017/2018 and 2019/2020 versions of the registers were available showed that there is an
393 apparent change towards inclusion of data elements that are critical in the computation of key
394 maternal and newborn care indicators. Overall, 21/27(78%) key data elements for tracking
395 maternal and newborn care are present in the latest versions of the registers reviewed (Table
396 9). The ones that are present in to varying degrees are: ANC visits <12 weeks, fetal heart rate,
397 patograph use, newborn resuscitation, breast/ Cervical cancer screening and contraception
398 counseling.

401 **Discussion**

402 This analysis reviews the registers for ANC, childbirth, and PNC for 21 countries in six regions
403 conducted through abstracting data elements from ANC, childbirth, and PNC registers with a
404 focus on evidence-based interventions as well as outcomes for the woman and newborn.
405 Overall, there is great variation in the number of data elements ranging from 24 in Nepal's
406 childbirth register to 188 in Eswatini's ANC register, as well as the types of elements that were
407 captured. Countries forms also varied in terms of longitudinal versus cross-sectional data
408 collection depending on the country context. This review has demonstrated lack of
409 harmonization and consistency in the types of information that are collected, how they are
410 collected and organized or recorded. Given that these registers the main source of maternal and
411 newborn data, information gathered plays a key role in programme planning and tracking
412 progress towards achieving national and global goals and targets.

413 Majority of the ANC registers reviewed for 20 countries capture routine information for prenatal
414 care, such as gestation age, weight, height, blood pressure, and haemoglobin level. However,
415 there were either gaps in capturing key data as per the 2016 WHO recommendations²⁹ or lack of
416 consistency in the data capture, for example on number of contacts or clinic visits, dietary
417 interventions, and fetal assessment. Overall, few countries recorded eight or more ANC visits or
418 having first ANC visit before 12 weeks gestation. Most of those recording eight or more ANC visits
419 are the ones who have electronic registries, suggesting that use of electronic medical records
420 provides an opportunity for a better tracking of ANC services. It's noteworthy that the majority
421 of registers (65%) included relevant medical history for the pregnant woman, although only one
422 third included complications from previous pregnancies. Most countries captured recommended

423 screening practices such as blood pressure measurement, hemoglobin levels and syphilis and HIV
424 screening and treatment. However, only one third of registers captured whether an ultrasound
425 was performed. In addition, the registers capture screening but not if any action was taken to
426 address risk factors. For childbirth, the majority of countries capture data on obstetric
427 complications, but few do preventative or management interventions for postpartum
428 hemorrhage or pre-eclampsia. Although there is evidence of documentation of key data on
429 childbirth, it is possible that some other supplemental documents such as the partograph, which
430 is a recommended by WHO for capturing data during active labour to inform care²⁹.

431 Regarding childbirth and PNC period, few countries tracked whether the partograph was used or
432 fetal heart monitoring. Furthermore, data on breastfeeding within one hour of birth, newborn
433 resuscitation and BCG immunization were also not routinely captured in most countries. The
434 PNC registers had the fewest data elements available and the least standardization in terms of
435 what was captured for the woman or newborn. In general, there was more information captured
436 for the woman than for the newborn, especially around nutrition and family planning, with
437 information for newborns focused on immunization and routine checks.

438 In a sub-analysis of four African countries, there was some improvement over time in terms of
439 the types of data elements collected. These countries track the same data elements in ANC
440 registries because of epidemiological reasons (e.g. HIV testing, STIs screening or Malaria
441 treatment), however a great variation of information has been found in childbirth and PNC
442 registers from these countries. Several of the newer data elements included newborn care
443 indicators as recommended by the Every Newborn Action Plan.

444 There were limitations to the study. First, although every effort was made to obtain the most
445 recent registers, these documents were not always available for all selected countries. In
446 addition, many of the data elements reviewed were relevant to only a sub-set of countries (e.g.
447 malaria prevention and HIV prevention and management). It was often difficult to interpret how
448 the registers were supposed to be completed and it was not always possible to obtain
449 instructions for completing the them, if at all they existed. Finally, we were only able to conduct
450 a sub-analysis of four countries to assess change over time, due to limitations in obtaining the
451 relevant registers from more countries. It would be helpful to expand this analysis to additional
452 countries and to include the data summary forms.

453 Although there are global recommendations for maternal and newborn indicators to be collected
454 within routine data systems²⁹⁻³¹, this analysis highlights the great variation among and between
455 countries. There is a need for additional guidance, standardization, and reduction of data
456 elements to capture the most important evidence-based practices for improving the quality of
457 care as well as tracking progress toward national and global targets. This analysis did not capture
458 the burden on health care workers to collect these data elements in addition to providing quality
459 care, but it is an essential consideration when selecting and updating registers and forms for
460 routine data systems.

461 Improving the quality and consistency of data reported through a national HIS, requires a
462 thorough understanding of facility registers with respect to how data recorded in facilities can be
463 most easily translated into aggregate indicators. Taking these factors into consideration when
464 designing a register allows for more accurate reporting and for inclusion of indicators that

465 provide information on quality of care, such as number of service contacts and timing of
466 interventions received.

467 **Conclusion**

468 The ANC, childbirth and PNC registers are a major source of essential maternal and newborn
469 data, but standardization in recording of data elements varies across countries. Managers and
470 frontline health workers use these data to monitor the performance of their national health
471 system and to guide the continuous improvement of health care services for women and
472 newborns. The results of this analysis will complement additional work and help to inform the
473 standardization of global indicators and provide information for other countries seeking to
474 introduce indicators in their health systems.

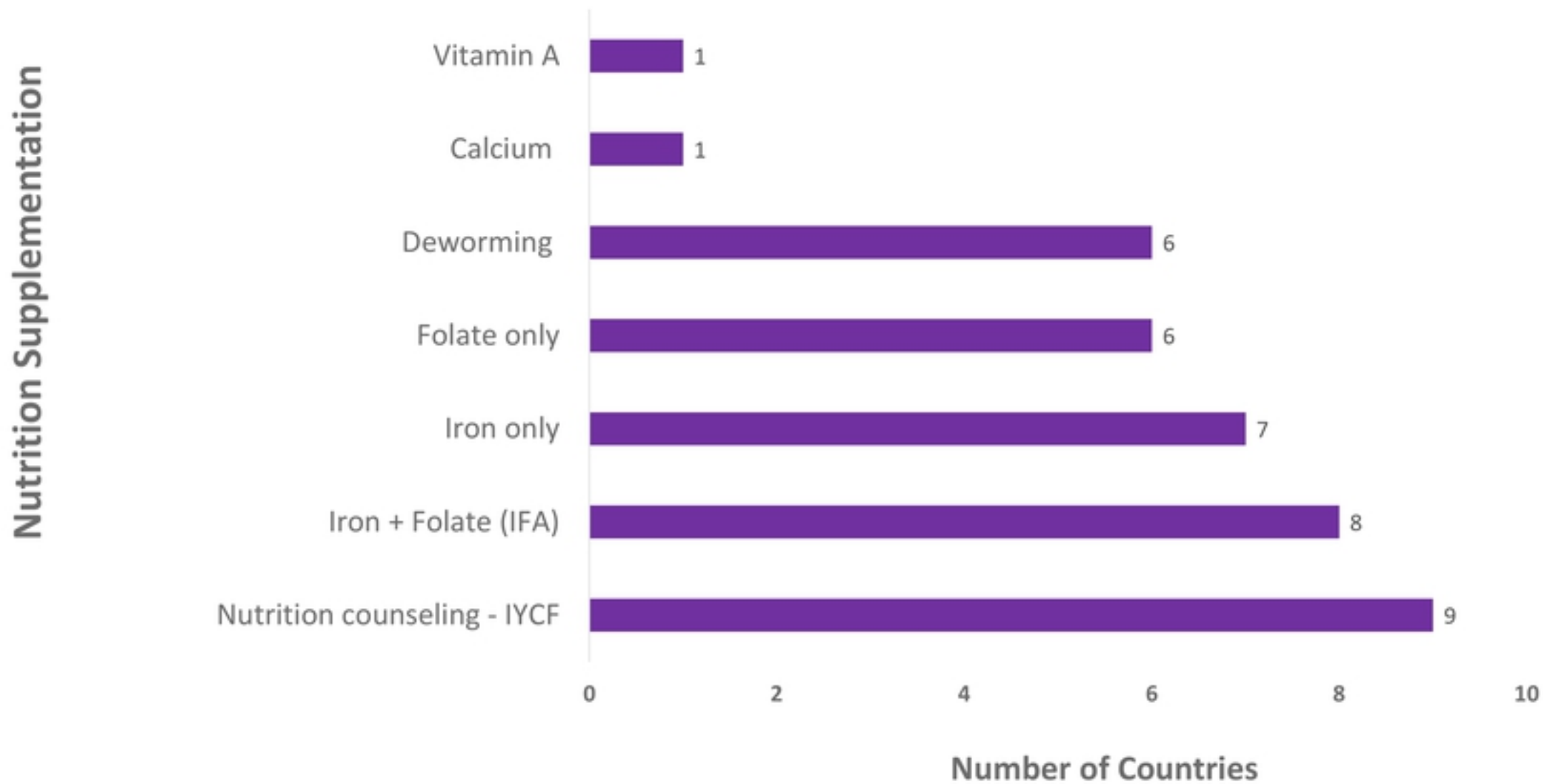


Figure 2_Nutrition supplementation and counseling

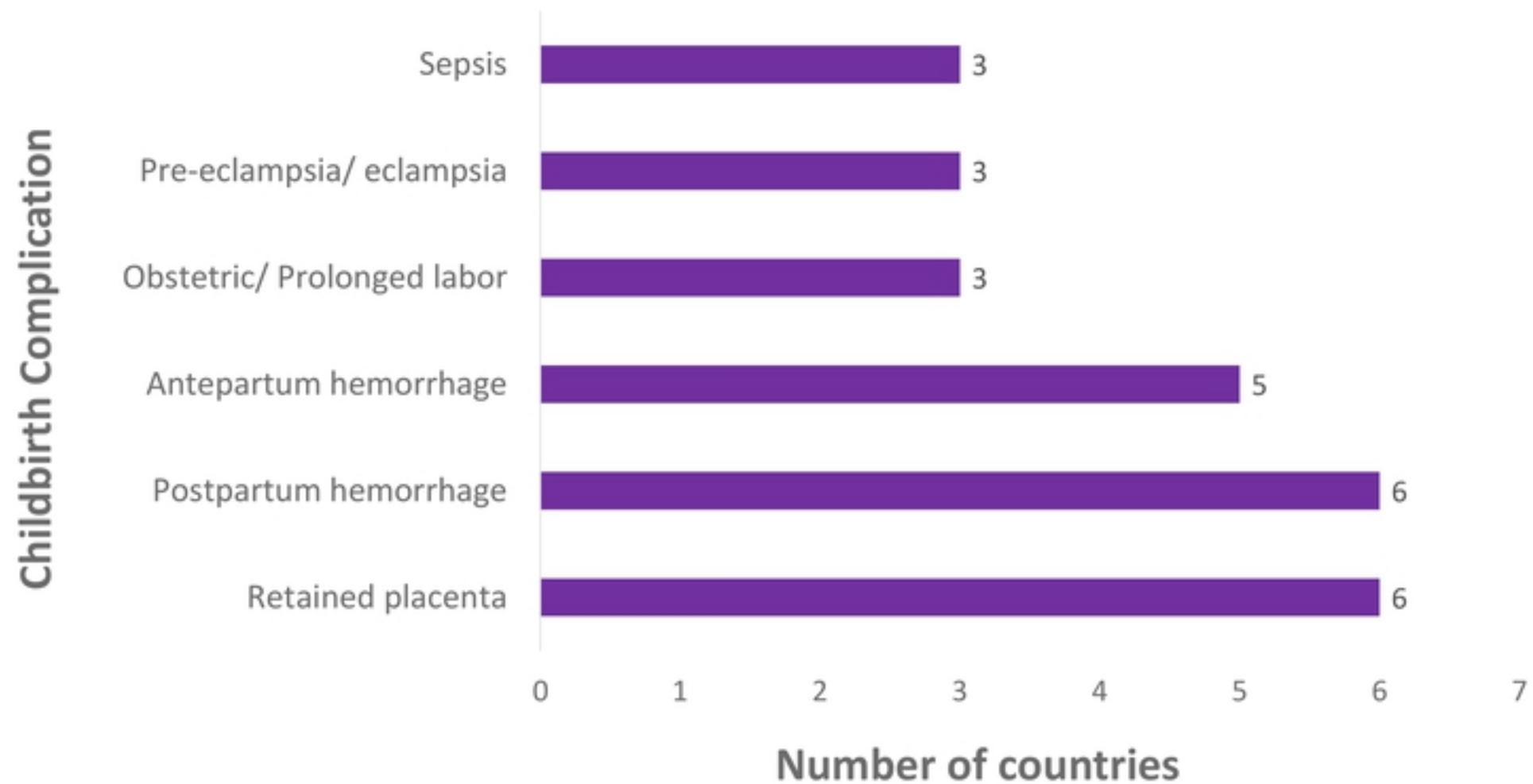


Figure 3_Maternal complications of childbirth

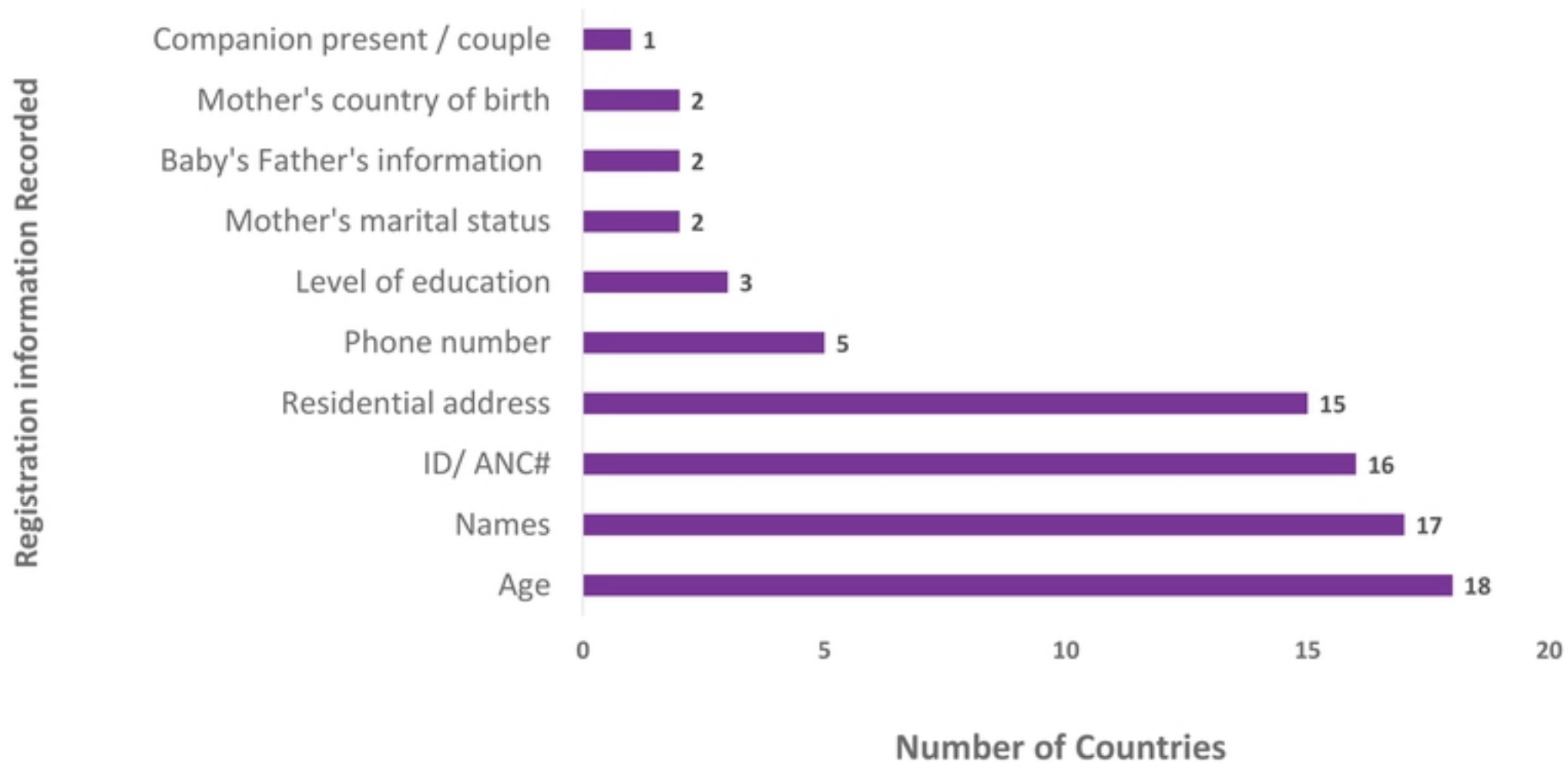


Figure 1-Client registration information
