# 2 Abstract

| 3  | Atypical disease presentations are common in older adults with COVID-19. The objective of this   |
|----|--|
| 4  | study was to determine the prevalence of atypical and typical symptoms in older adults with      |
| 5  | COVID-19 through progressive pandemic waves and the association of these symptoms with in-       |
| 6  | hospital mortality. This retrospective cohort study included consecutive adults aged over 65     |
| 7  | years with confirmed COVID-19 infection who were admitted to seven hospitals in Toronto,         |
| 8  | Canada from March 1, 2020 to June 30, 2021. The median age for the 1786 patients was 78.0        |
| 9  | years and 847 (47.5%) were female. Atypical symptoms (as defined by geriatric syndromes)         |
| 10 | occurred in 1187 patients (66.5%), but rarely occurred in the absence of other symptoms (n=106,  |
| 11 | 6.2%). The most common atypical symptoms were anorexia (n=598, 33.5%), weakness (n=519,          |
| 12 | 23.9%), and delirium (n=449, 25.1%). Dyspnea (adjusted odds ratio [aOR] 2.05, 95% confidence     |
| 13 | interval [CI] 1.62–2.62), tachycardia (aOR 1.87, 95% CI 1.14–3.04), and delirium (aOR 1.52,      |
| 14 | 95% CI 1.18–1.96) were independently associated with in-hospital mortality. In a cohort of older |
| 15 | adults hospitalized with COVID-19 infection, atypical presentations frequently overlapped with   |
| 16 | typical symptoms. Further research should be directed at understanding the cause and clinical    |
| 17 | significance of atypical presentations in older adults.  |

## 20 Introduction

| 21 | COVID-19 infection is associated with increased morbidity and mortality in older adults            |
|----|--|
| 22 | (Guan et al., 2020). Studies early in the pandemic revealed that older adults frequently did not   |
| 23 | have typical symptoms, such as cough, fever, or shortness of breath (Singhal et al., 2021).        |
| 24 | Atypical symptoms in older adults include geriatric syndromes, such as delirium, anorexia, or      |
| 25 | falls (Singhal et al., 2021). These presentations are non-specific to COVID-19 (Hofman et al.,     |
| 26 | 2017) and can occur with other diagnoses; as such, clinicians needed to increase their level of    |
| 27 | suspicion of COVID-19 infection in older adults. Atypical presentations in COVID-19 have been      |
| 28 | variably associated with mortality (Gan et al., 2020). However, the definition of atypical         |
| 29 | presentation differs by study and it is often mixed with non-geriatric syndromes, such as          |
| 30 | abdominal pain or headache (Gan et al., 2020). A geriatric-focused approach to the classification  |
| 31 | of COVID-19 symptoms would help better illustrate the spectrum of presentations.                   |
| 32 | As recurrent waves of the pandemic occurred across the world, new variants of COVID-               |
| 33 | 19 emerged. Later variants, particularly the beta (B.1.351), gamma (P.1), and delta (B.1617.2)     |
| 34 | variants, were more virulent (Fisman and Tuite, 2021) and presented with different symptoms        |
| 35 | (ZOE COVID Study, 2021). In Ontario, Canada, wave 1 was predominantly caused by wild-type          |
| 36 | SARS-CoV-2 virus, while wave 2 was predominantly alpha variant (B.1.1.7) and wave 3 had            |
| 37 | increasing beta and gamma variants (Health Ontario, 2021). It is unknown whether clinical          |
| 38 | presentation changed in older adults across these three waves.                                     |
| 39 | Furthermore, despite systematic reviews of early studies of COVID-19 symptoms                      |
| 40 | (Singhal et al., 2021), there is a lack of data looking at the way individuals with different      |
| 41 | comorbidities, place of residence, and frailty present. In particular, older age has been cited as |

42 the primary factor associated with atypical presentations of COVID-19, but it is unclear whether

43 comorbidities and frailty also play a role.

44 Using a multicentre study of consecutively admitted older adults with COVID-19, the

45 objectives of this study were to determine (i) the prevalence of each symptom and symptom

46 category in older adults with COVID-19, (ii) the association of each symptom with in-hospital

47 mortality, (iii) the change in symptoms with progressive waves of the pandemic and (iv) whether

48 clinical presentation differs by age, frailty, place of residence and comorbidity.

#### 49 Methods

50 This retrospective cohort study was done across seven hospitals in Toronto, Canada from

51 March 1, 2020 to June 30, 2021. Two sites had long-term care and rehabilitation beds

52 (Providence Healthcare and Baycrest Health Sciences). The remaining hospitals were acute care

53 institutions (St. Michael's Hospital, Mount Sinai Hospital, Sunnybrook Hospital, Toronto

54 General Hospital, and Toronto Western Hospital). Each of these facilities cared for patients with

55 COVID-19 infections. Research ethics approval was obtained through Clinical Trials Ontario

56 (3186-OPIA-Apr/2020-38044). The protocol for this study was published on Open Science

57 Framework (https://osf.io/k4g7a/).

#### 58 Inclusion criteria

59 1. Patients with COVID-19 infection confirmed by viral polymerase chain reaction (PCR)

60 swab available from hospital medical records. Patients received COVID-19 tests either by

61 screening protocols or by clinical suspicion of disease.

62 2. Age  $\geq$ 65 years at the time of COVID-19 detection.

63 3. Admitted to one of the acute care hospitals, rehabilitation facilities, or LTC homes listed64 above.

#### 65 Exclusion criteria

Re-admission to hospital after index admission for COVID-19. Only charts from the
 initial admission were included.

#### 68 **Data collection**

69 Decision support services at each hospital network identified COVID-19 cases in patients

age 65 years or older on a monthly basis. A trained chart assessor conducted the chart review of

each identified case and completed the case report forms hosted on a secure REDCap server at

the Applied Health Research Centre in St. Michael's Hospital.

73 Since reports in the literature used various definitions of typical and atypical symptoms

74 (Davis *et al.*, 2020; Pritchard *et al.*, 2020), we created 3 categories of symptoms: (i) classic, (ii)

75 typical, and (iii) atypical. Classic symptoms (sometimes referred to as "typical symptoms" in the

76 literature) included fever, cough and shortness of breath. Our definition of typical symptoms

77 included other symptoms (sometimes labelled as "atypical symptoms" in the literature) defined

78 by the World Health Organization case definition of COVID-19 infection (e.g. rhinorrhea,

diarrhea, nausea, and chills) (World Health Organization, 2020). We reserved the category of

80 atypical symptoms for geriatric syndromes reported in the literature (Emmett, 1998; Hofman et

81 al., 2017), such as delirium, anorexia, and weakness. Symptoms were extracted from each

82 patient's chart, along with clinical frailty scale (CFS) (Rockwood et al., 2005), place of residence

83 and significant past medical history. We used CFS classification from the original study

84 (Rockwood *et al.*, 2005).

The waves of the pandemic were defined by dates provided by Toronto Public Health or on the date of the nadir of case counts between waves if a public health definition was not available. Wave 1 occurred from March 11, 2020 to July 31, 2020, using dates defined by

88 Toronto Public Health (City of Toronto, 2021). Wave 2 spanned August 1, 2020 to February 20,

- 89 2021, which was defined by the nadir of case counts. Wave 3 occurred from February 21, 2021
- 90 until June 30, 2021, which was our predefined study end date.
- 91 The primary outcome was in-hospital mortality. Each chart was assessed for delirium on
- 92 presentation from emergency room and admission notes using a validated chart review method
- 93 (CHART-DEL) (Saczynski et al., 2014). Each chart assessor completed a training module for
- 94 determination of CFS and extraction of CFS was regularly reviewed with a physician

95 investigator. A training exercise was done on five charts where one of the physician investigators

96 (BL, JW, EW, KP, TI, and AV) extracted chart data in duplicate with the chart assessor. After,

97 the chart assessor regularly reviewed abstraction questions with the investigators. Five of the

98 physician investigators were geriatricians (BL, JW, EW, KP, and TI) and one was a family

99 physician (AV).

#### 100 Data processing

101 The dataset was reviewed for any missing variables. Missing key variables (e.g. CFS, 102 delirium, death) were flagged and those charts were reviewed by a physician investigator. Error 103 checking was done to identify variables outside of acceptable ranges. Summary variables were 104 created for any atypical presentation, any typical presentation, any classic symptoms and any 105 functional impairment. Missing CFS data was imputed as 6 (moderate frailty) for residents from 106 LTC and 5 (mild frailty) for those from retirement homes or assisted living facilities based on 107 local LTC admission criteria and published frailty estimates (Muscedere *et al.*, 2016). Missing 108 frailty or functional status data from community dwelling patients were not imputed because of 109 the diverse range of frailty levels in this cohort (Kelly et al., 2017).

#### 110 Analysis

111 Patient baseline characteristics were analysed descriptively with proportions, means 112 (standard deviations), and medians (interquartile range), where appropriate. Comparisons of 113 categorical variables were done by chi-squared test and of continuous variables by ANOVA test. 114 Non-normally distributed variables such as length of stay were compared using the Kruskal-115 Wallis test. The prevalence of each symptom was calculated by a proportion of exhibiting 116 patients compared with the whole group. 117 Multivariable logistic regression models were used to identify independent association of 118 symptoms for in-hospital mortality in older adults. Covariates of interest include age, sex, CFS, 119 and total comorbidity count (based on documented past medical history). In the multivariable 120 models, missing data were handled by listwise deletion. Statistical significance was defined at p 121  $\leq$  0.05. The analysis was done using R version 4.0.3. 122 Bubble plots were used to demonstrate the prevalence of typical and atypical symptoms 123 in individuals grouped by age, frailty, place of residence and comorbidity. For this analysis, we 124 combined classic and typical symptoms into a single "typical symptoms" category so that we 125 could plot the findings on two axes. The sample size of each plotted group was reflected in the

126 circle size. Bubble plots were generated by Microsoft Excel.

#### 127 Reporting standard

- 128 The Strengthening the Reporting of Observational Studies in Epidemiology (STROBE)
- 129 Statement was used to write this manuscript (Von Elm *et al.*, 2007).

#### 130 **Results**

#### 131 **Baseline characteristics**

132 A total of 1786 patients (Table 1) were included; their median age was 78.0 years

133 (interquartile range [IQR] 71.0–85.0) and 847 (47.5%) were female. Overall, most patients were

admitted from the community (n=1247, 70.0%) or LTC (n=258, 14.5%). The mean preadmission

135 CFS score was 4.73 (standard deviation [SD] 1.65). The median number of comorbidities per

136 patient was 2.0 (IQR 1.0–4.0).

#### 137 Clinical presentation

138 At least one of the classic symptoms (Table 1) of fever (n=832, 46.6%), cough (n=929,

139 52.0%) or dyspnea (n=857, 48.0%) occurred in 1412 patients (79.1%). One or more typical

140 symptoms occurred in 1263 patients (70.7%). The most common typical symptoms were

141 malaise/fatigue (n=665, 37.2%), diarrhea (n=291, 16.3%) and chills (n=201, 11.3%). Atypical

symptoms as defined by geriatric syndromes occurred in 1187 (66.5%) patients. The most

143 common geriatric syndromes were anorexia (n=598, 33.5%), weakness (n=519, 23.9%), and

144 delirium (n=449, 25.1%). Falls (n=265, 14.8%), functional decline (n=142, 8.0%) and urinary

145 incontinence (n=141, 7.9%) were less common presentations of COVID-19. Functional decline

- 146 as atypical presentation indicates a decline in functional status due to COVID-19 infection and
- 147 not a baseline reduction in functional status. Atypical symptoms often occurred in the presence
- 148 of classic (n=993, 83.7%) or typical symptoms (n=886, 74.6%). Approximately half of the

- 149 cohort (n=738, 43.3%) presented with all 3 classes of symptoms (Figure 1). Atypical symptoms
- 150 in isolation were uncommon (n=106, 6.2%).

#### 151 **Clinical presentation by pandemic wave**

152 Hospitalized patients were younger (median age 75 years in wave 3 vs. 78.5 in wave 1,

p<0.001) and less frail (mean CFS 4.09 in wave 3 vs. 5.21 in wave 1, p<0.001) in the later

- 154 pandemic waves (Table 2). The prevalence of individual symptoms varied through the waves.
- 155 For classic and typical symptoms, the prevalence of cough, abdominal pain, rhinorrhea, and
- 156 tachycardia decreased through the waves, while the prevalence of dyspnea, chest pain, and
- 157 dizziness increased. For atypical symptoms, the prevalence of anorexia, delirium, functional
- 158 decline and incontinence decreased through the waves, but the prevalence of weakness increased.

#### 159 Clinical presentation and mortality

160 In-hospital death occurred in 418 patients (23.4%). Based on univariate analysis, patients

161 who died (Table 1) were older (median age 82.0 years vs. 76.0, p <0.001), more likely to reside

162 in LTC (21.2% vs. 12.5%, p=<0.001), and more frail (CFS mean 5.28 vs. 4.56, p<0.001). In

univariate analysis, the presence of any classic (odds ratio [OR] 1.42, 95% confidence interval

164 [CI] 1.07–1.90) or atypical symptoms (OR 1.28, 95% CI 1.01–1.63) was associated with in-

165 hospital mortality. After adjusting for age, sex, CFS, and comorbidities (Table 3), only the

- 166 presence of any classic symptoms was independently associated with in-hospital mortality
- 167 (adjusted OR [aOR] 1.71, 95% CI 1.07–1.24).
- 168 For individual symptoms, the presence of dyspnea (aOR 2.05, 95% CI 1.62–2.62),
- 169 tachycardia (aOR 1.87, 95% CI 1.14–3.04), and delirium (aOR 1.52, 95% CI 1.18–1.96) were
- 170 independently associated with in-hospital mortality after adjusting for the same variables. The

171 presence of nausea (aOR 0.50, 95% CI 0.29–0.82) and chills (aOR 0.64, 95% CI 0.40–0.97) was

172 independently associated with lower mortality.

#### 173 Association of typical and atypical symptoms by age, frailty, place of residence and

174 comorbidities

175 We combined classic and typical symptoms into a single category for this analysis, in 176 order to plot it against atypical symptoms on a two-axis bubble plot. When grouped by age 177 (Figure 2), those who were younger than 80 years had slightly more typical symptoms (45.6% vs. 178 42.8% in those aged  $\geq$ 80 years), but the prevalence of atypical symptoms were similar. Frailty 179 had a larger impact on atypical symptoms (Figure 2). Frail individuals (CFS >4) had more 180 atypical symptoms compared to those who were not frail (61.1% vs. 38.9%). Looking at the 181 place of residence in older adults prior to hospitalization (Figure 3), those from the community 182 had fewer atypical symptoms (64.6% in community vs. 78.2% in LTC) compared to those from 183 LTC. When analysed by individual comorbidity (Figure 4), those with a history of dementia and 184 falls exhibited relatively more atypical symptoms (79.6% for both dementia and falls vs. 65.9% 185 for other comorbidities) compared with other comorbidities. Those with a history of chronic 186 obstructive pulmonary disease (COPD) had relatively more typical symptoms (91.2%) than 187 atypical symptoms (56.6%). The comorbidities of hypertension, diabetes, cancer, chronic kidney 188 disease and coronary artery disease clustered closely on the bubble plot, indicating a similar 189 profile of typical and atypical symptoms.

#### 190 **Discussion**

In this cohort study of consecutive older adults admitted to hospital and LTC with
COVID-19, we found that atypical presentations were common, but most patients presented with

| 193 | an overlap of atypical, typical and classic symptoms. Given the inconsistency in defining             |
|-----|---|
| 194 | atypical symptoms in the literature (Davis et al., 2020; Pritchard et al., 2020), we used three       |
| 195 | groups of symptoms to better describe the relationship between symptom types. The overlap in          |
| 196 | symptoms indicated that the presentation of COVID-19 in older adults was diverse. As such, a          |
| 197 | low threshold for testing is essential to detecting cases.  |
| 198 | Fever (64–70%), dyspnea (71–73%) and cough (67–96%) were common symptoms in                           |
| 199 | older adults (aged $\geq 65$ ) admitted to hospital with community acquired pneumonia or influenza in |
| 200 | pre-COVID studies (Riquelme et al., 1997; Walsh, Cox and Falsey, 2002). Comparatively, the            |
| 201 | prevalence of these symptoms in our cohort was lower (46.6–52.0%), suggesting that older              |
| 202 | adults with COVID-19 did not present as classically as respiratory infections of the past. A meta-    |
| 203 | analysis of COVID-19 studies in older adults from December 2019 to May 2020 revealed a                |
| 204 | weighted prevalence of 83% for fever, 60% for cough, and 42% for dyspnea. Increased virulence         |
| 205 | of the beta (B.1.351) and gamma (P.1) strains (Health Ontario, 2021), which predominated in the       |
| 206 | later waves in 2021, may have contributed to the higher proportion of dyspnea in our cohort           |
| 207 | (48.0%). Another explanation for higher dyspnea prevalence was the selection of sicker patients       |
| 208 | to be transferred from LTC to hospital given resource limitations at the time (CBC News, 2021)        |
| 209 | and from the community given increased recognition of symptoms requiring hospital treatment.          |
| 210 | We defined atypical presentation as geriatric syndromes aligned with the clinical                     |
| 211 | literature. Geriatric syndromes are phenotypes that arise from the interaction of frailty, multiple   |
| 212 | shared risk factors (e.g. cognitive impairment, gait instability, polypharmacy etc.) and the acute    |
| 213 | disease process (Inouye et al., 2007). They may not have a single direct pathophysiologic link to     |
| 214 | COVID-19, but rather the combination of infectious process on a susceptible older adult.              |
| 215 | Anorexia (44%) and delirium (44%) were the most common atypical symptoms in older adults              |

| 216 | hospitalized for community-acquired pneumonia in a study from Barcelona, Spain (Riquelme et      |
|-----|--|
| 217 | al., 1997). In a cohort from Korea (Jung et al., 2017), weakness (27.3%) and delirium (25.4%)    |
| 218 | were most common in older adults hospitalized with pneumonia. These findings mirror the most     |
| 219 | common atypical symptoms in our cohort. Studies of atypical presentations in older adults with   |
| 220 | COVID-19 mostly report on delirium (Pranata et al., no date) and falls (Gawronska and            |
| 221 | Lorkowski, 2021), with fewer studies looking at anorexia, weakness and other geriatric           |
| 222 | syndromes. One problem is the lack of consensus definition on which geriatric syndromes are      |
| 223 | most important to capture (Inouye et al., 2007). Despite early concerns of isolated atypical     |
| 224 | presentations in older adults (Solanki, 2020), our study found few patients who presented with a |
| 225 | geriatric syndrome alone without other symptoms (6.2%). The advocacy around atypical             |
| 226 | presentations raised awareness for case detection in this population, which helped improve       |
| 227 | protocols for LTC locally. Our findings highlighted the importance of understanding geriatric    |
| 228 | syndromes as part of disease presentations.  |
| 229 | Using multivariable models, we determined that dyspnea, tachycardia and delirium were            |

230 independently associated with in-hospital mortality. Systematic review of pooled univariate 231 analyses found similar associations with mortality for dyspnea (Shi et al., 2021), tachycardia (Shi 232 et al., 2021) and delirium (Pranata et al., no date). Dyspnea and tachycardia are likely reflective 233 of hypoxia, which is an important independent predictor for disease severity and mortality in 234 COVID-19 (Gallo Marin et al., 2021). Delirium is an independent predictor of mortality across 235 medical and surgical patients in studies prior to COVID-19 (Aung Thein et al., 2020). These 236 symptoms, including delirium, can help clinicians decide which patients to send to hospital in 237 repeated waves of the pandemic. LTC outbreaks are occurring again in Ontario as a result of the 238 omicron variant (McKenzie-Sutter, 2021) and clinicians can use these symptoms along with

239 oxygen saturation to determine which patients need medications or acute care treatment.

240 Conversely, the presence of nausea, chills, and myalgias were independently associated with

241 decreased in-hospital mortality. Previous studies have not found these associations (McKenzie-

242 Sutter, 2021), but most studies were done when the wild type version of the virus was circulating.

243 It is possible that certain variants trigger differing symptoms (Health Ontario, 2021). Nausea,

chills, and myalgias are also not related to respiratory status or hemodynamic instability, perhaps

reflecting milder disease.

246 We further analysed clinical presentation by place of residence and comorbidities. The 247 proportion of atypical symptoms were higher for those from LTC and those who had falls or 248 dementia on history. These populations were likely more frail, which predisposes them to 249 geriatric syndromes (Inouye et al., 2007). Patients from the community and those with common 250 comorbidities like hypertension, diabetes, and coronary artery disease had relatively more typical 251 symptoms as they were likely less frail. This finding suggests that in frail individuals with pre-252 existing geriatric syndromes attention should be given to atypical presentations and management 253 should include prevention of geriatric complications (e.g. delirium, falls, medication adverse 254 effects). Our analysis by frailty status and age confirmed that frailty was a relatively greater 255 contributor to atypical presentations compared with age (Figure 2). Another finding from the 256 bubble plot was that older patients with COPD often present with typical symptoms such as 257 dyspnea or cough. Patients with COPD have upregulation of the angiotensin-converting enzyme 258 2 (ACE-2) receptor in their airway epithelial cells, which is the primary target for spike protein 259 attachment during a SARS-CoV-2 infection (Higham et al., 2020). This allows for deeper and 260 more severe infections in patients with COPD, which may result in predominantly respiratory 261 symptoms, even early in the disease course (Higham et al., 2020). The varying clinical

262 presentations with different comorbidities should be explored in future studies to further aid

263 detection and mechanistic understanding of the disease.

264 This study was limited by its retrospective design, which did not allow for prospective 265 delirium assessment or collection of symptoms. Agreement was not assessed for the chart 266 abstraction process, but each chart assessor was trained and supervised by a physician 267 investigator through the study. Frailty data were based on the documented pre-admission 268 baseline functional status, and data were missing for some patients because a functional inquiry 269 was not always included in clinical notes. We imputed the CFS for patients admitted from 270 retirement home and LTC in a conservative way, which may underestimate true frailty. The CFS 271 data were also imputed at the chart abstraction stage. SARS-CoV-2 variant data was not 272 available at all sites, so we did not report it in this study, which limited our ability to analyse 273 symptoms by variant. 274 Strengths of this study included the use of a three-category classification of symptoms 275 that allowed determination of the contribution of geriatric syndromes. Compared to other studies 276 we included more geriatric-focused symptoms, such as incontinence, falls, and functional decline. 277 We also included consecutively admitted older adults to eight hospitals and had a consistent

chart review process at all sites, guided by a physician at each site. Delirium was abstracted

using a validated chart review method (Saczynski et al., 2014).

### 280 Conclusion

Atypical presentations of COVID-19 in isolation are uncommon in older adults who were hospitalized. Of all symptoms, dyspnea, tachycardia and delirium were independently associated with mortality. Symptoms also varied by risk factors of individual patients, particularly by frailty

- status. Future research should be directed at understanding how COVID-19 interacts with
- 285 different comorbid diseases and patient characteristics.

### 316 **Research in context**

- 317 Evidence before this study
- 318 Systematic reviews have demonstrated the prevalence of typical and atypical symptoms of
- 319 COVID-19 in older adults. Atypical symptoms can have various definitions in the literature,
- 320 including geriatric syndromes and other symptoms such as nausea, headache, and myalgia.
- 321 Certain symptoms were known to be associated with a higher risk of mortality.

- 332 Implications of all the available evidence
- 333 Awareness of the underlying patient characteristics can help guide clinicians in assessing for
- 334 COVID-19 risk. Future studies should be done to determine the impact of comorbidities and
- 335 frailty on disease presentations.
