### 45 **ABSTRACT**

- 46 Suicidal thoughts and behaviors have partially distinct genetic etiologies. We used PRS-CS to
- 47 create polygenic risk scores (PRS) from GWAS of non-suicidal self-injury, broad sense self-
- 48 harm ideation, non-fatal suicide attempt, death by suicide, and depression. Using mixed-effect
- 49 models, we estimated whether these PRS were associated with a range of suicidal thoughts
- 50 and behaviors in the Collaborative Study on the Genetics of Alcoholism (N = 7,526). All PRS
- 51 were significantly associated with suicidal ideation and suicide attempt (betas=0.08-0.44,
- 52 FDR<0.023). All PRS except non-suicidal self-injury PRS were associated with active suicidal
- 53 ideation and severity of suicidality (betas=0.04-0.22, FDR<0.034). Several associations
- 54 remained significant in models where all significant PRS were included as simultaneous
- 55 predictors, and when all PRS predicted suicide attempt, the PRS together explained 6.2% of the
- 56 variance in suicide attempt. Significant associations were also observed between some PRS
- 57 and persistent suicidal ideation, non-suicidal self-injury, attempt severity and desire to die. Our
- 58 findings suggest that PRS for depression does not explain the entirety of the variance in suicidal
- 59 thoughts and behaviors, with PRS specifically for suicidal thoughts and behaviors making
- 60 additional and sometimes unique contributions.

### 61 INTRODUCTION

#### 62

63 While several risk factors for suicidality are known [1–5], little research has identified which 64 factors may be particularly important to the progression from suicidal ideation to suicide attempt 65 to death by suicide [6–8]. Currently, the best predictors of suicide death are the preceding 66 stages. For example, high level of intent (measured using Beck's Suicidal Intention Scale [9]) at 67 previous attempt and having made a medically serious previous attempt were found to be 68 strong predictors of suicide death [10,11]. However, longitudinal studies following individuals 69 with a prior non-fatal suicide attempt found that a modest proportion (1.2%-6.7%) die by suicide 70 [12–14]. In contrast to death by suicide, suicide attempt is well predicted by its risk factors: 29% 71 of those reporting suicidal ideation and 56% of those reporting ideation and a plan, also endorse 72 suicide attempts [15].

74 Genome-wide association studies (GWAS) of broad sense self-harm ideation (i.e., thoughts of 75 self-harm regardless of suicidal intent) [16.17], self-harm [16.17], suicide attempt [18] and death 76 by suicide [19] have revealed significant SNP-heritability (the proportion of phenotypic variance 77 that is explained by all SNPs included in a GWAS) estimates (h<sup>2</sup><sub>SNP</sub>=0.068-0.25). Non-suicidal 78 self-injury and suicidal thoughts and behaviors are transdiagnostic, co-occurring with psychiatric 79 disorders ranging from bipolar disorder [20] to eating disorders [21], but are most frequently 80 studied in the context of depression. Polygenic risk scores (PRS; an estimate of one's genetic 81 liability to a trait of interest) for major depressive disorder, depressive symptoms and/or broad 82 depression are associated with self-reported suicidal thoughts and behaviors ranging from self-83 harm (in general) to suicidal ideation, suicide attempt and death by suicide [19,22–27]. 84 However, major depressive disorder [28] is only partially genetically correlated with suicidal 85 ideation ( $r_0=0.46$ ) [17] and suicide attempt ( $r_0=0.78$ ) [18] and depression [29] is also not 86 perfectly genetically correlated with death by suicide (r<sub>a</sub>=0.42) [30]. Some studies have found 87 significant associations between observed suicidal thoughts and behaviors and PRS of self-88 harm [16,23] and suicide attempt [18,24,31]. However, with the exception of a recent study from 89 Mullins et al. [18] which identified a significant association between suicide attempt and a PRS 90 constructed from a GWAS of suicide attempt conditioned on major depressive disorder [18], 91 little research has explored whether genetic liability to non-suicidal self-injury and suicidal 92 thoughts and behaviors that are independent from genetic liability to depression explain 93 variance in suicidal thoughts and behaviors. Thus, validating the transdiagnostic heritability of 94 various aspects of suicidal thoughts and behaviors requires that PRS constructed from GWAS 95 of non-suicidal self-injury and suicidal thoughts and behaviors be examined in other samples to 96 estimate whether this polygenic liability is an independent predictor of suicidal thoughts and 97 behaviors, beyond the genetics of depression. Such independent effects would further solidify 98 the need to consider the genetics of suicidal thoughts and behaviors as transdiagnostic markers 99 of liability to a broad range of psychopathology with suicidal thoughts and behaviors as 100 components. 101 102 Non-suicidal self-injury and suicidal thoughts and behaviors may represent a genetically 103 heterogeneous set of phenotypes. However, genetic research to date has struggled to

104 investigate this question due to the common overlap amongst these phenotypes. Twin and 105 family studies have been best able to answer these questions using distinct phenotypes; for

106 example, a recent study from Kendler *et al.* [32] found evidence to suggest that suicide attempt

and death by suicide are genetically distinct in ways beyond severity. Still, some relationships

108 between these phenotypes are less clear, with some twin studies having found that a large

109 portion of the variation in suicide attempt is explained by genetic factors shared with non-

110 suicidal self-injury [33] and that the two behaviors share a genetic correlation of 0.94 [34], while

a study from Russell *et al.* [35] was not able to identify any genetic correlation between non-

- suicidal self-injury and suicide attempt, although in a considerably smaller sample. Ability to
- explore these genetic relationships using GWAS data has been much more limited by omnibus
- 114 phenotype definitions. For example, GWAS of suicide attempt frequently include cases who
- have died by suicide [25], and GWAS of self-harm behavior often do not specify intent,
- 116 consequently combining non-suicidal self-injury and suicide attempt into one measure [16,17].
- 117 The inconsistent findings regarding genetic similarities and distinctions between suicidal
- 118 thoughts and behaviors necessitate further exploration using current, well-powered GWAS data.
- 119

120 Using GWAS of non-suicidal self-injury, broad sense self-harm ideation [36], non-fatal suicide

- 121 attempt [18], death by suicide [19] and depression [29,37], we examined whether polygenic
- 122 liability to these phenotypes was associated with 11 suicidal thoughts and behaviors in
- 123 individuals in the Collaborative Study on the Genetics of Alcoholism (COGA). As COGA was
- primarily ascertained for alcohol use disorders (AUD), individuals in the sample may have
- elevated risk for other mental health conditions including suicidal thoughts and behaviors, and its independent assessment of these suicidal thoughts and behaviors apart from depression
- 127 supports the use of COGA to address these questions. We hypothesized that: (1) PRS for
- suicidal thoughts and behaviors would explain additional, unique variance in suicidal thoughts
- and behaviors, beyond that explained by depression PRS and (2) non-suicidal self-injury would
- 130 be genetically distinct from suicidal thoughts and behaviors.

# 132 **METHODS**

133 **DATA** 

# 134 Target Dataset

- 135 COGA was designed to investigate the genetic underpinnings of AUD and has collected data 136 from extended families with an extensive AUD history as well as comparison families from the
- community [38–40]. Using the Semi-Structured Assessment for the Genetics of Alcoholism
   (SSAGA) interview [41,42], COGA collected data from all participants, on a wide variety of
- 139 mental health phenotypes, including depression and, independently, suicidal thoughts and
- behaviors. Many questions about suicidal thoughts and behaviors were nested, meaning that
- 141 they were only asked as follow-up questions to individuals endorsing a pre-requisite variable.
- 142 For example, data for active suicidal ideation was only collected for individuals who endorsed
- 143 any suicidal ideation. The nine mental health phenotypes used in the current study are:
- Non-suicidal self-injury: Individuals were asked, "(Other than when you tried to take your own life,) did you ever hurt yourself on purpose, for example, by cutting or burning yourself?"
  Suicidal ideation: Individuals were asked. "Have you ever thought about killing
  - Suicidal ideation: Individuals were asked, "Have you ever thought about killing yourself?"
- 149 Active suicidal ideation: Individuals endorsing suicidal ideation were 0 150 subsequently asked "Did you have a plan? (Did you actually consider a way to 151 take your life?)" 152 Persistent suicidal ideation: Individuals endorsing suicidal ideation were 153 subsequently asked "Did those thoughts persist for at least 7 days in a row?" 154 Suicide attempt: Individuals were asked "Have you ever tried to kill yourself?" More than one attempt: Individuals who endorsed a suicide attempt were asked 155 0 156 "How many times (did you try to kill yourself)?". Affected individuals answered 157 more than once.
- Medical treatment after attempt: Individuals who endorsed a suicide attempt
   were asked "Did you require medical treatment after you tried to kill yourself?"
   Substance use prior to attempt: Individuals who endersed a suicide attempt
- 160oSubstance use prior to attempt: Individuals who endorsed a suicide attempt161were asked "Did you try to kill yourself after you had been drinking?" and "Did

- 162 you try to kill yourself after using drugs?". Affected individuals answered yes to 163 either one or both of these questions. 164 Desire to die: Individuals who endorsed a suicide attempt were asked "Did you 0 165 really want to die?". Affected individuals answered "maybe" or "yes" to this 166 question. It may seem inconsistent that an individual would endorse having 167 attempted suicide and answer no to this question, however suicidal desire and 168 suicidal intent may actually be separate facets of suicidality [43], with only the 169 latter being required to classify self-injurious behavior as an attempt. 170 Considering this, individuals answering this question retrospectively may have 171 responded no if they experienced regret during their attempt or upon reflection 172 realized they may not have truly wanted to die despite intending to die. 173
- 174 In addition to the above SSAGA defined phenotypes, we constructed a binary variable ("attempt 175 severity") which compared individuals with a suicide attempt and at least one co-occurring
- 175 seventy) which compared individuals with a suicide attempt and at least one co-occurring 176 behavior considered to make it more severe (more than one attempt, requiring medical
- 177 treatment after an attempt, substance use prior to an attempt, desire to die) to individuals
- 178 endorsing only a single suicide attempt with no co-occurring conditions. We also created an
- 179 ordinal variable measuring "severity of suicidality". To do so, we first created a measure in which
- 180 individuals were given a score of 0 to 4, with increasing scores reflecting greater severity, i.e.,
- no suicidal thoughts and behaviors= 0, non-suicidal self-injury= 1, suicidal ideation= 2,
- 182 persistent or active suicidal ideation= 3, and suicide attempt= 4. For individuals with multiple
- assessments, an assignment was made using the highest endorsed category. A description of
- all binary phenotypes and their prevalence in the sample can be found in **Table 1**.
- 185

186 As discovery GWAS (see below) were only available in samples of European ancestry, and 187 accuracy of PRS prediction is low when genetic ancestries of discovery and target datasets 188 differ, our analyses were limited to individuals of European genetic ancestry. Genetic data and 189 analysis covariates were available for 7,646 individuals of European ancestry. The data 190 processing has been described in more detail previously [44]. Because the COGA sample was 191 genotyped using multiple arrays, QC focused on a common set of 47,000 high quality variants 192 that were genotyped in all arrays, and duplicate individuals were removed. Briefly, variants were 193 imputed separately for each array using the Haplotype Reference Consortium panel and were filtered to only include SNPs with INFO scores > 0.8, minor allele frequency > 0.01 and that 194 195 passed Hardy-Weinberg equilibrium (HWE p<10<sup>-6</sup>).

# 197 **Discovery Datasets**

198 We used summary statistics from existing GWAS of broad sense self-harm ideation, non-fatal 199 suicide attempt, death by suicide and depression and constructed our own GWAS of non-200 suicidal self-injury to calculate PRS for individuals in the COGA sample.

- 201 Broad sense self-harm ideation: GWAS summary statistics (N= 135,819) were derived 202 from European individuals in the UK Biobank who answered either "No", "Yes, once", or 203 "Yes, more than once" to "Have you contemplated harming yourself (for example by 204 cutting, biting, hitting yourself or taking an overdose)?" (Data-Field 20485, and was 205 analyzed as an ordinal variable, i.e., "No"= 0, "Yes, once"= 1 and "Yes, more than 206 once"= 2). We refer to this form of thinking as broad sense self-harm ideation as suicidal 207 intent could not be determined. The summary statistics were downloaded from the Pan-208 UKB GWAS results (https://pan.ukbb.broadinstitute.org).
- Non-fatal suicide attempt: Suicide attempt summary statistics came from a metaanalysis of GWAS of suicide attempt by the International Suicide Genetics Consortium (ISGC) using a combination of clinical interviews, self-report questionnaires, hospital records and ICD-10 codes [18]. Suicide attempt cases were categorized as individuals

- who made a non-fatal suicide attempt (an act of self-harm performed with intent to die)
  or died by suicide (~20% of cases). As there is prior evidence to suggest partly distinct
  genetic etiologies of suicide attempt and death by suicide [45], we obtained summary
  statistics from a GWAS of non-fatal suicide attempt only (i.e., excluding individuals who
  had died by suicide) from the ISGC (N= 507,744, N case= 23,767) in order to keep these
  phenotypes independent.
  Death by suicide: GWAS summary statistics (N= 18,223, N case= 3,413) were taken
  - Death by suicide: GWAS summary statistics (N= 18,223, N case= 3,413) were taken from data from the Utah Office of the Medical Examiner [19].
- 221 Non-suicidal self-injury: Previous GWAS have not specifically looked at non-suicidal self-222 injury, disentangling it from suicide attempt, so we conducted our own GWAS for non-223 suicidal self-injury in the UK Biobank sample using SAIGE [46]. A direct measure of non-224 suicidal self-injury is not provided by the UK Biobank; however, we derived this 225 phenotype using information from the UK Biobank's on-line "Thoughts and Feelings" 226 mental health questionnaire. The questionnaire asked individuals "Have you deliberately 227 harmed yourself, whether or not you meant to end your life?" (Data-Field 20480, N = 228 137,969), and those who answered "Yes" (N = 5,924) were then asked in a follow-up 229 question, "Have you harmed yourself with the intention to end your life?" (Data-Field 230 20483). Individuals who answered yes to both questions (N = 3,056), indicating self-231 harm with suicidal intent, were excluded from our analyses. After quality control (see 232 below), we were left with a remaining sample size of 133,620 individuals (N cases = 233 2,845). SAIGE performs a GWAS in two steps: first, it uses individual level genotype 234 data to fit the null logistic model, then uses imputed dosage data to perform the 235 association tests [46]. Step 1 of SAIGE used genotype array data (i.e., non-imputed) 236 which was filtered to exclude variants with > 5% missingness. Hardy-Weinberg 237 equilibrium p-values below 1e-10 and minor allele frequency < 0.05. Following QC, 238 genotype array data underwent LD pruning in PLINK (using the command --indep-239 pairwise 50 5 0.2). Step 2 of SAIGE was performed using imputed dosages downloaded 240 from the UK Biobank filtered for INFO score > 0.9, minor allele frequency > 0.01 and 241 minor allele count > 20. We limited our UK Biobank sample to individuals of European 242 genetic ancestry using the ancestry assignments published by the Pan-UKB team [36]. 243 Following the procedure from Zhou et al. (2018), we included sex, age and the first 10 244 genetic principal components (provided by the Pan-UKB team) as covariates in the 245 GWAS. We implemented the leave-one-chromosome-out option in SAIGE. The GWAS 246 produced no genome-wide significant (p < 5e-8) results; the strongest association (p =247 9.21e-7) was at lead SNP rs72778956 on chromosome 10 (Figure S1, Table S1).
- Depression: We used METAL [47] to meta-analyze two GWAS of depression (N=
   750,414, N case= 254,566): one from the Million Veteran Program sample [37] and the
   other from a previous meta-analysis of the UK Biobank and Psychiatric Genomics
   Consortium [29].

# 254 Polygenic risk scores

255 PRS in COGA individuals were calculated with PRS-CS [48], using effect sizes from the 256 previously mentioned GWAS summary statistics. For depression and non-fatal suicide attempt, 257 we allowed the software to learn the global shrinkage parameter from the data. However, when 258 calculating PRS using the non-suicidal self-injury, broad sense self-harm ideation and death by 259 suicide GWAS, for which sample sizes were more limited, we manually set the global shrinkage 260 parameter phi=1e-2 (following guidance from the PRS-CS development team and others 261 [48,49]). We used PLINK's --score command [50] to produce individual level PRS in the COGA 262 sample. PRS were scaled to a standard normal distribution. 263

### 264 Association Models

We used logistic mixed-effect regression models to formally test for associations between the non-suicidal self-injury, broad sense self-harm ideation, non-fatal suicide attempt, death by

- suicide and depression PRS and suicidal thoughts and behaviors in COGA. As an exception,
- we used a linear mixed-effect regression model to test for associations between PRS and the
- 269 ordinal severity of suicidality variable we constructed. All models included sex, age at last
- interview, genotyping array, and the first 10 genetic principal components as fixed covariates
- and family ID as a random intercept. Due to the ascertainment strategy for COGA families, we
- also tested whether significant associations between the PRS and suicidal thoughts and
- behaviors remained after additionally including AUD as a covariate. We used the MuMIn [51]
- 274 package in R to calculate pseudo-R<sup>2</sup> (percent variance explained) values.
- 275

276 For suicidal thoughts and behaviors that were associated with multiple PRS, we constructed

- follow-up "multi-PRS" models which accounted for those PRS as predictors simultaneously. For all models, we considered false discovery rate (FDR) < 0.05 as significant. FDR was calculated separately in each set of models, i.e., across the main single PRS models, then across the models covarying for AUD, then across the multi-PRS models.

## 282 Average PRS Visualization

To visualize the mean PRS values for affected and unaffected individuals, we fit a mixed effects model to get PRS residual values by regressing the following covariates on the PRS: sex, age at last interview, genotyping array, the first 10 genetic principal components, and family ID (as a random effect). For each suicidal thought or behavior, we split individuals into "affected" and "unaffected" groups and then calculated the average PRS residuals and standard errors in each of the groups for visualization purposes (shown in Fig. 1). As this figure compares affected and unaffected groups, only original binary phenotypes from COGA are included in the figure (i.e., derived phenetypes including attempt activity and activity of aviaidality are available.

- 290 derived phenotypes including attempt severity and severity of suicidality are excluded).

# 292 Genetic correlations

We calculated genome-wide genetic correlations (r<sub>g</sub>) among the five GWAS using LD score regression [52].

# 296 **RESULTS**

297 To maximize the total sample size in each model, our analytic sample included individuals who

- 298 had complete genetic data, information for all covariates and data for at least one suicidal
- thought or behavior (e.g., individuals with suicide attempt data but not non-suicidal self-injury
- data could still be included in the models with suicide attempt as an outcome). A total of 6,434
- individuals had data on non-suicidal self-injury (prevalence= 0.09; see Table 1). 7,526
- 302 individuals had data on suicidal ideation (prevalence= 0.43) and suicide attempt (prevalence=
- 303 0.11). Of those self-reporting suicidal ideation, 41% indicated active suicidal ideation and 31%
- 304 indicated persistent ideation. In the group of individuals self-reporting suicide attempt, 40% had
- 305 endorsed more than one attempt. Those who self-reported a suicide attempt were asked follow-
- 306 up questions about their attempt, or if they had endorsed multiple attempts were asked follow-
- 307 up questions in regards to their most serious attempt. Of these individuals who reported at least
- 308 one suicide attempt, 44% required medical treatment after their attempt, 45% had used a
- 309 substance prior to their attempt and 72% had indicated desire to die.
- 310
- 311 PRS were correlated with each other to varying degrees (see Table S2), with the highest
- 312 correlation between non-fatal suicide attempt and depression (r = 0.29) and the lowest
- 313 correlation between non-suicidal self-injury and death by suicide (r = 0.02). Overall, we found
- 314 that average PRS residual values were higher in individuals endorsing suicidal thoughts or

- behaviors compared to their counterparts who did not endorse suicidal thoughts or behaviors
- 316 (shown in Fig. 1), although when formally testing for associations between PRS and observed
- 317 suicidal thoughts and behaviors using logistic mixed-effect regression models, not all
- associations were significant after FDR corrections (shown in Table 2).
- 319

320 We found that all PRS were significantly associated with suicidal ideation (beta= 0.08-0.31, se= 321 0.026-0.028, FDR < 0.004, R<sup>2</sup> = 0.002-0.025) (shown in Table 2). Given that all PRS were 322 significantly associated with suicidal ideation in separate models, we constructed a multi-PRS 323 model in which all five PRS simultaneously predicted suicidal ideation. In the multi-PRS model, 324 the depression, non-fatal suicide attempt and broad sense self-harm ideation PRS remained 325 significantly associated with suicidal ideation (FDR < 1.10e-3), while the death by suicide PRS 326 and non-suicidal self-injury PRS were no longer significantly associated with suicidal ideation 327 (shown in Table S3).

328

Similarly, we observed that all PRS were significantly associated with suicide attempt (beta= 0.10-0.44, se= 0.040-0.044, FDR< 0.023,  $R^2 = 0.003$ -0.047), but the strongest association was with non-fatal suicide attempt PRS and the weakest association was with the non-suicidal selfinjury PRS. In the follow-up multi-PRS model which included all PRS as simultaneous predictors

- $(R^2 = 0.062)$ , associations only remained significant between suicide attempt and the
- depression and non-fatal suicide attempt PRS.
- 335

Active suicidal ideation was significantly associated with all PRS (beta= 0.14-0.22, se= 0.039-

- 337 0.043, FDR< 0.003, R<sup>2</sup> = 0.005-0.011) except for the non-suicidal self-injury PRS, and
- associations with all PRS remained significant, although they were slightly weaker, in the multi-
- 339 PRS model (beta= 0.11-0.16, se= 0.041-0.045, FDR < 0.024, R<sup>2</sup> = 0.023). We also observed
- 340 significant, although comparatively weak, associations between severity of suicidality and all
- 341 PRS (beta= 0.04-0.10, se= 0.015-0.016, FDR< 0.034, R<sup>2</sup> = 0.002-0.013) except for the non-
- suicidal self-injury PRS. In the multi-PRS model in which all PRS, except for the non-suicidal
- self-injury PRS, simultaneously predicted severity of suicidality ( $R^2 = 0.021$ ), only the depression and non-fatal suicide attempt PRS remained significant predictors (shown in Table S3).

Persistent suicidal ideation was significantly associated with the depression PRS (beta= 0.12, se= 0.042, FDR= 0.016,  $R^2 = 0.003$ ) and non-fatal suicide attempt PRS (beta= 0.18, se= 0.044, FDR= 2.2e-4,  $R^2 = 0.007$ ). However, in the multi-PRS model, the association between persistent suicidal ideation and the depression PRS was no longer significant, while the association with the non-fatal suicide attempt PRS remained significant (beta= 0.16, se= 0.05, FDR= 0.002). Desire to die was only significantly associated with non-fatal suicide attempt PRS (beta= 0.26,

- 352 se= 0.098, FDR= 0.019, R<sup>2</sup> = 0.009); similarly, attempt severity was only associated with the
- 353 non-fatal suicide attempt PRS (beta= 0.33, se= 0.15, FDR= 0.049,  $R^2 = 0.017$ ).
- 354

Non-suicidal self-injury was significantly associated with all PRS (beta= 0.16-0.24, se= 0.049-0.053, FDR< 0.0035, R<sup>2</sup> = 0.005-0.011) except for the death by suicide PRS. Notably, in the multi-PRS model in which non-suicidal self-injury was predicted by all PRS except for the death by suicide PRS, associations with the PRS remained significant with the exception of nonsuicidal self-injury's association with the non-suicidal self-injury PRS. More than one attempt, requiring medical treatment after an attempt and substance use prior to an attempt were not significantly associated with any of the PRS (shown in Table 2).

Additionally, we tested whether PRS remained significantly associated with suicidal thoughts and behaviors after controlling for AUD by adding it as an additional covariate in the models. We

found that all previously significant associations (shown in Table 2) remained significantly
 associated (FDR < 0.05) in the models covarying for AUD (shown in Table S4).</li>

Finally, we calculated significant, positive genetic correlations amongst all five GWAS ( $r_g = 0.54$ -0.84, all p < 6e-4; shown in Table S5). Death by suicide and suicide attempt were most strongly genetically correlated ( $r_g = 0.84$ , se = 0.08, p = 7.1e-24), while the weakest genetic correlation was observed between death by suicide and self-harm ideation ( $r_g = 0.53$ , se = 0.11, p = 9.2e-7). In general, non-suicidal self-injury had the weakest genetic correlations with the other traits ( $r_g = 0.54$ -0.69, se = 0.09-0.16, all p < 6e-4).

## 376 **DISCUSSION**

377 We explored the associations of polygenic liability for non-suicidal self-injury, broad sense self-378 harm ideation, non-fatal suicide attempt, death by suicide, and depression with a variety of 379 suicidal thoughts and behaviors observed in the COGA sample, a family-based sample that was 380 enriched for AUD diagnoses. All PRS were significantly associated with suicidal ideation and 381 suicide attempt, and active suicidal ideation and severity of suicidality were associated with all 382 PRS except for the non-suicidal self-injury PRS. In models where depression and suicidal 383 thoughts and behaviors were included as simultaneous predictors, many associations remained 384 significant, supporting our hypothesis that while genetic liability to suicidal thoughts and 385 behaviors and depression are related, they retain some independent genetic contributions to 386 suicidal thoughts and behaviors. On the other hand, non-suicidal self-injury PRS did not remain 387 significantly associated with any self-harm behaviors in COGA after accounting for the 388 depression and suicidal thoughts and behaviors PRS, suggesting that beyond its shared 389 genetics with the other PRS, non-suicidal self-injury PRS is not significantly associated with 390 suicidal thoughts and behaviors in this sample. Additionally, in models testing the association 391 between single PRS and active suicidal ideation and severity of suicidality, non-suicidal self-392 injury PRS was the only PRS that was not significantly associated, further suggesting that non-393 suicidal self-injury is somewhat genetically distinct from suicidal thoughts and behaviors. A 394 follow-up exploratory analysis in which we calculated genetic correlations between the non-395 suicidal self-injury and suicidal thoughts and behaviors GWAS provided partial support for a 396 genetic distinction, as the genetic correlations between non-suicidal self-injury and the suicidal 397 thoughts and behaviors GWAS ( $r_q = 0.54-0.69$ ) were, for the most part, weaker than those observed amongst the suicidal thoughts and behaviors themselves ( $r_g = 0.53-0.84$ ) (shown in 398 399 Table S5).

401 While genetic liability to broad sense self-harm ideation, non-fatal suicide attempt, death by 402 suicide and depression were all associated with greater likelihood of several suicidal thoughts 403 and behaviors, the finding that these associations even remain significant in some multi-PRS 404 models indicates that genetic liabilities to depression, broad sense self-harm ideation, non-fatal 405 suicide attempt and death by suicide independently contribute to variance in observed suicidal 406 thoughts and behaviors in COGA. While previous work has also shown that predisposition to 407 suicide attempt has a genetic component independent from depression [18,25], the current 408 study finds that genetic liability to other suicidal thoughts and behaviors, specifically broad 409 sense self-harm ideation and death by suicide, also make contributions that are independent 410 from depression (i.e., both PRS independently contribute to active suicidal ideation, and broad 411 sense self-harm ideation PRS independently contributes to suicidal ideation). These results add 412 to evidence from epidemiological studies that have found a family history of suicidal thoughts 413 and behaviors significantly increases risk of suicidal thoughts and behaviors independently of 414 family history for psychiatric illness (e.g., depression) [53]. Furthermore, we find that PRS for 415 suicidal thoughts and behaviors, particularly non-fatal suicide attempt PRS, may be better

416 predictors of some suicidal thoughts and behaviors than PRS for depression. For example, non-417 fatal suicide attempt PRS was significantly associated with desire to die and attempt severity 418 while depression PRS was not, non-fatal suicide attempt PRS showed a stronger association 419 with active suicidal ideation than depression PRS in univariate models, and depression PRS

- 419 with active succeal dealton than depression FRS in univariate models, and depression FRS 420 was no longer significantly associated with persistent suicidal ideation after accounting for non-
- 421 fatal suicide attempt PRS in a multi-PRS model. Thus, studies predicting suicidal thoughts and
- 422 behaviors should not rely on depression PRS alone.
- 423

424 The death by suicide PRS was predictive of suicidal ideation, active suicidal ideation, suicide 425 attempt and severity of suicidality in univariable models, although only the association with 426 active suicidal ideation remained significant in the multi-PRS models. The non-suicidal self-427 injury PRS was only predictive of non-suicidal self-injury, suicidal ideation and suicide attempt, 428 although none of these associations remained significant after accounting for the other 429 associated PRS. We consider that the relatively smaller sample sizes of the death by suicide 430 GWAS (N= 18.223, N cases = 3.413) and non-suicidal self-iniury GWAS (N= 133.620, N cases= 431 2,845) may be contributing to the differences observed in the non-suicidal self-injury and death 432 by suicide PRS, considering that sample size of the discovery GWAS is an important factor in 433 determining accuracy and predictive power of PRS [49,54]. Based on the SNP-heritability, 434 prevalence and sample sizes of these traits, we estimate our power to detect an association 435 between the non-suicidal self-injury PRS and non-suicidal self-injury in COGA to be only 5.6%, 436 and between the death by suicide PRS and suicide attempt in COGA to be between 40.51% 437 and 48.99%. Additional factors beyond the smaller sample size of the GWAS may have 438 influenced our lack of findings for the death by suicide PRS. For instance, individuals who are at 439 the highest levels of genetic risk for death by suicide may not be adequately represented in a 440 longitudinal study such as COGA. Furthermore, the death by suicide GWAS included individuals 441 who died by varied violent and nonviolent means [19], and as such may reflect a highly

- 442 heterogeneous set of genetic liabilities [60].
- 443

444 We did not observe associations between PRS and several suicidal thoughts and behaviors, 445 specifically no PRS were significantly associated with endorsing substance use prior to attempt, 446 requiring medical treatment after attempt, or reporting more than one attempt. Additionally, 447 several suicidal thoughts and behaviors (e.g., desire to die, persistent suicidal ideation) were 448 only significantly associated with one or two PRS. While it is possible that these behaviors may 449 not have as strong of a genetic component, we also consider that the nestedness of these 450 phenotypes may be contributing to these observations; these suicidal thoughts and behaviors 451 specifically represent co-occurring behaviors, such that they were only asked of individuals who 452 had endorsed suicidal ideation or suicide attempt and as such, any individual not endorsing the 453 prerequisite variable was not included in the follow-up variables (e.g., for requiring medical 454 treatment after an attempt, the unaffected group only included individuals who had made a 455 suicide attempt). As a result, the "control" groups for these variables represent an already high-456 risk group and we consider that while genetic liability contributes to suicidal thoughts and 457 behaviors broadly, related features of individual suicidal thoughts and behaviors may not be 458 influenced by the PRS studied by us. It is also plausible that some features of individual suicide 459 attempts may be situational; for example, requiring medical treatment after an attempt may 460 reflect lethality and mode of attempt, which may be environmental in nature [61-63]. 461 Furthermore, individuals with multiple suicide attempts only answered follow-up questions in 462 reference to their self-defined most serious attempt. For example, an individual may have made 463 a previous attempt after using substances, but if they had a made a different attempt they 464 believed to be more serious in which they didn't use a substance before the attempt, then they 465 answered no to substance use prior to attempt. As a result, some of the behaviors co-occurring

with suicide attempt that we studied may not accurately represent an individuals' history ofthese behaviors over their lifetime.

469 In addition to small discovery GWAS sample sizes for some traits and nestedness of some 470 variables in COGA, we acknowledge various other limitations to this study. First, COGA was 471 ascertained for families with an extensive history of AUD, and as such is not representative of 472 the broader population. Since individuals with substance use disorders are at higher risk for 473 suicidal thoughts and behaviors [64,65], our sample may be enriched for these phenotypes. 474 Second, concerns of accuracy and limited availability relating to data on family history of suicidal 475 thoughts and behaviors prevented us from constructing models in which PRS and family history 476 simultaneously predicted suicidal thoughts or behaviors, a method shown to improve risk 477 prediction for other disorders [66,67]. Third, as is the case for many PRS, these PRS may be 478 strongly associated with suicidal thoughts and behaviors at the population scale, but are not 479 useful for individual level prediction. This is not to say PRS for suicidal thoughts and behaviors 480 will never be useful for classification purposes, but currently they are not sufficiently powered. 481 nor have important ethical concerns been addressed [68] for prediction at the individual or 482 clinical level. Finally, because of the limited non-European ancestry GWAS available for suicidal 483 thoughts and behavior phenotypes, we were only able to conduct these analyses in a subset of 484 individuals in COGA with European ancestry, despite the diversity of the full COGA sample.

485

In conclusion, we find evidence that PRS computed from GWAS of non-suicidal self-injury,
 broad sense self-harm ideation, non-fatal suicide attempt, death by suicide and depression are
 significantly associated with increased risk of suicidal thoughts and behaviors in individuals in
 COGA. Results further corroborate that suicidal thoughts and behaviors are heterogeneous and
 partially genetically distinct from depression.
