Climate Change and Eco-Anxiety in the US: Predictors, Correlates, and Potential Solutions

35 ABSTRACT

36

37 Climate change has many adverse human health effects, including increased anxiety. However, eco-anxiety may also motivate climate action. An online survey was 38 developed and distributed to examine factors associated with eco-anxiety. Logistic 39 40 regression analysis showed that significant predictors of eco-anxiety include greater media exposure to climate change information, more frequent discussions about climate 41 42 change with friends and family, the perception that climate change will soon impact one personally, being younger, and being female. Additional analyses suggested that eco-43 anxiety was associated with a range of both positive and negative emotional impacts 44 including motivation, interest, sadness, and tension. Eco-anxiety was also associated 45 with greater likelihood to engage in environmental behaviors such as recycling. 46 Volunteering for environmental causes and accessing straightforward information with 47 48 less scientific jargon were found to have particular potential for anxiety reduction among 49 the eco-anxious. The research suggests practical strategies to reduce eco-anxiety while 50 retaining engagement in mitigating climate change. 51 **Keywords:** Anxiety; Mental Health; Climate Change; Eco-Anxiety; Global Warming; 52

55 BACKGROUND

The World Health Organization calls climate change the biggest health threat that 56 humanity faces today (World Health Organization, 2021). Beyond the immediate 57 casualties caused by extreme weather events, climate change has also been 58 59 associated with increased rates of allergies, asthma, heart attacks and strokes (Parker 60 et al., 2019). Furthermore, Taylor (2020) discussed how climate change can increase 61 both the likelihood of extreme weather events and pandemics, because warmer 62 temperatures can create more hospitable habitats for disease vectors and viruses. 63 People escaping extreme weather events may seek mass housing in shelters with other climate refugees, exacerbating the spread of contagious disease. Warmer temperatures 64 and shorter winters allow insects carrying disease to breed for longer and travel further, 65 facilitating insect-borne infectious disease outbreaks. For example, in Latin America 66 alone, a 4°C increase in temperature is projected to increase the number of dengue 67 68 fever cases by 8 million each year. Pollution has also been linked to various neurological and behavioral disorders, ranging from Alzheimer's disease to autism 69 spectrum disorders (Ramadan and Ataalah, 2021). 70 71 One often overlooked effect of climate change's rising threat is that it can

increase anxiety levels and worsen population mental health. Sociopolitical, economic
and physical health problems caused by climate change, including forced migration,
food shortages, job loss, increases in disease transmission, air pollution, and loss of
social support can lead to mental illness (American Psychiatric Association, 2019).
Exposure to natural disasters and severe weather events are correlated with anxiety,
depression, sleep disorders, and post-traumatic stress disorder (PTSD) (Warsini et. al,

2014). Edwards, Gray and Borja (2021) found that experiencing natural disasters was
associated with increased parental stress, food insecurity, and family violence, among
other effects. Cruz et al. (2020) found specific extreme weather impacts associated with
increased rates of psychological distress, anxiety, depression and PTSD, including
whether the victims had experienced evacuation, displacement, disruption of essential
services (e.g. electricity), and inability to attend work or school.

Ruminations about climate change's future impacts can also damage mental 84 85 health (Pihkala, 2018). "Eco-anxiety" is one term used to describe an emotional 86 response to climate change caused by fear of the impact of climate change on one's future (or the futures of loved ones), characterized by anxiety and stress. However, 87 emotions related to climate change are nuanced and complex. Ramadan et al. (2021), 88 identified ten different conceptualizations of the negative emotional response to climate 89 90 change, including climate anxiety, climate change worry, eco-anxiety, and eco-91 paralysis. Stanley et al. (2021) further explored the differing implications and impacts of 92 eco-depression, eco-anger, and eco-anxiety. Clayton and Karazsia (2020) developed a measure of climate change anxiety, including subscales for cognitive and functional 93 94 impairments, and found correlations with general anxiety and depression. Eco-anxiety 95 harms even people who have not personally experienced a climate crisis, causing 96 trauma, stress, grief, depression, and general cognitive impairment (Dailianis, 2020). 97 Hurley et al. (2022) described climate anxiety as a rational response given the enormous impacts of climate change, and Verplanken and Roy (2013) found that 98 99 people who frequently worried about climate change were no more likely than infrequent 100 ecological worriers to have pathological general levels of worry or emotional instability.

101	In contrast, Reyes et al. (2021) found that higher climate change anxiety was
102	associated with lower mental health in a sample of young adults from the Philippines.
103	Although eco-anxiety may be a reasonable and comprehensible reaction to
104	climate change, it can still be distressing and damaging (Comtesse et al., 2021).
105	Therapeutic strategies to address these issues have not been researched extensively,
106	but include resilience training and climate awareness. One important public health
107	challenge in treating eco-anxiety is helping people learn to cope with climate change
108	without becoming apathetic, managing a society's emotional responses at a complex
109	level. Behavioral strategies may play a role in managing eco-anxiety while retaining
110	some of its benefits, although these strategies have not been closely analyzed (Clayton,
111	2020). For example, some studies suggest the use of "social prescribing efforts" as
112	solutions to climate anxiety. Social prescribing in general, such as the promotion of
113	community-based activities including leisure, education and the arts, has been shown to
114	have significant positive impact on mental and physical health (Munford et al., 2020).
115	Social prescribing activities that may have a positive effect on eco-anxiety include
116	spending time in nature and community-based work to support social connections and
117	community-wide engagement, but these solutions have not yet been studied in-depth
118	(Cunsolo et. al, 2020; Howarth et al., 2020).
119	Some studies suggest that eco-anxiety has not been associated with any
120	particular behavioral responses to climate change (Clayton & Karazsia, 2020).
121	However, some researchers suggest that stress about climate change motivates people
122	and encourages climate action, hypothesizing that these effects may serve as potential

123 positive aspects of eco-anxiety. Sanson and Bellemo (2021) stated that, when it comes

124 to climate change, "action is the antidote to despair." Verplanken and Roy (2013) found 125 that habitual ecological worry was associated with positive environmental behaviors, such as recycling. Schwartz et al. (2022) determined that collective climate action may 126 127 have a protective effect against climate anxiety, but did not find this result for individual 128 environmental actions (such as personal recycling). In contrast, other studies suggest 129 that eco-anxiety can engender feelings of "eco-paralysis," or mental inhibition and levels of anxiety so extreme that they prevent one from taking action, resulting in 130 131 immobilization or apathy (Albrecht, 2011; Usher, 2019). 132 One factor that may contribute to eco-anxiety is lack of information or 133 overwhelming information about climate change and its effects. Exposure to climate 134 change through media influences stress and mental health (American Psychiatric 135 Association, 2019). Additionally, the indifference and ignorance of others to the climate 136 crisis and lack of coordinated global action to mitigate it can cause great distress among 137 those who care about the environment, leading to eco-anxiety (Rao and Powell, 2021). 138 Frequent exposure to climate change information, such as through social media, 139 newspapers, and television, has been correlated with heightened rates of eco-anxiety. 140 Fritze et al. (2008) observed that climate change information can be so worrying that 141 people react with skepticism and denial. Dodds (2021) noted that climate change doubt, 142 denial and apathy serve as defense mechanisms against climate anxiety. Interestingly, 143 research has also associated media exposure to climate change information with 144 empowerment, indicating the potential additional motivational features of eco-anxiety. 145 For example, Maran and Begotti (2021) found that climate anxiety in a sample of Italian 146 students was positively correlated with both media exposure to climate change

147 information and self-efficacy in dealing with climate change. Another study observed 148 that newspapers and media sources in the United States are often selective in the 149 content they portray, which can influence climate perceptions. Many newspapers 150 portray teen activism against climate change in a negative light to appeal to adult 151 readers, increasing eco-anxiety and sentiments that not enough work is being done or 152 that the being done is ineffectual. Additionally, fear of being misrepresented in the 153 media can repel climate activists from engaging productively with media, resulting in 154 less coverage of climate change efforts (Duffy, 2022). 155 Eco-anxiety is also influenced by factors including socioeconomic status, geographic location, and culture, causing it to disproportionately impact different groups. 156 157 Disadvantaged groups may be more likely to be exposed to environmental 158 contaminants: Verbeek (2018) found that levels of air pollution were correlated with lower household incomes and higher unemployment levels. Those with a lack of access 159 160 to resources and living in more vulnerable geographic conditions, such as in rural areas 161 or closer to coasts, are more likely to experience climate anxiety (Cianconi et. al, 2020). 162 Rural individuals, who may be more likely to labor in agriculture and thus be especially 163 dependent on the environment, are more likely to experience climate-related insomnia, 164 obsessive thinking, panic attacks, and appetite changes or eating disorders (Castellone, 165 2018). In addition to rural farmers, Indigenous Peoples, to whom the land has enhanced 166 cultural significance, are also more likely to suffer from eco-anxiety (Cunsolo & Ellis, 2018; Middleton et. al, 2020). 167 168 Marginalized individuals such as people belonging to stigmatized racial, gender, 169 and economic groups are more likely to suffer from the negative impacts of climate

170 change, including mental illness (Hayes et. al, 2018). Cruz et al.'s (2020) analysis 171 suggested that women, especially those in more vulnerable social positions, 172 experienced greater negative mental health impacts of extreme weather events and that 173 populations with unemployment or prior medical conditions are more likely to 174 experience mental health declines after severe weather. Obradovich et al. (2018) found 175 that climate change in the form of multiyear temperature increases and extreme 176 weather events was associated with declines in mental health, with these effects greater 177 for women and people with lower incomes.

178 Age also influences the mental health effects of climate change. Young people 179 with developing brains, limited emotional resilience, and less experienced adapting to 180 threats may be at greater risk for the effects of climate change and have more climate 181 stress (Vergunst & Berry, 2021). Hickman et al. (2021) conducted a global survey of young people and found that more than half of 16-25 year olds were "very" or 182 183 "extremely" worried about climate change and reported feeling sad, anxious, angry, 184 powerless, helpless and guilty regarding climate change. Nearly half of young people 185 surveyed said their feelings about climate change negatively affect their daily lives and 186 three guarters were fearful of the future. Experiencing extreme stress about the climate 187 can cause damage to brain chemistry, structure and function, creating the potential for 188 even more serious mental illness later in life, including substance abuse and depression (Wu et. al, 2020). These age-related impacts of climate change may also have 189 190 implications for the effects of climate anxiety on motivation and stress. Political 191 orientation, eco-skepticism, and eco-anxiety may also be related. Cann, Weaver and 192 Williams (2021) conducted social media sharing analysis of climate change information

193 and found that levels of climate skepticism were associated with political ideology and 194 information network polarization. As climate change continues to affect the planet, eco-195 anxiety and broad-scale research to understand the demographic and information 196 exposure factors associated with it have increasing importance. It is critical that 197 populations with high likelihood of suffering from eco-anxiety can be targeted for 198 interventions, and additional exploration is needed regarding the efficacy of eco-anxiety 199 interventions given that research in this area has been limited. Therefore, we conducted 200 research to assess factors associated with climate change anxiety and potential 201 solutions.

203 METHODS

An English-language online survey questionnaire was developed and 204 205 distributed to collect data about climate change attitudes. Institutional Review 206 Board (IRB) exemption was received from WCG IRB, an IRB specializing in 207 medical and public health research reviews. The IRB classified the survey as 208 exempt because it was an anonymous survey and no personally-identifying 209 information (PII) was collected from respondents. The survey instrument was 210 developed based on review of the literature and previously published surveys, 211 and programmed using AYTM online survey development and deployment 212 software. AYTM is a research software company that maintains a survey panel 213 of over 100 million potential respondents in 40 countries. 214 Potential US respondents were invited by text message and email to

215 participate in an online, English-language survey to collect data about climate

216	change attitudes. These potential respondents had previously agreed to
217	participate in surveys for research purposes. In January 2022, approximately
218	N=5,000 potential respondents were invited to participate in the survey and a
219	sample of N=2,000 US adults aged 18+ completed the survey, resulting in a
220	response rate of 40%. At the beginning of the survey, respondents were
221	informed of the purposes of the study and agreed to participate voluntarily.
222	Formal consent was not obtained because survey data was collected
223	anonymously. Survey respondents consisted of a broad range of ages, races,
224	ethnic backgrounds, income levels and geographic origins across the US.
225	The survey aimed to assess factors associated with eco-anxiety and
226	potential interventions to reduce its negative effects on mental health and quality
227	of life while retaining engagement and motivation regarding climate change. At
228	the beginning of the survey, respondents were asked to indicate their age and
229	their country of residence and to provide their consent to participate in a survey
230	about climate change. People who were under age 18 and/or currently lived
231	outside the US were thanked and terminated from the study.
232	In the first portion of the survey, respondents were asked to indicate their
233	knowledge, beliefs, behavior and emotions regarding climate change. The
234	complexity and measurement of the negative emotional responses to climate
235	change has been the subject of much exploration and discussion. Measures
236	used were informed by several scholarly approaches, including those of Clayton
237	and Karazsia (2020), Coffey et al., (2021), Helm et al., (2018), Hogg et al.,
238	(2021), Stanley et al. (2021) and Stewart (2021). In the next section of the

239	survey, respondents answered questions regarding their demographics. At the
240	end of the survey, respondents were thanked for their participation. Data were
241	analyzed using SPSS v.28.0 statistical analysis software. First, logistic
242	regression analysis was done to understand predictors of climate anxiety. Then,
243	χ^2 tests were conducted to examine the relationship of climate anxiety with
244	attitudes and behavior. In both the logistic regression and the $\chi 2$ tests, analysis
245	focused on self-reported responses to the question "Does climate change make
246	you feel anxious?"
247	
248	RESULTS
249	The survey sample consisted of people with a range of ages, relationship statuses,
250	education levels and racial/ethnic backgrounds (see Table 1). More females than males
251	completed the survey, but other demographic characteristics such as race and ethnicity
251 252	completed the survey, but other demographic characteristics such as race and ethnicity mirrored US population values according to the US Census. More than one quarter of
251 252 253	completed the survey, but other demographic characteristics such as race and ethnicity mirrored US population values according to the US Census. More than one quarter of survey respondents (26%) indicated they were anxious about climate change, and the

262 ECO-ANXIETY PREDICTORS

263 In the logistic regression model, climate anxiety served as the dependent 264 variable and demographics and climate change information exposure were independent variables. The model correctly classified 92% of those without eco-anxiety, substantially 265 266 higher than the 74% correct classification expected by the null model. The model also 267 correctly classified 33% of those with eco-anxiety, significantly better than the 26% correct classification expected by the null model (see Figure 1). The overall model had a 268 269 significant fit at p<.0001. The Nagelkerke R²=.296, so about one third of the variation in 270 the data was explained by the model (see Table 2). This is a moderately strong result for a social science model. 271

277 Factors including familiarity with climate change, political party, and education did 278 not serve as significant predictors of climate anxiety in the logistic regression model 279 (see Table 2). Frequency of media exposure about climate change was associated with 280 climate anxiety: in general, less frequent self-reported media exposure was associated 281 with lack of climate anxiety. Similarly, infrequency of climate discussions with friends 282 and family was associated with lack of climate anxiety. People who felt it would be a long time before climate change impacted them personally were less likely to be 283 284 anxious, as were males and older people.

286 ECO-ANXIETY CORRELATES

Associations between eco-anxiety and respondents' attitudes and behavior was 287 examined using χ^2 analysis. Those who indicated they were not anxious about climate 288 289 change were significantly more likely than those with eco-anxiety to say that climate 290 change is harmless, a hoax, not going to affect my daily life, and exaggerated (all 291 comparisons p<.05, see Figure 2). People without eco-anxiety were also significantly 292 more likely to say that climate change is caused mostly by natural changes in the 293 environment (28.2% vs. 15.8%, p<.05). Those with eco-anxiety were significantly more 294 likely than those without eco-anxiety to say climate change is something almost all 295 scientists agree about, is caused mostly by human activities, is real, and is already 296 happening (all comparisons p<.05). Interestingly, only about half (52.3%) of those 297 without climate anxiety said they believe climate change is real.

301	People without eco-anxiety were significantly more likely to say that information
302	about climate change is fake, one-sided, not trustworthy, and too political (all
303	comparisons p<.05, see Figure 3). More than a third (35.2%) of those without eco-
304	anxiety said information about climate chance is too political vs. 25.0% of those with
305	eco-anxiety (p<.05). Those with climate change anxiety were significantly more likely to
306	say that information about climate change is hard to understand, confusing and
307	overwhelming (p<.05). Nearly half (47.0%) of climate anxious respondents said climate
308	change information is overwhelming vs. just 19.9% of respondents without climate
309	anxiety (p<.05).

Respondents were also asked to indicate whether they felt other emotions about 313 314 climate change. People without eco-anxiety were more likely to say they felt skeptical 315 (16.2% vs. 8.9%, p <.05, see Figure 4). People with eco-anxiety were more likely to 316 report a range of emotions: they were more likely to report being motivated and 317 interested regarding climate change, but they were also more likely to say they felt 318 depressed, angry, sad, overwhelmed, frustrated and worried (all comparisons p<.05). 319 The survey also asked respondents to report how climate change is affecting their 320 mental health, if at all. The results showed that 84.7% of those who were not anxious 321 about climate change said their mental health was unaffected by climate change vs. 48.4% of those with climate change anxiety (p<.05). Nearly half (45.5%) of those with 322 323 climate change anxiety said climate change made their mental health somewhat worse 324 (vs. only 11.5% of those without climate change anxiety, p<.05) and 6.2% (vs. 3.8%,

325	p<.05) said climate change made their mental health a lot worse (see Figure 5). People
326	with climate change anxiety were significantly more likely to indicate that their eco-
327	anxiety negatively impacted their wellbeing and quality of life. They were more likely to
328	say that their concerns about climate change made it harder to get school/work
329	assignments done (5.2% vs. 2.8%), have fun with family and friends (7.5% vs. 2.6%),
330	and concentrate (10.2% vs. 4.2%) (all comparisons p<.05) (see Figure 6).

339	POTENTIAL SOLUTIONS
340	People with climate change anxiety were significantly more likely to
341	exhibit environmentally conscious behaviors, such as being vegetarians, driving
342	an electric/hybrid car, using public transportation, voting with relation to climate
343	issues, recycling, reducing energy usage, and having confidence that their
344	actions can have an impact on climate change (p<.05, see Figure 7). People
345	with climate anxiety were more likely to support organizations and charities
346	related to the environment or the effects of climate change through donating
347	time or money (24.7% vs. 10.2%, p<.05, see Figure 8). The eco-anxious were
348	also significantly more likely to support many other types of charitable

349	organizations, such as animal charities, human and social services and health
350	charities (p<.05). However, people without climate change anxiety were

352	p<.05). Of respondents not involved with environmental organizations, those
353	with climate anxiety were more likely to cite structural barriers like lack of time,
354	access, awareness, or experience (comparisons p<.05, see Figure 9). People
355	without eco-anxiety were more likely to say that lack of interest was the reason
356	they do not volunteer for or donate to environmental causes (17.0% vs. 6.4%,

381 **DISCUSSION**

382 Based on the logistic regression model results, climate change anxiety was associated with greater self-reported frequency of hearing about climate change in the 383 384 media and discussing climate change with friends and family. However, the direction of causality was not clear: media exposure to climate change information and talking about 385 386 it might cause climate change anxiety, or people who are already worried about climate 387 change might seek out information and want to talk about it with others. Younger age 388 and female gender were also associated with greater likelihood of climate change 389 anxiety. Furthermore, people who thought climate change would happen further into the future were less likely to have climate change anxiety. These results support prior 390 research that has shown that females have higher baseline levels of general anxiety, 391 392 which may contribute to their likelihood to develop climate change anxiety (Bahrami & 393 Yousefi, 2011). Young people, especially if they expect climate change to cause 394 damage in the shorter term future, would logically be more anxious about climate 395 change because they may anticipate that their lives overall will be more affected by it 396 than older people, since young people expect to have more remaining years of life. This 397 indicates that climate anxiety has several demographic factors that must be recognized 398 when developing tailored, targeted solution strategies.

399 Some variables in the logistic regression did not have the expected relationship 400 with eco-anxiety. Self-defined familiarity with climate change was not significantly 401 associated with climate change anxiety. It was hypothesized that the greater knowledge that people felt they had about climate change, the more anxious they would be. The 402 403 model results did not support this hypothesis. Political party affiliation and education 404 levels also did not have significant relationships with climate change anxiety. Prior research would suggest that more politically conservative and less educated survey 405 406 respondents would be less likely to have climate change anxiety, but these results were 407 not found in the analysis.

The results identified both positive and negative correlates of climate change 408 409 anxiety. People with eco-anxiety were more likely to say that climate change makes 410 them feel hopeless, tense, and troubled and made their mental health either a lot or 411 somewhat worse. Additionally, people with eco-anxiety were more likely to report that 412 their climate concerns damaged their ability to work productively, concentrate, and 413 enjoy free time with friends and family. This indicates the damaging toll that eco-anxiety 414 may take on personal wellbeing. However, the research also revealed several potentials 415 to utilize eco-anxiety and produce a positive impact. For example, those with climate 416 change anxiety were also more likely to say they take action in their daily lives to reduce 417 their contributions to climate change, being more likely to look for ways to reduce 418 energy usage, recycle, and use public transportation. Those with eco-anxiety were more 419 likely to say that climate change makes them feel motivated and interested and were 420 more likely to volunteer and/or donate to environmental organizations. Because eco-421 anxiety is so complex, with both positive and negative aspects, it is important to develop

and identify solution strategies that will exert the greatest impact on bettering mentalhealth while fighting apathy and retaining engagement in the climate cause.

To this end, the research identified several solutions to climate change anxiety. 424 425 including behavioral strategies, a potential indicated by previous studies. Those with 426 anxiety were more likely to believe that environmental volunteering would reduce their 427 anxiety. This may be because volunteering offers opportunities to directly impact the 428 local environment and help volunteers have a personal impact on the cause, which may soothe anxiety about lack of involvement or feelings of helplessness. Those who did not 429 430 volunteer cited reasons such as a lack of experience or awareness of how to get 431 involved. To combat this, environmental organizations may have an opportunity to 432 promote volunteering opportunities and organize easy-to-access climate volunteering 433 events for various communities. Those with eco-anxiety were also more likely to say 434 more information on climate change causes, effects, and current mitigation efforts would 435 reduce their anxiety, as well as climate change information that is easier to understand. 436 To prevent media from being overwhelming and exacerbating climate anxiety, clear and concise information about climate change and the science behind it should be promoted 437 438 in ways that contain limited jargon and are easy to understand for broader populations. 439 The results supported previous findings about eco-anxiety as a motivating factor

for taking action through environmentally conscious behaviors and support of climate charities, but this effect is counterbalanced by the potential for worsened quality of life through damaged mental health and prevalence of discouraging emotions. The research built on previous findings by identifying specific negative impacts of ecoanxiety, such as trouble focusing and enjoying free time. The authors found that people

who were anxious about climate change were more likely to hear about it frequently in
the media, but felt information about climate change is overwhelming and hard to find
and understand.

Limitations of the study include that the research was conducted only in English 448 449 and only among US residents. Additionally, as the survey was conducted online, 450 individuals without Internet access were unable to respond. The self-reported environmental and charitable behavior results may have been affected by events such 451 as the COVID-19 pandemic, which prevented many people from volunteering in-person 452 453 and potentially increased eco-anxiety rates. Furthermore, survey respondents had previously agreed to participate in research projects by being part of the survey panel 454 455 used to conduct the reserach. These people may not fully represent the US population 456 as a whole. Finally, the response rate, although high for an online survey, was not 457 100%. It is possible that the people who did not respond to the survey invitation are 458 somehow different than those who did complete the survey.

459 The potential eco-anxiety solutions are based on self-reports about the factors that survey respondents thought would decrease their eco-anxiety; however, laypeople 460 461 are often not the best predictors of their own future reactions (e.g., Poon, Koehler and 462 Buehler, 2014). Even if actions that respondents felt could mitigate eco-anxiety would not 463 immediately do so, they could nonetheless have societal benefits. Additionally, 464 participation in social activities like volunteering could increase social cohesion and community connections, which previous research has shown have positive effects on 465 466 psychological resilience and anxiety reduction, as well as other beneficial health 467 outcomes (Bowe et al., 2021; Generaal et al., 2019; Howarth et al., 2020; Robinette et al.,

468 2018; Robinette et al., 2021). Furthermore, the study did not cover personal experiences 469 with climate-influenced weather changes. Demski et al. (2017) found that personal 470 experience with extreme weather events like floods significantly increases people's 471 judgments of the importance of climate change as a social issue and their level of 472 personal risk. Future research should further explore the relationship of perceived 473 personal experience with climate-change-driven events, such as droughts or wildfires, 474 with eco-anxiety.

475

476 CONCLUSIONS

The results suggest that media exposure to climate change information was 477 478 associated with higher likelihood of climate anxiety, but that self-defined level of 479 knowledge about climate change was not significantly related to climate anxiety 480 likelihood. These results may be related to eco-anxious individuals' significantly higher 481 likelihood to see climate change information as confusing, overwhelming, or hard to 482 understand. Those with eco-anxiety were significantly more likely to indicate that more information about climate change's causes, effects, and current efforts would reduce 483 484 their anxiety. Developing and distributing straightforward, easy-to-understand climate 485 change information may reduce eco-anxiety associated with media exposure while 486 ensuring that these individuals remain accurately informed about the issue. More 487 research is needed to explore the relationship between media exposure, knowledge, and eco-anxiety, as well as which information adaptations may most effectively reduce 488 489 eco-anxiety and its association with media.

490 The findings support previous research about the positive and negative effects of

491 eco-anxiety, and confirmed the hypothesis that anxiety about climate change could be 492 reduced through behavioral strategies such as volunteering and information campaigns. 493 It identified that eco-anxiety is a motivating factor encouraging people to take action, as 494 well as several negative effects of eco-anxiety on the quality of life. The study expanded 495 upon past research efforts that proposed behavioral strategies to reduce eco-anxiety by 496 finding a significant association between volunteering efforts and predicted anxiety 497 reduction. This is a novel solution, as volunteering for environmental organizations can 498 reduce the negative effects of eco-anxiety while retaining motivation and interest and 499 simultaneously have a positive impact on the environment. To encourage more people 500 to volunteer, our study identified the importance of promoting information on how to get 501 involved and encouraging newcomers. Future experimental research could test the 502 impact of environmental volunteering to more clearly establish these effects.

503 The research also further explored the role of media and information on eco-504 anxiety, indicating that media about climate change can be overwhelming and 505 contribute to higher rates of anxiety. To reduce this issue, it is important to cover climate 506 change information in a way that is easy to understand by all populations. The media 507 could also be used to promote information about how to get involved with local 508 environmental volunteer groups, helping to encourage more people to get involved and 509 reduce eco-anxiety. Media and online services can also be utilized to provide better 510 climate mental health treatment access; Taylor (2020) notes that the COVID-19 511 pandemic has necessitated rapid online mental health service delivery, and that these 512 advances could be adapted to help address climate anxiety.

513 Women and younger people were found to have a greater likelihood of eco-

514	anxiety. Efforts and interventions to reduce eco-anxiety should be especially tailored
515	towards women and young people to help combat this effect. The lack of a statistically
516	significant relationship between education, political party membership, and eco-anxiety
517	was unexpected and merits further study. Future research should also delve deeper into
518	the association of eco-anxiety with age, gender, and other demographic factors.
519	Potential changes to the experimental procedure would be to ask more questions
520	surrounding age and youth perceptions of climate change, as previous studies identified
521	that younger people were more likely to be eco-anxious, or questions targeting
522	underrepresented racial, gender, and economic groups. Mixed-methods research could
523	also be used to more deeply understand respondents' experiences, attitudes and
524	associations and possible reasons for them. Qualitative exploration has not yet been
525	widely used in environmental epidemiology research, but has great promise for helping
526	better understand causal processes and develop effective interventions (Noël,
527	Vanroelen, & Gadeyne, 2021).
528	Furthermore, future studies should be conducted in multiple languages and with
529	larger sample sizes to reduce the limitations of the study and further establish the
530	robustness and reproducibility of the findings. Future research could also evaluate
531	groups of people with and without eco-anxiety and assess the direct effects of different
532	volunteering efforts or types of media exposure on anxiety reduction.
