

# 1 Adeno-associated virus type 2 in children from the United States with acute severe hepatitis

## 15 **ABSTRACT**

16 As of August 2022, cases of acute severe hepatitis of unknown etiology in children have been reported  
17 from 35 countries, including the United States. Here we used PCR testing, viral enrichment based sequencing,  
18 and agnostic metagenomic sequencing to analyze 27 samples, including nasopharyngeal swab, stool, plasma,  
19 and/or whole blood, from 16 such cases from 6 states (Alabama, California, Florida, Illinois, North Carolina,  
20 and South Dakota) presenting from October 1, 2021 to May 22, 2022, in parallel with whole blood samples  
21 from 45 controls. Among the 13 cases for whom whole blood was available, adeno-associated virus 2 (AAV2)  
22 sequences were detected in 92% (12 of 13) ( $p < 0.001$ ), while adenovirus sequences were detected in 100%, of  
23 which 11 (84.6%) were genotyped as human adenovirus type 41 (HAdV-41), one as HAdV-40, and one as  
24 HAdV-2. Co-infections of herpesviruses, Epstein-Barr virus (EBV) or human herpesvirus 6 (HHV-6), and/or  
25 enterovirus A71 (EV-A71) were also detected in all 13 cases. In contrast, AAV2 and HAdV-41 were not  
26 detected in any control, and EBV, HHV-6, or EV-A71 were each only detected in one or two of 45 controls  
27 ( $p < 0.001$ ). Analysis of assembled AAV2 viral genome sequences identified 35 coding mutations relative to the  
28 AAV2 reference genome, predominantly located in the VP1 capsid and assembly-activating protein (AAP)  
29 proteins, and AAV2 genomes from cases clustered together by phylogenetic analysis. Our findings of a distinct  
30 AAV2 strain in nearly all cases of acute severe hepatitis of unknown etiology in conjunction with one or more  
31 infecting helper viruses suggest that disease pathogenesis and/or severity may be related to co-infection with  
32 AAV2.

## 54 INTRODUCTION

55 Viral hepatitis is an inflammation of the liver most commonly caused by one of the major hepatitis  
56 viruses (A-E). Since October 2021, outbreaks of acute non A-E severe hepatitis of unknown etiology in children  
57 have been reported in 35 countries, including the United States (US)<sup>1,2</sup>. The majority of pediatric cases globally  
58 have been <6 years of age (76%), with an approximately equal gender distribution (48% male to 52% female)<sup>2</sup>.  
59 As of August 17, 2022, 358 persons under investigation (PUIs) have been reported in the United States, of  
60 whom 22 (6%) required a liver transplant and 13 (4%) died<sup>3</sup>.

61 Human adenoviruses (HAdVs) are non-enveloped, double-stranded DNA viruses that cause a variety of  
62 infections in both adults and children, including respiratory tract infection, conjunctivitis, and gastroenteritis  
63 (mainly from adenovirus species F including HAdV types 40 and 41<sup>4,5</sup>. Although previously reported as a  
64 severe and potentially fatal disease in immunocompromised patients<sup>4,6</sup>, hepatitis from adenovirus infection had  
65 been thought to be rare in immunocompetent children without underlying comorbidities<sup>7</sup>. In previous reports,  
66 adenoviruses, particularly adenovirus type 41 (HAdV-41), have been found in the blood from a majority of  
67 outbreak-associated cases of acute severe hepatitis from Scotland, the United Kingdom (UK), and the US<sup>6,8-11</sup>,  
68 although it is unclear whether this virus is causative. AAVs have also been reported in children with severe  
69 acute hepatitis in a study of 9 patients from the United Kingdom (UK)<sup>18</sup>, often in association with adenovirus or  
70 human herpesvirus 6 (HHV-6 infection)<sup>12</sup>. AAVs are small, single-stranded DNA parvoviruses that are thought  
71 to be non-pathogenic in humans and for this reason have been widely used as vectors for gene therapy<sup>13</sup>.  
72 Importantly, AAVs require a helper virus, such as a herpesvirus or adenovirus, for productive infection,  
73 although the contribution of AAVs to hepatitis remains unclear<sup>14,15</sup>.

74 In this study, we employ a variety of molecular and sequencing-based methods to investigate acute  
75 viral infections that may be causing severe hepatitis in children. These include metagenomic sequencing for  
76 agnostic detection of all viruses<sup>16</sup>, tiling multiplex PCR amplicon sequencing for AAV2 and HAdV-41<sup>17</sup>,  
77 metagenomic sequencing with probe capture viral enrichment for 3,153 viruses<sup>18</sup>, and virus-specific  
78 polymerase chain reaction (PCR). Our findings in affected US children from 6 geographically dispersed states

39 demonstrate co-infection from a distinct strain of adeno-associated virus type 2 (AAV2) in nearly all cases and  
40 none of the controls.

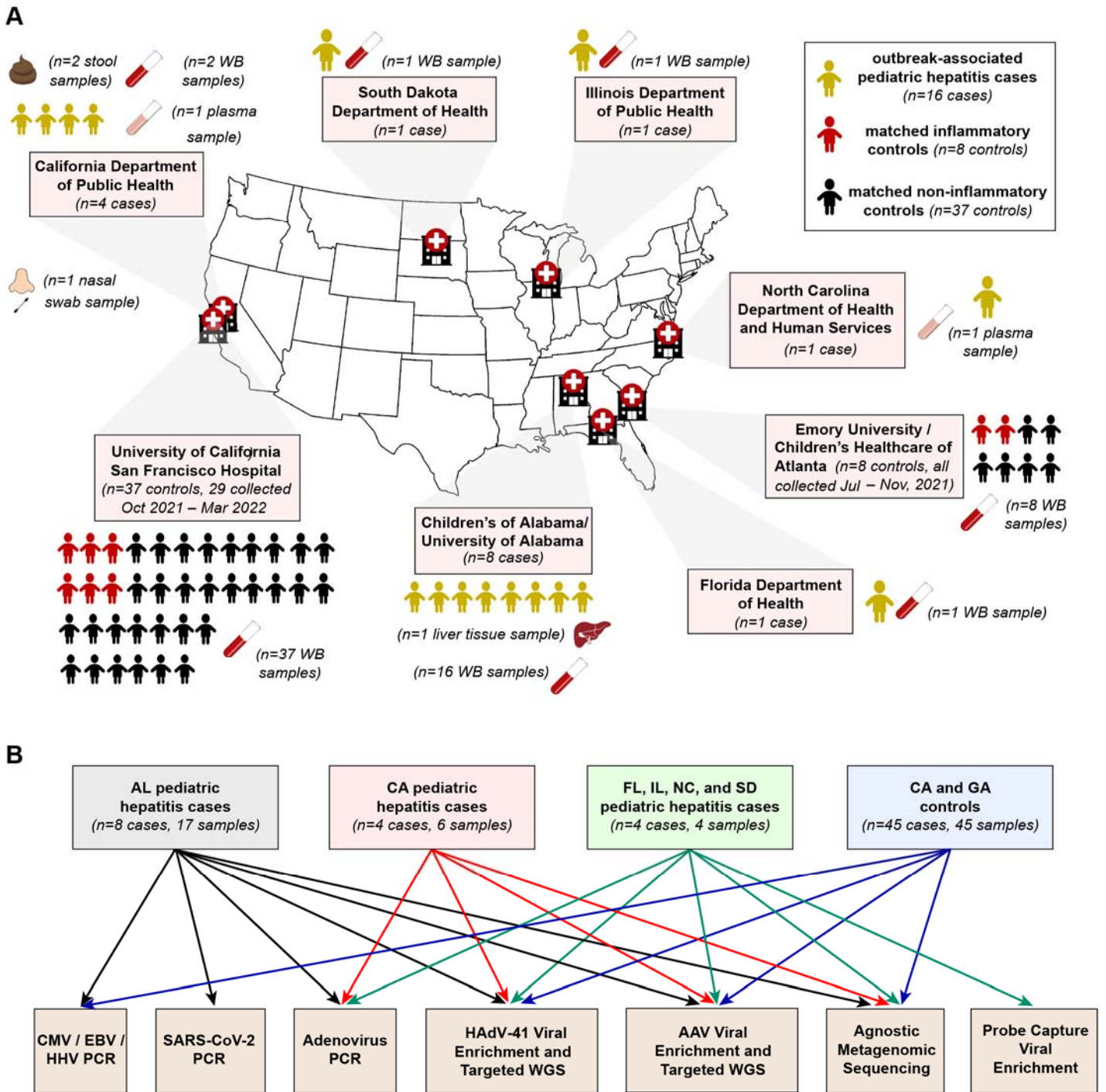
## 41 **Results**

### 42 **Patient and sample characteristics**

43 In this study, 27 samples (21 whole blood, 2 plasma, 1 liver tissue, 1 nasopharyngeal swab, and 2 stool  
44 sample(s)) from 16 pediatric patients with acute severe hepatitis of unknown etiology were analyzed (**Figure**  
45 **1A**). All patients met the clinical case definition for the disease established by the CDC, including lack of a  
46 confirmed etiology for the hepatitis (including negative testing for hepatitis viruses A-E), liver enzyme levels  
47 (aspartate aminotransferase / AST or alanine aminotransferase / ALT) >500 UL, age <10 years, and onset on  
48 or after October 1, 2021<sup>2,19</sup>. Affected children were admitted to tertiary care hospitals in 6 states (Alabama,  
49 California, Florida, Illinois, North Carolina, and South Dakota) from October 1, 2021 to May 22, 2022  
50 (**Extended Data Table 1**). Because many patients (12 of 16, 75%) were selected from those PUIs who tested  
51 positive for adenovirus and had samples submitted for adenovirus typing, PUIs with adenovirus infection may  
52 have been over-represented compared to the overall PUI population, of which adenovirus is detected in 45-  
53 90%<sup>6,8-11</sup>. The median age of affected children was 3 years. Mean elevations in AST and ALT were 2,652 +/-  
54 1,851 and 2,293 +/- 1,486, respectively; 2 children underwent liver transplantation and 0 died from  
55 complications of liver failure; the others are still hospitalized at time of data collection or recovered with  
56 supportive care.

57 Whole blood samples from 45 pediatric controls, 8 from Georgia to be geographically similar (located in  
58 a neighboring state) to the Alabama and Florida cases, and 37 from California to be geographically similar  
59 (located in the same state) to the California cases, were analyzed in parallel. Geographically similar samples  
60 for the North Carolina, Illinois, and South Dakota cases were not available. Control samples were collected  
61 between August 4, 2020 and March 28, 2022. Of the 45 control samples, 23 (62%) were also collected over  
62 the same time frame as the cases (i.e., collected between October 1, 2021 and March 28, 2022). The median  
63 age of controls was 9 +/- 5 years. Among the 45 controls, 8 (18%) were hospitalized patients with a non-

hepatitis inflammatory condition (e.g., sepsis, viral respiratory infection, osteomyelitis, etc.), 31 (69%) were hospitalized patient with a noninflammatory condition, while 6 (13%) were healthy blood donors.

### 24 **Detection of viruses in acute severe hepatitis cases**

25 Metagenomic sequencing, tiling multiplex PCR amplicon sequencing, metagenomic sequencing with  
26 probe capture viral enrichment (VE), and virus-specific PCR were performed to identify viruses in clinical  
27 samples from acute severe hepatitis cases **(Figure 1B)**. We detected AAV2 from available whole blood

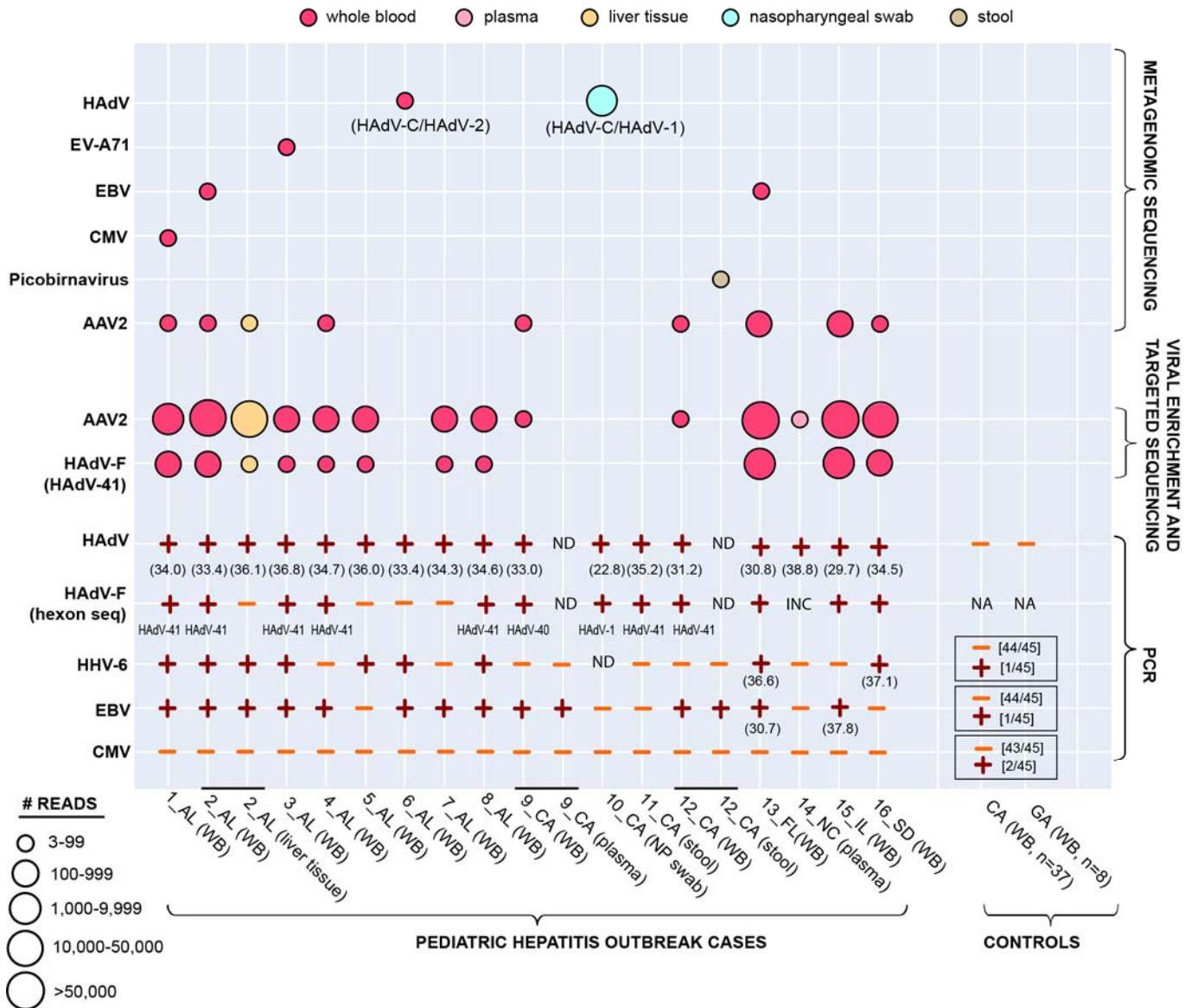


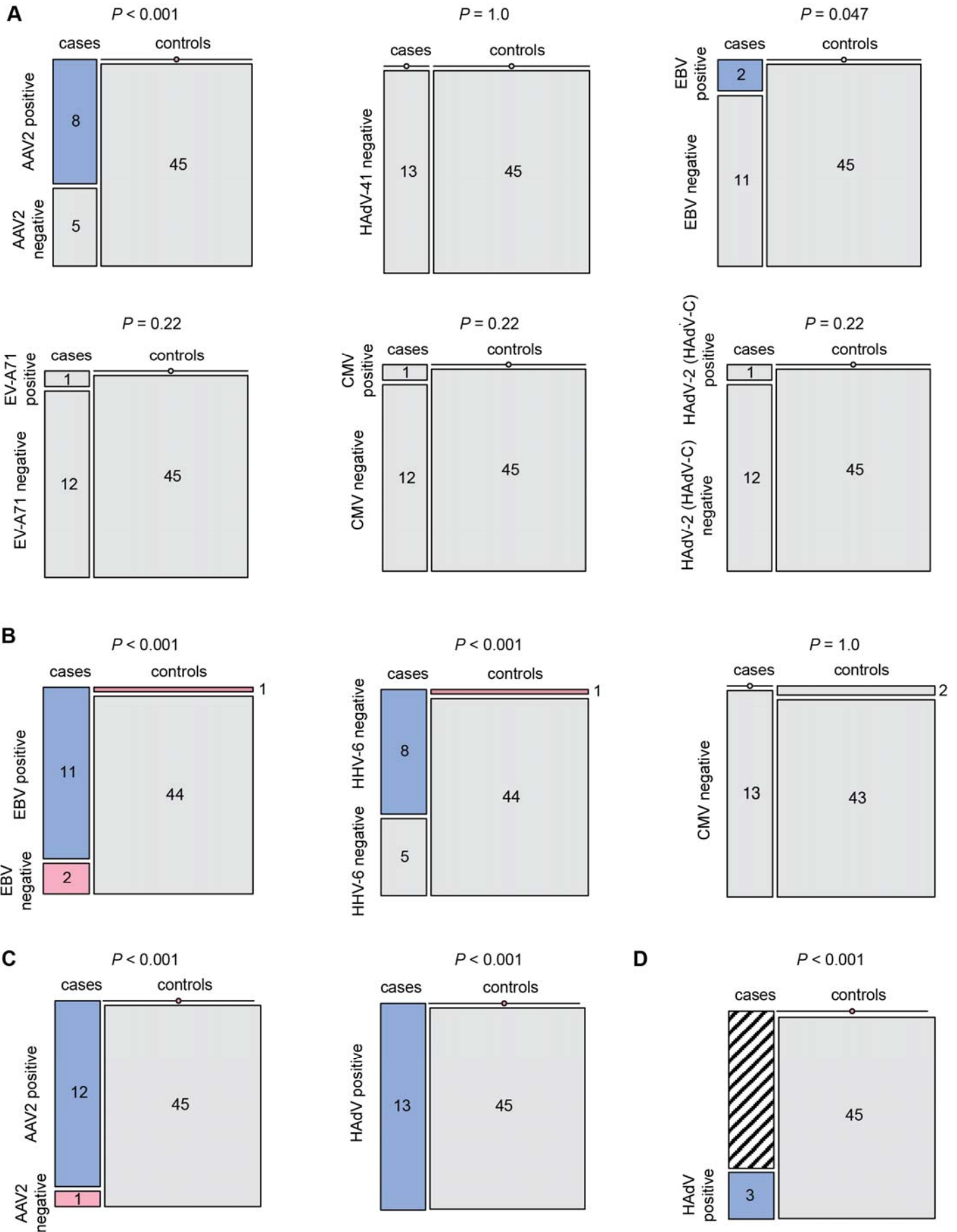
Figure 2. Overview of next-generation sequencing and molecular-based testing performed on cases and controls. Each circle represents a sequenced sample with at least 3 non-overlapping reads<sup>20</sup> aligning to a viral sequence in the National Center for Biotechnology Information (NCBI) database detected by metagenomic and targeted or virally enriched sequencing. The circles are color-coded based on the sample type and size-scaled based on viral read counts. PCR positive and negative results are denoted by plus and

28 samples in 12 (92%) of 13 cases and HAdV in all 13 cases **(Figure 2)**. Ten (77%) of the 13 cases were HAdV-  
29 41, one (7.7%) was HAdV-40, and one (7.7%) was HAdV-2. AAV2 and HAdV-41 enrichment were performed  
30 using either tiled multiplex PCR amplicon sequencing targeting the genomes of HAdV-41 and AAV (n=9  
31 samples, with a mean  $6.6 \pm 1.5$  (SD) million raw reads generated per sample) or probe capture VE targeting  
32 3,153 viral species (n=4, with a mean  $128 \pm 34$  (SD) million raw reads generated per sample). Mean viral read  
33 counts for AAV2 (6285 and 56815 reads from targeted and VE sequencing, respectively) were approximately  
34 30-100 times greater than for HAdV-41 (58 and 1676 reads from targeted and VE sequencing, respectively)  
35 **(Extended Data Table 1)**. AAV2 was detected in both liver tissue and whole blood from one case and in 1 of 2  
36 plasma samples, but neither AAV2 nor HAdV-41 were detected in nasopharyngeal swab and stool samples.  
37 No reads from AAVs other than AAV2 were detected, despite using methods that would enrich for other AAV  
38 subtypes.

39 Metagenomic sequencing was less sensitive than viral enrichment and targeted sequencing for  
40 detection of AAV2 (8 of 13 cases, 61.5%) and HAdV-41 (0 of 13 cases, 0%) **(Figure 2 and Extended Data**  
41 **Table 1)**. However, reads from additional viruses were identified including EBV (n=2), CMV (n=1), HAdV-2  
42 (adenovirus type C) (n=1), and enterovirus A71 (EV-A71) (n=1) from whole blood, HAdV-1 (adenovirus type C)  
43 (n=1) from nasopharyngeal swab, and picobirnavirus (n=1) from stool. EV-A71 was detected as a co-infection  
44 in an HAdV-41/AAV2 case, while HAdV-2 was detected in the single AAV2 negative case. Among the 45 whole  
45 blood controls, no viral pathogen was detected.

16 To identify additional viruses that may be associated with acute severe hepatitis, we performed virus-  
17 specific PCR testing for HAdV with genotyping by hexon gene sequencing, EBV, CMV, and HHV-6 for all  
18 cases and controls with sufficient volume for testing (**Figure 2 and Extended Data Table 1**). AdV PCR  
19 confirmed the detection of HAdV-41 (n=11), HAdV-2 (n=1), and HAdV-1 (n=1), but also identified an additional  
20 case of HAdV-40 infection that was missed by targeted and metagenomic sequencing. EBV and HHV-6 were  
21 detected from whole blood in 11 (85%) of 13 and 8 (62%) of 13 cases, respectively, versus 1 (0.02%) of 45  
22 controls for each virus. No tested cases were positive for CMV as compared to 2 (0.04%) of 45 controls.

23 Combining all 3 detection modalities yielded a positive detection for AAV2 in whole blood samples from  
24 12 (92%) of 13 cases and adenovirus, either HAdV-41 (n=10), HAdV-40(n=1), or HAdV-2 (n=1) in all 13 cases.  
25 The latter result is not surprising given that most patients with whole blood samples, 10 (76.9%) of 13, were  
26 known to be adenovirus positive by prior clinical testing. Co-infections with EBV and HHV-6 were also found in  
27 a large proportion of cases tested for these specific viruses, 11 (85%) of 13 for EBV and 8 (62%) of 13 for  
28 HHV-6. HAdV-1 was detected in a single patient for whom only nasopharyngeal swab sample was available.  
29 Of the remaining 3 cases of the 16 total for whom only a stool or plasma sample was available, 2 were  
30 negative for both AAV2 and adenovirus while 1 plasma sample was positive for AAV2 only.

### 31 **Associations between detected viruses and acute severe hepatitis cases**

32 We used Fisher's Exact Test on cases (n=13) and controls (n=45) to investigate associations between  
33 detected viruses in whole blood and acute severe hepatitis. For these analyses, we included data from  
34 agnostic metagenomic sequencing, PCR, targeted sequencing for HAdV-41 and AAV2, and probe capture viral  
35 enrichment-based sequencing (**Figure 3**). Among viruses detected by agnostic metagenomic sequencing  
36 (HAdV-41, AAV2, EV-A71, EBV, CMV, and HAdV-2), only AAV2 ( $P<.001$ ) and EBV ( $P=.047$ ) had a significant  
37 correlation with acute severe hepatitis (**Figure 3**). Using real-time PCR assays with probes specific for the  
38 detection of HHV-6, EBV and CMV, significant correlations were observed between HHV-6 ( $P<0.001$ ) and EBV  
39 ( $P<0.001$ ) (**Figure 3B**). Using a combination of metagenomic sequencing, probe capture viral enrichment, and  
40 targeted HAdV-41 and AAV2 sequencing, significant correlations were observed between AAV2 infection and  
41

acute severe hepatitis ( $p < 0.001$ ) (Figure 3C). A significant correlation was also observed between adenovirus infection and acute hepatitis ( $p < 0.001$ ), even after removal of the 10 (76.9%) of 13 cases that were known to be positive for adenovirus *a priori* (Figure 3D).

## 38 39 40 **Phylogenetic and mutation analyses**

41 Fourteen complete or partial AAV2 genomes were recovered from 12 whole blood samples, one liver  
42 tissue, and one plasma from 13 cases (**Figure 2**). We performed multiple sequence alignment and  
43 phylogenetic analysis of 13 recovered AAV2 genomes from 12 cases with >25% breadth of coverage (**Figures**  
44 **4 and 5**). One AAV2 genome, corresponding to sample 14\_NC, had <17% coverage so was excluded from  
45 further analysis. The multiple sequence alignment was performed in parallel with all complete 119 AAV2  
46 reference genomes deposited in GenBank as of August 18, 2022, consisting of sequences from humans  
47 (n=108), non-human primates (n=30), geese and ducks (n=3), rodents (n=3), and bats (n=2). A nucleotide  
48 phylogenetic tree constructed from the genomes and rooted using a bat AAV genome (NC\_014468.1)  
49 demonstrated clustering of the 13 recovered genomes from this study within a subgroup of a single large  
50 human AAV2 clade (**Figure 4A**). Other previously sequenced AAV2 genomes from France (MK139269.1 and  
51 MK139259.1) and the United States (KY271943.1, AY695372.1, AY695374.1 and AY695375.1) from patients  
52 without hepatitis were also found within this subgroup. Amino acid phylogenetic trees of the VP1 and AAP  
53 proteins showed slightly different topologies, but the 13 recovered genomes continued to cluster together in a  
54 distinct AAV2 subgroup within one of the subclusters.

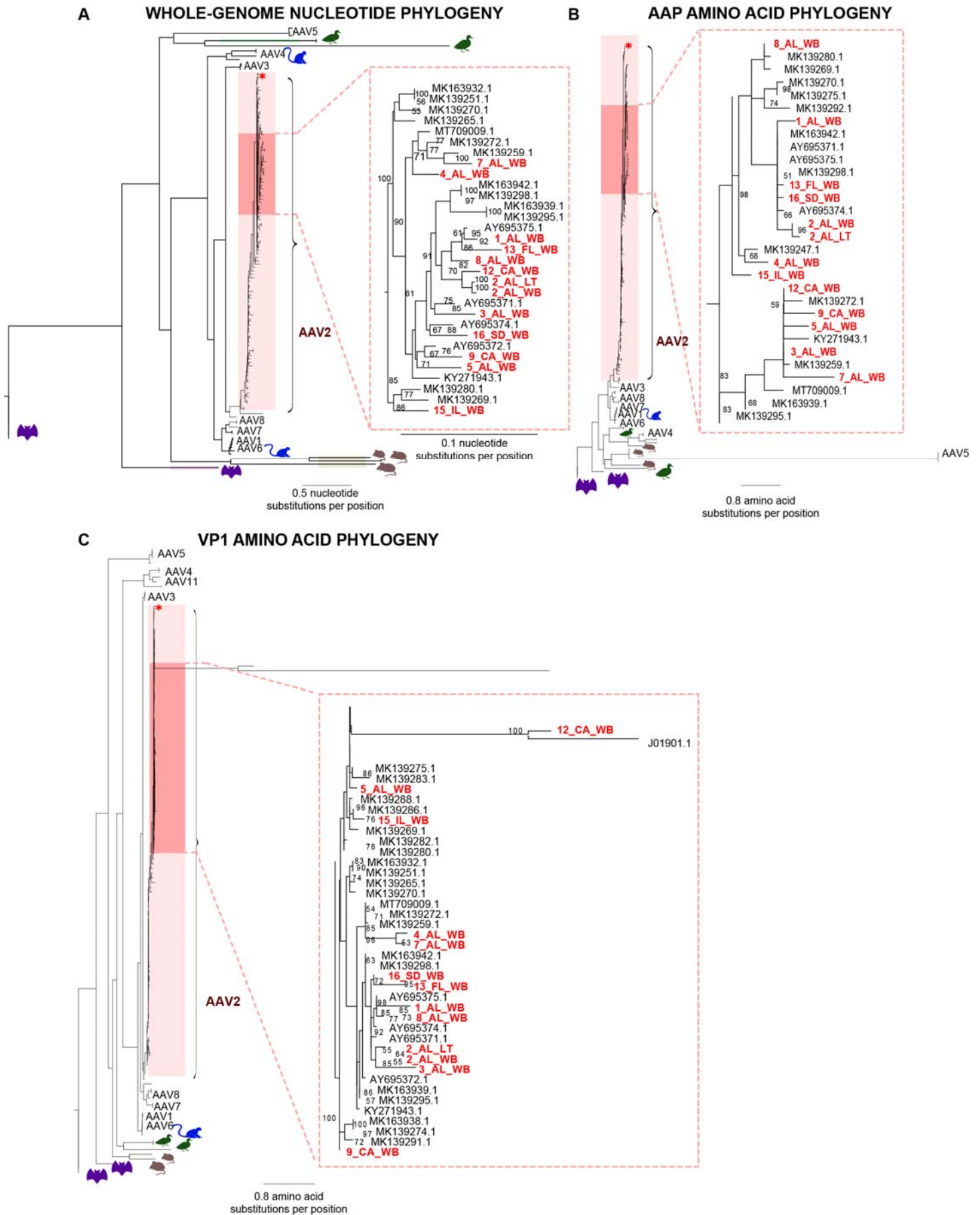

To explore the underlying basis behind the phylogenetic clustering, we performed a multiple sequence alignment of the 13 recovered AAV2 genomes and searched for shared coding mutations relative to the AAV2 reference genome (NC\_001401.2) that were found in  $\geq 50\%$  of recovered genomes with coverage at the nucleotide site. This analysis yielded 35 mutations that were unevenly distributed across the viral genome with 15 of 35 (42.9%) in the assembly activating protein (AAP), 14 of 35 (40%) in the VP1 protein, and 6 of 35 (17.1%) in the Rep78 protein (**Figure 5 and Extended Data Table 2**). Clusters of mutations were found to be located within hypervariable regions of the capsid VP1 and AAP proteins<sup>21</sup>. Of note, 25 (71.4%) of 35 mutations were shared with those identified in an independent study of severe pediatric hepatitis from the UK<sup>12</sup>, with 12 (34.3%) of 35 mutations found in 100% of recovered AAV2 genomes (with coverage at the variable site) from both studies.

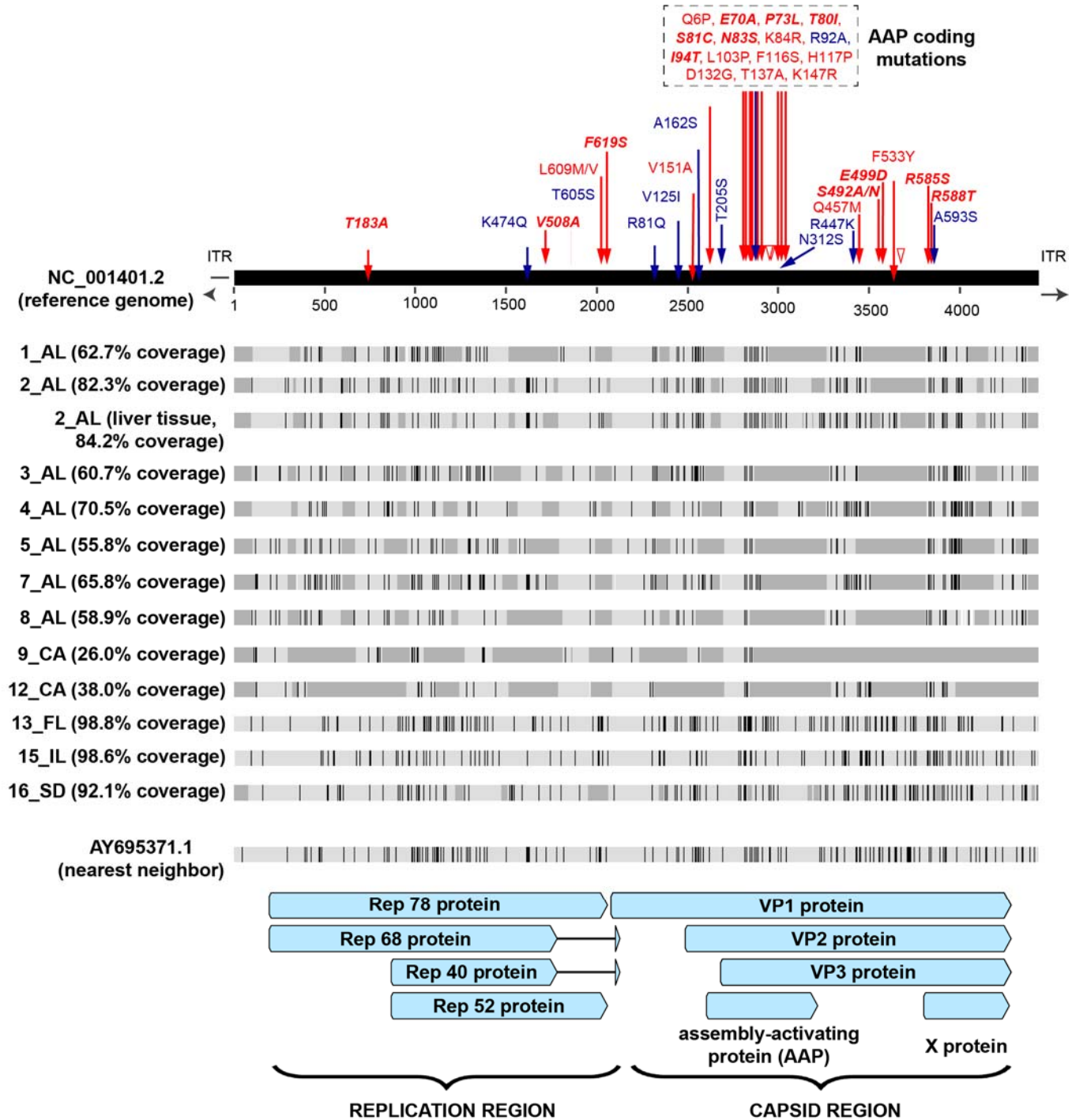

## 20 21 **Discussion**

22 We report here virus findings from PCR, metagenomic, and targeted sequencing of samples from 16  
23 pediatric cases of acute severe hepatitis of unknown etiology that were first identified in the United States in  
24 October 2021. After combining these three diagnostic modalities, AAV2 was detected in 92% (12 of 13) of  
25 cases for which whole blood was available ( $P<.001$ ). HAdV sequences were detected in all 13 cases, of which  
26 11 (84.6%) were genotyped as HAdV-41. Conversely, no control specimens had AAV2 and HAdV-41 detected.  
27 Although the 100% detection rate of HAdV may not be surprising as 10 (76.9%) of the 13 cases were known to  
28 be adenovirus positive by clinical testing *a priori*, the detection of HAdV in the 3 remaining cases and in 0 of 45  
29 controls is still significant ( $p<0.001$ ); further, adenovirus is detected in 45-90% of the overall PUI population<sup>6,8-</sup>  
30 <sup>11</sup>. Other co-infecting viruses, including EBV and HHV-6, were detected by PCR in many cases but rarely in  
31 controls ( $P<.001$ ); EV-A71 was also detected by metagenomic sequencing in one case but not in any control.  
32 These findings indicate an association between co-infection by AAV2 and one or more hepatotropic viral  
33 pathogens and the clinical manifestations of severe acute hepatitis, although a direct causal link has yet to be  
34 confirmed.

35 Initial epidemiological investigation and molecular testing have found adenovirus in 45-90% of severe  
36 acute hepatitis cases<sup>6,8-11</sup>. In the UK, 116 of 179 (64.8%) reported cases as of May 2022 have tested positive  
37 for adenovirus<sup>1</sup>. This is in comparison to 8 of 9 (88.9%) positive cases in the United States corresponding to a  
38 cluster of cases who presented at a children's hospital in Alabama between October 2021 and March 2022<sup>10</sup>.  
39 Slightly less than half (44.6%) of PUIs in an expanded national investigation in the United States had  
40 adenovirus detected<sup>8</sup>. In the current study, 9 (75%) of 13 cases were already known to be adenovirus positive  
41 *a priori* by clinical testing, with the remaining 4 cases adenovirus positive by viral PCR and/or sequencing.  
42 Consistent with prior reports<sup>10,12</sup>, genotyping by sequencing confirmed that most of the detected serotypes  
43 were HAdV-41 (10 of 13, 77%).

74 Our results suggest that co-infection with AAV2 may cause a more severe liver disease than infection  
75 by an adenovirus and/or herpesvirus alone. This condition may be analogous to the fulminant liver failure that  
76 can occur when hepatitis D virus (HDV, “delta”) infection is superimposed on a chronic hepatitis B virus (HBV)  
77 infection<sup>24</sup>. Here we found that in cases with AAV2/HAdV co-infection, viral loads for AAV2 were likely higher  
78 than for HAdV, with higher positivity rates and a 2-3 log<sub>10</sub> increase in the number of reads by targeted  
79 sequencing (mean AAV2 reads = 7,252 versus HAdV-41 reads = 67). This observation may be partially  
80 explained by previously published data showing that AAVs can suppress the replication of other hepatotropic  
81 viruses, including adenoviruses and herpesviruses<sup>15,25</sup>. Similarly, patients co-infected with HDV usually exhibit  
82 low HBV viral loads due to suppression of HBV replication by HDV-induced interferons<sup>26</sup>.

83 Among the AAVs, AAV2 is the most well-characterized AAV and has been shown to replicate to high  
84 titers in the liver and spleen<sup>27</sup>. Seroprevalence data from infants, children, and adults demonstrate that 30-80%  
85 of the general population is seropositive and that natural infection with AAV can occur at all ages<sup>28</sup>. However,  
86 there is a peak of AAV2 infection between the ages of 1 to 5 years old<sup>29</sup>, consistent with the observed  
87 distribution of ages of affected pediatric cases in the current study.

88 A whole-genome nucleotide phylogeny and amino acid phylogenies of the VP1 and AAP proteins of all  
89 sequenced human AAVs and representative nonhuman AAVs reveal that the recovered genomes from all  
90 cases cluster together in a distinct subclade of AAV2. The clustering is driven by groups of mutations located  
91 within hypervariable regions of the capsid VP1 and AAP proteins<sup>21</sup>. Notably, two of these mutations in the VP1  
92 protein, R585S and R588T, are arginine-to-serine and arginine-to-threonine mutations that likely impact  
93 receptor binding as these residues are necessary for the interaction of AAV2 with its heparan sulfate  
94 proteoglycan receptor<sup>30</sup>. These are shared not only among the US genomes in the current study but also  
95 overlap substantially with the mutations found in an independent study of severe pediatric cases from the UK<sup>12</sup>.  
96 Interestingly, several of these shared capsid mutations (V151A, Q457M, S492A, E499D, F533Y, R585S, and  
97 R588T) are also found in a sublineage of AAV2 (AAVv66) that exhibits increased replication, virion stability,  
98 central nervous system transduction, and evasion of neutralizing antibodies relative to wild-type AAV2.  
99 However, as other contemporary AAV2 genomes are not readily available, it is unclear whether the

relatedness in AAV2 genomes across geographically dispersed regions and to AAVv66 merely represents detection of the predominant global circulating strain.

In the current study, hepatotropic viruses other than HAdV, including EBV, HHV-6, and EV-A71, were detected, albeit in a smaller proportion of cases. Infection by HHV-6 or EBV alone has been implicated in cases of liver failure requiring transplantation<sup>31,32</sup>. Notably, among the 13 cases, dual or triple infections with adenovirus and one or both herpesviruses were detected in whole blood from at least 11 cases (>85%). We postulate that the COVID-19 pandemic and more than 2 years of school and childcare closures, social distancing measures, and decreased overall social interactions may have generated a vulnerable population of young children who have failed to develop broad immunity to common viral pathogens due to lack of exposure. This may potentially explain the increased proportion of cases with multiple viral infections observed in the current study, including from AAV2, that we speculate may have increased the likelihood of more severe disease manifestations such as hepatitis.

In summary, here we identify a distinct strain of AAV2 and co-infection with at least one helper virus in blood from US pediatric cases of acute severe hepatitis of unknown etiology. These results are consistent with findings from independent and contemporary studies of acute severe hepatitis in children from Scotland and the UK<sup>12,33</sup>. AAV2 infection may contribute to the pathogenesis and/or severity of the hepatitis, or alternatively, may be a non-pathogenic marker of liver inflammation. Further studies, including serosurveillance and cell culture and animal model studies, are needed to investigate a potential causal role infection from this strain or AAV2 in general may play in this disease.

## **METHODS**

### Ethics Statement

Remnant clinical samples from cases with acute severe hepatitis were collected and analyzed under “no subject contact” protocols with waiver of informed consent approved by the institutional review boards (IRBs) of University of Alabama, Birmingham, California Department of Public Health, New York State

26 Department of Health, and CDC. Whole blood samples from pediatric controls (age < 18) from Children's  
27 Healthcare of Atlanta were prospectively collected and analyzed under a protocol approved by the Emory IRB  
28 (STUDY00000723); parents or guardians of these children provided oral consent for study enrollment and  
29 collection and analysis of their samples. Remnant whole blood samples from pediatric controls (age < 18) at  
30 University of California, San Francisco (UCSF) were collected, biobanked, and analyzed under a "no subject  
31 contact" protocol with waiver of informed consent approved by the UCSF IRB (protocol no. 11-05519). This  
32 investigation was reviewed by CDC and conducted consistent with applicable federal law and CDC policy (45  
33 C.F.R. part 46.102(l)(2), 21 C.F.R. part 56; 42 U.S.C. Sect. 241(d); 5 U.S.C. Sect. 552a; 44 U.S.C. Sect.  
34 3501).

### 36 Sample Collection

37 All acute hepatitis cases in this study were categorized as severe as all patients were hospitalized with  
38 acute elevation in liver enzymes, aspartate aminotransferase (AST) or alanine aminotransferase (ALT), and  
39 one or more of the following symptoms on presentation: nausea, vomiting, jaundice, generalized weakness,  
40 and abdominal pain. Acute severe hepatitis cases from California were selected among those sent to the  
41 California Department of Public Health for typing and whole-genome sequencing after testing adenovirus  
42 positive, depending on sample availability. For cases from Alabama, Florida, Illinois, North Carolina, and South  
43 Dakota, samples from PUIs were collected and sent to the CDC for further diagnostic testing. A person under  
44 investigation (PUI) was defined as a person <10 years of age with elevated (>500 U/L) aspartate  
45 aminotransferase (AST) or alanine aminotransferase (ALT), an unknown etiology for the hepatitis, and onset  
46 on or after October 1, 2021<sup>3</sup>. For the Alabama cases (n=8), samples were selected for inclusion into the  
47 current study if they had tested positive for adenovirus and if there was sufficient available volume. For the  
48 remaining 4 cases from states other than Alabama or California for whom sufficient volume was available,  
49 samples were not previously known to be positive for adenovirus. Samples were stored at -80°C until use.

50 Remnant whole blood samples from controls from UCSF (n=37) were retrospectively biobanked and  
51 aliquoted with addition of 2X DNA/RNA Shield (Zymo Research) in a 1:1 ratio by volume and stored at -80°C



52 until use. These controls, all from California, were selected to be geographically similar (located within the  
53 same state) to the cases from California. Whole blood samples from controls from Children’s Healthcare of  
54 Atlanta (n=8) were obtained from children enrolled into a sample collection protocol following informed consent  
55 and assent, as appropriate for age. These controls were all from Georgia and were outpatient volunteers (n=6)  
56 or hospitalized patients (n=2), selected to geographically similar (located within a neighboring state with similar  
57 demographic characteristics) to the cases from Alabama and Florida<sup>34</sup>. Samples were stored at -80°C until  
58 use. Among the controls, 23 (51%) of 45 were collected over the same time frame as the cases (October 1,  
59 2021 to March 28, 2022).

### 51 Nucleic Acid Extraction

52 Whole blood and plasma samples collected from cases from Alabama were extracted at the Wadsworth  
53 Center laboratory using the NucliSENS® easyMAG “specific B” protocol (bioMerieux) according to the  
54 manufacturer’s instructions. Samples from cases from Florida, Illinois, North Carolina, and South Dakota were  
55 extracted using the Zymo Direct-zol™ DNA/RNA Miniprep Kit (Zymo Research) following the manufacturer’s  
56 instructions. Briefly, 200 µL of sample was extracted and total nucleic acid was eluted in 60 µL and stored at  
57 -80°C until use.

58 Samples from cases from California were extracted at the California Department of Public Health.  
59 Whole blood samples (200 µL) were extracted using the Qiagen Blood Mini Kit (Qiagen) according to the  
60 manufacturer’s instructions. Total nucleic acid was eluted in 100 µL and stored at -80°C until use. Respiratory  
61 samples, serum, plasma, and clarified stool suspensions were extracted using the NucliSENS easyMAG  
62 instrument (bioMerieux). Briefly, 300 µL of nasopharyngeal swab, serum, or plasma sample or 140 µL of  
63 clarified stool suspension was lysed with 1 mL of lysis buffer and incubated for 10 minutes at room  
64 temperature, followed by addition of 100 µL magnetic silica and transfer to the instrument to begin the  
65 automated extraction. Total nucleic acid was eluted in 110 µL for nasopharyngeal swab, serum, or plasma or  
66 60 µL for stool and stored at -80°C prior to use.

77 For control samples from California or Georgia extracted at UCSF, total nucleic acid was extracted from  
78 the original sample using two different protocols for whole blood and plasma. Whole blood samples (400 µl)  
79 that had been pretreated with DNA/RNA Shield (Zymo Research) were extracted using the Quick-RNA Whole  
80 Blood Kit (Zymo Research) according to the manufacturer's instructions. Total nucleic acid was eluted in 15 µl  
81 and stored at -80°C until use. Plasma samples (200 µl) were extracted using the Mag-Bind Viral DNA/RNA 96  
82 Kit (Omega Bio-Tek) on a KingFisher Flex instrument (Thermo-Fisher scientific) according to the  
83 manufacturer's instructions. Total nucleic acid was eluted in 100 µl and stored at -80°C until use.

### 84 85 Viral PCR testing

86 Samples from California cases were screened for adenovirus using a pan-adenovirus PCR targeting all  
87 human adenoviruses<sup>35</sup> and/or a group F adenovirus (HAdV-40 / HAdV-41) real-time PCR<sup>36</sup>. A cycle threshold  
88 cutoff of ≤40 was used to call a positive result by PCR. PCR and Sanger sequencing of the HAdV hexon gene  
89 targeting hypervariable regions 1-6<sup>37</sup> were performed on all adenovirus positive samples with purified PCR  
90 products sequenced in-house or sent to an outside laboratory (Sequetech, Mountain View, CA) for sequencing.  
91 Sanger sequences were assembled and edited in Sequencher 5.2.4 (Gene Codes) and analyzed using the  
92 nucleotide BLAST aligner<sup>38</sup>. Samples from cases outside of California and all control samples were screened  
93 for adenovirus using a pan-adenovirus PCR assay<sup>35</sup> and sequenced using a nested PCR assay targeting  
94 HAdV hexon hypervariable regions 1-6, followed by Sanger sequencing<sup>39</sup>. PCR testing for detection of CMV,  
95 EBV, and HHV-6 was performed as previously described<sup>40</sup>.

### 96 97 Viral Enrichment Based Targeted Sequencing

98 For cases from California and Alabama and all controls, viral enrichment followed by targeted  
99 sequencing of viral genomes was performed using custom spiked primers designed to target HAdV-41 or  
100 adeno-associated virus (AAV1-AAV8) genomes. Spiked primers were designed using the metagenomic  
101 sequencing with spiked primer enrichment (MSSPE) algorithm<sup>17</sup> as follows. For HAdV-41, 22 representative  
102 HAdV-41 genomes were aligned using MAFFT, while for AAV, 11 genomes representing AAV1-AAV8 were

aligned using MAFFT. Next, automated primer design was performed by running the MSSPE algorithm with the following parameters: kmer size=25, segment window=500, e-value=0.1, dS=2, dG=-9000. The algorithm generated 219 AdV and 150 AAV spiked primers (**Extended Data Table 3**). Libraries were prepared using NEBNext Ultra II DNA Kit (New England Biolabs). Briefly, adapters were ligated to the purified cDNA (1:25 diluted adaptor), followed by PCR library amplification using the spiked primers and barcoding using NEBNext Multiplex Oligos set 1 (New England Biolabs). Final libraries were quantified using the Qubit Flex instrument (Invitrogen) with the dsDNA HS Assay Kit (Invitrogen). Libraries were pooled and sequenced on a NextSeq 550 Sequencing System using 300 base pair (bp) single-end sequencing. Negative template controls were included in every run to monitor for contamination. No contamination from HAdV-41 or AAV2 reads was detected in the negative template control libraries.

For cases from Florida, Illinois, North Carolina, and South Dakota, probe capture target enrichment of viral genomes was performed on metagenomic libraries using the Twist Comprehensive Viral Research Panel (Twist Biosciences), which covers reference genomes of 3153 viruses and 15,488 different strains<sup>41</sup>. Individual DNA or cDNA/RNA libraries were hybridized to CVRP probes according to the manufacturer's instructions. Libraries were then barcoded and sequenced on an Illumina MiSeq (250 bp paired-end sequencing) or an Illumina NextSeq (150 bp paired-end sequencing) (Illumina). For plasma sample 14\_NC, nucleic acid carrier, either bacteriophage lambda DNA (New England Biolabs) or HeLa total RNA (Thermo-Fisher), was added during the library preparation step according to the manufacturer's instructions.

## Viral Metagenomic Sequencing and Analysis

Metagenomic DNA and RNA libraries were prepared using the NEBNext Ultra II DNA Library Prep Kit (New England Biolabs) and NEBNext Ultra II RNA Library Prep Kit (New England Biolabs), respectively, according to the manufacturer's instructions. Libraries were pooled and sequenced on a NextSeq 550 Sequencing System using 150 bp single-end sequencing. Potential contamination was monitored in each run by processing negative water and controls in parallel with samples.

28 Sequencing data from all cases and controls were analyzed for viral nucleic acids using SURPI+  
29 (v1.0.7-build.4)<sup>42</sup>, an automated bioinformatics pipeline for pathogen detection and discovery from  
30 metagenomic data that has been modified to incorporate enhanced filtering and classification algorithms<sup>20</sup>. A  
31 threshold of  $\geq 3$  non-overlapping reads was used for calling a positive virus detection<sup>20</sup>.

### 32 33 Phylogenetic Analysis

34 Multiple sequence alignments were performed using MAFFT algorithm<sup>22</sup> as implemented in Geneious  
35 (version 10.0.9)<sup>43</sup>. Nucleotide and amino acid phylogenetic trees were inferred using a maximum likelihood  
36 method with ultrafast bootstrap approximation as implemented in IQ-TREE (version 1.6.1)<sup>23</sup> using 1000  
37 bootstrap replicates. Trees were visualized using FigTree (version 1.4.4)<sup>44</sup>.

### 38 39 Viral Genome Assembly and Analysis

40 Binary base call (BCL) files generated by Illumina sequencers were simultaneously demultiplexed and  
41 converted to FASTQ files using bcl2fastq (version 2.20.0.422). A custom script was used to assemble HAdV  
42 and AAV2 genomes as follows. Briefly, raw FASTQ reads were filtered using BBDuk (version 38.87)<sup>45</sup> for  
43 removal of adapters, primer sequences, and low-quality reads, and then HAdV-41 or AAV reads were identified  
44 by Bowtie2<sup>46</sup> alignment (parameters: -D 20 -R 3 -L11 -N 1) to a reference database consisting of 1,395  
45 HAdV-41 or 3,600 AAV partial sequences / genomes, respectively. These aligned reads were then mapped to  
46 the HAdV-41 reference genome (accession DQ315364.2) or consecutively to AAV genomes 1-8. For all AAV  
47 genomes, the assembly with the highest breadth of coverage corresponded to the AAV2 reference genome  
48 (accession number NC\_001401.2). Consensus assemblies were generated using iVar<sup>47</sup> (parameters: -t 0.5  
49 -m 1). AAV consensus genomes were further analyzed for shared mutations in the nucleotide and translated  
50 nucleotide (amino acid) sequences relative to the AAV2 reference by performing a multiple sequence  
51 alignment using the MAFFT algorithm<sup>22</sup>, followed by visualization of the alignment using Geneious software  
52 (version 10.0.9)<sup>43</sup>.

## 54 Statistical Analysis

55 Statistical analyses were performed using the Python scipy package (version 1.5.2)<sup>48</sup> and rstatix package  
56 (version 0.7.0) in R (version 4.0.3)<sup>49</sup>. Fisher's Exact Test was used to assess the association between  
57 variables. All statistical tests were conducted as two-sided at the 0.05 significance level.

## 58 59 Data Visualization

60 Plots were generated using matplotlib (version 3.3.2), seaborn (version 0.11.0) and plotly (version 5.6.0)  
61 packages in Python software (version 3.7.12), Jupyter notebook (version 6.1.4), RStudio (version 1.4) and  
62 Adobe Illustrator (version 26.4.1) software.
