1 Adeno-associated virus type 2 in children from the United States with acute severe hepatitis

45 ABSTRACT

16 As of August 2022, cases of acute severe hepatitis of unknown etiology in children have been reported 17 from 35 countries, including the United States. Here we used PCR testing, viral enrichment based sequencing, 18 and agnostic metagenomic sequencing to analyze 27 samples, including nasopharyngeal swab, stool, plasma, 19 and/or whole blood, from 16 such cases from 6 states (Alabama, California, Florida, Illinois, North Carolina, 50 and South Dakota) presenting from October 1, 2021 to May 22, 2022, in parallel with whole blood samples 51 from 45 controls. Among the 13 cases for whom whole blood was available, adeno-associated virus 2 (AAV2) 52 sequences were detected in 92% (12 of 13) (p<0.001), while adenovirus sequences were detected in 100%, of 53 which 11 (84.6%) were genotyped as human adenovirus type 41 (HAdV-41), one as HAdV-40, and one as 54 HAdV-2. Co-infections of herpesviruses, Epstein-Barr virus (EBV) or human herpesvirus 6 (HHV-6), and/or enterovirus A71 (EV-A71) were also detected in all 13 cases. In contrast, AAV2 and HAdV-41 were not 55 56 detected in any control, and EBV, HHV-6, or EV-A71 were each only detected in one or two of 45 controls 57 (p<0.001). Analysis of assembled AAV2 viral genome sequences identified 35 coding mutations relative to the 58 AAV2 reference genome, predominantly located in the VP1 capsid and assembly-activating protein (AAP) 59 proteins, and AAV2 genomes from cases clustered together by phylogenetic analysis. Our findings of a distinct 50 AAV2 strain in nearly all cases of acute severe hepatitis of unknown etiology in conjunction with one or more 51 infecting helper viruses suggest that disease pathogenesis and/or severity may be related to co-infection with 52 AAV2.

54 INTRODUCTION

Viral hepatitis is an inflammation of the liver most commonly caused by one of the major hepatitis viruses (A-E). Since October 2021, outbreaks of acute non A-E severe hepatitis of unknown etiology in children have been reported in 35 countries, including the United States (US)^{1,2}. The majority of pediatric cases globally have been <6 years of age (76%), with an approximately equal gender distribution (48% male to 52% female)². As of August 17, 2022, 358 persons under investigation (PUIs) have been reported in the United States, of whom 22 (6%) required a liver transplant and 13 (4%) died³.

71 Human adenoviruses (HAdVs) are non-enveloped, double-stranded DNA viruses that cause a variety of 12 infections in both adults and children, including respiratory tract infection, conjunctivitis, and gastroenteritis (mainly from adenovirus species F including HAdV types 40 and 41^{4,5}. Although previously reported as a 13 severe and potentially fatal disease in immunocompromised patients^{4,6}, hepatitis from adenovirus infection had 14 75 been thought to be rare in immunocompetent children without underlying comorbidities⁷. In previous reports, 76 adenoviruses, particularly adenovirus type 41 (HAdV-41), have been found in the blood from a majority of outbreak-associated cases of acute severe hepatitis from Scotland, the United Kingdom (UK), and the US^{6,8-11}, 17 78 although it is unclear whether this virus is causative. AAVs have also been reported in children with severe acute hepatitis in a study of 9 patients from the United Kingdom (UK)¹⁸, often in association with adenovirus or 79 human herpesvirus 6 (HHV-6 infection)¹². AAVs are small, single-stranded DNA parvoviruses that are thought 30 to be non-pathogenic in humans and for this reason have been widely used as vectors for gene therapy¹³. 31 32 Importantly, AAVs require a helper virus, such as a herpesvirus or adenovirus, for productive infection, 33 although the contribution of AAVs to hepatitis remains unclear^{14,15}.

In this study, we employ a variety of molecular and sequencing-based methods to investigate acute viral infections that may be causing severe hepatitis in children. These include metagenomic sequencing for agnostic detection of all viruses¹⁶, tiling multiplex PCR amplicon sequencing for AAV2 and HAdV-41¹⁷, metagenomic sequencing with probe capture viral enrichment for 3,153 viruses¹⁸, and virus-specific polymerase chain reaction (PCR). Our findings in affected US children from 6 geographically dispersed states


Patient and sample characteristics

*)*4 In this study, 27 samples (21 whole blood, 2 plasma, 1 liver tissue, 1 nasopharyngeal swab, and 2 stool sample(s)) from 16 pediatric patients with acute severe hepatitis of unknown etiology were analyzed (Figure **)**5 *)*6 **1A).** All patients met the clinical case definition for the disease established by the CDC, including lack of a **)**7 confirmed etiology for the hepatitis (including negative testing for hepatitis viruses A-E), liver enzyme levels 98 (aspartate aminotransferase / AST or alanine aminotransferase / ALT) >500 UL, age <10 years, and onset on or after October 1, 2021^{2,19}. Affected children were admitted to tertiary care hospitals in 6 states (Alabama,)9 California, Florida, Illinois, North Carolina, and South Dakota) from October 1, 2021 to May 22, 2022)())1 (Extended Data Table 1). Because many patients (12 of 16, 75%) were selected from those PUIs who tested)2 positive for adenovirus and had samples submitted for adenovirus typing. PUIs with adenovirus infection may)3 have been over-represented compared to the overall PUI population, of which adenovirus is detected in 45-)4 90%^{6,8-11}. The median age of affected children was 3 years. Mean elevations in AST and ALT were 2,652 +/-)5 1,851 and 2,293 +/- 1,486, respectively; 2 children underwent liver transplantation and 0 died from)6 complications of liver failure; the others are still hospitalized at time of data collection or recovered with)7 supportive care.

Whole blood samples from 45 pediatric controls, 8 from Georgia to be geographically similar (located in a neighboring state) to the Alabama and Florida cases, and 37 from California to be geographically similar (located in the same state) to the California cases, were analyzed in parallel. Geographically similar samples for the North Carolina, Illinois, and South Dakota cases were not available. Control samples were collected between August 4, 2020 and March 28, 2022. Of the 45 control samples, 23 (62%) were also collected over the same time frame as the cases (i.e., collected between October 1, 2021 and March 28, 2022). The median age of controls was 9 +/- 5 years. Among the 45 controls, 8 (18%) were hospitalized patients with a non-

24 Detection of viruses in acute severe hepatitis cases

Metagenomic sequencing, tiling multiplex PCR amplicon sequencing, metagenomic sequencing with 25 26 probe capture viral enrichment (VE), and virus-specific PCR were performed to identify viruses in clinical 27 samples from acute severe hepatitis cases (Figure 1B). We detected AAV2 from available whole blood 28 samples in 12 (92%) of 13 cases and HAdV in all 13 cases (Figure 2). Ten (77%) of the 13 cases were HAdV-29 41, one (7.7%) was HAdV-40, and one (7.7%) was HAdV-2. AAV2 and HAdV-41 enrichment were performed 30 using either tiled multiplex PCR amplicon sequencing targeting the genomes of HAdV-41 and AAV (n=9 samples, with a mean 6.6±1.5 (SD) million raw reads generated per sample) or probe capture VE targeting 31 32 3,153 viral species (n=4, with a mean 128±34 (SD) million raw reads generated per sample). Mean viral read 33 counts for AAV2 (6285 and 56815 reads from targeted and VE sequencing, respectively) were approximately 34 30-100 times greater than for HAdV-41 (58 and 1676 reads from targeted and VE sequencing, respectively) 35 (Extended Data Table 1). AAV2 was detected in both liver tissue and whole blood from one case and in 1 of 2 36 plasma samples, but neither AAV2 nor HAdV-41 were detected in nasopharyngeal swab and stool samples. 37 No reads from AAVs other than AAV2 were detected, despite using methods that would enrich for other AAV 38 subtypes.

Metagenomic sequencing was less sensitive than viral enrichment and targeted sequencing for detection of AAV2 (8 of 13 cases, 61.5%) and HAdV-41 (0 of 13 cases, 0%) (Figure 2 and Extended Data Table 1). However, reads from additional viruses were identified including EBV (n=2), CMV (n=1), HAdV-2 (adenovirus type C) (n=1), and enterovirus A71 (EV-A71) (n=1) from whole blood, HAdV-1 (adenovirus type C) (n=1) from nasopharyngeal swab, and picobirnavirus (n=1) from stool. EV-A71 was detected as a co-infection in an HAdV-41/AAV2 case, while HAdV-2 was detected in the single AAV2 negative case. Among the 45 whole blood controls, no viral pathogen was detected.


16 To identify additional viruses that may be associated with acute severe hepatitis, we performed virus-17 specific PCR testing for HAdV with genotyping by hexon gene seguencing, EBV, CMV, and HHV-6 for all 18 cases and controls with sufficient volume for testing (Figure 2 and Extended Data Table 1). AdV PCR 19 confirmed the detection of HAdV-41 (n=11), HAdV-2 (n=1), and HAdV-1 (n=1), but also identified an additional 50 case of HAdV-40 infection that was missed by targeted and metagenomic sequencing. EBV and HHV-6 were 51 detected from whole blood in 11 (85%) of 13 and 8 (62%) of 13 cases, respectively, versus 1 (0.02%) of 45 52 controls for each virus. No tested cases were positive for CMV as compared to 2 (0.04%) of 45 controls. 53 Combining all 3 detection modalities yielded a positive detection for AAV2 in whole blood samples from 54 12 (92%) of 13 cases and adenovirus, either HAdV-41 (n=10), HAdV-40(n=1), or HAdV-2 (n=1) in all 13 cases. 55 The latter result is not surprising given that most patients with whole blood samples, 10 (76.9%) of 13, were 56 known to be adenovirus positive by prior clinical testing. Co-infections with EBV and HHV-6 were also found in a large proportion of cases tested for these specific viruses, 11 (85%) of 13 for EBV and 8 (62%) of 13 for 57 58 HHV-6. HAdV-1 was detected in a single patient for whom only nasopharyngeal swab sample was available. 59 Of the remaining 3 cases of the 16 total for whom only a stool or plasma sample was available, 2 were 50 negative for both AAV2 and adenovirus while 1 plasma sample was positive for AAV2 only.

52 Associations between detected viruses and acute severe hepatitis cases

53 We used Fisher's Exact Test on cases (n=13) and controls (n=45) to investigate associations between 54 detected viruses in whole blood and acute severe hepatitis. For these analyses, we included data from 55 agnostic metagenomic sequencing, PCR, targeted sequencing for HAdV-41 and AAV2, and probe capture viral 56 enrichment-based sequencing (Figure 3). Among viruses detected by agnostic metagenomic sequencing 57 (HAdV-41, AAV2, EV-A71, EBV, CMV, and HAdV-2), only AAV2 (P<.001) and EBV (P=.047) had a significant 58 correlation with acute severe hepatitis (Figure 3). Using real-time PCR assays with probes specific for the 59 detection of HHV-6, EBV and CMV, significant correlations were observed between HHV-6 (P<0.001) and EBV 70 (P<0.001) (Figure 3B). Using a combination of metagenomic sequencing, probe capture viral enrichment, and targeted HAdV-41 and AAV2 sequencing, significant correlations were observed between AAV2 infection and 71

- *i*² acute severe hepatitis (p<0.001) (Figure 3C). A significant correlation was also observed between adenovirus
- ¹³ infection and acute hepatitis (p<0.001), even after removal of the 10 (76.9%) of 13 cases that were known to
- ¹⁴ be positive for adenovirus *a priori* (Figure 3D).




90 Phylogenetic and mutation analyses

)1 Fourteen complete or partial AAV2 genomes were recovered from 12 whole blood samples, one liver **)**2 tissue, and one plasma from 13 cases (Figure 2). We performed multiple sequence alignment and phylogenetic analysis of 13 recovered AAV2 genomes from 12 cases with >25% breadth of coverage (Figures **)**3 *)*4 4 and 5). One AAV2 genome, corresponding to sample 14 NC, had <17% coverage so was excluded from **)**5 further analysis. The multiple sequence alignment was performed in parallel with all complete 119 AAV2 *)*6 reference genomes deposited in GenBank as of August 18, 2022, consisting of sequences from humans (n=108), non-human primates (n=30), geese and ducks (n=3), rodents (n=3), and bats (n=2). A nucleotide)7 98 phylogenetic tree constructed from the genomes and rooted using a bat AAV genome (NC 014468.1))9 demonstrated clustering of the 13 recovered genomes from this study within a subgroup of a single large)() human AAV2 clade (Figure 4A). Other previously sequenced AAV2 genomes from France (MK139269.1 and MK139259.1) and the United States (KY271943.1, AY695372.1, AY695374.1 and AY695375.1) from patients)1)2 without hepatitis were also found within this subgroup. Amino acid phylogenetic trees of the VP1 and AAP)3 proteins showed slightly different topologies, but the 13 recovered genomes continued to cluster together in a)4 distinct AAV2 subgroup within one of the subclusters.





















17 To explore the underlying basis behind the phylogenetic clustering, we performed a multiple sequence 8 alignment of the 13 recovered AAV2 genomes and searched for shared coding mutations relative to the AAV2 9 reference genome (NC 001401.2) that were found in \geq 50% of recovered genomes with coverage at the nucleotide site. This analysis vielded 35 mutations that were unevenly distributed across the viral genome with 20 21 15 of 35 (42.9%) in the assembly activating protein (AAP), 14 of 35 (40%) in the VP1 protein, and 6 of 35 22 (17.1%) in the Rep78 protein (Figure 5 and Extended Data Table 2). Clusters of mutations were found to be located within hypervariable regions of the capsid VP1 and AAP proteins²¹. Of note, 25 (71.4%) of 35 23 24 mutations were shared with those identified in an independent study of severe pediatric hepatitis from the 25 UK¹², with 12 (34.3%) of 35 mutations found in 100% of recovered AAV2 genomes (with coverage at the variable site) from both studies. 26



51 Discussion

52 We report here virus findings from PCR, metagenomic, and targeted sequencing of samples from 16 53 pediatric cases of acute severe hepatitis of unknown etiology that were first identified in the United States in 54 October 2021. After combining these three diagnostic modalities, AAV2 was detected in 92% (12 of 13) of 55 cases for which whole blood was available (P<.001). HAdV sequences were detected in all 13 cases, of which 56 11 (84.6%) were genotyped as HAdV-41. Conversely, no control specimens had AAV2 and HAdV-41 detected. 57 Although the 100% detection rate of HAdV may not be surprising as 10 (76.9%) of the 13 cases were known to 58 be adenovirus positive by clinical testing a priori, the detection of HAdV in the 3 remaining cases and in 0 of 45 59 controls is still significant (p<0.001); further, adenovirus is detected in 45-90% of the overall PUI population^{6,8-} 50 ¹¹. Other co-infecting viruses, including EBV and HHV-6, were detected by PCR in many cases but rarely in 51 controls (P<.001); EV-A71 was also detected by metagenomic sequencing in one case but not in any control. These findings indicate an association between co-infection by AAV2 and one or more hepatotropic viral 52 53 pathogens and the clinical manifestations of severe acute hepatitis, although a direct causal link has vet to be 54 confirmed.

55 Initial epidemiological investigation and molecular testing have found adenovirus in 45-90% of severe acute hepatitis cases^{6,8-11}. In the UK, 116 of 179 (64.8%) reported cases as of May 2022 have tested positive 56 for adenovirus¹. This is in comparison to 8 of 9 (88.9%) positive cases in the United States corresponding to a 57 cluster of cases who presented at a children's hospital in Alabama between October 2021 and March 2022¹⁰. 58 59 Slightly less than half (44.6%) of PUIs in an expanded national investigation in the United States had 70 adenovirus detected⁸. In the current study, 9 (75%) of 13 cases were already known to be adenovirus positive 71 a priori by clinical testing, with the remaining 4 cases adenovirus positive by viral PCR and/or sequencing. Consistent with prior reports^{10,12}, genotyping by sequencing confirmed that most of the detected serotypes 12 were HAdV-41 (10 of 13, 77%). 13

14 Our results suggest that co-infection with AAV2 may cause ta more severe liver disease than infection 75 by an adenovirus and/or herpesvirus alone. This condition may be analogous to the fulminant liver failure that can occur when hepatitis D virus (HDV, "delta") infection is superimposed on a chronic hepatitis B virus (HBV) 76 17 infection²⁴. Here we found that in cases with AAV2/HAdV co-infection, viral loads for AAV2 were likely higher 78 than for HAdV, with higher positivity rates and a 2-3 log₁₀ increase in the number of reads by targeted 79 sequencing (mean AAV2 reads = 7,252 versus HAdV-41 reads = 67). This observation may be partially 30 explained by previously published data showing that AAVs can suppress the replication of other hepatotropic 31 viruses, including adenoviruses and herpesviruses^{15,25}. Similarly, patients co-infected with HDV usually exhibit low HBV viral loads due to suppression of HBV replication by HDV-induced interferons²⁶. 32

Among the AAVs, AAV2 is the most well-characterized AAV and has been shown to replicate to high titers in the liver and spleen²⁷. Seroprevalence data from infants, children, and adults demonstrate that 30-80% of the general population is seropositive and that natural infection with AAV can occur at all ages²⁸. However, there is a peak of AAV2 infection between the ages of 1 to 5 years old²⁹, consistent with the observed distribution of ages of affected pediatric cases in the current study.

A whole-genome nucleotide phylogeny and amino acid phylogenies of the VP1 and AAP proteins of all 38 39 sequenced human AAVs and representative nonhuman AAVs reveal that the recovered genomes from all)() cases cluster together in a distinct subclade of AAV2. The clustering is driven by groups of mutations located within hypervariable regions of the capsid VP1 and AAP proteins²¹. Notably, two of these mutations in the VP1 **)**1)2 protein, R585S and R588T, are arginine-to-serine and arginine-to-threonine mutations that likely impact *)*3 receptor binding as these residues are necessary for the interaction of AAV2 with its heparan sulfate proteoglycan receptor³⁰. These are shared not only among the US genomes in the current study but also *)*4 overlap substantially with the mutations found in an independent study of severe pediatric cases from the UK¹². **)**5 Interestingly, several of these shared capsid mutations (V151A, Q457M, S492A, E499D, F533Y, R585S, and 96 **)**7 R588T) are also found in a sublineage of AAV2 (AAVv66) that exhibits increased replication, virion stability, 98 central nervous system transduction, and evasion of neutralizing antibodies relative to wild-type AAV2.)9 However, as other contemporary AAV2 genomes are not readily available, it is unclear whether the

In the current study, hepatotropic viruses other than HAdV, including EBV, HHV-6, and EV-A71, were)2)3 detected, albeit in a smaller proportion of cases. Infection by HHV-6 or EBV alone has been implicated in cases of liver failure requiring transplantation^{31,32}. Notably, among the 13 cases, dual or triple infections with)4 adenovirus and one or both herpesviruses were detected in whole blood from at least 11 cases (>85%). We)5)6 postulate that the COVID-19 pandemic and more than 2 years of school and childcare closures, social)7 distancing measures, and decreased overall social interactions may have generated a vulnerable population of)8 young children who have failed to develop broad immunity to common viral pathogens due to lack of exposure.)9 This may potentially explain the increased proportion of cases with multiple viral infections observed in the current study, including from AAV2, that we speculate may have increased the likelihood of more severe 101 disease manifestations such as hepatitis. 12In summary, here we identify a distinct strain of AAV2 and co-infection with at least one helper virus in

blood from US pediatric cases of acute severe hepatitis of unknown etiology. These results are consistent with findings from independent and contemporary studies of acute severe hepatitis in children from Scotland and the UK^{12,33}. AAV2 infection may contribute to the pathogenesis and/or severity of the hepatitis, or alternatively, may be a non-pathogenic marker of liver inflammation. Further studies, including serosurveillance and cell culture and animal model studies, are needed to investigate a potential causal role infection from this strain or AAV2 in general may play in this disease.

36 Sample Collection

52 until use. These controls, all from California, were selected to be geographically similar (located within the 53 same state) to the cases from California. 51 Nucleic Acid Extraction

Whole blood and plasma samples collected from cases from Alabama were extracted at the Wadsworth Center laboratory using the NucliSENS® easyMAG "specific B" protocol (bioMerieux) according to the manufacturer's instructions. Samples from cases from Florida, Illinois, North Carolina, and South Dakota were extracted using the Zymo Direct-zol[™] DNA/RNA Miniprep Kit (Zymo Research) following the manufacturer's instructions. Briefly, 200 µL of sample was extracted and total nucleic acid was eluted in 60 µL and stored at -80°C until use.

Samples from cases form California were extracted at the California Department of Public Health. 58 59 Whole blood samples (200 µL) were extracted using the Qiagen Blood Mini Kit (Qiagen) according to the 70 manufacturer's instructions. Total nucleic acid was eluted in 100 µL and stored at -80°C until use. Respiratory 71 samples, serum, plasma, and clarified stool suspensions were extracted using the NucliSENS easyMAG instrument (bioMerieux). Total nucleic acid was eluted in 110 µL for nasopharyngeal swab, serum, or plasma or 60 µL for stool and stored at -80°C prior to use. 76

For control samples from California or Georgia extracted at UCSF, total nucleic acid was extracted from the original sample using two different protocols for whole blood and plasma. Whole blood samples (400 µl) that had been pretreated with DNA/RNA Shield (Zymo Research) were extracted using the Quick-RNA Whole Blood Kit (Zymo Research) according to the manufacturer's instructions. Total nucleic acid was eluted in 15 µl and stored at -80°C until use. Plasma samples (200 µl) were extracted using the Mag-Bind Viral DNA/RNA 96 Kit (Omega Bio-Tek) on a KingFisher Flex instrument (Thermo-Fisher scientific) according to the manufacturer's instructions. Samples from cases outside of California and all control samples were screened **)**2 for adenovirus using a pan-adenovirus PCR assay³⁵ and sequenced using a nested PCR assay targeting *)*3 HAdV hexon hypervariable regions 1-6, followed by Sanger sequencing³⁹. Viral Enrichment Based Targeted Sequencing

For cases from California and Alabama and all controls, viral enrichment followed by targeted sequencing of viral genomes was performed using custom spiked primers designed to target HAdV-41 or adeno-associated virus (AAV1-AAV8) genomes. The algorithm generated 219 AdV and 150 AAV spiked primers (Extended Data Table 3). Libraries were)5)6 prepared using NEBNext Ultra II DNA Kit (New England Biolabs). Briefly, adapters were ligated to the purified)7 cDNA (1:25 diluted adaptor), followed by PCR library amplification using the spiked primers and barcoding)8 using NEBNext Multiplex Oligos set 1 (New England Biolabs). Final libraries were quantified using the Qubit)9 Flex instrument (Invitrogen) with the dsDNA HS Assay Kit (Invitrogen). Libraries were pooled and sequenced 10on a NextSeq 550 Sequencing System using 300 base pair (bp) single-end sequencing. Negative template 1 controls were included in every run to monitor for contamination. No contamination from HAdV-41 or AAV2 12reads was detected in the negative template control libraries.

13 For cases from Florida, Illinois, North Carolina, and South Dakota, probe capture target enrichment of 4 viral genomes was performed on metagenomic libraries using the Twist Comprehensive Viral Research Panel (Twist Biosciences), which covers reference genomes of 3153 viruses and 15.488 different strains⁴¹, Individual 15 DNA or cDNA/RNA libraries were hybridized to CVRP probes according to the manufacturer's instructions. 16 17 Libraries were then barcoded and sequenced on an Illumina MiSeq (250 bp paired-end sequencing) or an 8 Illumina NextSeg (150 bp paired-end sequencing) (Illumina). 22 Viral Metagenomic Sequencing and Analysis

Metagenomic DNA and RNA libraries were prepared using the NEBNext Ultra II DNA Library Prep Kit (New England Biolabs) and NEBNext Ultra II RNA Library Prep Kit (New England Biolabs), respectively, according to the manufacturer's instructions. Libraries were pooled and sequenced on a NextSeq 550 Sequencing System using 150 bp single-end sequencing. 33 Phylogenetic Analysis

Multiple sequence alignments were performed using MAFFT algorithm²² as implemented in Geneious (version 10.0.9)⁴³. Nucleotide and amino acid phylogenetic trees were inferred using a maximum likelihood method with ultrafast bootstrap approximation as implemented in IQ-TREE (version 1.6.1)²³ using 1000 bootstrap replicates. Trees were visualized using FigTree (version 1.4.4)⁴⁴.

39 Viral Genome Assembly and Analysis

Binary base call (BCL) files generated by Illumina sequencers were simultaneously demultiplexed and 10 11 converted to FASTQ files using bcl2fastg (version 2.20.0.422). A custom script was used to assemble HAdV and AAV2 genomes as follows. Briefly, raw FASTQ reads were filtered using BBDuk (version 38.87)⁴⁵ for 12 13 removal of adapters, primer sequences, and low-quality reads, and then HAdV-41 or AAV reads were identified by Bowtie2⁴⁶ alignment (parameters: -D 20 -R 3 -L11 -N 1) to a reference database consisting of 1,395 14 15 HAdV-41 or 3,600 AAV partial sequences / genomes, respectively. These aligned reads were then mapped to the HAdV-41 reference genome (accession DQ315364.2) or consecutively to AAV genomes 1-8. For all AAV 16 17 genomes, the assembly with the highest breadth of coverage corresponded to the AAV2 reference genome (accession number NC 001401.2). Consensus assemblies were generated using iVar⁴⁷ (parameters: -t 0.5 18 19 -m 1). AAV consensus genomes were further analyzed for shared mutations in the nucleotide and translated 50 nucleotide (amino acid) sequences relative to the AAV2 reference by performing a multiple sequence alignment using the MAFFT algorithm²², followed by visualization of the alignment using Geneious software 51 $(version 10.0.9)^{43}$. 52
