

A NURSING PHILOSOPHY OF FAMILY EMPOWERMENT IN CARING UNDER-FIVE CHILDREN ILLNESS

Abstract

Introduction: Sick children will be at risk of experiencing growth and development disorders and experiencing severe conditions to decreased quality of life. Quality of care through proper management of sick children under five is a priority. However, in the field of pediatric nursing, there are still obstacles to the application of family empowerment in caring for sick children, so it is important to examine a literature review with a philosophical approach the application of family empowerment in caring for sick children, as an effort to optimize the care of sick children under-five. **Method:** This study was based on the results of the Literature Review. Articles were obtained from 3 databases, namely Scopus, Science Direct and PubMed. The keywords used in searching the literature in this study were ((parent) OR (mother) AND (parental AND empowerment) OR (engagement) AND (children) OR (sick AND children)). Articles searched from 2018-2022, which were open access and in English, from this literature review search, found 12 articles. **Result:** Based on a philosophical approach of family empowerment in the care of sick children under-five, family empowerment interventions with the principle of involving families in care, and increasing family knowledge and skills in caring for sick children can be implemented as an effort to optimize care for sick toddlers. **Conclusion:** The results of this literature review can be used as a basis for nursing interventions that require parental involvement in caring for sick children. Family empowerment programs that are planned and structured can be applied in the care of sick children at home or in the hospital.

Introduction

Illness and mortality in children under five is a global problem that requires handling in various aspects holistically. Sick toddlers need serious attention, pain in toddlers if they don't get prompt and proper treatment will fall into a severe condition that results in death (Rachmawati et al., 2022). the under-five mortality rate in Indonesia until 2017 was 32 per 1000 live births (USAID, 2020). Parents whose children are sick experience stressful conditions this is due to many factors, such as children's health, financial problems, children's

behavior (Damen et al., 2021). Families have a big role in child care, especially in the initial treatment of sick children or daily child care. The family's ability to care for a sick child determines the severity or recovery of the child because the family is the unit closest to the child in daily life.

Children under five years of age are at the stage of the golden age period, so this toddler age is in a period of very rapid physical growth and development, the first 1000 days of a child's life become a golden period which if passed with poor quality stimulation will have a negative impact on the life of the next child (Toto Sudargo, Tira Aristasari, 2018). Under-five children who are sick will experience a decrease in quality of life so they are at risk of experiencing obstacles to growth and development optimally, as well as families who care for children also experience a decrease in quality of life, due to anxiety, fatigue, helplessness, lack of knowledge and ability to care for children (Rachmawati et al., 2016).

The family is the smallest unit closest to the child, good family knowledge and skills in caring for sick toddlers determine the level of recovery. Research shows that parents need information from health workers to improve their skills in caring for sick children (May et al., 2018). Family Center Care improves child nursing services by involving parents in the stages of nursing care for sick children. Nurses have an important role in providing nursing care to sick toddlers, through family empowerment it is hoped that they can optimize the nursing interventions provided, so it is important to elaborate more deeply on family empowerment in a philosophical review of child nursing. This Literature review aims to describe family empowerment in caring for sick children based on a philosophical approach to ontology, epistemology and axiology.

Method

This literature review is in the search for articles using the PICOS framework with the question "how is parental empowerment in treating sick children with a philosophical approach" taken from 3 data bases, namely Scopus, Science Direct and Pubmed which are limited from 2017-2022 and all articles are in English. The articles obtained were based on the keywords ((parent) OR (mother) AND (parental AND empowerment) OR (engagement) AND (children) OR (sick AND children)). All articles were analyzed by PRISMA Flowchart to get relevant articles.

Results

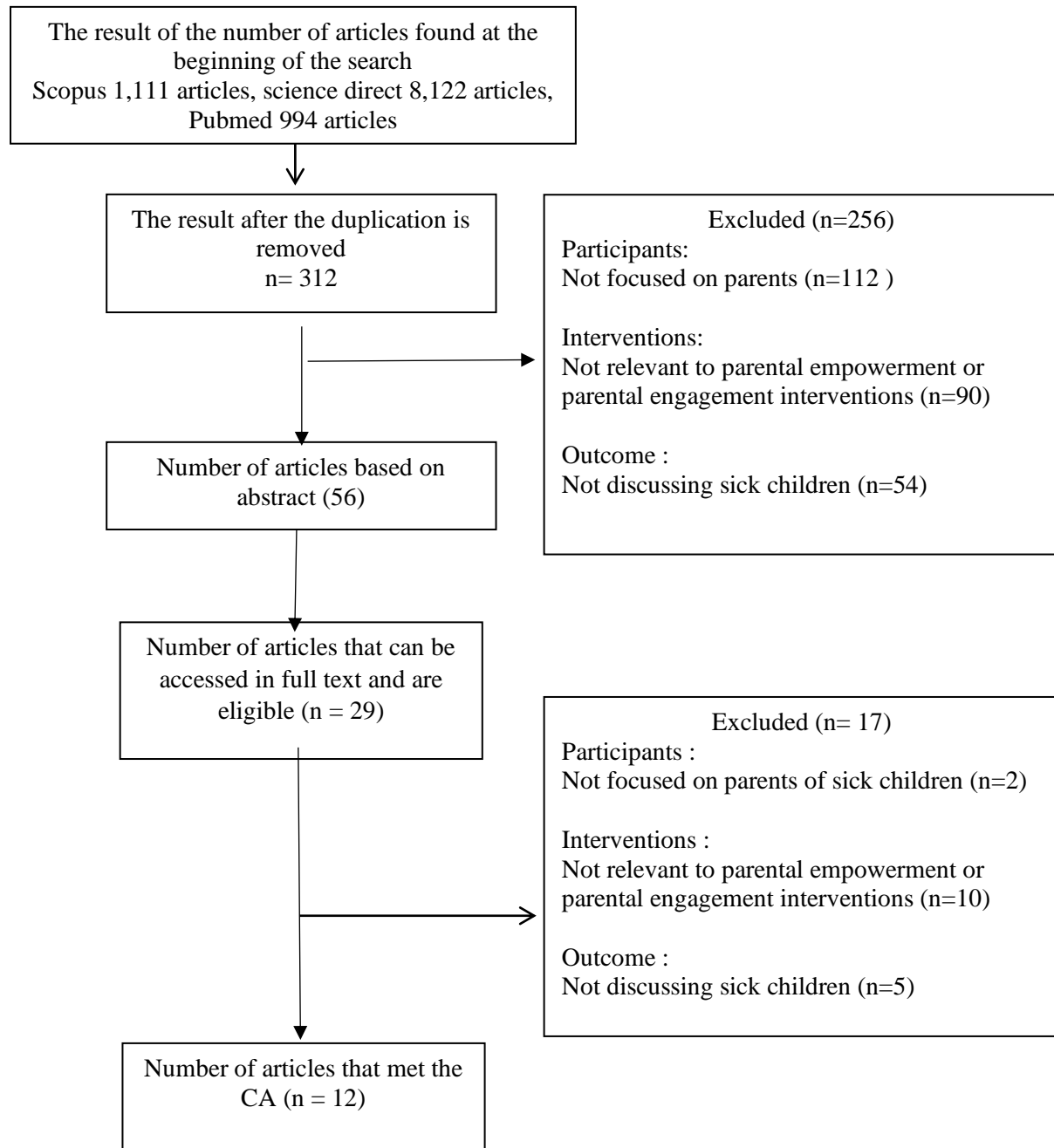


Figure 1. Literature Review flow diagram based on PRISMA

Search results and article analysis from the Scopus, Pubmed and Sciencedirect databases, using the PRISMA Flowchart as shown in Figure 1. found 12 articles.

Discussion

Ontology of Family Empowerment in Caring Under-Five Children Illness

In essence, children's health cannot be separated from factors from parents or family, because children are in the system within the family, so the family is a very important element in the growth and development of children, both in healthy and sick children (Yuni Sufyanti Arief et al., 2018). Children have unique characteristics that are different from adults, when

children are sick they need specific treatment according to the disease they are experiencing, and the first level of care when a sick toddler is in the family. Families caring for sick toddlers often experience stress caused by worries about the illness experienced by the child and how to treat the child when the child is sick (Mohammadzadeh et al., 2022). Parents caring for sick children are in a state of confusion about the roles they have to do, they tend not to be confident in managing treatment when their children are sick, this results in parents not being able to make the right decisions when the child is sick, even though the role of parents is very important in this condition (Maaret Vuorenmaa et al., 2016).

The discipline of pediatric nursing in improving health and disease prevention in children is oriented toward family-centered nursing services (Family Center Care) which are oriented to capacity building and involving families in every child and family care. The philosophy of pediatric nursing states that the health and nursing services needed by children must involve the family in every process through empowerment (Hockenberry & Wilson, 2013), to prevent trauma, recurrence, and disease severity.

Epistemological of Family Empowerment in Caring Under-Five Children Illness

Toddlers who are sick are at risk of having problems meeting the needs for growth and development. The family as a unit that is close to the child is expected to be the first level in the care of sick toddlers. This phenomenon is the basic foundation of the importance of developing child nursing science through family empowerment for the care of sick toddlers.

Various studies and theories of family empowerment have been developed as a basis for scientific proof of the philosophy of family-centered nursing. Family-centered nursing is the main intervention for child support. Information obtained by families and children is important in clinical decision-making (Friedman et al., 2003). One of the theories regarding the application of family nursing care with a family-centered nursing approach is the Friedman Model, in which Family Center Nursing is based on the perspective that the family is the basic unit for individual care, the family is the basic unit of a community and society, each of which has its characteristics. different in culture, race, ethnicity, and socioeconomic (Pediatric, 2012).

Treatment with the principles of Family Center Care (FCC) provides family support by increasing self-confidence and the ability to care for children. Two basic concepts in family-centered care are *empowerment* and *enabling* (Hockenberry & Wilson, 2013). FCC provides information from basic to sustainable development, with the aim that families and children can be more effective in care and decision making, providing support facilities both formal and informal. Family empowerment aims to increase knowledge to improve family skills in caring

for sick children (Shoghi et al., 2019). The implementation of parental empowerment needs to consider aspects of the personal characteristics of parents and families because the empowerment of parents in caring for children is also related to the personal characteristics of parents or families of sick children. and make decisions, in addition to maternal health, family finances, mothers aged 30 years or older and father's high education are also related to parental empowerment (M. Vuorenmaa et al., 2016), by looking at the underlying or related parental characteristics, which are expected to realize the appropriate and appropriate application of parental empowerment.

Several studies have stated that family-centered nursing interventions by empowering families are effective in increasing the closeness of children and parents and the ability of parents to care for their children (Rasheed et al., 2021; Arief et al., 2020; Piotrowska et al., 2017), By involving families in child care, it reduces parental concerns about the child care process while the child is sick (M. Vuorenmaa et al., 2016). Another study states that family empowerment by health workers can reduce parental stress and also improve the quality of life of sick children (Mohammadzadeh et al., 2022). The closest family and have the right to make decisions on children including children's health are parents, both fathers, and mothers, with the application of parental empowerment in health services, they can train parents on how they should play a role in daily child care or when the child is sick, improve their knowledge and skills, can increase their confidence in caring for children so that parents can work together with health workers in making the right decisions in the care of their children (Maaret Vuorenmaa et al., 2016).

WHO recommends one of the treatments for sick toddlers in developing countries through the Integrated Management of Childhood Illness (IMCI), which is an integrated approach to the management of sick toddlers with a focus on the health of children aged 0-5 years (toddlers) as a whole, in this IMCI-based management one of the components is improving family and community practices in-home care and efforts to seek help for sick toddlers (impact increasing community empowerment in health services) (García Sierra & Ocampo Cañas, 2020) (Kementrian kesehatan Republik Indonesia, 2022).

Axiology of Family Empowerment in Caring Under-Five Children Illness

Children as individuals need to grow and develop optimally. Sick conditions will reduce the quality of life of children and their families, children are at risk of losing the opportunity to get stimulation, carry out normal activities and get nutritional intake that supports their growth and development, so it is important for toddlers who are sick to get the proper care. Nurses

play a role in providing nursing care, to achieve the fulfillment of the needs of an individual or family.

The role of nurses is very important to provide appropriate interventions for sick toddlers. A nurse is someone who is highly educated in nursing and carries out nursing activities based on nursing science by providing care to individuals, families, groups, or communities. Family empowerment interventions in sick children based on scientific evidence can be used as the basis for interventions for nurses in the care of sick toddlers (García Sierra & Ocampo Cañas, 2020).

Family Center Care (FCC) is a holistic approach, where the provision of nursing care is not only for individuals (children) but also forms a relationship between nurses and families. (Kuo et al., 2012). The implementation of the FCC focuses on collaboration between nurses and children's families starting from planning, carrying out, and evaluating actions (Krisnana et al., 2019). The application of FCC aims to involve families in child care, so nurses need to enable families to take care of children when they are sick or healthy (Smeltzer & Bare, 2009). Management of Sick Toddlers through Integrated Management of Childhood Illness (IMCI) in addition to improving the skills of health workers, it also improves family and community practices in-home care and efforts to seek help for sick toddlers (Kementrian kesehatan Republik Indonesia, 2022).

Parental empowerment is a process for parents to better understand the situation, including the condition of a child who is sick (Zimmerman et al., 1992). Family empowerment serves to enable families or improve family competence in interacting with children, through the stages of empowerment and providing assistance to families effectively and efficiently so that families can play a role and make appropriate decisions (Rachmawati et al., 2016).

Family empowerment that can be done by nurses in caring for sick children based on existing theories and research includes providing continuous information, facilitating families with various activities, cooperating in child care, identifying the abilities of children and families, helping to recognize self-ability, increasing the capacity and confidence of children and families (Pediatric, 2012).

Empowerment programs that can be applied based on scientific evidence are through several component approaches such as perceived threats, skills, and self-efficiency, increasing self-confidence through educational participation and evaluation (Shoghi et al., 2019). Another application of family empowerment in caring for sick children with burns is empowerment based on a family-centered care model consisting of four stages, namely threat perception, self-efficacy, self-esteem, and evaluation (Mohammadzadeh et al., 2022). The first stage is the

perception of threat, which is to examine the parent's perception of the child's health, by explaining the disease that is being experienced by the child starting from the definition, the impact of hospital and home care, and treatment on the treatment plan. The second stage is increasing the self-efficacy of parents, at this stage how a health worker teaches parents how to manage stress, help parents and empower parents in child care. The third stage is self-esteem and self-control, namely by explaining the treatment carried out at home and the healing process and the fourth stage is evaluation, here is an evaluation of what parents have done, evaluation

Research on parental empowerment programs says that parents are agents of change, which in its application says that parental empowerment programs provide support to parents emotionally, help solve problems, help parents develop special competencies, such as effective communication, and help create community with other people. other parents so that they can support each other in the care of their sick children (Olin et al., 2010).

Empowerment of parents or families can be increased by strengthening self-confidence, and providing concrete emotional support so that nurses or health workers can provide better services (M. Vuorenmaa et al., 2016). There are three dimensions in empowering parents in caring for children, namely the family dimension, the dimension of the service situation, and the dimension of the service system. they use, while the service system dimension is the improvement of basic health care services for children. Conceptually, the principle of family empowerment is the same in various places, however, the application can be different, depending on the health service system used and conditions in the local area (M. Vuorenmaa et al., 2016).

According to M. Vuorenmaa et al., (2016) success in parental empowerment in the family aspect is seen from the aspect of fathers and mothers, fathers and mothers who are confident in their skills in parenting, do not experience difficulties when caring for children, and feel that there is easy access when they need help. Indicators of increasing maternal empowerment in situations include when the mother feels confident in her skills and responsibilities as a parent in caring for her child, does not feel worried about the child's physical health, and does not find it difficult to take care of her family or carry out work, feel easy to access services. 30 years and a place for daily child care, while in the aspect of the indicator paragraph in increasing father empowerment, namely when fathers believe in child care skills, do not find it difficult to work and take care of their daily families, and facilitate child care services. In the dimension of the family service system, indicators of increasing maternal empowerment in child care are confidence in their child-rearing skills and roles as

parents, not finding it difficult to take care of their family and carry out daily work, and being 30 years of age or older and where children are cared for daily, while from the father's factor the indicators of success in increasing parental empowerment are the father's confidence in his child-rearing skills, ease of access to assistance and the high level of father education.

Conclusion

Sick toddlers need proper care and treatment to prevent the severity of the disease that can have an impact on disrupting the growth and development process of Toddlers, the family is the closest unit to under-five children who can determine the Toddler's health. A philosophical review of family empowerment in the care of sick children can be the basis for pediatric nurses in providing nursing care to sick toddlers. Nurses can implement women's empowerment programs by providing continuous information, facilitating families with various activities, cooperating in child care, identifying the abilities of children and families, helping to recognize self-ability, and increasing the capacity and confidence of children and families.
